WARRANT FOR ANNUAL TOWN MEETING

(L. S.)

To the inhabitants of the Town of Canterbury in the County of Merrimack in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at the Town Hall in said Canterbury on Tuesday, the tenth day of March next, at nine of the clock in the forenoon, to act upon the following subjects:

1. To choose all necessary Town Officers for the year ensuing.

2. To raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriation of the same.

3. To see if the people will authorize the Selectmen to dispose of any Real Estate acquired by the Town through Tax Collector's deeds in the ensuing year.

4. To see if the people will vote to give a discount on taxes paid before a certain date set by the people and the amount of discount.

5. To see if the Town will vote to adopt the provisions of the municipal budget act.

6. To see if the people will vote to accept State Aid Construction on the Baptist Road, the State to contribute \$1,808.00 providing the Town raises \$904.50 or to accept Class V road assistance, the Town to raise \$775.93 and the State to contribute \$3,103.74.

7. To see if the Town will vote to give the Selectmen authority to borrow money in anticipation of taxes.

8. To see if the Town will vote to raise enough money to create a new Cemetery in the Center and to pick a location.

9. To see if the Town will raise more than was raised last year for a furnace heating plant in the Town Hall and garage.

10. To see if the Town will raise enough money to buy a tractor for snow removal and vote a way for payments.

11. To see if the people will vote to purchase 3 or 4 horse sheds to be made into storage quarters for road equipment.

12. To see if the people will vote to raise money for a sanitary toilet at the Center.

13. To see if the Town will vote money for Pine Blister Rust.

14. To transact any other business that legally comes before this meeting.

2. To choose a Clerk for the ensuing year.
3. To choose a Member of the School Board to serve for three years, to fill the vacancy arising from the expiration of the term of office of Herman R. Colby.
4. To choose a Treasurer for the ensuing year.
5. To determine and appoint the salaries of the School Board and Truant Officer, and fix the compensation of any other officers or agent of the district.
6. To hear the reports of Agents, Auditors, Committees, or Officers heretofore chosen, and pass any vote relating thereto.
7. To choose Agents, Auditors and Committees in relation to any subject embraced in this warrant.
8. To see if the District will vote to make any alteration in the amount of money required to be assessed for the

ensuing year for the support of public schools and the payment of the statutory obligations of the district, as determined by the School Board in its annual report.

9. To see if the district will vote to raise and appropriate the sum of three hundred dollars (\$300) for remodeling the Carter school building.

REPORT OF SUPERINTENDENT OF SCHOOLS

To the School Board and Citizens of Canterbury:

I herewith submit my second annual report as superintendent of schools.

The organization of the Tilton-Northfield Supervisory Union remains the same as last year, consisting of the school districts of Tilton-Northfield, Belmont, Canterbury, Gilford and Gilmanton. There are forty-six teachers and nearly twelve hundred pupils in the union.

The following is a comparison of certain records for the school year ending June 30, 1935 with those of the year previous.

Last year showed a marked drop in the number of tardinesses and a decided increase in the per cent of attendance. These are decided improvements. Eight pupils had perfect records in attendance for the entire year and are deserving special commendation.

At this writing there are eighty-five (85), pupils enrolled in our schools. The Uplands, which has an enrollment of only seven (7), is our smallest school.

Closing exercises for all schools were held jointly on the evening of June 13, 1935, at Canterbury Center. The pro-

gram was presented entirely by the pupils under the direction of the teachers. Unfortunately illness interfered somewhat with the plans. The bringing together of all the children in the district for such an occasion seemed a worthwhile project.

Diplomas were presented those pupils completing the eighth grade work and who were qualified to enter high school. The following were the graduates:

Only one of these pupils found it possible to enter high school in September.

There has been only one change in our teaching force within the year. Mrs. Sarah Stone Hill of the Kezer School resigned in June and was succeeded by Miss Helen Ericson of Concord, a teacher of several years experience.

There are now eleven (11) Canterbury children attending high school, five (5) at Concord, five (5) at Penacook and one (1) at Henniker. This is a decided drop in number from last year when there were twenty-five (25) children in attendance.

The Uplands, Center, and Blanchard school rooms present a much more attractive appearance. The walls and ceilings of these schools have been repainted. Much should be done to the Carter school to make this building satisfactory. The School Board recommends a special appropriation to put this building in shape. The present entrance should be a part of the school-room, additional windows should be installed, and a new entrance added to the building, so arranged that there would be access to the shed and toilets without going out of doors.
