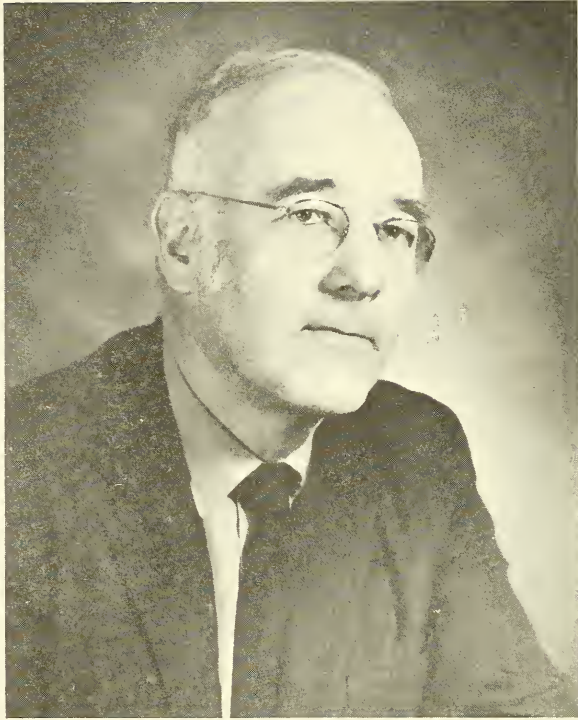

The Business portion of the Town Meeting will begin at 7:30 P.M.

To the Inhabitants of the Town of Goshen, New Hampshire in the County of Sullivan in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at Goshen Town Hall in said Goshen on Tuesday, the Ninth day of March, next at One of the clock in the afternoon to act upon the following subjects:

1. To choose all necessary Town Officers for the ensuing year.
2. To receive the reports of the Town Officers and take action thereon.
3. To see if the Town will vote to raise and appropriate the following sums of money:

Purpose

Town Officers' Salaries	\$7,700.00
Town Officers' Expenses	6,000.00
Election and Registration Expense	1,000.00
Cemeteries	500.00
Town Hall and Other Buildings	5,800.00
Damages and Legal Expense	2,000.00
And authorize the withdrawal of \$6,870.00 (from above purpose) from the Federal Revenue Sharing Fund with the balance to be raised by taxation.	

4. To see if the Town will vote to have a reappraisal made of all real estate in the town; to raise and appropriate the sum of \$20,000.00 for this purpose.
5. To see if the Town will vote to raise and appropriate the sum of \$1,000.00 for Planning and Zoning.
6. To see if the Town will vote to raise and appropriate the sum of \$141.00 for the purpose of publicizing and promoting the national advantages and resources of the Town together with other towns in the Dartmouth-Lake Sunapee Region.
7. To see if the Town will vote to raise and appropriate the sum of \$412.00 to remain a member of the Upper Valley-Lake Sunapee Council.
8. To see if the Town will vote to elect the Planning Board starting with the 1983 Town Meeting in accordance with RSA 36:4 II cb.

9. To see if it is the sense of this meeting to make and to perfect from time to time a Master Plan for the development of this municipality.
10. To see if the Town will vote to raise and appropriate the sum of \$3,000.00 for the Police Department Capital Reserve Fund; and to authorize the selectmen to withdraw from this Capital Reserve Fund and purchase a police cruiser in an amount not to exceed \$9,000.00
11. To see if the Town will vote to raise and appropriate the sum of \$8,000.00 for the use of the Police Department.
12. To see if the Town will vote to raise and appropriate the following sums of money:

Fire Department	\$5,600.00
Civil Defense	100.00
Building Inspection	150.00
13. To see if the Town will vote to raise and appropriate the sum of \$15,000.00 for Summer Maintenance of Roads, and \$12,000.00 for Winter Maintenance of Roads. These sums to include road work helper wage up to an hourly rate of \$4.50; General Expense of Highway Department, \$7,500.00; Street Lighting, \$120.00.
14. To see if the Town will vote to raise and appropriate the sum of \$6,194.50 for the construction or reconstruction of Town Roads and to accept from the State approximately \$6,194.50 of Additional Highway Subsidy Funds for this purpose, in accordance with RSA 241:15.
15. To see if the Town will vote to apply for Town Road Aid and to raise and appropriate the sum of \$346.81 for the same with the State contribution \$2,312.10.
16. "Shall the Town of Goshen accept the provisions of Section 1 to 10 inclusive of Chapter 53-B of the Revised Statutes Annotated providing for the establishment of a Regional Refuse Disposal District, together with the Towns of Acworth, Charlestown, Cornish; Croydon, Grantham, Langdon, Lempster, Newport, Plainfield, Springfield, Sunapee, Unity and Washington, and the City of Claremont, and the construction, maintenance, and operation of a Regional Refuse Disposal Facility by said District in accordance with the provisions of a proposed agreement filed with the selectmen, and shall the Town enter into said agreement as an interlocal agreement pursuant to RSA 53-A for said purposes?"

18. To see if the Town will vote to raise and appropriate the sum of \$3,200.00 to maintain the Town Dump.

19. To see if the Town will vote to raise and appropriate the sum of \$2,612.75 for the Health Department: Newport Area Home Health Agency, \$1,373.00; (Newport Ambulance Service, \$1,239.75 or Golden Cross Ambulance Service \$1,239.75.)

POLICE DEPARTMENT REPORT 1982

I respectfully submit the following report on services provided by the Goshen Police Department.

The Goshen Police responded to 257 calls and handled a total of 319 incidents in 1981. This is an increase of 40% over 1980 for calls but a decrease in the number of incidents handled. Because of a lack of funds, the department cut way back on patrol and attempted to go out only as calls came in.

The radar received minimal use because of the low patrol time and therefore, traffic violation enforcement was very down this year. Three officers: Officer Linda Gentes, Officer David Burnham, and myself, became certified as Radar Operators by the New Hampshire Police Standards and Training Council.

This was the first year we had the new dog leash law in effect. We investigated 55 leash law complaints and processed 29 unlicensed dogs. Six (6) dog owners were brought to court for violations.

A crime prevention program will be put in effect in cooperation with and under the guidance of the International Association of Chiefs of Police. It is hoped that through this program the community will become more aware of the problems in this area. Homeowners will be invited to participate in an operation identification program in an effort to reduce burglaries and other related crimes.

A police pager was added to the Goshen Police Department this year. We now not only have an answering system for the non-emergency calls, but also can be reached twenty four hours a day through the Newport Police Department via the police pager system. We hope to acquire one more pager this year to increase our efficiency in answering emergency calls.

The Goshen Police Department is also attempting this year to form a Fast Squad for the Town of Goshen. It will be a separate unit but still under the guidance of the Police Department. Anyone interested in becoming a member should contact us.

I wish to thank the people of Goshen for their support again this year.

REPORT OF THE FIRE DEPARTMENT

In 1981 the fire department answered 23 calls with 215 men responding. Total reported fire loss was \$12,200.00.

I want to stress again, to report a fire in Goshen call 542-5155, give your emergency information to the dispatcher and we will be notified by radio pager. Every Goshen firefighter has a pocket sized radio receiver and although this seems complicated it has reduced our response time tremendously. Please remember 542-5155 is the number to call for fire emergencies ONLY. For burning permits call Forest Warden Arthur Nelson at 863-1509. For all other information and fire department business call 863-2055 or 863-3293.

The fire department is qualified to advise you about chimneys, and gas, oil and wood stove installation. PLEASE, if in doubt, seek advise BEFORE you install your wood stove or other heating unit. And remember, Smoke Detectors do save lives.

Our mutual aid agreements with neighbor communities have made us all more efficient firefighters. No community can afford all the equipment it might need at a fire without mutual aid. We all help each other with no cost to the receiving town.

The annual Firemen's Auction earned \$1,650.00 (net) in 1981 for our equipment fund. When you do your sprint cleaning, please remember our auction and give us a call at 863-2055 or 863-3293 if you have something to donate. We pick up year round.

All fire department funds are spent on service and equipment. No firefighter receives pay for working on equipment, training or firefighting.

In 1981 we were able to purchase training aids (slides & tapes) with funds given in memory of Harry (Jack) Warburton and Stanley (Stan) Williamson. Good training is essential to good firefighting.

My sincere thanks go to the firefighters for their many hours of work and participation and to the dispatchers, auction crew, town officials and to all citizens and tax payers for the help and cooperation given to make the Goshen Volunteer Fire Department a very effective service to the town.

RSA 76:11 provides for delivery of the list (warrant) to the collector within thirty days of receipt of approval of the tax rate unless for good cause the time is extended by the department. The collector shall within thirty days after receipt of the warrant from the selectmen (assessors) send out the tax bills unless for good cause the time is extended by this department.

RSA 76:11-a Information Required. The tax bill which is sent to every person taxed, or his agent, if known, as provided in section 11, shall show the rate of municipal, school and county taxes separately, and each bill shall also show the assessed valuation of all lands and buildings for which said person is being taxed. The 1981 rate breakdown reflects a proportionate share of the Reimbursement a/c Property Exempted by 1970 Special Session for each unit of government.

RSA 76:13 provides that interest at 12% per annum shall be charged upon all taxes except resident taxes not paid on or before Dec. 1, except that in the case where a tax bill was sent to a taxpayer on or after Nov. 2 and before April 1st, interest shall not be charged until 30 days after the bills are mailed. The collector shall state on the bill the date from which interest will be charged.

The tax bill which you mail must contain the date from which interest will be charged and this date is determined by the date you send the last bill on the list committed to you. RSA 76:13 also requires that you notify this department in writing of the date on which you send the last bill. There is enclosed a form for this purpose.

GOSHEN PLANNING BOARD

The Goshen Planning Board, with extensive input and support from the sixty-one (61) member Goshen Sounding Board, has primarily focused its attention this past year on two (2) major projects.

Comprehensive Master Plan

The preparation of this plan has been made a great deal smoother because five town sub-committees have been working on a regular basis to provide advice and information to the Planning Board. Committee members focused their attention in the following areas:

1. Roads and Transportation-Eddie Baker
2. Municipal - Rita Purmont
3. Historical-Betty Nelson
4. Land Use and Population-Phyllis Baker
5. Natural and Critical Resources-Lillian Scranton

Revision and Up-Dating of Subdivision Regulations

During this past year the Planning Board has re-written portions of the Subdivision Regulations to bring them into line with legislative action and town wishes. In addition to Sounding Board suggestions, the Planning Board has received considerable help and guidance from technicians such as; the Sullivan County Engineer, the Upper Valley-Lake Sunapee County Engineer, the Upper Valley-Lake Sunapee Council, the Office of State Planning, and the Soil Conservation Service.

The Planning Board is not proposing any new, or amended changes to the Zoning Ordinance for consideration this year. The Board will carefully review the Ordinance, gather citizen input, and suggest appropriate changes at the 1983 Town Meeting. This would allow the Subdivision Regulations, Master Plan, and Zoning Ordinance to be in support of each other, and to accurately reflect town wishes.

NEWPORT AREA HOME HEALTH AGENCY

In 1981 there were some shifts in Home Health Care Service provided to area towns by the Newport Area Home Health Agency. These shifts were caused by changes in staffing, government policies and individual town utilization and need of service.

Skilled Nursing home visits, the Agency's core service remained stable as did physical therapy visits and service to mothers and children in the Agency's Well Child Program. There was a decrease in occupational therapy and office visits and an increase in Home Health Aide service.

The Agency's clinics remained well attended - an Adult Screening Clinic for Blood Pressure, Diabets and Enemia held in Grantham was highly successful. The Agency will hold such a clinic in other small towns that desire this service.

Newport Area Home Health Agency participated in the Dartmouth Medical School program that orients prospective doctors to community medicine. Newport Area Home Health Agency staff worked with the professional staff of the Counseling Center of Sullivan County to gain mental health counseling skills. These activities as well as staff attendance at educational workshops added knowledge and skills to help area citizens with health problems.

The Agency continued its Child Abuse and neglect Program with funding from the United Way. Newport Area Home Health Agency appreciates the support of the towns and will continue to provide high quality service to all those who need home health care.

REPORT OF THE GOSHEN CONSERVATION COMMISSION 1981

The Goshen Conservation Commission has established a regular monthly meeting date on the first Monday of the month, and has met seven times this year, including two meetings with the joint town boards.

At our request, the Selectmen approved the increase of our membership to seven, with Gerald Dickerman, Steven Edes, Barry Genzlinger, and Philip Mygatt becoming our new members.

This year, three workshops were attended by a Goshen Conservation Commission member. These workshops help to keep commission members up-to-date on new legislation and programs. The information obtained at the workshops is shared with the other members, so that we may be able to function more effectively as a commission. In August, there was a Prime Wetlands Workshop which was held in Hancock. This workshop provided information on the new Prime Wetlands Regulations of the New Hampshire Wetlands Board. In November, the New Hampshire Association of Conservation Commissions held its Eleventh Annual Meeting in Wolfeboro. By-laws were discussed, as well as prime wetlands legislation and hazardous waste sites. Also in November, there was an Acid Rain Workshop held in Hancock. Goshen is now participating in a monitoring system sponsored by The Citizens' Task Force on Acid Rain and the New Hampshire Association of Conservation Commissions. Barry Genzlinger is Goshen's official observer.

This summer and fall, the Goshen Conservation Commission made several on-site inspections of the D-2 site. Questions were discussed with Judy Tuomosa, biologist for the Soil Conservation Service, concerning her "Proposed Wildlife Management Plan".

Another project that was started this fall was the indexing of the wetlands in Goshen. This task will take considerable time, effort, and possibly outside expertise.

All meetings of the Goshen Conservation Commission are open to the public. Interested citizens are urged to attend and share their ideas.

**REPORT OF HEAD TEACHER
(1981)
Goshen-Lempster Cooperative School**

January of 1981 began Goshen-Lempster's first complete year of operation with the new school addition. Faculty and student members enthusiastically utilized the new space; the classrooms became less crowded and, therefore, more effective as a learning environment. The Activities Room now provides a place for school and community functions, and it is now possible for student groups to continue to play organized team sports throughout the winter and during inclement weather.

The year was quite active with many events and student experiences, curricular and extra-curricular. Some of these events were:

- January - Artist Jane Burnham began a print making project with sixth, seventh and eighth grade students as part of the Artists In The Schools (A.I.S.) program. This was a ten week project involved with collagraph and styrofoam relief printing.
- February - The Eighth Grade Class held a Valentine's dance, the first dance held in the new activities room.
- March - Artist Gretchen Cochran, A.I.S., began a five week clay project with second and third grade students. The project consisted of clay sculpture and the construction of personalized clay masks.

"Musher" Bill and Heidi Bartlett of Goshen presented a slide program of an Alaskan dog sled race. The entire student body assembled in the activities room to hear Musher Bill's account of his grueling adventure in the 1100 mile Iditarod Dog Sled Race.
- April - During the Spring vacation, The Parent - Teachers Club (PTC) and friends installed outdoor play equipment on the playground. The pieces consist of a balance beam, parallel bars, and a monkey bar unit. The equipment was purchased by the PTC last year.
- May - Mrs. Rudenfelt's Newport Junior High School choral group gave a concert for the school in the Activities Room.

Mr. Barry Genzlinger and Newport's Alternative Class spent an afternoon with our first grade students, involving them in a jump rope making project.

Artist Gretchen Cochran, initiated a five week totem pole project with the first grade class. Two totem poles, one representing good spirits and the other representing bad spirits, were erected on the playground with the aid of Mr. Newton.

June - Sixth and seventh grade students improved the school grounds as part of a science - conservation program. The students spread wood chips, planted flowering crab trees, and planted such shrubs as Potentillas, Junipers, and Spreading Upright Yews.

Graduation exercises were held in the Activities Room; the Reverend Lilian Warner of Lempster gave the Invocation and the Benediction, and School Board Member Doris Adler issued diplomas. Thomas Lohman was the Valedictorian; Robin Johnson was the Salutatorian; Timothy McGinnis and Joyce Murray were co-Third Honors graduates.

September - At the start of the new school year the following personnel changes occurred: Mrs. Linda Warner of Sunapee was added to the teaching faculty as she assumed her duties in a classroom of third and fourth grade students; School Nurse Laurel Johnson joined our staff and now spends Thursday and Friday mornings at the school; Mrs. Cheryll McGinnis replaced Mrs. Elizabeth Lohman as the Library/Administrative Aide; Mrs. Rachel Tirrel succeeded Mrs. Linda Smith as School Lunch Coordinator.

October - Mrs. Collier, Teacher Aide, Mrs. Bryce, and the Resource Room students traveled to Mount Kearsarge for a mountain climbing experience.

The School Board contracted services for the purpose of revitalizing our television reception so that educational television services could be resumed in the classroom.

November - The sixth, seventh and eighth grade students traveled to the Boston Museum of Science. Their

experience consisted of a planetarium viewing, a special biology program, and a tour of the exhibit halls.

Mrs. Collier's Special Education Class conducted a field trip to the New London hospital.

The seventh and eighth grade students initiated the project of a student film festival. The first film, a Walt Disney animation, was shown on a Friday evening in the activities room with many members of the community in attendance. This was the first of six such films to be shown in the current school year.

Mrs. Cheryl McGinnis (Librarian) and Mrs. Jeanette Struble (Art Teacher) teamed in sponsoring a student Book Mark Contest. The contest was judged by grade level at a display in the library. The winners were: Lester Caron (grade 8), Tyler Henderson (grade 7), Jon Ghidoni (grade 6), Kati Pavlik (grade 5), Keith Chadwick (grade 4), Kim DePoyster (grade 3), David Hamilton (grade 2), and Josh Janicke (grade 1).

Mr. Joel Maiola, representing U.S. Congressman Judd Gregg, gave sixth, seventh and eighth grade students a slide presentation on the various activities of a congressman. The finale of the presentation was a telephone hook-up with Congressman Gregg in Washington, D.C. Students were allowed the opportunity to ask their Congressman questions.

The Open House was a great success with a stupendous parent turnout. School Nurse Laurel Johnson exhibited student literature on growth through puberty and film on menstruation to be used with fourth through eighth grade students. The Eighth Grade Class provided refreshments.

December - Karen Rexford, an International Four-H Youth Exchange (IFYE) representative, presented the entire student body a slide presentation of her experiences in Norway. She also displayed artifacts of her host country to the students.

The second Disney film, an animal adventure, of the student film festival was shown in the activities room on a Friday evening.

Last Spring the faculty submitted to the School Board a formalized language arts curriculum, a concerted effort ensuring continuity between the grade levels. This year's goal is to provide a formalized mathematics curriculum.

At least two-thirds of last year's graduates made the freshman honor roll for the first quarter in their respective high schools. Of the twelve students that graduated three out of five attending Newport received honors, three out of three attending Sunapee received honors (one of those was the only freshman high honors), one out of two attending Claremont received honors, one student in Keene received honors, and for one student in Vermont there is no data.

Many recent visitors to the Goshen-Lempster Cooperative School have remarked on the changes at the school. It has been said that the school is now among the most attractive in the area. This outward appearance reflects an inner attitude of all those associated with the school, and, more importantly, the school now stands as a monument to community pride, a pride for its children.

To see if the District will vote to raise and appropriate the sum of \$420,819.00, as recommended by the School Board, for the support of schools, for the payment of salaries of School District Officials and Agents, and for the payment of statutory obligations of the District, and to authorize the application against said appropriation of available income estimated at \$21,161.00.

ARTICLE 7. To see if the District will authorize the School Board to appropriate receipts from federal lunch reimbursements, tuition, gifts, and other receipts from miscellaneous sources, in addition to the original appropriation for 1982-83 for the school lunch program, general expenses, equipment, and improvements.

ARTICLE 8. To see if the school district will vote to raise and appropriate the sum of \$1,500.00 for heat and/or smoke detectors in the Goshen-Lempster School. (Inserted by petition)

ARTICLE 9. To transact any other business that may legally come before this meeting.
