TOWN WARRANT

To the inhabitants of the Town of Langdon, in the County of Sullivan and State of New Hampshire.

You are hereby notified to meet at the Town Hall in said Langdon on Tuesday, the 10th day of March next, at 10 o'clock in the forenoon to act upon the following articles :

Art. 1. To choose all necessary Town Officers for the year ensuing.

Art. 2. To see if the Town will appropriate and authorize the selectmen to use the income from :

- a. Savings Bank Tax
- b. Interest & Dividends Tax
- c. Yield (Timber) Tax
- d. Reimbursement on Account of Growing Wood and Timber
- e. Dog Licenses
- f. Motor Vehicle Permit Fees
- g. Interest
- h. Rent of Town Buildings
- i. Miscellaneous

to defray Town Charges. Town Charges to include, but not being limited to :

- a. Town Officers Salaries
- b. Town Officers Expenses
- c. Election & Registration Expenses
- d. Printing Town Report
- e. Expenses of Town Hall & Other Town Buildings
- f. Police
- g. Bounties
- h. Damages by Dogs
- i. Insurance
- j. Vital Statistics
- k. Old Age Assistance
- l. Town Poor
- m. Interest
- n. Cemeteries

Art. 3. To see what sum of money the Town will raise and appropriate, to be used together with the income referred to in article 2. above, to defray Town Charges.

Art. 4. To see what sum of money the Town will raise and appropriate, to be used together with and in addition to the sum of \$757.00 Class V Maintenance Allotment, for the summer maintenance of highways and bridges.

Art. 5. To see what sum of money the Town will raise and appropriate for the winter maintenance of highways and bridges.

Art. 6. To see if the Town will vote to raise and appropriate the sum of \$346.00 and apply for Class V assistance, T. R. A. so-called, the state to furnish \$2,309.00.

Art. 7. To see if the Town will vote to raise and appropriate the sum of \$500.00 to retire the note due Jan. 4, 1954 for building the State Aid Bates Bridge.

Art. 8. To see if the Town will vote to authorize the selectmen to apply for State Bridge Aid for the construction of a new bridge over Great Brook to replace the present Prentiss Covered Bridge, so-called; and if granted to make all contracts necessary and bind the Town to the payment of its share of the expense of such construction.

Art. 9. To see if the Town will vote to authorize the selectmen to borrow money, on long term notes of the Town, if necessary to pay for the Town's share of the cost of constructing the new bridge referred to in Art. 8.

Art. 10. To see if the Town will authorize the selectmen to sell or otherwise dispose of the so-called Prentiss Covered Bridge as an incident to the construction of the new bridge referred to in Art 8.

Art. 11. To see what sum of money the Town will raise and appropriate for a Prentiss Bridge Reserve Fund, said fund to be used to pay for part of the Town's share of the cost of constructing the new bridge referred to in Art. 8.

Art. 12. To see if the Town will vote to raise and appropriate the sum of \$200.00 for the control of White Pine Blister Rust.

Art. 13. To see what sum of money the Town will raise and appropriate for the support of the Fire Department, and for the purchase of fire fighting equipment; and authorize the selectmen to pay over said sum to the Fire Department.

Art. 14. To see what sum of money the Town will raise and appropriate for Fire Protection.

Art. 15 To see what sum of money the Town will raise and appropriate to reduce the principal amount of the note incurred for the purchase of the Fire Truck.

Art. 16. To see if the Town will vote to raise and appropriate the sum of \$50.00 for the observance of Memorial Day.

Art. 17. To see if the Town will vote to raise and appropriate the sum of \$150.00 for the Town Library.

Art. 18. To see if the Town will vote to raise and appropriate the sum of \$50.00 for the privilege of the use for one year of the Alstead Public Dump.

Art. 19. To see if the Town will authorize the imposition of a fine of 50 cents per month for the delinquent payment of dog licenses.

Art. 20. To see what sum of money the Town will raise and appropriate for the repair of the South Cemetery Fence.

Art. 21. To see if the Town will vote to allow the selectmen, collector of taxes and town treasurer additional compensation for their services in assessing, collecting and receiving and paying out the State Head Tax, and to fix the amount thereof.

Art. 22. To see if the Town will authorize the selectmen to sell, lease, mortgage and in all ways deal with and convey any or complete title to any land or land rights acquired by the Town by a tax collector's deed.

Art. 23. To see if the Town will authorize the selectmen : to have mimeographed lists made of all the taxable property in town with the assessed value thereof for the year 1952 ; to distribute one copy to each resident property owner ; and to pay for the expense of same as a Town Charge.

Art. 24. To see if the Town will vote to accept all Trust Funds of \$100.00 or more, each, received for the perpetual care of cemetery lots.

Art. 25. To see if the Town will vote to authorize the selectmen to borrow money in anticipation of taxes.

Art. 26. To transact any other business that may legally come before said meeting.

Art. 27. To allow accounts.

REPORT OF THE AUDITOR

This is to certify that the accounts and records of all officials of the Town of Langdon charged with the custody, receipt, and disbursement of public funds were examined and audited. Vouchers and cancelled checks were compared with supporting invoices and payrolls, as well as the entries in the book of records. Receipts were checked by source insofar as possible and totals of receipts and expenditures verified. All records are correct to the best of my knowledge.

However there is, in the opinion of the undersigned, a discrepancy in the accounting regarding the fire services. The balance of the Fire Department appropriation was not paid to or on behalf of the Fire Department, and the Fire Department account is mixed up with the Forest Fire account.

FIRE DEPARTMENT

The fire Department held two drills per month from April through November.

Two organizational meetings were held. At one held on July fifteenth, George B. Porter was elected President; Royal B. Holmes, Vice President; Bernard Matthews, Secretary; Chester Mason, Treasurer. A committee was appointed to work up a Constitution and By-laws. This committee met and drew up some recommendations which were presented at a meeting held on August twenty-first. One of the basic provisions was adopted at this meeting requiring that voting privileges for active members should be confined to those who attended 50 percent of the drills. Associate members could attend meetings, take part in the proceedings, but not vote.

100 feet of 2½ inch hose was presented to the Department in July.

Two of the boys attended the State Fire School held in Laconia.

Of the \$500.00 appropriated by the Town at the 1952 meeting, \$266.84 was paid in on the fire truck and \$50.00 was paid to the Department Treasurer, leaving an unexpended balance of \$183.16 in the hands of the Selectmen.

Of the \$50.00 paid to the Treasurer, \$17.00 was paid out for the fire school, \$3.00 was taken in for fire pump service from Leon Whitton. Leaving a balance in the hands of the Treasurer of \$36.00. There is an outstanding garage bill of about \$12.00.

SUPERINTENDENT'S REPORT

To the School Board and Citizens of Langdon, I herewith submit my first annual report as Superintendent of Schools:

The school building and furniture were repaired during the summer. The roof over the front entrance received attention, and the front of the building, which was badly discolored, was painted. The cellar was thoroughly cleaned. Eight new "aeroplane" type desks and sixteen chairs were purchased for the primary room. These have proved most satisfactory. Eight movable type desks were also purchased for the intermediate room as well as a new desk for each teacher.

The blackboards were painted green, and this has added to the attractiveness of the rooms, as well as making it easier on the eyes when children are reading or doing work.

An entering class of fourteen made it necessary to move the fourth grade into the intermediate room. From the present estimate of ten new first graders next year, it appears that this condition will continue until enrollment figures justify another change.

It is gratifying to observe children so interested in their school work as evidenced by the displays which appear in the rooms, and their complete oblivion to the audience during performances in recognition of special holidays. Special mention should be made of the prizes won in competition at the Alstead Fair. It would be an excellent addition to our school program if we could offer a more thorough music program. A music supervisor who could also offer private lessons is needed.

I have enjoyed working with the teachers, school board and parents in Langdon during the few months I have been with you. The efforts of adult organizations to raise funds to provide "extras" indicate your willingness to work with and support the elected representatives in carrying out their duties. I wish to express my sincere thanks for your cooperation, and I hope I may help you in your efforts to provide even better educational opportunities to the boys and girls.

SCHOOL NURSE'S REPORT

Healthy development of the child is of basic importance. Good health is essential to effective living. What better place than the school to teach "GOOD HEALTH HABITS?" Good health is an important goal of education.

Your school nurse has been privileged with the opportunity to continue to improve the health of your school child. The methods used are not new. A yearly inspection is done. This includes weight and height. An inspection of posture, skin, hair, teeth and throat are also a part of the routine. Your child's vision is tested by means of the Massachusetts Vision Testing Machine. Hearing is tested individually by means of the audiometer. Hearing is done about every other year as the testing apparatus is loaned by the State Board of Education. As time permits, your nurse visits the classrooms and has discussions with the children on different phases of the health problems.

Now to explain what happens following the inspection. A "Notice to Parents" is sent home by the school nurse. What is on this notice? The defects observed by your nurse are sent to you for your consideration. You may request the assistance of the nurse, check that you will consult your family doctor or family dentist. Home visits are made by the nurse where it is necessary: to discuss the plan to be taken; to discuss health problems; to give suggestions in the care of the sick child as needed.

A health record is kept on your child so that the nurse, teachers, principal and superintendent may have access to the health progress of each child. Should parents wish to discuss this record, they may consult the nurse at their convenience. A close relationship between local, state, social and health agencies is gratefully appreciated. There is a full cooperation with the State Board of Education, State Health Department and State Department of Public Welfare. Thus through the cooperation of "ALL OF US," our endeavor will be to keep the school child healthy in mind and body.
