TOWN WARRANT

To the Inhabitants of the Town of Nelson in the County of Cheshire in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at Town Hall in said Nelson on Tuesday, the 14th day of March, next, at nine of the clock in the forenoon, to act upon the following subjects:

1. To choose all necessary Town Officers for the year ensuing.
2. To raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriations of the same.
3. To see what sum of money the town will raise and appropriate for repairing highways and bridges, or take any action in relation thereto.
4. To see if the town will vote to raise and appropriate the sum of \$150.57 for the construction of Class V highway, the state to contribute \$602.26.
5. To see if the town will raise and appropriate money to Calcium Chloride Class V highways, or take any action in relation thereto.
6. To see if the town will vote to raise and appropriate the sum of \$38.00 (1/100 of 1% of the valuation) to the Monadnock Region Association of Southern New Hampshire.
7. To see what sum of money the town will raise and appropriate for Memorial Day.
8. To see what sum of money the town will raise and appropriate for Old Home Day.

9. To see what sum of money the town will raise and appropriate for the support of the Library.

10. To see if the town will raise and appropriate money for the improvement of the well in the common of Nelson village or take any action in relation thereto.

11. To see if the town will give the selectmen the right to borrow money in anticipation of taxes.

12. To transact any other business which may legally come before this meeting.

The present crisis in world affairs has created an emergency in the education of American youth that requires immediate attention and action. Large numbers of pupils and teachers are now leaving school to go to work. The motives which impel youth to leave school for work are understandable. The alarming response to these motives of high wages and the desire to do something definite to help win the war has been made in many cases without giving ample thought to other considerations which are of far greater importance to the national welfare. All adults concerned in these matters—particularly employers, school officials, and parents—should make sure that all youths clearly understand certain basic conclusions before making the decision to leave school.

“Twenty-seven million citizens of the decade beginning 1950 are being prepared in our public schools now for the world that is being shaped with so much ‘toil and blood and tears.’ How futile our every war effort if these citizens are not fitted for their places!”

This great challenge to our educational system must be met in spite of the innumerable demands on limited time, energy, and materials resulting from the war emergency.
