She was an active member of the Epsom Baptist Church and had served as the Sunday School teacher for more than 30 years. She also had been Sunday School superintendent, a Pioneer Girl Guide and committee chairman, and a member of the church choir.

She was also a member of the McClary Grange, Epsom, and a member of the Epsom Band.

TOWN WARRANT
The State of New Hampshire

To the Inhabitants of the Town of Epsom in the County of Merrimack in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at Town Hall in said Epsom on Tuesday, the 6th day of March, next at ten of the clock in the forenoon, to act upon the following subjects:

1. To choose all necessary Town Officers for the year ensuing.

2. To see what action the Town will take upon the Budget submitted by the Budget Committee.

3. To see if the Town will raise and appropriate the sum of \$902.15 for the maintenance, construction, or reconstruction of Class V Highways, the State to contribute \$6,014.34 as provided in Chapter 83 Laws of 1953.

4. To see if the Town will vote to authorize the Selectmen to borrow such sums of money as may be necessary in anticipation of taxes.

5. Pursuant to the Provisions of the Laws as revised, Chapter 292, Section 7, 1949. The following Article is submitted: Shall the Provisions of Chapter 171-A of the revised Laws relative to playing games of Beano be adopted in this Town?

6. To see if the Town will vote to raise and appropriate the sum of \$585.00 for the Concord Hospital to help offset the estimated deficit for the year 1971. (Recommended in the Budget)

7. To see if the Town will vote to raise and appropriate the sum of \$2,300.00 for the Barnstead Ambulance Fund. (Recommended in the Budget)

8. To see if the Town will vote to raise and appropriate the sum of \$4,000.00 to be put in a Capital Reserve Fund in anticipation of improvements to Knowles' Bridge.

9. To see if the Town will vote to raise and appropriate the sum of \$5,000.00 to be put in the Capital Reserve Fund for the purpose of a Town Dump (Sanitary Land Fill Project, or an incinerator.) (Recommended in the Budget)

10. To see if the Town will vote to accept the following Trust Funds, the interest only to be used for the care of family lots in Epsom Cemeteries:

Edward B. Demers Fund	\$200.00
Ethel I. Warren Fund	200.00
James & Aaron Osborne Fund	200.00
Fred W. Yeaton Fund	200.00
True & Ethel Kelley Fund	200.00
Elmore & Orville Bickford Fund	200.00

11. To see if the Town will vote to reopen that portion of the Mt. Road from the residence of Edwin Martell to the residence of Garfield Hyde. (approximately 1/10 of a mile)

12. To appropriate a sum for the Town's share of operation of the Central N. H. Regional Planning Commission.

To see if the Town will vote to appropriate the sum of \$974.00 as the Town's share for the studies and operation of the Central N. H. Regional Planning Commission. These funds will be used for financing the staff, operation expenses, planning studies, technical assistance and

other programs of the Commission. These funds may be used in conjunction with other State and Federal funds available for planning purposes.

13. That the Regional Refuse Disposal Planning Committee, in Conjunction with other Towns represented on the Regional Refuse Disposal Planning Board, work out a detailed proposal to resolve the Town's Solid Waste Management problems and to undertake such analysis, negotiations, and determination of costs, as may be necessary to implement the proposed solution and to present these to the Selectmen for action at a Town Meeting, and to appropriate \$440.00 at a rate of 30¢ per capita as the Town's share of costs of the Regional Refuse Disposal Planning Board, conditional upon the terms set forth in the Board's proposed bylaws.

14. To see what salaries the Town will vote to pay the Town Officers: (\$3,500.00 recommended in the Budget)

15. To see if the Town will vote to authorize and empower the Planning Board to approve or disapprove, in its discretion, plats showing streets, or the widening thereof, or parks and to regulate subdivisions of land within the Town in accordance with the provisions of Chapter 36, N. H. Revised Statutes Annotated, 1955, as amended.

16. To see if the Town will vote to authorize the withdrawal from the Revenue Sharing Funds established under the provisions of the State and Local Assistance Act of 1972 for use as set-offs against budgeted appropriations for the following priority purposes and in amounts indicated or take any other action hereon:

17. To see if the town will vote to amend the zoning regulations (article III F 1) to meet the following problem:

When and if an Epsom resident or couple reach retirement age and have been a substantial taxpayer and long term resident (10 years or more), find themselves unable or it is unwise to continue their present responsibilities because of health or financial reasons, they may set aside a small tract of land, one acre or more, on which a mobile home can be placed for dwelling purposes. When it is no longer needed by the requesting individuals, it must be removed to be replaced by a conventional structure or remain an open lot. (By Petition)

18. To transact any other business that may legally be brought before this meeting. (Polls will not close until after the the Business Meeting.)

REPORT OF THE FOREST FIRE WARDEN AND DISTRICT CHIEF

In New Hampshire, forest fire control is a cooperative State-town program. The Town Forest Fire Warden, appointed by the Director, Division of Resources Development upon recommendation of the Selectmen and the State's District Forest Fire Chief is responsible for fire suppression and other related duties. The State shares equally with the town in the cost of most forest fires, except illegal and careless fires, which are charged to the responsible party. The State further provides fire detection services, prevention programs, fire training for town wardens and crews, and back-up equipment for fire suppression.

By authority of the State, the Town Forest Fire Warden controls all outside burning in his town except backyard cooking fires. Any person wishing to kindle a fire when the ground is not covered with snow must obtain a fire permit, free of cost, from the Town Forest Fire Warden. No permits will be issued for fires between 9:00 A. M. and 5:00 P. M. unless it is raining, except for commercial purposes.

Please be careful when using fire, remember it can be an extremely useful tool when under control but once allowed to run wild it can become a disastrous and devastating force. Only you can prevent a forest fire.

DISPOSAL PLANNING COMMITTEE

The Advisory Committee authorized at the last Town Meeting and appointed by the Moderator has met with the Central N. H. Regional Planning Commission through the summer and fall, reviewed technical studies on various means of waste disposal; reviewed State air pollution control requirements; and evaluated alternate plans to help Epsom upgrade our solid waste disposal practices.

We have concluded that:

- A. our present dump operation must be upgraded to meet State requirements by July 1, 1975;
- B. that a sanitary landfill procedure offers the best method of disposal at least cost for the foreseeable future; that the number of potential sites, however, is limited and require detailed analysis and community discussion before they can be recommended as acceptable;
- C. that there appears to be significant savings if towns can work toward a joint solution, but that exact costs cannot be determined until further studies are completed;
- D. that there is significant interest in at least eleven other municipalities in working toward joint resolution of the problem. This is evidenced by the agreement and action of the towns to form a Regional Refuse Disposal Planning Board as provided under State law.

It is recommended that the Town take the following action at the 1973 Town Meeting:

1. Direct the Committee in conjunction with other towns represented on the Regional Refuse Disposal Planning Board to —

- A. work out a detailed proposal to resolve the Town's solid waste management problems or to report why such a joint action is not advisable, and
 - B. Undertake such analysis, negotiations, and determination of costs for initial and continuing operations, and to draft the proper legal documents and organization procedures necessary to implement the proposed solution and to present these to the Selectmen for action at a Town Meeting.
2. Appropriate \$440.00 at a rate of thirty cents per capita as the Town's share of costs of the Regional Refuse Disposal Planning Board to undertake its work, conditional upon the terms set forth in the Board's proposed by-laws.

SUPERINTENDENT'S REPORT

Today's schools are indeed becoming more and more complex. We see evidence of this here in Epsom. The job of the teacher is ever more demanding and one that requires constant re-evaluation in terms of today's curriculum.

We now find the school curriculum has become everybody's business. Inside and outside education, there are forces that propose changes in our schools.

Some call for a return to "basic education," while still others want more emphasis on "creativity" and "individualized instruction." This is the dilemma facing your School Board.

At our town level, we realize that the curriculum is affected by the availability of materials, physical facilities, and community demands, including financial resources.

Teaching techniques previously have been geared toward drill and repetition. Today we find the stress on developing understanding and overall content, rather than studying isolated factual material.

There is great need to adjust the curriculum to the needs of the times. We might very well find in the near future, full-time teachers working on developing the curriculum when students are not in attendance.

Libraries or media centers will need to receive a high priority in our town budget if standards are to be maintained. Title II of the Elementary and Secondary Act of 1965 has helped us some but much more local effort is needed in the years to come.

We need and hopefully will see much stress in the future on Vocational Education. A school program is certainly needed that will enable every young person completing Grade 12 to be ready to enter higher education or to enter useful and rewarding employment. We are really talking about the capacity of our people to sustain and accelerate the pace of progress in this country during a lifetime of learning.

I appreciate the cooperation of the School Board and the community in our educational endeavors.

SCHOOL HEALTH REPORT

Epsom, New Hampshire

1971 - 1972

To the Superintendent:

The health program for the year 1971-1972 was carried out in the usual manner with an annual physical inspection of each student by the nurse. When defects were noted, the appropriate referral and follow-up were made.

The students received the benefit of preventive dental care through classroom visits by a hygienist sponsored by the N. H. Bureau of Dental Public Health. One hundred and ninety-nine children responded to the cleaning and fluoride clinic held during the fall months.

The Heaf Test was offered to all school personnel and to the incoming first grade students. A total of 72 tests were administered. Immunization clinics were sponsored by the Epsom P.T.O. during the months of March, April and May. A total of 114 doses of vaccine were given by Dr. Patrick Kelly, Pittsfield, N. H. Forty-four children were registered for school entry at a pre-school clinic in May. First aid was administered to approximately 106 students, 11 home visits were made, 17 ill students transported home and 5 students were taken to clinics or medical appointments. Eight faculty members completed the Red Cross Multi-Media First Aid Course taught by the school nurse. Two students were evaluated for possible learning disabilities at the Manchester Rehabilitation Center.

During the 1971 legislative session the following health requirements were passed.

“All children shall be immunized prior to school entrance according to the current recommendations of the

State Health Agency." The immunizations listed below must be completed prior to school entry.

1. Measles Vaccine — regular (Having had measles is acceptable when verified)
2. Oral Trivalent Polio Vaccine (Sabin)
3. Diphtheria, Pertussis and Tetanus (D.P.T.)
4. Rubella (German Measles) Vaccine

All children shall be examined prior to school entrance to detect symptoms of Tuberculosis. All children shall have a routine physical examination by a physician before school entry. At the March 1972 meeting, the Epsom School Board adopted the above policy relative to Immunization Requirements and Examinations for school entrants as required by state law.
