MINUTES OF TOWN MEETING — MARCH 13, 1984

Article 1 - The Annual Town Meeting was called to order at 10 A.M. by the Moderator, Richard L. Russman, for the balloting for Town Officers and the Officers of the Sanborn Regional School District. It was voted to adjourn the meeting, after the close of the counting of ballots, until 12 Noon Saturday, to take up the remaining articles of the warrant; the continued meeting to be held at the Swasey Gymnasium.

The Town Clerk, Bettie C. Ouellette, broke the seals on the boxes of ballots, and the Moderator inspected the voting booths and the ballot boxes. The Moderator also announced that the Absentee Ballots would be processed at 3 P.M. The Assistant Moderator was George H. Harmon, and the Ballot Clerks were Holly Ouellette, Carolyn Christie, Rochelle Lafontaine, Esther Greenwood and Barbara Comeau. Peter Basler was the Police Officer and extra counters at night were Judith Smith, Marilyn Bartlett, Electra Alessio and David Conant. Selectmen were John J. Reinfuss and Bernard E. Robie.

**MINUTES OF CONTINUED TOWN MEETING AT
SWASEY GYMNASIUM
March 17, 1984**

Meeting was called to order at 12 Noon by the Moderator, Richard L. Russman. Prayer was offered by Rev. Wendell J. Irvine, First Congregational Church. The Moderator introduced the Selectmen: Chairman Michael R. Priore, John J. Reinfuss and Bernard E. Robie, and the Town Clerk, Bettie C. Ouellette. He welcomed everyone, including the new voters. The Moderator did not read the results of the balloting from the past Tuesday as everyone had seen them in the local newspaper. He announced the appointment of the following people to the Finance Committee: Phyllis Buckley, Bruce Sloan, David Welch and Carroll Wright. He thanked the four people leaving the committee - Donald Day, Edward Howard, Jr., Richard Dever and David Conant.

Article 2 - A motion was made and seconded to raise and appropriate \$888,833.58 to defray Town charges for the ensuing year. An amendment was made by Charles Hannagan and seconded to reduce the budget by \$19,730.00 on nine items. This amendment was later withdrawn, and a new amendment was made by Charles Hannagan, and seconded, to change the total figure to \$876,300.83, meaning a reduction of \$12,532.75. After much discussion, this amendment was defeated on a voice vote. This followed a vote to "move the question", made by Norman Bower. Then upon returning to the original motion, a new amendment was made by George Korn, and seconded, to follow the recommendations of the Finance Committee and reduce the budget by \$6,500.00 on the following items: Planning & Zoning \$1,000.; Police Dept. \$1,000.; Recreation Commission - increase \$500.; and Debt Service \$5,000. It was voted, by voice vote, to reduce the budget by \$6,500., and therefore, the corrected amount of \$882,333.58 was passed. During the discussion on this first article, there was a question as to whether the meeting was legal in that the posted copies of the Warrant did not bear the Town seal. Frank Murphy made a motion to adjourn the meeting, and this was ruled out of order. The Moderator ruled that it was a legal meeting as the original Warrant was properly sealed.

Article 3 - It was voted, by voice vote, to authorize the Selectmen and Town Treasurer to borrow such sums of money in anticipation of the collection of taxes for the current year and to issue in the name of the Town, negotiable notes, the aforesaid notes to be paid during the current year from taxes collected during the year.

Article 4 - It was voted, by voice vote, to appropriate and authorize the withdrawal of the sum of \$2,500.00 from the Revenue Sharing Fund, established under the provisions of the State and Local Assistance Act of 1972. Said money to be used for the purchase of a new copy machine for the Town Clerk's Office. Said machine would be an updated model and the old machine would be traded in or sold.

Article 5 - It was voted, by voice vote, to authorize the appointment of a Deputy Tax Collector. Said appointment to be made by the Tax Collector with the approval of the Selectmen, per RSA 41:38.

Article 6 - It was voted, by voice vote, to authorize the Tax Collector to allow a deduction of 1 1/2% from Town Property Tax when payment is made within 30 days of billing.

Article 7 - It was voted, by voice vote, to authorize the Board of Selectmen to apply for, accept and expend, without further action by the Town Meeting, money from the State, Federal or other Governmental unit or a private source which becomes available during the fiscal year to be used only for legal purposes for which a Town may appropriate money. The Selectmen shall hold a prior public hearing on the action to be taken and such action shall not require the expenditure of other Town funds and shall be exempt from all provisions of RSA 32 relative to limitation and expenditure of Town Monies.

Article 8 - It was voted, as amended, by voice vote, to raise and appropriate the sum of \$15,273.30 for salary increases. A maximum of \$10,909.50 is to be expended for a 5% general increase for Town employees, excluding Selectmen, with \$4,363.80 (approximately 2%) to be held in escrow until a wage matrix has been adopted by the Selectmen in accordance with the procedures set forth in the personnel policy, and

that this Wage Matrix be implemented within 90 days. The last part of the article was an amendment made by Harry Carr and it was passed by voice vote.

Article 9 - It was voted, by voice vote, to appropriate and authorize the withdrawal of the sum of \$1,700.00 from the Revenue Sharing Fund, established under the provisions of the State and Local Assistance Act of 1972, for the purchase of office equipment for the Selectmen's Office and Town Clerk/Tax Collector's Office.

Article 10 - It was voted, by voice vote, to appropriate and authorize the withdrawal of the sum of \$2,500.00 from the Revenue Sharing Fund, established under the provisions of the State and Local Assistance Act of 1972, for the purchase of a new chain saw, portable air operating grease gun with drum and two overhead, motor operating door closers for the Town garage.

Article 11 - It was voted, by voice vote, to appropriate and authorize the withdrawal of the sum of \$3,500.00 from the Revenue Sharing Fund, established under the provisions of the State and Local Assistance Act of 1972, for the purpose of reconstruction of a crossover from Route 111 at Main Street West and Church Street. Said monies to be supplemented by a \$7,000.00 matching grant from the State of N. H.

Article 12 - It was voted, by voice vote, to appropriate and authorize the withdrawal of the sum of \$20,000.00 from the Revenue Sharing Fund, established under the provisions of the State and Local Assistance Act of 1972. Said monies to be placed in a Capital Reserve Fund for the purpose of revaluation of the Town.

Article 13 - It was voted, by voice vote, to raise and appropriate the sum of \$3,109.40 for dues to Rockingham Planning Commission for services in regional planning and local technical assistance.

Article 14 - It was voted, by voice vote, to raise and appropriate the sum of \$1,536.00 to assist Rockingham County Community Action Program, Inc. These funds are to

be used for current operating expenses to enable Rockingham County Community Action Program, Inc. to continue providing services to residents of the Town of Kingston at no cost to said residents.

Article 15 - It was voted, by voice vote, to raise and appropriate the sum of \$1,250.00 to support the services of the Newmarket Health Center, Inc. These funds are to be used for providing transportation to the elderly and handicapped. The Newmarket Regional Health Center also provides primary health and social services, including the Health Center's Prenatal Program. These services are available to Kingston residents at the Lamprey River Clinic in Raymond.

Article 16 - It was voted, by voice vote, to raise and appropriate the sum of \$1,272.00 to assist Rockingham Child & Family Services, a private, non-profit organization. The amount of this request is based on services rendered to 32 residents of Kingston during the period 7/1/82 to 6/30/83, inclusive. These residents used \$6,580.00 worth of services however, only \$3,366.00 was received. These funds to be used for current operating expenses to enable Rockingham County & Family Services to continue providing individual and family counseling for residents of Kingston whether or not said residents are able to pay.

Article 17 - It was voted, by voice vote, to raise and appropriate the sum of \$5,108.00 for the support of the Exeter Area Visiting Nurse Association, Inc.

Article 18 - It was voted, by voice vote, to raise and appropriate the sum of \$2,000.00 for the support of the Seacoast Regional Mental Health Center, Inc. These funds to be used to provide services to residents of Kingston whether or not said residents are able to pay.

Article 19 - This article relative to raising and appropriating \$795.00 on behalf of Seacoast Big Brother/Big Sister of N.H., was NOT passed, by voice vote.

Article 20 - This article relative to an increase in the salary of the part-time secretary for the Police and Fire Departments was withdrawn by Jean M. Spinella, petitioner.

Article 21 - It was voted, by voice vote, to raise and appropriate the sum of \$5,000.00 to be placed in a capital reserve for the purchase of a recreation building.

Article 22 - It was voted, by voice vote, to raise and appropriate the sum of \$2,000.00 for a parade and band concert to celebrate the Fourth of July.

Article 23 - It was voted, by voice vote, to raise and appropriate the sum of \$160.00 for the purchase and installation of four signs to be placed in such a manner to identify the approximate limits of what is commonly referred to as the "Main Street Historic District".

Article 24 - It was voted, by voice vote, to raise and appropriate the sum of \$1,500.00 to purchase a portable type PA system in the Town Hall.

Article 25 - It was voted, by voice vote, to establish a General Reserve Fund for the cemetery maintenance in the amount of \$28,168.54 by transferring that sum from the funds now held by the Trustees of Trust Funds which have accumulated in the past from the sale of cemetery lots, the sale of timber from cemetery land and a Greenwood Cemetery Fund acquired by the Town in 1956, in order to conform with current State law. Additions to this fund may be made by vote of the Town. The Fund shall be administered by the Trustees of Trust Funds with interest only to be used at their discretion for general cemetery maintenance and improvements.

Article 26 - It was voted, as amended, by voice vote, to raise and appropriate \$20,000.00 to be added to the Capital Reserve Fund for the future replacement of Fire Apparatus. A committee is being formed to study this new truck. The amendment which was made by Gordon Bakie, was voted by voice vote. This amendment substituted the words "Fire Apparatus" for "Engine No. 2, 1968 Chevrolet".

Article 27 - It was voted, by voice vote, to withdraw from the general fund the sum of \$625.00 and to place said monies into a Capital Reserve Fund for the future replacement of the

ambulance. (RSA 35:11) These monies represent the portion of 1983 revenues derived from the use of the ambulance, not previously remitted to the Capital Reserve Fund.

Article 28 - It was voted, by voice vote, to appropriate and authorize the withdrawal of \$500.00 from the Revenue Sharing Fund, established under the provisions of the State and Local Assistance Act of 1972. Said money to be used for the purchase of two file cabinets with locks.

Article 29 - It was voted, by voice vote, to raise and appropriate the sum of not more than \$200.00 for the installation and maintenance of outdoor lighting for the purpose of skating at the corner of Church & Chase Streets.

Article 30 - It was voted, as amended, by voice vote, to raise and appropriate the sum of \$5,000.00 as a capital reserve fund for the replacement of the old cruiser for 1985, and the Board of Selectmen shall, within 45 days, auction to the highest bidder the old cruiser which was replaced in 1982, as surplus equipment. This amendment was made by Donald Eadie and he deleted a sentence from the first motion in order to comply with a ruling from the Dept. of Revenue Administration relative to Capital Reserve Funds. The wording above is exactly the way it was voted.

The Moderator declared a 10 minute recess.

Article 31 - This article relative to a portable alarm system for the Police Dept. was withdrawn by Chief Parker.

Article 32 - It was voted, by voice vote, to authorize the Selectmen to apply for, receive and expend a sum of \$10,000.00 for radar patrol if available or awarded under the State of N.H. Highway Safety program as 100% State funded.

Article 33 - It was voted, by voice vote, to raise and appropriate the sum of \$1,400.00 to replace 4 channel mobile radio with an 8 channel mobile radio. This will be State bid price.

Article 34 - It was voted, by voice vote, to raise and appropriate the sum of \$1,400.00 for one portable radio. This will be State bid price.

Article 35 - It was voted, by voice vote, to raise and appropriate \$800.00 for a computer desk and accessories, chair and desk for the Secretary. (This wording was changed from the original petition which asked for \$1,700.00.)

Article 36 - This article relative to authorizing a third full-time Police Officer was withdrawn by Chief Parker.

Article 37 - It was voted to authorize the Selectmen to increase the hourly wage of part-time Police Officers by 25 cents an hour after 5 years' service and 25 cents an hour after 10 years' service to recognize their years of service to the Town; the cost of this article would be \$1,000.00.

Article 38 - This article relative to an increase in pay for the part-time Police Officers and the Secretary, was withdrawn by Chief Parker.

Article 39 - This article relative to an increase in pay for the Deputy Police Chief was withdrawn by Norman Bower.

Article 40 - This article relative to an increase in pay for the Police Chief was withdrawn by Chief Parker.

Article 41 - This article relative to installing an elevator in the Town Hall was NOT passed, by voice vote.

Article 42 - It was voted, by voice vote, to raise and appropriate a sum not to exceed \$8,000.00 for the installation of a ramp on the outside staircase for the use of handicapped people. At present there is no access to the main floor of the Town Hall for the handicapped. During the discussion on the article, the Moderator instructed the Town Clerk to make proper note that the intention of the voters was to get handicapped from the ground into the main hall upstairs.

Article 43 - It was voted, by voice vote, to raise and appropriate \$2,100.00 for the purchase of an industrial range for the kitchen of the Town Hall and the electrical line needed to support it.

Article 44 - This article relative to installing restrooms for the handicapped on the main floor of the Town Hall was NOT passed, by voice vote.

Article 45 - This article relative to a cost of living increase for all town employees was withdrawn by Bettie Ouellette.

Article 46 - It was voted, by voice vote, to approve the transfer of any balance remaining at year end in the Kingston Conservation Commission budget to the Conservation Fund as established under RSA 36A-5, to include the balance of 1983 KCC budget funds.

Article 47 - It was voted to adopt the following Ordinance: Relative to approval of plans for septic systems and wells in the Town of Kingston on building lots in the Town of Kingston. (This was a voice vote.)

The Town of Kingston adopts the following Ordinance pursuant to the provisions of N. H. RSA 41:8 and N. H. RSA 149-E:5 III and N. H. RSA 149-E:6 to regulate the installation and construction of wells and septic systems on building lots in the Town of Kingston.

All plans for installation of wells and septic systems on building lots in the Town of Kingston shall be submitted to the Board of Selectmen for the Town for approval before the submission of such plans to the State of N.H. Water Supply/ & Pollution Control Commission for State approval pursuant to the provisions of 149-E. The approval of such plans shall not be unreasonably withheld by the Town.

Article 48 - This article relative to adopting an Ordinance regulating the use of Town Roads and Highways was NOT passed, by voice vote. An amendment made by Donald Eadie was voted, by voice vote, as follows: "If this article does not pass the Selectmen of the Town of Kingston shall be prohibited from enacting this or any similar ordinance without prior approval of Town Meeting." When the Moderator returned to

the main motion, as amended, the article was defeated. The vote was taken after a motion made by Steven Smith "to move the question" was passed by a voice vote. A motion made by Alan Nadeau to add word "not" to read "not to adopt the Ordinance", was ruled out of order by the Moderator.

Article 49 - This article relative to adopting an Ordinance governing rules and regulations for repairing, replacing and installation of new or existing sewerage disposal systems was NOT passed., by voice vote. There were 2 changes made to the original article by Charles Hannagan, and these were voted in the affirmative, but had no effect when the main motion was defeated. This amendment added the words "Board of Selectmen" in paragraph 2, after the word "Health Officer," and in paragraph 3, changed the word "Health Officer" to "Town of Kingston." The vote on this amendment came after a motion "to move the question," made by Edward Ahlman, was passed. Upon returning to the discussion on the main motion, the vote was taken after a motion "to move the question," made by Norman Bower, was passed.

Article 50 - This article relative to calling a Special Session of Legislature for the sole purpose of preventing the imposition of high cost increases in electric rates resulting from the Seabrook Nuclear Power Plant on the citizens, businesses, schools and agencies in Kingston, was NOT passed, by voice vote.

Article 51 - The Moderator advised the voters that this Article is unlawful, upon the advice of Town Counsel. He also explained to the voters that this is their meeting and it is up to them what they want to do on the article. A motion was then made by Alan Nadeau to adopt the article as read - "To see if the Town of Kingston will vote to eliminate the elected office of Fireward and divide the duties of the office between Selectmen and Fire Chief." It was seconded and a lot of discussion followed. It was voted on a motion made by Carroll Wright, "to move the question", whereupon the Moderator announced this would be a secret ballot since he had already received a petition to do so. It was then voted to adjourn after the results of the secret ballot were announced, until Tuesday Night at 7 P.M. at the Swasey Gymnasium. The Moderator, Richard L.

Russman, could not remain for a longer period of time for this meeting, and William S. Bartlett, Jr., was appointed Moderator pro-tempore, for the remainder of the meeting. The results of the secret ballot were announced by the Acting Moderator, as follows: Yes 60; No 106; Invalid 5. Total votes cast 171.

The meeting was adjourned at 5:45 P.M.

**MINUTES OF CONTINUED TOWN MEETING
MARCH 20, 1984**

This meeting was called to order at the Swasey Gymnasium at 7 P.M. by the Moderator, Richard L. Russman.

Article 52 - This article relative to authorizing the Fire Chief to send fire apparatus out of Town and receive fire apparatus from other Towns on a donated basis, was NOT passed on a voice vote. An amendment made by Michael Priore to change "Fire Chief" to "Fire Dept.", was seconded, but it did NOT pass. A motion made by Donald Briggs, Sr., to table the Article was defeated. When the voice vote was uncertain, the Moderator called for a show of hands, and it was still uncertain. He then appointed the following tellers to count a standing vote: George Korn, Holly Ouellette, David Conant and Sheila Whittier. Results of the standing vote were: Yes 43, No 47.

Article 53 - This article was relative to the Town of Kingston accepting the By-Laws for the Kingston Fire Dept. The Moderator read a legal opinion from the Town Counsel on this article and the Moderator informed the voters that they were in the same spot as they had been on Article 51 at the previous meeting, in that the Town Counsel had ruled this article to also be illegal. The Moderator then asked the voters if they wished to pass over the article, and the vote was in the affirmative - by hand vote.

Article 54 - This article relative to pay increases for Town employees was withdrawn by the Petitioner, George A. Schiller, Jr.

Article 55 - It was voted, by voice vote, to appropriate and authorize the withdrawal of the sum of \$3,130.00 from the Revenue Sharing Fund, as established under the provisions of the State and Local Assistance Act of 1972, for the purchase of 10 Motorola Pocket Pagers, to be used by the Fire Dept.

Article 56 - This article relative to electing all full-time police officers beginning in 1985, was withdrawn by the Board of Selectmen.

Article 57 - It was voted, by voice vote, to authorize the Selectmen to sell tax deeded property at Public Auction.

Article 58 - A motion was made and seconded to accept the Auditor's Report and Town Report as printed, whereupon an amendment was made by Lynn Merrill to add "as corrected." This amendment was seconded but was NOT passed, by voice vote. Upon returning to the main motion, the article was NOT passed, by voice vote.

Article 59 - A motion was made and seconded to accept the Estate of Isabelle G. Magnusson, the gift of a piece of land on Route 111 containing 5.6 acres more or less. Said lot being registered with the Town under Map No. R34-66. Said piece of land to be used as a public park known as "Isabelle G. & Waldo M. Magnusson Memorial Park". If the Town votes to accept the land as a gift, the Town will bear the expense of transferring and recording such transaction. Then an amendment was made by William Bedal II, and seconded, to accept the gift to be known as the Isabelle G. & Waldo M. Magnusson Wildlife Preserve and that the Town put a little suitable marker there." Mr. Bedal pointed out that this area is zoned Single Family Residential - Agricultural. The vote was taken on the amendment after it was voted, by voice vote, on a motion made by David Conant "to move the question". The amendment was NOT passed. After further discussion on the main article, it was passed on a voice vote.

Article 60 - Under this article "to transact any other business tha may legally come before the meeting", the following Resolutions were introduced:

(1) Resolved, that it is the intention of the people of the Town of Kingston that the emergency vehicles purchased by the Town of Kingston for the use by the Police and Fire Departments of the Town of Kingston are solely for the use of the officers of those departments and those qualified members of each department designated by the respective department's officers. This Resolution was introduced by Donald Eadie and it was passed, after a motion by John Pizar "to move the question" had been passed.

(2) Harry Carr wanted it recorded that his Resolution

stated 10 A.M. last year. (This Resolution was recorded correctly by the Town Clerk in the 1983 minutes.)

(3) George Schiller, Jr. presented the following: "Be it resolved that the Finance Committee meet in public session with the Selectmen six months before the next Town Meeting and monthly thereafter for the purpose of establishing and carrying out a budget procedure and process. After much debate, the following "replacement" was introduced by Charles Hannagan: "The Budget Committee meet with the Selectmen in open public session at least two months in advance of Town Meeting and a full budget must be presented by Selectmen to the full Finance Committee no later than 30 days before the Annual Town Meeting." This amended Resolution was then passed, by voice vote.

(4) Gertrude McGlinchey introduced the following: "With reference to Article 43, may the funds received from the sale of the old stove be used for pots and pans for the Town Hall kitchen." This was passed, by voice vote.

(5) Warren Ames introduced the following: "Using the Town Hall for political meetings for a fee." This was NOT passed, by voice vote.

It was voted to adjourn the meeting at 8:17 P.M.

ARTICLE 1. To see if the Town will vote to authorize the Kingston Fire department to go to the aid of another city, town, village or fire district within or without the State, for the purpose of extinguishing fires therein subject to the rights, privileges and immunities set forth in New Hampshire RSA Chapter 154, section 25 through 29.

ARTICLE 2. To see if the Town will adopt the following ordinance pursuant to New Hampshire RSA 31:39 to promote the health, welfare and safety of the Inhabitants of the Town of Kingston:

**ORDINANCE
RULES AND REGULATIONS GOVERNING THE
REPLACEMENT AND INSTALLATION OF NEW OR
EXISTING SEWERAGE DISPOSAL SYSTEMS**

DEFINITIONS:

“Persons”: means any individual, partnership, corporation or other entity.

“Plans and Specifications”: mean any drawings, documents or plans upon which the design and construction of the proposed replacement or installation of the sewerage disposal system is to be based.

“Sewerage Disposal System”: means any septic tank, leachfield, dry well, any pipes, conduits, or other means of carrying away sewerage and waste matters, or any other equipment used in conjunction with any of the above and associated with the removal, disposal or carrying away of sewerage and other waste products.

1. Any person who intends to undertake any replacement of an existing sewerage disposal system, or who intends to install a new sewerage disposal system, shall first submit the plans and specifications for such work to the Town for its review and approval prior to the commencement of any construction.

2. Following the submission of the plans and specifications to the Town and its review and approval of such plans, the Health Officer shall inspect the site of the proposed installation to confirm compliance with applicable New Hampshire Statutes, Water Supply and Pollution Control Regulations and the Ordinances and Regulations of the Town of Kingston.

3. At the time of the submission of the plans and specifications to the Town, the person intending or desiring to undertake the work shall pay to the Town an inspection fee of \$25.00 for each sewerage disposal system to be replaced or installed.

4. The plans and specifications submitted to the Town for its review and approval must be prepared by a person holding a permit pursuant to New Hampshire RSA 149-E:x(a) and must be installed by a person approved by Water Supply and Pollution Control Commission as a sewerage disposal system installer pursuant to New Hampshire RSA 149-E:3-a, except for persons installing sewerage systems on their own land who meet the criteria of New Hampshire RSA 149-E:3x(b) and RSA 149-E:3-all.

5. If, following inspection by the Health Officer, the Health Officer finds that the construction to be undertaken conforms with requirements of this Ordinance, he shall issue written approval for the proposed construction.

6. After the Health Officer has issued written approval of the plans and specifications, no changes or additions may be made in said plans or specifications without a resubmission to the Health Officer and his subsequent written approval of the proposed changes.

7. Any person who violates any provisions of this Ordinance shall be subject to a fine of \$100.00 per day for each day the violation is found to exist.

8. This Ordinance shall be effective upon its adoption.

ARTICLE 3. To see whether or not the Town will authorize the Selectmen to lease the Town Hall to various political organizations in the Town of Kingston for the holding of political rallies and gatherings.

ARTICLE 4. To see if the Town will vote to adopt the following ordinance pursuant to New Hampshire RSA 31:39 to promote the health, welfare and safety of the Inhabitants of the Town of Kingston.

RULES AND REGULATIONS GOVERNING THE REPAIR OF SEWERAGE DISPOSAL SYSTEMS

1. Any person who intends to undertake any repair of an existing sewerage disposal system shall first submit an application for a permit to the Health Officer for his review and approval of such repair prior to the commencement of any construction.

2. The Health Officer shall inspect the site of the proposed repair to confirm compliance with applicable New Hampshire Statutes, Water Supply and Pollution Control Regulations and the ordinances and regulations of the Town of Kingston.

3. If, following inspection by the Health Officer, the health Officer finds that the repair to be undertaken conforms with the requirements of this ordinance, he shall issue written approval for the proposed repair.

4. After the Health Officer has issued written approval for the repair, no changes or additions may be made with regard to said repair without submitting a new application to the Health Officer and his subsequent written approval of the proposed additional repairs.

5. Any person who violates any provision of this ordinance shall be subject to a fine of \$100.00 per day for each day the violation is found to exist.

6. This ordinance shall be effective upon its adoption.

ARTICLE 5. To transact any other business that may legally come before the meeting.

He read from RSA 675:2 through 7, as well as 656:13, saying that he had received this information from the Secretary of State. Mr. Nason questioned why there had been no public hearing.) An amendment was made by Richard Russman, to change the fine under Section 7 to "\$10.00 per day for each day the violation is found to exist," instead of \$100.00 per day. This amendment was passed, by voice vote. However, upon returning to the original motion, as amended, the article was defeated. The Moderator was assisted by Warren Ames, Sr. and David Conant, for taking the hand count. It was very obviously defeated; so no exact numbers were recorded.

ARTICLE 3 — it was voted, by voice vote, to authorize the Selectmen to lease the Town Hall to various political organizations in the Town of Kingston for the holding of political rallies and gatherings. An amendment which was made by Charles Hannagan, "excluding fund raising events," was NOT passed by a voice vote. This vote on the amendment

was taken after a motion made by Richard Russman “to move the question,” was passed.

ARTICLE 4 — This article relative to adopting an Ordinance governing the repair of sewerage disposal systems was NOT passed, by voice vote.

ARTICLE 5 — It was voted, by voice vote, to adjourn the meeting, at 8:00 P.M.

To the inhabitants of the Town of Kingston in the County of Rockingham in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at the Town Hall in said Kingston on Tuesday, the twelfth day of March, next at 10 of the clock in the forenoon to act upon the following subjects:

1. To chose all necessary Town Officers for the year ensuing.

2. To raise such sums of money as may be necessary to defray Town charges for the ensuing year and make appropriations of the same.

3. To see if the Town will vote to authorize the Selectmen and Town Treasurer to borrow such sums of money in anticipation of the collection of taxes for the current year and to issue in the name of the Town, negotiable notes, the aforesaid notes to be paid during the current year from taxes collected during the year.

4. To see if the Town will vote to authorize the Tax Collector to allow a deduction of 1½% from Town Property Tax when payment is made within 30 days of billing.

5. To see if the Town will vote to raise and appropriate the sum of \$20,000.00 for the purpose of revaluation of the Town.

6. To see if the Town will vote to appropriate and authorize the withdrawal of the sum of \$4,400.00 from the Revenue Sharing Fund, established under the provisions of the State and Local Assistance Act of 1972, for the purchase of a garden tractor with attachments for the maintenance of Town property.

7. To see if the Town will vote to raise and appropriate the sum of \$6,600.00 for the purchase of a tract of land, situated on the westerly side of Route 125 as shown on the Town of Kingston Tax Map R34 as Parcel No. 68 owned by the State of New Hampshire and abutted on the north by land of Alfred J. & Amy L. Alberts; on the west by land

of Alfred J. & Amy L. Alberts and Stanley & Myra J. Shalett; on the south by land of Sanborn Regional School District (D. J. Bakie Elementary School). This land is to be set aside for the future construction of a recreation building.

8. To see if the Town will vote to raise and appropriate the sum of \$5,000.00 to meet requirements mandated by the State of New Hampshire in order that Greenwood Beach remain open to the residents of Kingston.

9. To see if the Town will vote to appropriate and authorize the withdrawal of the sum of \$3,000.00 from the Revenue Sharing Fund, established under the State and Local Assistance Act of 1972, for the purchase of a new copy machine for the office of the Selectmen.

10. To see if the Town will vote to appropriate and authorize the withdrawal of the sum of \$400.00 from the Revenue Sharing Fund, established under the provisions of the State and Local Assistance Act of 1972, for the purchase of two (2) file cabinets for the office of the Town Clerk/Tax Collector.

11. To see if the Town will vote to raise and appropriate the sum of \$8,921.69. \$6,372.64 as a 5% cost-of-living increase for all full-time employees with \$2,549.05 to be set aside for merit increases deemed appropriate by the Board of Selectmen upon supervisory recommendation.

12. To see if the Town will vote to appropriate and authorize the withdrawal of the sum of \$9,600.00 from the Revenue Sharing Fund, established under the provisions of the State and Local Assistance Act of 1972, for the purchase and installation of security and fire alarm system for the Town Hall and Historical Museum Building.

13. To see if the Town will vote to raise and appropriate the sum of \$30,000.00 for the purpose of conducting a hydrogeological study and closure plan for the Kingston Landfill as mandated by State regulations.

14. On petition of the Kingston Fire Wards, and 15 others on behalf of the Kingston Fire Department: "To see if the Town will vote to raise and appropriate \$20,000.00 (twenty thousand dollars) to be added to the Capital Reserve Fund for the future replacement of Engine No. 2, 1968 Chevrolet."

15. On petition of the Kingston Fire Wards, and 12 others on behalf of the Kingston Fire Department: "To see if the Town will vote to appropriate and authorize the withdrawal of \$1,200.00 (twelve hundred dollars) from the Revenue Sharing Fund, established under the provisions of the State and Local Assistance Act of 1972, said money to be used for the purchase of one (1) desk, one (1) chair and one (1) typewriter."

16. On petition of the Kingston Fire Wards, and 15 others on behalf of the Kingston Fire Department: "To see if the Town will vote to withdraw from the General Funds all monies received from the use of the ambulance for the year 1984 and to place all monies from the use of the ambulance into a Capital Reserve Fund for the future replacement of the ambulance. RSA 35:1(B) (Supp) & 35:3 (Supp) & 35:11 & Chapter 35 generally."

17. On petition of the Kingston Fire Wards and 14 others on behalf of the Kingston Fire Department: "To see if the Town will vote to appropriate and authorize the withdrawal of the sum of \$2,000.00 (two thousand dollars) from the Revenue Sharing Fund, established under the provisions of the State and Local Assistance Act of 1972, for the purchase of six Motorola Monitor Pagers."

18. On petition of the Kingston Fire Wards and 10 others on behalf of the Kingston Fire Department: "To see if the Town will vote to appropriate and authorize the withdrawal of the sum of \$829.25 (eight hundred twenty-nine and 25/100) from the Revenue Sharing Fund, established under the provisions of the State and Local Assistance Act of 1972, for the purchase of one (1) Motorola Portable Radio."

19. On petition of the Kingston Fire Wards and 10 others, on behalf of the Kingston Fire Department: "To see if the Town will vote to abolish the position of part-time secretary for the Police and Fire Departments as described in Art. 23 of the 1983 Town Warrant and will raise and appropriate \$3,712.50 (three thousand seven hundred twelve dollars and fifty cents), for the purpose of creating the position of part-time secretary for the Fire Department at wage matrix level Class IX."

20. On petition of the Kingston Fire Wards and 10 others on behalf of the Kingston Fire Department: "To see

if the Town will vote to accept RSA Chapter 154 in its entirety.”

21. On petition of the Kingston Fire Wards and 9 others on behalf of the Kingston Fire Department: “To see if the Town of Kingston will vote to accept the attached by-laws for the Kingston Fire Department.”

1. The Kingston Fire Department shall consist of paid personnel to be determined by the Chief and Fire Wards. The chain of command within the Department shall be as follows in descending order of authority: Fire Wards, Fire Chief, Deputy Chiefs, Captains, Lieutenants. There shall also be an Ambulance Director appointed by the Chief who will hold the rank of Captain during all rescue procedures. The Ambulance Director shall appoint any Lieutenant that he or she may deem necessary.
2. A. The Fire Wards are the three members of the Department who are elected by the townspeople. Each Fire Ward is elected for a three-year term and the terms of the three Fire Wards are staggered such that only one Fire Ward’s term expires each year and accordingly, only one Fire Ward is elected each year.
B. The Fire Chief shall be appointed by the Selectmen from a nomination made by the Fire Wards. The Fire Department members may submit to the Fire Wards a list of not less than two nor more than five persons whom the members desire to be Chief but the Fire Wards are not restricted in their nomination to the names appearing on the list submitted to them by the Fire Department. The Chief must be technically qualified by training or experience and have the ability to command men and hold their respect and confidence.
C. The Fire Chief shall be appointed for an indefinite period of time but his terms of office shall depend upon his good conduct and efficiency. He may be removed by the Selectmen only for just cause and after hearing before them with reasonable notice in writing from the Fire Wards of the charges against him.
D. No one person shall hold the offices of Fire Chief and Fire Ward at the same time unless extraordinary circumstances arise as determined by the Fire Wards.

- E. The Deputy Chiefs and other Officers he deems it necessary to appoint shall be appointed by the Fire Chief subject to the approval of the Fire Wards.
 - F. A non-resident of the Town of Kingston shall not hold any office in the Kingston Fire Department unless extraordinary circumstances arise as determined by the Fire Wards.
3. The Chief shall be accountable to the Fire Wards only; all other officers and members of the Department shall be accountable to the Chief.

Duties of the Fire Wards and the Chief

4. The duties of the Fire Wards include, in addition to those set forth in these Rules and Regulations or N.H. RSA Ch. 154, administering all financial aspects of the day-to-day operation of the Department and all policies connected therewith so as to ensure a well-run Fire Department for the Town. In addition to other duties set forth in these Rules and Regulations and by State law, the Chief or his appointed Officer shall be in charge at all fires, as well as at all emergency situations when danger to life or property exists. The Chief or his appointed Officer is in charge of all training for the Department.

The Chief is authorized to enter into agreements or contracts with neighboring towns to provide mutual aid to them with the approval of the Fire Wards. The Chief shall see that complete records are kept of all fires, inspections, emergency calls, apparatus and minor equipment. The Chief shall make a complete yearly report to the Town of Kingston to be printed in the Annual Town Report. He shall keep attendance records for any activity for which any member is to receive pay.

Membership

5. Any person age 16 or over whose legal residence or principal place of employment is in Kingston, or is a fire fighter in the town in which he resides and who is in good physical condition, shall be eligible for membership upon written or oral application. They may then be appointed by the Chief, in writing, to a paid or trainee position in the Department if a vacancy exists.

- A. No member under 18 years of age may ride in or on a fire truck or rescue wagon to a fire.
 - B. No member under 18 years of age may engage in any hazardous activities, designated as such by the Officer in charge.
6. Non-resident firemen whose principal place of employment is in Kingston shall abide by the following:
 - A. Respond during the hours of 7:00 A.M. to 5:00 P.M. Monday through Friday.
 - B. Will not be issued any fire equipment other than a tone alert receiver or pocket pager.
 - C. The Officer in charge at fire scene shall release non-resident firemen if there is sufficient help.
 7. Any member of the Department may be suspended or discharged from the Department by the Chief at any time he may deem such action necessary for the good of the Department. On written request of such member to the Fire Wards, the member shall be given a hearing on the charges brought by the Chief.
 8. A Fire Department member shall not miss more than four consecutive drills without notifying the Chief or Deputy Chiefs to remain in good standing.
 9. Every Fire Department member shall try to attend at at least one training session at a state training school in 12 months.

Equipment

10. The Department shall be equipped with such apparatus and other equipment as may be required from time to time to maintain its efficiency and properly protect life and property from fire or other emergencies.
11. Recommendations of apparatus and equipment needed shall be made by the Chief and after approval by the Fire Wards shall be purchased in such manner as may be designated by them.
12. All equipment of the Department shall be safely and conveniently housed in such places as may be designated by the Fire Wards. Such places shall be heated during the winter season.
13. The Chief and Fire Wards shall make suitable arrangement or equipment shall be provided for citizens to turn in an alarm and for notifying all members of the Department so that they may promptly respond.

14. No person shall use any fire apparatus or equipment for any private purpose, nor shall any person willfully and without proper authority remove or conceal any article used in any way by the Department. The Department does not make service calls unless authorized by the Fire Wards.
15. No apparatus shall be hired out or permitted to leave the Town except in response to a call for aid at a fire or emergency in a neighboring community without the consent of the Fire Wards.
16. All members in good standing shall be issued tone alert receivers and/or pocket pagers and except for non-resident fire fighters protective clothing subject to the following conditions:
 - A. Title to all equipment remains with the Kingston Fire Department.
 - B. Members will use the equipment to be alerted and will respond to all emergencies when humanly possible.
 - C. Equipment will be given reasonable care by the members.
 - D. At the discretion of the Fire Chief the equipment may be recalled upon the poor record of a member's performance, if a member changes place of residence, resigns from the Fire Department or dies.
 - E. The Kingston Fire Department will assume all financial responsibilities to keep the equipment in good condition. All holders of Fire Department equipment will inform the Chief whether they are available for day or night calls for fires depending on their work schedules. Those firefighters who do not respond to fires or drills will be asked to turn in their equipment to the Chief so they may be distributed to other firefighters who will respond to give the best coverage available.
17. Each firefighter, upon receipt of his equipment, shall sign a receipt therefor and be responsible for it. Upon leaving the Department, or if suspended or discharged, or if no longer in good standing the firefighter shall return said equipment.
18. All members in good standing shall be issued one arm patch and one auto ID plate free. Any additional patches or plates will be sold to the member at cost.

Meetings

19. The Kingston Fire Department shall meet on the third Monday of each month, at 7:30 in the evening.
20. Members shall miss no more than four consecutive meetings to remain in good standing.
21. Meetings shall be conducted according to Robert Rules of Order.

Drinking of Alcoholic Beverages

22. There will be no drinking of alcoholic beverages on or in any Fire Department equipment or property without prior written approval of the Fire Wards. Failure to comply with this directive will result in immediate suspension from the Department and any office therein.”

22. To see if the Town will vote to raise and appropriate the sum of \$30,000.00 for the purchase of a new GMC or Chevrolet dump truck to replace the 1974 model, currently in use, which is to be used in trade.

23. To see if the Town will vote to raise and appropriate the sum of \$11,356.80 for the purpose of hiring an additional man in the position of laborer in the Highway Department.

24. On petition of Neil R. Parker and 12 others: “To see if the Town will vote to raise and appropriate \$1,700.00 to purchase one eight-channel radio to replace our current radio, which is seventeen years old. This radio to be purchased at state bid price.”

25. On petition of Neil R. Parker and 10 others: “To see if the Town will vote to raise and appropriate \$825.00 to purchase a new electronic typewriter by sealed bid for the Police Department.

26. On petition of Neil R. Parker and 12 others: “To see if the Town will vote to raise and appropriate the sum of \$7,737.13 for the purchase of a 1985 Ford Crown Victoria ‘S’ four-door sedan, with electronic siren and a new cage, Police Cruiser at state bid price.”

27. On petition of Neil R. Parker and 12 others on behalf of the Kingston Police Department: “To see if the Town will authorize the Selectmen to apply for, receive and expend a sum of \$10,000.00 (ten thousand dollars), for radar patrol if available or awarded under the State of New Hampshire Highway Safety Program as one hundred percent (100%) state funded.”

28. On petition of Neil R. Parker and 10 others: "To see if the Town will vote to raise and appropriate the sum of \$800.00 for a 20,000 BTU air conditioner to replace the old one at the Police Station."

29. On petition of Neil R. Parker and 12 others: "To see if the Town will vote to raise and appropriate the sum of \$400.00 to purchase an in-line wattmeter for testing radios being set up or tuned up for all Fire Department, Highway Department, and Police Department radios."

30. On petition of Neil R. Parker and 12 others: "To see if the Town will vote and authorize the Selectmen to withdraw \$5,000.00 (five thousand dollars) from the Capital Reserve Fund for the purpose of buying a new cruiser (1985) at state bid price, the balance to be raised in Article No. 26."

31. On petition of Neil R. Parker and 12 others: "To see if the Town will vote to raise and appropriate the sum of \$500.00 to hire an engineering firm to plan and engineer a safety complex building for the Police Department adjacent to the Fire House and to propose an estimated price for construction."

32. On petition of Neil R. Parker and 11 others: "To see if the Town will vote to raise and appropriate the sum of \$15,000.00 (fifteen thousand dollars) to be placed in a Capital Reserve Fund for the future building of Police Station."

33. On petition of Neil R. Parker and 9 others: "To see if the Town will vote to raise and appropriate the sum of \$16,000.00 per year to authorize one additional full-time Police Officer. The first year would be funded for only six (6) months at \$8,000.00"

34. On petition of Neil R. Parker and 9 others: "To see if the Town will vote and authorize the Selectmen to change Secretary of Safety Services Clerk (Police and Fire Departments) to Secretary for Police Department only and to see if the Town will vote to raise and appropriate thirty two hundred and seventeen dollars at 25 hours per week, yearly for this secretarial position for the Police Department."

35. To see if the Town will vote to appropriate and authorize the withdrawal of the sum of \$8,000.00 from the Revenue Sharing Fund, established under the State and Local Assistance Act of 1972, for the purchase of a chair lift to be installed in the Town Hall.

36. To see if the Town will vote to add to the General Reserve Fund, established in 1984, for cemetery maintenance, the sum of \$600.00 being the amount received in 1984 for the sale of cemetery lots.

37. To see if the Town will vote to establish a Cemetery Committee of three members to be appointed by the Selectmen for terms of three years, except that in 1985 the appointments shall be one for three years, one for two years and one for one year. Said Committee shall be responsible for the care and maintenance of cemeteries and cemetery equipment and for expenditure of funds available from Trust Fund earnings and Town appropriations. One member of the Trustee of Trust Funds shall be a member of this Committee.

38. To see if the Town will vote to raise and appropriate the sum of \$2,000.00 for the support of the Seacoast Regional Health Center, Inc., these funds requested, in this instance being \$2,000.00, to be used to provide services to residents of the Town of Kingston whether or not said residents are able to pay.

39. To see if the Town will vote to raise and appropriate the sum of \$6,000 for the support of the Family Mediation Program of So. Rockingham County.

40. On petition of Neil R. Parker and 12 others: "To see if the Town will vote to raise and appropriate \$1,000.00 to cover the increased cost of Kingston's share of the Family Mediation Program established in 1983. Each town in the six-town district will share in this expense."

41. To see if the Town will vote to raise and appropriate the sum of \$1,628.00 to assist Rockingham County Community Action Program, Inc. These funds requested, in this instance \$1,628.00, are to be used for current operating expenses to enable Rockingham County Community Action Program, Inc. to continue providing services to residents of the Town of Kingston at no cost to said residents.

42. To see if the Town will vote to raise and appropriate the sum of \$3,220.70 for dues to Rockingham Planning Commission for services in regional planning and local technical assistance.

43. To see if the Town will vote to raise and appropriate the sum of \$6,357.00 for the support of the Exeter Area Visiting Nurse Association, Inc.

44. To see if the Town will vote to raise and appropriate the sum of \$1,350.00 to support the services of the Newmarket Health Center, Inc. These funds requested, in this instance being \$1,350.00, are to be used for providing transportation to the elderly and handicapped. The Newmarket Regional health center also provides primary health and social services, including the Health Center's Prenatal Program. These services are available to Kingston residents at the Lamprey River Clinic in Raymond, N.H. and in 1984 over 237 visits were made by Kingston residents.

45. To see if the Town will vote to raise and appropriate the sum of \$929.00 to assist Rockingham Child and Family Services, a private non-profit organization. The amount of the request is based on services rendered to 11 residents of the Town of Kingston during the period July 1, 1983 through June 30, 1984, inclusive.

46. To see if the Town will vote to approve in accordance with the provisions of the Kingston Zoning Ordinance Sections 4.42 and 7.40 an industrial development as recommended by the Selectmen on a tract of land in the rural residential district containing seven (7) acres, more or less, situated on the easterly side of Mill Road as shown on the Town of Kingston Tax Map R-22 as Parcel No. 18A owned by Mark Chmielewski and abutted on the north by land of Michael Fletcher; on the west by land of Geraldine E. Lavoie; on the south by land of the State of New Hampshire; on the east by land of James H., Jr. and Nancy G. Finney.

The proposed facility will be offices and plant operations of Unifab, Inc. a manufacturer of plastic components for the computer and electronics industries.

47. On petition of Paul C. Nelson, Jr. and thirteen others: "To see if the Town will vote to raise and appropriate the sum of five thousand dollars (\$5,000.00) to be placed in a Capital Reserve for the purchase of a recreation building."

48. To see if the Town will vote to adopt the following ordinance:

ORDINANCE
Adopted June 25, 1984

Relative to Inter-Community Police Assistance

An Ordinance adopted pursuant to New Hampshire RSA 106-C:3 to promote the health, safety and welfare of the inhabitants of the Town of Kingston.

The Selectmen of the Town of Kingston hereby authorize pursuant to the provisions of New Hampshire RSA 106-C:3 the Chief of the Kingston Police Department to extend assistance in time of emergency to any other municipality or the County of Rockingham subject to such restrictions and conditions as may be imposed by law.

49. On petition of Carroll E. Wright and 11 others: "To see if the Town will vote to authorize the Moderator to appoint a committee to be known as the Finance Committee of the Town of Kingston. Said Committee shall consist of 13 members appointed by the Moderator to serve three-year terms. This Committee shall elect officers, establish an agenda and review the proposed budgets for the purpose of making recommendations to the Board of Selectmen and to the voters at the Annual Town Meeting."

50. On petition of Harry J. Carr and 24 others: "To see if the Town will vote to adopt the provisions of the Municipal Budget Law."

51. On petition of Judith M. Brown and 102 others: "Are you in favor of increasing the Board of Selectmen to 5 members?". Said Article to be voted by written ballot.

52. On petition of Lawrence Neil and 52 others: "To see if the Town will vote to reduce the annual salary of each member of the Board of Selectmen to one thousand dollars (\$1,000.00)."

53. On petition of Judy A. Gagne and 12 others: "To see if the Town, out of concern for the health and safety of its citizens, will instruct its Selectmen and other appropriate public officials to work cooperatively with the New Hampshire Civil Defense Agency and other involved State agencies to help improve the Town's Draft Emergency Response Plan which has been prepared in order to protect the public in the event of an accident at Seabrook Station or any emergency such as a major fire, flood, storm or toxic spill, and in so doing, to participate in the exercise conducted in cooperation

with State and Federal Officials to test the Plan. This article is not intended to constitute final approval by the Town of the Draft Emergency Response Plan.”

54. On petition of Barbara Burbank and 13 registered voters: “To see if the Town of Kingston will vote to raise and appropriate the sum of \$1,250.00 (twelve hundred-fifty dollars) to assist Seacoast Hospice, a non-profit organization.”

55. To see if the Town will vote to authorize the Selectmen to sell tax-deeded property at public auction.

56. To see if the Town will vote to accept the Auditor’s Report for the Town Report as printed.

57. To transact any other business that may legally come before the meeting.

1984 REPORT

The year 1984 shows another increase of \$54,634.00 in Motor Vehicle Permit Receipts which was largely due to more new vehicles being registered and also, due to the higher factory list prices on new cars. A total of 708 dogs and 14 groups were licensed, showing a decrease of \$439.95 in receipts. Notices will be mailed to dog owners who are delinquent. Many thanks to Brenda and Dick Samoissette for their fine cooperation. Dogs must be licensed once a year, by State Law. These are due April 30 and penalty of \$1.00 per month after May 31.

The following Vital Statistics were recorded: 46 Berths, 71 Marriages and 34 Deaths, showing a decrease of 10 Births; and increase of 15 Marriages; and increase of 15 Deaths. The revenue from the Boat Taxes shows an increase of \$285.00. In 1985, decals will be used to renew Boat Plates. These should arrive about March 1st.

During 1984, 412 Voter Registrations were accepted, as well as 14 name changes and 17 party changes. Since this was a Presidential Election year, the registrations increased by 317. We work in full cooperation with the Supervisors of the Check List. There were four elections — Feb. 28, Mar. 13, Sept. 11 and Nov. 6. The number of absentee ballots were as follows, respectively: 90, 114, 47 and 186. There was also a Special Town Meeting on June 25th. Thanks to the Moderators and all ballot clerks, counters and assistants who help me at every election. I was sorry to learn of the resignation of Richard L. Russman as Moderator. The Supervisors of the Check List appointed George H. Harmon to replace him and George has already worked at two elections. The November one was really long because the Constitutional Amendment Questions took many extra hours to tally. I left the Town Hall at 5 A.M. the next morning and was back at the Town Hall at 8:30 A.M. to serve the public!

In 1985, there will be one election — Town Meeting on March 12th. The voting takes place upstairs in the Town Hall, and the polls are open from 10 A.M. to 7 P.M. Absentee ballots are available for anyone who is physically unable to come to vote, as well as those who are on vacation, working out of Town, etc. Call 642-3112 if there are any questions.

Since December, 1982, Kingston has been issuing renewal Decals for the State of N.H. — Motor Vehicle Dept. and this service continues to be happily received since it saves time and gas. We have the added feature of being open two evenings — Monday and Tuesday — 7 to 9, as the Motor Vehicle Dept. is not open at night. We can renew the same plate to the same person to the same vehicle. **NO NEW PLATES AND NO TRANSFERS.** Under a new ruling, we can now issue **FIVE DAY TEMPORARY PLATES.**

In March the Town accepted with deep regrets, the resignation of my Deputy, Rochelle Lafontaine. After numerous interviews, she was replaced by Gail Wozniak, 10 Chisholm Road. Gail is still training and learning the numerous procedures and voluminous amount of necessary information. I wish to express my deepest appreciation to Holly Ouelette, Deputy Tax Collector and Office Clerk, for her continued dedication to my office and to the Town of Kingston, and for all her expertise in the many areas of work covered in my office. In case of illness or emergency, these two employees will be able to serve you well.

In the Tax Dept., the Warrant shows another increase of \$230,236.41, and as of December 31st, 86.5% of the total was collected. Total Resident Taxes were 3369, an increase of 227. The balance of the Unredeemed Taxes for 1982 and 1983 is \$79,354.11 which is \$10,149.16 more than last year. A complicated Notice of Tax Delinquencies and Arrearages now has to be mailed to each delinquent taxpayer, according to a ruling made by the Supreme Court. These forms have to be mailed to both the old and new owners. It takes many hours to compute the interest. The form can be mailed with the tax bill or 90 days later.

Another change which was effective in 1984, is the billing of property taxes to the current owner at the time the bill is mailed, rather than the owner of record as of April 1st. A courtesy copy of the bill is now mailed to the old owner. The transfers were all updated as of Sept. 1st before the tax rate was set. The mailing date of the bills is governed by the time that the Selectmen finish their work and go to Concord to get the Tax Rate. Sometimes they have to wait for the school figures to be received or approved in Concord. After the rate is set, the Computer Company in Burlington,

Mass. is notified and it's usually ten days to two weeks before the Warrants and Bills are received. Then all the bills and figures are verified before mailing. In 1984, the work fell into the same week as the November Election, making it extremely difficult to get it all accomplished.

Many thanks to the Board of Selectmen, Treasurer and all other officers and committees for their fine cooperation all year. Again, one of the most pleasant things of the year was the third Holiday Party on Dec. 15th at the Plaistow Caterers for all Town Employees, committee members and guests. There were 172 reservations, but the weather and illness kept about 10 away. I want to thank everyone who helped to make the Party a big success. I am looking forward to the 1985 Party — date and place to be announced.

A sincere thank you to all residents for the continued support which you have shown me. It continues to be a pleasure to serve Kingston as I complete 25 years as Tax Collector and 15 years as Town Clerk. I am also commissioned as a Notary Public and Justice of the Peace, serving all Town Departments as well as the residents. As the years go by, I continue to build my "Library of Knowledge" to better serve my Town, County and State.

TRUSTEES OF TRUST FUNDS REPORT - 1984

There was no change in membership of the Board in 1984; Robert B. Kitt and Walter S. Clark were reelected in March. A summary of trust fund accounts and a listing of cemetery lot trust funds are given in the Report of Trust Funds. The full report is on file with the Selectmen, Trustees and required State offices and may be seen on request.

TRUST FUNDS

Investments of cemetery trust funds which had earned some 16 percent interest for 30 months matured in February and March, 1984, and were reinvested at current rates of between 8 and 9 percent (varying monthly). Ten new perpetual care trust funds were established; nine for new lots and one other.

CEMETERIES

Again, for 1985, the budget item request from the Town remains at \$7,000. Maintenance costs over that amount are covered by trust fund earnings. (This was shown in the 1983 Town Report as \$10,274.50 total expenditures, page 66, reimbursed from trust funds \$3,274.50 page 52, leaving a cost to the Town of \$7,000.00.)

Special projects in 1984 included repairs to the southern fence at the Plains, fertilizer for three cemeteries, re-grading the roadside at happy Hollow and purchase of new mowers.

Maintenance work was hampered by the loss of Jack Tilton through illness and scarcity of workers until a crew was completed in June. George Leate again took good care of South Kingston. Charles Geary, Jr., Seth Carr and Joseph Camire, Sr., were regular workers at the three central cemeteries.

REPORT OF THE NICHOLS MEMORIAL LIBRARY

The total number of volumes of circulating books was increased in 1984 by 728. Of these, the library purchased 577 and the remaining 151 were either donated or given as memorial books.

We have also started a collection of large print books for the visually impaired.

The Encyclopedia Britannica and the New Hampshire RSA's were also bought for the reference shelves.

The State Library and surrounding libraries continue to be valuable sources for requested material that is not in our collection.

A survey was conducted concerning the needs of the library and as a result, the lighting was improved by the installation of four quartz lighting fixtures in the reading room. The lack of parking facilities was the second biggest problem which the trustees are still working on.

The resignation of Christina Anderson as trustee was accepted in September. Carol Forsythe is finishing her unexpired term.

Additional shelving was added in the children's room to alleviate the crowded condition of the youth fiction books. Another welcome addition downstairs was the "Listening Center" that The Friends of the Library donated.

It was with deep regret that we had to accept Barbara Khalkhali's resignation as Children's Librarian because of health reasons. She was very devoted to the children and we will always be grateful for all that she did.

Florence Campbell was appointed the new Children's Librarian in May. She has two weekly pre-school story and craft programs that are very successful, and occasional movies for school age children all of which make it a very busy room

KINGSTON CONSERVATION COMMISSION ANNUAL REPORT 1984

The KCC continues to enjoy full 7-member board participation in a wide range of activities: Reviewing applications for Dredge/Fill as submitted to the NHS Wetlands Board for approval, reviewing with the Planning Board proposed subdivisions which fall within the Wetlands Conservation District, review of septic system plans and on-site inspection of building lots which contain wetland, continuation of the Forest Management Program, joint inspection and monitoring of gravel pits with the Selectmen and Planning Board, and investigation of violations of local and State regulations which may impact the quality of groundwater or surface waters.

Due to a conflict of snowday make-up days with an early Conservation Camp date, we were unable to send a Kingston youth last summer. However, we hope to sponsor two students for summer 1985.

Some KCC members attended the Municipal Law Lecture Series, as well as several workshops regarding water quality issues. A Town Lands Inventory has been completed for Master Plan, and a Wetlands Inventory review with on-site inspection is now in progress in order to help plan for future water needs of Kingston.

In addition to continuing our several inspection schedules and Forest Management program, the KCC will focus on water management issues and groundwater protection for the coming year. KINGSTON CIVIL DEFENSE AGENCY

This year there were two incidents in town that the Kingston Civil Defense was involved with. From 31 May thru 2 June we had some heavy rains that at times threatened the property of several residents by flooding. During this period the ponds were closely monitored and preparations were made in case of any danger to the surrounding properties. There was approximately \$9,700.00 worth of damage done due to this incident.

The second incident occurred on 30 October at the Kingston, Danville, Hampstead town lines. The collection of tires owned by Ernest Hunt caught fire. The immediate residents were evacuated from the area, and the surrounding area was monitored in case additional evacuation was needed. As of 31 December the fire was still burning, but is not of any danger to the surrounding residents. This incident has cost the town approximately \$3,256.36 to date.

In addition, I have monitored the clean-up operation at the Kingston Steel Drum facility on Rt. 125, where approximately 3,000 buried barrels have been excavated and removed from the site.

I have continued working with the Public Service Company and its contractor and the New Hampshire Civil Defense Agency with preparations for emergency procedures in the event of an incident at Seabrook Power Station.

This agency has applied for and received \$543.01, in reimbursement, from the Federal Government thru the Emergency Management Assistance funding program.

REPORT OF THE KINGSTON FIRE DEPARTMENT

The Town of Kingston continued its fine fire loss record in 1984. Our residents are to be commended for their fire safety precautions.

We responded to 159 calls and 233 ambulance calls.

During last year the Ambulance Association contributed over \$1500.00 to upgrade equipment and clothing for the Ambulance Department. This money had been donated to the Ambulance Department by generous Kingston citizens who care about the ambulance service. It was used to purchase new blood pressure cuffs and stethoscopes, a Resuscitator Annie, a special blood pressure stethoscope to take blood pressure over clothing, and jackets for ambulance attendants that are visible at night. Their next projects are the purchase of Mast Trousers, which are going to be a requirement as of July, 1985, and an Emergency Fracture Kit. The Ambulance Department was also very pleased to receive a Miller Board, which was generously donated to them by the Kingston V.F.W. Post 1088 Auxiliary. Kingston is among the first to have this piece of equipment.

In the past six years our population has increased about 25 percent; however, our fire record continues to be low. Our per capita operating cost is the lowest in the immediate area.

I would like to thank Sgt. Donald Briggs, Jr. of the Police Department for keeping our radios repaired and Ambulance Director Arlene Sargent for her dedication and efficient operation of the ambulance squad.

A special thank you goes to the fire fighters, ambulance attendants and the people of Kingston for their cooperation.

REPORT OF THE TOWN FOREST FIRE WARDEN AND STATE FOREST RANGER

Our first forest fire prevention law was enacted by our State Legislature 90 years ago. This early law set in place a cooperative forest fire prevention and suppression effort between city and town governments and State government. It simply stated that no open fire could be kindled, when the ground is free of snow, without the written permission of the town/city Forest Fire Warden. This law also stated that anyone kindling a fire without written permission shall be liable for the damage caused and subject to a \$1000 fine.

During the past 90 years, this law has worked so well that it has remained unchanged. All open fires when the ground is not covered with snow must be authorized by the local Forest Fire Warden. Persons kindling a fire without a permit when one is required are liable for damages caused, fire suppression costs and subject to a \$1,000 fine.

This cooperative fire prevention law has contributed significantly to our nationally recognized annual forest fire loss record.

KINGSTON PLANNING BOARD ANNUAL REPORT 1984

The responsibilities of the planning board increased dramatically this year. To comply with state statutes, the board now performs site plan review, inspects gravel pits and grants driveway permits. Site plan review involves public hearings for design and siting of all non-residential buildings with the exception of barns, garages and other ancillary buildings.

These additional duties were added to an already full agenda of subdivisions hearings, lot line adjustments, planning and zoning ordinances, and work on the master plan which should be completed soon.

As part of their further education in performing their planning duties, most of the board members have attended the Law Lecture Series sponsored by the New Hampshire Municipal Association, or soil workshops offered by the U.S. Soil Conservation Service.

A landmark legal decision in the case of Lewis Builders vs. the Town of Atkinson has caused all area towns to reappraise all zoning and planning to the extent that it denies opportunity in housing for all income levels. The board's attorney, Peter J. Loughlin, and the Rockingham Planning Commission have been invaluable in this review.

The make-up of the board has had two changes from last year. Selectman Bernard Robie replaced Selectman John Reinfuss as the ex officio board member. Chet Woodbury will replace Eileen Nash, who resigned in September.

KINGSTON RECREATION COMMISSION REPORT FOR 1984

This year has been a time for learning for the Commission because three of the five members have been on the Commission one year or less. We are, however, pleased with results of the year's activities, and we look forward to some possible expansions in the coming year.

We tried several new things this year, most notably working with other town groups in sponsoring activities and programs. Several groups, including the Boy Scouts and Kingston Community House, helped with the annual Christmas lighting program in early December. A large number of people joined the Scouts' hayride to sing carols around the Plains and Kingston Pines, and then we all returned to the Town Hall for hot chocolate and cookies, which we provided.

Another example of cooperative effort was the annual Halloween party for elementary school children. Numerous volunteers helped with the activities, the haunted house and treats handed out afterward.

The Commission was also very lucky to have the donations of several local groups and businesses to help with the year's programs.

We offered a new activity this summer for teens - a harbor cruise out of Portsmouth for teens only. The Commission provided the bus and chaperones, and the teens paid their passage and snack costs. The bus was full for the trip, and we plan to continue this program in 1985.

One activity we had planned but which was not offered was a family pass program to three museums in the area. The Selectmen did not approve the expenditure because they felt we did not offer enough proof that the passes would be used. To remedy this objection, we completed a survey of Bakie School parents, and of all the forms returned, only one objected. So we hope to have this program approved for use in 1985.

We have put some money in a capital reserve fund for a recreation building, and we are sponsoring an article in 1985 to continue this effort. We believe that the town is growing fast enough so that space for recreational activities will be needed in the future.

We are also working on providing a light for the small pond on Church Street for night skating. A warrant article was passed to pay for this light, and we are trying to find the most cost effective and safest way to provide it.

All the activities the Commission now sponsors, including the Easter party at the Nichols Memorial Library for preschoolers, the summer recreation program for elementary age children, and the Halloween party for Bakie School children, are very successful.

In a way, this very success has led to a problem. The numbers at each of these activities are so large that the programs have become unwieldy. We are exploring ways to alleviate this situation now.

For the coming year, we are considering expanding our activities for families, including possibly one day trip. We are also exploring the need for and location of public ballfields.

Since we try to offer programs of interest to residents, we would appreciate suggestions and comments.
