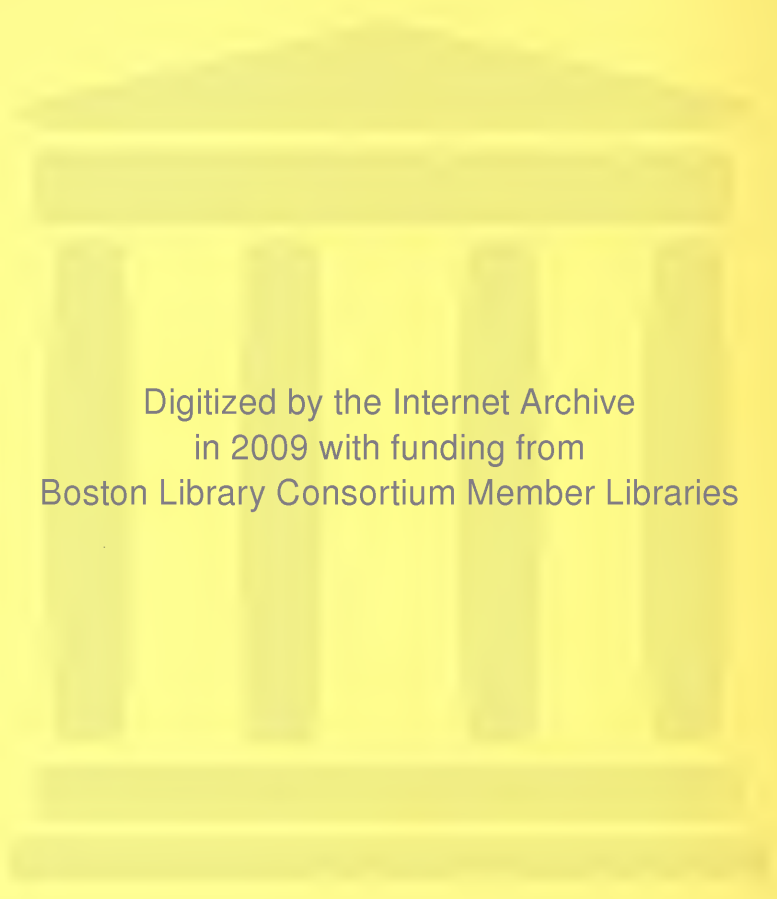

This past year saw the beginning of the reassessment ordered by the State Board of Taxation. The single State employee that has been doing the preliminary work, will soon be joined by several more. It is hoped that they will complete the reassessment by late summer, so that Chesterfield can get its tax rate in time for early tax billing.

The commercial area on Route Nine near Brattleboro has seen some activity the past year, with Prospect Park Press moving to its new building. Reports received thus far have been all positive as to design and esthetic qualities of this facility.

At Spofford Lake, Tall Pines is rapidly progressing with their construction, with an early summer date scheduled for opening in the coming year.

New house construction was down in Chesterfield, the first decrease in several years. This condition seems to be attributable to the scarcity of mortgage money and the high interest rates on what little is available.

We would like to take this opportunity to thank the various boards and department for a job well done in the past year. The many hours spent by these people contribute greatly to making Chesterfield the great place it is to live in. Thank you.

To the Inhabitants of the Town of Chesterfield in the County of Cheshire in said State, qualified to vote in Town affairs:

You are hereby notified to meet at the Town Hall in said Chesterfield on Tuesday, the Eleventh (11th) day of March, next at 6:30 o'clock in the evening to act upon the following subjects:

(Polls will be open at 10:00 A.M. and will close at 8:00 P.M.)

ARTICLE 1. To vote an Australian Ballot for all necessary Town Officers.

ARTICLE 2. To vote by ballot on amendments to the Zoning Ordinance.

ARTICLE 3. To determine the method of collecting taxes for the ensuing year.

ARTICLE 4. To see if the Town will authorize the Selectmen to borrow money in anticipation of taxes.

ARTICLE 5. To hear the report of the Budget Committee and act thereon.

ARTICLE 6. To see if the Town will vote to raise and appropriate the following sums, as approved by the Budget Committee for:

To see if the Town will vote to appropriate and authorize the withdrawal from the Revenue Sharing Fund established under the provisions of the State and Local Assistance Act of 1972 for use as setoffs against budgeted appropriations for the following specific purposes and in the amounts indicated herewith or take any other action hereon:

\$10,000.00 toward the operation of the Town Dump. (Approved by the Budget Committee.)

ARTICLE 8. To see if the Town will vote to make application for Town Road Aid and raise the sum of \$1,511.50 thereby receiving an additional \$10,076.66 from the State for Town Road Construction. (Approved by the Budget Committee)

ARTICLE 9 To see if the Town will vote to raise and appropriate the sum of \$70,000.00 for Summer Maintenance of roads. (Approved by the Budget Committee.)

ARTICLE 10. To see if the Town will vote to raise and appropriate the sum of \$56,000.00 for Winter Maintenance of roads. (Approved by the Budget Committee.)

ARTICLE 11. To see if the Town will vote to raise and appropriate the sum of \$23,000.00 for the Repair and Upkeep of Highway Equipment. (Approved by the Budget Committee.)

ARTICLE 12. To see if the Town will vote to raise and appropriate the sum of \$9,000.00 for Street Lighting. (Approved by the Budget Committee)

ARTICLE 13. To see if the Town will vote to accept and appropriate the sum of \$16,570.00 for the specified use by the State for the purpose of construction and reconstruction of Class IV and Class V Highways. (Approved by the Budget Committee.)

ARTICLE 14. To see if the Town will vote to raise and appropriate the sum of \$5,350.00 to aid the Chesterfield Home Health Agency in delivering skilled nursing care to all peoples. (Approved by the Budget Committee.)

ARTICLE 15. To see if the Town will vote to raise and appropriate the sum of \$1,047.00 to help support the work of the Monadnock Family and Mental Health Service. (Approved by the Budget Committee.)

ARTICLE 16. To see if the Town will vote to raise and appropriate the sum of \$1,849.00 to join the Southwestern New Hampshire Regional Planning Commission as provided for in New Hampshire RSA 36:45 to aid the town in future planning. (Approved by the Budget Committee.)

ARTICLE 17. To see if the Town will vote to raise and appropriate the sum of \$4,500.00 for ambulance service for the ensuing year. Of this amount, \$2,750.00 is to go to the Keene City Ambulance Service and \$1,750.00 to Rescue Inc. of Brattleboro. (Approved by the Budget Committee.)

ARTICLE 18. To see if the Town will vote to raise and appropriate the sum of \$8,000.00 for the reappraisal being conducted for the 1980 tax year. This additional amount is an updated figure submitted by the Property Tax Appraisal Division. (Approved by the Budget Committee.)

ARTICLE 19. To see if the Town will vote to appropriate the sum of \$6,912.00 for the purchase of a cruiser for the Police Department, authorizing \$2,000.00 to be withdrawn from the Cruiser Reserve Fund and \$4,912.00 to be authorized and withdrawn from the Revenue Sharing Fund as established under the provisions of the State and Local Assistance Act of 1972. (Approved by the Budget Committee.)

ARTICLE 20. To see if the Town will vote to raise and appropriate the sum of \$2,000.00 for necessary repairs to be made to the Spofford Dam as ordered by the U.S. Department of Army Corps of Engineers. (Approved by the Budget Committee.)

ARTICLE 21. To see if the Town will vote to appropriate the sum of \$400.00 being the remaining income from the building permit for Tall Pines to be used for the expenses of the Building Inspector on the Tall Pines project. (Approved by the Budget Committee.)

ARTICLE 22. To see if the Town will vote to appropriate the sum of \$512.00 being the income from sales of the Tax Map toward the expenses in 1980 of updating the tax map. (Approved by the Budget Committee.)

ARTICLE 23. To see if the Town will vote to accept the Stoneleigh Road as a town road. This road is in the Stoneleigh subdivision off the River Road, has the necessary number of residences and has been approved by the Road Agent and the Selectmen.

ARTICLE 24. To see if the Town will vote to accept Hewitt Road and Key Circle located in the Spofford Stage development. This road has been built to agreed upon specifications and has been approved by the Road Agent and the Selectmen. There are seven homes on the road now.

ARTICLE 25. To see if the Town will vote to prohibit the transportation of radioactive materials and radioactive waste from nuclear facilities across town lines. (By petition)

ARTICLE 26. To see if the Town will vote to prohibit the storage of radioactive materials, and dumping of radioactive waste from nuclear facilities within the town lines of Chesterfield. (By petition)

ARTICLE 27. To see if the Town will vote to accept the amount of \$100.00 from Beatrice Wintle for the Trust Fund on Reuben & Beatrice Wintle Lot #123 in Chesterfield West Cemetery. Income from the same to be paid to the Chesterfield West Cemetery Association for perpetual care and upkeep of said lot and to be known as The Reuben & Beatrice Wintle Trust Fund.

ARTICLE 28. To see if the Town will vote to accept the amount of \$200.00 from Lawrence W. & Margurite W. Hill for Trust Fund on Cecil H. Watkins Lot #299-300. Income from same to be paid to the Chesterfield West Cemetery Association for perpetual care and upkeep of said lot and to be known as the Cecil H. Watkins Trust Fund.

ARTICLE 29. To see if the Town will vote to accept the sum of \$200.00 from Ira Shaw to be added to the Morris Friedsam Fund, the income to be used for perpetual care in said cemetery and known as the Ira Shaw Trust Fund.

ARTICLE 30. To see if the Town will vote to accept the sum of \$200.00 from Mildred M. Kemp to be added to the Morris Friedsam Fund, the income to be used for perpetual care in said cemetery and known as the Mildred M. Kemp Trust Fund.

ARTICLE 31. To see if the Town will vote to accept the sum of \$200.00 from Mrs. Robert Mitchell to be added to the Morris Friedsam Fund, the income to be used for perpetual care in said cemetery and known as the Robert Mitchell Trust Fund.

ARTICLE 32. To see if the Town will vote to accept the sum of \$200.00 from Clifford G. Bedaw to be added to the Morris Friedsam Fund the income to be used for perpetual care in said cemetery and known as the Clifford G. Bedaw Trust Fund.

ARTICLE 33. To see if the Town will vote to accept the sum of \$50.00 from Jean Lucier to be added to the Spofford Cemetery Annex Fund the income from same to be used for perpetual care in said cemetery and to be known as the Jean F. Lucier Trust Fund.

ANNUAL TOWN MEETING, 1979

Proceedings of the Annual Meeting of the voters of the Town of Chesterfield, New Hampshire called at the Town Hall in said Town on Tuesday, March 13, 1979.

The meeting was called to order at ten o'clock in the forenoon by the Moderator, James E. O'Neil, Sr., who read the Warrant through Articles 1 and 2 and declared the polls open for voting by ballot for Town Officers and Admendments to the Zoning and Building Ordinances.

At six-thirty the Moderator called the meeting to order, with Forest Hall, Jr. and Ethel Mills acting as Assistant Moderator and Assistant Clerk, respectively.

The Moderator then called on Rev. Theodore VanPatten, who offered prayer.

The Articles of the Warrant were then disposed of as follows:

Voted by voice vote on motion made by Warren Allen and supported by William Mitchell to dispense with reading of the Warrant as it could be found on pages 6 to 11 inclusive of the Annual Report, and the Moderator will read each Article as it is considered. Vote declared by the Moderator to be carried in the affirmative.

ARTICLE 3 Voted by voice vote on motion made by Gary Winn and supported by Russell Johnson to use the same method of collecting taxes for the ensuing year as was used last year. Vote declared by the Moderator to be carried in the affirmative.

ARTICLE 4 Voted by voice vote on motion made by H. Claude Mowry and supported by Robert Callahan to authorize the Selectmen to borrow money in anticipation of taxes. Vote declared by the Moderator to be carried in the affirmative.

ARTICLE 5 The report of the Budget Committee was given by Robert Beard, Chairman, who stated that they had met the required number of meetings and the report could be found on pages 12 and 13 of the Annual Report. Voted by voice vote on motion by Robert Callahan and supported by JoAnn Morse to accept the report as given. Vote declared by the Moderator to be carried in the affirmative.

ARTICLE 6 Motion made by Robert Woodman and supported by Claude Mowry to set aside Article VI until after Article VII. Vote declared by the Moderator to be in the affirmative.

ARTICLE 7 The Moderator called on Chairman, Donald Emery, to explain and clarify the article. Considerable Debate followed. Joseph Scrivan made the following resolution and supported by Carol Beal "that we vote by hand or standing count to approve the decision of the State Board of Taxation to reassess the Town of Chesterfield thereby establishing for the record the feelings of the citizens". Voted by show of hands Yes (11) No (108). Vote declared by the Moderator to be carried in the negative.

Motion made by Claude Mowry and supported by Frank Symonds to amend the Article to raise and appropriate the sum of

\$46,200.00 to have the Town reassessed as mandated by the State Board of Taxation; said reassessment to be conducted by the State of New Hampshire, Department of Revenue Administration and by No private assessing firm retained by the Town. Voted by voice vote on amendment and declared by the Moderator to be carried in the affirmative, and the Article as amended voted in the affirmative.

ARTICLE 6 Motion made by Michael Wiggin and supported by Russell Johnson to raise and appropriate the following sums as approved by the Budget Committee:

Voted by voice vote on a motion made by Robert Woodman and supported by Frank Symonds to amend this Article by reducing Item 9 (Insurance) from \$19,100.00 to \$18,325.00. Reduction of \$775.00 on Police Insurance. Vote declared by the Moderator to be carried in the affirmative.

Voted by voice vote on the article as amended. Vote declared by the Moderator to be carried in the affirmative.

ARTICLE 8 Voted by voice vote on motion made by Wayne Winn and supported by Raymond Egan to make application for Town Road Aid and raise the sum of \$1,533.89 thereby receiving an additional \$10,225.96 (this figure corrected, due to error from \$14,229.56) from the State for Town Road Construction. Vote declared by the Moderator to be carried in the affirmative.

ARTICLE 9 Voted by voice vote on motion made by Robert Woodman and supported by Frank Symonds to raise and appropriate the sum of \$60,300.00 for Summer Maintenance of roads. Vote declared by the Moderator to be carried in the affirmative.

ARTICLE 10 Voted by voice vote on motion made by Richard Wolf and supported by Russell Johnson to raise and appropriate the sum of \$53,000.00 for Winter Maintenance of roads. Vote declared by the

Moderator to be carried in the affirmative.

ARTICLE 11 Voted by voice vote on motion made by Gary Winn and supported by Donald Emery to raise and appropriate the sum of \$23,000.00 for the Repair and Upkeep of Highway Equipment. Vote declared by the Moderator to be carried in the affirmative.

ARTICLE 12 Voted by voice vote on motion made by Wayne Winn and supported by Winston Cray to raise and appropriate the sum of \$7,500.00 for Street Lighting. Vote declared by the Moderator to be carried in the affirmative.

Vote declared by the Moderator to be carried in the negative and the motion was lost.

Voted by voice vote on motion made by Frank Seay and supported by Winston Cray to raise and appropriate the sum of \$1,047.00 to help support the work of the Monadnock Family and Mental Health Service. Voted declared by the Moderator to be carried in the affirmative.

ARTICLE 15 Voted by voice vote on motion made by Antonio Souza and supported by Winston Cray to accept and appropriate the sum of \$12,883.74 for the specified use by The State for the purpose of construction and reconstruction of Class IV and Class V highways. Vote declared by the Moderator to be carried in the affirmative.

ARTICLE 28 Voted by voice vote on motion made by Donald Emery and supported by Robert Mills to accept the Stoneleigh Road as soon as the proper number of houses are built. Vote declared by the Moderator to be in the negative and motion was lost.

ARTICLE 29 Voted by voice vote on motion made by Donald Emery and supported by Richard Wolf to install a streetlight at, or near the Western entrance to Maple Lane in Spofford. Vote declared by the Moderator to be in the affirmative.

ARTICLE 30 Voted by voice vote on motion made by Donald Emery and supported by Wayne Winn to particiapte and support a regional solution to handling solid waste either by agreeing to accept a Landfill site in the Town, providing cover material from that Town, accepting an alternative Operation in the Town or agreeing to whatever other aspect of a regional solid waste operation appears to be sensible to serve the region so that a good cooperative regional solution will be a reality and a commitment.

If agreed, the Board of Selectmen of the Town will appoint their representatives of the Town to a Area Solid Waste Study Committee. Vote declared by the Moderator to be in the affirmative.

1. To amend the first sentence of Section II, GENERAL PROVISIONS, paragraph 2.08 to read: The removal of clay, sod, loam, sand, or gravel is permitted for private use, provided that all excavation, handling, processing and storage facilities shall be removed and the area shall be regraded or otherwise covered to assure that the premises are left in a safe and slightly condition and protected against erosion

2. Add paragraph 2.08A as follows: The opening of a pit for the removal of clay, sod, sand, gravel or crushed stone for sale may be permitted by the Board of Adjustment after a Public Hearing, Provided that proper provision is made to safeguard traffic, and subject to the same conditions contained in paragraph 2.08.

3. To amend the first sentence of paragraph 13.02 to read as follows: No new building, structure, or chimney shall be erected, or an existing structure or chimney be altered, maintenance and interior excluded except for chimneys, without a building permit from the Building Inspector to whom adequate plans of proposed building or alterations shall be submitted. (The purpose of this amendment is to require a Building Permit for altering or constructing a chimney).

4. To amend paragraph 13.07 to read as follows: All chimneys and fireplaces shall be constructed of stone, brick, concrete or cinder blocks, on an eight (8) inch thick concrete footing. Footing shall be cast in place at a minimum depth of four (4) feet below ground level for frost protection. Width of footing shall be one foot wider in each direction than the width of proposed chimney. All masonry chimneys shall be lined with flue tile beginning at the footing and extend two (2) feet higher than the ridge of a peaked roof, or two (2) feet higher than a ten (10) foot measurement horizontally to a roof. All entrances to chimneys shall be of fireproof construction with each flue to have a cleanout at its base. Chimneys shall not be used to support beams or timbers in any manner

No smoke pipe or thimble shall be installed so as to be within eighteen (18) inches of any combustible floor or ceiling unless amply protected with non-combustible material. No smoke pipe shall be installed which passes into or through partitions or walls of combustible materials except when guarded by a double collar of metal with air space of at least five (5) inches, or by at least five (5) inches of brick or other non-combustible material between the pipe and the combustible material. Flue tiles will be joined with refractory cement. Under no circumstances will mortar cement be permitted to join flues together. Prefabricated chimneys bearing the approved label of the National Board of Fire Underwriters shall also be allowed, provided they are installed in an approved manner.

ROAD CONSTRUCTION STANDARDS AND SPECIFICATIONS

5. To Section IV add the following paragraph 16.03: Any new drive from a town public road shall require a driveway permit from the town Road Agent. Factors to be considered include a safe location, suitable grade at its junction with the public road, and adequate drainage. The Building Inspector shall not issue a building permit before the securing of a driveway permit, if a new driveway is required.

CHESTERFIELD POLICE DEPARTMENT
ANNUAL REPORT 1979

The Chesterfield Police Dept. went to full time status in September of 1979. There are many reasons why we went full time, one being that the State of New Hampshire law indicates that if anyone earns \$5,000.00 or more per year as a police officer he and the department is to be considered full time. Although there have been a few changes, basically we are operating the same. I now have one full time man, Officer John Brady of Westmoreland Road, Spofford. The two of us try to offer the town 24 hour coverage, it isn't easy, thats 12 hours a day, 7 days a week. We still need two or three special officers to help out. Each full time officer is also required to go to the Police Academy for 8 weeks, Officer Brady goes February 25, 1980 and I will start in May. We also attended a 16 day school at Keene State College put on by the State Police Standards and Training Council last spring. This was for two nights a week for 8 weeks. State law also says that all full time police officers shall be certified by the state, thats why we must go to the academy. Our work load has been very heavy and there is no indication of its slowing down. Vandalism still tops the list, we urge anyone who sees anything suspicious to call the police department and report it. Registration numbers and identification is of course, most helpful. We did solve some of the burglaries and other things this last year because of this kind of help. One of our big needs right now is for more room. We share our office with the Chesterfield Home Health Agency. These ladies do a terrific job for the townspeople, but it does get confusing. Our combination office measures only 10 feet by 12 feet and contains two desks, 5 file cabinets, chairs, evidence, recovered property, etc., etc. Can you imagine trying to hold a blood pressure clinic, do an interrogation, take fingerprints and mug shots all at the same time!

I am at the office most every Thursday night and will gladly answer any questions I can.

I want to thank everyone for using the 352-1100 police number for all police calls -- it has been a big help.

ROAD AGENTS REPORT
December 31, 1979

I have issued 28 driveway permits since the ordinance went into effect on April 1, 1979. This is working out very well with inconvenience only to those who do not comply with the rules.

The Streeter Hill TRA construction project is completed. All paving was done this year with the use of about 30 percent of Subsidy II funds along with the balance of the TRA account.

The balance of Subsidy II funds were used to do additional blasting and reconstruction work on the lower Gulf Road. We still have about 250 feet of road to be blasted and reconstructed to eliminate the winter ice problems and also to lift the road 4 feet higher to get above flood level.

I strongly advise that the 1980 TRA funds be expended on the present tar section of the Horseshoe Road, which is the last "bad section" of tar road to be reconstructed in town. The road will then be asphalt paved in 1981 as per new schedule.

We now have all blacktop roads worked into a four year resurfacing schedule which is on file in the selectmen's office. We have abandoned the old way of sealing and have turned to making our own asphalt mixture and laying it out on the road with the rader which really smooths up our paved highways. This method is also easier on our budget. With asphalt prices soaring, I felt we had to find a more economical system. The 1980 increases in both summer and winter maintenance reflect the increase in petroleum products used by the highway department.

PLANNING BOARD REPORT
FOR 1979

There were 17 meetings of the Board during the year with public hearings for 17 subdivisions, 3 site plan reviews, a public hearing regarding amendments to the subdivision regulations, and 3 public hearings on amendments for the Zoning Ordinances.

James O'Neil, Jr. became a regular member of the board.

Important work included revisions, editing, and reprinting of both the subdivision regulations and the zoning ordinances. I especially appreciate the work of Joan Dittrich, Mayda Berg, Ronald Viarengo, and James O'Neil, Jr. who served on special committees for these projects. Mayda Berg is thanked for her work in typing the manuscripts prior to publication.

The Planning Board hopes that the townspeople will approve the appropriation for joining the South Western Regional Planning Commission. This appropriation is very small in comparison with the total expenditures of over 1 million of your tax dollars by the town this year. We have good capable people on the Planning Board. However, all members serve without pay, and the time available to them is mostly consumed in the routine administration of subdivision regulations and zoning ordinances. The Board feels that this town needs the technical assistance of the South Western Regional Planning Commission and that it is important to share in those planning activities regarding growth, sanitary facilities, garbage disposal, transportation, and the protection of the environment and natural resources which are important to all of us, and which should be considered on a regional basis.

AMBULANCE COMMITTEE REPORT FOR 1979

At a meeting of the Chesterfield Ambulance Committee held on December 11, 1979 it was unanimously decided to recommend a budget amount of \$4,500.00 for ambulance service for the coming year. \$1,750.00 to be donated to Rescue, Inc. and \$2,750.00 to cover the Keene charges.

Some facts brought to our attention at the meeting are as follows: Rescue, Inc. - As of December 11, they had 46 calls to Chesterfield which is 3% of their total. Their budget for 1980 is \$107,000.00. 3% of that is slightly over \$3,100.00 so a \$1,750.00 donation is the minimum we should give.

Keene Fire Department Ambulance - As of December 11, they had approximately 60 calls to Chesterfield. While their budget request is 8% higher they don't anticipate increasing our standby costs. The recommended increase is only to cover a possible increase in bad debts.

In the spring we will hold another meeting to try to straighten out some minor problems that came to our attention at the meeting mainly regarding street indexes and running cards at the control center. Also the committee expressed a willingness to participate in the preparation of a town disaster plan.

CHESTERFIELD HOME HEALTH AGENCY, INC.
FIFTH ANNUAL REPORT - FISCAL YEAR 1979

1979 was a busy year for our Home Health Agency. We were fortunate to obtain the services of Marilyn Rousseau, R.N. after the resignation of our former nurse. Mrs. Rousseau has a varied nursing background including home health care experience. She helped to make what could have been a difficult time into a smooth period of transition.

As administrator as well as nurse, and with the help of an efficient book-keeper/clerk and an excellent volunteer treasurer, Mrs. Rousseau has ably met the numerous and often difficult requirements of the state and federal governments. This is essential in order to receive the accreditation necessary for Medicare and Medicaid participation and to maintain a certified agency.

During the past year board members and the nurse have spent considerable time on the study to determine the best and most economical and efficient ways to bring home nursing care to the residents of Cheshire County. In 1980 the Chesterfield Home Health Agency will continue to be represented at all such meetings.

The budget which follows this report indicated our sources of income. We thank the Town of Chesterfield for their continued support and are grateful to all who contribute to the membership drive. In 1979 we netted \$1,326.00 representing 375 memberships plus donations.

The Memorial Fund contributions totaled \$65 in memory of Bernard Chickering, Beverly Jacques and Winifred Lathrop. This is a thoughtful, practical way to honor a loved one's memory. The fund is used for extras not provided by the agency's regular budget and in 1979 we purchased a typewriter table, a file cabinet with lock, an otoscope and a nurse's reference book.

Among the services offered the community by your agency are skilled nursing care, free monthly blood pressure clinics, the federally-funded women, infants and children (WIC) program, and a free visit to each newborn and mother. A physical therapist, an occupational therapist and home health aides are available through the agency on a contractual basis. Another service is the loan of medicalequipment such as wheelchairs, canes and crutches, to townspeople at no cost.

The Chesterfield Agency has a charge to provide education in health promotion and disease prevention in the community. Because of this we are a resource and referral agency, making available information to citizens or citizen groups on health and related topics. For example, we held an open meeting on teenage pregnancy in December.

I am grateful to the nurse/administrator and to the members of the board for their dedication of time (approximately 1500 hours in 1979) and of their committee efforts which have made an efficient organization.

ARTICLE 2. To hear reports of agents, auditors, committees or officers chosen, and pass any vote relating thereto.

The Moderator, H. Claude Mowry, opened the polls for voting at 3:00 P.M. Prior to opening the polls for voting, James O'Neil, Jr. and Evelyn Callahan were appointed for ballot clerks and took the Oath of Office from the Moderator, H. Claude Mowry. Wayne Winn was sworn in as Assistant Moderator and Joyce Winn as Assistant Clerk after being appointed by the Moderator.

At 8:00 P.M. the Moderator, H. Claude Mowry, called the meeting to order for the purpose of acting on articles in the Warrant. The Moderator read the articles in the Warrant.

The articles were disposed of as follows:

ARTICLE 2. Earl Yeaw moved that the reports of agents, auditors, committees or Officers chosen be accepted as printed in the Annual Town Report and placed on file. Seconded by Clara B. Wellington. Moderator declared approved by a voice vote.

ARTICLE 3. Jay Woodman moved and seconded by Gary Winn to accept article 3 as read. That the district authorize the board (school) to make application for and to accept and use in the name of the district such advances, grants-in-aid, or other funds for Educational purposes as may now or hereafter be forthcoming from the United States Government, the State of New Hampshire, or any department or agency thereof, or any Federal, State or private Agency. The Moderator declared the motion carried in the affirmative.

ARTICLE 4. Robert Woodman made the motion then seconded by Clara B. Wellington on article 4, that the District raise and appropriate the sum of \$767,847.00 for the support of schools for the salaries for the School District Officers, agents and for the payment of Statutory obligations of the district. Moderator called for discussion. Mike Wiggan moved to amend the amount of money to be appropriated from \$767,847.00 to be increased by \$9,700.00 making the total amount to be appropriated \$777,547.00. Amended motion was seconded by Richard Wolf. After much discussion, pro & con, then the breakdown, of additional monies:

Raise of School Principals Salary	\$ 900.00
Clerical Worker Wage Increase	500.00
Keeping the Extra Teacher	7800.00
Teachers Supplies	500.00
Total Increase	<u>\$ 9700.00</u>

This increase is the difference from what the budget committee approved. Moderator asked for a show of hands on the amended motion, the motion was approved, the Moderator declared the amended motion carried in the affirmative. Approved \$777,547.00

ARTICLE 5. James O'Neil, Sr. moved and was duly seconded that article 5 be accepted as written. To see if the District will vote to authorize the school board to contract with a qualified independent auditing firm or the Department of Revenue Administration for the fiscal year audit, in

accordance with the laws of the State of New Hampshire (R.S.A, 197:14 Revised). Said authorization to remain in effect until such time as the District votes to elect local auditors as provided by state statutes and further, the term of the auditor elected this date under Article I shall become null and void and the term of the previously elected auditor shall terminate June 30, 1979. Moderator declared motion carried in the affirmative.

ARTICLE 6. Erroll Sowers moved then seconded by Merrill Yeaw to see if the district will vote to raise and appropriate the sum of \$300.00 to effectuate the purpose of Article 5. Motion passed over.

ARTICLE 7. Other transactions of business.

Motion by Nancy Belsky and seconded by Robert Laneau states: Be it resolved that the Board of Education of the Chesterfield School District shall appoint a committee to investigate and report at a special School District Meeting to be called by the School Board to be held at the Chesterfield School District on Saturday, September 15, 1979, at 7:30 P.M., the possibility of increasing the Board of Education of Chesterfield School District from 3 to 5 members and establish at that time the term of office. Motion was adopted.

Motion made by Robert Cannell and seconded by Richard Benjamin to adopt the following resolution:

Be it resolved that the Board of Education of the Chesterfield School District shall appoint a committee to investigate and report at a special School District Meeting to be called at the Chesterfield School on Saturday, September 15, 1979, at 7:30 P.M., the feasibility of establishing a kindergarten within the Chesterfield School District; and further that this report include costs and effects relating to transportation, housing, salaries operating costs, and any state or federal monies which might help to establish or partially fund such a program.

Be it further resolved that pursuant to the presentation of the facts and recommendations of the board and any discussion from interested persons in the community, the issue be placed on the Spring 1980 school warrant and the voters be asked to decide by Australian Ballot whether or not they wish to incorporate a Kindergarten into their District School. Motion was adopted.

Motion made by Nancy Belsky and seconded by Robert Laneau to adopt the following resolution:

Be it resolved that the Board of Education of the Chesterfield School District shall appoint a committee to investigate and report at a special School District Meeting to be called by the School Board to be held at the Chesterfield School District on Saturday, September 15, 1979 at 7:30 P.M., the possibility of increasing the Board of Education of Chesterfield School District from 3 to 5 members and establish at that time the term of office. Motion was adopted.

Erroll Sowers made a motion and seconded by Charles Johnson that the Chesterfield School Board appoint a 3 person committee to investigate the student drop-out rate problem, to make recommendations as to what course of action could be taken to reduce the number of drop-outs and make its reports not later than June 1, 1979. Motion was adopted.

The Moderator declared the polls closed for voting at 9:30 P.M.

A motion was made and duly seconded that the meeting be adjourned. On a voice vote the Moderator declared the motion carried in the affirmative. The meeting was adjourned at 10:58 P.M.

ADMINISTRATIVE REPORT

The current trend in American education today is to ensure that the students receive an adequate background in the 'basics'.

The emphasis in the 'Town' school districts this past year has been the development of curriculum guides. These guides will help insure that the students receive the basic skills in a sequential order, and also guarantee that all students will be exposed to the same skills in their elementary education.

The curriculum committee has been working for the past year to develop a language arts curriculum guide. This guide will be in the hands of the 'Town' teachers by September, of 1980 and is to be used as a student record system enabling the teachers and parents to know what skills each child has mastered.

In order to evaluate our educational system, all students in the 'Towns' will be given a national achievement test in the Spring of 1980. The results of these tests will be used as a guide for teacher curriculum development. Parents will be urged to contact their school and obtain a copy of their child's test report. These reports should be retained by the parents and compared with the test results of the achievement tests given early each spring.

It is the hope of the school board and staff that by developing curriculum guides, and monitoring the progress of the students through achievement tests, we will be able to improve the quality of education for our students.

We wish to thank the school board and teaching staff for their assistance in the above projects. Also, the administration of the Keene Junior High School and Keene High School for their assistance in the curriculum projects. They have given freely of their time and abilities to begin the process of upgrading the education of the students in our community.

PRINCIPAL'S REPORT

The 1979 - 1980 school year opened on September 4, with 314 students.

New to the Chesterfield staff this year are: Irene Alexa, grade five; Deborah Child, grade one; Bernadette Kuhn, Science, Grades 6-8; Kathleen York, Title I teacher; Carl Walley, Principal.

The American Legion Home was leased in order to provide space for the increased school enrollment. Mr. Jonas' fifth grade class moved into the Legion home.

Chesterfield, along with the other towns of School Administrative Unit 29, began the process of writing a Curriculum Guide for Language Arts. The purpose of the guide is to coordinate instruction in reading, grammar and spelling among Chesterfield and the other schools in School Administrative Unit 29. The purchase of new mathematics textbooks for the upper grades completes the placement of the new series begun two years ago. In addition, new textbooks were purchased for English, grades 6 - 8.

Our Parent-Teacher Association received an award from the State Parent-Teacher's Association. Our association is ranked as one of the more effective groups in the state. The Parent Volunteer Program continues to provide meaningful service to Chesterfield students under the direction of Jean Mansfield, Volunteer Coordinator.

Through an Artist in Residency program students are being introduced to a variety of artists and art disciplines such as drawing, weaving, song writing and mask making.

Several committees were established to study various aspects of education in the Chesterfield School District. The reports presented in September dealt with a study of reasons for Chesterfield's high dropout rate, the feasibility of a public kindergarten and the need for a five-member school board. Additionally, the board established a Health Curriculum Committee to select a comprehensive health curriculum which would meet the State of New Hampshire requirements.

As a final word, I would like to thank the individuals and organizations who have devoted their time and resources to our school. I would also like to thank the staff, students, school board and central office administrators for their assistance in making the school year a success.

SCHOOL HEALTH SERVICES REPORT

Immunization levels of 99% of our school population have been updated successfully, this goal was reached with much emphasis and cooperation of the parents of our community.

Physical appraisals were performed by our school physicians to all students participating in interscholastic athletics and 4th and 8th grade.

Preschool Vision and Hearing Clinic (PSVS-PSHS) was held in May with the cooperation of the Chesterfield Home Health Agency. Preschool children (ages 4-6) were invited from Westmoreland and our community. Fifty-six children participated. Six children were identified with hearing loss. Pretesting after three weeks and done with the Pure-tone audiometer and appropriate referrals to physicians made at that time.

Dental Health Education and treatment was accomplished with the Dry Brushing Program and Dental Clinic, organized and supported by the P.T.A. and this office.

CHESTERFIELD LUNCH PROGRAM
1978-1979

The School Lunch Program served lunch from the opening day of school to the closing day. Two-thirds of the children participated in the lunch program. We try to teach them to 'Learn to eat and eat to learn'.

Free and reduced lunches are offered to all children with applications which are sent home the first week of school. The price of the meal remained at 45¢ and this included their lunch milk. Recess milk and extra milk are available at 5¢.

The menu is sent home monthly. Lunch money 'collection day' is on Friday, which is an advance payment for the following week. Parents may pay by the week or month, by cash or check, whichever is most convenient. The menu was also sent to the two radio stations in Keene.

Government surplus foods continued to be plentiful through the year. This helped to keep the program costs down and provided us with many good things to eat. We received turkeys, hamburger, canned beef and chicken, canned fruits and vegetables, peanuts, raisins and flour at a very small cost for the program.

We enjoy our work and try to encourage your children to try new foods. We also encourage them to use the menu to choose their meals for the week as this cuts down on plate waste. We welcome your suggestions, your ideas and/or concerns. Please stop in and see us.

Special School District Meeting to hear reports

The moderator, Errol G. Sowers, called the meeting to order at 7:30 P.M. Mrs. Dorothy O'Neil was sworn in as assistant moderator. The warrant was read by the Moderator.

The purpose of the meeting as stated in the warrant was to "hear reports of committees established by the Chesterfield School District at their annual meeting held March 10, 1979.

A. Committee to study the possibility of increasing the school Board of the Chesterfield School District from three to five members.

B. Committee to study the feasibility of establishing a Kindergarten within the Chesterfield School District.

C. A continuation of the report of the committee to study the drop out rate of Chesterfield students attending Keene High School."

The report of investigation of three and five member school boards was presented by committee chairman, Thomas Allen.

Discussion of this report centered around the following points:

The ability of a five member board being more able to handle problems than a three member board.

Limited feedback from other School Boards in New Hampshire towns of size similar to Chesterfield, and questions if these boards have problems such as those in Chesterfield.

The chairperson felt that this committee's work must continue in order to get more information from other town's board members, and to see if they have similar problems. The committee felt that the 3 member board was doing a good job.

The question of whether 2 additional members would be more effective was left open because this issue must be decided upon by voters at some future District Meeting.

Report of the feasibility of incorporating a Public Kindergarten into the Chesterfield School District was read by chairman, W. Neil Manders. This committee's report was presented on a strictly budgetary basis in order to stay away from any philosophical issues.

Discussion centered around the following points:

- A. The possibility of using one of the following buildings to house a public kindergarten:

1. The American Legion Hall
 2. The Town Hall
 3. Camp Spofford (Which currently houses the Tiny Tots Kindergarten, a private cooperative kindergarten.)
 4. A temporary classroom building separate from the main school building.
 5. Space within the existing Chesterfield Central School
- B. Problems associated with the use of various buildings:
1. Lack of water and insulation in the Legion Hall.
 2. Lack of space and the current overcrowding in the present School building.
 3. Conflict of use, and lack of water in the Town Hall.
 4. Distance from the Central School to Camp Spofford, and possible subsequent necessity of employing an aide, and administrative supervision difficulties.
 5. A temporary classroom, or building, could soon become a "permanent" one and a subsequent eyesore. It would also add an additional load to the school water and sewer systems, but it was thought that these systems could handle this load.

C. Busing of Kindergarten students home at noon and the problems associated with half day arrangements, including the cost of extra bus runs, the legal requirements of having to provide buses, split sessions, morning and afternoon, and/or day care afternoon session.

D. Other problems:

1. All financial figures by the committee were at best educated guesses, because the committee could not enter into direct negotiations with other parties involved.
2. The question of how temporary a "temporary" classroom would be, the availability of such units, the appearance and use of such a building after several years of use.
3. The question of overcrowding presently at the Chesterfield Central School with 311 students.

The committee recommended that a Kindergarten be incorporated into the school system, and if possible, in the present school building. If use of the school was not feasible then they recommended the use of the American Legion Hall as a temporary building until such time as the student population decreases or a building program is undertaken.

A short recess was declared to allow the third committee to set up their presentation. Because the Moderator was chairman of the committee, he relinquished the Moderator's chair to the assistant moderator, Mrs. Dorothy O' Neill, for the duration of the report and discussion session.

The committee's report, Findings and Recommendations Pertaining to Chesterfield Student Drop-Out Problem, was presented by the committee chairperson, Errol G. Sowers.

Much of the discussion following the report centered around the "Facts and Findings" section on pages 2-4, and included personal observations from committee members, Chesterfield teachers, parents of Chesterfield students now, or in the past, enrolled at Keene High School, and former students.

Possible solutions were also presented in the report and elaborated on. The major points discussed being:

1. The use of a late bus to encourage Chesterfield students to remain at Keene High School to make up work that was missed for various reasons, and to compete in practice and games with the athletic teams.
2. Orientation at Keene, more accurate description of courses. This was recommended not only for the students, but also for the eighth grade teacher at Chesterfield who helps in the selection of courses for students before they go to Keene.
3. Monitoring of "warning indicators" that show which students may be possible drop-outs, and counselling them and their parents before problems arise.

The committee expressed a desire that this study not be stopped now, but continued, and the recommendations be followed out in order to assure that Chesterfield be responsible for graduating young men and women of high character, sound integrity, and who can demonstrate minimum proficiency in the basic academic subjects and skills.

The committee was congratulated on a fine report, which the public felt touched on all points of concern, and made very reasonable and productive recommendations.

The meeting was turned back to the moderator, who adjourned the meeting at 10:17 P.M.
