TOWN WARRANT

The State of New Hampshire

To the inhabitants of the Town of Warren in the County of Grafton in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at The Town Hall in said Warren on Tuesday, the Eighth day of March, next at nine of the clock in the forenoon, to act upon the following subjects:

1. To choose all necessary Town Officers for the year ensuing.
- 2 To raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriations of the same.
3. To hear the report of Selectmen and other Town officers and pass any vote relating thereto.
4. To raise and appropriate money to maintain Highways and bridges, and raise and appropriate or set aside some amount of money for sidewalk fund.
5. To see if the Town will vote to accept State Aid for Class V Roads and raise and appropriate or set aside for said purpose a sum in accordance with the action of the present legislature.
6. To raise and appropriate money to maintain street lights
7. To raise and appropriate money for support of fire department.
8. To raise and appropriate money for town library purposes.
9. To raise and appropriate money for Town Poor Old Age Assistance and Soldiers' Aid.

10. To raise and appropriate money for Memorial Day and care of Parks and Playgrounds.

11. To raise and appropriate money for cemeteries.

12. To see what sum of money the Town will raise for White Pine Blister Rust control and pass any vote relating thereto.

13. To see if the Town will vote to raise the sum of \$400.00 as a bonus for Dr. F. J. Kasheta, and pass any vote relating thereto.

14. To see if the Town will vote to raise \$1,000.00 and authorize the Selectmen to hire as much more money as may be necessary with State Aid to replace the Foote Bridge so called.

15. To see if the Town will vote to raise and set aside \$1,000.00 for use toward purchase of fire equipment.

16. To raise and appropriate the sum of \$400.00 toward running Town Lines.

17. To see if the Town will vote to raise and appropriate a sum of money sufficient to make over a room in the Town Hall to be used as an Office for the Selectmen.

18. To see if the Town will vote to raise and appropriate the sum of \$600.00 to the Sceva Speare Memorial Hospital Association for the construction of a new hospital, or take any action relating thereto.

19. To see if the Town will vote to raise and appropriate the sum of \$59.86 to the White Mountains Region Association, being 10 cents per \$1,000. of assessed valuation (1-100 of 1%) for the purpose of issuing and distributing printing matter and otherwise publicizing the advantages of the town in cooperation with the 45 other towns in the region.

20. To see if the Town will vote to raise the salaries of the Selectmen and take any action relating thereto.

21. To see what action the Town will take relative to a reroute of the Beech Hill Road, and take any action relating thereto.

22. To see if the Town will vote to grant a discount on property taxes of 1949 and determine date and percentage of same.

23. To authorize the Selectmen to hire money in anticipation of taxes.

24. To see if the Town will vote to petition the State Tax Commission to have an audit made by the Division of Municipal Accounting, and to make an appropriation to cover the expense of such audit.

25. To transact any other business that may legally come before said meeting.

Teachers and Pupils: Two new teachers were employed to replace those leaving the District last June. Mrs. Dorothy Jesseman, a graduate of Plymouth Teachers' College with a B. Ed. degree, became Principal and teacher of grades 6-8, replacing Howard Evans, who accepted a Principalship in Haverhill. Mrs. Christie Caldron of North Woodstock, replaced Mrs. Mable Cole who returned to her home in Walpole, New Hampshire. Mrs. Caldron teaches in grades 4 and 5.

Buildings and Grounds: Major repairs were made at the Village school during the summer by remodeling of the north end of the lower hallway to accomodate an enlarged toilet room for the girls in which sanitary flush toilets were installed, as well as radiation. The School Board is to be highly commended for this outstanding improvement to the school plant. It is hoped that a similar change may be made for the boys. General minor repairs were made to both school buildings.

The diligent work of the members of the newly organized Parent Teachers' Association deserves high praise. The playground equipment erected at both the Village and the Glenciff schools is a project of outstanding merit. The health of our youth is a serious matter, and one we too often neglect. The apparatus installed by the P. T. A. will have benefits undetermined by the casual observer. The teachers, School Board, and your Superintendent are especially grateful for this equipment.

General Information: During the year, the Co-operative Secondary School District Committee, composed of members of the School Board, Mrs. William Whitcher, and Mr. Fayne Anderson, met several times during the year. The findings of this committee show a need for such a Co-operative District. Many facts substantiate this premise, a few of which I present for your consideration:

1. A secondary school with less than 300 pupils cannot be economically administered. The proposed school would enroll 350-400 pupils, grades VII-XIII.
2. A small secondary unit cannot offer a program of sufficient scope to meet the varying interests of the majority of its students. The proposed school should include such additional practical courses as the following: Vocational Agriculture; Cabinet making; Sheet Metal work; Shop Mathematics; Distributive Education; Paper-hanging; Dress designing; and Beauty Culture.
3. The small secondary units necessitate duplication of instructors on the staff.

The secondary school to be effective as an educative institution, should offer a curriculum that will enrich our children's ability to do a better job in a complicated society. This can only be done by a school unit of sufficient size to include a faculty competent to offer a varied program.

Conclusion: I wish to express my appreciation to the Members of the School Board for their help in the administration of school affairs, to the residents of the district for their efforts on behalf of education, and to the teachers for their loyal and conscientious service.

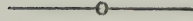
