THE WARRANT

THE STATE OF NEW HAMPSHIRE.

To the inhabitants of the Town of Sutton in the County of Merrimack, in said State, qualified to vote in town affairs: You are hereby notified to meet at the Town Hall in said Town of Sutton, on Tuesday, the ninth day of March next, at nine of the clock in the forenoon to act on the following subjects:

- 1st. To choose all necessary Town Officers for the year ensuing.
- 2d. To raise such sums of money as may be necessary to defray town charges for the ensuing year, and make appropriations for the same.
- 3d. To see how much money the town will vote to raise and appropriate for the repair of highways and bridges for the ensuing year.
- 4th. To see if the town will vote to accept State Aid and raise and appropriate money for the same.
- 5th. To see how much money the town will vote to raise and appropriate for the maintenance of State highways.
- 6th. To see how much money the town will vote to raise and appropriate for street lighting.
- 7th. To see how much money the town will vote to raise and appropriate for Old Home Day.
- 8th. To see what action the town will take in regard to purchasing and erecting a tablet or other suitable memorial for the veterans of the Great War.
- 9th. To see how much money the town will vote to raise and appropriate for the support of the New London Hospital and Nursing Association.
- 10th. To see how much money the town will vote to raise and appropriate for the purpose of cooperating with the state and federal government in the control of the white pine blister rust.
- 11th. To see how much money the town will vote to raise and appropriate for a district nurse.

12th. To transact any other business that may legally come before said meeting.

SCHOOL REPORT.

REPORT OF SUPERINTENDENT OF SCHOOLS.

Members of the School Board:

Entering upon my work as the first superintendent of schools for your district, I found the school buildings, school rooms and toilets in good condition, showing the fidelity and efficiency of the school board.

The work of the schools I will discuss under three heads: Organization, Discipline, and Instruction.

The premises, buildings and school furniture were kept clean. The school rooms were properly warmed and ventilated. The classification of the scholars, the following of a daily timetable, showing to each class the subject taught and the time and length of each recitation, and the prompt opening and closing of the schools were not as carefully observed as would bring about the best results.

In most of the schools the discipline was commendable. In one school the teacher was inclined to resent suggestions for improvement in her method of work and discipline.

The instruction was too dogmatic, the teachers apparently having little idea of correlating and unifying the work in the different branches.

SCHOOL ATTENDANCE.

Unless excused for physical or mental reasons, any child of school age must attend a public or an approved private school all the time such school is in session. It is the particular duty of the truant officer to see that this law is enforced. I know of no other civil law so frequently violated by otherwise law-abiding citizens as is the school attendance law.

The effect of non-attendance at school is most pernicious both to pupil and school. A day out of school is a day lost in the pupil's school life. A large percent of retardation or lack of promotion is caused by irregular attendance.

RECOMMENDATIONS.

In making a survey of the schools of your district, I would recommend that your schools be consolidated into two or three buildings. This would mean that the district would own covered and heated barges for the conveyance of the pupils, the employment of a trustworthy person as driver, and that the barges run on schedule time, thus preventing tardiness and non-attendance.

These schools should have facilities for teaching manual training, cooking, sewing, school gardening and elementary agriculture. Sutton is primarily an agricultural town and the course of study should tend to promote its agricultural resources.

Consolidated schools mean a building of few rooms, with approved and qualified teachers, equipped with modern improvements.

In conclusion, I wish to thank the citizens, teachers and members of the school board for their sympathetic co-operation. The members of the school board were deeply interested in the welfare of the pupils and anxious to bring about modern improvements.
