## District Warrant

THE STATE OF NEW HAMPSHIRE—ROCKINGHAM.SS.

To the Inhabitants of Little Boar's Head District (a village district in the Town of North Hampton, organized under provisions of Chapter 196, Session Laws of 1905) qualified to vote in District affairs:

You are hereby notified to meet at Union Chapel, 7 Willow Avenue, in said District, on the first Tuesday of September next — September 2, 1980 — at half past seven o'clock in the evening (7:30 P.M.) for the following purposes:

- **Article 1**. To elect a Moderator, a Clerk, a Treasurer, and an Auditor for the ensuing year.
- **Article 2.** To elect one Commissioner to serve for three years (following the expiration at this meeting of the term of the present Commissioner Daniel F. Reagan).
- **Article 3.** To hear the reports of the Clerk, Treasurer, Commissioners, Zoning Inspectors, and other officers of said District, and to take such action as may be desired with regard to them.
- **Article 4.** To take such action as you may desire in regard to allowing the same discount on District taxes as may be allowed by the Town of North Hampton on town taxes.
- **Article 5.** To take such action as you may desire in regard to giving the Treasurer of the District authority to borrow money in anticipation of taxes.
- **Article 6.** To see if the District will vote to transfer \$1,200.00 from its unexpended surplus at the close of the fiscal year ending August 31, 1980, into the existing Capital Reserve Fund for the financing of all or part of the cost of construction or reconstruction of sidewalks and/or parks, as capital improvements in this District. (Recommeded by the Budget Committee.)
- **Article 7.** To see if the District will vote to designate the District Commissioners as its agents carry out the objects of, and to determine the expenditures to be made from the

Capital Reserve Fund established under the preceding and any prior year's article, and to authorize the payment from said Capital Reserve Fund of such bills for sidewalk and/or park construction or reconstruction within the scope of said Capital Reserve Fund, as said Commissioners or a majority of them shall approve from time to time.

**Article 8.** To see if the District will vote to accept in whole or in part the budget as submitted by the Municipal Budget Committee.

Article 9. To raise and appropriate such sums of money as may be needed for the purposes included in the Budget, including the extinguishment of fires, the lighting or sprinkling of streets, the planting and care for shade and ornamental trees, the supply of water for domestic and fire purposes, the construction and maintenance of sidewalks and main drains or common sewers, the construction and maintenance and care of parks or commons, the maintenance of activities for recreational promotion, the control of pollen, insects and pests, the impoundment of water, the maintenance of roads, the appointing and employment of watchmen and police officers, the enacting and enforcing of zoning regulations, and all other miscellaneous District expenses for the ensuing year.

**Article 10.** To transact such other business as may legally come before said meeting.

## Commissioner's Report Little Boar's Head District 1979-1980

#### 1. THE BEACH AREA

The Little Boar's Head bathing beach has changed. No longer is it a family beach to which we all repaired about 10:00 a.m. — where everyone knew everyone else, and where certain groups had "their" section of sand to themselves and their own particular friends. Nowadays there are no parking spaces left at 10:00 a.m., and most of the cars are from out of state.

However, some changes have been for the better. The State, after taking control last year, has this year put up "comfort" stations and made parking spaces for the handicapped. There are now two lifeguards, in place of the one previously, and with radio communication to Hampton Beach. Best of all, the State has made a serious effort to keep the parking area and the beach clean.

The traffic has been extremely heavy on Ocean Boulevard. The count for this past month of June alone was 172,424 vehicles — an average of 5747 cars a day — with doubtless a much larger count for July and August. This has created additional police problems, since U.S. Route 1-A, though a State road, is patrolled by the Town, which currently has two police cruisers on duty 7 days a week. The State keeps its police to patrol U.S. Routes 1 and 95.

With more State control, certain privileges have gone. No more fires are allowed on the beach; rubber rafts are not allowed; and boat launching in the central bathing area has been discouraged. This last is still permissible, however, in the vicinity of the Fishhouses.

Overall, conditions have improved, and the beach has been made safer and cleaner. We believe that in the future, the State will be compelled to assist with the traffic problems, particularly at night. Currently a great many more people (and many of them out-of-towners) can enjoy our bathing beach, even though it may have become less desirable for the "old timers."

#### 2. SIDEWALKS

After the extensive repairs that had been made to our walk-ways on Atlantic Avenue, Sea Road and Ocean Boulevard during the fiscal year of 1978-1979, the Commissioners limited this past year's sidewalk expenditures to the Bass Beach shale pile area. A large portion of the plank walk installed there each Spring had become unusable, and it was felt that a more permanent walk-way would alleviate the need for expensive annual replacements. A black-top walk-way three feet in width was installed from the Rye Beach District line south for 100 feet or more. Future extension of this walk will await determination of the physical stability of the shale pile, now that the State has reinforced it a year ago with a lining of massive rocks.

#### 3. BUDGETS

As will be seen in the latter section of this report, the District has remained well within its budgetary limitations this past year. From its 1979-80 budget of \$12,500.00, total expenditures have been \$8,596.63. Included in this latter figure is the initial funding of \$2,500.00 for the establishment of a Capital Reserve Fund for the financing of all or part of the costs of construction or reconstruction of sidewalks and/or parks. From this account \$1,200.00 were used to partially pay for the extensive sidewalks renovations completed previous to our last annual meeting, but paid for in the 1979-80 fiscal year. The remainder of our 1978 Disaster Aid Fund (\$2,162.61) was also used during this period to pay for such renovations.

As of the date of this report, the district's bank account had a balance of \$4,556.79, the major part of which surplus will be available to fund a large portion of our district's expenses for the coming year, and should result in a reduction in the Little Boar's Head District tax rate below last year's rate of \$1.00 per \$1,000.00 of value.

#### 4. ZONING COMMISSION

With the regretted death last spring of Frederic C. McCabe, a member of our Zoning Commission since 1971, we have at present only two members left. Mr. McCabe gave much time and thought to the amendments of our Zoning Ordinance. It is desirable for the District to appoint a third member to fill the vacancy before further extensive amendments to the Ordinance.



# The Post Office At Little Boar's Head

It was built about 1881 on the present site of the garage of Mrs. J. D. Cahill at 17 Atlantic Avenue, and ceased operation there in 1920. In 1922 the structure was moved to the field behind the home of Mr. and Mrs. Daniel F. Reagan, and in 1930 it was sold and moved to its present location — off High Street in Hampton.

During Republican administrations, starting with those of Presidents Garfield, Arthur, and Harrison the Postmaster was Albert Bachelder, with the post office as above. During Democratic administrations of President Cleveland, the Postmaster was Otis S. Brown, with the post office in the building at 8 Atlantic Avenue, now owned by Mrs. Richard Kent and occupied as the summer home of Mr. and Mrs. Donald Rockwell.
