TOWN WARRANT
THE STATE OF NEW HAMPSHIRE

The polls will be open from 10:00 A.M. to 7:30 P.M.

To the Inhabitants of the Town of Kensington in the County of Rockingham in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at the Town Hall in said Kensington on Tuesday, the Tenth day of March, next at 10:00 of the clock in the forenoon, to act upon the following subjects:

1. To choose all necessary Town Officers for the year ensuing.

Polls will close at 7:30 p.m.

You are hereby notified to meet at the American Legion Hall in said Kensington on Thursday, the Twelfth day of March next at 7:30 p.m. to act upon Article 2 and subsequent articles.

2. To raise such sums of money as may be necessary to defray Town charges for the ensuing year and make appropriations of the same. Selectmen's estimate of expenditures for the ensuing year is \$169,058.79.
3. To see if the Town wishes to allow a discount on taxes paid within 30 or 60 days after presentation of tax bills.
4. To vote on the basis of payment and the amount thereof to be paid to the Tax Collector for the collection of taxes.
5. To see if the Town will grant the Selectmen authority to borrow money in anticipation of taxes.
6. To see if the Town will vote to appropriate the sum of Four thousand three hundred ninety six dollars and twenty two cents (\$4,396.22) from the Revenue Sharing Fund to be transferred to the Capital Reserve Fund, established for the investment of a Town Office Building.
7. To see if the Town will vote to install a water hole on Route 107 on the property of William E. Simon, said water hole to be graded, fenced and a hydrant installed and to allocate to said installation the sum of Four thousand five hundred dollars (\$4,500.00) which was raised and appropriated pursuant to Article 14 in the Warrant at the Annual Town Meeting in March 1980.
8. By petition of David C. Heasley and others, to see if the Town will vote to discontinue that portion of Austin Road, so-called, running Westerly from the premises of David and Janet Heasley, provided that no owner of land along that portion so discontinued shall, without his written consent, be deprived of access over that portion, at his own risk. Subject to bars and gates.
9. To see if the Town will authorize the Selectmen to enter into an agreement with the E M T Ambulance Service of Exeter for stand-by Ambulance Service and to raise and appropriate Two

thousand six hundred sixty six dollars, (\$2,666.00) for this service.

10. By petition of David W. Smith and others, to see if the Town will vote to petition the Representatives and Senators who represent the Town in the General Court to support in the current session of the General Court, the concurrent resolution to amend the State Constitution to limit the annual increase in property taxes to five percent and to limit the annual increase in spending by the state or any city, town, or other governmental unit of the state to five percent.

11. By petition of Sandra Gavutis and others, to see if the Town will appropriate the sum of One hundred sixty-five dollars (\$165.00) to the Greater Raymond Community Action Center, a part of Rockingham County Community Action Program, Inc., a private, non-profit, anti-poverty agency. This figure represents 2.5% of Six thousand Six Hundred Sixteen dollars, (\$6,616.00) the value of services rendered to Kensington residents from September 1, 1979 through August 31, 1980, and will be used to continue services to Kensington residents during the upcoming year.

12. By petition of Judith S. Pease and others, to see if the Town will vote to raise and appropriate the sum of Sixty eight dollars (\$68.00) to assist Rockingham Child and Family Services, a private, non-profit organization. The amount of this request is based on services rendered to 7 residents of the Town of Kensington during the period July 1, 1979 through June 30, 1980, inclusive. These residents used One hundred seventy five (\$175.00) worth of services, however, only One hundred seven (\$107.00) could be billed according to their ability to pay. We therefore request the minimum amount needed from the Town, in this instance being Sixty eight dollars, (\$68.00). These funds to be used for current operating expenses to enable Rockingham Child and Family Services to continue providing individual and family counseling for residents of the Town of Kensington whether or not said residents are able to pay.

13. By petition of Hubert H. Schweizer, Jr., and others, to see if the Town will vote to authorize the purchase of a new Ambulance and necessary equipment, said Ambulance to meet State Emergency Medical Service requirements: and for this purchase, to raise a sum not exceeding Twenty six thousand eight hundred dollard (\$26,800.00) by issue of serial notes of the Town, under and in accordance with the provision of Chapter 33 (Municipal Finance Act) of New Hampshire Revised Statutes Annotated as amended, the discretion of fixing the date, maturities, interest rate or discount rate, the place of payment, the form and other details of said notes to be delegated to the Selectmen.

14. By petition of Hubert H. Schweizer, Jr., and others, to see if the Town will raise and appropriate the sum of Three thousand five hundred dollars (\$3,500.00) for operation expenses for an Ambulance Squad.

15. By petition of Frank W. Rosencrantz and others, to see if the Town will vote to have a professional appraizal firm or the Appraisal Division of the Department of Revenue Administration,

to conduct a complete revaluation starting in 1982 and to establish a Capital Reserve Fund for the purpose of conducting such revaluation.

16. By petition of Frank W. Rosencrantz and others, to see if the Town will raise and appropriate the sum of Ten thousand dollars (\$10,000.00) to be placed in the Capital Reserve Fund for the revaluation of the Town by a professional appraisal firm or the Appraisal Division of the Department of Revenue Administration. The Selectmen to include in the annual warrant (1982) the total cost of a complete revaluation of the town and raise such sums as may be necessary. Estimated cost by the appraisal Division Department of Revenue Administration, Nineteen thousand, six hundred fifty dollars(\$19,650.00).

17. To see if the Town will vote to raise and appropriate the sum of three thousand six hundred dollars (\$3,600.00) for the purchase of land adjacent to Town land in rear of Town Hall from Patricia Williams and Edith Babkey. This land is for the purpose of a roadway and parking area for Town Office Building. Cost of land, three thousand dollars (\$3,000.00) Selectmen's estimate of appraisal, closing costs and surveying costs, six hundred dollars (\$600.00).

18. To see if the Town will vote to appropriate Fifty thousand nine hundred seventy three dollars and sixty one cents (\$50,973.61) for a Town Office Building and authorize the withdrawal of the amount required for this purpose from the Federal Revenue Sharing Fund. This amount includes Eight thousand one hundred eleven dollars ;(\$8,111.00) which is 1981 allocation.

19. To transact any other business that may legally come before the meeting.

You are hereby notified to meet at the Town Hall, in said Kensington on Tuesday the eleventh day of March next, at ten o'clock in the forenoon, to choose all necessary Town Officers for the ensuing year, by official ballot and to take action required on said official ballot; the polls to open at ten o'clock in the forenoon and to close not earlier than seven-thirty o'clock in the evening, and thereafter to reconvene at the American Legion Hall on Thursday, March thirteenth, 1980 for the purpose of acting upon all other matters to come before the meeting.

ARTICLE 1. To choose all necessary Town Officers for the year ensuing.

ARTICLE 2. On ballot: petition by Elias P. Collins and others to see if the Town will vote to adopt the provisions of Revised Statutes Annotated 72:43-a through c regarding expanded elderly property tax exemptions for those property owners who own assets of any kind not in excess of \$50,000 and meet certain other age and annual income requirements, with such Statutes to be the subject of a public hearing to be held by the Board of Selectmen in conformance with the provisions of RSA 72:43-a before the date of the Annual Town Meeting, with such question to be placed on the ballot for that Meeting as follows:

Shall we adopt the provisions of RSA:43-b and 43-c for expanded exemptions on real estate which provide for a resident 65 years of age up to 75, a \$5,000 exemption; a resident 75 years of age up to 80, a \$10,000 exemption; provided that the resident owns the real estate individually or jointly with another or his spouse with whom he has been living for at least 5 years as man and wife; said resident had a net income of less than \$7,000 or combined income with spouse of less than \$9,000; and owns assets of any kind, tangible or intangible, less bona fida encumbrances, not in excess of value specified in RSA:43-c III; provided that the exemption shall be based upon assessed value of the real estate? YES 245 NO 79

ARTICLE 3. On ballot: petition by William B. Grant and others, to see if the Town will vote to adopt Amendent to RSA:56 by inserting after section 40 the following new section:

1. Application to Town Clerk or City Clerk: Changes to be forwarded. A Town or City Clerk may permit changes in party affiliation to be registered with a Town or City Clerk.
2. In addition to the methods of changing party affiliation provided in RSA 56:40, any person whose name appears on the checklist of a Town or ward may apply to the Town or City Clerk for the purpose of having his party affiliation changed. A person desiring to change his party affiliation shall state to the Town or City Clerk under oath of affiliation:
 - (a) He intends to affiliate with and generally supports the party with which he offers to register: or
 - (b) He does not wish to register as a member of any party. YES 203 NO 109

ARTICLE 4. To see if the Town will vote to amend the Zoning Ordinance Article 2 by adding the following:

There shall be no more than one dwelling or residence on a parcel of land, except for multiple dwellings as permitted by Article 13. YES 230 NO 144

ARTICLE 5. To see if the Town will vote to amend the Zoning Ordinance Article 28 by revising the number of building permits and extend termination date until the March Town Meeting of 1981 as follows:

To guide the growth of the Town in such a manner not to exceed its capacity for providing expanded services to support such growth, the following restrictions are set:

- (a) Building permits for new buildings will be limited in each calendar year to four building lots or lots occupying

20 percent of the parcel, whichever is greater. A building permit for a new dwelling will expire one year from date of issue if above-ground construction has not begun. (b) All parcels are defined as those contiguous areas under a single ownership as shown on the Kensington tax map of April 1, 1976, regardless of subsequent division or combination.

(c) Subdivision plats will be processed and approved as whole and shall be marked with locations of the records of the building inspector.

(d) Mobile home permits will be limited to one permit per parcel.

(e) Permits for non-dwelling construction or permits for expansion, alteration, or replacement of existing buildings will not be affected by this article.

(f) This article will be in effect until the March Town Meeting of 1981. YES 241 NO 127

ARTICLE 6. To see if the Town will vote to amend the present subdivision control regulations to permit the Planning Board to review and regulate site plans and industrial developments and Multi-family dwellings as follows:

Site Plan Review Regulations: For non-residential development, and multi-family development in excess of two(2) units, whether or not such development includes a subdivision or re-subdivision of the site.

1. PURPOSE: The purpose of Site Review Procedure is to protect the public health, safety and welfare; to promote balanced growth; to promote the timing of development to prevent premature and uncoordinated development of land without the adequate provision of public services and facilities; to ensure sound site utilization; to avoid development which may result in negative environmental impacts; and to guide the character of development. The site Review Procedure in no way relieves the developer, his/her agent, or individual from compliance with the Zoning Ordinance, Subdivisions Regulations or any other ordinance which pertains to the proposed development. No site plan will be approved until it complies in all respects to any and all pertinent ordinances and regulations.

2. PROCEDURES: Site Plan Review shall be conducted in accordance with the procedural requirements contained in Subdivision Regulations, Section 3 for review of final plats including the notice to abutters and a public hearing. The list of all abutters shall be submitted to the Planning Board. The cost of notifying abutters will be borne by the developer. If the site plan meets the evaluation criteria and is approved by the Planning Board, then the applicant may apply for a building permit. No building permit will be issued until approval of the site plan is granted. The applicant will be notified of approval or disapproval of site plan.

3. SUBMISSION REQUIREMENTS:

1. Application for Site Review properly filled out

2. Site Plan

(a) Sheet Size 22" x 34" maximum

(b) Scale: not less than 1" = 60'

(c) Match lines when needed

(d) Original on mylar in permanent ink, to be retained by the Planning Board at its option

- (e) Three (3) prints of each plan sheet (blue or black line)
 - (f) Date, title, scale, north arrow, location location map
 - (g) Name and address of developer, designer/engineer, and owner of record
 - (h) Topographical plan with contour lines at two (2) foot vertical intervals. Benchmark from USGS datum
 - (i) Show all easements
3. List of current names and addresses of all abutters within 200 feet of the property line including those across any street.
4. Abutters' notification and public hearing fee of \$25 payable to Town of Kensington.
4. REQUIRED EXHIBITS AND DATA:
The following items are required on site plan(s):
- 1. Sketch of site showing existing natural features including water courses and water bodies, trees and other vegetation, topographical features, any other soils information features which should be considered in site design process;
 - 2. Plan of all buildings with their type, size, location (set backs) and elevation of first floor slab, indicated: (assume permanent on site elevation);
 - 3. An elevation view of all buildings indicating their height, bulk and surface treatment;
 - 4. Location of off-street parking and loading spaces with a layout of the parking indicated;
 - 5. The location, width, curbing and type of access ways and egress ways, plus streets within and around proposed site;
 - 6. (a) an approved sewage disposal plan by NHWSPCC with provisions for future expansion of sewage and water facilities, and all distances from existing water and sewage facilities on the site and on abutting properties to a distance of 200 feet;
(b) Plans for the provision of water for process use, drinking, fire suppressions, etc.;
 - 7. The plan for solid waste disposal
 - 8. The location, elevation and layout of catch basins and other surface drainage features;
 - 9. Existing and proposed contours and finished grade elevations--all contours shall be a minimum of 2-foot intervals;
 - 10. The type, extent and location of existing and proposed landscaping and open space areas will be retained;
 - 11. The location, size and design of proposed signs and other advertising or instructional devices;
 - 12. The size and location of all public service connections - gas, power, telephone, fire alarm, overhead or underground;
 - 13. The type and location of lighting for all outdoor facilities;
 - 14. Lines of all existing adjoining streets;
 - 15. Surveyed property lines showing their deflection angles, distances, radius, lengths of arcs, control angles, along property lines and monument locations and names of all abutters within 200 feet;

16. If a subdivision, then lines and names of all proposed streets, lanes, ways or easements intended to be dedicated for public use - all subdivisions regulations shall apply;

17. Any other exhibits or data that the Planning Board may require and to adequately evaluate proposed development for Site Review.

18. There shall be an erosion and sedimentation plan (see Section V-E).

5. GENERAL STANDARDS:

A. Design of development should fit the existing natural and man-made environments with the least stress:

1. Site preparation is to be conducted with minimal disturbance to existing vegetation. Stripped topsoil is to be piled and reused on the site where needed. A minimum of 4 inches of topsoil is to be placed on the disturbed area. The site shall be adequately landscaped.

2. Landscaping treatment shall consist of natural, undisturbed vegetation or features, or ground cover, shrubs or trees as appropriate.

3. Grading and filling must be conducted to minimize the alteration of surface and subsurface drainage to, toward or across abutting properties, unless the written consent of the abutting owner is obtained.

B. Appropriate buffers are to be maintained or installed to provide privacy and noise reduction to residential areas abutting non-residential sites.

1. Buffer strips must be maintained between use and residential zones. Buffer strip between non-residential and residential zone must contain vegetation which will screen non-residential uses from sight from residential area during the winter months.

2. A landscaping plan must be submitted showing locations and types of vegetation to be retained or established.

C. Screening must be provided to reduce visual pollution:

1. Storage areas must be fenced or screened from on site or adjoining parking and neighboring properties.

2. Litter (garbage) collection areas must be screened.

3. The use of either fencing or hedges is permitted.

D. Parking, loading and pedestrian safety:

1. Sufficient off-street parking and emergency access lanes satisfactory to the P. B. must be provided for the anticipated use to accommodate both employees and customers so that no parking is forced onto public streets.

2. Sufficient off-street loading and/or unloading space satisfactory to the Planning Board must be provided, including off-street parking and areas for maneuvering of anticipated trucks or other vehicles. Maneuvers for parking and/or loading or unloading must not take place from a public street.

3. Access, parking and loading areas are to be constructed so as to minimize dust, erosion, and run-off conditions that would have a detrimental effect on abutting or neighboring properties.

a. Crushed rock may be used which might reduce the need for installation of drainage facilities to accommodate run-off, however,

b. The board may require that access, parking, and loading areas be conventionally paved if appropriate or necessary.

4. Sidewalks. Sidewalks shall be provided for pedestrian traffic to provide connection between the main entrances of business, housing or industrial establishments and parking areas. In the event that pedestrian shoppers or employees are reasonable anticipated, provision shall be made therefore by sidewalks running from the street line to the establishments. All such sidewalks shall be at least six (6) inches above grade and protected by curbing.

E. Erosion and Sedimentation Plan shall:

1. Make provision to accommodate the increased run-off caused by changed soil and surface conditions during and after development. Sediment in the run-off water shall be trapped by the use of sediment basins or other acceptable methods until the area disturbed is stabilized. Diversion, sediment retention basins and other such devices, shall be constructed prior to any on-site grading or disturbance of existing surface material.

2. Show any control measures both during construction and any permanent controls to remain after construction.

3. Identify, locate, and show elevation, grades and/or contours at intervals of not more than two (2) feet for the existing and proposed drainage ways, drainage easements, drainage structures, and water bodies.

4. Identify, and relatively locate, proposed erosion and sediment control measures and structures during and after development.

5. Include drawings and specifications for each proposed soil erosion and sediment control measure and structure in accordance with the Town and Rockingham County Conservation District standards.

6. Include drawings, details and specifications for proposed flood hazard prevention measures and structures and for proposed storm water retention basins.

7. Ensure that stripping of vegetation, regarding or other development will be done in such a way that will minimize soil erosion. Temporary seedlings and/or mulching may be required by the Board to protect exposed critical areas during development. Whenever practical, natural vegetation shall be retained, protected and supplemented.

F. Illumination:

1. Outdoor lighting shall not glare on abutting properties or on public highways or streets.

2. Indirect lighting should be used on signs advertising goods or services offered on premises. Moving, fluttering, blinking, or flashing lights or signs are not permitted.

3. Outdoor lighting is restricted to that which is necessary for advertising and security of the development.

G. Access to Public Streets.

1. Access to public streets will meet the requirements of the New Hampshire Dept. of Public Works and Highways and/or of the Town, as adopted and amended.

H. Water supply and sewage disposal systems must be sized to adequately meet the needs of the proposed use

under the regulations of the New Hampshire Water Supply and Pollution Control Commission and/or the Town of Kensington Subdivision Regulations in areas not currently served by public sewers, it shall be the responsibility of the developer or his agent to provide adequate information to prove that the area of the lot is adequate to permit the installation and operation of an individual sewerage disposal system (septic tank and tile field). The developer shall be required to provide the necessary percolation tests and submit such tests together with the proposed plan to the State of New Hampshire Water Pollution and Control Commission for its consideration and approval.

I. Flood Hazard Areas:

1. Site plans for both non-residential development and multi-family units other than one and two family dwellings will be reviewed to determine whether such proposals will be reasonably safe from flooding. If such a proposal is determined to be in a flood prone area, such proposals will be reviewed to assure that:

a. all such proposals are consistent with the need to minimize flood damage within the flood prone area;

b. all public utilities and facilities, such as sewer, gas, electrical, and water systems are located and constructed to minimize or eliminate flood damage;

c. septic systems, if required, shall be designed to minimize or eliminate infiltration of flood waters into the systems and discharges from the systems into flood waters;

d. the lowest floor (including the basement) is elevated or flood-proofed to or above the base flood level.

J. The Town engineer, or in the absence of a Town engineer, a registered engineer hired by the Town shall inspect all site improvements. The developer shall pay the cost of the Board's employment of said engineer and the cost of any inspection(s) and test(s) deemed necessary by the Board or engineer. A letter certifying to the developer's concurrence to the employment of said engineer shall be filed with the Board as part of the site plan review. Engineer is defined as the duly designated engineer of the Town of Kensington, or other official, assigned by the Planning Board, who shall be a duly registered engineer.

K. The planning Board may waive any requirements listed in the Site Plan Review Regulations, if it determines that such regulation does not apply to the proposed development.

L. The Planning Board may require that a performance bond, the amount to be determined by the Planning Board, in the form of a passbook savings deposit or a bond, be posted by the developer and held by the Town until the Town is satisfied that all conditions of the site plan approval and any other zoning ordinance(s) subdivision regulation(s) and building regulation(s) have been met. The bond may be released in part when the project is substantially completed.

M. The Site Plan Map, which shows, at a minimum, lot lines and proposed construction, roads, and other improvements, and Planning Board approval, should be recorded with the Registry of Deeds. Should the approval be subject to conditions not apparent on the face of the map, such

conditions shall be recorded as well with reference to such recording on the face of the map. YES 263 NO 112

ARTICLE 7. To raise such sums of money as may be necessary to defray Town charges for the year ensuing and make appropriations of the same. The Selectmen's estimate of expenditures for the ensuing year is \$169,834.81. Motion by Charles Eastman to accept article 7, seconded by Seth Perry. Voice vote was affirmative.

ARTICLE 8. To see if the Town wishes to allow a discount on taxes paid within 30 or 60 days after presentation of tax bills. Motion by Jesse York for indefinite postponement of article 8, seconded by several. Voice vote was affirmative for postponement.

ARTICLE 9. To vote on the basis of payment and the amount thereof to be paid to the Tax Collector for the collection of taxes. Motion by Charles Eastman to accept article 9, seconded by W. Grant. The amount to remain the same as last year $\frac{3}{4}$ of 1%. James Rosencrantz amended the article to read, the basis of payment for collection of taxes by the Tax Collector to be $\frac{1}{2}$ of 1%, seconded by Paul O'Brien. Voice vote on the amendment was affirmative, voice vote on the amended article 9 was affirmative.

ARTICLE 10. To see if the Town will vote to grant the Selectmen authority to borrow money in anticipation of taxes. Motion by Charles Eastman to accept article 10, seconded by several. The amount not to exceed \$300,000. Voice vote on article 10 was in the affirmative.

ARTICLE 11. To see if the Town will vote to appropriate the sum of \$10,472.57 from the Rev. Sharing Fund to be transferred to the Capital Reserve Fund, established for the investment of a Town Office Building. Motion by Charles Eastman to accept article 11, seconded by Gary Easson. Voice vote on article 11 was affirmative.

ARTICLE 12. By petition of Christie Ann Jones and others, to see if the Town will vote to raise and appropriate the sum of \$240.00 to assist Rockingham Child and Family Services, a private non-profit organization. The amount of this request is based on services rendered to 18 residents of Kensington during the period July 1, 1978 through June 30, 1979, inclusive. These residents used \$560.00 worth of services, however, only \$240.00 could be billed according to their ability to pay. We therefore request the minimum amount needed from Town, in this case being \$240.00. These funds to be used for current operating expenses to enable Rockingham Child and Family Services to continue providing individual family counseling for residents of Kensington whether or not said residents are able to pay. Motion by Gary Easson to accept article 12, seconded by Edith Prescott. Voice vote to accept article 12 was affirmative.

ARTICLE 13. To see if the Town will vote to adopt an Ordinance regulation the use of the Town Park situated adjacent to Trundle Bed Lane said Ordinance to be as follows:

1. AUTHORITY- In accordance with the authority granted by Chapter 31:39 and any other applicable Chapter or Amendment thereto of the N H Revised Statutes Annotated, the following Ordinance is hereby adopted by the Town of Kensington to regulate the care, protection, preservation and use of the Town Park.

2. RULES AND REGULATIONS:

- (a) Alcoholic beverages are prohibited at any time.
- (b) Sleeping during the night time hours is not permitted.
- (c) The Park is closed to vehicles from dusk to dawn.
- (d) Fires are allowed only after securing a permit from the Fire Dept.
- (e) All waste and trash must be cleaned up and removed by owner(s).
- (f) No mini bikes, motorcycles or summer recreational vehicles are permitted.

3. PENALTY. Any person(s) violating any of the provisions of this Ordinance shall be liable to a penalty of not more than \$100.00 for each offence.

4. VALIDITY. If any section or part of a section or paragraph of this Ordinance is declared invalid, or unconstitutional, it shall not be held to invalidate or impair the validity, force or effect of any other section or sections or paragraph of this Ordinance. Motion by H. Bodwell to accept article 13, seconded by several. Motion by James Rosencrantz to amend 2(a), seconded by several. The Amendment, Alcoholic beverages will be allowed. Motion by C. Streck to amend to 2(a), seconded by several. The amended amendment, "alcoholic beverages will be permitted only after securing a permit from one of the Selectmen. Vote on the amendment to the amendment to 2 (a) was affirmative. Vote on the amended amendment 2(a) was affirmative. Motion by Mark Kimball to amend 2(b), seconded by several. The amendment, sleeping during the night time hours is not permitted except by Town groups with permission from the Selectmen. Vote on amended 2(b) was in the affirmative. Motion by H. Schweizer, Jr. to amend 2(d), seconded by several. The amendment, fires are permitted after securing a permit from the Town Forest Fire Warden or his authorized deputies. Vote on the amendment was affirmative, vote on the amended 2(d) was affirmative. Motion by Paul Steeves to amend 2(f), seconded by several. The amendment, no mini bikes, motorcycles or summer recreation vehicles are permitted beyond the parking lot. Vote on the amendment was affirmative. Vote on the amended 2(f) was affirmative. Voice vote on article 13 as amended was in the affirmative.

ARTICLE 14. To see if the Town will vote to raise and appropriate the sum of Four Thousand Five Hundred Dollars (\$4,500.00) to install a water hole on Route 108 on the property of John W. Tuthill, said water hole to be graded, fenced and hydrant installed. Motion by James Rosencrantz to accept Article 14, seconded by several. Voice vote was affirmative.

ARTICLE 15. By petition of Bradley R. Brown and others: The Kensington Police Department petitions the Town to see if the Town will purchase a new cruiser, purchase price being no higher than \$7,000.00. Motion by Gary Easson to accept article 15, seconded by several. Voice vote was affirmative.

ARTICLE 16. To see if the Town will vote to authorize the Selectmen to settle the legal controversy with Michael Dingman over the ownership and use of the "range way" on Moulton's Ridge (located between the Town land and Moulton's Ridge Road or Nudd's Hill Road) and to authorize the Selectmen to excute and deliver to Michael Dingman a quite claim deed of any interest the Town may have in the "range way" in exchange for a completed survey (tape and transit) quality, prepared by a licensed New Hampshire surveyor, and in recordable form at no cost to the Town, of all the Town land located on Moulton's Ridge (extending to Route 108); provided, however, that the entire transaction will be contingent upon the survey establishing that the Town, through uninterrupted contiguous ownership, has legal access from Route 108 to all parcels of Town-owned land on Moulton's Ridge. Motion by Seth Perry to accept article 16, seconded by several. Voice was not conclusive, therefore, the Moderator called for a show of hands. The Selectmen, Paul O'Brien and Seth Perry were assigned the task of counting. The show of hands vote was tallied and the assigned persons agreed that the count was YES 65 NO 35.

ARTICLE 17. By petition of Clark Jacobs and others: to authorize the Selectmen to print the list of assessments every three years, starting in 1981 in the Town Report or a supplement to. Motion by Clark Jacobs to accept article 17, seconded by George Martin. Voice vote was in the affirmative.

ARTICLE 18. By petition of Sandra Gavutis and others: Whereas the Nuclear Regulatory Commission (NRC) has requested citizen input on evacuation of a 10 to 50 mile radius around nuclear facilities, we the citizens of Kensington hereby request the Selectmen to inform the NRC that in our opinion no license shall be granted for the Seabrook Nuclear Power Station until, and unless, a safe evacuation plan has been demonstrated. And further Town evacuation plan for Seabrook Nuclear Power Station. Motion by Sandra Gavutis to accept article 18, seconded by Clark Jacobs. Voice vote was affirmative.

ARTICLE 19. By petition of George W. Gavutis and others: To see if the Town will vote to raise and appropriate the sum of Fifteen Hundred Dollars (\$1500.00) to be added to the Special Conservation Fund in accordance with RSA 36:A:5 to be managed by the Conservation Commission, said fund to used to purchase development rights and conservation easements as well as aquire and/or manage unique and/or threatened open space such as prime farm lands, stream banks, forest and wet lands. Voice vote was in the negative. (moderators decission.)

ARTICLE 20. To see if the Town will authorize the Selectmen to apply for, receive and expand Federal or State grants, which may become available during the course of the year, and to accept and expand money from any other governmental unit or private source to be used for the purpose for which the Town may legally appropriate money; provided; (1) that such grants and other monies do not require the expenditure of other Town Funds, (2) that a public hearing shall be held by the Selectmen prior to the receipt and expenditure of such and monies; and (3) that such items shall be exempt from all provisions of RSA 32 relative to limitation and expenditure of Town monies, all as provided by RSA:95-b. Motion by Charles Eastman to accept article

20, seconded by Edward Walker. Voice vote was in the affirmative.

ARTICLE 21. To see if the Town will vote to raise and appropriate a sum not to exceed \$142,000.00 to acquire and purchase the Dillennebeck property, 10 acres more or less, of land and buildings, and to authorize the Selectmen to negotiate the terms and condition of said sale. Motion by Harold Bodwell to indefinitely postpone article 21, seconded by Paul O'Brien. Voice vote was in the affirmative.

ARTICLE 22. To see if the Town will vote to appropriate and allocate the total amount in the Capital Reserve Fund established for the Town Office Building Project together with accumulated interest to date of withdrawal, the principal amount being \$35,497.03, said sum and accumulated interest to be applied towards the purchase of the Dillennebeck property. Motion by Harold Bodwell to indefinitely postpone article 22, seconded by several. Voice vote was in the affirmative.

ARTICLE 23. To see if the Town will vote to authorize the Selectmen to subdivide the Dillennebeck property to enable 3-4 acres of land and buildings to be sold and the balance of the land retained by the Town, and to further authorize the Selectmen to negotiate the terms and conditions of such sale. Motion by Jesse York to indefinitely postpone article 23, seconded by several. Voice vote was in the affirmative.

ARTICLE 24. To see if the Town will vote to raise and appropriate the sum of \$ 75,000.00 for the purpose of financing and constructing a new Town Office building and site preparation on the Dillennebeck property, such sum to be raised by the issuance of serial bonds or notes of the Town, not to exceed the sum of \$75,000.00, under and in compliance with the provisions of the Municipal Finance Act (Chapter) 33 of the NH Revised Statutes Annotated and any emendments thereto) and any other enabling authority; authorize the Selectmen to issue and sell such bonds or notes and determine the rate of interest to be paid thereon as may be necessary to effect the issuance, negotiation, sale and delivery of such notes and bonds as shall be in the best interest of the Town of Kensington; authorize the Selectmen to enter into agreements and contracts and to take other action necessary to complete said Town Office Building Project and to apply for and accept State or Federal grants in aid of said project; and any other action in connection with the foregoing matters or any of them. Motion by Harold Bodwell to indefinitely postpone article 24, seconded by several. Voice vote to indefinitely postpone article 24 was in the affirmative.

ARTICLE 25. To transact any other business that may legally come before the meeting. Motion by Charles Eastman to accept article 25 and continue the Town Office Building Committee and to adjourn the meeting, seconded by several. Voice vote to retain the Town Office Building Committee and to adjourn the meeting was in the affirmative.

The circulation increased slightly over 1,000 in 1980. We registered quite a few new borrowers and welcomed back some familiar faces of people who hadn't taken advantage of the library for a while. We do make every effort to fill requests and our average is very good. If we do not have the book, we try inter-library loan, the bookmobile or the State Library. We have even bought the book if we can't find it. We continue to answer the telephone on strictly town business. We answer the question when possible or give the caller the name and telephone number of the correct town official. We answered the telephone on town calls 235 times in 1980.

456 books were added to the library collection this past year. 204 of these books were bought with funds from the library budget. The Friends of the Library bought the 22 volume, 1980, World Book Encyclopedia and 51 books were bought with funds donated to the library. 22 books for the children's room were purchased with the remainder of the Eben Rice Memorial Fund. 34 books were bought with money contributed by the Kensington School District for the children's room. The American Legion Auxillary gave us \$110 with which we bought 15 books evenly divided between adult and children's books. The rest of the books were miscellaneous gifts. Memorial books were placed in the library in memory of Fred Yardley, David Atwood, Robert Burns, Jr., Rev. Roland D. Sawyer and E. Winter Eastman. A film strip was given in the memory of Mabel Brewer. Books and magazines that are given to the library are greatly appreciated and a big help in stretching the budget.

A summer "Kids Film" program and Summer Reading Program were held again in 1980 and were well attended. A Book and Bake sale were held in July. Surplus books were sold with the money added to the book budget. The money from the bake sale went to a special fund for use of the library staff for special projects and equipment. Our thanks to everyone who helped. A Christmas party was held early in Dec. for the community and was well attended.

The library staff wishes to thank the faithful and hard-working group of volunteers. Sue Dillenbeck, Mari Welch, Joanne Cole, Lesslie Frank, Margaret Perry, Becie Brewer and Linda Buxton were volunteers in the children's room while the school classes were in and they are invaluable. Ann Smith and Claudia Welch come in to help after school and willingly help at any task. Jan Heasley and Margaret Perry acted as guest

story tellers. The library staff held a morning coffee for the volunteers in the spring as a small token of our appreciation. Sue Dillenbeck was honor guest as she was moving out of state.

During the summer months we had a group of junior volunteers to help us. They were 5th and 6th grade girls and were a great help to us. The junior volunteers were Pam Welch, Rebecca Engel, Chrystal St.Martin, Brenda DeMaree and Cassie Frank. We thank you, girls, for the many ways you helped.

Library news has appeared in the Hampton Union, Exeter News-letter on a fairly regular basis. Ann Smith has taken over library news report in the Church Newsletter.

A free blood pressure clinic was held at the library during the year on the 4th Monday of most months. It will be continued in 1981 on an every other monthly basis. It will still be on the 4th Monday at the library from 1:30 to 2:30 p.m. It is with the cooperation of the visiting nurse's association and is open to everyone.

I would like to thank Stanley Underhill for his continued supervision of the library grounds. The Social and Public Library trustees for their cooperation and support, the Friends of the Library for their contributions and anyone else I've neglected to thank who have helped in any way. You are all deeply appreciated.

I thank the library staff, June Armstrong, assistant librarian, Sally Head, Children's librarian and Priscilla prescott, substitute for their hard work, dedication and support.

To the community, may I remind you that this is your library. We work for you, the tax payers. We serve no special segment of the population. You are all welcome and we will try very hard to serve your needs to the best of our ability.

EXETER AREA VISITING NURSE ASSOCIATION, INC.

The Exeter Area Visiting Nurse Association, Inc. is a community health service that provides health care to individuals and families in their home, in the office, or in clinics. The care may be to prevent disease, promote, maintain, or restore health or it may be to minimize the effects of illness or disability.

The Association is a non-profit agency governed by a Board of Directors. This Board is made up of people who are appointed by the selectmen in your town.

Funding for the Association comes from Medicare, Medicaid, patient fees, local taxes, and donations. Town appropriations make the service available to the town.

HOME CARE. Professional nurses give care to the sick and disabled under medical direction, teach and supervise care by the family and others. They are responsible for the management of patient care, coordinating the services of other disciplines, within and out of the Agency. Care is family centered and consideration is given to the total needs of the patient and family for health promotion and disease prevention and rehabilitation as well as care and support during the dying process.

MATERNAL AND CHILD HEALTH. Free visits are made to new or expectant mothers to provide information and instruction in the care of themselves and their babies. Well Child Clinics are held twice a month and provide the following services: Physical exams by a local physician, immunizations, hearing and vision screening, lead and urine testing, special counseling, family planning and referral when appropriate. The Clinics are for infants and preschool children.

ADULT HEALTH SCREENING. Clinics are held each month to check blood pressure, provide diet and medication counseling, and general health instruction. Referrals are made when appropriate. New clinics were added this year to test for diabetes.

FLU CLINICS. 12 Clinics are held each fall (1 in each town) to immunize hi-risk (65 and over, or chronic disease) persons against influenza.

THERE IS NO CHARGE FOR ANY CLINIC SERVICES.

The Association has many valuable volunteers who work at the clinics in addition to staff.

MENTAL HEALTH. Visits to persons who have mental and/or emotional problems. Coordination between patient, family, psychiatrist and community.

COMMUNICABLE DISEASE. Visits to persons who have or are contacts of persons with tuberculosis for testing and/or medication and general health supervision. Other communicable diseases-testing and/or care as appropriate.

CONTINUING CARE. An Agency nurse is in the local hospital part of each day to assist in planning, coordinating and arranging for care at home so that a person can move from hospital to home without any interruption in care.

10,938 units of service were provided to residents of the service area between January 1, 1980 and December 31, 1980. (Individual town statistics are sent to the selectmen of each town).

REPORT OF THE NEW TOWN OFFICE BUILDING

Members of the committee for a new Town Office Building started their meetings July of 1980 and met as a whole six times during the winter. The first decision made was not to join the school in having the town offices constructed within the school.

Sub-committees visited town offices of the towns Brentwood, Greenland, Durham, Hampton Falls and Northwood. Studies were made on what would be advisable for floor space required by the town officials. There were few possibilities of where the office building could be built. All were looked into extensively. One possibility was locating the offices at the town park, another was remodeling the town hall which entailed the taking off the kitchen portion, a new foundation under the building and the removal of the stage. Safety factors were discussed on the entrance of the town hall should it hold the town offices there.

Clem Streck made a temporary sketch of a proposed building. It was voted to have a plan made up to show the citizens of Kensington a building which would be constructed adjacent to the town hall. The ground floor would hold the offices and the second story would at a later date be completed for a meeting hall or additional office space. In the future the two buildings could be joined together.

The committee agreed this plan would only be advisable if we could purchase 6/10 ac. behind the town hall so that a safe driveway could be used. This exit would be approximately 300 feet from the front of the town hall. \$3,000.00 is required to obtain this land..

Growth is essential to the health of a community so long as it is not at too rapid a pace without thought of the future. Happily, we can report that the future is being thought of, and the Town Master Plan Committee, created by action of the Planning Board, has made a major effort to tap the widest possible range of citizens' opinion on the shape it should take. Their report is now being drafted and will be published soon. It should be understood that in no way will the report or any of its provisions have the force of law until they have been discussed in public meetings and then voted on by the citizens of the town.

The Planning Board would also like to remind everyone that their meetings are public and take place regularly in the Town Hall at 7:30 PM on the first Thursday of each month. Much of the board's regular business involves the consideration of new subdivisions. When subdivisions are proposed for Planning Board approval they are always announced by public notice in three places in town (fire station, town hall, and store) and in the legal notices column of the Exeter Newsletter at least two weeks prior to the required public hearing, which normally takes place at one of the regular monthly meetings.

REPORT OF FOREST FIRE WARDEN AND STATE FOREST FIRE SERVICE

Forest Fire Prevention: Your Business, Our Business, Good Business. Forest fire prevention slogans have been seen in association with Smokey Bear since the late nineteen forties when a national effort to check the spread of forest fires was implemented.

New Hampshire residents recognized that forest fire prevention and suppression was the responsibility of every citizen, a half century before this national campaign, when our legislature established our first forest fire law in 1903. Since that date, the State has appointed a town/city forest fire warden who is responsible for forest fire law enforcement in his municipality.

All fires kindled out of doors when there is no snow on the ground must be approved in writing by the forest fire warden before being kindled. All forest fires must be suppressed by the warden and his deputies as soon as they are reported. The cost of fire suppressing is shared jointly by the town/city and the State of New Hampshire, as are forest fire prevention and forest fire training costs.

This state and local municipality cooperative forest fire program has given New Hampshire one of the best forest fire records in the United States.

1980 ANNUAL REPORT - KENSINGTON RECREATION COMMISSION

The year opened with a public meeting in January. A concern was vandalism and misuse of the park after dark. An ordinance restricting the use of the park after dark, and requiring a permit for use of alcoholic beverages on the grounds was drawn up. The penalty for breaking this ordinance is a \$25.00 fine. It was also decided to install a gate at the driveway entrance to the upper level, to discourage overuse by vehicles.

Representatives of the Little League were concerned about maintenance of the field and related problems. The Recreation Commission agreed to help with their needs, when possible.

Some improvements to the park this year include; work on the Little League field by members of the team and parents; equipment work to enlarge and improve the parking area; re-wiring of the outdoor receptacles; a swing-gate at the driveway entrance to upper level; and large picnic tables for use in the summer program. All work was donated by volunteers. Thanks for all the community effort and support!

The summer program was held in July, (morning and afternoon) three days a week. There were special events, field trips, and a camp-out, as well as games and crafts. Many

volunteers helped to make it fun for all! Bonnie Schweitzer held swimming lessons at the Lambert's pool. Her Red Cross Certificate program had great response and was of benefit to all who participated.

At the close of the year, Regina O'Brien (Rec. Director, New Durham, N. H.) and Chas. Christy (State Director of Parks & Recreation) came to a public meeting and made recommendations as to the possibility of creating a year-round recreation program for our community. We thank them for their helpful support and hope to implement some of their suggestions in the coming year.

RECORD OF THE 1980 SCHOOL DISTRICT MEETING

KENSINGTON, N.H. - MARCH 8, 1980

The Annual School District Meeting was called to order by the Moderator, Thomas Welch, at 7:08 P.M., who then read the Warrant, followed by the salute to the Flag and an appropriate prayer led by Rev. Roger Daly.

ARTICLE 1. To determine and appoint the salaries of the School Board and Truant Officer and fix the compensation of any officers or agents of the School District.

Hal Bodwell moved that they stay the same.
Seconded by Jesse York. The vote was affirmative.

ARTICLE 2. To hear the reports of Agents, Auditors, Committees or Officers heretofore chosen and pass any vote relative thereto.

Jean Paratore gave report on the land purchase for the school and reasons for an addition. An acquired 2.4 acres would give a total of 6.11 acres. Land is still under the questioning stage. Two architectural firms have been contacted, a Mr. Rouse from Hampton, N.H. and Mr. Van Dam from Portland, Maine. The sum of One Thousand, Five Hundred (\$1,500.00) will be the cost for the following:

1. A careful exploration of the programatic requirements, this would be achieved through meetings with the Building Committee and any interested member.

2. A complete set of schematics, including plans, elevations, and a budget.

3. Participation in the effort to present the project to the community. This could include presentation, drawings, a model and appearances at public meetings.

The fee of One Thousand, Five Hundred Dollars (\$1,500.00) will be applied toward the total fee for construction.

John York accepted the report, Carl Singer seconded.

ARTICLE 3. To see if the District will vote to raise and appropriate a sum not to exceed Two Thousand

Dollars (\$2,000.00) for the purpose of covering the cost of a feasibility study for a new addition to the elementary school building. Hal Bodwell moved to adopt Article 3. Carl Singer seconded. The money difference was discussed, and Hal Bodwell explained that there could be miscellaneous items. The vote was in the affirmative.

ARTICLE 4. To see if the District will vote to authorize the School Board to make application for, accept, and expend on behalf of the School District, all gifts, advances, grants in aid, revenue sharing funds or any other funds for educational purposes as may now or hereafter be available or forthcoming from the U. S. Government, the State of New Hampshire or any of its municipalities or any other state, local or federal agency.

Gordon Swift moved to adopt the article and Doris Bickford seconded. The vote was affirmative.

ARTICLE 5. To see what sum of money the School District will vote to raise and appropriate for the support of schools, for the payment of salaries for School District officials and agents and for the statutory obligations of the District.

Hal Bodwell moved to adopt the sum of Five Hundred Twenty Two Thousand, Two Hundred Eighty Two Dollars (\$522,282.00) for the year 1980-1981. Harry Bodwell Jr. seconded. After some discussion, the vote was affirmative.

ARTICLE 6. To choose Agents and/or Committees in relation to any subject embraced by this warrant. Jane Stemple moved to reappoint a land and building committee for another year. Edward Ruggeri seconded. Vote was affirmative.

ARTICLE 7. To transact any other business that may legally come before this meeting. Hal Bodwell suggested that it might be better to hold the Annual School Meeting on a week night. John York said it was very dangerous to have so few people attending our school meeting, enough people could be brought in to vote everything down. People should be more concerned for the way school money is spent, maybe there should be a fine for not attending.

Doris Swift motioned to move the meeting to the Monday night preceeding town meeting. John York seconded. After lengthy discussion. June Armstrong motioned to Amend Doris Swift's motion and let the school board take care of the meeting date. No one seconded, the motion failed. Doris Swift's motion was acted on, motion failed.

Hal Bodwell introduced the new area administrator, Walter Pierce. John York moved that the meeting adjourn, seconded by Harry Bodwell.

The Moderator, Thomas Welch, declared the School District Meeting adjourned at 7:44 P.M.

Kensington School District

As we approach another school district meeting it is with pleasure I submit to the citizens of Kensington this report. This has been a busy year which included the hope that a new addition to the Kensington Elementary School would be a reality, and a new teacher negotiated agreement for the 81-82 school year has come about after much effort and time.

A new science program will be seen in most grades in Sept. 1981. This is a results of the S.A.U. #16 Science Curriculum Study during this school year. This committee worked hard under the leadership of Richard Short, Teacher Consultant. Both school people and citizens actively worked to review, study and select a new program. Teachers are looking forward to working with these new materials next fall.

The Kensington School District has long been committed to meeting the individual needs of students. We have done much to improve our offerings to special education youngsters both in self-contained classrooms and mainstreaming. Our Title I federally funded program has provided supplementary help to LD students in reading. The many aides and professionals working with these students have resulted in impressive progress rates and our programs have received state-wide attention as an exemplary program.

A complete evaluation of our elementary schools will be done by the time you read this report. Last year a committee reviewed our Senior High and Junior High Schools in detail. As a results commendation and suggestions were made, and we received 5 year accreditation for both schools. Now our elementary schools will be reviewed by the State Department and we will work with the results of that evaluation in all of our towns during the spring and fall of '81.

I would be remiss if I did not mention our recently completed tests of achievement which tells us where our schools rate in relation to the rest of the country. The average score nationally is at the 50 percentile. I call your attention to our fourth and sixth grade scores in this Unit which showed we again rank in the top quarter of schools in the country. Reading was 85% for grade 4 and 88% for grade six. Mathematics was 85% for grade 4 and 87% for grade six. Isn't this really what education is all about? If our schools, our teachers, and our administrators are doing their job and doing it well our students will be well prepared and can compete nationally with anyone. We have such scores and our schools continue to maintain high quality. We do have schools we can be proud of and it is my belief most of our citizens are pleased with

the results of the staff educational endeavors.

Frank Scala, the school principal, has submitted to me the following report which I would like to quote here:

"The levels program that has been in effect for some years has once again shown that our students are achieving through quality programs. Results of the Iowa tests show that our students are averaging in the 90th percentile in reading and math. We should be proud of such accomplishments.

New staff changes have effected part-time personnel; Nurse - Mrs. Judy Waleryszak, Speech Therapist - Mrs. Kathy Herold, Art - Mrs. Anita Bailey and Music - Mrs. Pat Liddy.

Our students have had the opportunity to participate in extended supplemental activities such as New Hampshire Spelling Bee Contest, I Love to Read activities, Gifted Pilot Program and Poets in New Hampshire Schools program.

Also, renewed parent participation through P.T.A. and the New Hampshire School Volunteers Program have been of great value in strengthening the curriculum and concerned interest in the children's education.

In addition, we have been fortunate in having two UNH interns assist the primary and intermediate units.

New interests for the coming years are beginning to take shape. First, S.A.U. #16 is looking for a coordinated science program. Also, career awareness sessions have been implemented to help children become aware of career choices early.

Finally, the staff and community are looking forward to working together to meet the needs of the children through an enlarged school facility."

In conclusion, I understand full well the problems of the local taxpayer. There is going to be pressure on school budgets in the future with the need to keep taxes at a reasonable level. Since very little monies come from the State the property owner bears the burden of the rising school costs, much of which (oil, telephone, electricity, tuition, transportation) is beyond the control of the board. We must all work together to continue to provide the quality of education that we now have with reasonable tax increases. I believe we can accomplish this.

INFORMATION FOR KENSINGTON RESIDENTS

RULES & REGULATIONS FOR WASTE OR REFUSE DISPOSAL

1. There will be a house to house pickup every Wednesday of each week.
2. Waste must be contained in plastic bags or trash containers, not to exceed a capacity of 30 gallons.
3. Solid waste must be placed at end of driveway at 7 A.M.
4. Weight of any container not to exceed 100 pounds.
5. No brush or stumps will be picked up and no 55 gallon drums are to be used.
6. Refrigerators, stoves, washing machines, dryers and tires will be picked up the first Tuesday in February, May, August and November.
7. Providing leaves are to be disposed of along with solid waste, the limit for each week will be four 30 gallon trash containers or 8 plastic bags.
8. There will be a container placed at the Elementary School for the use of the School, Fire House, Library, Town Hall, Church and American Legion.

LICENSING OF DOGS

Each owner of a dog 3 months old or over must register the dog with the Town Clerk before May 1st. Each dog over 3 months must have received a "rabies vaccination" certificate of vaccination to be presented to the Town Clerk at time of licensing. Each dog must wear a collar around its neck; attached to said collar a metal tag distinctly marked with its registration number.

License fees are as follows: Male dog - \$6.00, Female dog - \$6.50, Spayed female dog - \$3.50, Neutered male dog - \$3.50. Penalties - \$1.00 per month after May 1st.

JUNK CAR REGULATIONS

A recent New Hampshire Statute requires anyone with two or more unregistered or old cars no longer intended or in condition for legal use on highways or used auto parts equal in bulk to two vehicles must obtain a license or be subject to a \$10.00 a day fine and a mandatory injunction to end the violation by the selectmen or city council. New and used car dealers registered as such are not considered auto junk dealers but must remove any junk cars from their premises within 160 days.
