## TOWN WARRANT

### THE STATE OF NEW HAMPSHIRE

To the inhabitants of the Town of Ossipee qualified to vote in Town affairs:

You are hereby notified to meet at the hall of the Y. M. C. A. Incorporated, in said Town on the second Tuesday of March next, at nine-thirty o'clock in the forenoon, to act on the following subjects:

ARTICLE 1. To see if the Town will vote to authorize the Selectmen to hire money in anticipation of taxes.

ARTICLE 2. To see if the Town will vote to petition the State Tax Commission to have an audit made by the Municipal Accounting Department:

To vote an estimated appropriation of \$300.00 to cover expenses of such audit of the Town.

ARTICLE 3. To see if the Town will approve and adopt the recommendations of the Budget Committee and raise and appropriate the various sums contained in their report for the purposes specified, which include the following Special appropriations:

ARTICLE 4. To see if the Town will vote to rescind, the regulations now in force, to allow Town officials, and Election Day assistants, in excess of their salary, their dinners, at hotels or restaurants, it being considered their salary payments includes all refreshments of our Town employees.

ARTICLE 5. To see if the Town will authorize the Selectmen to sell any and all property deeded to the Town by persons aided by the Town which the Town now owns, or may hereafter acquire. This authority to continue until rescinded by a vote of the Town.

ARTICLE 6. To see if the Voters will allow the School District of Ossipee to use the Community House, so called, for school purposes.

ARTICLE 7. To see if the Voters will instruct



the Tax Collector to allow payment of taxes in a system of monthly payments, the last payment to be on or before December 15th of each year.

ARTICLE 8. To choose a Selectman for three years, Town Clerk, Treasurer, Highway Agents, Tax Collector, Auditors, and all other Officers and Agents for the ensuing year.

ARTICLE 9. To transact any other business that may legally come before said meeting.

In 1940 this hospital took care of one hundred and seven patients from Ossipee. Forty-three of these accounts were paid by patients and seventeen by the town directly. These figures show that we have forty-seven open accounts with balances totalling \$2,569.85 for the past year alone.

The cost to the hospital per patient per day in 1940 was \$4.74.

As you know this hospital is not a profit-making institution but is dependent upon the help of the public. We appreciate your 1940 appropriation of \$300.00 and would be very glad to be included in your budget for the coming year.

## THE LAKES REGION ASSOCIATION OF NEW HAMPSHIRE

We are inclosing herewith an article which we respectfully request that you place in your town warrant to be acted upon at the Town Meeting. The amount requested is one one-hundreth of one percent of the town's valuation.

In 1940 we published three booklets with 50,000 copies. In the last five years we have published a series of 14 booklets totalling 275,000 copies, which were distributed throughout the United States, and which have resulted in much increased business. We had an Industrial and Recreational Exhibit at the Eastern States Exposition and Exhibited at the Boston Winter Sports Show and also advertised the Region in Boston and New York newspapers.

In cooperation with the University of N. H. we conducted a survey of Industry with the object of establishing Vocational Schools.

We answered several thousand inquiries from people out of state inquiring for places to stay, Industrial opportunities, Real Estate etc. which we released to interested people in the Region.

We will be happy to assist you in compiling local booklets and will distribute them for you.

In the five organized regions of the State more than 90% of the towns now make their appropriations to their regional Association.

## EXPLANATION OF

## ABOVE TABULATION

- (a) **Property Valuation.** This figure stands at approximately the same figure from year to year.
- (b) **Town Appropriation.** The necessities of the past three years seem to have been reduced. This should not be construed as a policy which the town can always follow. When new things are needed to help the town, and they are O.K.'d by the Budget Committee and placed in the warrant and voted on, they become expenditures which the town must meet.
- (c) **School Appropriation.** With an ever increasing awareness that better educational facilities should be placed at the disposal of our children, this item is self explanatory.
- (d) **Tax Rate.** This is figured by dividing the town's valuation into the total of the Town & School appropriations.
- (e) **Property Owned by the Town.** You will notice a big increase in these totals after 1938. The reason is simply that for the first

time, ALL property owned by the town is listed. The 1940-41 figures include the Town House, all Schools (buildings and property), Ski Lodge, Public Beach, and other properties, tools, machinery, property taken by tax deeds, etc.

(f) **County Tax.** This amount the Town of Ossipee has to pay as its share of the Carroll County expenses. It is set up by the Carroll County Delegation and is administered by the Carroll County Commissioners. If the County Budget goes UP, so will your individual tax rate.

(g) **Town Needy.** It is the job of your Board of Selectmen to help our citizens who need assistance in securing supplies, medical care and hospitalization. We are pleased to report that not one able bodied citizen is on the Relief Rolls (Hospitalization not included). Reduction of 50% is due in part to the County taking over some cases.

(h) **Old Age Assistance.** Unfortunately more

and more of our citizens are reaching an age where we must look after them with the help of the Federal and State governments. (50% is paid by the Federal government, 25% by the State and the balance by this town).

(i) **Winter Roads.** This item is one, obviously, over which we have no control. All we endeavor to do is see that our roads are as efficiently plowed and sanded as possible.

(j) **Discount Allowed.** Previous to 1939 the citizens of this town were allowed a 2% discount by making early tax payments. To save this average \$500 to \$600 per annum expense, this practice was stopped. This was done because we can borrow money at 1%. This is a saving to YOU of 7¢ per hundred on your taxes.

(k) **Interest Paid.** In 1938 this town owed L. O. Moulton \$847.45 for 1935-36-37 back interest which previous administrations had **not reported.** This bill was finally paid in 1938.

Because the above mentioned 2% is now not

being paid, we borrow money at 1% to operate the town until taxes are due and payable.

(l) **Summer Roads.** Due to wash-outs and other emergencies over the past three summers, we have gone a bit over the \$3,000 annual appropriation—which incidentally, is the same amount that has been made for the past 15 years, in the face of greatly increased automobile traffic.

(m) **Bridges & Culverts.** When bridges and culverts have needed repair, it has been done with cement and steel. This method serves the double purpose of making them safer for increased traffic and more permanent than wood.

(n) **Cash on Hand.** Between Jan. 31 when the town books are closed until after Town Meeting when the new appropriations are sanctioned, the business of the town must still go on. In the past three years it has been the policy of your Selectmen to have more cash on hand so as to make immediate payments, take cash discounts, etc. This figure



includes \$652.50 of good accounts receivable (see page 21 for details)

(o) **Taxes Bought.** The Selectmen are pleased to note that there is a steady decrease in the amount of taxes they have had to buy in the name of the town.

(p) **Previous Taxes Due.** This is the amount of money which citizens of this town owe in back taxes dating as far back as 1927. Your Selectmen spend a great deal of time in doing their level best to reduce this amount.

(q) **Gross Debt.** This is the total liabilities of the town LESS the cash on hand, plus good accounts receivable (see Statement of Assets & Liabilities).

Through error the Moultonville School indebtedness was NOT included in the 1937-38 and 39 figures. It IS shown in the 1940 figures.

(r) **Net Taxes Due.** This is the total of Taxes BOUGHT and taxes DUE since 1927.

(s) **Net Surplus.** In 1936-37 you will note a

gross debt of \$5,800 and a NET surplus of \$4,733.98. In analyzing these figures you will note a jump to \$20,113.95 in 1937-38. Through errors and omissions of **charging off assets proven to be not liquid**, these figures were erroneously arrived at. (The Moultonville School's debt of \$4,200; \$100.00 error in School District Account and \$2,385.95 of bills due not reported plus failing to charge off \$2,000 for the Summer Brook Property and \$885.00 on the Daniel Heath Estate). In 1938-39 the Summer Brook & Daniel Heath properties were still not charged off. In 1939-40 they were. The Moultonville School Debt was not taken into consideration until 1940-41, although the School Board has been reducing this indebtedness each year. To give the citizens the true NET Debt we are showing the Moultonville School balance.

(t) **Net Debt.** This is the Gross debt less Cash & Accounts Receivable, taxes due and collectable.

## WHITE PINE BLISTER RUST CONTROL

---

White Pine Blister Rust control as conducted in this town during 1940 by the State Forestry & Recreation Department and the Federal Bureau of Entomology was a part of a nationwide program of protecting white pine growth from a bark disease, which, though not spectacular, represents a very serious menace to this tree if not controlled. Throughout the northeastern states, where white pine is especially important, counties, towns, cities, and individual owners have cooperated with State and Federal agencies. In the Far West, upon the National Forests and holdings of large lumber companies, Blister Rust control is recognized as a necessary practice in growing white pine. Recently, the Federal Government reaffirmed and emphasized the need of White Pine Blister Rust control by the passage of an act authorizing financial assistance to such states as are carrying on control measures. All towns and their citizens are strongly urged to cooperate with the State and Federal governments in their efforts to maintain control of this destructive disease.

The following financial statement shows expenditures made in this town during 1940 for Blister Rust control by the agencies indicated. Persons interested in the detail of control work and the life history of Blister Rust may receive a circular by applying to the State Forester, Concord, N. H.

## SUPERINTENDENT'S REPORT

---

To the School Board of Ossipee:

I herewith submit my fifteenth annual report as superintendent of schools, it being the twenty-first in the series of such reports.

Democracy is challenged today as never before. Schools, church and home form the triangle on which our safety rests. The triangle is a rigid figure and used much in the construction of foundations of heavy structures. If any side is imperfect the foundation gives way and the structure falls.

Homes and churches should be very active in building characters for worthy citizenship. Our immediate task lies in the schools, in which teachers work so many days each year. We have comfortable buildings and good materials in a land at peace. We should do much. People in European countries are dying and the children are growing up in ignorance. The children of America must save the world for Freedom and Democracy.

We must train for sound bodies, so we teach health lessons, we provide healthful conditions and outdoor playgrounds, and we have nurses and doctors to check up and correct defects.

We must train for mechanical skills for trades and industries. Our immediate defense program is calling loudly for workers with intelligent manual ability. It would be very wise to introduce more mechanical work, either in the form of shop work or agriculture with farm mechanics. The girls should have an opportunity for domestic arts. More space should be provided for these practical arts. In connection with these activities, room should be provided for a suitable noon lunch program.

We must train for governmental tasks. So we have classes in History and Government, Economics and Sociology and much discussion of Current Events

which are very much alive in these days. We have club activities and parliamentary procedure. We argue and discuss as people should in a Democracy. We try to train for future citizenship and worthy office-holding. Our seniors visit Town Meeting. They go to Concord to see the Legislature in session and visit government buildings.

The orchestra, glee club and athletic teams add interest and give pupils fine training in working together for school welfare.

We must train for scientific knowledge of plant and animal life. We must search the secrets of the laboratory in Chemistry and Physics. We must know about the earth's formation and the movements of winds and tides.

America marches on! What will be her fate? The answer lies in the progress we make in character and the finer arts. Education without character is shown in the world gone mad today. We have music and art, poetry and literature. We seek to find the virtues which endure—the finer senses of beauty, harmony, justice and honesty. We try to understand that our home country is free and prosperous because others worked, struggled and suffered for us.

Some fine improvements have been made in school property this year. A well-arranged shed was constructed at West Ossipee. Wells of water were provided at Water Village and Moultonville. The boiler at the Center School has been repaired and rearranged. Electric lights have been installed at Water Village, and now every schoolhouse in town is lighted with electricity. New seats and desks have been provided at Granite and Water Village. Every schoolhouse now has modern furniture.

In the coming year septic toilets should be provided at West Ossipee. Shingling should be finished at the Center and some form of ventilation be installed. The athletic field should be graded and all school lawns

should be graded and beautified. Above all, the Center Building should be enlarged to make noon lunch service possible. A definite plan for more manual work for the boys and domestic arts for the girls should be made. An agricultural course would be most desirable for our school. This could be introduced at small expense.

The high school is still advancing well and scholarship is improving. The enrollment is the largest in our history. We have been fortunate to keep the same strong headmaster, John H. Frye. Our new teacher, Mr. Taylor, has done well and has been able to add some special work in posture classes. Mr. Bennett has had part time off to study at Plymouth Teachers' College and Miss Woodeson has done some fine work with the orchestra and vocal work. We appreciate the interest of the Men's Club and the Woman's Club in inviting the boys and girls to appear in musical and discussion groups.

The good work of our nurse, Mrs. Marion Davis, continues. Statistics appear in the Nurse's report.
