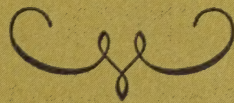

WARRANT FOR THE TOWN MEETING

The polls will be open from 11:00 A.M. to 7:00 P.M.

To the Inhabitants of the Town of Webster in the County of Merrimack in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at Grange Hall in said Webster on Tuesday, the 8th day of March, next at 11:00 of the clock in the forenoon, to act upon the following subjects:

1. To choose all necessary Town Officers for the year ensuing.
2. To raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriations of the same.
 - a. Town Officers' Salaries
 - b. Town Officers' Expenses
 - c. Election & Registration
 - d. General Expense
 - e. Town Hall & Other Town Buildings
 - f. Rent of Grange Hall
 - g. Tax Map Committee
 - h. Police Department
 - i. Conservation Commission
 - j. Insurance
 - k. Planning & Zoning
 - l. Damages & Legal Expenses
 - m. Civil Defense
3.
 - a. To see if the Town will vote to join the Concord Mutual Aid Compact.
 - b. To raise and appropriate the sum of \$9,010.00 for the support of the Fire Department, including Forest Fires.
4. To raise and appropriate such sums of money as may be necessary for the Health Department.
 - a. Concord Hospital
 - b. Franklin Visiting Nurses' Association
 - c. Sanitary Landfill
5. To raise and appropriate such sums of money as may be necessary for maintenance of highways and bridges.
 - a. Summer Maintenance
 - b. Winter Maintenance
 - c. Street Lighting
 - d. General Expense of Highway Department
6. To raise and appropriate the sum of \$717.71 for Class V road construction.
7. To raise and appropriate such sums of money as may be necessary for the support of the Town Library. \$1,400.00

8. To raise and appropriate such sums of money as may be necessary for Public Welfare.
 - a. Town Poor
 - b. Old Age Assistance
9. To see if the Town will vote to raise and appropriate the sum of \$577.75 for the continuation of services to the town through the Kearsarge Valley Area Center of the Community Action Program, Belknap-Merrimack Counties, Inc.
10. To raise and appropriate such sums of money as may be necessary for Old Home Day.
11. To see if the Town will vote \$500.00 for the maintenance of the park and playground.
12. To see what sum the Town will vote to raise and appropriate for the care of the cemeteries. \$1,800.00
13. To see if the Town will vote to raise and appropriate the sum of \$1,200.00 for interest on temporary loans.
14. To authorize and empower the Board of Selectmen to borrow for the Town, by issuance of notes, a sum not exceeding \$100,000.00 in anticipation of taxes for the year 1977, said notes payable from said taxes within one year of issuance, and to authorize the Board of Selectmen to determine the rate of interest on such notes and to provide for the sale thereof.
15.
 - a. To see if the Town will vote to have the appraisal Division of the Department of Revenue Administration conduct a complete revaluation and to establish a capital reserve fund for the purpose of conducting such revaluation.
 - b. To see if the Town will vote to raise \$10,000.00 to be placed in the capital reserve fund for the revaluation of the Town by the Appraisal Division of the Department of Revenue Administration.
16. To see if the Town will vote to discontinue, subject to gates and bars, the road leading from Route 127 easterly past the home of Leslie Corliss then northerly past the Roy Roby estate, intersecting again at Route 127 near the property of John P. H. Chandler III.
17. To see if the Town will vote to hire a Public Accountant for the purpose of conducting an audit of the Town's accounts and to raise and appropriate the sum of \$600.00 for this purpose.
18. To see what action the Town will take on unencumbered Revenue Sharing Funds and accrued interest that may be available by end of December, 1976.
19. To transact any other business that may legally come before this meeting.

ROAD AGENT'S REPORT

The Highway Department in 1976 used Duncan Fund money to widen a portion of Mutton Road, making it much easier to plow in the winter. Some of the remaining Duncan Fund money, plus the T.R.A. money, was spent on continuing last year's work on the Warner Road.

The highway appropriation for summer and winter maintenance has not been increased since 1972. Winter maintenance expenses have necessitated the reduction of summer work so that there would not be an overdraft of appropriations. Two-thirds of last year's highway maintenance budget was spent on winter maintenance. Costs of labor, equipment and materials have increased. The price of tar has more than doubled in the last two years. The price of sand and gravel has tripled. Some roads in town are in need of resurfacing, others need to be sealed.

It is my hope that with your support of an additional \$10,000.00 asked for in this year's budget that more summer maintenance may be performed to improve the roads.

FIRE CHIEF'S REPORT

The Hy-Mar Fire Department had three fire chiefs in 1976. Kenneth F. Hoar retired in March after 13 years as chief and the fire department would like to thank Ken for his many years of dedicated service to the town. Kenneth R. Hoar was appointed but had to resign in June because of his work hours and I was appointed in July.

The chiefs and firemen from the surrounding towns have complimented our department on the extensive training programs that we have undertaken in the past year.

Training:

- 15 week basic firefighters course (State instructed)
- 8 week Scott Air Pack Course (State instructed)
- 8 hour house burn (Marion Jones) (State instructed)
- 5 hour house burn (Hopkinton)
- 6 hour house burn (Franklin)
- 3 hour class on ventilation
- 2 hour class on communication
- 2 day firefighter training school at Keene
- 4 hour course on forest fires put on by State Forestry Division

I would like to thank the men for their time donated for this training and our weekly equipment checks and drills.

Communications:

A fire phone system has been set up in town that rings in the firehouse and also alerts six other firemen, who in turn use a call list and alert the rest of the department. While this is a big improvement over the old system, it does have its drawbacks. An FM radio base station was purchased and a license applied for. This will be the beginning of our radio communication which will put us in contact with the surrounding towns who have switched to FM almost completely.

Recreation:

This year we had our first annual lobster and clam bake. It was a great success and we hope to have it again this year. We have organized a softball team and bowling team.

REPORT OF DISTRICT FIRE CHIEF AND TOWN FOREST FIRE WARDEN

Since its beginning in 1893, the State Forestry Department has recognized the fact that forest fire prevention and suppression is a joint state and town or city responsibility. Local authorities recommend names of persons to the State Forester, who appoints one person as town or city fire warden and several other persons as town or city deputy fire wardens to a three year term.

The local forest fire warden controls the kindling of all outside fires, when the ground is not covered with snow, by issuing a written permit for kindling a fire. Permits are only issued at such times and in such places as the fire warden deems as safe.

The State Forest Fire Service trains the local forest fire organization in modern forest fire prevention and suppression tactics. The State also provides backup personnel and equipment for suppression and prevention activities.

The combination of State and local forces has resulted in one of the smallest acreage loss due to forest fires in the United States for the past 20 years.

POLICE REPORT

The Webster Police Department in 1976 investigated a variety of crimes of serious nature. Among these were assaults, burglaries, drugs, thefts, extortion, and threats to human life. These cases consumed a great portion of our time. We were also plagued with motor vehicle accidents and complaints. Accidents in 1976 were many. Ten persons suffered serious injuries incurred from these accidents, caused directly from alcohol or excessive speed. A substantial effort was put forth to curtail speeding and alcohol abuse while operating motor vehicles.

The juvenile problem is increasing within our town limits, with many juveniles indulging in drugs and alcohol and serious crimes. For the year 1977 our efforts will be concentrated toward the juvenile offender and stricter enforcement of traffic laws and more investigations of drug related cases.

The Webster Police Department is asking for \$8500.00 this year. Most of this figure will be mostly used in much the same way as last year except for purchasing some uniforms and possibly a new radio to enhance our communications. The cruiser is in good repair and should last until 1978 at which time it should be replaced with a new model.

Once again I solicit your support at Town Meeting and I will continue my efforts to the best of my ability as Chief of Police, enforcing the laws and rendering protection to the people of Webster.

Your Bicentennial Commission was appointed and organized in January 1976 to assist the town in celebrating the 200th anniversary of the founding of the American Republic.

A special dance was held on the Saturday following Town Meeting. The Hall was filled. Many of those attending wore colonial period costumes.

A contest was held to select a design for a Town medallion. The work of Beverly Ham appears on one side and that of Sandy Starkey on the other. The medallion was produced in bronze and silver. They have been purchased in large numbers locally, some statewide, and a few nationwide. A stencil of the medallion was cut and has been applied to walls, trays, and placques. A large replica was used as the focal point of the float in the Old Home Day Parade.

House dating signs were made available, to show date of construction. A great many of our new homes as well as old homes are now dated.

The three old stumps in front of the Church were removed by Bob Lake. Three new maple trees were then planted.

On the last Sunday in June, Reverend Wry conducted a special Bicentennial Service at the Church. Many attended in colonial attire. Following the service, Elizabeth Sanborn Millard, representing the State of New Hampshire, presented Paul Mock, the ranking elected official of Webster with a Bicentennial flag in recognition of our activities. The flag was then presented to the Webster Meeting House and has flown next to the American flag all summer.

A collection of old tried and true recipes used by local people was gathered by Avis Hancock Girard and published as a Bicentennial Cookbook. A great many have been sold.

SPECIAL TOWN MEETING

October 29, 1976

Meeting called to order at 7:40 P. M. at the Webster Grange Hall, by Moderator Randolph Inman, who read the warrant for the meeting.

Robert H. Pearson, Jr., Chairman of the Town Hall Committee, proceeded to outline facts that the committee had obtained; funds from the Public Works & Employment Act of 1976 would be 100% federally funded (amount \$200,000). The purpose of this grant would be to help employment in the immediate area, but whereas our town's unemployment rate is so low, we could use a thirty mile radius within Merrimack County for unemployment figures.

Ninety days after the grant is awarded, work must start on the project and be completed within one year.

In the building there would be offices for the selectmen, police department, town officers, library, committee room, vault for storage, an auditorium to hold 500 people, also a kitchen and dining room.

Working plans are required to present with the application for this grant. Out of \$300 raised at the March Town Meeting for the Committee's use, \$65 was spent for septic system tests.

\$12,000 is needed for preliminary planning, design and engineering, to pay Michael Ingram, head of Architectural Engineering Firm of Manchester. If Webster does not receive the grant, the plans, etc., could be used to apply for other federally funded programs in the future.

Loren Scribner has surveyed the land. Mr. Pearson, with other committee members present, namely, Jeremy Pendleton and Samuel Wilson, expressed their approval of the grant. Dr. Lamar Riggs and Arnold Perreton, who also have worked hard on the studies of the project, were not present, due to other commitments.

Mr. Michael Ingram, arriving late from a trip to Maine, was introduced and explained plans for the proposed new town hall. Approximately \$10,000,000 is coming into the state for projects. \$12,000, if voted, but the grant not allowed, would not be reimbursed to the town, however, the plans, etc. could be utilized. The town fund of \$40,000 could be used toward maintenance and furnishings, though some furnishings are included in this program. Rental fees would help maintenance costs.

The building would be approximately 8,000 square feet, with additional expansion space; there would also be access to the building for people in wheelchairs, to be in compliance with the government's requirements.

The most economical fuel would be considered, with most windows facing south; also the use of materials and finishes to require the least maintenance. There were objections to the proposed shed-type roof and Mr. Ingram said this could be changed. In reply to requests to view finished plans before voting, Mr. Ingram stated this was impossible, if the deadline is to be met. Question asked about a sprinkler system - the reply was negative.

Motion made and seconded, vote passed, to have ballot votes and Article I was voted favorably (60 Yes - 18 No) to authorize the Selectmen to apply for a grant under the Public Works & Employment Act of 1976. (\$200,000)

By a vote of 62 Yes - 12 No, Article II (by ballot) the Selectmen were authorized to spend \$12,000 from current Town Hall Fund to pay architect Michael Ingram, to do the preliminary planning, design and engineering for the new town hall.

Voted to adjourn.

Purpose of Committee: To investigate and report on feasibility of retaining the Corporation and turning over certain responsibilities to the District.

Background Information: Pillsbury Lake Management, Inc.

The Corporation was formed to promote and police Pillsbury Lake Subdivision for retirees, summer residences and permanent residences. Legally all owners within this subdivision are subject to "Property Restrictions and Easements" plus the building inspector of the Town of Webster. The Corporation is financed by an annual fifteen dollar (\$15.00) fee by each owner regardless of the number of lots owned. Special assessments can be voted on by members of the Corporation from time to time if financial problems arise but must be voted on by members of the Corporation.

Pillsbury Lake District

The District is part of the Town of Webster and has its own officers to conduct its responsibilities. It makes up its budget, submits it to the Town of Webster for collecting of the district tax which is returned to the District. The tax rate applied is based on a per \$1,000 valuation. Breakdown of rate is as follows:

Recommendations: The following recommendations are made by this Committee to be submitted to the District meeting of July 8, 1976:

1. Retain the Corporation with its only assets consisting of the Club House, the land thereon which includes a beach(s) and a swimming float.
2. Turn over all other responsibilities to the District, which include
 - A. Beach at end of Concord Drive
 - B. Beach on Deer Meadow Road
 - C. Beach at end of New Hampshire Drive
(sometimes called "The Island")
 - D. Beach and cabana at north end of Lake
 - E. Control of Lake, dams and dewatering of Lake
 - F. Bridge at dam
3. In order to reduce costs to both the Corporation and the District, the following is also recommended:
 - A. Informally close beaches under
 - 2 - B
 - 2 - C

This could be accomplished by removing present signs, picnic tables, litter, etc. New poles could be placed to prevent vehicle access. Signs to be worded: "No Swimming, per order of the Commissioners. Non members only."
 - B. Cancel two street lights at the playground area.
 - C. Form a volunteer committee to pick up litter from time to time within the District.
 - D. Form a volunteer committee to cut grass, trim shrubs, do minor repairs at the Club House. If necessary hire someone for grass cutting.
 - E. Reactivate the Building Control Committee.

Conclusion: The above recommendations would reduce operating costs for both the Corporation and the District. It would also retain the clubhouse under the Corporation control for social events and meetings. It would also retain "Property Restrictions and Easements" to prevent undesirable structures, mobile homes and trailers. It would also prevent high speed boats for water skiing, etc.
