TOWN WARRANT

THE STATE OF NEW HAMPSHIRE

To the Inhabitants of the Town of Bedford in the County of Hillsborough, in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at the Town Hall in said town on Tuesday, the thirteenth day of March, next, at ten of the clock in the forenoon, to act upon the following subjects:

- Article 1. To bring forward your ballots for the necessary Town Officers for the ensuing year and the ensuing three years.
- Article 2. To raise such sums of money as may be necessary to defray Town charges for the ensuing year, and make appropriations for the same.
- Article 3. To raise and appropriate such sums of money as may be necessary for the support of the poor, and assistance to the aged.
- Article 4. To see if the Town will vote to raise and appropriate the sum of \$4,500.00 for the maintenance of highways and bridges, and for any other necessary expense of the Town.
- Article 5. To see if the Town will vote to authorize the Selectmen to hire money in anticipation of taxes up to the sum of \$15,000.00 if needed.
- Article 6. To see if the Town will vote to raise and appropriate the sum of \$300.00 for the Town Library.
 - Article 7. To see if the Town will vote to raise and

appropriate the sum of \$15.00 for the care of the clock on the church.

- Article 8. To see if the Town will vote to raise and appropriate the sum of \$810.30 for the construction of Class V highways, the State to contribute \$3,241.20.
- Article 9. To see if the Town will vote to raise and appropriate the sum of \$3,000.00 for the tarring of Class V highways, under the direction of the Selectmen.
- Article 10. To see if the Town will vote to raise and appropriate the sum of \$50.00 for Memorial Day and patriotic purposes.
- Article 11. To see if the Town will vote to raise and appropriate the sum of \$200.00 for the care of the New Cemetery; \$25.00 for pumping water for same; \$50.00 for the care of Jappa Cemetery; \$10.00 for the care of the Old Cemetery on the Back River Road; and \$25.00 for the care of the Beals Cemetery.
- Article 12. To see if the Town will vote to raise and appropriate the sum of \$4,000.00 for the purchase of a motor grader for general highway work and in addition, authorize the Selectmen to expend the \$4,000.00 in the Capital Reserve Fund previously established for Highway Equipment for this purpose.
- Article 13. To see if the Town will vote to raise and appropriate the sum of \$2,000.00 for the construction of a suitable shed for housing highway equipment.
- Article 14. To see if the Town will vote to accept Ridgewood Road westerly from the River Road.
- Article 15. To see if the Town will vote to accept a short street, no name, southerly from Boynton St. to the residence of Theodore Gagnon.
 - Article 16. To see if the Town will vote to accept a

short street, no name, southerly from Boynton St. to the residence of Felix Angeli.

Article 17. To see if the Town will vote to accept Fourth Street northerly from Worthley Road about 300 feet.

Article 18. To see if the Town will vote to support United States membership in a general system of international cooperation, such as that proposed at the Dumbarton Oaks Conference, having police power to maintain the peace of the world.

Article 19. To see if the Town will vote to accept \$2,000.00 in trust, from the late Frank H. Waters, the interest from which to be expended for the purchase of books for the Town Library.

Article 20. To see if the Town will vote to accept \$100.00 in trust, from John Leslie, the interest from which to be expended for the care of lot No. 133 in the Bedford Center Cemetery.

Article 21. To see if the Town will vote to accept \$1,500.00 from the late Frances E. Woodbury, the interest from which to be expended for maintenance and general expenses of the Town Library or property in connection with same.

Article 22. To see if the Town will vote to accept \$1,000.00 in trust, from the late Willis B. Kendall, the interest from which to be expended for the maintenance of the lot and the structures thereon at the Bedford Center Cemetery where his parents and brother (Mr. and Mrs. James T. Kendall and Edward Kendall) are buried.

Article 23. To see if the Town will vote to accept \$2,000.00 in trust, from the late Willis B. Kendall, the interest from which to be expended to promote an annual Prize Speaking contest similar to one established in Manchester, N. H. by the late John B. Clark, to be conducted

by the School Board of the Town and open to all attending public schools of the Town.

Article 24. To see if the Town will vote to accept \$1,000.00 in trust, from the late Willis B. Kendall, the interest from which to be expended for the purchase of books for the Bedford Library.

Article 25. To see if the Town will vote to establish a Temporary Honor Roll or Memorial to the sons of Bedford serving in the present war or take any action thereto.

Article 26. To hear the reports of Agents, Auditors, Committees and of other officers heretofore chosen, and to transact any other business that may legally come before said meeting.

REPORT OF THE SUPERINTENDENT OF SCHOOLS

Bedford, New Hampshire, February 1, 1945

To the School Board and Citizens of the Town of Bedford:

I herewith submit my fourth annual report as Superintendent of Schools.

We have had an unusual number of changes in the teaching staff this year, partly due to war conditions. Miss Dorothy Goodale, who had taught in the Stevens-Buswell School for ten years resigned to accept a position in Manchester. We are sorry to lose her services. We feel highly complimented that her long and faithful service here was recognized by our large neighbor. The best wishes of the school and community go with her. Mrs. Dorothy Marcy takes her place.

Miss Anna O'Connor, who held the upper grade position very acceptably for two years, secured a position in a junior high school. Her place is taken by Mrs. Helen Owen. We are fortunate in filing these places with experienced teachers.

Mrs. Ellen Forbes Graham left the teaching profession last June to be married. She had a very successful year at Donald Street. Her place is taken by Miss Grace Driscoll, a graduate of Salem Teachers College. In these times we are fortunate in having our schools so well manned.

Last June, seventeen pupils graduated from the eighth grade. Fifteen entered high school last fall. In general, high school enrollment has been greatly lessened by the war demands for labor. This tendency has not affected

the Bedford children to any great extent. Our enrollment in high school is up to standard for recent years.

The question of reorganizing the whole Bedford school system is still very much in the fore-front of our thinking. The number of children in the Peter Woodbury and Bedford Center districts is still much too small for economical administration of the present set-up. Unless conditions change, we will still be faced with the problem of too few children in too many rooms with too many teachers. The Donald Street population seems stable, and is sufficient for good organization of the present system.

In closing I wish to thank the Teachers, School Board and many interested citizens who have contributed liberally to make the school year a successful and happy one for all concerned.

ANOTHER ENEMY TO CONQUER

Here is a home front fight that everyone can get into. Last year in this State, 558 brush and forest fires burned over 4,648 acres of land, of which 2,788 acres were valuable timber and young growth. With available manpower the lowest of any year since the war started, you can help to keep this loss down by preventing these fires from starting.

Keep in mind these simple rules:

- 1. Always get a permit from your forest fire warden before starting any fires in the open. Burning under certain conditions is permitted.
- 2. Never burn unless you have enough help to control your fire—a permit does not excuse you of negligence in case it gets away.
- 3. Always report any uncontrolled fire promptly to your forest fire warden. Minutes lost are acres lost.
- 4. Be especially careful with cigarettes, matches and pipes. Smokers caused most of our fires.
- 5. Never leave a fire unless it is dead out. You can't feel safe while there is a spark left.
