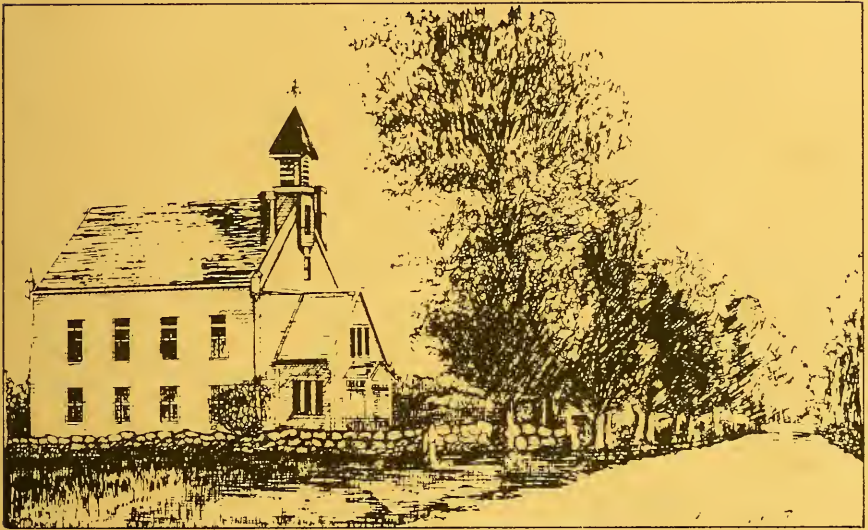

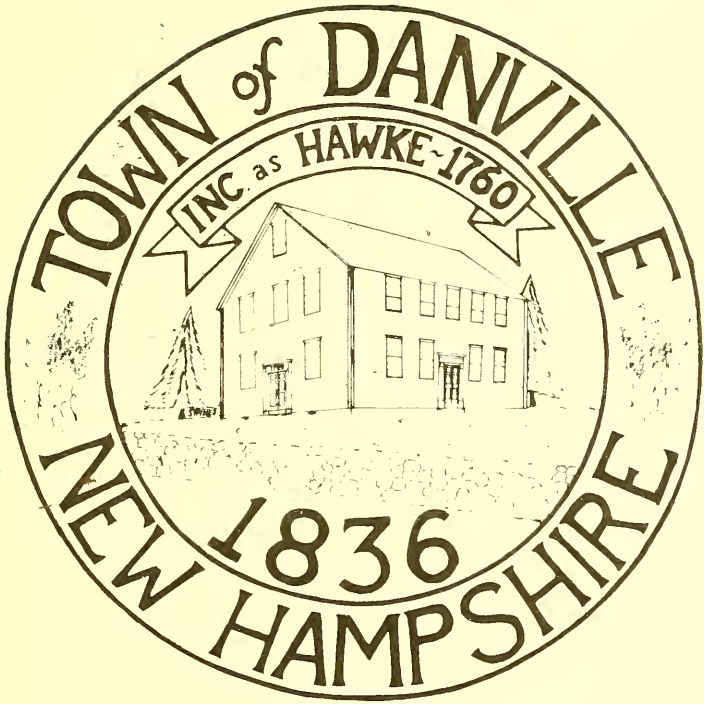

TOWN WARRANT

The State Of New Hampshire

To the Inhabitants of the Town of Danville in the County of Rockingham in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at the Danville Town Hall in said Danville on Tuesday, the Thirteenth (13th) day of March, next at ten of the clock in the forenoon, to act upon the following subjects:

1. To choose all necessary Town Officers for the year ensuing.

2. To choose all necessary School District Officers for the year ensuing.

3. To raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriations of the same.

4. To see how much of the Parsonage Fund the Town will vote to spend for preaching for the ensuing year.

5. To see if the Town will vote to authorize the Selectmen to hire money for the use of the Town in anticipation of taxes.

6. To see if the Town will vote to authorize the Selectmen to sell Tax Title Property by public auction.

7. To see if the Town will vote to authorize the Selectmen to apply for, contract for, and accept aid relative to natural disasters from the Federal Government from the Federal Disaster Assistance Administration in Washington.

8. To see if the Town will vote to appropriate and authorize the withdrawal from the Revenue Sharing Fund established under the provisions of the State and Local Assistance Act of 1972 for use as setoffs against budgeted appropriations for the following specific purposes and in amounts indicated herewith or take any other action hereon:
Police - \$2,000. Fire - \$2,000. Health - \$1,500.

9. To see if the Town will vote to adopt a new Amendment to the existing Danville Zoning Ordinances and Land Subdivision Control Regulations as proposed by the Danville Planning Board as follows: Adopt a separate ordinance, under the police powers doctrine of the State of New Hampshire, to protect the nature and future of the Town of Danville by controlling a limit upon the number of building permits issued for new housing. This ordinance will be in effect for no more than two (2) years or until the adoption of a Town Master Plan, whichever is sooner. This limit will be set at four percent (4%) of the total number of housing units within the Town at year-end 1978. To insure equitable distribution of these permits, applications for new housing will be taken by the Selectmen for the thirty (30) day period beginning April 1 and ending April 30 of each year. Only landowners of land within Danville may apply with a limit of no more than two (2) applications per landowner. If the number of applicants exceed the available number of permits, a drawing will be held on April 30 to select those applicants who will receive permits during that year and assign a number to the remaining applicants. This number will be used in the next year for issuance of permits without drawing until the number of previous applicants is exhausted. A new drawing will occur in accordance with the above when all original applicants have received permits, and there remains permits within the 4% limit.

10. To see if the Town will vote to adopt the Amendment to the existing Danville Zoning Ordinances and Land Subdivision Control Regulations as proposed by the Danville Planning Board as follows: Amend Article XIV, Definitions, by adding Paragraph: "T. Safety Inspections. All new installations of wood burning stoves, fireplaces, or other contrivances, and their related equipment must undergo and pass a Fire Safety Inspection to insure the proper and safe installation of the equipment prior to their use. This Inspection will be performed by the Fire Department."

11. To see if the Town will vote to adopt the Amendment to the existing Danville Zoning Ordinances and Land Subdivision Control Regulations as proposed by the Danville Planning Board as follows: Amend Article XIV, Definitions, by adding Paragraph: "U. Electrical Inspections. Prior to initiation of new and/or modified electrical installations in an existing dwelling, an Electrical Permit shall be obtained from the Building Inspector(s). Prior to use of any such installation, an inspection will be performed by the Building Inspector(s) to insure adherence to all safety standards and codes."

12. To see if the Town will vote to adopt the Amendment to the existing Danville Zoning Ordinances and Land Subdivision Control Regulations as proposed by the Danville Planning Board as follows: Amend Article XIV, Definitions, by adding Paragraph: "V. Occupancy Permits. Prior to occupancy of any new house, mobile home, or dwelling rebuilt after a fire within the Town, the proposed occupant is required to apply for and receive an occupancy permit from the Building Inspector(s) of the Town of Danville."

13. To see if the Town will vote to adopt the

Amendment to the existing Danville Zoning Ordinances and Land Subdivision Control Regulations as proposed by the Danville Planning Board as follows: Amend Article VI Section A, Lot Area and Yard Requirements, Paragraph 1: Change the frontage from one hundred fifty (150) feet to two hundred (200) feet.

14. To see if the Town will vote to adopt the Amendment to the existing Danville Zoning Ordinances and Land Subdivision Control Regulations as proposed by the Danville Planning Board as follows: Amend Article IV, Section B., New Streets, Paragraph 1: Change sixty (60) foot turn-around radius at the deadend to eleven thousand three hundred (11,300) square feet turn-around area, the shape of which is to be determined by the Town Engineer.

15. To see if the Town will vote to adopt the Amendment to the existing Danville Zoning Ordinances and Land Subdivision Control Regulations as proposed by the Danville Planning Board as follows: Amend Article II, General Provisions, by adding a new Paragraph: "G. Water, Health and Safety Provisions. No structure shall be erected or fill placed within marshy, wet, or seasonally flooded areas within the Town which will reduce the natural seasonal high water storage capacity, interfere with the natural flow of water courses or risk the health and safety of present or future residents of the Town. All new construction shall require a building permit review. All building permit applications filed with the Building Inspector(s) will be reviewed by a Permit Site Evaluation Committee consisting of a Building Inspector, Road Agent and/or Town Engineer, Conservation Commission member and Health Officer. This Committee will determine if the proposed location falls within an area which will reduce the natural seasonal high water storage capacity or interfere with the natural flow of any

flood or seasonal high water. The Committee will insure that those areas of proposed construction or fill must be at an elevation above the mean seasonal high water mark."

16. To see if the Town will vote to adopt the Amendment to the existing Danville Zoning Ordinances and Land Subdivision Control Regulations as proposed by the Danville Planning Board as follows: Amend Section III, Procedure, Paragraph B., Application, by adding a last sentence: "For those subdivisions involving the construction of new streets or roads, an additional fee of twenty dollars (\$20.00) per lot will be paid by the applicant prior to subdivision approval. These fees shall be used to cover the cost of inspection and certification of the proposed streets by the Town Engineer."

17. To see if the Town will vote to approve the acceptance and expenditures of any funds received from the Federal Government under Rockingham/Strafford Manpower Administration for use of Tax Map, Youth Corps, IRS and sundry CETA programs in the sum of \$15,000. conditioned upon receipt of said funds. (Not recommended by Budget Committee.)

18. To see if the Town will vote to raise and appropriate a sum not to exceed \$20,000. for "Disaster Control Purposes" and to authorize the Selectmen and/or Fire wards to apply for, contract for, accept, receive and spend any aid, financial or otherwise from Federal, State or other sources, public or private, conditioned upon receipt of said funds.

19. To see if the Town will vote to authorize the establishment of a Capital Reserve Fund for the purpose of future development of a municipal service complex, including land purchase, site development and construction; to authorize the sum of

\$19,000.00 be appropriated therefor, said amount to be transferred before April 1, 1979 from the escrow account currently containing the \$19,000.00 appropriated for purchase of the Garmen land by the Town Meetings of March 4, 1975 and March 14, 1978; to authorize the Selectmen to appoint a Committee of seven members to develop a plan for the complex to be presented for acceptance by the Town at a future Town Meeting, said Committee to include representatives from the Police, Fire and Highway Departments, Selectmen, Planning Board and town residents; and to authorize that the Capital Reserve Fund be under the management of the Trustees of Trust Funds, with the stipulation that any interest earned be reinvested and/or returned to said Capital Reserve Fund. (By petition.)

20. To see if the Town of Danville will appropriate and raise the sum of One Thousand, Five Hundred Dollars, (\$1,500) being a contribution to the Vic Geary Drop-In Center for Senior Citizens. (By petition) (Not recommended by Budget Committee.)

21. To see if the Town will vote to accept the purchase of a parcel of land from Alden Colby on the easterly shore of Little Cub Pond, known as the "right of way".

22. To see if the Town will vote to accept the "Report on wages, salary and Fringe Benefit Recommendations for the Town of Danville" as prepared by the Salary Committee, 1978.

23. To see if the Town will vote to raise and appropriate a sum not to exceed \$1,000. for the purpose of paying for engineering services as referred to in Article 10, and subject to passage of same Article.

24. To see if the Town will vote to raise and appropriate a sum of \$100. for the N. H. Seacoast Region Association. (Not recommended by Budget Committee.)

25. To see if the Town will vote to raise and appropriate a sum of \$400. for the Mental Health Center of Southern N. H.

26. To see if the Town will vote that \$750. of the \$1,500. raised and approved at the Town Meeting of 3/8/72, under Article 11, Phase 1 of the Town of Danville Outdoor Recreation Program, be used for the purpose of completing the ballfield adjacent to the Fire Association Hall, under the direction of the Selectmen.

27. To transact any other business that may legally come before the Meeting.

The polls will be open from 10:00 a.m. to 7:00 p.m.

The second session of the Business Meeting will be held at 7:00 p.m. on Saturday, March 17, at the Fire Association Hall.

DISTRICT FIRE CHIEF AND TOWN FOREST FIRE WARDEN

For more than 80 years, a cooperative effort between the State of New Hampshire and local forest fire authorities has created a forest fire prevention and suppression program that is recognized as superior throughout the United States.

Since the first forest fire laws were written in 1895, the state and local community governments have worked together to prevent and combat forest fires.

Today, 249 forest fire wardens and more than 1,800 deputy wardens are appointed every three years by the State Forester to work with the members of the State Forest Fire staff in this effort. State funds are used to pay one-half the cost of forest fire suppression costs incurred by local forest fire organizations, within pay rates established by the Governor and Council. State funds matched by local funds are used to purchase hand tools to suppress forest fires, to train local forest fire crews and in forest fire prevention work.

All outside burning, when the ground is not covered with snow, is permitted only after obtaining a written fire permit from your local Forest Fire Warden. Penalty for burning without a permit when one is required is a misdemeanor punishable by a fine up to \$1,000. or a jail term of up to one year or both.

Please notify the local fire officials before attempting any burning.

COLBY MEMORIAL LIBRARY

The Friends of the Library Group was formed this year. Their purpose is to provide services and undertake projects beyond the scope of the regular library budget. POLICE DEPARTMENT

During the past year the Danville Police Department has endeavored to provide the people of Danville with the best protection available at the least possible cost, with well over 500 hours of active duty time donated.

We are thankful we can report no substantial increase in "hard" crime, however, there has been an increase in calls including family and neighborhood disputes, vandalism, animal problems, delivering messages, motor vehicle violations, accidents and other emergencies.

If you have studied your Town Report you will have seen in the Summary of Payments for the Police Department, an amount of money paid each officer. It is only fair to these officers to make sure the citizens of Danville fully understand that the amount beside each name is not only for hours of duty, but includes mileage paid for using their own vehicles in carrying out their duty. The actual money paid for police duty (including Chief) comes to a total of \$2,785.47. The balance of payment was for mileage at 13¢ per mile and at today's cost for gasoline, tires and general repairs, this hardly compensates, and in no way can be considered income. It is a reimbursement for an expenditure.

In February, Officers Arthur Storey and Robert Wilson attended a Juvenile Seminar Series which included N. H. Laws Relating to Juvenile Offenses, Legal Limitations and Provisions, Juvenile and Parent Interviewing Techniques. These Seminars are conducted by the N. H. Police Standards and Training Council and funded by The Governor's Commission on Crime and Delinquency.

Chief Clyde Goldthwaite, Officers Eleanor Goldthwaite, Richard O'Brien, Arthur Storey and Robert Wilson, received certificates for successfully completing a course in C.P.R., which was conducted by Instructor and Danville Police Officer, Bruce Antognoni. Many thanks to Officer Antognoni who gave his time and effort to conduct this course for us.

Thanks also, to the many Danville citizens who have been so cooperative and helpful during the past year. It is only with their support and understanding we can make Danville a better place.

PLANNING BOARD

In 1978, the Planning Board: (1) was presented with four sub-division requests and acted favorably on all of them; (2) placed on the 1979 Town Warrant eight amendments to the Zoning Ordinances and Land Subdivision Control Regulations; and (3) conducted an opinion survey of the Town to establish goals for Master Planning.

The pressures of new development continue to be felt throughout the region and particularly in Town. The interim moratorium on new housing proved to be of questionable legality and was not effective in controlling growth.

The survey of the Town conducted by the Master Plan Subcommittee of the Planning Board indicated that the majority of the residents of Danville wanted to: (a) protect the rural nature of the Town; (b) control growth of new housing to less than 4% per year; (c) encourage agriculture; and (d) give priority to schools and business. The Planning Board is structuring both the Master Plan activity and its proposed ordinances in accordance with these desires.

MOSQUITO CONTROL COMMISSION

Three thousand five hundred (3,500) dragon fly larvae were purchased as authorized, under the 1978 Warrant Article 32 and placed by Commission members in mosquito producing waters of the Town. Due to either the dry weather which occurred during the mosquito breeding season and/or the dragon fly larvae and adults feeding upon mosquito larvae and adults, or a combination of both factors, the community enjoyed a summer relatively free of numerous mosquitoes.

The numbers of adult dragon flies were noticeably higher this summer than during previous years, due to the release program. Natural dragon fly reproduction each subsequent year should at least maintain the present population or helpfully increase their numbers.

The Commission will monitor the numbers of these beneficial mosquito eating insects in 1979. Hopefully, no additional town money will need to be spent on mosquito control related activities as a result of this release program.

No assistance was received under C.E.T.A. or Youth Corps programs due to cutbacks in both these federally funded activities.

EXETER AREA VISITING NURSE ASSOCIATION, INC.

The Exeter Area V. N. A., Inc. is a non-profit community health service agency designed to provide acute, chronic and preventative health care to individuals and families in their home; maintain, or restore health; or it may be to minimize the effects of illness or disability.

Funding for the Association comes from Medicare, Medicaid, patient fees, local taxes, and donations. Town appropriations make the service

available to the Town, they do not buy units of service for individuals. Under the Medicare program, people over 65 or those who have been getting disability benefits for 24 consecutive months, part-time nursing and other health services are provided through this Association; which is the certified agency authorized to provide the service.

The services provided, upon referral, are as follows:

1. Home Health Care, including a registered nurse, physical therapist, and/or home health aide.
2. Maternal and Child Health Program including Nursing visits to expectant and new mothers. A post-partum home visit is available without charge. Contact the Association Office. Well Child Clinics are held bimonthly with family planning and referral available.
3. Adult Screening Program including Blood Pressure clinics which are held bimonthly and Annual Flu Vaccine Clinics which are open to all who are 65 years and to those with a prescription under 65.
4. Mental Health Program including home visits and coordination of patient's program.
5. Communicable Disease Program including home visits, testing, instruction and referral.
6. Hospital Referral Program which is done while the patient is hospitalized just prior to discharge to assist in planning, coordinating, and arranging for care at home after discharge.

A portion of Article III of the E.A.V.N.A. By-laws reads as follows: "The services so rendered shall be part time or intermittent, that is, to patients who normally require service a few hours or less a day, several days or less a week, and shall be provided without regard to race, color, origin, or ability to pay."

MENTAL HEALTH CENTER FOR SOUTHERN NEW HAMPSHIRE Annual Report for 1978

Fiscal Year 1977-78 saw a major turning point in the history of the Mental Health Center for So. N. H. In May, 1978, a Federal Grant was secured to expand services beyond the outpatient facilities in Salem and Hampstead. The Derry and Hampstead offices and the Salem Clinic staff was expanded to meet the growing demand for screening, diagnosis, and treatment of individuals and families. The Center plans to work closely with schools, town institutions and service agencies toward early detection and prevention. The newly established Community Services and Education Department offers supporting services to clients, lectures and seminars, radio and television programs, and resource material on mental health issues and problems of daily living.

The Center continues to provide localized inpatient services and care. To expand Sustaining Care to serve a wider range of citizens, Day Treatment and Elcers Services have been developed. Special programs for children and the treatment of alcoholism are being planned for the near future. A new 24-hour Emergency Service, available by calling 432-2253, has been operating since August 1978. All services and programs are planned and administered to be as comprehensive as possible, while being responsive to the particular needs of the client and the community.

In Fiscal Year 1977-78, 13 clients from Danville were seen, with 66 hours spent in outpatient, screening, and identification services and long term services. During the latter half of 1978, the need for services declined, resulting in a total of 9 hours spent in direct outpatient services, and four contacts with Emergency Services. The Mental Health Center recognizes its continuing responsibility to provide this community with the most comprehensive mental health care available.
