## TOWN WARRANT

---

### STATE OF NEW HAMPSHIRE

To the Inhabitants of the Town of Bedford in the County of Hillsborough, in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at the Town Hall in said town on Tuesday, the eleventh day of March, next, at ten of the clock in the forenoon, to act upon the following subjects:

Article 1. To bring forward your ballots for the necessary Town Officers for the ensuing year and the ensuing three years.

Article 2. To raise such sums of money as may be necessary to defray Town charges for the ensuing year, and make appropriations for the same.

Article 3. To raise and appropriate such sums of money as may be necessary for the support of the poor, and assistance to the aged.

Article 4. To see if the Town will vote to raise and appropriate the sum of \$6,000.00 for the maintenance of highways and bridges, and for any other necessary expense of the Town.

Article 5. To see if the Town will vote to authorize the Selectmen to hire money in anticipation of taxes up to the sum of \$15,000.00 if needed.

Article 6. To see if the Town will vote to raise and appropriate the sum of \$300.00 for the Town Library.

Article 7. To see if the Town will vote to raise and appropriate the sum of \$20.00 for the care of the clock on the church.

Article 8. To see if the Town will vote to raise and appropriate the sum of \$978.30 for the construction of Class V highways, the State to contribute \$3,713.20.

Article 9. To see if the Town will vote to raise and appropriate the sum of \$3,000.00 for the tarring of Class V highways, under the direction of the Selectmen.

Article 10. To see if the Town will vote to raise and appropriate the sum of \$50.00 for Memorial Day and patriotic purposes.

Article 11. To see if the Town will vote to raise and appropriate the sum of \$300.00 for the care of the New Cemetery; \$25.00 for pumping water for same; \$50.00 for the care of Joppa Cemetery; \$10.00 for the care of the Old Cemetery on the Back River Road; and \$15.00 for the care of the Beals Cemetery.

Article 12. To see if the Town will vote to petition the State Tax Commission to have an audit made by the Division of Municipal Accounting, and to raise and appropriate such sum of money to cover the expense of such audit as may be necessary.

Article 13. To see if the Town will vote to authorize the Selectmen to secure the assistance of the State Tax Commission in reappraising the taxable property in the Town in order to secure greater equality as between taxpayers, and to insure the assessment of all property in the Town on the same standard of value, and to raise and appropriate money to pay for the same.

Article 14. To see if the Town will vote to raise and appropriate a sum not to exceed \$188.60 to the Merrimack Valley Region Association for the purpose of publicizing



and promoting the national advantages and resources of the town in co-operation with the other 37 communities in the Merrimack Valley Region.

Article 15. To see if the Town will vote to establish a street light at the corner of College Road and Worthy Road and raise and appropriate money for the same.

Article 16. To see if the Town will vote to establish additional street lights on Donald Street and raise and appropriate money for the same.

Article 17. To see if the Town will vote to raise and appropriate the sum of \$100.00 to be used toward the eradication of poison ivy on public grounds and road sides.

Article 18. To see if the Town will vote to establish and maintain a dump in the Donald Street section and raise and appropriate money for same.

Article 19. To see if the Town will vote to accept \$200.00 in trust from the late Charles D. Barnard, the interest to be expended for the care of his lot in the Bedford Center Cemetery.

Article 20. To see if the Town will vote to accept \$150.00 in trust from Achsah A. Snell in will of Elizabeth S. Merrill, late of Concord, N. H., the interest to be expended for the care of lot No. 60 in the Bedford Center Cemetery.

Article 21. To see if the Town will vote to accept \$100.00 in trust from Mrs. Anna Holbrook, the interest from which to be expended for the care of her lot (No. 68) in the New Cemetery.

To hear the reports of Agents, Auditors, Committees and of other officers heretofore chosen, and to transact any other business that may legally come before said meeting.

## ANNUAL REPORT OF BEDFORD SCHOOL BOARD

-----  
(1946-1947)

The most important development upon which the Board wishes to comment is the increased expense of education which must be borne by tax payers of the town. The estimated expenses for the year 1947-1948 under the budget to be submitted for approval at the annual district meeting are \$36,844.32, an increase of about \$3,500 over the previous year.

The largest single item contributing to this increase is the appropriation for teachers' salaries. At the 1946 annual district meeting the salaries were increased from \$1,250 to \$1,350. Before the end of the school year it became apparent that this increase was insufficient if the town was to have competent and satisfactory teachers because of the fact that other localities were offering considerably higher salaries. Accordingly at a special district meeting held in July it was voted to increase salaries to \$1,550 a year. It now appears that further increase is necessary if the town is to maintain a proper standard of instruction in its schools and the Board has recommended that teachers' salaries be established for the coming year at \$1,700. This additional expense reflects the general upward trend in teaching salaries.

Another unavoidable increase in cost is found in the high school tuition now required to be paid in the Manchester schools. In the last year this has grown from \$114 a pupil to \$123 which with an estimated 90 pupils who will be attending high school represents a substantial increase. Transportation costs have likewise increased steadily for a number of years as is indicated by the fact that the ap-



appropriation for the school year 1937-1938 was \$2,367.50 as against a figure of \$4,206.83 recommended in the current budget. The upward swing is found in practically every other category. For example, there has been an increase in the cost of fuel and in janitor service and practically all other items show some increase. The Board has attempted to fix the budget at the minimum amount required, but feels that it can not be cut below the recommended figure if the schools are to be maintained at the level of efficiency and service which they have rendered in the past.

The Board wishes to report that the new heating plant at the Donald Street School authorized at the last annual district meeting has been installed and is operating satisfactorily.

An experiment has been introduced at the Peter Woodbury School in the furnishing of school lunches. Financial assistance is provided under a program of the Federal Department of Agriculture and the balance of the expense is borne by the parents. It is too early yet to report on the results of this experiment.

It is hoped that the present method of notification in the event the schools are closed because of stormy weather is proving to be satisfactory.

Some time ago the Board sent a letter to the parents of all the children attending the schools expressing the hope that constructive suggestions would be made to the Board and interested parents or others were invited to attend meetings for the purpose of discussing any of the school problems in town. This invitation is renewed and it is hoped that the Board may receive more suggestions from interested towns people.

## REPORT OF SUPERINTENDENT OF SCHOOLS

---

*To the School Board and Citizens of the School District of Bedford:*

I submit to you my first annual report as Superintendent of your schools.

It was my good fortune to find a corps of interested and efficient teachers in your schools. I am happy that so nearly all could be induced to remain during this present year. The economic pressure coupled with offers from other towns and our desire to deal properly with our teachers, make it imperative to elevate our ideas of the pay which is appropriate for the service rendered.

We were very sorry that Mrs. Marcy decided to give up teaching. This opened up two problems—a teacher in the lower grades and means of transportation for the teachers at Stevens Buswell School. These problems were solved when Mrs. Helen Owen agreed to transfer from the upper to the lower grades at Stevens Buswell School and Mrs. Isabelle Barry agreed to transfer from Peter Woodbury School upper grades to Stevens Buswell School upper grades. Then Mrs. Myrtie Sargent took over the upper grades at the Peter Woodbury School.

Again the large number of pupils in the lower grade group at Stevens Buswell School made it seem advisable to provide part-time assistance. We are indeed fortunate to have available a teacher who can so well fill this need. Mrs. Rose Isham works with the 3rd and 4th grades during the morning session. While the number entering the 1st grade continues to be large, we shall need to continue, at least, this part-time program.

The decision to change the heating plant at Donald Street appears to have been wise. After much planning and looking about for more favorable offers, an oil burning steam system using convection type radiators was installed at a cost somewhat in excess of the special appropriation. Its operation has been very satisfactory and quite economical. This experience with oil burning equipment tends to suggest that it might be worthwhile to change the Peter Woodbury School plant from coal stoker to oil burner.

I have been most favorably impressed by the desire of the School Board to meet fully their responsibility to plan for the educational welfare of all the children in the District. Cooperation with your School Board in eliminating all hint of sectional jealousy can result in an improved plan of educational opportunity for all.

## HELP YOUR FOREST FIRE WARDEN PREVENT FIRES—IT PAYS!

---

Prevention is one of the most important phases of all fire effort. This is particularly true of forest fire control work. Preventing forest fires preserves valuable forest growth and other property, conserves man power and permits their use in productive channels, saves taxpayers' money and conserves fire fighting equipment.

The prevention of forest fires is the most important and difficult part of the work of your forest fire warden who heads a local organization set up primarily for the security of your community's forest property. Appointed by the State Forester, upon recommendation of the Selectmen, he is charged by law with the responsibility of local administration of forest fire laws, fire prevention and suppression. In his work he is aided by deputy forest fire wardens who, in emergency, may assume his power and authority. The warden is guided in his work by instructions received from the State Forester and by the District Fire Chief who represents the State Forester.

The importance and value of the work of the forest fire warden and his deputies is, perhaps, best appreciated during hazardous periods when fire danger is greatest. The public, however, looks to him at all times for speedy and economical suppression of going fires.

To properly fulfill his mission, the warden needs the generous and understanding cooperation of the public at large. He attempts to secure this cooperation by the posting of caution notices, news items and by word of mouth, always carefully explaining the necessity of re-

strictions imposed. In the matter of giving cooperation, however, the public often fails. The record shows that an average of 7,300 acres of woodland are burned over by forest fires in New Hampshire each year. Analysis of fire causes reveal the fact that more than 98 percent of all forest fires are, consistently, the result of human carelessness and are preventable.

The careless smoker fails to properly extinguish his cigar, cigarette or pipe ashes or thoughtlessly throws them from the car window; the debris burner fails or refuses to consult the warden, as the law requires when the ground is not covered with snow, before attempting to burn; campers fail to properly extinguish their fires or frequently build fires when conditions are unfavorable.

The elimination of human causes from the forest fire problem is the answer. This is not as difficult of accomplishment as it might appear at first glance. Let each one who reads this—

1. Use ordinary common sense with fire in and near woodland.

2. Comply with requirements on the use of fire in and near woodland and when the ground is not covered with snow, secure written permission to burn from the forest fire warden.

3. Be careful when smoking in or near woodlands. Don't throw lighted material from moving vehicles.

4. Cooperate with and assist the warden and urge others to do so.

5. **HELP YOUR FOREST FIRE WARDEN PREVENT FIRES**—his efforts are only as effective as is the cooperation you give him!
