STATE OF NEW HAMPSHIRE

To the Inhabitants of the Town of Bristol in the County of Grafton in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at the Town House in said Bristol on Tuesday, the thirteenth day of March next, at nine of the clock in the forenoon to act upon the following subjects:

1. To choose one Selectman for three years, and choose all other necessary Town Officers for the year ensuing, and to bring in your ballots upon the question as to whether the amendment proposed by the Convention to revise the Constitution shall be approved.

2. To raise such sums of money as may be necessary to defray town charges for the ensuing year, and make appropriation of the same.

3. To see what sum of money the Town will raise for the support of Highways and Bridges for the year ensuing, and make appropriation of the same.

4. To see if the Town will raise money for the maintenance of the State Aid and Trunk Line Roads for the year ensuing, and make appropriation of the same.

5. To see if the Town will vote to accept the provisions of Chapter 117, Laws of 1917, on a section of the Sunapee Lake Road, so called, and appropriate, or set aside from the amount raised for highway work, the sum of two hundred and fifty (\$250.00) dollars for this purpose.

6. To see if the Town will vote to raise the sum of one hundred and fifty dollars (\$150.00) for the observance of Memorial Day for the ensuing year, and make appropriation of the same.

7. To see what sum of money the Town will vote to raise for the Maintenance and Construction of Sidewalks for the year ensuing, and make appropriation of the same.

8. To see what sum of money the Town will vote to raise for the Maintenance of Sewers for the year ensuing, and make appropriation of the same.

9. To see what sum of money the Town will vote to raise for the Construction of Sewers for the year ensuing, and make appropriation of the same.

10. To see if the Town will vote to authorize the Selectmen to appoint instead of electing a Police Officer for the year ensuing.

11. Agreeably to vote of the Town at the Annual March Meeting, March 8, 1921, to elect five (5) members for the Budget Committee for a term of three years.

12. To see if the Town will vote to raise a sum of money, to be applied on Town Debt, and make appropriation for the same.

13. To see if the Town will vote to authorize the Selectmen to issue Serial Notes as provided by law, to take care of the present outstanding Notes, not to include Notes issued for the purpose of anticipation of Taxes.

14. To see if the Town will vote to raise the sum of three hundred dollars (\$300.00) for Band Concerts,

and make appropriation of the same, and elect or appoint a committee with authority to make such expenditure.

15. To see if the Town will vote to accept the provisions of Chapter 155, Laws of 1921, relative to building or rebuilding any Bridge, on any Trunk Line, Cross State or any designated State Aid Highway in said Town of Bristol, if accepted and adopted, raise and appropriate, such sum of money as may be deemed necessary for any Bridge or Bridges the Town shall designate.

16. To see if the Town will vote to raise, instead of setting aside from the regular Highway Money, the sum required by law, for the purpose of permanent improvement on some designated piece of Town Highway, approved by Town Officials, and make appropriation of same.

17. To see if the Town will vote to accept Trunk Line Aid for Construction, and raise the sum of twenty-three hundred and sixty-one dollars (\$2361.00), and make appropriation of the same.

18. To see what action the Town will take, relative to building new Bridge on Pleasant Street near the Junction of Pleasant and Lake Street, and raise money for this purpose and make appropriation of the same.

19. To see what action the Town will take, relative to Lower Covered Bridge over the Pemigewasset River near the B. & M. Railroad Station, as to repairing or building new Bridge, and if the Town will vote to raise money and make appropriation for this purpose.

20. To transact any other business that may legally come before said meeting.

MINOT-SLEEPER LIBRARY—REPORT OF TRUSTEES

To the Inhabitants of the Town of Bristol:

There is nothing specially new to report for the past year.

The library has been pursuing the even tenor of its way in affording pleasure and instruction to all who choose to take advantage of the fine opportunity which a public library of this character offers to its patrons.

Eleven thousand seventy-six books have been loaned from the circulating department, to which have been added about two hundred volumes during the past year, about one-half being juveniles, the remainder mainly fiction and valuable works of history and travel. During the year the Trustees have been endeavoring to secure complete sets of the writings of the distinguished authors and scholars, Fred Lewis Pattee and Eugene R. Musgrove, such volumes as may be useful for general reading. Some of the books written by Prof. Pattee are already out of print and difficult to secure, but two of the Trustees, Messrs. Ackerman and Cavis, have kindly offered to donate some of the needed volumes and doubtless others who may have them will be glad to help out. Such of these as the library has, or has had, have been worn out by constant use. Anyone having any of these volumes to spare will confer a favor by mentioning the same to the committee, Messrs. Chase, Cowan, and White.

The following magazines, kindly furnished by the Minnie Maria Jackman Fund, may be found on the reading tables, viz., American, American Boy, American

Nature Magazine, Asia, Atlantic, Century, Christian Century, Constitutional Review, Current Opinion, Garden Magazine, Geographic, Granite Monthly, Harper's, Ladies' Home Journal, Literary Digest, North American Review, Our Dumb Animals, Our World, Outlook, Pictorial Review, Popular Mechanics, Review of Reviews, Scribner's, Travel, World's Work, Youth's Companion, and American Forestry by Miss Whipple.

Books cost nearly double the price of a few years ago, so that the purchasing power of our funds for new books and renewal of desirable old ones is much lessened. But the addition of reading and reference books have so crowded the space of the present building that more room is absolutely needed. The tax payers of Bristol in considering the problem of a new schoolhouse or the enlargement of the present school building, should not forget that there is also an imperative need for the enlargement of the library building.

At the recent annual meeting of the Trustees Mrs. Mary A. Dodge was re-elected librarian.

REPORT OF SUPERINTENDENT OF SCHOOLS

To the School Boards of Bristol Town and Bristol Union
School Districts:

I submit herein my first report as superintendent of schools.

Because of the fact that I have been in service here a little over six months you will readily appreciate why my report does not cover the work of the year, 1921-22.

On the other hand it will be more in the nature of an outline of what I hope to do with the schools as I continue to serve you as your superintendent.

TOWN DISTRICT

I was glad to be able to start in with the same corps of teachers. This meant that they could carry on their work about where they left off last summer, and less confusion resulted. Length of service insures good work both on the part of the pupils and teachers and in the long run means better schools.

Repairs

A certain amount of repairing seems always necessary, and hardly a school year goes by without the need of a little being done. The Dolloff schoolhouse needs a lot of such work to put it into shape. A wood shed is needed. Within the building, the plastering is falling off. The lack of blackboard space is very noticeable. I suggest that a sufficient amount of money be raised to put this building into first class shape—that a new shed be built; that the entrance be either through the

shed or by means of a vestibule; that the walls and ceiling be sheathed; that a blackboard be placed to cover the entire wall in front of the pupils, and that the building be painted. One judges a community more or less by the appearance of its school houses. If the District would put each school house into repair one at a time the upkeep could be kept at a very low figure.

Books

I believe it wise to pattern the course of study after that of the Union School District. There should be no reason why this cannot be done. So far, I have tried to purchase for these schools the same texts that I have purchased for the Special District. Many more books are needed; perhaps more than can be bought in one year. In the course of time I hope that all the needs along this line will be fulfilled.

Tuition

Now that the Union District has raised the elementary tuition to \$1.50 per week, it is a debateable question just what the Town District ought to do in regard to paying the tuition of its seventh and eighth grade pupils.

To pay the tuition of several pupils means the expenditure of quite a sum of money that otherwise would be available for use in the three schools already running. If it is advisable to pay this tuition I suggest that a sum be appropriated at the annual school meeting for this particular, thus leaving intact any money received from the state for the support of elementary schools.

Opening Date

The three Town schools began the school year August 28th. While this was a week earlier than the Union school opened it was without question the wisest thing to do. People are reluctant to send their children long distances in extreme cold weather. By starting as early as possible nearly half the school year can be gone through before the disagreeable weather sets in. The Dolloff school closed Jan. 19th at the end of the twentieth week for an indefinite period. The weather and condition of the roads showed the wisdom of starting the school year early.

UNION SCHOOL

So much has been said in the past about the overcrowded condition of the building that it hardly seems necessary to dwell very long on this phase of the school system. Yet this is one of the things that struck me very forcibly as I watched the work of the year progress. The enrollment printed elsewhere was the number in the building during the first week of school. There has been little change since then; the enrollment at this writing is 222. Such conditions hamper both teachers and pupils; making the problem of discipline more difficult and lessening the effectiveness of the quality of instruction. The pupils in the long run are the losers.

Teachers

The teaching force of last term was retained with the exception of the high school assistant. Miss Coombs, a graduate of Bates College, took the place of Miss Rowley. She entered upon her work with enthusiasm.

Program of Studies

A slight change was made in the program of studies because at the time it seemed the only way to get around a problem that appeared rather serious to me.

French was taken from the seventh and eighth grades and placed in the first and second years of the high school. This change seemed wise because previously there was a break in the French after the eighth grade until the second year of high school. Pupils coming in from the rural schools to the high school were not able to compete with their mates in the second year of high school because they had had no French in the schools from which they came. If the high school is to look to the surrounding towns for members, I felt it ought to offer some inducement of equality to those coming from the outside districts. In the place of French in the seventh and eighth grades more Arithmetic was added, and this to my mind has strengthened the course of study there.

The course in Domestic Arts was dropped for the time being. To have retained it would have made an unbalanced course. There was no way of giving the boys Manual Training, and until the time comes when these two vocational courses can be offered to the boys and girls alike I believe it better to omit them. This, in brief, constitutes the changes in the course of study.

School Day

Another change was made in the opening hour of the school and all rooms now start the day at 9:00 a. m. Except in extreme cold and rainy weather the doors are not opened until 8:45. Pupils may then enter the building and go to their rooms; the second bell rings

at 8:55 and all pupils are required to be in their seats; the next five minutes are spent getting ready for the day's work.

The scheduled work of the day ends at four o'clock; however, pupils who have not been tardy either session and whose work is up to grade go at 3:30, the others remain till four or until their work is finished. This arrangement has lessened the number of tardinesses and the daily attendance has been generally bettered.

Needs

Books and maps are badly needed. Some books have been bought but not enough to meet all the needs. In some instances only half the number needed have been purchased. These have been passed around. This is a saving financially but is a rather troublesome method. Each child should have a book.

Maps are needed too. There is hardly an up-to-date map in the building.

Plans

In the fall a public spelling match was held. The whole building was drilled on the Ayres list in preparation for this. By this scheme the interest in spelling was awakened and the result has been that the spelling has been improved. The banner was won by the High school and the individual prize went to Converse White. Names of the contestants will be found elsewhere in this report.

I believe a similar contest in Arithmetic might be arranged that would be of value to the pupils.

The Terman Group Intelligence Test has been given to the pupils from the High school down to the fourth grade.

Diagnostic Tests in the Fundamental processes of Arithmetic have been given to the pupils of the seventh and eighth grades and graphic charts prepared for each pupil. By means of this test the individual weakness of each pupil was determined. Each pupil is now working to overcome this weakness and a second test will be given before the year is over. Other Diagnostic Tests will be given in Language, Reading, History and Geography, and Reasoning Tests in Arithmetic. The use of Standard Tests and the Termán Group Intelligence Test form a pretty sure basis of promotion.

Appreciation

Let me add a word of appreciation for the kindly way in which my family has been received by the people of Bristol. Everyone has been most kind and the feeling of loneliness usually attendant upon the moving to a new place has been wholly lacking.

To both committees and to the teachers in the schools I am indeed grateful for your willingness to carry on the work under different management.
