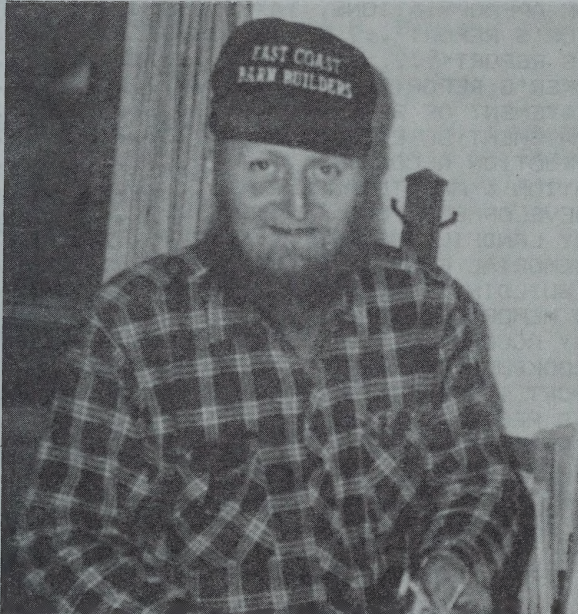

# TOWN WARRANT

THE STATE OF NEW HAMPSHIRE

THE POLLS WILL BE OPEN FROM 10:00 A.M. TO 7:00 P.M.

To the Inhabitants of the Town of Pittsburg, in the County of Coos, in the State of New Hampshire, qualified to vote in Town Affairs:

You are hereby notified to meet at the Bremer Pond Auditorium in said Town of Pittsburg on Tuesday, the eighth day of March next, at 10:00 of the clock in the forenoon, to act upon the following subjects:

1. To bring in your ballots for the election of one Selectman for three years; one Road Agent for one year; one Moderator for two years; one Supervisor of the Checklist for six years; one Overseer of Welfare for one year; one Trustee of Trust Funds for three years; one Town Treasurer for three years; one Library Trustee for three years; two Planning Board Members for three years; one Planning Board Member for one year.

Also, to bring in your ballots on the following questions:

Question 1: "Are you in favor of abolishing the Planning Board as proposed by petition of the voters of this town?"

Question 2: "Are you in favor of the adoption of the zoning ordinance as proposed by the Planning Board?"

To see if the Town will vote to give the Selectmen authority to appoint all necessary Town Officers not listed under Article 1.

"Shall the Town accept the provision of RSA 33:7 providing that any town at an annual meeting may adopt an article authorizing indefinitely, until specific rescission of such authority, the Selectmen to issue tax anticipation notes?"



4. To see if the Town will vote to authorize the Town Treasurer to appoint a deputy treasurer with the approval of the Selectmen. Said deputy shall be sworn, shall have the powers of the treasurer, and may be removed at the pleasure of the treasurer per RSA 41:29-a.
5. To see if the Town will vote to raise and appropriate the sum of twelve hundred dollars (\$1,200) to observe Old Home Day and elect a committee to manage the observance of same. (Recommended by the Selectmen)
6. (By Petition) "Shall we adopt the provisions of RSA 72:28, V and VI for an optional veterans' tax credit and an expanded qualifying war service for veterans seeking the tax credit? The optional veterans' tax credit is \$100, rather than \$50."  
(Ballot vote required)
7. To see if the Town will vote to have the Road Agent appointed, rather than elected, beginning in the year 1995.
8. To see if the Town will vote to raise and appropriate the sum of ten thousand dollars (\$10,000) for the dump closure plan. This appropriation may be encumbered for up to five years. (Recommended by Selectmen)
9. To see if the Town will vote to close out the Sewer Construction Account and to raise and appropriate the sum of twenty-one thousand one hundred seventy-five dollars (\$21,175) from this account (which represents the balance plus estimated accrued interest to date of withdrawal) to be used to reduce the debt service that is included in the operating budget.  
(Recommended by the Selectmen)
10. To see if the Town will vote to raise and appropriate the sum of five thousand dollars (\$5,000) to be added to the Police Cruiser Capital Reserve Fund previously established. (Recommended by the Selectmen)
11. To see if the Town will vote to raise and appropriate the sum of ten thousand dollars (\$10,000) to be added to the Highway Department Heavy Equipment Capital Reserve Fund previously established.  
(Recommended by the Selectmen)

12. To see if the Town will vote to raise and appropriate the sum of twenty thousand dollars (\$20,000) to be added to the Fire Truck Capital Reserve Fund previously established. (Recommended by the Selectmen)
13. To see if the Town will vote to close out the Veterans' Memorial Fund and raise and appropriate the sum of one hundred twenty-four dollars (\$124) from this account (which represents the balance plus estimated accrued interest to date of withdrawal) to be used at the memorial site. (Recommended by the Selectmen)
14. To see if the Town will vote to rescind the action taken at the 1993 Town Meeting regarding the refurbishing of the Hollow Cemetery tomb and vote to have the tomb removed; and also vote to appropriate the \$2,000 raised and encumbered toward the costs of removal and use the balance for other cemetery work. (Recommended by the Selectmen)
15. To see if the Town will vote to authorize the Selectmen and the Library Trustees to expend the balance of the money raised and encumbered for Town Library shelving, and appropriate the unused balance of \$9,479 for other Library purposes. (Recommended by the Selectmen)
16. To see if the Town will vote to discontinue plowing driveways beginning in the fall of 1994.
17. "Shall the Town accept the provisions of RSA 31:95-b providing that any town at an annual meeting may adopt an article authorizing indefinitely, until specific rescission of such authority, the Selectmen to apply for, accept and expend, without further action by the town meeting, unanticipated money from a state, federal, or other governmental unit or a private source which becomes available during the fiscal year? This authorization will remain in effect until rescinded by a vote of the municipal meeting."
18. To see if the Town will vote to raise and appropriate the sum of \$622,249 which represents the operating budget. Said sum does not include special articles addressed. (Recommended by the Selectmen)

19. To transact any other business that may legally come before this meeting.

Polls will not close before 7:00 P.M.

## TRANSMITTAL AND COMMENTARY LETTER

To the Members of  
the Board of Selectmen  
Town of Pittsburg  
Pittsburg, New Hampshire 03592

Members of the Board:

In planning and performing our audit of the financial statements of the Town of Pittsburg, New Hampshire for the year ended December 31, 1992 we considered the Town's internal control structure to determine our auditing procedures for the purpose of expressing an opinion on the financial statements and not to provide assurance of the internal control structure.

However, during our audit, we became aware of the following conditions that should be corrected in order to strengthen internal controls and operating efficiency. This letter does not affect our report dated June 30, 1993 on the financial statements of the Town of Pittsburg, New Hampshire.

Our following remarks are being made in the hope that they will improve the existing procedure and are in no way a criticism of Town personnel.

1. Community Development Fund

During our audit of the Community Development Fund we noted that the voucher or manifest system for the Selectmen to authorize payment was not implemented. The Selectmen just verbally approved the payments.

Recommendation

Because this Special Revenue Fund is designated for specific purposes, the Selectmen should implement a voucher or manifest system to authorize payments only after reviewing each invoice or backup document.

2. Preparation of Budget

The Town prepares the budget using the net amount for each department which is total anticipated expenditures minus respective departmental income.



Recommendation

The purpose of budgeting is to establish a comprehensive basis for management's control and planning. It is recommended that the Town separate gross revenue from gross appropriation for each department so that the management can effectively monitor the financial activity.

3. Trust Funds

The ending cash balances of several Trust Accounts on the Trust report were not in agreement with the bank statements.

Recommendation

Although the amounts were not material, the Bookkeeper of the Trust Funds should reconcile the ending cash balances with the bank statements before submitting the Trust report to the State.

4. Fire Department Building Fund

We had a difficult time obtaining the accounting records of the Fire Department Building Fund. It is clear that internal accounting control over the Building Fund's records are weak. No controls are in place that would uncover errors and irregularities within a reasonable time.


Recommendation

The Town Treasurer should have custody of all monies, including building funds, belonging to the Town according to RSA 41:29. In doing this, the Town would be able to ensure that the fund is managed according to the designated purpose. We made this recommendation in the 1991 audit report.

We extend our thanks to the officials and employees of the Town of Pittsburg for their assistance during the course of our audit.

It is our opinion that the Selectmen, other officials and staff are doing an excellent job administering the Town of Pittsburg.

## ROAD AGENT'S REPORT

In July 1993, we made our last payment on the Dresser Grader. The Town now owns it free and clear! At present, it has about 2800 hours on it and is still in excellent condition. Our Case Loader is 22 years old with about 2500 hours, and, despite its age, it is still in very good condition. Our three plow trucks are as follows: 1985 Int'l. with 75,000 miles, 1976 GMC with 36,000 miles, and 1989 Chevy with 37,000 miles. I anticipate having to replace the GMC in two to three years.

We have four large plows approaching 20 years old and three 5-yard sanders, one at 9 years and the other two at 15 years. Also we have the 9-foot plow and the 3-yard sander for the Chevy 1-ton which are both from 1991. In addition, we have a rock rake, a sweeper (which was donated to us), two chloride spreaders, and a small V plow. We have a maintenance schedule which is followed up by me and my two helpers, Kendall Wheeler and Greg Smith.

In 1993, the town spent a little over \$29,000 for hired pickups with plows. We currently plow 507 driveways. We also plow a little over five miles of private roads, the cost of which is over and above that figure, as it is for the most part done with town trucks. Also it should be noted that the three town trucks plow many of the larger driveways as I feel it is cost effective to do so.

We gravelled the upper end of Halls Stream Road, widened and gravelled the lower end of Tabor Road, gravelled the lower end of Danforth Road and part of River Road. We also removed a huge boulder from Back Lake Road and gravelled there as well. We also paved part of Hill Road, all of Judd Road, and part of Beach Road.

I would like to thank the crew for a job well done and you, the townspeople, for your continued support.

# POLICE DEPARTMENT REPORT

The year 1993 saw the Pittsburg Police Department investigating a total of 75 motor vehicle accidents. Of this total, 29 involved either deer or moose. I would caution everyone who is driving near an area that is frequented by such animals to please slow down and expect the unexpected.

In addition to investigating these accidents, we were busy investigating over 50 criminal cases and were able to prosecute over 100 motor vehicle cases in court. "Driving While Under the Influence" cases were up 50% in 1993 and with the new .08 Law, we anticipate an increase once again in 1994. Please be aware of the dangerous consequences of driving while under the influence and help make our highways safe. We totally support the designated driver approach and hope that everyone uses good common sense.

In 1993, Sgt. Albert vonDohrmann chose not to return to the department after being on a years leave of absence. We were fortunate to have Dwayne Covell join us and hope to have him complete the part-time Officer's School in the Spring.

At this time, I would like to stress the fact that we want to make sure that you know how to reach an officer when necessary. The Police Office number is 538-7003 and if no one is there, we now have an answering machine that will take your non-emergency messages. If you have an emergency, call 538-6611 where we have 24 hour dispatching capabilities through Colebrook base.

With the threat of rabies in the area, it is vital that all dog and cat owners be sure that their pets have updated rabies shots. We will make a concentrated effort in 1994 to see that all dog owners license their dogs in accordance with the law. Violators will face a potential court date if they fail to comply. We urge everyone to maintain control of their pets as it is usually wild animals that carry rabies and infect domestic pets. A rabies clinic will be held in the Spring and everyone is urged to take advantage of it.

In closing, I would like to thank each of my officers for their continued support and dedication to the department. I would also like to remind you that we are there for you and welcome any suggestions or comments as to how we can better serve you.



At that time, our four ambitious attendants, Jill and Sandy Young, Gloria DeGray, and Millicent Philbrook will be Certified Emergency Medical Technicians (EMT's), making our Corps staffed with 12 EMT's and 4 First Responders.

In 1993 four of our Corps members decided not to re-certify. I would like to take this opportunity to thank Richard Jolicoeur, Kevin Judd, Dave Perry, and Brendon K. McKeage, for their many years of dedication and service. Your help and caring was greatly appreciated by all.

During the month of November, Sandy Young, along with Troy Chase and Sid Young, decided to put their talents to work and build a rescue sled for the Corps. The sled will be able to transport one patient and up to two attendants. It will be mainly for winter use but may have capabilities for summer use in the future. Sandy, Troy, and Sid have donated their time and efforts to this project and I would like to thank them very much, the help is greatly appreciated. The sled is expected to be completed in February.

Our emergency number remains 538-6611. Please remember to give the dispatcher as much information as possible and the phone number of where your're calling from, in case the dispatcher must call back. By doing this you will enable the ambulance attendants to serve you as quickly and as best as possible.

In closing I would like to thank the Selectmen and townspeople for their continued encouragement and support. I would also like to remind everyone that the Ambulance Corps is a non-profit organization and we greatly appreciate any donations. ## PLANNING BOARD REPORT

The Board remained active during the 1993 season with nine subdivision application requests, consisting of: four lot line adjustments, four minor subdivisions and one major subdivision in the Camp Otter area. We started updating our files on previously approved subdivisions that were required to bring the roads up to the subdivision standards and made several on-site road inspections to determine their current status.

The Board developed a checklist that will be used with all major subdivision requests to insure that the same process is used for all applications. Part of the process will include the request for a surety bond in order to guarantee proper road development and construction.

The Board continued to have informational meetings on the proposed zoning ordinance and held the final public hearings in late December. The final draft of the proposed zoning ordinance was printed in January, 1994 and this revision will be the one that is voted on by ballot at the town meeting in March.

In late November, a petition was received requesting the abolishment of the Board. As regulated by State law, a public hearing was held in response to the petition. Board members in attendance attempted to clarify some of the issues that were raised during the meeting. The Members pointed out that if the Board was abolished, then the subdivision rules and regulations would also be abolished, although the Master Plan would continue to be a guide for the future growth of the town. There was much confusion about the Board's role and the proposed zoning ordinance, and it was made clear that the zoning ordinance is a separate issue and, if enacted, would have its own separate Board of Adjustment. The question of whether to abolish the Planning Board will be brought to ballot at the town meeting as well.

The Board meetings are open to the public and more recently are only held on the fourth Thursday of every month at the Town Office Conference Room starting at 7:30 PM. The Board encourages any interested party to attend or you may send written correspondence to Pittsburg Planning Board, P.O. Box 60, Pittsburg, NH 03592.

The Board wishes to thank its many supporters and looks forward to continuing to serve the town in the coming years ahead.
