



ROCKINGHAM COUNTY DELEGATION

Monday, February 27th, 1956 Pursuant to notice as provided by law, the Rockingham County Delegation met at the County Farm, Brentwood, N. H. at 10 a.m. this date.

Chairman Draper W. Parmenter presided. The roll call showed a presence of 43 Representatives and 4 Delegates.

Mr. Frank A. Robinson, Budget Chairman read and explained the budget as submitted by the Finance Committee, and the Chairman proceeded with the business of the meeting.

Motion by Mr. Scamman to adopt from No. 1 to No. 11. Motion carried.

Motion by Mr. Murch to adopt No. 12. Motion carried.

Motion by Mr. Eastman (Exeter) to adopt No. 13 from a to e. Motion carried.

At this point where we are considering item f of No. 13, Mr. Sayre Merrill of Exeter gives us a talk about his personal investigation of the Men's Home, and Mr. Merrill concludes with the following motion: That the Executive Committee be instructed to conduct a thorough study of the advisibility of replacing the 80 year old Infirmary with a modern building, together with a study of such alterations of the Men's Home as will afford a means of housing the patients of the Infirmary, in all, or a part of the Home, during the process of the demolition of the present Infirmary, and report their conclusions and recommendations to the Delegation prior to Sept. 1, 1956. Motion carried.

Then Mr. Douglas Scamman makes a motion that "An appropriation of \$2500. be made for the Executive Committee to investigate the Old Men's Home for repairs and alterations, said Committee to report at the next meeting". Motion carried.

Motion by Mr. Merrill to adopt No. 14. Motion carried. Motion by Mrs. Margaret Griffin to adopt No. 15. Motion carried.

Motion by Mr. Charles H. Gay to adopt Nos. 16 & 17. Motion carried.

Mr. Scamman moves that we adopt No. 18 with the following motion: Resolved that the County of Rockingham hereby revokes its election heretofore made to have its officers and employees become eligible to participate in the State Employees Retirement System, such revocation to be effective with respect to officers & employees who shall enter the service of the County on or after July 1, 1956 and with respect to officers and employees in the service of the County on June 30th 1956 who are inactive members of the State Employees Retirement System. Motion carried.

On the Special: "Architect's services", we heard Architect Blaisdell who had been invited by Mr. Hilton to talk about plans and fees in regard to the future alterations at the Men's Home, then it was voted to pass over the suggested appropriation of \$2500. and wait for a Survey Report from the Executive Committee.

Mr. Merrill made a motion to adopt No. 19. Motion carried.

Motion was made by Mr. Rathbone to adopt No. 20. Motion carried.

Motion was made by Mr. Merrill to adopt No. 21. Motion carried.

Motion was made by Mr. Emory Eldredge to adopt No. 22. Motion carried.

Motion was made by Mr. Harold L. Jones to adopt No. 23. Motion carried.

Motion was made by Mr. Scamman to adopt Nos. 24 to 28 with the following motion on item 27: That the Extension Budget of \$20,793.20 be approved, and that the proper County officials be authorized to advance to the Extension Service Treasurer such sums as necessary to carry on existing services until such time as the 1957 budget is authorized. Motion carried.

Motion by Mrs. Lise L. Payette to adopt No. 28. Motion carried.

Motion by Mr. Rathbone to adopt No. 29. Motion carried.

Motion by Mr. Henry Murch to adopt No. 30. Motion carried.

Motion by Mr. Merrill to adopt No. 31 to the end of the proposed budget, which will be that the County raise and appropriate the sum of \$629,604.10 against which will be credited estimated revenue of \$180,116.96, leaving the amount to be committed to taxation \$449,487.14 and the motion was carried.

REPORTS OF SPECIAL SURVEY COMMITTEE FOR NEW NURSING HOME

March 28, 1956

The first meeting of the Special Survey Committee or Building Committee for the new Nursing Home was held at the County Home, by notice of Frank A. Robinson, on March 28, 1956 at 11 A.M. This meeting was called to find out what is necessary in regard to the work to be done on the new nursing home, alterations to the present building, etc. Present were Edwin W. Eastman, Exeter; Draper W. Parmenter, Londonderry; Albert Sewall, Newmarket; George Carter, North Hampton; Ernest Pinkham, Northwood; Mary C. Dondero, Portsmouth; Walter Haigh, Salem and Frank Robinson, South Hampton, Mr. Hilton, Supt. spoke about the need of the new nursing home and outlined the necessary work to be done. There was a general discussion, and there was a suggestion about meeting with the various architects in the State. Long discussion in regard to the method to be used. Dinner was served at noon. Meeting adjourned at 2:30 P.M.

Brentwood, April 6th, 1956

Meeting called to order at 10:30 a.m. by Chairman Robinson.

Present are 10 members of the Budget Committee, and the 3 Commissioners.

Mr. Lester K. Billings, Director of the State Hospital Advisory Council's bureau of hospital service, having been invited by Mr. George Hilton Supt. of our County Home and Mr. Frank Robinson, gives us an interesting talk on hospitals and nursing homes, in view of the fact that this Committee had been duly authorized to look into the possibility of constructing a new Infirmary, and a period of questions and answers follows, with points likes these emphasized:

- 1. Licensing laws.
- 2. New Hampshire having the highest population over 65 years of age.
- 3. Federal grant would be 50% of the cost if we meet all specifications.
- 4. A building of 2 floors with working basement is recommended, and a depreciation of 2% a year is to be figured on.

At one o'clock dinner was served and the meeting was concluded with the visit of the Infirmary.

Appointed are: Frank Robinson, Mary C. Dondero and Lise L. Payette.

And the Clerk is asked to mail a copy of said letter to *our* 21 Architects.

The Chairman reads 16 letters from different Architects, in reply to our letters sent to them on April 13th, and then it is a unanimous wish to write again to the Architects who have shown an interest, and give them a date to come and meet with this Committee, the Clerk is informed to do the necessary correspondence and divide the interviews for May 1st, 3rd and 7th.

Brentwood, May 1st, 1956.

Meeting called to order at 9:30 a.m. by Chairman Robinson.

Present are 8 Members of the Committee and Commissioner Fuller of the Derry District.

Mr. Bradt, Architect of Exeter and his associate Engineer Ritchie present themselves and their backgrounds (Education, experience and past business) to this Committee, and show us different plans. They tell us that they have a personnel of 4 and give us the names of several big buildings that they have worked on not too long ago: York Hospital, addition; 2 Schools in York; Swimming Pools, Manchester V A Hospital; Hospitals in: Deerfield, Pennsylvania, Malden, Brookline, Study of Portsmouth Hospital, Study of Ipswich, Mass. The next Architect to be introduced is: Mr. Irving Hersey of Durham. He has a staff of 30 men and has been in business for 30 years, having done all kinds of: Elementary & Secondary Schools; Residences; Industrial work; Banks & Misc. for a total of 38 million; Dormitories at Airport; Maintenance at Airport; Operation Buildings at Navy Yard; Dover Hospital (Recently); State Hospital (Recently-addition) and Post offices in the State. Fee: 6%.

The 3rd Architects to appear were: Messrs. Lyford & Magenau of Concord, who told us that they have a staff of 4 and they have been in business since 1935. They left us a list of the most important jobs they have done, and their fee is: 6% including all engineering.

Meeting adjourned at 2:30 p.m.

Brentwood, May 3rd, 1956.

Meeting called to order at 9 a.m. by Chairman Robinson.

Present are 9 members of this Committee and Commissioner Fuller of the Derry District.

The following Architects were introduced by Mr. Hilton: 1. Edward Benton Miles of Exeter. 2. Leo P. Provost of Manchester, 3. Mr. Tracy of Nashua, 4. Willis Littlefield of Dover, 5. Prescott & Erickson of Laconia. Mr. Miles is a graduate of UNH 1939 and tells us that he has worked with Architect Witmer in Portsmouth, for years did work with the City Planners of Portsmouth, and his most recent enterprises were: Exeter Country Club, Exeter Shopping Center, Exeter Co-operative Bank, School Annex in Candia, School Annex in Greenland and UNH Dormitories and Fraternities. Fee 7%.

Mr. Provost tells us that he is a graduate of UNH 1936, has worked with his father who was an Architect in Manchester for 30 years and was a specialist in Institutional work. For the last 3 years Mr. Provost has done all institutional work himself; has 4 Architects and 4 Engineers on his staff. His fee is 6%. Here is a partial list of his recent undertakings: Notre-Dame Hospital in Manchester; 70-bed Hospital in Lewiston, Maine and St. Georges Church in Manchester.

Mr. Tracy of Nashua appeared alone and he has done more school work than anything else, but has been in business since 1937, has done only one hospital in Groton, Conn. Has done the Infirmary and Dental Clinic at the Portsmouth Air Force Base; is Trustee of 2 Homes in Nashua, and prior to being a Trustee, had done some extensive work on those Homes. There are 6 on his staff; 4 Architects: Messrs. Tracy, Hildreth, Snodgrass and Charles Gray. Also 2 Draftsmen. Is proud to say that he has been very successful in making estimates. Fee 6%.

Mr. Littlefield appears with his Associate Mr. George Berry, they have never done any Hospital work but feel able to do it. Their fee about 6%. They have a staff of 3 and have been in business for 10 years. Their most recent completions have been: Strafford County Home and Strafford County Court House. Mr. Prescott appeared alone, has been in business for 9 years and has done a building very substantially like the one we are now planning. Has just completed a Dormitory at the Golden Rule Farm, now preparing drawings for 3 Dormitories to a building at the Laconia School, and a Library addition in Laconia. Always 3 or 4 men on staff. Fee about 6%.

Meeting adjourned at 3:30 p.m.

Brentwood, May 7th, 1956.

Meeting called to order at 9:30 a.m. by Chairman Robinson.

Present are 11 members of this Committee and Commissioners Fuller and Brown.

The following Architects were introduced by Mr. Hilton: Carl E. Peterson of Manchester, Mr. Hudson from Hanover, Dirsa & Lampron of Manchester, and Granger Associates of Hanover.

1. Mr. Peterson has been in business for 30 years, has a staff of 5 to 6 people; tells us that he has done a 40-bed hospital in Manchester at the cost of \$240,000. very similar to what we need. Supervises all the work himself. Fee 6%.

2. Mr. Hudson from the firm of Hudson & Ingram of Hanover appeared alone and told us that he had been in business since 1942, and prior to that date had worked for the firm Alfred T. Granger of Hanover. 2 Architects, 2 Draftsmen and a stenographer on staff; suggests to have a Clerk of the work. Below is a partial list of their work: County farm — Hanover; State Hospital, Sullivan County; Laconia State School Infirmary;

Lancaster Hospital; 30-bed Hospital in Woodsville; Many dormitories and lot of work in Grafton County. Fee 7%.

3. Messrs. Dirsa & Lampron of Manchester are both graduates of UNH in 1934, have been in business since 1946, have done many dormitories in Maine, School in Bennington, Vermont, Housing Projects, High School in Vermont, School in Manchester, but have never done hospital work. 3 People on staff. Fee 6%.

3. Mr. Alfred T. Granger of Hanover appeared with his Associate Mr. Stevens who is his Clerk of the works. Has been in business for 26 years in New Hampshire. Has 6 men on staff and assures us that he can do all types of work, is a Rockingham County taxpayer as his Summer residence is at Boars' Head. At the present time is working for the Cheshire County Home, has done a Nursing Home for Grassmere, Grafton & Sullivan County Farms. Fee 6%. Mr. Granger is also willing to submit to us some preliminary plans deductible from the cost of the building, but payable if the Architect is not retained. And Mr. Granger highly recommends the following contractors: Swanberg Constr., Maxam, and Davidson.

Mr. Granger was unanimously voted architect.

Meeting adjourned at 4 p.m.

Brentwood, July 27th, 1956.

A meeting of the Executive Committee was held at the County Home. Those present were: Chairman Frank Robinson, Mary Dondero, Draper Parmenter, Chairman of the Delegation, Henry Murch, William Wardwell, George Carter, Ernest Pinkham, Albert Sewall and Lise L. Payette.

It was voted unanimously to allow the Commissioners to take sufficient funds from the surplus, less \$1500.00 insurance adjustment, to replace the boiler in the Exeter Court House. The Committee further left it to the discretion of the Commissioners to employ a heating Engineer. The Committee recommended that the Commissioners put the job out to bid.

The Committee conferred with the Commissioners, the Superintendent, the Architect and Mr. Billings with respect to the proposed new Infirmary building. The preliminary plans were viewed.

From Mr. Billings it was learned that the Delegation will have to vote the bond issue before application can be made for federal funds.

Mr. Granger gave a resume of schemes A, B and C. He explained that the figure for scheme C, which is a proposed building attached to the north end of the Mitchell Hospital for 84 beds on two floors, the basement to include a new kitchen, staff dining room, patients' dining room, freezer locker, process room and storage rooms, sewage disposal and is estimated at \$859,000.

It was voted that a meeting of the Committee be held Thursday, August 2nd at 9:30 A.M. at the County Home.

Brentwood, August 2nd, 1956.

Meeting called to order at 10 a.m. by Chairman Robinson. Ten members of the Executive Committee and Commissioners Brown and Fuller are present. At this stage, the Committee feels that it is logical to lay their cards on the table and discuss finances: our books show that our \$200,000. bond issue expires this Fall and then we will be able to borrow 2% of our County valuation, which means exactly \$2,698,658.62 — those details will have to be brought out at the next County Delegation meeting.

Mrs. Dondero moves that the proposed plan for the contemplated new Nursing Home be adopted and recommended to the County Delegation, Motion seconded by Mr. Pinkham.

The Clerk is asked by the Finance Chairman to prepare a summary report of what has been done by this Committee in regards to the new construction, so to inform the County Delegation on August 15th.

Mr. Carter proposes that the Clerk receive a compensation for all the work she has done, and Mr. Murch seconds the proposal, then Mr. Robinson makes a motion that the Clerk gets paid for the two meetings that she missed, and Mrs. Dondero seconds the motion.

The meeting is adjourned at 12 o'clock with the group thanking Mr. and Mrs. Hilton for their precious help and hospitality, and Chairman Robinson for his wonderful directive.

Brentwood, August 15th, 1956

In accordance with duly published notice a meeting of the Delegation was called to order at 10:30 a.m. by Chairman Robinson. 29 Members were present, also 3 Commissioners, Mr. and Mrs. Hilton, Mr. Lester Billings and Mr. Alfred Granger. The Chairman read a summary of what has been done to date by the Executive Committee in regards to the contemplated new Nursing Home.

Then Mr. Granger the Architect explained many details with the showing of the plans and told us that the whole thing came to \$1.50 per cubic foot.

Mr. Draper Parmenter read a letter received from Mr. Billings, Director, Bureau of Hospital Services, in regards to Federal Aid, and then Mr. Billings himself explains it, and he assures us of getting some aid but cannot say exactly how much.

Mr. Hilton, Supt. of the Home, took his turn at explaining and selling the plans to the entire Delegation.

Motion offered by Doris Spollett and 2nd by Henry Murch:

Moved that before acting on the question, that ε Public Hearing be held on Sept. 5th 1956 at Record Building in Exeter and that this meeting of the County Convention be adjourned to Sept. 20th at Brentwood, N. COMMENTS AND RECOMMENDATIONS AS TO THE COURT HOUSE

Portsmouth

One Term of the Superior Court is held in Portsmouth during the months of January, February and March.

No recommendations as to improvement are being made by this Office because we feel that the County is unduly burdened with the necessity of maintaining the Portsmouth Court House solely for a mere three months' use by the Superior Court. We are reluctant to make any recommendations or suggestions because the expense of making them would far exceed any conveniences which might be accomplished.

The entire second floor is used by the Superior Court exclusively.

R.S.A., Ch. 496, Sec. 1, provides that Superior Court shall be held in Portsmouth and Exeter, and that the Superior Court determine when Terms of Court shall be held.

Exeter

The Superior Court is held in Exeter from the second Tuesday in September through December, and from the first Tuesday of April through June.

There is no regular Term during July and August, but numerous hearings are held in the Superior Court House in Exeter.

Clerk's Office

The permanent Clerk's Office with all its records is in neither of the Court Houses. It is therefore necessary to keep the two Court Houses constantly equipped with all types of office supplies, the various printed

forms used by the Superior Court, as well as to maintain telephones constantly in all three buildings.

There is a distinct disadvantage to everyone connected with the Superior Court in not having the office of the Clerk of Superior Court in the same building where Court is held. The work of the office consist largely of keeping the records of all the business of the Superior Court, Naturalization records, planning the work of the Superior Court, keeping in constant contact with the various attorneys and jurors, and of many incidental matters.

The volume of business has increased from 800 entries in the year 1952 to 1000 in the year 1956.

Some changes have been made in the Exeter Court House, but facilities for the office of the Clerk of Superior Court are by no means adequate, although a little improved.

It is strongly recommended that the location of the office of Clerk of Superior Court be moved from the Records Building where it now is to the Superior Court House across the street.

An alternate suggestion is that an addition be made to the rear of the Records Building, and that minor incidental changes be made in the interior of the Records Building so that the Superior Court Room may be located on the second floor of the new addition and thereby providing much space for the expansion of the Deeds and Probate offices on the first floor of the addition.

The expense of maintaining the present Superior Court House is great and somewhat unnecessary because a portion of the building is not used at all, and from the nature of the location of the rooms, the present unused space cannot be efficiently utilized.

Housing Superior Court in the present Records Building would mean just one County Building in Exeter, and appreciably diminish the expense of maintenance. It would also greatly increase the efficiency of the handling of the County business of the Superior Court and also be of great help to the general public.

ROCKINGHAM COUNTY SOLICITOR'S REPORT

There were no major felonies committed in Rockingham County in 1956. The minor felonies such as breaking and entry, larceny and larceny by check occurred about as frequently as during the previou year. In the vast majority of cases the respondents entered a guilty plea in Superior Court and were either committed to State Prison, House of Correction or placed on probation.

It has been the policy of the Solicitor during his term of office to recommend fines or some form of suspended sentence and probation for first offenders unless the crime is an intentional one and involves danger to human life or results in bodily injury. It is very rare that committal to prison is recommended for motor vehicle violations.

Most of the misdemeanors were disposed of in Mu nicipal Court. A few cases were appealed and prosecuted in Superior Court.

Rockingham County is fortunate in having experienced police officers in the towns, in the Sheriff's Department and in the State Police, and I extend my thanks to them for their cooperation.

SHERIFF'S REPORT

To the Honorable Board of County Commissioners for the County of Rockingham:

Another year has passed and it becomes my duty to report to you the activities of the Sheriff's department for the past year, and to make recommendations for the future.

Juvenile crime within the County increased slightly, while the number of felonies decreased from the year of 1955, and they were also of a less serious nature. As a matter of fact, considering the large increase in the population within our County, due to the establishmen of the Portsmouth-Newington Air Base, and the building and occupying of new homes in every town throughout the County, it is quite remarkable that we had se small a percentage of crime, compared to our total population. I believe it speaks highly of the ability and efficiency of every law enforcement agency throughout our County, and also of the high type of citizenship that goes to make up our County.

I consider that our County delegation has contributed a lot to law-enforcement by increasing the amount for the Sheriff's appropriation for night patrol for each of the last two years. By their decision I have been able to have from two to eight men on the highways of our County when they were most needed, between midnight and daylight when there was scarcely any coverage by law enforcement officers except in the City of Portsmouth and the other four towns with organized police forces. The youngsters that traveled the highways after midnight, whether they were from this County or from without the County or the State, knew that these officers were on the highways, stopping cars and examining buildings and doors of stores, filling stations, unoccupied homes and public places, with the results that these cars containing three or four youngsters without special reason for being on the highways during these hours, are now by-passing Rockingha. county in the early morning hours.

My department is very much pleased with the increased coverage given by the County Commissioners and the Superintendent of the County Home of our Radio Station at the House of Correction. By their new schedule of the working hours of the Jailors and radio operations at the Jail, they are now giving twenty four hour service which is most important, because none of us know just what moment we are going to need the radio to summons help from a fellow officer.

Superior Court has gone along with the three sessions during the past year being presided over by Chief Justice Stephen M. Wheeler and Superior Court Justice George R. Grant, Jr., with the result that our docket has very few cases to be disposed of that have been entered over eighteen months.

I want to thank our Solicitor Lindsey R. Brigham for the quick and efficient proscecution of crime, and fecthat, that together with the excellent work of Local Police Departments, State Police, Probation Depaments and all other law enforcement bodies, has helped to make for the wonderful record of practically no unsolved cases, and I want to thank all for their contribution along this line.

May I at this time pay tribute to one of my deputies who had served with me for many years and who was a most capable and fearless officer, Deputy Sheriff Everet⁴ E. Judkins. To his wife and family we extend our deepest sympathy. I would remind you that my service and those of my entire department are available to all persons within our County, whenever or wherever needed. I extend to my staff of Deputies my appreciation for their efficient services and herewith submit a list of the Deputies both active and special for the years of 1956-57.

ROCKINGHAM COOPERATIVE EXTENSION SERVICE

Work is made possible through the cooperation of the United States Department of Agriculture, University of New Hampshire and Rockingham County. The Rockingham County Farm Bureau (through its Executive Board) is the recognized local official organization cooperating in a supervisory capacity. County Extension Work is an Educational Program in Agriculture and Home Economics which is available to people throughout the country. Brief reports of each agent, covering the highlights of the regular lines of work i.e. County Agricultural, County Forester, Home Demonstration and 4-H Club Work have been given in the past Rockingham County Annual Reports. As suggested by the Delegation Budget Committee complete reports on the work have been omitted to save space and expense. Mimeographed reports or information covering the work will gladly be supplied by your Extension Service Office.

The main office of the Rockingham County Extension Service is in the Masonic Block, 61 Water St., Exeter, N. H. Five regular Extension Agents are employed for work in the county. Also since February 1, 1955, we have had an Assistant Agricultural Agent on a part time basis. Your County Agricultural Agent holds office hours every Saturday morning in the County Commissioners' Office, Adams Memorial Hall, Derry, N. H. as well as office day as a rule at Exeter on Monday mornings.

This has turned out to be a most exciting, busy, and enjoyable year — exciting from the point of view of realization of a dream coming true in having a new Nursing Home in which to better care for our folks; busy, working with the County Commissioners, Building Committee, and Architect in preparing plans and specifications; enjoyable because everyone connected with the project has been so cooperative, amiable, and forthright in his or her thinking that what was presumed to be a huge task has melted into a nicely molded program. In our capacity we appreciate this opportunity to commend the members of the delegation for their recognition of the institution's needs in approving modern and adequate facilities for the care of the chronically ill.

The farming operations have run along this year fairly comparable to last year. We are, however, very proud to report that we again won first place in the Green Pasture program competing with other County and State institutions. We believe this speaks well of the caliber of our Boss Farmer, Russ Waterman.

We have continued to work toward completing our long range program of soil conservation by the completion of a farm pond, installing more sod waterways, and tile drainage. We feel that the approach to planning and installing these projects is sound and practical. The results that we are obtaining cause us to have high regard for this county agency.

We have not only dealt with conserving our soil, but our forests likewise. We are carrying on a fine forestry program under the able direction and supervision of our County Forester, Roger Sloan. This program is enabling us to utilize our limited stand of timber to a greater advantage than had been anticipated, thus providing the institution with lumber for building and main-

tenance. Looking to the future needs, a fine young stand of red pine has been established.

Our herd of pure bred Holsteins has produced very satisfactorily this year in producing an abundance of both milk and meat for the institution's needs. Our herdsman is very happy in the new home completed this past year. Through the cooperative efforts of our good friend and County Agent, Jimmy Purington, we have enjoyed acting as hosts for several farm meetings during the year. We have also been pleased that Miss Ruth Stimson, our capable Home Demonstration Agent, has held many of her meetings for the county in the auditorium of the Mitchell Memorial Hospital. Both Mr. Purington and Miss Stimson find that because the institution is geographically centered in the county, it makes for less travel for our county folks to attend meetings here.

Our family here at the Home has been on the average slightly larger than last year. It is interesting to note that the average age of our patients has increased by seven years over the last ten years, the average age now being seventy-one.

To assist us in meeting the responsibilities and the challenges of running this institution, we feel very grateful to our faithful employees for their contribution to its success and welfare. Longevity of employment merits recognition, and we submit the following record of service.
