### TOWN WARRANT

#### THE STATE OF NEW HAMPSHIRE

THE FOLLS WILL BE OPEN FROM 10:00 A.M. TO 7:00 P.M.

To the Inhabitants of the Town of Pittsburg, in the County of Coos, in the State of New Hampshire, qualified to vote in Town Affairs:

You are hereby notified to meet at the Bremer Pond Auditorium in said Town of Pittsburg on Tuesday, the twelfth day of March next, at 10:00 of the clock in the forenoon, to act upon the following subjects:

- 1. To bring in your ballots for the election of one moderator for two years; one Selectman for three years; one Road Agent for one year; one Library Trustee for three years; one Overseer of Welfare for one year; one Trustee of Trust Funds for three years; one Cemetery Trustee for three years; one Supervisor of the Checklist for six years.
- 2. To see if the Town will vote to give the Selectmen authority to appoint all necessary Town Officers not listed under Article 1.
- 3. To see if the Town will vote to observe Old Home Day and have the Selectmen appoint a committee to manage the observance of same.
- 4. To see if the Town will vote to purchase a 1996 Police Cruiser and to trade in the 1993 Police Cruiser toward this purchase; and also to see if the Town will vote to raise and appropriate the sum of eighteen thousand dollars (\$18,000) for this trade-in purchase, and authorize the withdrawal of ten thousand five hundred dollars (\$10,500) from the Police Cruiser Capital Reserve Fund created for this purpose. The balance of seven thousand five hundred dollars (\$7,500) is to be raised by taxes. (Recommended by the Selectmen)
- 5. To see if the Town will vote to raise and appropriate the sum of fifteen thousand dollars (\$15,000) to be added to the Fire Truck Capital Reserve Fund previously established. (Recommended by the Selectmen)

- 6. "Shall we delegate the duties and responsibilities of the cemetery trustees to the Board of Selectmen?" If the majority vote in the affirmative, then the delegation shall take effect 90 days after adoption and shall continue until rescinded by vote of the town meeting. (RSA 289:6)
- 7. To see if the Town will vote to raise and appropriate the sum of <u>\$656,456</u> which represents the operating budget. Said sum does not include special articles addressed. (Recommended by the Selectmen)
- 8. To transact any other business that may legally come before this meeting.

Polls will not close before 7:00 P.M.

Any person with a physical disability who needs assistance to attend the Town Meeting and/or needs assistance while at the Town Meeting is to contact Burnham Judd - Chairman, Board of Selectmen at 538-6697.

#### TRANSMITTAL AND COMMENTARY LETTER

To the Members of the Board of Selectmen Town of Pittsburg Pittsburg, New Hampshire 03592

#### Members of the Board:

In planning and performing our audit of the financial statements of the Town of Pittsburg, New Hampshire for the year ended December 31, 1994 we considered the Town's internal control structure to determine our auditing procedures for the purpose of expressing an opinion on the financial statements and not to provide assurance on the internal control structure.

However, during our audit, we became aware of the following condition that should be corrected in order to strengthen internal controls and operating efficiency. This letter does not affect our report dated June 2, 1995 on the financial statements of the Town of Pittsburg, New Hampshire.

Our following remark is being made in the hope that it will improve the existing procedure and is in no way a criticism of Town personnel.

#### School Scholarship Fund

The School District transferred Scholarship Funds to the Town Trustee of Trust Funds. The principal amount of Scholarship Funds were not accurate due to lack of information.

Recommendation The Trustee of Trust Funds needs to research the principal amounts and keep records that separately track the principal portion and the income portion.

We extend our thanks to the officials and employees of the Town of Pittsburg for their assistance during the course of our audit.

# POLICE DEPARTMENT REPORT

In 1995 the Pittsburg Police Department investigated a total of 73 accidents. Of this total 32% of the accidents were animal related (moose/deer). Included in this total were 1 OHRV fatality and 1 motorcycle fatality.

In addition to investigating these accidents, the Pittsburg Police handled 53 criminal cases, 72 motor vehicle cases, 54 OHRV cases, 14 animal cases, 8 juvenile cases and 6 unauthorized camping cases. Included in the criminal cases were several thefts and camp breaks. The department has an active property-check policy. This policy not only enables us to check some of the seasonal properties, but at the same time helps to familiarize the officers with the area and the new road names.

It seems that every year more and more people are forgetting to license their dogs. I want to remind all dog owners that you are obligated by law to license your dogs or face civil penalties and/or court action. Cat owners are also reminded that although you are not required to license your cats, you are required to see that they have their rabies shots. I am asking that all pet owners please comply with these laws.

Each of the department officers received training and were certified in the use of 0.C. spray in 1995. In addition to this, each officer attended several training sessions in 1995 in our continued commitment to ensure that we give the town the best trained and equipped officers that we can. Once again, I want to remind you that if anyone has any comments, suggestions, etc., on how we can better serve the needs of the community, please feel free to contact me.

I want to thank each of my officers for their continued support and dedication to the department. I also want to thank the other local, state, and federal agencies that have come to the assistance of our department in 1995. It is through this cooperative effort that we are able to provide you with the type of service that we do. I also want to thank the Selectmen for their continued support of the department in allowing us to attend the training that we do and for providing us with some of the finest equipment available. We look forward to serving you in 1996.

### FIRE DEPARTMENT REPORT

Over the past six years the Pittsburg Fire Department Building Committee has raised a total of \$83,470.61 for a new fire station through their annual auction and other donations. This account is administered by the town treasurer. It is the firemen's hope that by raising half the cost of a new facility, the town will appropriate the other half when needed. It is anticipated that the new facility will house all of the town's emergency services and equipment.

Engine No. 2 (one of our older vehicles) has been repaired and is back on line. It was found that the pump needed refurbishing. These older vehicles have steel water tanks and are usually guaranteed for ten years. This one is now twenty-nine years old so we may anticipate more problems.

Currently, there are 26 active members participating inthe meetings and training sessions. We are still cooperating with our neighboring departments in putting on a two-day "Tri-Town Fire School". This past summer we added two more Level I firemen with Tim Owen and Rick Dube taking the course that was offered in Colebrook. Also, in August, members of the department gave a presentation of the Fire Department to the Historical Society and concluded with an open house and demonstration at the station.

### **AMBULANCE CORPS REPORT**

The year of 1995 brought us a total of 84 calls, 3 of which were transfers, 81 were emergency runs.

In 1995 all our attendants became certified to operate our Marquette Defibrillator which was purchased in late 1994 with money the Corps received as donations. The cost of the new unit was \$6,994.10. 'The certification process consisted of 15 hours followed by a brief test. 1995 also was a recertification year for most of us. In order to qualify for recertification, each one of us must complete 27 hours of training modules and an additional 48 hours of "Further Education" within 2 years. Once these hours have been completed, we then sit for a written exam followed by a practical test. Congratulations to all of our attendants. You've all come through with flying colors once again!

I would like to take this opportunity to thank the community of Pittsburg for being extremely supportive with both donations of money and equipment. We do have several items that are available to everyone (Hoyer lift, crutches, beds, commodes, etc.), all of which are items that have been donated to the Corps by different families in the area.

Last but not least, I'd like to welcome our new members and thank everyone for always being dedicated volunteers; no matter what hour of the day (or night) they are called!
