## MINUTES OF TOWN MEETING - MARCH 14, 1967

### EXCEPTING SECTIONS APPEARING ELSEWHERE IN THIS TOWN REPORT

Moderator, Frederick Houle, opened meeting at 7:30 P. M.

Article 2. The Budget was taken up item by item, at the end of which it was voted that the sum of \$173,463.67 be raised and appropriated as the total Town Budget figure.

Article 10 appropriating \$180 as the Town's share of the Fire Chief's Retirement passed in the affirmative.

Article 14 authorizing the purchase of a piece of land on Marsh Road for the use of the Cemetery passed in the affirmative.

Article 11 passed in the affirmative, thus establishing a Recreation Commission.

Article 13 also passed in the affirmative, appropriating a sum of \$2,500.00 to be used by the above Commission for Parks and Playgrounds, etc.

Article 16, passing in the affirmative, allowed the continuance of the program started last year, of putting up uniform metal street signs all over town.

Article 17, appropriating \$1,500 to be used by the Planning Board for the purpose of taking land options on desirable locations, passed.

Article 7, raising one-half of the amount necessary to have the State reappraise the Town next year, passed in the affirmative.

Article 5 passed, appropriating \$2,000 to add to the Capital Reserve Fund for purchase of a fire truck.

Article 8, pertaining to the construction of a combination police and fire station building on land owned by the Town brought much controversy. The recommendations and plans of the Committee were thoroughly explained by Mr. Powers. Mr. Rock offered information of a similar building in the town of Stowe, Mass. for a cost of \$45,000, built on town owned land. A motion was made to "postpone any further action on Article 8 and when we adjourn this evening, we adjourn to meet on April 13th at 8 P. M. at the Sherburne School to give further consideration to this article and to any other articles that may legally come before this meeting." This passed in the affirmative.

The meeting was adjourned at 11:45 P. M.

The meeting was called to order on April 13, 1967 at 8 P. M. and Article 8 was resumed. Mr. Powers made a motion which asked to appropriate the sum of \$89,960. for the construction of the police and fire station, rather than the sum in the original Article 8 of \$110,000. He explained that the committee was still in favor of their original plan for the building but that they felt they could trim some corners and arrive at the new figure.

Mr. Hodgman, as Civil Defense Director, moved to amend the motion to read \$99,960 to provide for the building of an emergency operating center to be constructed under ground under the proposed building. This passed and the main motion was thus amended.

When the standing vote was taken, 117 were for and 102 against the motion. Since a 2/3 vote was needed, it was lost.

It was then moved that the original motion be voted on, substituting the figure of \$89,960 for \$110,000. It was moved from the floor that the motion be amended to read \$70,000, but this amendment was de-

feated. The motion before the house was voted with those in favor being 118, and those opposed 92. Of the 210 voting it was necessary to have a 2/3 vote, so the motion was lost.

Articles 3 and 4 were passed in the affirmative.

Article 12 was voted to be passed over.

Articles 18, 19, 20 were passed in the affirmative.

Article 21 was voted to pass over.

Articles 22, 23, 24 could not be acted upon since they were not recommended by the Budget Committee.

Under Article 25 Mrs. Mansfield reported that the Committee that had been formed to see about having a Doctor come into Town was still active.

Mr. Currier moved that the Moderator appoint a committee of five to study the possibility of establishing a Highway Dept., and this passed in the affirmative.

Mr. Parent moved that Article 2 of the Town Warrant contain only the necessary salaries and expenditures and any increase from these amounts should come before the Town Meeting in the form of a separate article. The resolution was put to a vote and lost.

The Town Meeting was adjourned at 11:15 P. M.

## SUMMARY OF FINDINGS AND RECOMMENDATIONS

February 13, 1968

Gentlemen:

Submitted herewith is the report of the annual examination and audit of the accounts of the Town of Pelham for the fiscal year ended December 31, 1967, which was made by this Division in accordance with the vote of the Town. Exhibits as hereafter listed are included as part of the report.

### SCOPE OF AUDIT

Included in the examination and audit were the accounts and records of the Board of Selectmen, Treasurer, Tax Collector, Town Clerk, Cemetery Trustees, Library and Municipal Court.

### FINANCIAL STATEMENTS

Comparative Balance Sheets: December 31, 1966 - December 31, 1967: (Exhibit A-1)

Comparative Balance Sheets as of December 31, 1966 and December 31, 1967, are presented in Exhibit A-1. As indicated therein, the Surplus increased by \$5,872.40, from \$27,727.09 to \$33,599.49 in 1967. Inasmuch as there were no outstanding bonds or long term notes, the Balance Sheet Surplus of \$33,599.49 represented the Current Surplus (excess of total assets over current liabilities) as of December 31, 1967.

Analysis of Change in Financial Condition: (Exhibit A-2)

An analysis of change in financial condition of the Town during the year is made in Exhibit A-2, with the factors which caused the change indicated therein.

Comparative Statements of Appropriations and Expenditures - Estimated and Actual Revenues: (Exhibits A-3 and A-4)

Comparative Statements of appropriations and expenditures, estimated and actual revenues for the fiscal year ended December 31, 1967, are presented in Exhibits A-3 and A-4. As indicated by the budget summary (Exhibit A-4), a revenue surplus of \$5,029.06, plus a net unexpended balance of appropriations of \$887.93, resulted in a net budget surplus of \$5,916.99.

Summary Statement of Receipts and Expenditures: (Exhibit B-1)

A summary statement of receipts and expenditures for the fiscal year ended December 31, 1967, made up in accordance with the uniform classification of accounts, is included in Exhibit B-1. Proof of the Treasurer's balance as of December 31, 1967, is indicated in Exhibit B-2.

Cemetery Trustees' Accounts: (Exhibit F-1)

A statement of the activity in the Cemetery Trustees' Accounts for the fiscal year is presented in Exhibit F-1.

Municipal Court: (Exhibit H)

A statement of the accounts of the Municipal Court is contained in Exhibit H.

### AUDIT PROCEDURE

The accounts and records of all town officials charged with the custody, receipt and disbursement of public funds were examined and audited. Vouchers and cancelled checks were compared with supporting invoices and payrolls as well as entries in the books of record. Receipts were checked by source insofar as possible.



and totals of receipts and expenditures verified. Book balances were verified by comparison with reconciled bank balances made from statements submitted by depository banks. Verification of uncollected taxes was made by mailing notices to delinquent taxpayers as indicated by the Collector's records. The amounts of uncollected and unredeemed taxes as indicated in this report are therefore subject to any changes which may be necessitated by the return of verification notices.

#### GENERAL COMMENTS

Trust Funds:

The records of the Trust Funds were incomplete therefore, no audit could be made.

Town Clerk:

Town Clerk,

It is recommended that a fifty dollar (\$50.00) change fund be established for the use of the

Clerk of Municipal Court:

It is suggested all miscellaneous receipts of the court be recorded in the same book of record as the small claims are entered.

Tax Collector:

It is recommended that a one hundred dollar (\$100.00) change fund be established for the use of the tax collector.

Inasmuch as the two year period provided by Law in which redemptions from tax sales may be made has expired on these unredeemed taxes, a Tax Collector's deed should be given to the Town for all the properties involved.

Conclusion:

The provisions of Chapter 184 of the Laws of 1955, require that this report or the summary of findings and recommendations (letter of transmittal) shall be published in the next annual report of the Town.

We extend our thanks to the officials of the Town of Pelham for their assistance during the course of the audit.

## REPORT OF HIGHWAY AGENT

This report is more for people who have lived in Pelham a short time and do not understand the way work is done on our highways and the reasons.

First of all, we have over 20 miles of roads which are maintained and plowed by the New Hampshire Department of Public Works and Highways under their direct supervision, at no cost directly from our local taxes. Secondly, the Town does not own any equipment except the snow plows that are mounted on privately owned trucks. These are hired on a part-time basis as needed; the equipment used for summer maintenance and new construction is also hired in the same manner. There are no full time employees, and this is why people are amazed when they call and find me out of town or on some other job other than town road work. I am available if an emergency arises, however, the summer maintenance, resealing and new construction work, has to be scheduled when the hired equipment is available.

I have recommended that the Town build or construct a salt bin on Town-owned land, as the present location is on private land which cost the Town nothing, except labor. With the increasing number of tar roads and satisfaction of residents in our using salt to treat ice in the winter, I feel this will be a permanent installation.

In keeping with this, I feel serious consideration should be given to the establishment of a full time, two-man department, with a truck suitable for the various summer jobs and also for plowing in the winter with the hired equipment.

## POLICE DEPARTMENT

The time has come again for us to forget that which has transpired and to plan for the future.

We have had a very busy year as the records will show; 3,888 calls this past year. The workload has increased tremendously. As more and more cars are put on the road, accidents increase. The number of cars plus other factors such as the weather, carelessness and the lack of courtesy on the highway, are the main causes of accidents. As more houses are built and new businesses come into town, the duties of the Police Department increase.

Pelham has had a series of house breaks during the past year, as have surrounding towns, who have also been hit very hard. Much time has been spent in investigating these breaks both day and night. It is with this mention, that I would like to bring to your attention the new rulings by the Supreme Court, which virtually tie the hands of today's policemen. A suspect cannot be interrogated by the police without having his lawyer present, who immediately informs him "not to say a word." The outlaws and gangsters are given protection which you and I do not have. The general public is not aware of these barriers until something comes along which affects them personally. Several times the police have known that a subject has taken part in breaks, etc., but because of this new ruling are unable to further their authority. Also, Pelham, being a border town, is more susceptible to these incidents, because of the heavier traffic flow, etc.

I would like to make mention of the second cruiser which I am recommending to the budget committee. This would be available for emergencies that arise especially when the other cruiser is out of town. I'm sure everyone is aware of the fact that our trips to the hospitals are not 1 and 2 mile trips, such as those made by the city police, but 8, 9 and 10 mile trips, as we have to travel to Lowell, Nashua and Lawrence. Our trips are even more hindered by bad weather and slippery driving, which takes that much longer. With the new D. W. I. law, an officer may be making a routine check of an accident, but come upon a D. W. I. case which takes him nearly 3 hours to complete, and 10 miles from home. The party must be picked up, taken to the Nashua Memorial Hospital for a blood test, then taken to the Nashua Police Department where he is then booked. Also, there should be 2 officers, as there has to be a witness to all this. During these trips, other emergencies are arising back in town, which leaves us unprotected. I do not intend to use this vehicle on a 24-hour basis, but would use it for emergencies, investigations and at accidents. It is impossible for one cruiser to cover 27 square miles of area.

An extra officer has also been submitted for approval. In the daytime, I am required to spend a considerable amount of time in the office, answering calls, returning calls on accident reports, etc., and more and more people are coming to the station seeking information and assistance. I need assistance in emergency situations, resuscitator calls, accidents, directing ambulances, and house and business establishment breaks. It is impossible for one man to handle alone. As an example, while aiding in resuscitation of a person, you can't leave and go to meet the ambulance to direct them to the scene. There has been quite a few miles increased on the school bus routes also. I realize that this officer won't be able to stop house breaks, but could possibly help deter it. Often there are times when an officer is requested to investigate a nuisance, prowlers, speeders and rough parties, which are quite often in the summer months, especially at the various swimming places.

At present, the two regular officers work a 45-hour week and I work a 52-hour week, plus I work when my help is needed at an accident or with breaks, etc.

When we read about the surrounding towns plagued with problems on vandalism, rowdy crowds, etc., we can be proud of the youth in Pelham, in the manner in which they conduct themselves. Naturally, there are always a few who cannot come under this category.

During the past year, the regular officers have attended the police seminars which are conducted at St. Anselm's College. In addition to this, Officer Corbin attended the State Police School in Concord, which is a three week course. If the new officer is approved, he will also be trained at this same school.

It has been asked of me what constitutes a miscellaneous call and why they aren't listed under the category of "types of calls." This is just a light run-down of these types of calls, and in no way are they a reflection on those who made them, which are of importance to that person at the time: Request to have cruiser check suspicious car in area; check car side of road; report person sick or dead; deliver message to people or member of family sick or passed away; locate child who has failed to return home after school, scout meeting or other function, and usually deliver same to home; children throwing articles or ice and snowballs at passing motorists; is laundromat open; any races today; any school today; are roads O. K.; where can we have water tested; is liquor store open; where was my car towed; cows or horses loose in road; barking dogs, can't sleep; dispose of dead cat; dead animal in road;



where can we get dog groomed; what time does post office open; water in my cellar, what can I do?; what time does town hall open. This is just a general run-down of these calls, where someone had to answer same, and are accounted for in the log. I could go on and on.

I would like to take this opportunity to thank the Police Relief Association who has so generously donated to the department, and has done so for a number of years now. This year a tranquilizer gun was purchased (\$240) to be used in aiding rescue to injured animals. They have also taken it upon themselves to financially aid the Civil Defense truck with needed equipment. There are a number of items that the Association can be thanked for, which are given to the town at no cost to the taxpayer.

It was through the instruction of those present at last year's town meeting, that the committee to investigate costs and plans for a combination fire and police station, continue their investigation and report their findings at the 1968 town meeting. This we have done, and have come up with a plan which we hope is acceptable. Every year that this is detained, the costs are increased just that much more. We do need the facilities desperately. One incident, we had over 25 young teenagers who were involved in a beer party. We had no facilities to detain and question these young people. Anyone who has visited our present station is aware of the small cubicles which this department is expected to work with.

I would like to take this opportunity to thank the Selectmen and other Town Officials who have assisted me and the townspeople for their cooperation and also the Police Officers who work with me in this department.

## REPORT OF THE POLICE STATION-FIRE HOUSE COMMITTEE

The Pelham Town Meeting of 1966 appropriated the sum of \$2,500 to enable this committee to secure land options and preliminary architectural drawings. This report details the steps taken by the committee and the reasoning behind its recommendations.

### Site Study Phase.

Considerable time and discussion was devoted to the location of the proposed building. The major factors considered were site size, availability, cost and geographical location. With these factors in mind, along with a tentative decision to restrict the search to the "greater center area," a listing of thirteen possible sites was prepared and descriptions of these parcels were obtained. The full committee visited each of the sites and agreement was reached on four sites, one of these being Town-owned land.

Letters were sent to four landowners inviting them to meet with the committee. Two landowners responded to the request and discussed the cost and availability of their respective parcels.

The committee then decided to concentrate on the Town-owned land as THE site and a request was made of the Selectmen to have the Town Engineer survey the parcel at the corner of Marsh and Nashua Roads (the site of the old Town Hall).

### Recommendation

THAT THE SITE FOR THE PROPOSED COMBINATION POLICE AND FIRE STATION BE THE TOWN-OWNED LAND AT THE CORNER OF MARSH AND NASHUA ROADS.

### Factors

- i. Geographical location gives immediate access to all major town roads irrespective of which area of town is "developed" next.
- ii. Retains the "center" characteristic and adds to this area the first municipal building constructed in over thirty years.
- iii. Does not require the expenditure of monies for land acquisition - constructive use of Town-owned land.
- iv. Close to the buildings which temporarily house the largest numbers of people - the schools and churches.

### Building Study Phase.

The question "Do we need a new fire house and police station?" is readily answered in the affirmative when both the use factor and available space of the present building are considered. These factors are detailed below.

The lower level is used for the housing of four fire trucks in an area designed to accommodate three trucks, along with the supplies and equipment peculiar to a Fire Department's operation. The way in which this equipment is placed in the available area is a splendid example of "packaging." This concept is correct if all of this equipment were simply being stored, BUT IT IS NOT! This is the same equipment used to protect the lives of approximately 5,000 inhabitants and their property valued in excess of ten million dollars. The facts we face now are that there is no room to store additional apparatus at the present station and that any expansion is impossible for the building has been expanded to cover almost all of the present site.

The upper level is partitioned into two meeting rooms, two small offices for the use of the Police Department, the Chief of Police and the Civil Defense Department, along with several free-standing storage lockers. Entry to any of these areas is through a single door at the sides of the meeting rooms. The current practice of locating the Police Department, which is a permanent, full-time branch of the Town Government, in this area along with the two meeting rooms being scheduled both afternoons and evenings for various civic activities, i. e., Scouts, First Aid Courses, Civil Defense Courses, etc. has resulted in some very awkward and embarrassing situations in regard to effective and professional police work such as:

- i. Normal entry and exit is by an OUTSIDE staircase to the SECOND FLOOR.
- ii. No detention facilities.
- iii. No privacy.
- iv. Lack of file space and data security.
- v. Communication facilities housed in an open corner of the room which is also the department headquarters.
- vi. The Chief of Police shares the office with the Civil Defense group.
- vii. No storage area for major or minor pieces of equipment such as a boat and trailer, present or additional police vehicles, etc.

### Recommendation

THAT THE TOWN VOTE IMMEDIATE APPROVAL OF THE PROPOSED COMBINATION POLICE AND FIRE STATION.

### Factors

In light of the discussion above, the pertinent factors hardly need enumeration. Anyone who has visited the present facility could perhaps add to the points raised in this report by considering parking areas, etc.



Formulation and Finalization. At this point, the committee engaged the services of Fenton G. Keyes, Associates, Consulting Architects-Engineers to assist in the drawing up of some preliminary sketches and plans - using as a basis the ideas and suggestions that the committee had gathered in their individual visits to the facilities of the surrounding towns.

The building proposed by this committee for Town Meeting action is presented in the accompanying figures showing front elevation, floor plan and building placement on the proposed site.

#### Recommendation

THAT THE TOWN VOTE TO RAISE AND APPROPRIATE THE SUM OF SEVENTY THOUSAND DOLLARS (\$70,000) FOR THE CONSTRUCTION OF THE PROPOSED COMBINATION POLICE AND FIRE STATION. (See Appendix I, Item 1)

#### Factors

- i. Exit and entrance at both ends of apparatus room.
- ii. Adequate area for fire apparatus at this central station.
- iii. Building and placement adds to aesthetic beauty of the center of town.
- iv. Functional building incorporating a minimum of niceties.
- v. Door and overhead clearance ample for future additions such as a hook and ladder truck, etc.
- vi. Consideration was given to constructing just the apparatus room and the police wing along with the alternate approach of constructing the apparatus room, police wing and just the shell of the fire wing. These approaches were discarded when they were considered in light of rising construction costs and the requirement of providing the facilities (light, heat, power, water, sewerage, etc.) during this construction phase.

#### Conclusions

The committee feels that the proposed building is adequate to meet the current and immediate future needs of the Town. However, we do feel that the following recommendations, which result from the various areas touched upon in this study, do round out the report in that they do not deal with the proposed building or site, but with topics that are deserving of consideration and/or study.

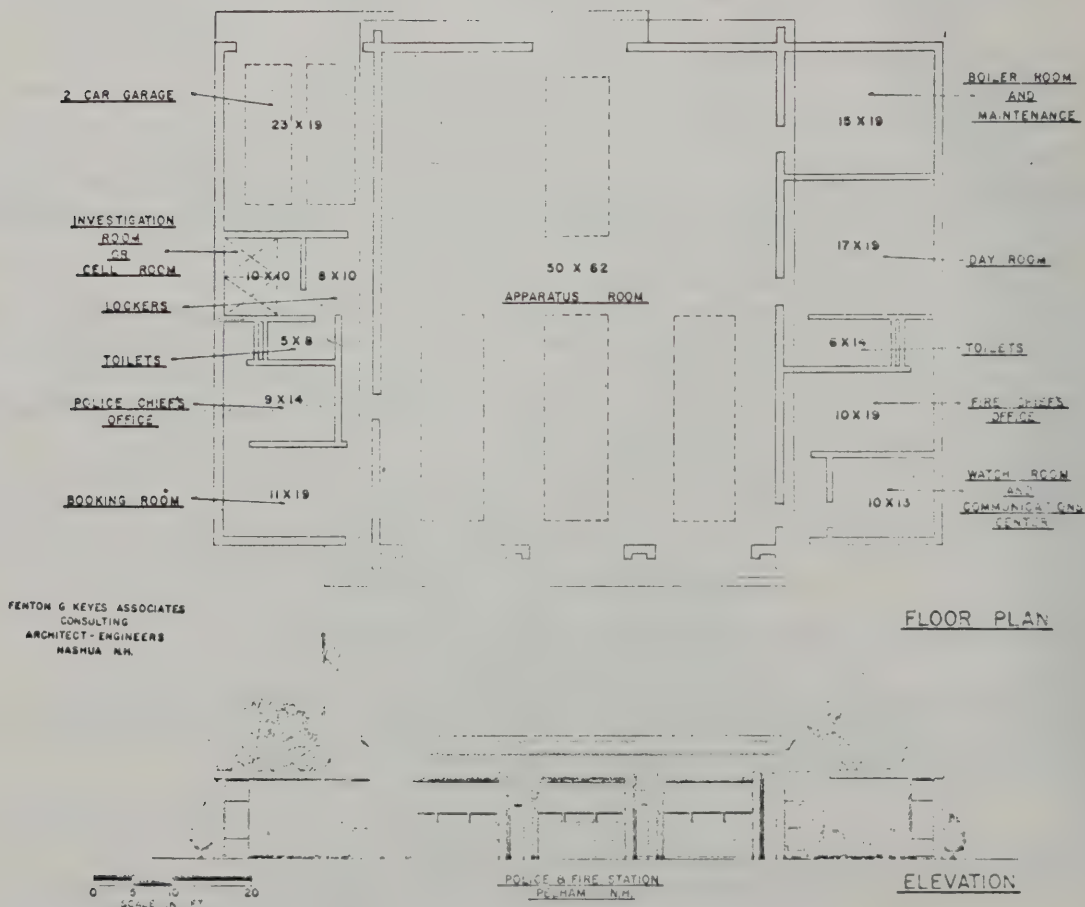
This committee further recommends:

- A. That the Town vote the proposed hardened shelter (see Appendix I, Item 3) as its Civil Defense Headquarters.
- B. That the meeting rooms be designated as a Civic Area and continue to be made available to the numerous civic groups. (See Appendix I, Item 4)

- C. That the Town retain ownership of the older Model A fire trucks for their civic use in parades, musters, etc. along with their practical use in brush and forest fires due to their high road clearance.
- D. That consideration be given to the acquisition of a small boat, motor and trailer for police and fire use.
- E. That the Town purchase the Parsonage property.
- F. That the Town terminate Marsh Road at Common Road to allow safer traffic flow.
- G. That the Fire Department develop a philosophy of expansion using the proposed building as a central station and construct future sub-stations in those areas of Town having the greatest population density.
- H. If this proposal does not obtain the approval of the Town Meeting, that the article setting up the twenty thousand dollars (\$20,000) Capital Reserve Fund pass in the affirmative. (See Appendix I, Item 2)

### BUDGETORY ITEMS PROPOSED BY THE FIRE HOUSE/POLICE STATION COMMITTEE

- Item 1. To see if the Town will vote to authorize the Selectmen to construct a combination police and fire station building on land owned by the Town at the intersection of Marsh and Nashua Roads, being the site of the Old Town Hall, after giving due consideration to the recommendations for such building as made by the Police Station and Fire House Committee; to appropriate the sum of \$70,000.00 for this purpose and to raise said \$70,000.00 by the issuance of serial notes of the Town payable over a five-year period in equal annual principal amounts, at interest not to exceed 4 per cent per annum, pursuant to the provisions of the Municipal Finance Act, Chapter 33, Section 8, of the New Hampshire Revised Statutes Annotated, and to authorize the Selectmen and the Treasurer to negotiate said notes in the name of and on behalf of the Town, and any and all balances remaining after payment in full for said building shall revert to a capital reserve fund for the purchase of a fire truck and/or other major equipment for the Fire Department.

Several complaints have been received regarding disposal systems and in each case the owners were advised that New Hampshire Law provides that waste material from sinks, toilets, etc. must be conveyed away underground in a manner so as not to be offensive. One investigation was made by the N. H. Water Pollution Commission at my request of a sewage system at Little Island Pond, and a dye test confirmed pollution was entering the pond and the situation was corrected.

I wish to thank Terry Hauser, School Nurse, for reporting cases of communicable diseases in the Pelham schools.

I also wish to express my sincere thanks for all courtesies that were extended to me in the investigations carried out during the year.

## CIVIL DEFENSE DIRECTOR'S REPORT

All the equipment making up 3 Radef Units located within the Town of Pelham was exchanged during the year and each unit was periodically checked to assure proper working order and battery strength.

Standard and advanced First Aid classes were held during 1967 and several Police and Auxiliary Police Officers graduated along with some Firemen. Classes sponsored by C. D. were conducted by the American Red Cross and Leo Bongers, Jr. was the Class Instructor.

Contact was made with State C. D. to furnish information regarding Matching Funds for an Emergency Operating Center to be located in the new proposed Fire and Police station. Plans were passed along to the architects. The Matching Funds Program would have paid one-half of the costs of the Emergency Operating Center.

The Town of Pelham is no longer eligible for Matching Funds because of the lack of a Hardened Emergency Operation Center, therefore, no purchases were made under the Matching Funds program.

Our RACES group continues to participate in one hour practice sessions every Tuesday evening. Routine messages are received and sent along with practice Radef messages.

Two Fallout Shelters have been designated for Pelham, one at the St. Patrick Hall and one at Memorial School, and official signs have been placed on the two buildings.

Our Auxiliary Police Unit continues to be very active and assists the regular Police with church traffic, answering telephone and as extra men for cruiser patrol. A special project during 1967 was the repair of a van type truck to be used as a Rescue Truck for the Town of Pelham.

A second-hand truck was purchased by the Pelham Police Association and members of the Auxiliary Police, under the direction of Police Officers John Newcomb, Wayne Bartlett and Michael Kapez, overhauled the motor and reconditioned the body of the truck, painted the truck and installed emergency lights and a C. D. Forestry Band Radio.

I wish to thank publicly, the following:

Robert Fletcher, Nate Boutwell and Arthur Seaman for the free use of their garages for storage of the vehicle and facilities for working on the truck to get it into shape;

The Pelham Police Relief Association for their generous donation of money for the truck and some supplies;

The Lions Club for their donation toward the purchase of a porta-power tool for the rescue truck;

Ray's Auto Parts for donations of parts for the rescue truck.

I sincerely hope that other organizations will make contributions this year of other necessary emergency rescue equipment. Those desiring to make a contribution should contact either the new C. D. Director or Ralph Boutwell, Chief of Police.

Arrangements have been made and classes have been scheduled for training in the use of Radef instruments to be conducted early in 1968.

This is my last report as C. D. Director for the Town of Pelham. I will continue to work in Civil Defense, and have recently accepted an appointment by A. B. Trowbridge, Secy. of Commerce to the National Defense Executive Reserve, and in the event of an escalated conventional war or an attack on the U. S., I will be required to report to a pre-arranged Government Center, thus my services would not be available to the Town of Pelham.

I wish to extend my thanks for the assistance I have received as your C. D. Director and my thanks and gratitude to those who have participated in the various C. D. programs and classes over the past few years.

I urge your continued support of the various C. D. functions in the future and for your sake as well as mine, I wish the new C. D. Director many successful programs in the future.

You are hereby notified that the annual meeting of the Town of Pelham will take place on Tuesday, March 12, 1968 at 10:00 o'clock in the forenoon at the E. G. Sherburne School in said Pelham for the election of Town Officers, and to act upon the subjects listed below. 4. To see if the Town will vote to raise and appropriate the sum of \$2,000.00 to add to the Capital Reserve Fund, for the purpose of purchasing a fire truck, or take any other action relative thereto.

5. To see if the Town will vote to raise and appropriate the sum of \$8,000.00 due in 1968 for the purpose of completing the appraisal of all taxable real properties in the Town by the New Hampshire Tax Commission as authorized by the 1967 annual meeting of the Town. (Approved by the Budget Committee)

6. To see if the Town will vote to adopt the following Ordinance as permitted by Chapter 41 Section 11 of the New Hampshire Revised Statutes Annotated;

It shall be unlawful for the owner, operator or other person having the care, custody or control of any motor vehicle to park such motor vehicle on any public street or highway on any day in the Town of Pelham between the hours of twelve midnight and seven A.M. from December 15 to April 1 of each year, except in the case of an emergency. The fine for each violation of this Ordinance shall be \$10.00 and all motor vehicles found by the police to be in violation thereof shall be towed away at the owner's expense.

7. To see if the Town will vote to authorize the Selectmen to construct a combination police and fire station building on land owned by the Town at the intersection of Marsh and Nashua Roads, being the site of the Old Town Hall, after giving due consideration to the recommendations for such building as made by the Police Station and Fire House Committee.

8. To see if the Town will vote to appropriate the sum of \$70,000.00 for the purpose of constructing a combination police and fire station building as authorized under Article 7 above of this Warrant; and to raise the said sum of \$70,000.00 by the issuance of serial notes of the Town payable over a five-year period in equal annual principal amounts, at interest not to exceed 4-1/4 per cent per annum, pursuant to the provisions of the Municipal Finance Act, Chapter 33, Section 8 of the New Hampshire Revised Statutes Annotated, and to authorize the Selectmen and the Treasurer of the Town to negotiate said notes in the name of and on behalf of the Town, and any and all balances remaining after payment in full for said building shall revert to a capital reserve fund for the purchase of a fire truck and/or other major equipment for the Fire Department. (Approved by the Budget Committee)



9. To see if the Town will vote to raise and appropriate the sum of \$20,000.00 to set up a Capital Reserve Fund for the future construction of a combination fire house/police station building, or take any other action relative thereto.

10. To see if the Town will vote to raise and appropriate the sum of \$8,000.00 for the purpose of including a hardened Civil Defense shelter within the proposed combination police and fire station building, and to authorize the Selectmen to apply for and accept reimbursement of such proportion thereof as may be available to the Town from the United States Government under the United States Civil Defense and Mobilization Act, or other Federal law.

11. To see if the Town will authorize the Selectmen to sell the present fire house building together with all the lands adjoining the same on the east side of Bridge Street in the Town, at such time and upon such terms as they shall determine to be in the best interest of the Town, and to execute a deed or deeds to the purchaser or purchasers of the same evidencing such sale or sales. (No expenditure item)

12. To see if the Town will vote to commit the balance of the Fire Department appropriation to a Capital Reserve Fund, such fund to be used for the purchase of a fire truck.

13. To see if the Town will vote to raise and appropriate the sum of \$750.00 for the purpose of assisting the Greater Salem Community Mental Health Association as permitted under New Hampshire Revised Statutes Annotated Chapter 126-B.

14. To see if the Town will vote to raise and appropriate the sum of \$2,015.00 for the purpose of purchasing a snow plow and wing assembly, or take any other action relative thereto. (Approved by Budget Committee)

15. To see if the Town will vote to accept, raise and appropriate the sum of \$1,650.00 for the purpose of graveling and tarring Greenwood Terrace, so-called, a distance of 2/10 of a mile. (approximately) (By petition)

16. To see if the Town will vote to authorize the Selectmen to appoint a Committee of five to investigate the possibility of establishing a Town Highway Department and to render a report on their findings at the next annual Town Meeting.

17. To transact any other business that may legally come before said meeting.

Miss Hobbs was the first librarian of the Town of Pelham, and served in that capacity from 1893, when the library was first organized, until her resignation in 1958. Her service of sixty-five years as librarian was one of real dedication to the library and the townspeople, with a particular interest in the children. The trustees and all friends of the library appreciate her lifelong and devoted service and interest, and hereby make permanent record.

A metal, four drawer file cabinet has been purchased and installed in the Memorial Room beside the fireplace. It is called a vertical or pamphlet file, and contains news clippings, dated and filed, of current scholastic interest, but too recent to be in book form. Free informative pamphlet material can also be filed.

We were recipients of a \$100.00 State aid grant for reference material.

I attended a weekly extension course last fall at the University of New Hampshire. The name of this course is Library Technique I. These courses lead to a trained librarian's certificate.

The Mother Goose Kindergarten made a class field trip to the library.

New book purchases are being posted on the bulletin board in the library.

Our library has materials regularly provided by the Girl Scouts, Grange League of Women Voters, our town representatives, and generous donations by private individuals. We have also accepted and shelved many paperback donations.

Three individuals are saving clippings of Pelham news from three daily papers, and an interested citizen mounts them in three separate scrapbooks giving us a current history of our town.

Magazines subscribed to: Natural History, Scientific American, Consumer's Guide, National Geographic, Science Digest, Changing Times, Saturday Evening Post, New Hampshire Profiles, Jack and Jill, Life, Today's Health, and Science Digest.

Magazines donated: U. S. News, Look, Prevention, Holiday, Travel, Reader's Digest, Hunting and Fishing, and Children's Life.

Magazines may be signed out under book rules.

Scarcely a day goes by but what new patrons are registered.

This is also our second year that we have been able to furnish our new patrons with our own much needed book marks, listing our present hours as Monday through Thursday nights 7 - 9, and Monday and Wednesday afternoons 2 - 5. The printer has also significantly inscribed on the book marks "Read More and Know More."

## ANNUAL REPORT OF PELHAM RECREATION COMMISSION

The establishment of this committee within the structure of our town government has proven a most progressive step toward developing long-needed citizen recreation services. The members of this committee have faithfully served the taxing responsibilities associated with such a program. The following is a brief summary of activities and projects undertaken this past seven months.

A meeting was held in June with all community association leaders invited. The purpose was to assist our efforts toward a series of priorities in establishing a comprehensive community recreation program. Secondly, we wanted to receive community suggestions on the direction the commission should gear its efforts. Approximately 1,500 questionnaires were mailed to residents to evaluate their interests in this area. Research of town-owned land shared number one priority with the development of town bathing facilities. Through inquiries the commission was able to set aside 85 acres of town-owned land, and acquire a generous gift of 12 acres (from the William Landry family of Draçut). We are presently negotiating toward 3 town water recreation areas.

We met with the school district with the intention of coordinating programs and discussing a permanent town recreation site to the rear of the E. G. Sherburne School.

The committee has sponsored: Red Cross (swimming) water safety program at Harris' beach on White's Pond; the Ford Motor Co. Punt, Pass and Kick competition held in Nashua (5 Pelham boys achieved trophies); a ski school program was instituted at the Methuen Ski slope with 55 attending the courses; and an ice skating rink was formed in back of the E. G. Sherburne School. Appreciation is extended to the school district and the Fire Department for the use of land and flooding equipment. Expansion and the maintenance of our program is totally dependent upon the fiscal and physical determination of you - fellow citizens.

Committee members attended a Physical Education and Recreation Workshop in Concord, and arranged a communication linkage with State levels in the Recreation field. As the year 1967 comes to an end, we express our thanks to those people who have generously assisted our efforts. In 1968, we have planned an expansion of our recreational activities for both young and old.

## RECORD OF THE ANNUAL SCHOOL DISTRICT MEETING MARCH 29, 1967

The annual meeting of the Pelham School District was called to order by Moderator Alton M. Hodgman at 1 P.M. The polls were declared open until 9 P.M. with action on Article 2 through 8 to begin at 8 P.M.

Moderator Hodgman called business meeting to order at 8 P.M. School Board Chairman C. Michael McLlarky introduced Supt. of Schools Claude Leavitt, Asst. Supt. Peter Dolloff and School Counsel Edward P. McDuffee and requested permission that they be allowed to sit in on the meeting. Hearing no objection, permission was granted.

A motion was made and seconded that the total sum of the recommended 1967-68 budget, \$654,501.10 be approved. The motion was then amended to read that the recommended school board figure of \$660,488.48 be approved. Both were defeated by a standing vote and Articles 2 and 5 were taken up item by item by Randall H. Richardson, chairman of the budget committee as follows:

A motion was made, supported and passed in the affirmative to accept total appropriation of \$654,501.10.



The Moderator declared polls closed at 9 P. M.

Under Item 4 of the budget which was Salaries, a motion was made and seconded to accept budget committee figure of \$203,310.00. It was then amended to read that the school board recommended figure of \$206,110.00 be accepted. The salary of the principal and the physical education teacher was discussed along with the need for a guidance counselor by Supt. Leavitt and Mr. McLlarky. On a standing vote, the figure of \$203,310.00 was accepted and the amendment figure of \$206,110.00 was defeated - 48 for - 52 against.

Article 3 was taken up and Board Chairman McLlarky announced that the owner of the land on which the Memorial School was constructed was awarded a court finding of \$40,000 for the land and an additional approximate \$4,000 for court costs and interest payments.

The following resolution was made, seconded and passed in the affirmative:

Resolved - that the sense of this meeting encourage the school board to request the budget committee to overexpend the 1966-67 School District Budget for the purpose of paying the court award of eminent domain proceedings and pertinent costs.

Under Article 6, the School Board was authorized by the vote of the meeting to make application for grants and funds that may be forthcoming from state or federal governments.

Article 7 was passed in the affirmative.

Under Article 8, James Powers, chairman of the steering committee for construction of a new high school, reported on progress being made by the group.

Albert J. Maki, chairman of the student transportation committee, also reported on the findings and progress of his committee.

A motion was made and supported in the affirmative to adjourn the meeting at 10:55 P.M.

Moderator Hodgman declared the state of the ballots as follows: School Board member for 3 years - Frederick Houle - 139 (elected); Moderator for 1 year - Alton M. Hodgman - 145 (elected); Treasurer for one year - Dorothy Hill - 143; clerk for one year - Dorothy Hill - 142 (elected).

Oath of office given to Moderator Alton Hodgman, School Board member Frederick Houle and treasurer and clerk, Dorothy Hill by Clerk Dorothy Hardy. Used and unused ballots sealed and certified by Moderator Hodgman.

# SCHOOL WARRANT

## THE STATE OF NEW HAMPSHIRE

To the inhabitants of the School District in the town of Pelham qualified to vote in district affairs:

You are hereby notified to meet at the Ernest G. Sherburne School Auditorium in said district on the 27th day of March, 1968, at one o'clock in the afternoon, to act upon Article I (Note: Polls for the election of School District Officers will open at 1 P.M. and will close not sooner than 9 P.M.) Action on remaining Articles will begin at 8 P.M.

1. To choose all necessary School District Officers:

- A. To choose a Moderator for the coming year.
- B. To choose a Clerk for the ensuing year.
- C. To choose a Member of the School Board for the ensuing three years.
- D. To choose a Treasurer for the ensuing year.

2. To determine and appoint the salaries of the School Board and Truant Officer, and fix the compensation of any other Officers or Agents of the district.

3. To hear the reports of Agents, Auditors, Committees or Officers chosen, and pass any vote relating thereto.

4. To choose Agents, Auditors, and Committees in relation to any subject embraced in this Warrant.

5. To see what sum of money the District will vote to raise and appropriate for the support of schools, for the payment of salaries for the school district and agents and for the payment of the statutory obligations of the district, that is, to see if the School District will vote to accept the School District Budget as prepared by the Budget Committee or to take any other action thereon.

6. To see if the District will vote to authorize the design, and construction of an addition to the Memorial School and to appropriate a sum not to exceed \$500,000.00 for the aforesaid purpose; said sum to be in addition to any local, state or federal funds made available therefor; and to raise the same by the issuance of bonds or serial notes in accordance with the provisions of the Municipal Finance Act, Chapter 33, of the Revised Statutes Annotated of New Hampshire, as amended, and to authorize the Pelham School Board to so issue and negotiate said bonds or notes in the name of or on the credit of the District, said board to have discretionary powers described in Section 8 of said Chapter 33 in respect to said notes or bonds.

7. To see if the District will authorize the School Board to make application for and to receive in the name of the district such advances, grants-in-aid or other funds for educational purposes as may now or hereafter be forthcoming from the United States Government, the State of New Hampshire or any other federal or state agency.

8. To see if the District will create a school planning and study committee and to authorize the school board to appoint such committee.

9. By Petition of - Thelma Boutwell, Diane Blais, Carole A. Chesbrough, and others: To see if the school district will vote to relinquish authority of 4-6 acres of its property to the rear of the E. G. Sherburne (school) to the town of Pelham for recreational purposes, or take Action relative thereto.

10. By Petition of - Thelma Boutwell, Diane Blais, Ethel Rondeau, and others: To see if the school district will vote to convene all future annual district meetings on the second Tuesday after the First Monday of March Concurrent with the Annual Town meeting. Or take action relative thereto.

11. To transact any other business that may legally come before this meeting.

Submitted herewith is the report of an examination and audit of the accounts of the Pelham School District for the fiscal year ended June 30, 1967, which was made by this Division in accordance with the vote of the District. Exhibits as hereafter listed are included as part of the report.

### SCOPE OF AUDIT

Included in the examination and audit were the accounts and records of the School Board and the School District Treasurer.

### FINANCIAL STATEMENTS

#### Comparative Balance Sheets: (Exhibit A)

Comparative Balance Sheets as of June 30, 1966 and June 30, 1967, are presented in Exhibit A. As indicated therein, the Net Debt decreased by \$60,791.73 during the fiscal year ended June 30, 1967.

#### Analysis of Change in Financial Condition: (Exhibit B)

An analysis of the change in financial condition of the School District during the fiscal year is made in Exhibit B, with the factors which caused the change indicated therein.

#### Comparative Statements of Appropriations and Expenditures - Estimated and Actual Revenues: (Exhibits C & D)

Comparative statements of appropriations and expenditures, estimated and actual revenues for the fiscal year ended June 30, 1967, are presented in Exhibits C and D. As indicated by the budget summary (Exhibit D), a revenue surplus of \$4,583.89, plus a net unexpended balance of appropriations of \$1,284.32, resulted in a net budget surplus of \$5,868.21.

#### Statement of Receipts and Expenditures: (Exhibit E)

A summary statement of receipts and expenditures for the fiscal year ended June 30, 1967, made up in accordance with the uniform classification of accounts, is included in Exhibit E. Proof of the Treasurer's balance as of June 30, 1967, is indicated in Exhibit F.

#### Building Fund Account: (Exhibit G)

A statement of the Building Fund Account for the fiscal year ended June 30, 1967, is presented in Exhibit G.

#### School Lunch Program Account: (Exhibit H)

Exhibit H presents a statement of the School Lunch Program Account for the fiscal year ended June 30, 1967.

#### Statement of School Tax Account: (Exhibit I)

A statement of the School Tax Account with the Town of Pelham is presented in Exhibit I. As indicated therein, as of June 30, 1967, a balance of \$1,704.94 on account of the 1966-67 School Tax was due the School District from the Town.

Statement of Long Term Indebtedness: (Exhibit J)

A statement of the outstanding long term indebtedness of the School District as of June 30, 1967, showing annual debt service requirements, is contained in Exhibit J.

GENERAL COMMENTS

Current Surplus:

It is noted that the current surplus (excess of total assets over current liabilities) decreased by \$9,208.27, from \$15,076.48 to \$5,868.21 during the fiscal year ended June 30, 1967, as shown herewith:

## SCHOOL BOARD REPORT

To the Townspeople of Pelham:

Pelham, which is a part of Supervisory Union #27 consisting of five School Districts, has as its Superintendent of Schools, Claude H. Leavitt, who excels in the dedication and proficiency of his position. Assistant Superintendent Peter G. Dolloff has demonstrated his knowledge and capabilities. Business Administrator James Jordan replaced Mr. James Tierney, who resigned to accept the position of Principal at Memorial Junior High School in Hudson. Mr. Jordan has demonstrated his abilities in the area of purchasing.

Principal Moses Brown exerts his administrative capabilities in a commendable manner. He initiated a summer school program that proved successful for all those attending. The projected enrollment deems it necessary to ask you to provide an Assistant Principal at the E. G. Sherburne School.

Our instructional staff has excelled in the performance of their duties through our progressive program. To maintain this excellence, we ask your consideration of the proposed salary schedule.

Our Physical Education program molds the physical development of our young people through regular classes, intermural programs, and inter-school competition through its hard working and dedicated director, Mr. John Duclos.

The Guidance Counseling program initiated this past year, utilizing Title I Funds, has proven to be a tremendous asset to our school district. The Guidance Counselor, Mr. Roland Maheu, has done an outstanding job counseling students with the cooperation of their parents.

The fine work of maintaining records, issuing parental bulletins, and all other related school office tasks belongs to Mrs. Sandra Corbin, Office Secretary.

Our School Lunch Program through the enthusiastic direction of Mrs. Velma Houle and her capable staff continue to provide through central cooking a hot lunch program for our young people.

Our Health Program through our School Nurse continues to be a vital part of our schools. Mrs. June Groele was hired when the board accepted, with regret, Mrs. Terry Hauser's resignation in December.

Mr. George Masson, Supervisor of Custodians and Maintenance, and his staff of Custodians, Mr. Lorin Raymond, Mr. Raymond Barrette, Mr. William Jelley, and Mr. Thomas Desmarais continue to maintain our schools in an efficient manner.

The board proposes that music and art programs be initiated this year and ask your consideration. These programs were on a limited basis three years ago.

Based on enrollment projections, the board proposes an addition to the Pelham Memorial School, which will include twelve classrooms plus special areas necessary to the continuity of our instructional program. The permanent steering committee under the chairmanship of Mr. James Powers has supported this proposal. We ask your consideration of Article 6 in the School District Warrant.

The board proposes a planning and study committee to explore our high school needs, which will report to the school district its findings, hopefully, prior to the annual school district meeting in March, 1969, so that the town may take action relative thereto.

Recommendations of the Transportation Committee under Chairman Albert Maki relative to reducing the high school routes were implemented by the board in September, 1967. If these routes are maintained there will be no increase in the cost of regular transportation this year.

The appreciation of the School District is extended to the organizations and individuals, who have contributed their time and funds to the welfare and well being of our young people, by your school board. To you, both anonymous and acknowledged. Thank You!

The board brings to you a budget which reflects the best thinking and reasoning of not only itself, but of the Superintendent and the entire Staff. To maintain our program of progress and quality in the education of our young people we ask your continued cooperation and participation.

## REPORT OF THE SUPERINTENDENT OF SCHOOLS

To the School Board and Citizens of Pelham:

The Memorial and Sherburne Schools continue to meet the space requirements of our pupils in grades one through eight. However, our growing pupil enrollment is pressing us to increase our available classroom space by September, 1969. This can best be seen by the growth of the past three years. In September of 1966 we enrolled 611 pupils and 713 last September. We project 812 for September, 1968. This is a steady and constant growth of over 100 pupils per year which is nearly equal to four classrooms.

As we think in terms of growth and additional building needs, we should let our instructional program needs guide our building plans. We should not only strengthen existing programs, but implement additional programs, which will allow us to better meet the needs of our pupils and offer a more comprehensive elementary program. Serious budgetary attention is required if we are to add pupil services in art, music, remedial and developmental reading, special education and library science.

The present educational opportunities at Alvirne High School for our secondary school pupils are excellent. However, Pelham has one more year, with an option for two more, on its tuition contract with Hudson. The voters of Pelham will be well advised to take a good hard look at the future of its secondary school pupils before this contract expires.

The educational future of Pelham offers several alternatives. Pelham may choose to proceed into the 1970's independent of other school districts, or in conjunction with one or more neighboring communities. It seems that the best solution for Pelham will appear only when all the alternatives have been pursued and discussed. This may require a planning and study committee appointed for this specific purpose.

The program of studies offered our children is taught by a well-trained and dedicated teaching staff. Pelham should make every effort to continue to attract and hold competent teachers. It is a pleasure to acknowledge the following additions to our instructional staff:

## REPORT OF THE ASSISTANT SUPERINTENDENT

Dear Mr. Leavitt:

The following paragraphs constitute my report as Assistant Superintendent in the School District of Pelham, New Hampshire.

The current school year has seen the second year of our Middle School Program. During this second year, we have had the opportunity to refine and expand this concept of school organization. We feel we have been able during these two years to fulfill our three major goals. The comprehensive facilities in the Memorial School are available to all youngsters in grades 5-8. Teachers have the opportunity to teach in areas of specialization at a time when the curriculum is becoming too sophisticated to expect the self-contained classroom teacher to do an adequate job in all areas. Finally, we see evidence that we are better able to cater to the basic physiological and psychological changes that are peculiar to the eleven to fourteen year age bracket.

The scope of our pupil services have been significantly increased with the addition of guidance personnel. As indicated in last year's report, the guidance counsellor is able to assist each child in developing his capacity to function as close to his level of potential as possible, both with regard to intellectual potential for academic production and potential for personal-social competency. We anticipate receiving approximately \$2,500.00 toward support of the guidance program through Title I of the Elementary and Secondary Education Act of 1965.

Title II of ESEA 89:10 provides for the purchase of library resources, textbooks and other printed and published materials. During the current year, Pelham will receive approximately \$1,375.00 in library materials. During the last fiscal year, Pelham received \$962.00 in library material through Title II. In addition to this, Pelham received \$1,900.00 awarded on a competitive basis with other communities in the state of New Hampshire. Upon review of the community's efforts in establishing an excellent library facility at the Pelham Memorial School, this library was adjudged to be a model library and one deserving of this extra grant in aid.

In addition to the afore-mentioned, Pelham has been using the services of Project TRY. This project is funded through Title III of ESEA 89:10, and provides professional practitioners in the visual and performing arts to present performances designed to expose children to the aesthetic qualities in programs of this type.

During the coming year, priority consideration should be extended toward those services necessary to provide a comprehensive elementary program. Every child needs frequent opportunity and stimulation to express his thoughts and feelings through art and music experiences. Through art and music the child may exercise his imagination, develop aesthetic judgement, acquire sensitized awareness, grow in ability to listen and observe, use his creativity, gain in skill, and learn something of his art and music heritage. What is equally important, he will receive the background necessary to compete with and understand his peers based on a broad academic and aesthetic background.

Probably the most pressing problem facing the school district during the coming year is the need for additional space. In order to maintain their excellent pupil-teacher ratio, additional classroom area is an absolute necessity.

In closing, I would like to thank the School Board and yourself for your direction and guidance, Mr. Brown for his unfailing cooperation, and finally the citizens of Pelham for their commitment to excellence in the educational program.

Submitted herewith is my fourth annual report as supervising principal of the Sherburne and Memorial Schools.

### PREFACE

The opening day of school in September found us with 115 additional students over the opening day of the previous year. Every available classroom is being utilized in addition to the library and the science laboratory being used as homerooms. Study periods are held in the cafeteria six periods a day. Once again we are faced with a critical need for additional classrooms. This next school year will see class size increase to a number that will be detrimental to effective instruction. Immediate construction of additional facilities is imperative.

### INSTRUCTION AND PERSONNEL

Meetings were held with Math and Foreign Language Department heads of Alvirne High School to fully coordinate these programs and to ensure continuity and sequence of instruction in these areas. We are most pleased to note that the majority of our 8th grade students make the transition from Pelham to Alvirne High School with ease. End of the year testing is also done which enables the guidance department at Alvirne to properly place the incoming ninth grade students from Pelham.

The Science Department at the Memorial School was strengthened by an additional science teacher with subsequent schedules arranged which have permitted team teaching in this area.

The area of in-depth pupil services has been effected through the combined and cooperative efforts of Mrs. Hauser, our school nurse, and Mr. Maheu, our guidance counselor. Through their combined efforts, many students have been assisted through a difficult and trying period in their young lives.

This next school year will see the completion of the adoption of the Betts Basal readers through grade six. This program has and is proving to be highly effective and beneficial to students at all reading levels.

With the return of Mr. Duclos, our Physical Education Director who spent the last six months of the 1966 school year in the service, the physical education program was resumed with most pleasing results. During the first part of this school year, he tested all students using standards set up by the President's Physical Fitness Program. At present, Mr. Duclos is working in areas of specific weaknesses as revealed by the testing program.

This year a new innovation was begun in the Pelham School District. Once a month a released time day is held in both schools. Students are dismissed at 1:30 and the remainder of the day is devoted to parent-teacher conferences, teacher in-service training programs, seminars, and workshops. To date, these have been most effective and beneficial to students, parents and teachers.

### FUTURE NEEDS

For a well-rounded, comprehensive instructional program for our students, it is hoped that this next year we will have an art and music program in the Pelham School District. Students leaving our schools suffer in comparison with those who have had the benefits of these programs.

In closing, I wish to thank you Mr. Leavitt, Mr. Dolloff, our school board and our dedicated staff for the support and cooperation so freely and generously given this past school year.

A measles clinic was held November 15, 1966 with 108 children receiving immunizations. At the well-baby clinics held April 6, May 11, and June 1, 1967, 233 children received immunizations as follows: toxoid - 195, smallpox vaccine - 40 and polio vaccine - 40. At the pre-school dental clinic held May 4, 1967, 118 children were treated.

Dr. Luther March, Dr. James Sullivan, and Dr. Albert Murphy were the attending physicians. Those who assisted me at the clinics were Mrs. Anna Horskin, Mrs. Georgia Atwood, Mrs. Florence Porter, and Mrs. Avis Fairbanks. Acting as clerks were Mrs. Ruth Carleton, Mrs. Gertrude Tuttle, Mrs. Claire Hanlon and Mrs. Dot Constantin.

## Special Referrals

- 15 pupils referred to Crotched Mountain for educational testing and evaluation.
- 2 pupils referred to PERC Institute for testing for specific language disability.
- 11 pupils referred to Concord Child Guidance Clinic for testing and therapy.
- 2 pupils sent to Crotched Mountain hearing clinic for testing and diagnosis of hearing disorder.

Financial assistance for some of these children came to me from various sources. The P. T. A. donated \$100.00 and \$45.00 was given by one of the teachers. The Lion's Club gave assistance where needed for those with visual problems. The Pelham Grange gave me \$25.00 which was used to provide dental care for several pupils. I want to thank all of these generous donors.

A measles clinic was held October 10, 1967; 128 immunizations were given.

#### Special Referrals

- 1 perceptually handicapped pupil sent to Crotched Mountain for schooling.  
 Tuition was provided by a generous local organization.
- 1 referral to Crotched Mountain for educational testing and evaluation.
- 10 referrals for auditory training.

Because of the rapidly increasing pupil enrollment, the schedule of testing was changed this year to coincide with the complete physicals. These are given at first, third, fifth and seventh grade level. Students with known problems will be tested yearly as well as referrals from teachers or students themselves. New pupils will also be tested upon entering our system.

Pelham has always attempted to provide needed services for our school children. This means that in the very near future, we must provide an additional nurse to help take care of our schools. The nurse should have adequate time to provide counselling pertaining to health problems and time to act as resource person for health materials and information. She must also take care of pupil referrals and needed follow-up to see that recommended treatments are carried out as directed. There should, ideally, be time for health education by means of films and classes. The urgent areas of drug addiction, alcoholism, consumer education, sex education, and family life education can no longer be ignored. The problems are already with us and a way must be found to help our youngsters to cope with them. The immunization clinics must also be increased as the new vaccines become available - as in the case of measles and mumps vaccines.

Whatever we can provide for our students in the way of health services, counselling, remedial teaching or special education will be money well spent. Prevention is far cheaper than treatment both in terms of money and human suffering. Since New Hampshire does not have the facilities or resources to take care of all our children with various handicaps, we should do our best to provide for them on a local level.

# REPORT OF THE GUIDANCE COUNSELOR

Dear Mr. Leavitt:

It is my pleasure to submit to you my report as Guidance Counselor in the School District of Pelham, New Hampshire.

The counseling program was officially inaugurated in September, 1967. The purpose of counseling in Pelham is to help children to resolve those issues which seem to interfere with their learning. Counseling takes place on two levels. The E. G. Sherburne School houses the playroom in which various play materials are located. The purpose of the play material is to enable children to act out feelings that they cannot put into words. Often times a child will communicate verbally more easily if he is engaged in some physical activity. Also, a child may communicate non-verbally through play activity. On the other level, counseling takes place in the counseling rooms of the Memorial School. In that area, individual and group counseling also occurs. This area also contains some materials such as clay and drawing materials which allow older children to express themselves through the constructive use of their hands. Counseling at St. Patrick's is more difficult as there is no permanent counseling setting at the present time.

We feel that we have accomplished a great deal in the short time that the program has been in service. In an effort to coordinate our activities with outside agencies, the counselor has visited a number of referral agencies which are available to us. This activity is important so that we may offer the best service possible by utilizing the unique services of these various agencies.

In the area of educational growth, the counselor is continuing to take courses in counseling at the University of New Hampshire. This department also employs audio-visual aids such as tape recordings in an effort at continued educational growth.

The counseling department has recently produced a 15 minute, 8 mm, color, sound film on elementary school counseling which will be available to clubs and civic groups. This film may be the first of its kind to be produced anywhere.

School children were introduced to counseling in a September orientation to each class. Two essential points were covered: How easy it is to see the counselor, and what occurs in counseling with special emphasis on the concept of confidence. Following is a breakdown of counseling activity for the period September 15 to December 22, 1967:

Types of counseling: Educational - Discussion of something directly concerned with school. Personal - Something other than school is discussed. Request: Self - The child requested counseling himself. Referred - The child was sent to counseling by someone else.

Aside from school counseling, the counselor also meets with parents and teachers, coordinates the school testing program, and advises the Principal on matters of counseling.

A look to the future:

1. The workload is enormous; one counselor for 1,100 students. It is hoped that the number of personnel in the Counseling Department will be increased.

2. There is a vital need for a private telephone line so that parental conferences may be carried on over the telephone in strict confidence.

3. Counseling settings:

- a. Sherburne School - The size of the room is inadequate.
- b. Memorial School - The room is adequate in size, but is located between two classrooms. This affects the privacy so necessary in counseling.
- c. St. Patrick's - A permanent setting will have to be established where materials may be maintained and where privacy so necessary to counseling may be maintained.

4. The establishment of a Pupil Personnel Service whereby all special education, counseling, and health services will be integrated and synchronized is in the planning stage. There would be a coordination of services in order to avoid duplication and waste of activity.

5. A readiness program for pre-schoolers should be established. The school counselor will be attending the Gessel Readiness course in February.

Progress has been made in the area of counseling. But we should not become complacent and accept what we have as good enough for our children. The past four months have been especially rewarding for me because of the enthusiasm I have found, for the program, in the town of Pelham.

## LUNCH PROGRAM REPORT

At no time in the history of the School Lunch Program, have we faced the problems we do today. We are in an era of automation and rapid changes with advancing food costs, new type equipment, rising labor costs and a sharp cut in federal assistance. We are handling two of our citizens' valuable possessions - his children and his money - and only through cooperation and team effort can we hope to "hold the line" and maintain our high standards.

In 1967, we served 67,173 pupils and 3,602 adults with the outlook even greater for the coming year. The Federal Government continues to cut its support in reimbursement as well as food products. The five cent increase in the lunch price last year enabled us to operate our program in the black and hopefully will continue to in the future. Increased participation at both schools is one of the most helpful factors in meeting the financial needs of the program.

The Pelham Relief Association continues to assist with contributions to the program for free lunches.

The women of the community are ever ready to answer the call for volunteer help to the program. I would like to thank the following women for their assistance with the School Picnic and Thanksgiving dinner: Doris Dobson, Dorothy Constantin, Claire Hanlon, Ruth Brock, Phyllis Robinson, Anna Bolduc, Eleanor Burton, Jan Pitts, Phyllis Hague, Jean Robarge, Lou Haldeman, Barbara Vitale, Judith Lehmann, Joanne Edwards, Carolyn Law, LaVerne Steck, and Jane Burton.

Helping our children and young people to establish good food habits is probably the most important and gratifying thing that we do. My thanks to the faithful lunch program staff for their untiring efforts in this behalf. This year's staff includes: Ethel Duarte, Hellen Orlando, Agnes Lawlor, Doris Simpson, Anna Fitzpatrick and Judith Lehmann. Alvina Spaulding who has given much to the program through the years has taken a leave of absence due to illness and Judith Lehmann is taking her place at the Sherburne School.

We are very fortunate in having a list of conscientious substitutes and we call on them frequently throughout the year.

I wish to extend my thanks to the Staff, School Board and Superintendent's Office as well as the townspeople for their help in support of the Lunch Program.

## REPORT OF THE PERMANENT STEERING COMMITTEE

### History and Purpose:

The Permanent Steering Committee was established by a vote of the School District at a special meeting held on December 18, 1963, based on the recommendation that "A Permanent Steering Committee be appointed to assist the school board in planning and projection for future school district needs."

The purpose and function of this committee is to work with, advise and recommend to the school board, possible solutions to the educational problems of the District concerning the students and their futures, the facilities needed to carry out these solutions, the Town's ability to support these requirements and any particular problem's place in the long-range objectives of the school district.

This report attempts to convey, detail and summarize this committee's thinking on the topics delineated below. The order in which the topics are listed is not to be interpreted as being indicative of their importance, but simply a rather arbitrary listing.

In those instances where the committee studied and discussed a topic to its satisfaction, a recommendation is made concerning future action. All other topics terminate with an opinion as to future study or suggested course of action.

### High School Facilities:

This concern is one that has evoked much discussion. "Simple" solutions range from continuing on a tuition basis to building our own high school. This committee urges that the District pursue the compromise area that lies between these two extremes and RECOMMENDS THAT THE DISTRICT SUPPORT THE ARTICLE CALLING FOR THE FORMULATION OF THE STUDY COMMITTEE - ONE ON THE AREA (AUTHORIZED REGIONAL ENROLLMENT AREA) SCHOOL AND THE OTHER ON THE COOPERATIVE SCHOOL DISTRICT. The committee feels that only after a comprehensive study of the "trade-offs" of all of these alternatives is released, can the District decide its future course of action - this decision will be both expensive and binding.

### Elementary Curriculum:

One of the most basic skills in our affluent society is the ability to read. Truly, this ability to read (as well as one is able) is the cornerstone of our formal educational structure.

A problem, NOT UNIQUE TO THE PELHAM SCHOOL DISTRICT, is the fact that many children read below their grade level. We suggest that the district accelerate its efforts in programs of remedial reading - striving to bring each and every student to his or her excellence level.

In the area of new programs, we suggest that the District initiate a structured sequence that develops the natural talents of our students in the technological skills and crafts. We are all well aware of the man-machine interface problems we face all about us - viz - the broken appliance, the difficulty we have in getting service and repairs performed, etc. Many of these devices, machines, etc. we cannot begin to understand much less attempt to repair. We say it takes a certain kind of talent and then hire an individual with that talent to carry out the repairs. However, many of our supposedly "less able" students can and many times do understand (perhaps in an intuitive sense) "how" these things work and could possibly repair them. These students are not the "best" students in an academic sense because the curriculum that has as its objective the college freshman does not interest and motivate these "practical" interests. What is suggested here is a program that interests, encourages and develops these students - many of whom are or become our "force-outs" (formerly called "drop-outs"). A program of this type could terminate at the high school level, the junior or community college (a reality in the greater Nashua area within perhaps ten years) level, or even the senior college level.

Admittedly the committee knows of no program of this type in existence at the elementary level. However, one could evolve from the Pelham School District - perhaps funded by a Federal Grant.

### Elementary Facilities:

The District's primary concern has been and continues to be adequate physical plant for elementary education. For a town with a residential tax base, we can and should be proud of the educational facilities we offer our children. However, the time has come for our District to give very serious attention to a comprehensive plan of growth so that we might reap some of the wisdom of the experiences of our neighboring towns, rather than "re-invent the wheel" ourselves.

The District is only too well aware of the rapid growth of the town and the increases in instructional salaries, transportation and buildings. We cannot continue to expand in these categories without soon



answering the obvious question, "what plan are we following - which way do we go next?" This committee suggests that a goal in terms of physical plant(s) might be approached in the following way:

It appears that the most probable course of action in the high school needs will be met by one of the alternatives discussed above, i.e. AREA, COOP, tuition or our own high school.

Next, consider the Memorial School as gradually evolving into a junior high school and perhaps retaining its middle school characteristic. Consider further the possibility of tuition junior high school students in Pelham.

Follow this with neighborhood elementary schools springing up in the densely populated areas of town, servicing grades 1 thru 4 on a walking basis. (Sidewalks will become a reality within our lifetimes.)

Admittedly much of the above might seem to be "blue-sky" thinking to some, but the point of all this discussion is that we do have an ideal or goal to strive for and this in itself gives direction and purpose to our actions. This committee urges that we clearly establish the "big-picture" so that we might commence planning the pieces.

#### Memorial School Addition:

Since its reactivation in January, 1967, the committee has studied and discussed the rising enrollment in the District. After considering the feasibility of adding to the existing buildings, the committee agreed to "Recommend that the School District take initial steps to start a twelve-room addition to the Memorial School." The committee suggested that perhaps an appeal to the Budget Committee for an emergency appropriation to start the footings for the twelve-room addition might be investigated. However, further action was deferred until the borrowing capacity of the School District could be determined.

The need is now upon us and the additional classrooms are necessary. Therefore, the committee RECOMMENDS THAT THE DISTRICT SUPPORT THE SCHOOL BOARD'S PROPOSAL FOR AN ADDITION TO THE MEMORIAL SCHOOL THAT WILL SATISFY THE DISTRICT'S IMMEDIATE NEEDS.

The committee would also like to point out that the next pressing need will be in the lower elementary facilities, grade 1 thru 4.

#### Acknowledgement:

The steering committee extends a grateful "thank you" to the Provisional League of Women Voters for honoring its request and sponsoring the open meeting held on Thursday, January 11, 1968. The committee believes that through the use of this means of communication, we can better acquaint our fellow citizens with the problems and proposals of the district.

#### Committee Meetings and Prospective Members:

The steering committee meets the last Wednesday of the month at 8:00 p.m. in the Memorial School. The meetings are open to the public and as with any appointed committee, vacancies occur periodically. Any interested citizen wishing to serve on this committee is requested to contact either the chairman or the district school board.

#### Conclusion:

Much of the foregoing is not what many expect in a report to a district meeting. This committee's purpose and meaning is, however, one of "planning and projection for FUTURE School District needs." Therefore, we report herein, concepts, ideas and methods of implementation which we feel give the District food for thought, suggested courses of action and perhaps more reality than fantasy.
