You are hereby notified to meet at **The Roxbury Meeting House** in said **Town** on **Tuesday, the Twelfth (12th) day of March**, next at **7:00** of the clock in the afternoon, to act upon the following subjects:

Article 1: To choose all necessary **Town Officers** for the ensuing year:

Article 2. To see if the Town will vote to raise and appropriate the sum of **\$27,450.00** for **general municipal operations**, as follows:

Article 3: To see if the Town will vote to raise and appropriate the sum of **\$11,500.00** for salaries and expenses of the **Police Department**.

Article 4: To see if the Town will vote to raise and appropriate the sum of **\$4,651.00** for the purpose of compensating the Roxbury **Police Department** for the summer patrols at Otter Brook Park. These funds for expenditure are designated to the town through the US Army Corps of Engineers. The appropriation does not effect the Town's tax rate, but to be properly expended a vote is required.

Article 5: To see if the Town will vote to raise and appropriate the sum of **\$800.00** for the salaries and expenses of the **Fire Department**.

Article 6: To see if the Town will vote to raise and appropriate the sum of **\$1,000.00** to the **Capitol Reserve Fund** for replacement of the Town's six wheel ATV.

Article 7: To see if the Town will vote to raise and appropriate the sum of **\$1,500.00**, as its fair share of stand-by costs for the use of the **City of Keene's ambulance service**.

Article 8: To see if the Town will vote to raise and appropriate the sum of **\$22,000.00** for **Summer and Winter road maintenance**.

Article 9: To see if the Town will vote to raise and appropriate the sum of **\$29,283.27** for **highway construction and reconstruction**. Selectmen's comment: These funds for expenditure are designated to the Town through the Highway Block Grant Fund. The appropriation does not affect the Town's tax rate, but to be properly expended a vote is required.

Article 10: To see if the Town will vote to raise and appropriate the sum of **\$12,105.00** to be paid for **Solid Waste Disposal and Recycling Center privileges** in the town of Marlborough.

Article 11: To see if the Town will vote to raise and appropriate the sum of **\$104.00** for the community participation in the **City of Keene's Household Hazardous Waste Collection Project**.

Article 12: To see if the Town will vote to raise and appropriate the sum of **\$500.00** for **Town Welfare and emergency assistance to the Town Poor**.

Article 13: To see if the Town will vote to raise and appropriate the sum of **\$921.00** to support **Southwestern Community Services, Home Health Care and Community Services, The Community Kitchen INC. and Monadnock Family Mental Health Services**.

Article 14: To see if the Town will vote to raise and appropriate the sum of **\$750.00** for the upkeep of **Cemeteries**.

Article 15: To see if the Town will vote to authorize the Selectmen to **borrow money** in anticipation of taxes and will vote to raise the sum of **\$2,000.00** for interest expense.

Article 16: To see if the Town will vote to raise and appropriate the sum of **\$100.00** for the **contingency fund**.

Article 17: To see if the Town will vote to raise and appropriate the sum of **\$400.00** as the Town's planning expenses and its share of expenses for the operation of **The Southwestern New Hampshire Planning Commission**. These funds may be used for financing the staff, operation expenses, planning, studies, technical assistance and other programs of the commission. These funds may be used in conjunction with other State and Federal Funds available for planning purposes.

Article 18: To see if the Town will vote to raise and appropriate the sum of **\$5,000.00** to be added to the Road Capitol Reserve Fund previously established.

Article 19: To see if the Town will vote to raise and appropriate the sum of **\$1,000.00** to be added to the **Capital Reserve Fund** for the Town Police Cruiser previously established.

Article 20: To see if the Town will vote to raise and appropriate the sum of **\$3,000.00** for the initial **building improvements** to the Town's Meeting Hall and Offices.

Article 21: To see if the Town will vote to raise and appropriate the sum of **\$5,000.00** to be added to the **Capital Reserve Fund** for future **reevaluation** as previously established.

Article 22: To see if the Town will vote to raise and appropriate the sum of **\$7,000.00** to be added to the already established **Road Improvement Capitol Reserve Fund**. This sum is to come from the fund balance (surplus) and no amount is to be raised from taxation.

Article 23: To see if the Town will vote to raise and appropriate the sum of **\$6,900.00** for **repairs to the foundation of the Town Hall**. These monies will come from a settlement with Peerless Insurance Co. and the balance from the building Improvement Fund.

Article 24: To see if the Town will vote to raise and appropriate the sum of **\$3,700.00** for the construction of a Basketball court in the Town Hall Parking lot. **\$2,500.00** of the cost will be provided by a grant from **The Cheshire County Youth Betterment Program**.

Article 25: To see if the Town will vote to raise and appropriate the sum of **\$5,000.00** to establish a **Capitol Reserve Fund for a new Tax Map**.

Article 26: To transact any other business which may come before the said meeting.

The Roxbury Cemeteries

The Roxbury burying ground, originally part of the Breed Batcheller farm, and used for burials as early as 1798, as indicated by head stones. On the incorporation of Roxbury in 1813, Ruth Batcheller sold the plat to the town as "being the land which contains the old burying ground."

Roxbury remains incredibly fortunate to have Steve Yardley as its Cemetary sexton and we thank him for his services. We also thank the group of Roxbury residents who have helped to clear several overgrown areas and pile the resulting brush. The Roxbury cemeteries contain a good deal of "history" and it is our combined responsibility to preserve them in the best possible manner. We need to update our Cemetary Maps and, make certain we have a complete list of all Veterans buried in either cemetary. There are a number of broken headstones and, at some point, it would be nice to consider having them repaired.

Presently, (and primarily due to the abundance of ledge in the area) there appears to be no more room for Vaults in the Roxbury cemetary - which means that anyone wishing to be buried there must be cremated. An up-to-date map will give us an accurate picture of exactly what will be required in the ensuing years.

The Cemetary Trust funds continue to be invested with the Bank of New Hampshire and MBIA - the NH Public Investment Pool. The

combined Kingsbury, Davis (2), Nye, Clark, Eveleth, Phillips and Roxbury Cemetary funds with the Bank of NH, earned \$49.45 in interest during 2001.

The MBIA accounts include the Cemetary Trust and the Robert Pyne Trust. The Cemetary trust earned a total of \$88.00 during 2001 and the Pyne Trust earned \$435.52 during 2001. We suggest \$150.00 "interest" from the Cemetary Trust account be used to supplement the increase in the 2002 cemetary budget request. The usual \$500 appropriation barely covers summer mowing and clean-up and we have reached a point where there are a few additional things that simply need doing. There are four Capital Reserve Funds with MBIA: Police, Roads, Re-Value and Fire, ATV. COMMUNITY FOREST FIRE WARDEN AND STATE FOREST RANGER REPORT

Your local Forest Fire Warden, Fire Department, and the State of New Hampshire Division of Forests and Lands cooperate and coordinate to reduce the risk of wildland fires in New Hampshire. To help us assist you, contact your local Forest Fire Warden or Fire Department to find out if a permit is required before doing ALL outside burning. Fire permits are mandatory for any open burning unless the ground where the burning is to be done (and surrounding areas) is completely covered with snow. Violations of RSA 227-L:17, the fire permit law and the other burning laws of the State of New Hampshire are misdemeanors punishable by fines up to \$2,000 and/or a year in jail. Violators are also liable for all fire suppression costs. Open burning is a privilege, **NOT** a right. Help us to protect you and our forest resource! Build small brush piles that can be quickly burned and extinguished.

New Hampshire experienced over 940 wildland fires in 2001. Most of the fires were human caused. Due to dry conditions fires spread quickly impacting more than 20 structures. Homeowners can help protect their homes by maintaining adequate green space around the house and make sure that the house number is correct and visible. **Only You Can Prevent Wildland Fires.** Contact your local Fire Department or the New Hampshire Division of Forests and Lands website at www.nhdfi.com or call 271-2217 for wildland fire safety information.

ROXBURY POLICE DEPARTMENT TOWN REPORT FOR 2001

The Roxbury Police Department had a pretty good year this year. Complaints were about normal. Patrolling was done off and on, as problems arose. It takes a lot of planning to try to give the best police coverage for the budget that is past at town meeting. Investigation time was down, administration time was up slightly and patrol time was average, along with court time was about the same as last year. As normal automotive complaints were up, with Animal complaints doubled. Again I would request that if you see something suspicious to report it right away, as it may help us with something we are already working on. We are not on patrol on a full time basis, so it's hard to know if there is a problem in your area, unless you report it. Note the following things to report.

CHANGE OF OFFICERS

After 20 years of service with the Roxbury Police Department, I have decided to retire. I have enjoyed serving the towns people. Roxbury is a quiet nice bedroom community. I want to thank all the towns' people for their support over the years, and wish everyone well in the future. The new Chief that is replacing me, GARY LAFRENIERE comes from an extensive background in law enforcement. He has experience working in several small towns and will fit in very well. Earl Nelson has retired after 24 years of service. I personally want to thank him for his wisdom and guidance to me thought the years. And wish him a long and healthily retirement.

The officers work different shifts to allow more coverage day and night to handle calls. To contact an officer call 911 or 352-1100 for emergencies or 352-1291 for non-emergencies. By calling these numbers only will connect you to the dispatch center, which has capabilities of paging the officers as well as calling them on the phone.

SUSPICIOUS VEHICLES

These are vehicles that seem to be hanging around in an area that you don't normally see them in. To properly report this, things to look for.

Color of vehicle

Plate number, state

Number of people in vehicle

Lights out

Loud exhaust

Anything that will help us locate the vehicle, you may not be able to get all this information, however the more information you get the better chance we have to locate the vehicle.

CRUSIER

For those of you that have not heard, We have a new cruiser, a 2000 ford explorer. This vehicle was received by the generous donation from David ford of Keene. This vehicle cost

\$27500. Half the cost was donated by David ford, \$5000 was in capital reserve. The town appropriated about \$4000. This vehicle now is in full service. A new state digital 2 way radio was installed, by a grant from the state (no cost to town). A cage between the front and rear seat was installed for officer's safety. A box in the rear of the vehicle contains fire extinguisher, paperwork, flares, lockout tools, and items needed to investigate an accident. The old blue lights were taken off the truck and placed on the new cruiser. Along with the siren unit. A problem has a rose with the blue lights and they will need replacement this year. Once again this vehicle is a much needed vehicle, as it has 4 wheel drive and allows us to answer complaints in bad weather, especially to those residences that have burglar alarms in summer homes where the driveways are not plowed. As well as accidents on the hilly areas of town.

EQUIPMENT

Some of the items purchased this year were uniforms for the new chief, a cage for the new cruiser, a new fire extinguisher for the cruiser and some updated animal control equipment.

CLOSING

I would again like to thank all the towns' people for their continuing support of the Police Department. Over the years the Police department has grown a little at a time trying to keep up with todays demands. The Department is in good standing and is in compliance with all state standards of the State of New Hampshire at this time.

Pistol permits applications may be picked up at the selectmens office on Monday nights from 7 to 9 PM. The cost of the permit is \$10.00 for 4 years. Please allow 14 days for processing.

Report of the School Board Representative

Monadnock Regional School District
Fiscal Year 2002 – 2003

It is an honor for me, Stephen Mettling, to announce that I have assumed the position of your town school board representative, effective December of last year. My appointment fills the vacancy left by Emily Yardley who gave up her seat for business and personal reasons at that time. I have also committed to running for this post in the upcoming election March 12.

On the assumption that you elect me for the upcoming term, I would like to assure Roxbury residents that they will be capably and conscientiously represented within the Monadnock Regional School District. With thirty years of professional experience in training, education and business, I am confident I can provide strong yet sensible advocacy on your behalf. Philosophically, in a nutshell, we as educators must strive for and achieve educational excellence for our students. However, this goal must be achieved within the constraints of economic realities and limited resources. We all need to get maximum bang for our buck.

Speaking of bucks, some key highlights for the coming year:

I. The 2002-2003 budget

- >> the upcoming budget is \$23,646,826; this is virtually the same as the “default” budget which is last year’s expenditures plus additional expenditures *required* by law.
- >> the MSRSD *cut* \$1.2 million from proposed expenditures for the upcoming year to arrive at its budget.
- >> there are three warrant articles (#2, #3, #4) that call for certain capital reclassifications and investments. These are necessary actions to improve overcrowding and do not affect your school taxes.
- >> there are four warrant articles (#5, #6, #7, #8) that address deficient teacher and staff wages. These call for modest payroll increases (eg. 4% for teachers) that serve to offset large increases in health care costs or, in other instances, to bring existing employees up to the current pay schedule.
- >> in all, the 2002-2003 budget is very tight, reflecting austerity and restraint. They should all be approved by you the voter in the March 12 election!

II. MRSD versus Keene School District Expenditures

To evidence MSRSD’s frugality, the following comparisons can be made with Keene for the upcoming fiscal year:

\$ spent per student

	<u>School Pop.</u>	<u>Op Budget</u>	<u>\$/student</u>
Keene	3928	\$41.244MM	\$10,500
MRSD	2504	\$23,646 MM	\$9,400

To bring our spending per student up to the level of Keene’s, we would have to add \$2.6 million to the budget!

III. Roxbury Expenditures in the MRSD

Roxbury has roughly 34 students in the MRSD (34.3 average daily membership). Its total upcoming tax assessment for this is \$322,360, or ***\$9398 per student***.

The state contributes \$100,992, or ***\$2944 per student***.

As residents we pay a *state school tax rate* of \$5.80 per \$1,000 of equalized assessed valuation for Roxbury, or \$70,576. In addition, to bridge the gap between the total tax assessment, the state's contribution, and the \$5.80 school tax, we pay a *local school tax* of \$150,792. Thus our total tax burden we pay is \$221,368, or ***\$6454 per student***. The local school tax is up 21.18% over last year, owing to a smaller state tax rate and the modest budget increases.

Again, I look forward to serving you in the future as your school board representative. If you have questions or comments, please do not hesitate to call. If I don't have a ready answer, I will get the answer from the board for you.

14. To see if the Town will vote to raise and appropriate the sum of **\$200.00** to support the meals program of **The Community Kitchen, Inc**. Motion carried.
15. To see if the Town will vote to raise and appropriate the sum of **\$175.00** to support the **Southwestern Community Services**. Motion carried.
16. To see if the Town will vote to raise and appropriate the sum of **\$250.00** to support the **Home Health Care & Community Services**. Motion carried.
17. To see if the Town will vote to raise and appropriate the sum of **\$500.00** for upkeep of the **Cemeteries**. Motion carried.
18. To see if the Town will vote to authorize the selectmen to **borrow money** in anticipation of taxes and will vote to raise the sum of **\$2,000.00** for interest expense. Motion carried.
19. To see if the Town will vote to raise and appropriate the sum of **\$100.00** for a **contingency fund**. Motion carried.
20. To see if the Town will vote to raise and appropriate the sum of **\$400.00** as the Town's

planning expenses and it's share of expenses for the operation of **The Southwestern New Hampshire Planning Commission**. These funds may be used for financing the staff, operation expenses, planning, studies, technical assistance and other programs of the commission. These funds may be used in conjunction with other State and Federal Funds available for planning purposes. Motion carried.

Adjacent to Otter Brook Dam Preservation. \$18,970.00 of the amount will come from Road Improvement Capitol Fund and the balance of \$17,050.00 shall come from the funds voted for regular maintenance. Motion carried.
29. To see if the Town will vote a **disabled exemption** for taxes of \$10,000.00 under the provisions or R.S.A. 72:37-B that subject to an income limit of \$15,000.00 per year if single and \$30,000.00 yearly if married, and is not in possession of \$40,000.00 in assets excluding the value of any residential real-estate. Article was amended to read: To see if the Town will vote a **disabled exemption** to reduce property valuation by \$10,000.00 for tax purpose under

the provisions of R.S.A. 72:37-B that subject to an income limit of \$15,000.00 per year if single and \$30,000.00 yearly if married, and is not in possession of \$40,000.00 in assets excluding the value of any residential real-estate. Article passed as amended.

30. To transact any other business which may come before the said meeting.

Health Officer Glen White advised us t pay attention and eliminate any standing water which could serve as a breeding area for mosquitoes carrying the West Nile Virus.

Dick Donohue was recognized for his many years of service to the Town as Fire Chief and Forest Fire Warden.


Glen White was recognized for his many years of service to the Town as Selectman, member of the Planning Board, 20 plus years as School Board Representative and his years of service as Health Officer.
