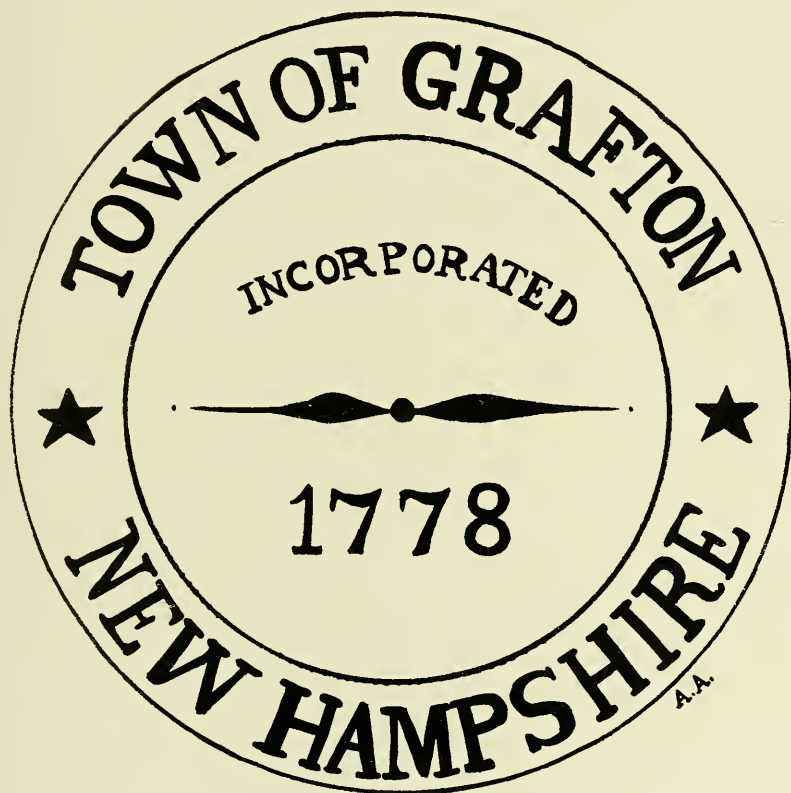

EARLY DAYS OF GRAFTON, NEW HAMPSHIRE

Adapted from a report by Barbara Gove, including information from A. Stuart Gage, F. Jerome Hoyt and Laurence C. Andrew

The Town of Grafton was first granted by charter in 1761 to Ephraim Shearman and others by colonial New Hampshire Governor Benning Wentworth. The governor named both town and county after his aristocratic relation in England, the Duke of Grafton. It was not until 1772, however, that Grafton's first settler, Captain Joseph Hoyt, arrived from Massachusetts. Other families from the Bay Colony's Cheshire County soon joined him. By 1773 there were 107 people (including the town's firstborn Jacob Barney), a grain mill and a saw mill.

On November 11, 1778, the New Hampshire General Assembly approved the incorporation of Grafton after receiving two heartfelt petitions from the town's residents. The first, in 1777, read:

"Hon gentlemen of the general Assembly in the State of New Hamsheir Wee take this poertunty to inform your onners that you Demand More of us than Wee are Able to perform for you Require of us a valiation of our Ratibel Estates Which valiation must Bee taken By our seleckmen Which Your Honners Never Empowred us to Chuse And Wee your huble petitioners Do pray that your honours Will authorize and grant us Liberty to Chuse our Select Men: and incorporate us: and Chuse a gestes of the Pees for us in the town and We take Leave to Nominate Capt. Aaron Barney to be the man: and then Wee Will com in town order: and than We will give onners A true Estamation and one faviour more Wee ask of your honours that is to have A privileges to Leve a Part of our tax upon the Wild and if Your Honners see Cause to Tax us and the Reason ee give for that is this there is Men that has a grade Dele of Land in our town hich Lives out of this state and they Will not Due any Duty on the Rodes Except Wee make their Wild Lands Do it and our Rodes are very bad and Wont a gradel of work Don on them And We pray Honners to take this in to Consideratation...and grant us our Pertision and Put us in order that We may Do our Bisenes in our one town And Where in Wee have mised it Wee Bag that your onners Will Direct us to Do Better for the futer...We Ecknowleg ourselves to Be under the Laws and Derecktions of your Onners, sonomore."

The successful 1778 petition was less humble:

"The Petition of the Freeholders & other inhabitants of the Ton of

Grafton Humbly Sheeth that it is ith the Gratest Grief & Distress of mind that e are Constrained to Lay before your Honours the Deplorable & Shocking Situation of the People of this Ton Paper Currency So amediately Sinking & a Great Scarcity of Cash almost None Surculating in this part of the State that the Like as Never Experienced by a Free People our Taxes are arge & Not money in the town to Discharge one Twentieth Part of the Tax & it Seems at Such an innormous Rate there is Not Money to be had to Pay Even for the Copy of the Rits & if there is Not Something Done we Shall Soon be reduced to a State of abel Begary therefore we Pray your honours to Pass an act to inable the People to Pay there Debts without money for we have Property of your honours would in your wisdom Pass an act that State Securities of any of the four New England States shall be a Tender & Stock & any kind of Marchantable Produce to Dischare Debts in order to Stop Suing or to Pint out Some other Method to Releave your Distesser Subjects."

gradually a sizeable community of settlements grew. By the early nineteenth century there were two meeting houses for public worship, seven grain mills, five saw mills, a bark mill, clothing and carding mills, two pot or pearlash mills, two retail stores, ten school districts, eleven schoolhouses, eight blacksmiths, four joiners, three carpenters, eight cordwainers, a tanner, clothier, saddler, hatter, two coopers and a tinker. East Grafton was the center for various industries, with axes, bobbins, shingles, clapboards, flour, carded wool, lumber, barrels and coffins among the essentials produced there.

The urge to move westward affected Grafton as it did other towns, however, and 136 families emigrated between 1807 and 1823. Later, around 1840, the railroad from Boston to White River Junction came through Grafton, bringing new work and new families. It is said that Daniel Webster, who enjoyed visiting Grafton, arrived on the first train. Less fortunately, Grafton citizen, James Kilton lost money when he contracted to build part of the railroad. Kilton, owner of a saw mill and grist mill powered from Kilton Pond, joined the California gold rush to recoup his losses.

One settlement that flourished from the town's beginning through the nineteenth century was Slab City in southeastern Grafton. Two of the earliest settlers, Joseph Hoyt and Aaron Barney, and their descendants found farming to be good in the

area, also known as Pleasant Valley. Twenty-five families settled there in Grafton's early days. The brook was dammed where it entered the gorge and a mill was built for lumber, shingles and grain. Soon there were at least two stores, a cooper shop, blacksmith, two more mills and a brickyard. Its bricks were used in the schoolhouse built at Slab City in 1848 that also became a social center for that friendly, active area.

These local bricks were also used in the charcoal kilns built near the Depot at Grafton Center, another focus of town activity. There were six or seven of the arch-shaped kilns that were 20 by 30 by 16 feet high. Each held 20 to 30 cords of wood and one was emptied and one filled each day. They had to be closely watched, for if a sudden wind created too much draft a whole kilnful of charcoal could be ruined by burning out of control. In 1890 George Sawing, owner of the kilns as well as of a hotel and sawmill at the Depot, ran for election as town representative to the state legislature. Sawing promoted a barbecue that year that may have been Grafton's greatest occasion. It probably attracted much of the town's population, which peaked at nearly 1300 around that time. A large ox was roasted on the Common and dinner was served to hundreds in the railroad woodsheds. There was a band and a special train brought in guests, including Governor David Goodell of Antrim, the main speaker.

Another important area of Grafton in the early days was Razor Hill, where the Fifth N.H. Turnpike ran long before a road existed along the present Route 4. There were several taverns along the Turnpike and a stable where the stage stopped each day to exchange horse. Grafton's first meeting house was on Razor Hill and its first settled minister, Oliver Williams, was buried in the churchyard in 1790. In 1842 the church was moved to East Grafton by eight teams of oxen. Further west was the Fourth Turnpike which ran south to meet the Kinsman Highway from Wilmot near the Enfield line. In that area was one of Grafton's largest and longest active sawmills, with an annual capacity of one million feet of lumber as well as machinery for planing, matching shingle and lathe.

Also in the western part of town, on Isinglass Mountain is Ruggles Mine, probably the oldest mica mine in the United States. When wily Sam Ruggles discovered mica on his property

in 1803, he promptly set to work to take advantage of the great demand for clear mica sheets for lamps and stoves without letting his neighbors know of his good fortune. He used his big family to dig out the large and heavy "books" of mica. Then he hid the mica under regular farm produce and hauled it at night by ox team to Portsmouth, where he shipped it to England to a relative to market guarding his secret by not selling in this country. The Ruggles family concern was not only material, for when James Kilton sailed for California, he carried a Bible given to him by George Ruggles.

All in all, Grafton's early days and early citizens were a good reflection of New Hampshire life and development.

MASTER PLAN FOR THE TOWN OF GRAFTON, NEW HAMPSHIRE

The Town of Grafton Planning Board presents the following Master Plan pursuant to NHRSA Chapter 36, Sections 13-15.

This Master Plan is intended as a guide for orderly growth in the Town of Grafton, for protection of our natural resources, for promotion of the health and safety of our Townspeople, and for preservation of the present rural character of the Town and any historical landmarks.

A. AIR: Protect and improve when necessary the quality of the air in the Town, paying special attention to the discharge of air pollutants within the Town.

B. WATER: Protect and improve where necessary the quality of the water in the Town, giving special consideration to the discharge of pollutants directly and/or indirectly into the surface and subsurface waters within the Town, bearing in mind that prevention is less costly than cure. Attention should also be given to the establishment and protection of permanent reservoirs and watersheds that could supply the needs of the Town in the future.

C. SOIL: Protect and improve if necessary the quality of the soil in the Town.

D. FORESTRY: Maintain and improve the quality of Town forests and promote a Town Forest Management Program as a source of revenue, as insurance against air pollution and soil erosion, and as preservation of land for recreation.

E. AGRICULTURE: Bearing in mind that Grafton has a history of agriculture, promote and preserve this "industry" as a way of improving and maintaining open spaces and of providing economical benefit to Townspeople.

F. RECREATION AND OPEN SPACE: Provide and maintain where possible adequate and easily accessible recreation/open space facilities and resources for the present and future needs of all Townspeople.

G. OTHER NATURAL RESOURCES: Guard against exploitation of other natural resources that would be inconsistent with any provisions of this document.

H. ENERGY: Research and promote the means of conserving energy by sensibly using our natural resources when - and where ever possible.

I. HISTORIC RESOURCES: Identify, protect and preserve the historic resources of the Town for the appreciation by, education of, and enjoyment of present and future Townspeople.

J. EDUCATION: Provide and maintain whenever possible multi-faceted education for Townspeople of all ages and interests.

K. HOUSING: Provide and maintain health and safety standards for housing in the Town. Promote the means for sufficient spacing to insure privacy and to maintain the rural quality of the Town. Also, guide growth so that it is commensurate with the services needed and so that it guarantees proper spacing between water sources and waste systems.

L. PUBLIC SAFETY: Promote and improve where necessary the means to provide the Town with effective safety and health care at minimal cost to the Town.

M. ROADWAYS: Provide for safe, effective, and practical roadways and guide growth to avoid overtaxing our roadway system. Attempt to keep roads in the Town in line with the scenic beauty and natural resources of the Town.

N. ECONOMICS: Seek ways to relieve the tax burden on our Townspeople and to provide for income to the Town and for possible employment for Townspeople.

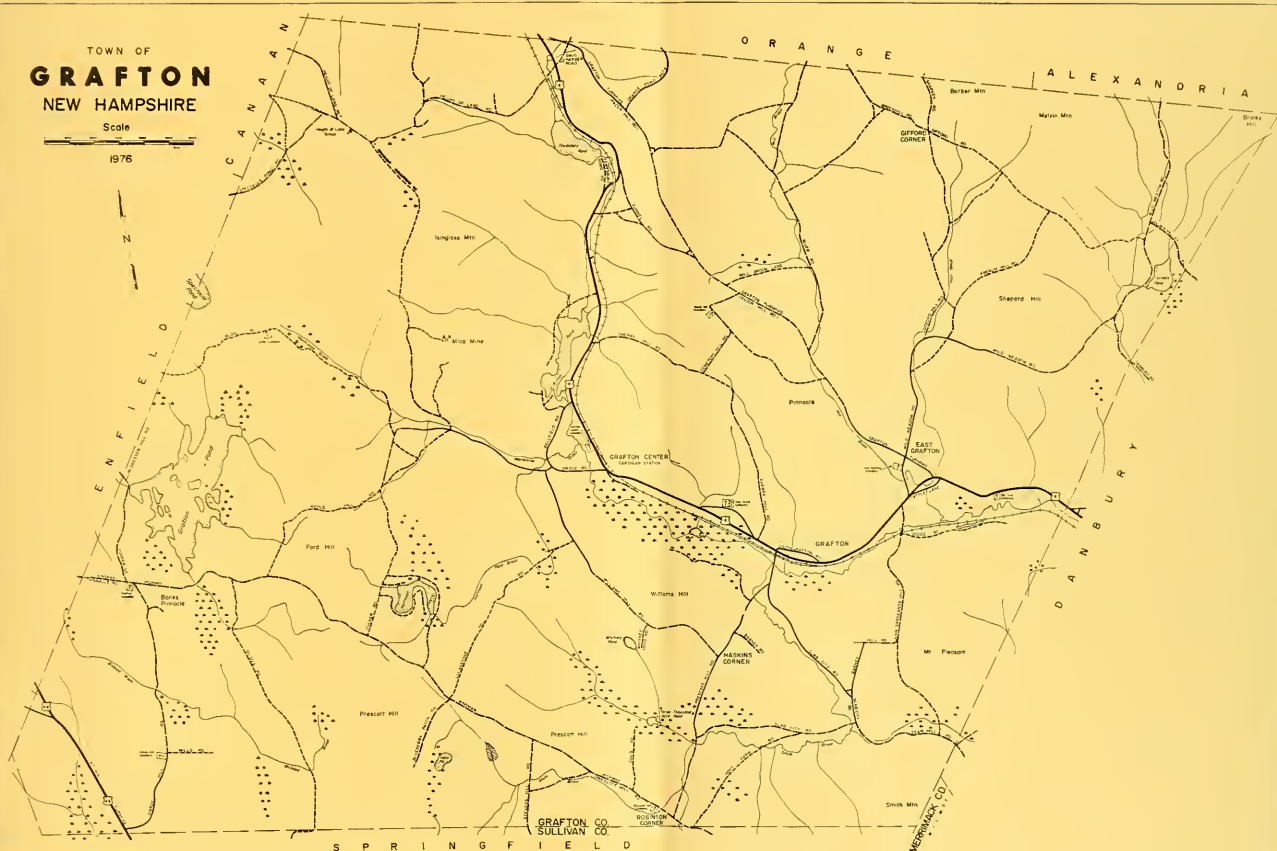
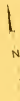
O. WASTES: Encourage the solution for disposal of different types of waste and provide whenever possible the means for maintaining proper health and safety standards. Encourage recycling.

**WARRANT FOR THE TOWN OF GRAFTON
THE STATE OF NEW HAMPSHIRE**

THE POLLS WILL BE OPEN FROM 1 p.m. to 6 p.m.

To the Inhabitants of the Town of Grafton in the County of Grafton in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at the Town Hall in Said Grafton on Tuesday, the fourteenth day of March next, at 1:00 of the clock in the afternoon, to act upon the following subjects:

1. To choose all necessary Town Officers for the year ensuing.

The business meeting to act on the remaining articles in the 1978 town warrant will begin at 8:00 p.m. at the Grafton Town Hall.

2. To see if the town will vote to hear a report of the Budget Committee and to act thereon.

3. To raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriations of the same.

4. To see if the town will vote to authorize the selectmen to borrow in anticipation of tax revenue.

5. To see if the town will vote to authorize the selectmen to convey by quitclaim deed all property acquired by tax deed or to take any other action pertaining thereto.

6. To see if the town will vote to raise and appropriate the sum of one thousand one hundred fifty-two and 52/100 dollars (\$1,152.52) and thereby receive seven thousand six hundred eighty-three and 45/100 dollars (\$7,683.45) from the state for town road aid.

7. To see if the town will vote to authorize the expenditure of monies in the Dump Fund as set up and approved in Article 4 in the Warrant of the March 2, 1976 Town Meeting.

[The purpose of this fund (1978 total will be \$3,000.00 plus

interest) and the Landfill Fund (see Warrant Article 8-b following) are the same, to help solve the waste disposal problem. Federal and State law mandates that our open burning dump be closed. We currently have an extension to September 1978 to solve the problem. This is our last extension.]

8-a. To see if the town will vote to authorize the expenditure of 1977 Revenue Sharing Funds (part of E.P. #7 and E.P. #8 which is \$8,521.00 plus interest of \$324.25) as voted and approved at the March 8, 1977 town meeting and here included in the 1978 budget appropriation.

8-b. To see if the town will vote to appropriate and authorize withdrawal from Revenue Sharing Fund established under the provisions of the State and Local Assistance Act of 1972 for use as setoffs against budget appropriations or other purposes, and authorize the expenditure of these funds by the selectmen as detailed below and appropriated in the 1978 budget; and to further authorize the selectmen to make pro rata reductions in the amount if estimated entitlements (\$9,639.00 for E.P. #9) are reduced, or take any other action thereon:

1) Town Hall Fund for town office addition, new Hall entrance, possible improvement of parking area, possible roof repair.	\$5,000.00
2) Dump Fund (previously called Landfill Fund) for purchase of land or other use to solve the waste disposal problem. [This \$4,000.00 plus the \$2,500.00 from last year plus the \$3,000.00 in the basic Dump Fund will give us a 1978 total available fund of \$9,500.00.]	4,000.00
3) Purchase of office equipment	639.00
Total	<u>9,639.00</u>

9. To see if the town will vote to allow monies accumulated through rental of town highway equipment and monies presently in the Highway Equipment Fund to be used for purchase of highway equipment by the Road Agent with the consent of the Selectmen.

10. To see if the town will vote to appropriate the sum of \$346.00 to be give to the Upper Valley Senior Citizens Center to help partially defray program costs.

[See the Senior Citizens Center report later in this issue.]

11. To see if the town will vote to adopt the provisions for new Elderly Exemption Law (RSA 72:43-b and 43-c) which provides for expanded exemptions in real estate for a resident 65 years of age up to 75, a \$5,000.00 exemption; a resident 75 years of age to 80, a \$10,000 exemption; a resident 80 years of age or older, a \$20,000 exemption, provided that the resident owns the real estate individually, or jointly with another, or his spouse with whom he has been living for at least 5 years as man and wife; said resident had a net income of less than \$7,000.00 or a combined income with spouse of less than \$9,000.00; and owns assets of any kind, tangible or intangible, less bona fide encumbrances, not in excess of \$50,000.00.

12. To see if the town will vote to appropriate \$650.00 to be expended as salary and expenses for additional police officer(s). (RSA-105:1)

13. To see if the town will vote to appropriate \$500.00 to be used to relocate and preserve the Blackman memorial stone found (1976) on the Old Danbury Road, these monies to be placed in an Historic Fund if not expended during 1978.

14. To see if the town will vote to exempt itself from the provisions of RSA 55-9-a and 55-9-b which would authorize the Town Clerk to consider applications for additions to the voter checklist.

(Approval of this article means that applications for voters consideration would be handled by the Supervisors of the Checklist as in the past.)

15. To see if the town will vote to appropriate and authorize the expenditure of \$120.00 to cover membership fee for the Dartmouth-Lake Sunapee Region Association.

This association promotes tourism which results in financial benefit to Grafton. For example, increased tourist or other use of restaurants and motels in this area increases the

total size of the Rooms and Meals Tax, and thereby the percentage that Grafton receives, based on its population.

16. To see if the town will vote to appropriate and expend the sum of \$800.00 to cover the insurance for the new ambulance.

REPORT OF TRUSTEES OF TRUST FUNDS FOR 1977

1977 was an active year in trust funds activity.

Ruth Leonard gave \$2,000.00 to set up a new fund for the town library, the income to be used annually to purchase new books.

Convinced that the Grafton Volunteer Ambulance Service badly needed a new vehicle to continue its vital contribution and urged by the State of New Hampshire to spend additional income from the Volana Kilton Doctor Fund, the trustees contributed \$20,000.00 of income from the Fund toward the purchase of a new, more efficient ambulance. With the aim of supporting health services for all age and income groups, the trustees also continued the \$10 per resident reimbursement program as well as payment to the Town for its per capita support of the Mascoma Area Health Council.

Income from purchase of lots in Pine Grove Cemetery increased during 1977, making possible investment in another certificate of deposit which provides a higher rate of income than a savings account. The trustees now have nearly all cemetery funds invested at maximum rates in the hope of reducing the Town's outlay of tax money for cemetery care.

SELECTMEN'S REPORT

1977 turned out about as we had hoped. We made progress on some of our problems. Despite higher school and county taxes we kept our total tax down, but this must change. The pressures from outside the town are growing. Federal and State actions require more and more from the cities and towns. New Hampshire ranks last in state support for public education, putting a large burden on the municipalities. The school budget is ever-increasing and Grafton's cost rises with it, as do town expenses. Grafton, like other towns, depends to a great extent on the property tax for revenues to cover our costs. From a total tax point of view, Grafton seems to compare favorably with other towns in the area and ranks about in the middle in the state.

One of our pressing problems still is solid waste disposal. We obtained another extension allowing the use of the dump until September 1978. We have been told that this has to be the last extension and seeing other towns' experiences we believe it. The establishment of a landfill still appears our best and cheapest solution. This requires land that satisfies federal requirements and local desires. We are now looking for suitable land that the town can afford.

A positive step has been the preparation by the Planning Board of the Master Plan which appears in this report. While this document is very general in its terms and can be changed according to town needs, it is basic to future town planning. Land sales are increasing in town as is building. The interest of all Grafton residents will be best served by some well considered guidelines for whatever development may be in the offing, following the thoughts expressed in the Master Plan.

Our tax mapping project, mandated by the State, is proceeding according to schedule. Planning Maps, Inc. reports that all property owners have been contacted and requested to help with information about their land. The company has developed preliminary maps and page layouts, and has compiled a master list of all owners. It is now cataloguing all data received. In the next year, the company will be doing final research, measuring the roads in town, and making base maps in

preparation for compiling. If you have not responded to their questionnaire, it is not too late to do so. We can forward your replies to the mapping company, or you may send it directly to them. All information you can provide will be useful and appreciated since it will result in more accurate maps.

Another happy note is the report that Grafton's pine forests are considered to be in good condition. The New Hampshire Division of Forests and Lands has advised that it examined 850 acres in Grafton in 1977 for white pine blister rust. Their survey revealed no serious problem.

We would like to call attention to the fact that November 1978 marks Grafton's own bicentennial, completing 200 years of incorporation. A description of the "Early Days of Grafton, New Hampshire" appears in this report and is certainly of interest to all. Perhaps some group in town would be interested in organizing a celebration of the event. Also in the interest of preserving the town's past, attention is called to the "Blackman Stone" warrant article, and the need for practical means for removing the engraving to a safe location.

Grafton perhaps should establish its own historic committee. There is a wealth of information available and certainly worth collecting and establishing in a manner and location easily available to any interested person. There are numerous sources of historic interest items in Grafton — small, old mines for mineral examples, old cellar holes, walls of abandoned buildings, old town documents, the thoughts and memories in the minds of friends and relatives.

It may also be timely to suggest the re-organization of a civic association. For one thing, it is a means of communication, a way of getting the word about on any topic of interest. It can be a very useful center for discussion of town needs, a way of bringing them to the attention of those concerned. With our civic life being made more complicated with more problems facing the town, a civic association can be a focal point for ideas and solutions.

Finally, we want to thank all the town officers for their real dedication and cooperation. Last year was most successful in that regard. We specifically express the appreciation of the town to John O'Brien for his hard work during his three year tour as Grafton's representative on the Mascoma Regional School Board.

REPORT OF DISTRICT FIRE CHIEF AND TOWN FOREST FIRE WARDEN

Forest fire control in New Hampshire is a joint state and town/city responsibility (RSA 224).

The Director, Division of Forests and Lands (State Forester) appoints a forest fire warden and several deputy forest fire wardens in each town/city upon the recommendation of local authorities.

The local forest fire warden is responsible for forest fire prevention and suppression activities in his town. He regulates the kindling of outside fires when the ground is not covered with snow by the issuance of written permits only when conditions are safe. He is responsible for suppression with the town/city and state sharing cost. Suppression costs in excess of 1/4 of 1% of the assessed valuation of the town are assumed by the state.

The state provides training for the local fire organization and helps coordinate activities between towns/cities. The state also supports local forces with backup personnel, equipment and supplies for suppression and prevention.

This combination of state and local cooperation, started in 1893, works well, for New Hampshire has enjoyed one of the smallest acreage losses due to forest fires in the United States for the past 25 years.

Some members made a quantity of lovely ceramics in 1976 commemorating our Country's Bi-Centennial as observed in Grafton. The Club purchased the material and all work was donated in making these attractive pieces. All above mentioned items were available in our booth, together with white elephant items donated by you.

Since 1973 we have donated approximately \$2,100.00 to the Fire Dept. for purchase of a resuscitator, a special radio for the fire truck, special type nozzle, chrome plate for truck, emblems for all trucks, tot-finders for distribution, thermos jugs to be used for drinks on fires, outright gifts amounting to \$300.00 to be used as needed. In addition we also gave \$273.22 to the Ambulance. This coming year we hope to be able to furnish outfits for some of the firemen consisting of coats, boots and helmets.

Without the help and support of all you good people in Grafton and some of our good friends in Orange and Canaan, all this would be impossible. We want to take this opportunity to thank everyone who participated in these fund raising efforts. We welcome all interested women to join our group.

1977 — MASCOMA AREA HEALTH COUNCIL TOWN REPORTS OF ENFIELD, CANAAN, GRAFTON DORCHESTER AND ORANGE

The Health Council is entering its ninth year of service to towns in the Mascoma area. In 1977 the office was moved from the high school to Whitney Hall in Enfield. The telephone number remains the same: 632-7234.

The existence of the Mascoma Area Health Council continues to attract state funds for the free children's health and dental programs, as well as assistance with Adult Health Screening. Eighty (80) Mascoma children were given vision and hearing tests before entering the Canaan and Enfield Elementary Schools in the fall. Federal assistance is often available to Grafton people for nursing, physical therapy and home health aide services provided in the home. All programs are available to anyone in Grafton regardless of their ability to pay.

SUPERVISORS OF CHECKLIST REPORT

1977 was a quiet year as far as elections were concerned. Voting was on a local level with people casting ballots on Town Meeting Day and School Meeting.

New laws have been passed in Concord this past year concerning the registering of new people for voting. Listed below are the guidelines used by the Supervisors.

1. When determining the qualifications of an applicant under the provisions hereof, the supervisors may require said applicant to present the following:

- a. His birth certificate
- b. His naturalization papers if he is a naturalized citizen
- c. Proof of residency in the form of an affidavit declaring that the applicant is an inhabitant of and dwells in the town, city, or ward in which he desires to vote and
- d. Any other evidence they may request.

2. The supervisors may refuse to add the name of an applicant to the checklist if he fails to present the evidence required by this section.

REPORT OF THE GRAFTON PLANNING BOARD
January 1978

At the beginning of the year, the Planning Board embarked on a more complete Master Plan for the Town of Grafton. The first step toward this was the formation of a questionnaire to help us determine the wishes of the Townspeople. We presented the first draft of the questionnaire at our Open Meeting at the beginning of the summer and subsequently went on a door-to-door campaign with the final draft. At our Open Meeting, the tabulations were presented and general comments heard. In December, we presented the Master Plan which appears in its adopted form in this Town Report.

Among the many other topics discussed at the Open Meetings were: minimum road frontage, enforcement of laws and possible fines, subdivision regulations designed to protect the town against potential outside developers, recreation, and taxes. Out of discussions on this last subject came the formation of the Tax Study Committee consisting of five residents and two non-residents who have periodically presented their findings at the Open Meetings.

In the course of our regular meetings, we approved 6 subdivisions and 6 transfers; modified and approved 1 subdivision; and rejected none of the items presented to us.

The Financial Report follows, including an anonymous donation earmarked for the Tax Study Committee.
