

TOWN WARRANT THE STATE OF NEW HAMPSHIRE

To the inhabitants of the Town of Hebron, in the County of Grafton, in the State of New Hampshire, you qualified to vote in Town Affairs:

You are hereby notified to meet at the Community Hall in said Hebron on Tuesday, the eleventh (11) day of March, next, at five o'clock in the afternoon to act upon the following subjects:

1. To choose all necessary Town Officers for the year ensuing. Polls will be open from 5 to 9 p. m. The business meeting will open at 7:00 p. m. A "pot luck" supper will be served at 5:30 p. m. for those who wish it.

2. To hear the reports of any standing and/or other committees.

3. To see if the Town will authorize the Selectmen to borrow money in anticipation of taxes.

4. To see if the Town will vote to allow two percent cash discount on property taxes if paid within thirty days from the date of the tax bill.

5. To see if the Town will vote to raise such sums of money as may be necessary to defray the Town charges for the ensuing year and make appropriations for the same.

6. To see if the Town will authorize the Selectmen to accept from Raymond Davis and Bruce Barnard, on behalf of the Town, a warranty deed described as a road and turn around on their property on Cooper Road.

7. To see if the Town will vote to authorize withdrawal of \$4080.00 from the Revenue Sharing Fund established under the provisions of the State and Local Assistance Act of 1972, for use as an offset against the 1977 Fire Truck note.

8. To see if the Town will vote to create a capital reserve fund for the purpose of defraying capital expenditures of the Fire Department and to appoint the Selectmen to carry out the administration of this fund and to make expenditures from it.

9. To see if the Town will vote to create a capital reserve fund for the purpose of defraying future road and bridge building/rebuilding

expenditures and to appoint the Selectmen to carry out the administration of this fund and to make expenditures from it.

10. To see if the Town will vote to adopt the provisions of RSA 72:62 for a property tax exemption on real property equipped with solar energy heating systems, which exemption shall be in an amount equal to the assessed value of the solar heating system.

11. To transact any other business which may legally come before said meeting.

HEBRON POLICE DEPARTMENT REPORT 1979

We are pleased to report that our accident rate decreased; from eleven in 1978 to six in 1979. This is in sharp contrast to the State rate which rose. Best of all, we recorded no personal injury; but we hasten to add that we have observed several near accidents, and that a high percentage of the drivers live in or near Hebron and are familiar with our roads. We note that our traffic count was down during the first part of the summer but increased during the latter part. Our court cases increased this year, covering a wider range of violations, and our conviction rate remains excellent. We continue to see speed as a major highway concern: we used two radar units this year, a stationary type and a moving type. Both are FCC licensed and checked frequently for accuracy. While Hebron remains more liberal than some surrounding towns regarding strict speed enforcement, we expect more pressure at both the State and Federal levels as a condition for receiving highway funds. We note that radar is a tool which must be properly used, and that while its' use was ruled against in a highly-publicized case in a particular application in Florida, its' use has since been upheld in several other states in their application.

We continue to be very concerned about homes which are unoccupied even for short periods of time. Along with having someone periodically check your property, we encourage fire, freeze and intrusion alarm systems, and the use of a "house-sitter" while you are away. We suggest marking your valuables for rapid identification, and we can arrange to loan you the tools to do this. In addition, we are glad to make specific suggestions toward making your home and property more secure. The number of court cases and convictions regarding breaks was good in 1979, but we'd like to see an improvement both in the prevention and solution of these.

We are concerned about the sharp increase in wanton vandalism in Hebron and surrounding areas. Vandalism frequently occurs from an age group below that of majority (under 18) - an area which neither the courts nor the police can deal with effectively, partly because of the offender's age and also partly because some are not New Hampshire residents. In addition, our geographic area has no intermediate program (court diversion program) at present - the Youth Development Center usually is not the place for a young first offender, with an equally poor option of returning the offender to his home with no action taken. On a more positive note, it is now possible under some circumstances to recover damages from the offender's parents.

Our calls in 1979 were substantially higher - a jump of 35%, coming primarily during the summer months. We see this as a signal of what we should expect in the future, and we continue to encourage folks to report all incidents. We had several instances this year where small bits of seemingly unimportant information contributed toward the resolution of a problem. We depend heavily on the information you provide.

As mandated by the State Legislature, you will be asked on your ballot to express your thoughts regarding a local leash ordinance. Hebron presently has none of its' own, but relies on a loose State statute which we feel does not deal adequately with those owners who habitually fail in their responsibility to keep their animals from running at large, or in those instances where a dog is thought to be ugly or vicious, as was demonstrated in a nearby town last fall. We do believe that a local ordinance would help our animal officer, Mary Lou Stancil, in these situations, but still allow flexibility in those occasional and unintentional cases where a dog does get away.

Hebron officers meet and exceed both the present and proposed standards for part time officers. They continue to take police-related courses during the winter, and rank very favorably with their full time counterparts. Tom Smith, Tim Keefe, Jerry Bilodeau, and Mary Lou Stancil have done an exceptional job this year, putting in a great deal of time, often at inconvenient times and with little or no notice. I'm proud of them, and appreciate their assistance to me and Hebron.

HEBRON FIRE DEPARTMENT ANNUAL REPORT For 1979

During 1979 the Hebron Fire Department responded to 32 calls. Of those 8 were classified as rescues. In these cases fire was not directly involved, but rather they were accidents or medical emergencies. Perhaps our most difficult rescue was of the man who fell off of the bridge at Sculptured Rocks. He sustained multiple injuries and required over an hour to treat the injuries and bring him up safely to the waiting ambulance.

All this goes to show that as "orange juice isn't just for breakfast anymore," so the fire department isn't just for fires anymore. We are handling a variety of emergencies and with our increased skills are handling them effectively.

During the year, members of our department, in addition to our own training program, attended the annual Twin Rivers Fire School sponsored by the towns of the Twin Rvers Mutual Aid association of which Hebron is a member (total membership is 19 departments). Our roster presently stands at 20, 6 officers and 14 firefighters. With several of these usually in town during the day, and several others working second shift, we are in good position for adequate response any hour of the day.

This past year our major expenditure was for a new F. M. communications system including base station, 3 mobiles and 2 portables (4 other mobiles are privately owned by members of the department). This change over was necessary because our old A. M. system was obsolete, no one manufactures the equipment any more, and the surrounding towns had already changed over, so that we couldn't communicate with them any longer. All this was made possible by using the money Groton pays for fire protection, the proceeds from the sale of the 1941 Chevy and some of our operating budget. The total cost was about \$3,000.

The department also received a number of donations from firefighters turning in their pay checks to the Improvement Fund and from citizens in town. We wish to express our special thanks to Sid and Florence Thompson for their gift of a new resuscitator. It is carried on board Engine 2 along with our other first aid equipment.

As we look toward 1980 we will be applying for matching federal funds probably to purchase tone-activated home radio receivers for the firefighters in order to upgrade our alerting capability. However, our chances for receiving these funds are slim. We are also beginning to plan for an ice rescue capability in the event of accidents on the lake. At present no such specific capability exists on Newfound.

Finally, let me remind you that the department is always ready to give advice on and inspect wood stove installations. Feel free to call the business number 744-5584 if you have any questions. Our emergency number is, as always, 744-2277.

\$ 339.94 Respectfully submitted, PAUL C. WHITE, Treasurer 1979 was an active year for the Board. William J. Crane was reappointed to the Board for a four year term and reelected chairman, Norman W. Sanborn was reelected vice chairman and Suzanne Sheehan was elected secretary. Josie Gemmill, secretary from 1976 to 1979, resigned in July, prior to residence in Concord. Mary G. Haselton, appointed an alternate in April, was appointed a member to serve the unexpired term. Peter Fortescue served as representative of the Selectmen. Alan Barnard was appointed an alternate in April.

The Board recommended to the annual 1979 Town Meeting the adoption of an updated and liberalized revision of Article IV:D. Signs of the Zoning Ordinance and an amendment in regard to the number of nominees submitted for appointment to the Board of Adjustment which were accepted. Two subdivisions were approved which contained ten lots. Five permits for private driveway entrances on Town highways were granted.

On the agenda for 1980: 1) the adoption of amendments to update the Subdivision Regulations and comply with new 1979 Statutes, 2) the development of a Master Plan which, briefly stated, provides guidelines for the future growth of the Town. The Plan is required by State Statute and its importance was emphasized in the recent court decision of Beck vs. Town of Raymond, and 3) drafting an amendment to the Zoning Ordinance which states the conditions for the granting of a special exception by the Board of Adjustment for planned unit, cluster housing and condominium developments.

The Board appreciates the cooperation of all persons involved in the implementation of the Regulations during the past year. Hebron is a GREAT little Town. - let's keep it that way!

REPORT OF FOREST FIRE WARDEN AND STATE FOREST FIRE SERVICE

Prevention and control of forest fires is handled through a cooperative effort between town/city fire organizations and the State Forest Fire Service.

Since 1903, when the first forest fire laws were passed by our Legislature, the State Forester has appointed someone in each municipality as a Forest Fire Warden and charged him with the responsibility of forest fire prevention and control within his town/city. This person may ask the State Forester to appoint as many Deputy Forest Fire Wardens as may be necessary to efficiently carry out his charge.

The State Forester has divided the State into ten forest fire districts with a full time District Forest Fire Chief in each district. The State organization is charged with assisting the municiple forest fire organization in any way possible.

State personnel conduct fire training schools, assist with forest fire suppression, fire cause investigation, prosecution of fire law violators and forest fire prevention programs. Forest fire suppression equipment is purchased through State bulk purchasing ability and sold to local forest fire organizations at one-half cost. Excess military property is obtained and turned over to town/city fire departments at no cost to local departments for conversion into fire suppression units. This cooperative arrangement between State and municipality has resulted in one of the best forest fire records in the United States with less than one-half acre of woodland burned in each fire reported.

To the Citizens of Grafton County:

In an effort to communicate more directly with the taxpaying citizens of Grafton County, we, the Grafton County Commissioners, are writing to you through your individual town or municipal reports.

Last year (1978-79) the total county tax raised was \$1,977,142. These monies were appropriated by the County Delegation and administered by the Commissioners. Some of the ways this money was spent was in maintenance of our courthouse, nursing home, county farm, sheriff's department, jail and house of correction, social welfare, etc.

The average number of patients in our nursing home is 140. The average daily census of the Jail/House of Correction is 25. We had a total of 349 inmates in the Jail and 114 inmates in the House of Correction during our fiscal year.

In addition to providing food for the nursing home complex and agricultural services for the community, the farm also continually shows a profit. In our fiscal year 1979 the farm profit was \$60,654, due in part to sales of pigs at \$5,500, cows at \$27,000, wood at \$1,800, hay at \$2,100, milk at \$135,444 and produce at \$48,129.

We have completed Phase 11-Design of the sewage project and anticipate beginning construction under Phase 111 in the spring. The total overall cost of the project is approximately \$540,000, of which \$400,000 is federal grant, \$110,000 State share and \$30,000 County share.

We are making an effort to conserve energy, particularly in the courthouse building, and are taking a hard look at any modifications in this so called "modern" facility that will make it a less expensive consumer of fuel.

A trial dispatching service was instituted for 16 area fire departments and probably will be make a permanent function during the latter part of 1979. A yearly fee is charged for this service.

Grafton County employs 230 people of whom we are very proud. It is because of these people that Grafton County continues to operate efficiently and within budget.

There are many other concerns that we, the Commissioners, deal with. We invite the citizens of Grafton County to take part in any of our regular meetings held each Monday morning at the courthouse in North Haverhill.
