Warrant for the Annual Town Meeting March 10, 1942**THE STATE OF NEW HAMPSHIRE**

To the inhabitants of the Town of Tuftonboro in the County of Carroll in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at the Town Hall in said Tuftonboro on Tuesday, the tenth day of March, next, at nine of the clock in the forenoon, to act upon the following subjects:

1. To choose all necessary Town Officers for the year ensuing.

2. To raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriations of the same. (\$10,413.50) figures of the Budget Committee.

3. To see if the Town will vote to raise and appropriate the sum of one thousand nine hundred and fifty dollars (\$1,950), the State to raise a like amount for State Aid Construction on the Ledge Hill Road.

4. To see if the Town will vote to raise and appropriate the sum of four thousand dollars (\$4,000) for tarring Town roads.

5. To see if the Town will vote to raise and appropriate the sum of one hundred thirty dollars (\$130) to the Lakes Region Association of New Hampshire.

6. To see if the Town will vote to raise and appropriate the sum of six hundred dollars (\$600) for repairing the Basin Bridge, so-called.

7. To see if the Town will vote to authorize the Selectmen to borrow money in anticipation of taxes of the levy of 1942.

8. To transact any other business that may legally come before said meeting.
