To the inhabitants of the Town of Sutton, in the County of Merrimack, in said State, qualified to vote in town affairs:

You are hereby notified to meet at Pillsbury Memorial Hall, in said Sutton, on Tuesday, the tenth day of March next, at ten of the clock in the forenoon, to act upon the following subjects:

1. To choose all necessary town officers for the year ensuing.
2. To raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriation of the same.
3. To see how much money the town will vote to raise and appropriate for the repair of highways and bridges.
4. To see if the town will vote to accept State Aid and raise and appropriate money for the same.
5. To see how much money the town will vote to raise and appropriate for the maintenance of state highways.
6. To see how much money the town will vote to raise and appropriate for street lighting.
7. To see how much money the town will vote to raise and appropriate for Old Home Day.
8. To see if the town will vote to raise and appropriate a sum of money for the control of White Pine Blister.



9. To see what action the town will take in regard to reducing the town debt and raise and appropriate money for the same.

10. To see if the town will vote to install an electric light at the east entrance to Wadleigh Park.

11. To see how much money the town will vote to raise and appropriate for Memorial Day celebration.

12. To see what action the town will vote to take in regard to disposing of the snow rollers.

13. To see what action the town will vote to take in regard to disposing of the East Sutton school house.

14. To see if the town will vote to accept the bequests under the will of the late Christina L. Eaton.

15. To see if the town will vote to accept the bequest under the will of the late Matthew Harvey Kohlrausch.

16. To transact any other business that may legally come before said meeting.

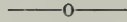
