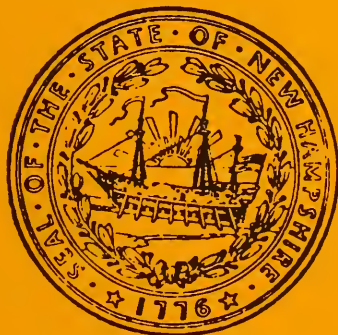

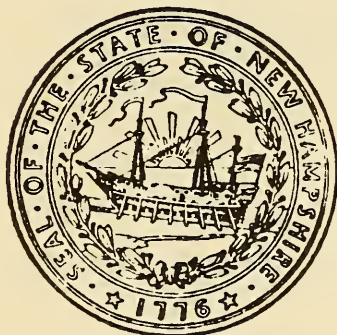

THE STATE OF NEW HAMPSHIRE**

To the inhabitants of the Town of Hebron, in Grafton County, in the State of New Hampshire, you qualified to vote in Town affairs:

You are hereby notified to meet at the Community Hall in Hebron on Tuesday, the ninth day of March next, at five o'clock in the afternoon to act upon the following subjects:

1. To choose all necessary Town Officers for the ensuing year. The polls will open at five PM and close at nine PM with the business meeting commencing at seven PM. The Kindergarten Committee will prepare and serve a roast beef dinner and would appreciate advance reservations. Please contact Sherry Pessari.

2. To hear the reports of any committee.

3. To see if the Town will authorize the Selectmen to borrow money in anticipation of taxes.

4. To see if the Town will vote to allow two percent cash discount on property taxes if paid within thirty days from the date of the tax bill.

5. To see if the Town will vote to increase the Town Officers' salaries as follows:

6. To see if the Town will vote to appropriate \$3,000 to complete the purchase of a 1959 GMC Fire Truck, \$2,000 to be paid to the Town of Bristol and \$1,000 to reimburse the Fire Department Improvement Fund, and authorize the withdrawal of this amount from the Federal Revenue Sharing Fund.

7. To see if the Town will vote to raise and appropriate such sums of money as may be necessary to defray Town charges for the ensuing year.

8. Shall the citizens of Hebron ask members of the New Hampshire Congressional delegation to support or co-sponsor a resolution in the U. S. Congress to:

Request the President of the United States to propose to the Soviet Union that the United States and the Soviet Union adopt a mutual freeze on the testing, production, and deployment of nuclear weapons and of missiles and new aircraft designed primarily to deliver nuclear weapons, with verification safeguards satisfactory to both countries. (By Petition)

9. To transact any other business which may legally come before it.

## **REPORT OF THE HEBRON LIBRARY 1981**

Last year the Hebron Libray tried to meet the needs of the people of Hebron by getting out of the building to bring the Library to the community. In 1981, the community came into the Libray to improve the services the Library could provide.

Beginning early in the year, the Library Trustees and other interested people formulated plans to move the Libray to the Grange Hall from the old school building where there were concerns about the safety of the floor and of accessibility. At Town Meeting, the voters approved the plans, and, almost immediately, John Matthews and George Merrill started making the building energy efficient and attractive. Ed Gempka did the rewiring and the Ramsays did the finishing of the shelves.

On August 20th, the work of moving the stove, furniture, free standing bookcases and over 5,000 books was started. More than 100 people of all ages volunteered to help with the move, and, by August 22nd, we were in the new Library with all of the books on the shelves in order! The first official Library patron was Isobel Blodgett, the former Librarian.

Since then, community interest has not diminished. We have received gifts of money, the antique sofa and rocking chair have been redone, the rugs cleaned, curtains purchased and rehung, and the woodstove set up and operable. We have been given several gifts of books and a display of antique toys was loaned to us for the holidays. The Library thanks the individuals who donated their money and time to make these things possible.

We have seen a great increase in the number of people using the Library this year. More people are coming into the new building, we have set up a "branch" Library at the Church, and collections of books are loaned to the Kindergarten and Nursery School. The children from the elementary school come once a week to take out books. We have made extensive use of the State Library to supplement our collection and have tried to purchase books that will make a lasting contribution to our library with money from the town. We had two film programs last spring; one an evening of comedy movies, and the other a popular program on gardening with a movie about Ruth Stout followed by a lively discussion of gardening techniques.

Our plans for 1982 include film programs for children on Saturday afternoons, adult films once a month, and special programs and exhibits at the Library. Now that we have room for displays, we hope people let us know if they have collections we can "show off". We also look forward to having groups use the facilities.

The people of Hebron should be proud of the time, effort, and money spent for the Library. It is a community endeavor that is truly an asset to our town.

## HEBRON FIRE DEPARTMENT ANNUAL REPORT—1981

During the year of 1981 the Hebron Fire Department responded to a total of 29 calls, 7 of which were medical emergencies. This is down from our average of 40. For the first time in many years we had no major structure fires, and of particular interest was the decline of woodstove related fires. This is significant in view of the fact that wood burning continues to increase. The explanation for this, I believe, is that people are becoming more careful in installing and maintaining their stoves and chimneys.

In 1981 a Rescue Squad was established as part of the Fire Department for responding to the increasing number of calls for medical emergencies. The squad is made up of specially trained members of the department. The concept behind the formation of the squad is that members who are in town can respond to an emergency and take immediate action to stabilize a victim while the ambulance is enroute from Bristol. With a response time to the scene of only several minutes versus 15 - 20 minutes for the ambulance those precious minutes, in some cases, could mean the difference between life and death. The Rescue Squad can be called by using the Fire Department number 744-2277.

In terms of fire suppression capability, the department took a major step forward in purchasing a used engine from the town of Bristol. This engine replaces the truck we had in the East Hebron Station, a truck which had very limited capability (all it had was a portable pump on the back step.) The new engine (a 1959 Seagrave) has a 500 gpm. mid-ship pump and 500 gallon tank. The engine is fully equipped except for hose. Our department lacks the hose it should have, a condition we hope to correct in 1982.

In 1981 we continued to improve our alerting capability. We were able to purchase 8 home radio receivers for the firefighters. Six were purchased out of the department's own funds costing \$1,170. and 2 were bought from our budget for \$436. We would like to buy 2 more during 1982 giving us a total of 20.

One of the most difficult things for fire departments to cope with is the escalating cost of equipment. It now costs \$430. to outfit a firefighter as compared to \$395. last year. Other costs are even more incredible: 2½" nozzle - \$663.50, 1½" nozzle - \$365.75, 50 ft. length of 2½" hose (the kind we use for attack line) \$244! It seems that every couple of months costs go up another 10%. Fire protection is not inexpensive.

We have come a long way in the past 5 years, and we have spent

the money you have given us wisely. With your continued support, we hope to be able to keep improving our tradition of service to this community.
