## TENTATIVE WARRANT

To the inhabitants of the Town of Madison in the County of Carroll in said State, qualified to vote in Town affairs:

You are hereby notified to meet at the Town Hall in said Madison on Tuesday, March 14, 1961 at nine o'clock in the forenoon, to act upon the following subjects.

1. To choose all necessary officers for the ensuing year.

2. To raise such sum of money as may be necessary to defray town charges for the ensuing year and make appropriations for the same.

As follows:

- Town officers' salaries
- Town officers' expenses
- Expenses of recreation hall
- Expenses of town hall
- Employees' Retirement and Social Security
- Police department
- Fire department
- Insurance
- Damage and Legal Expense
- Health department including hospitals
- Vital statistics
- Town Dump
- Summer highway maintenance
- Winter highway maintenance
- Street lighting
- General expense of highway department
- Town road aid
- Libraries
- Town poor

Old age assistance  
Memorial day  
Old home week  
Parks and playgrounds  
Interest on temporary loans  
Water control on Silver Lake

3. To see if the town will vote to raise and appropriate the sum of \$159.22 which is 1/100 of 1% of the assessed valuation of the Town to the Lakes Region Association for the purpose of publicizing and promoting the natural advantages and resources of the town, in cooperation with other towns in the Lakes Region.

4. To see if the Town will vote to authorize the Selectmen to expend the Duncan Fund (1038.91) on the Madison Boulder road and railroad crossing subject to the approval of the Division engineer.

5. To see if the Town of Madison will raise and appropriate the sum of \$500.00 to furnish and place marker buoys to completely outline and safeguard the four public beaches on Silver Lake during the summer season, for the protection of bathers using these beaches; place marker buoys to outline a channel to deep water from the boat landing at the Southern end of Silver Lake, to restrict water skiers to this channel in entering and leaving the lake; and place a large and easily read sign at this boat landing warning water skiers and boat operators of the provisions of the laws and regulations, which require water skiers and their boats to stay away 150 feet from all bathers, boats, buoys, canoes, shorelines, etc.

6. To see if the Town will vote to raise and appropriate a sufficient sum to construct a hard surface



highway, with adequate ditches and culverts, for one half mile on Tasker Hill road from its junction with the road from Conway to Pea Porridge Pond.

7. To see if the Town will vote to construct a hard top surface highway together with appropriate ditches and culverts for a distance of about six tenths of a mile on the road known as the Tasker Hill Road from the intersection at the Wheeler property to the crown of the hill near the Beck property, and to raise and appropriate such sum as shall be sufficient for the same.

You are hereby notified to meet at the Town Hall in said district on the 14th day of March 1961, at 2:00 o'clock in the afternoon, to act upon the following subjects:

1. To choose a Moderator for the coming year.
2. To choose a Clerk for the ensuing year.
3. To choose a Member of the School Board for the ensuing three years, and a board member for the ensuing two years.
4. To choose a Treasurer for the ensuing year.
5. To determine and appoint the salaries of the School Board and Truant Officer, and fix the compensation of any other officers or agent of the district.
6. To hear the reports of Agents, Auditors, Committees, or Officers chosen, and pass any vote relating thereto.
7. To choose Agents, Auditors and Committees in relation to any subject embraced in this warrant.
8. To see what sum of money the district will raise and appropriate for the support of schools, for the salaries of school district officials and agents, and for the payment of statutory obligations of the district, and to authorize the application against said appropriation of such sums as are estimated to be re-

ceived from the state foundation aid fund together with other income; the school board to certify to the selectmen the balance between the estimated revenue and the appropriation, which balance is to be raised by taxes by the town.

9. To see if the district will vote to buy a new school bus, and authorize the school board to use the \$1,000.00 and accrued interest, now in the capital reserve fund, in part payment therefor.

10. If the preceeding article is voted, to see if the district will appropriate the sum of \$1,500.00.

11. If the two preceeding articles are voted, to see if the district will vote to authorize the school board to borrow on the credit of the district, a sum not to exceed \$3,500.00 through the issuance of serial notes or bonds therefor; to authorize the school board to determine the terms and conditions upon which such notes or bonds shall be issued, and the time and place of payment of capital and interest, in accordance with the provisions of the Municipal Finance Act. New Hampshire Revised Statutes, Chapter 33, and any amendments thereto.

12. To see what sum of money the district will vote to raise and appropriate for the purchase and installation of new lights in the school building.

13. To see if the district will vote to authorize the school board to make application for and accept in the name of the school district for education purposes such funds or grants-in-aid as may be obtained from the State of Federal Government or any department or agency thereof, or any other sources.

14. To transact any other business that may legally come before said meeting.

## REPORT OF THE SUPERINTENDENT OF SCHOOLS

To the School Board and Citizens of Madison :

During the school year 1959-60 the teachers in the Madison School were: Principal Frank Richardson, grades 6, 7 and 8; Mrs. Ruth Chick, grades 4 and 5; Mrs. Linnie Giles, grades 1, 2 and 3. Mr. Richardson resigned at the end of the year to do a year of graduate work.

At the beginning of the current year Mrs. Chick and Mrs. Giles returned to their respective positions. Mr. Richardson was succeeded by Mr. Bertram Berube who is a graduate of Salem Teachers College and has a Master of Education Degree from the same college. He has taught in the Salem and Attleboro, Mass., schools. Madison is fortunate to have a staff of competent, effective teachers.

The school health service continues under the efficient direction of Mrs. Rebecca Sanborn, R. N.

Total enrollment in the Madison School was 64 pupils. In September 1960 the school opened with an enrollment of 62 pupils. This has increased to 67 at this date. Estimated enrollment for 1961-62 is 72. There were 21 pupils enrolled at Kennett High School and the tuition rate was \$355.00. The same number of pupils are enrolled this year and the tuition rate is \$370.00. The announced tuition rate for 1961-62 is \$395.00.

Mrs. Margaret Ward continues her magic in the lunch room where she serves excellent meals at very low cost. The lunch program again had a small surplus at the close of school last June.

At the last annual district meetings Effingham,

Freedom, Madison and Ossipee appropriated funds to be used for music instruction. These districts jointly engaged Mrs. Dagny Blouin as the music teacher. This is the first time our pupils have experienced the advantage of music instruction by a professionally trained music teacher. Mrs. Blouin holds the degree of Bachelor of Music, and has taken education courses at the University of New Hampshire. Necessarily the instruction this first year is elementary, but the children are making good progress and are enjoying the experience. Mrs. Blouin is to be complimented on the good work she is doing.

During the current year the school building has been painted throughout the interior, and fire escapes installed on both classrooms in the main part of the building. A new set of swings was purchased and, with help from U. T. A. members, installed in front of the primary room.

Last year a television receiver was installed and programs in science and New Hampshire history were received from WENH-TV Channel 11. This year an additional program in elementary French is being received and supplementary instruction in grades four through eight is provided by Mr. Berube. Television will become an increasingly important means of instruction in our schools.

It has been my privilege to serve as your superintendent of schools during the past fifteen years. My association with members of the school board, teachers, citizens, and pupils has been very pleasant, and is most earnestly appreciated.
