STATE OF NEW HAMPSHIRE

To the inhabitants of the Town of Sutton, in the County of Merrimack, in said State, qualified to vote in town affairs:

You are hereby notified to meet at Pillsbury Memorial Hall, in said Sutton, on Tuesday, the eighth day of March next, at ten of the clock in the forenoon, to act upon the following subjects:

1. To choose all necessary town officers for the year ensuing.
2. To raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriation of the same.
3. To see how much money the town will vote to raise and appropriate for the repair of highways and bridges.
4. To see if the town will vote to accept State Aid and raise and appropriate money for the same.
5. To see how much money the town will vote to raise and appropriate for the maintenance of state highways.
6. To see how much money the town will vote to raise and appropriate for street lighting.
7. To see how much money the town will vote to raise and appropriate for Old Home Day.
8. To see if the town will vote to raise and appropriate a sum of money for the control of White Pine Blister.

9. To see what action the town will take in regard to purchasing a truck for State Aid maintenance and raise and appropriate money for the same.

10. To see what action the town will take in regard to purchasing one or more blades for snow removal with trucks and raise and appropriate money for the same.

11. To see what action the town will take in regard to purchasing a fire engine and raise and appropriate money for the same.

12. To see if the town will vote to build a concrete bridge at South Sutton and raise and appropriate money for the same.

13. To see if the town will vote to discontinue the road over King's Hill from the poor farm corner to the Newbury town line, subject to gates and bars.

14. To see what portion of the old highways over Dodge Hill the town will vote to discontinue, subject to gates and bars.

15. To see if the town will vote to discontinue the highway from the Mrs. Emma Duley place to Frank Todd's pasture, subject to gates and bars.

16. To see if the town will vote to accept the bequest under the will of the late Abbie Dillingham.

17. To see if the town will vote to accept the bequest under the will of the late Sarah Emma Richards.

18. To bring in your votes for the election of delegates-at-large, alternate delegates-at-large, district delegates, alternate district delegates, to the national convention of the Democratic and Republican parties to be held for the purpose of nominating party candidates for President and Vice-President of the United States.

19. To transact any other business that may legally come before said meeting.

This makes a total of 93 pupils residing in the district and attending public schools. Last year the number was 86.

Health Inspection

The annual health inspection of the schools was made by Dr. W. P. Clough of New London, and reported as follows:

These cases were reported to the respective parents of the pupils.

A dental clinic was held at the Mills in the town hall, March 2-7. The attending dentist was Dr. Ralph McLaughlin of Pittsfield, N. H. Forty-two pupils were treated. Of these 11 received free care, 1 paid part cost, and 30 full cost.

The following pupils completed the work of the eighth grade at North Sutton, and were given diplomas at the close of school in June: Marguerite Bartlett, Woodrow Davis, Hazel Whitcher. There were no graduations at either of the other two schools.

In the summer of 1931 the two windows on the right hand side of the schoolroom at South Sutton were eliminated. This removes the cross-lighting so harmful to the eyes of the pupils when writing. It is probable that very few repairs will be needed in any of the schools during the next year. By that time the period of financial depression in the nation may have passed, and any necessary changes can be made with less burden of taxation.

In conclusion we thank the board and the parents of the pupils for their co-operation and support during the year.
