TOWN WARRANT

To the inhabitants of the Town of Grantham, in Sullivan County, qualified to vote in town affairs:

You are hereby notified to meet at the Town's Municipal Building in said Grantham on Tuesday, the thirteenth of March next, at 9 o'clock in the forenoon, to act on the following subjects:

Article 1. To choose by ballot and major vote, for the ensuing three years: one (1) Selectman

one (1) Treasurer

one (1) Town Clerk

one (1) Trustee of the Library

one (1) Trustee of Trust Funds

one (1) Member of the Planning Board

And, for the ensuing two years:

one (1) Moderator

And, for the ensuing one year:

two (2) Auditors

And for the ensuing six years:

one (1) Supervisor of the Checklist

And to elect all other necessary Town Officers, Agents and Committees, and pass any vote relating thereto.

Article 2. To instruct the Selectmen to receive sealed bids until March 21, 1984 from all persons interested in being appointed Tax Collector for the ensuing three (3) years. The Selectmen having the right to accept or reject any or all bids and to take such action as they deem necessary.

Article 3. To see if the Town will vote to raise and appropriate the sum of \$11,200.00 to defray Town Officers' Salaries and \$13,600.00 to defray Town Officers' Expense.

Article 4. To see if the Town will vote to raise and appropriate the sum of \$2,000.00 for the care and maintenance of cemeteries.

Article 5. To see if the Town will vote to appropriate one thousand two hundred fifty dollars (\$1,250.00) to install adequate drainage and blue stone the driveway to the Municipal Building and authorize the withdrawal of the amount required for this purpose from the Federal Revenue Sharing Fund.

Article 6. To see if the Town will vote to appropriate one thousand four hundred dollars (\$1,400.00) to relocate the stone wall at the entrance to the Municipal Building driveway and authorize the withdrawal of the amount required for this purpose from the Federal Revenue Sharing Fund.

Article 7. To see if the Town will vote to appropriate three thousand seven hundred dollars (\$3,700.00) to replace the present mower for more efficient operation and authorize the withdrawal of the amount required for this purpose from the Federal Revenue Sharing Fund.

Article 8. To see if the Town will vote to raise and appropriate the sum of \$17,175.00 for the care, maintenance and insurance of the Town Hall, Municipal Building and Town Office.

Article 9. To see if the Town will vote to raise and appropriate the sum of \$3,000.00 to be used for Legal Assistance and Fees.

Article 10. To see if the Town will vote to raise and appropriate the sum of \$581.00 to support the Upper Valley - Lake Sunapee Council for the ensuing year.

Article 11. To see if the Town will vote to appropriate three thousand dollars (\$3,000.00) for the purchase of Video Training Equipment to be used by the FAST Squad, Fire Department and Police Department and authorize the withdrawal of the

amount required for this purpose from the Federal Revenue Sharing Fund.

Article 12. To see if the Town will vote to raise and appropriate the sum of \$39,900.00 for the use of the Police Department.

Article 13. To see if the Town will vote to raise and appropriate the sum of \$19,500.00 for the use of the Volunteer Fire Department.

Article 14. To see if the Town will vote to raise and appropriate \$14,649.00 for Summer Maintenance of roads and to appropriate the sum of \$14,717.00 from the Highway Block Grant for Summer Maintenance and Improvement of roads.

Article 15. To see if the Town will vote to raise and appropriate the sum of \$14,000.00 for the Winter Maintenance of roads.

Article 16. To see if the Town will vote to raise and appropriate the sum of \$2,300.00 to defray the cost of Street Lighting.

Article 17. To see if the Town will approve of the Selectmen entering into a five (5) year contract with contractor of their choice for the disposal of solid waste.

Article 18. To see if the Town will vote to appropriate ten thousand dollars (\$10,000.00) for the purpose of building a transfer station for the disposal of solid waste and authorize the withdrawal of the amount required for this purpose from the Federal Revenue Sharing Fund.

Article 19. To see if the Town will vote to appropriate ten thousand seven hundred dollars (\$10,700.00) to cover, grade and seed the present dump site and authorize the withdrawal of the amount required for this purpose from the Federal Revenue Sharing Fund.

Article 20. To see if the Town will vote to raise and appropriate the sum of \$20,300.00 to provide for operating the solid waste disposal facility.

Article 21. To see if the Town will vote to withdraw from membership in the NH/VT Regional Refuse Disposal District as voted in Article 2 of the Annual Town Meeting held on Tuesday, the ninth of March, 1981.

Article 22. To see if the Town will raise and appropriate the sum of \$878.00 to support the NH/VT Solid Waste Project for the ensuing year.

Article 23. To see if the Town will vote to raise and appropriate the sum of \$300.00 to support a local nursing service, and \$1,935.00 to subscribe to the Newport Area Home Health Agency.

Article 24. To see if the Town will vote to raise and appropriate the sum of \$1,588.50 which will enable Grantham to be serviced by the Newport Ambulance Service.

Article 25. To see if the Town will vote to raise and appropriate the sum of \$300.00 to support the New London Ambulance Service.

Article 26. To see if the Town will vote to raise and appropriate the sum of \$2,500.00 for Old Age Assistance, Town Poor and Aid to Permanently Disabled Persons.

Article 27. To see if the Town will vote to raise and appropriate the sum of \$250.00 for Sullivan Nutrition, a subsidiary of the Newport Senior Center, for the support of its Meals on Wheels Program for the benefit of Grantham residents.

Article 28. To see if the Town will approve the combining of the Dunbar Free Library with the School Library in the new Grantham Elementary School.

Article 29. To see if the Town will vote to appropriate five thousand dollars (\$5,000.00) for the purchase of books for enlarged library and authorize the withdrawal of the amount required for this purpose from the Federal Revenue Sharing Fund.

Article 30. To see if the Town will vote to raise and appropriate the sum of \$7,520.00 for the support of the Dunbar Free Library.

Article 31. To see if the Town will raise and appropriate the sum of \$1,800.00 to support the Youth Recreation Program.

Article 32. To see if the Town will vote to raise and appropriate the sum of

\$1,200.00 to be used for the Independence Day - Old Home Day Celebration.

Article 33. To see if the Town will vote to authorize the Selectmen to borrow money in anticipation of taxes and raise and appropriate \$30,000.00 for Interest Expense.

Article 34. To see if the Town will vote to raise and appropriate the sum of \$24,000.00 to finish paying for the Fire Station.

Article 35. To see if the Town will vote to discontinue that section of Old Route 10 beginning near the residence of Stanley Hall and continuing south past the residence of Peter Forest and property of Wilfred Hastings.

Article 36. To see if the Town will vote to authorize the Selectmen to accept title to land which is the present solid waste disposal site located on the Springfield Road.

Article 37. To see if the Town will vote to raise and appropriate the sum of \$700.00 for the operation of the Planning Board.

Article 38. To see if the Town will vote to raise and appropriate the sum of \$50,000.00 to be turned over to the Trustees of the Trust Funds to set up a Capital Reserve Fund entitled "New Fire Truck."

Article 39. To see if the Town will vote to appropriate an amount not to exceed six hundred dollars (\$600.00) to extend the chain link fence between the school and the river and authorize the withdrawal of the amount required for this purpose from the Revenue Sharing Fund.

Article 40. To see if the Town will vote to appropriate the sum of \$14.46 for Town Road Aid the same being contributed by the State.

Article 41. To see if the Town will vote to petition the State Tax Commission to have an audit made by the Division of Municipal Accounting and make an appropriation to cover the expense of the Audit.

Article 42. To see if the Town will vote to authorize the Selectmen to dispose of any acquired properties through sealed bids, with the Selectmen having the right to accept or reject any or all bids.

Article 43. (By Petition) "To see if the Town of Grantham shall call upon the Governor and Executive Council, its State Representative(s) and State Senator to promptly convene a Special Session of the Legislature for the sole purpose of preventing the imposition of huge cost increases in electric rates resulting from the Seabrook Nuclear Power Plant on the citizens, businesses, schools and agencies in the Town of Grantham, and to direct the Selectmen to promptly notify our above listed officials of the Town's desire."

Article 44. To hear the reports of Officers, Agents and Committees heretofore chosen and pass any vote relating thereto.

Article 45. To transact any other business that may legally come before this meeting.

4) a request by Alvah Jack Pillsbury to divide his approximate 6 plus or minus acre property on Pillsbury Road into two parcels.

5) a request by Wilfred Cote to divide his approximate 2.9 plus or minus acre property on Burpee Hill Road into two parcels.

6) a request from Myra Z. Laundy to divide her approximate 18.9 plus or minus acre property on Dunbar Hill Road into three parcels.

This past year we saw a slight decrease in circulation. When the school children moved to the new school, they no longer used the library. This accounts for the circulation decrease in children's books. All other areas of circulation have increased. The hours we are open remained the same; Monday - 9:00 to 12:00; Wednesday - 9:00 to 12:00, 2:00 to 4:30, 6:30 to 8:30; Saturday - 9:00 to 12:00. We have story time every Wednesday morning at 10:30. We purchased 330 books both hardback and paperback and accepted numerous donations of books and magazines. In an effort to cut our heating costs the library had plastic wrapped and tacked around the building's foundation. This has definitely cut down on the wind whistling through the floor and the lower library walls.

Due to the lack of space the adult books, both fiction and non-fiction, were weeded. This was done by using professional guidelines and by having a State Library consultant come and spend a morning weeding. Another paperback book shelf was added to free up the shelves for hardback books.

The summer reading program was "Up, up and away." Each child decorated a paper kite. For every book read a bow was added to their kite tail and a prize of candy or ice cream was awarded at Reney's General Store. Twenty-seven children signed up and read 391 books. At the end of the summer a party was held for all participants.

This past summer was the year of the biennial book sale. It was extremely successful thanks to the many donations of books, cakes, white elephants and the help of the volunteers. The money made from this sale was spent on books. This year the library has been trying to buy more non-fiction reference books to build up the collection. There are books which libraries should have even though these particular books may not circulate much.

This year the State discontinued the van delivery of additional books. As a result the libraries were allowed to pick books to add to their permanent collection. I picked mostly children's books due to the age of the collection. The turnover loss of 200-300 different books three times a year is felt by the heavy readers.

This year the town will be asked to vote on combining with the school library. The trustees and school board members are in favor of combining. If the town votes to combine, an agreement would be drawn up between school and public library covering operating and management details. The library would work with a State Library consultant for input on this agreement and on the daily operating procedures. The combination can work and it would strengthen both libraries.

Meeting called to order by F. Robert Osgood, Moderator, at 7:35 p.m.

Article I. Motion made by Stewart Sargent to accept reports of Agents, Auditors, Committees and other officers as printed in the Annual School Report. Seconded by Donald Taylor. Voted in the affirmative.

Article II. Donald Taylor offered following resolution: That the District vote to accept the AREA Agreement among the school districts of Grantham, Lebanon and Plainfield as revised and recommended by the area school plan review board, said revision being establishment of tuition rates based on the estimated per pupil cost determined from the approved budget (MS-22) and actual enrollment on October 1 for the year immediately preceding that for which the charge is being made plus an adjustment of one-half the average difference in per pupil cost for the two years preceding. Seconded by Stewart Sargent. Voted in the affirmative.

Article III. Motion made by Robert Guyette that the District vote to sell the Grantham Village School building and lot consisting of one acre located on Dunbar Hill Road to the town of Grantham for one dollar and authorize the school board to execute and deliver a suitable warranty deed and to take any other action or sign any other documents which may be necessary to carry out this vote. Seconded by Merle Schotanus. Affirmative vote.

Article IV. Article was offered as a resolution by Kathi Osgood. That the District vote to elect 2 auditors for the terms herein provided. The terms of office shall be staggered so that after the year of adoption one auditor shall be chosen for a term a office for the same number of years as there are auditors, provided, however, that in the year of adoption the auditors shall be chosen for varying terms so that the term of one auditor shall expire in the next succeeding year, the term of the second auditor, the next year, and so on for the number of years as there are number of auditors. Seconded by Jack English. Affirmative vote.

Article V. Merle Schotanus made a motion to raise, appropriate and expend the sum of \$2,825.00 for the following items of equipment for the new school library: charge desk, card catalogue, book truck, four drawer file cabinet, two chairs, two tables. Seconded by Helen Schotanus. Number of students may reach ten but average one to six. Question moved by Leslie Taylor after Mr. Lalley explained he had checked on lease of smaller bus for this and the cost made it not feasible. 65 voters voted by ballot. 39-Yes — 26-No. Motion carried.

Article VII. Following resolution was offered by Donald Taylor: That the District vote to raise, appropriate and expend the sum of \$365,099.00 for the support of the school, for the salaries of school district officials and agents, and for the statutory obligations of said district and to authorize the application against said appropriation of such sums as are estimated to be received from state and federal governments together with other income, the School Board to certify to the Selectmen the balance, which balance is to be raised by taxation by the District. This sum represents the proposed budget of \$360,086.00 plus \$2,825.00 to purchase new library equipment voted under Article V of this Warrant; plus \$2,188.00 to continue late activity bus voted under Article VI of this Warrant. Seconded by Stewart Sargent. This represents

a 33% increase. Voted in the affirmative.

Article VIII. Joey Holmes offered following resolution: That the District vote to authorize the School Board to make application for, to accept and expend on behalf of the District any and all grants or other funds which may now or hereafter be forthcoming from the United States Government, foundations and individuals. Seconded by Phoebe Wing. Affirmative vote.

Article IX. Sumner Libbey read a resolution recognizing F. Robert Osgood, Donald Taylor, Paul Osgood, Julie Tilden, Wilfred Hastings, Kenneth Barton, Stewart Sargent, Betty Harris and Robert Guyette for the work they did as the Building Needs Committee in gaining passage of the bond issue for the new school and overseeing the construction and financing of the facility.

Donald Taylor suggested that the district look into the possibility of purchasing catastrophic aid coverage from Lloyds of London for out of district placement costs for special education students. Lalley said the office would look into it.

Motion was made to adjourn by Joey Holmes. Seconded by Merle Schotanus. Affirmative vote. Meeting ended at 8:30 p.m.

The estimated cost of educating all handicapped children in 1984-85 is \$13,139. It is expected that the District will receive \$8,020 in state and federal handicapped funds which reduces the amount to be raised through local taxes.

G1-1200-112-00 Special Education Teacher

A one-quarter-time certified special education teacher is continued.

G1-1290-330-00 Private Assessment

Testing of students who are suspected of being handicapped sometimes requires a specialization which exceeds the qualifications of anyone on staff. In these instances, an outside agency is contracted.

G1-1290-331-00 Speech Therapy

Provides speech therapy to three children one hour each week for the school year. $11.40/hour \times 3 hours/week \times 36 weeks = 1.231.00$

G1-1290-334-00 Psychological Services

The services of a psychologist are required to comply with state and federal laws for the handicapped. The school psychologist works four days a week and each of the districts in SAU #32 (Mascoma Valley, Lebanon, Plainfield and Grantham) contributes to his salary in proportion to the number of handicapped students in each district as of October 1, 1983. Employing our own psychologist continues to be more effective and less costly than contracting one on an hourluy basis with a private agency for these services.

G1-1290-561/569-30 Special Education Tuition

Presently, no Grantham student in the 3 to 21 age group is so severely handicapped as to require placement in an out-of-district program. A \$5,000.00 appropriation is proposed in the event an out-of-district placement becomes necessary. Tuition and transportation charges of \$10,000.00 to \$25,000.00 annually are not unusual to educate a severely handicapped child.


