

TOWN MEETING WARRANT

The State of New Hampshire

To the Inhabitants of the Town of Landaff, in the County of Grafton in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at the Town Hall in said Landaff on Tuesday, the 13th day of March, next at nine of the clock in the forenoon, to act upon the following subjects:

- 1. To choose all necessary Town Officers for the year ensuing.
- 2. To raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriations of the same.
- 3. To see if the town will vote to accept state aid for T.R.A. highways and raise and appropriate money for same.
- 4. To see how much money the town will vote to raise and appropriate for the support of the Lisbon District Nursing Association.
- 5. To see if the town will authorize the selectmen to borrow money in anticipation of taxes.
- 6. To see if the town will vote a discount of 2% on property taxes paid on or before July 1, and 1% September 1.
- 7. To see if the town will vote to raise and appropriate the sum of \$28.16 to the White Mountain Region Association, being 10 cents per \$1,000 of the

assessed valuation (1/100 of 1%) for the purpose of issuing and distributing printed matter and advertising and otherwise publicizing the advantages of the town, in cooperation with the 45 towns of the region.

- 8. To see how much the town will raise and appropriate for control of the White Pine Blister Rust in the town during 1956.
- 9. To see if the town will vote to raise and appropriate the sum of \$500.00 to be used for graveling Class V highways.
- 10. To see if the town will approve of removing the partition between the Dining Room and the Library Room and will vote to raise and appropriate \$100.00 to cover this work.
- 11. To determine disposition of Library.

 To transact any other business that may legally come before the said meeting.

SUPERINTENDENT'S REPORT

To the School Board and Citizens of the Landaff School District:

I herewith submit my thirteenth annual report as Superintendent of Schools.

The total enrollment in Blue School last year was 22. The average membership was 17.5 and the percent of attendance was 88.2. There were 14 pupils attending Lisbon Elementary School and 11 attending Lisbon High School.

The enrollment in Blue School this year is 24. Seventeen pupils are attending Lisbon Elementary School and 14 are attending Lisbon High School for a grand total of 55 Landaff children enrolled in the public schools.

Your teacher, Mrs. Pearl Sunbury, is completing her third year at Blue School. She retires in June. I wish to thank Mrs. Sunbury for her good work and excellent cooperation.

Every year the United States, country wide, is losing more teachers than it is gaining. About 90,000 leave the profession and only 50,000 new graduates come in, a net loss of 40,000, for which there are now few replacements. Rural schools are first to suffer because few teachers will take a multiple grade position when there are so many single grade jobs available.

Landaff received more State Aid this year. The amount was \$5,714.18 as compared with \$4,047.23 the year before.

Repairs were made on the Ireland and Scotland Schools as voted at the last school meeting. The Ireland School is newly shingled with black asphalt shingles. The Scotland School doors and windows were boarded up. The Youth Group meet in the Ireland School, under the direction of Miss Betty Huber. The group shows fine spirit and takes part in many community affairs and finances the maintenance of the building.

I wish to thank the School Board and the many interested townspeople who help the children with their educational activities.
