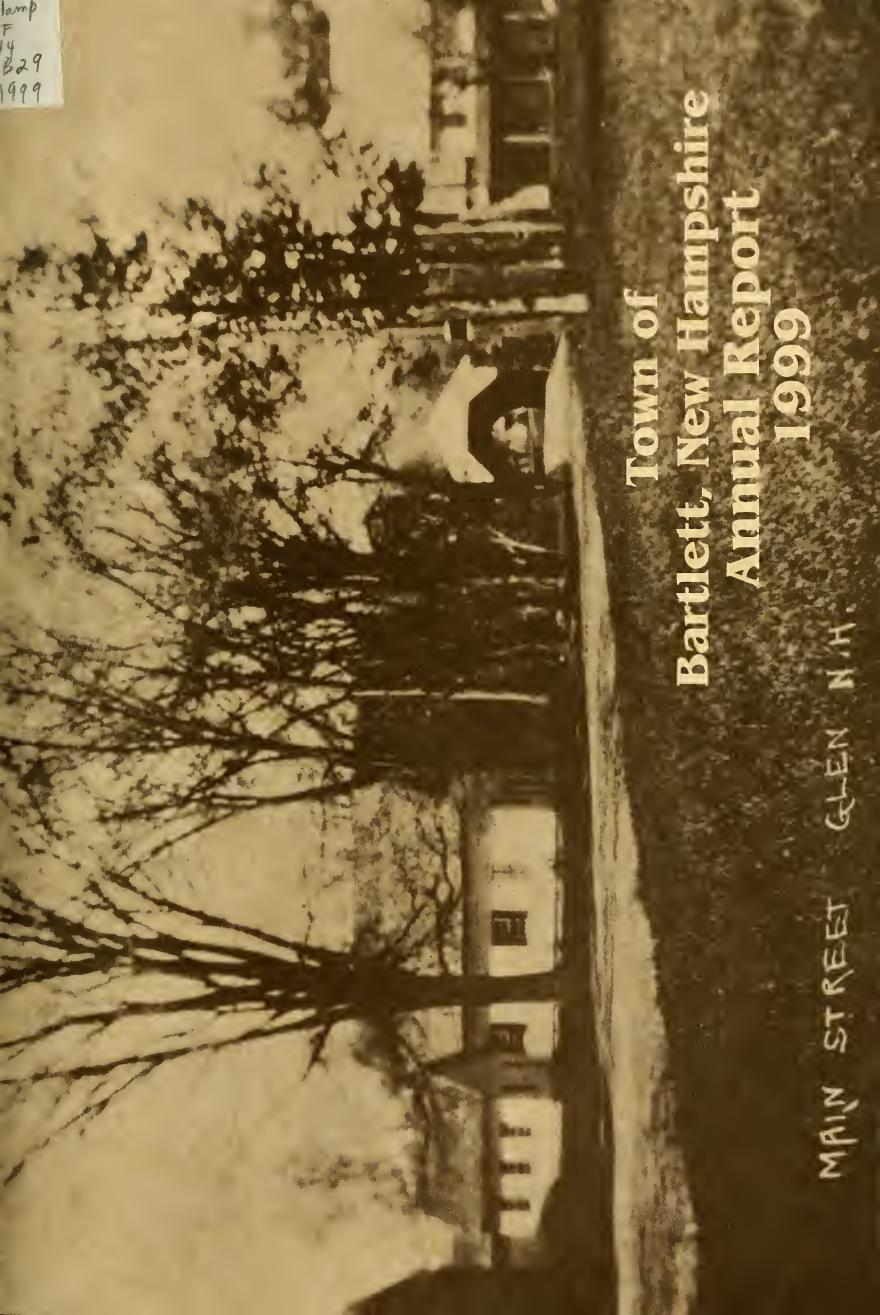

## ON THE COVER

### COVERED BRIDGE OVER THE ELLIS RIVER, IN GLEN, NH

While old details are a bit sketchy, it appears that a Town Meeting held September 8, 1877 voted to build a covered bridge over the Ellis River near the Town House and despite a few votes later that year, it appears that 1877 is the year the project was established. there are no available records that speak to the completion but we can assume it would be a year or two at most after 1877 when the covered bridge over the Ellis River was completed. It seems that the covered bridge served the town until 1938 when it was replaced by a steel Pratt truss bridge which was in service until the present structure was built in 1998.

Records from the NH Department of Transportation show that the covered bridge had a span of 129 feet, a height of 18.5 feet and a clear roadway width of 18.8 feet. The total cost of the 1938 bridge project including removal of the covered bridge, engineering, contingency and construction of the new bridge was \$35,736.63. No report is made whether the job came in under budget.

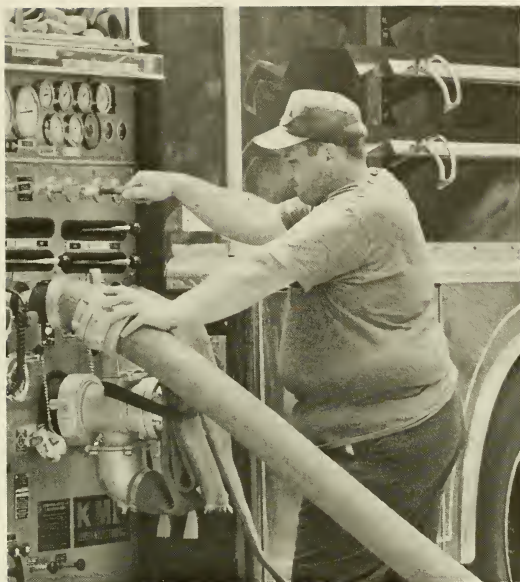

## 2000 TOWN MEETING WARRANT

To the inhabitants of the Town of Bartlett, New Hampshire in the County of Carroll in said State, qualified to vote in the Town affairs: You are hereby notified to meet in the Town Hall in said Bartlett on Tuesday, March 14, 2000 at eight o'clock in the forenoon to act upon the following subjects hereinafter set forth. The voting on Articles 1-5 will be by official ballot at the Town Hall and the polls shall open for balloting at eight o'clock in the forenoon and shall not close before seven o'clock in the evening. The following articles (Articles 6-31) in the warrant will be acted upon on Thursday, March 16, 2000 at six thirty o'clock in the evening at the Josiah Bartlett Elementary School in Bartlett Village.

ARTICLE 1. To choose all necessary Town Officers for the ensuing year.

ARTICLE 2. Are you in favor of the adoption of Amendment No. 1 as proposed by the Planning Board for the Town of Bartlett Zoning Ordinance as follows: To amend Article IX Green Areas Section A to allow for exceptions to the green area requirements as they apply to ski trails, golf course fairways, or other such limited uses; to include a provision waiving green area requirements on common boundaries of contiguous lots under control of the same entity or person through a Special Use Permit from the US Forest Service; and to provide for side and rear green areas for pre-existing, nonconforming commercial uses in the Town Residential District A. (Planning Board favors, Selectmen Patch/Chandler oppose, Roode favors)

Are you in favor of the adoption of Amendment No. 2 as proposed by the Planning Board for the Town of Bartlett Zoning Ordinance as follows: To amend Article XIII Permitted Uses Section C to allow for a Multifunction Research, Education, and/or Cultural Facility and add the definition to Article XIX. (Planning Board favors, Selectmen favor)

ARTICLE 4. Are you in favor of the adoption of Amendment No. 3 as proposed by the Planning Board for the Town of Bartlett Zoning Ordinance as follows: To amend Article XIII Permitted Uses Section C to allow for a Research Facility and

add the definition to Article XIX. (Planning Board favors, Selectmen favor)

ARTICLE 5. Are you in favor of the adoption of Amendment No. 4 as proposed by the Planning Board for the Town of Bartlett Zoning Ordinance as follows: To amend Article XI Setbacks Section A-1 to exempt structures from setback requirements on common boundaries of contiguous lots under control of the same entity or person through a Special Use permit from the US Forest Service. (Planning Board favors, Selectmen oppose)

ARTICLE 6. To raise such sums of money as may be necessary to defray Town charges for the ensuing year and make appropriations of the same. Selectmen favor.

ARTICLE 7. To see if the Town will vote to raise and appropriate the sum of \$125,000.00 for town road improvements. Selectmen favor.

ARTICLE 8. To see if the Town will vote to raise and appropriate the sum of \$22,000.00 for the purchase of a new marked, police cruiser and related communication/safety equipment. Selectmen favor.

ARTICLE 9. To see if the Town will vote to raise and appropriate the sum of \$15,000.00 for maintenance and repairs at the Bartlett Village Fire Station. Specific May projects include replacement of overhead doors, installation of a new furnace and painting the building. Selectmen favor.

ARTICLE 10. To see if the Town will vote to raise and appropriate the sum of \$9,900.00 for a new stainless steel sander body which was ordered last fall to replace an unusable sander body. Selectmen favor.

ARTICLE 11. To see if the Town will vote to raise and appropriate the sum of \$15,000.00 as the town's 20% share as part of the State Bridge Aid program for repairs on the bridge on Town Hall Road that crosses the East Branch River. Selectmen favor.

ARTICLE 12. To see if the Town will vote to raise and appropriate the sum of \$4,900.00 as its share of final closure of the septage lagoons. The Town of Jackson and the landowner shared in the total cost of closure which was completed in 1999. Selectmen favor.

ARTICLE 13. To see if the Town will vote to raise and appropriate the sum of \$25,000.00 for a new 4 wheel drive, extended cab pick up truck for the Fire Department, replacing the existing pickup truck. Selectmen favor.

ARTICLE 14. To see if the Town will vote to raise and appropriate the sum of \$15,000.00 for site work regarding possible ground contamination resulting from the removal of underground tanks at the Town Garage. Revenue from the State Oil Fund will offset this expenditure. Selectmen favor.

ARTICLE 15. To see if the Town will vote to raise and appropriate the sum of \$12,000.00 as its share of the establishment and operation of a town/school recreation department. (This sum represents 8 months of the town's share). If approved, these funds will be combined with funds raised at School Meeting to provide for the establishment and operation of a town-wide recreation department as tentatively approved at the 1999 Town Meeting Article 13. Selectmen favor.

ARTICLE 16. To see if the Town will vote to send the following resolution to the New Hampshire General Court: Resolved, New Hampshire's natural, cultural and historic resources in this town and throughout the state are worthy of protection and, therefore, the State of New Hampshire should establish and fund a permanent public/private partnership for the voluntary conservation of these important resources. Agreeable to a petition signed by David Publicover and others. Selectmen oppose.

ARTICLE 17. To see if the Town will vote to authorize the Selectmen, at their discretion, to distribute to Valley Vision up to 20 percent of the franchise fee the town receives from Adelphia Cable. The town receives approximately \$30,000. This expenditure not to exceed \$6,000.00 and is for the betterment of Valley Vision television programming. Valley Vision is a non-profit organization and an educational governmental cable television station. Agreeable to a petition signed by Richard Glines and others. Patch opposes, Chandler/Roode support lesser amount.

ARTICLE 18. To see if the Town will vote to raise and appropriate the sum of \$500.00 for the Mt. Washington Valley Chamber of Commerce. Agreeable to a petition signed by Cynthia Cini and others. Selectmen oppose.

ARTICLE 19. To see if the Town will vote to raise and appropriate the sum of \$100.00 for dues to the Mount Washington Valley Economic Council. Selectmen oppose.

ARTICLE 20. To see if the Town will vote to raise and appropriate the sum of \$1,707.00 to help defray the costs of Service Delivery of the Mt. Washington Valley Chapter of the American Red Cross. Agreeable to a petition signed by Robert Boynton, Jr. and others. Chandler/Patch oppose - not a proper use of town funds for national organizations; people should have an individual choice concerning donations to charitable organizations/Roode favors.

ARTICLE 21. To see if the Town will vote to raise and appropriate the sum of \$7,755.00 for the Children's Health Center. Agreeable to a petition signed by Steve Miller and others. Selectmen oppose.

ARTICLE 22. To see if the Town will vote to raise and appropriate the sum of \$2,000.00 for support of the Tri-County Community Action Program for the purpose of continuing services of the Fuel Assistance Program for the residents of Bartlett. Agreeable to a petition signed by Robert Burcaw and others. Selectmen favor.

ARTICLE 23. To see if the Town will vote to raise and appropriate the sum of \$1,275.00 to assist the Family Health Centre. Agreeable to a petition signed by Vicki Varrichione and others. Selectmen oppose.

ARTICLE 24. To see if the Town will vote to raise and appropriate the sum of \$500.00 for support of operating expenses of the Eastern Slope Regional Airport Authority. Selectmen favor.

ARTICLE 25. To see if the Town will vote to raise and appropriate the sum of \$1,000.00 for the support of Starting Point for providing crisis services to victims of domestic and sexual violence and their children. Agreeable to a petition signed by Karen Hebert and others. Selectmen favor.

ARTICLE 26. To see if the Town will vote to raise and appropriate the sum of \$2,326.00 for the Visiting Nurse and Hospice Care Services of Northern Carroll County, Inc. Agreeable to a petition signed by Terrie Kroger and others. Selectmen favor.

ARTICLE 27. To see if the Town will vote to raise and appropriate the sum of \$2,780.00 to assist the Carroll County Mental Health Service. Agreeable to a petition signed by Vicki Varrichione and others. Selectmen favor.

ARTICLE 28. To see if the Town will vote to raise and appropriate the sum of \$4,769.00 for the support of the Gibson Center

for Senior Services. Agreeable to a petition signed by Yvonne Kinsman and others. Selectmen favor.

ARTICLE 29. To see if the Town will vote to raise and appropriate the sum of \$1,725.00 for the Early Support and Services Program (birth to 3 years) of Children Unlimited, Inc. Agreeable to a petition signed by Kimberly Perley and others. Selectmen favor.

ARTICLE 30. To see if the Town will vote to raise and appropriate \$75,000 as provided in NH RSA 231:28 (the Betterment Assessment law) to construct North Ledge Road to an acceptable town road standard. All costs incurred by said construction would be borne by the abutting landowners through a betterment assessment and, therefore would be no effect on the tax rate. Selectmen favor.

ARTICLE 31. To transact any other business that may legally come before said meeting.

## SELECTMEN'S REPORT

This represents the final Selectmen's Report of the last century but we will confine our remarks to just the year 1999.

As noted in last year's report, the landfill closure is now complete and the Town received \$57,351.58 from the State Landfill Closure Grant program in 1999 to help share in the cost of the closure. Also in 1999, the saga of the septage lagoons was brought to a close with a successful closure of that area. The cost was shared 1/3 by the Towns of Jackson and Bartlett and 2/3 by the owner. The 1/3 Bartlett/Jackson share was divided on a 70/30 ratio resulting in a cost to Bartlett of \$4,900. With a court action by the State ready to happen, the Selectmen approved the closure procedure and expenditure and have an article on this year's warrant asking for the funds to pay for same.

The Transfer Station has been operating smoothly and the long standing pile of furniture has been removed. While we have been fortunate to dispose of the metal goods at no cost to the town and are optimistic we can continue this contract, we need to make an effort to maximize our return on recyclables and expand our recycling efforts.

While the recycling effort is being maintained at a fairly high level, our outlets for recyclables and therefore our proceeds for our materials are not at a level the Selectmen would like. We have engaged the Northeast Resource Recovery Association to work with us on a better plan for our recyclables and also have inserted some funds in the budget to perhaps hire a part-time person to keep us updated on various programs that become available and to monitor our operation from time to time.

One sure fire way of gauging the Valley's economy is to look at the expenses at the Transfer Station and taking a look at last year's expenses shows us that the area's economy was very good in 1999. The town has attended meetings and discussed the Pay As You Throw (PAYT) program and this still seems to be an attractive idea but at every program and in most informational packets, the key point is to move slowly, do thorough research and have a good education policy in place prior to making the move.

The E-911 numbering system is still ongoing and is substantially ready to be implemented. The street name process is basically finished and a public hearing will be held once all the street names have been put on the official map by the State. The

911 emergency system is functioning in Bartlett and that is the preferred number to call for true emergencies. This is not a process that can be rushed through as accuracy is of the utmost importance and there are more roads in Bartlett than one would think, but unfortunately we were held up by a dispute with the 911 folks over the location of the Bartlett/Hart's Location town line and several properties were involved. Despite letters from Selectmen of both towns agreeing on the proper line, it was difficult getting acceptance by the 911 office. This process should have been completed last year and the Selectmen will shoulder the blame and time will be allocated to finish the job as a priority item. Once again, please use the 911 number for true emergencies as all of our emergency teams are tied in to the State system.

It seems we are having more extended power outages due to the increased storm velocities and we want to remind everyone that in the case of any emergency, whether it be power outages, floods or other catastrophes, the Glen Fire Station is set up and equipped to provide emergency shelter and will be staffed in the event of an emergency.

Last year the town voted to spend \$300,000 in road improvements and borrow the money to be repaid over the next few years. In putting out to bid a project in Alpendorf, ironically the bids came in at exactly the same price. Faced with a dilemma of whether to re-bid or just try and negotiate, the Selectmen contacted the contractors and gave the Alpendorf project to LA Drew, Inc. and gave Hanson Excavating a like amount of work in other areas. Hanson did reconstruction work on Thorn Hill Road, Linderhof, and Glenwood. Unfortunately, LA Drew did not get the Alpendorf project done, but he did agree to apply quite a bit of hot top at his expense to the road last fall to make it better for winter traffic and plowing. The money for the job has been carried over (which is why the 1999 Special Article 4 shows as having unexpended funds) and will be done this summer. Other areas of major reconstruction included Chandler Mountain Road and the Holiday Ridge area and Pendexter Woods Road. Additionally, many other roads received considerable amounts of shimming and sealing. Since water line projects were being done in Holiday Ridge and Pendexter Woods, those projects were moved up on the schedule with the result that the planned work on Cobb Farm Road was not completed. That project will be done this year and a Special Article for that and other projects is in this year's warrant.

The town could easily spend over a million dollars on its road system, but the Selectmen have tried to find a balance between good roads, keeping speeds safe and not least of all avoiding an adverse impact on the tax rate. While there certainly are merits to having a long term plan in place, there are also some drawbacks. It is hard to calculate what the costs for repairing a road will be 5-10 years down the road and when you are limited in funds available, whenever an emergency comes up it affects the validity of the plan. Additionally, items such as water line work or other types of work allow the town to make judgment calls and take advantage of cost sharing, which we could not do if we had to stick to a plan. By having this flexibility, the town has gotten more "bang for our buck" in such areas as the Village roads, Linderhof, Pendexter Woods, Dundee Road, and Holiday Ridge by joining in with the Bartlett Village Water Precinct, Lower Bartlett Water Precinct and North Conway Water Precinct. Over the past six years, the town has appropriated \$695,000 over and above the regular highway budget and the majority of our most traveled roads show the results of that work. Recently every town warrant has had an article to raise money for the road network and it is certainly within the purview of the voters at Town Meeting to raise or lower the recommended amount. Just to give an idea of the costs involved in a reconstruction project, the bids received for approximately 1200 feet of reconstruction work last year were approximately \$53,000.

The Selectmen have been able to receive funding from the State of New Hampshire through a special National Forest road program to redo most if not all of Town Hall Road. The project should be ready to bid by March or April and is expected to be completed this summer. The State Department of Transportation and National Forest have been very cooperative on this matter and a public meeting was well attended.

This is a period where we need to be extra careful about our tax rate, especially in light of the onerous extra burden of being a "donor" town with regard to the statewide property tax. It is evident that the plaintiffs and education leaders and lobbyists are not going to be satisfied with the present amount of extra State funding and will be pushing for more. Unfortunately, one of the easiest places to raise more money is an increase in the Statewide property tax. Until this volatile issue is either settled once and for all, or at least a more stable revenue stream is established, we need to be increasingly vigilant. While this year's Statewide property tax hit on Bartlett amounted to \$1.81



per thousand dollars of valuation which amounts to \$181 in increased taxes on a house assessed at \$100,000, which may be able to be absorbed by the taxpayer without much pain, extra increases in the Statewide tax will prove to be more onerous as it has in other towns.

The Selectmen had deferred a couple of large projects, namely a new fire truck and a large road improvement bond, waiting until the final school building bond payment was made. This idea would have seen an increase in the Town's portion of the tax bill and a resulting decrease in the school tax portion, thereby leaving the effect on the taxpayer relatively benign. Unfortunately, the school budget is considerably higher and the Selectmen are hopeful to work with the School Board to see if we can't work out some details to avoid what would otherwise be an astronomical increase in the tax rate.

Due to the first payment and interest on the \$300,000 road construction bond from 1999, this year's budget shows an increase of \$112,800 or 10.8%. Other than those two items totalling \$90,000, the remainder of the budget shows an increase of \$22,600 or 2.2% over last year.

While last year's Selectmen's Report noted a touch of sadness and nostalgia involved with printing the last Town Report of the century, we are excited and optimistic to be part of such a great town and have a role along with all the citizens of Bartlett in printing the first Town Report of this century.

We do need to move ahead and look to the future but let us not forget all of those who helped Bartlett become the great town that it is and most of all, let us not forget those ideals and New England ethics that make Bartlett such a great place to live, work, and raise a family.

On behalf of all of Bartlett's citizens, the Selectmen would like to thank not only all of the Town employees for their dedication to the jobs and the community but also to all the volunteers both in the town sector and private sector who contribute so much to Bartlett and surrounding communities.

As we enter into a new decade, I would like to take a moment to reflect on the past as well as new changes to come. This office has seen a constant and steady increase in activity (10% yearly) that correlates with the growth we have seen in Bartlett during the 1990's. Mr. Howard Nichols, our former Town Clerk/Tax Collector was a pioneer when it came to changing the way the town clerk's office operated. He took the position first as Town Clerk and then worked towards combining the office to include the Tax Collector's office. This enabled the office to be open on a more full time basis. He also enabled our Town to take on the job of Municipal Agent with the State of NH. This saved residents the extra trip to a State substation to finish their motor vehicle registrations and obtain license plates. We were one of the first six towns volunteering for this new program. Howard was instrumental in computerizing the office. With over 5,000 tax bills issued today along with over 4,000 motor vehicle registrations issued yearly, I can't imagine processing everything in handwritten ledgers! Thank you Howard, as this enables us to keep the staffing in this office at a minimum. I want to thank the voters for investing in a municipal software program in 1998 that enables us to print our tax bills here instead of paying for outside printing. The ease and accuracy of issuing statements and calculating interest due has done much to streamline the office and increase the collection rate.

The groundwork laid out by Howard in the past set our town up to forge ahead with the changes that will come during the next century. Computerization will enable us to enter into the millennium with the capability to be "on-line" with the State of New Hampshire governmental offices during these next couple of years. Vital records will be available from any Town Hall that is connected. Motor Vehicles will also be on-line, ending the countless long distant calls we place now to verify information, thereby processing your registrations even more quickly. We

now have our voter checklist computerized and processed in house thus enabling us to keep it updated more frequently at no additional costs to the town. More public information data is available on computer disks thus cutting down on costs of printing paper information. Mail costs are being decreased by the use of a fax machine for local distribution or email. I am excited with the technological changes to come and will do all I can to keep abreast of the times.

I am currently completing my third year of a four-year certification program with the NH Tax Collector/Town Clerk's association. I've found tremendous value in the training received as well as networking out to other offices throughout the state. I currently serve on the State Certification Board that meets once a month in Concord. I found it extremely helpful to get to know the people in the offices that we interact with "way up North here". I would encourage anyone visiting the Concord area to take a trip to the Capital Buildings. For those with computer access I would also mention two web sites for state and local information. The first is the State of NH site of [www.webster.state.nh.us/](http://www.webster.state.nh.us/) to contact any state office or keep abreast of current legislation. The other is our local school web site of [www.schools.ncia.net/bartlett](http://www.schools.ncia.net/bartlett) for community information in Bartlett. Please let me know what my office may do to serve the needs of the community.

## 1999 PLANNING BOARD REPORT

Last spring the Planning Board authorized the formation of an Ad Hoc Committee, comprised of board members and community volunteers from both the private and business sectors, to comprehensively review and update our master plan and to respond to several enforcement issues that had become a concern for the Selectmen. The effort has been remarkably successful thanks to the hard work and dedication of the individuals involved. The relaxed and unceremonious atmosphere has provided a unique forum for exploring new planning concepts as well as evaluating our present ordinance and assessing its effectiveness for preserving our small-town New England heritage as we move into the next century.

The headlines and litigation throughout the last year have focused our attention on zoning interpretation and the compelling need to assess the effectiveness of our growth management strategies. We have undertaken a comprehensive review of our Master Plan to evaluate our needs and identify long term goals. We are looking at creative techniques for managing growth and protecting open space in both our residential and commercial districts, and we are investigating the effects of "sprawl" on our own community and how our present regulations may be contributing to it.

The Board is working hard to define that balance between growth and sustainability and preserving our natural, cultural and historic resources. We will continue to work pro-actively with citizens, developers and businesses to achieve benefits to our community that are measurable. Your involvement in the planning process insures that we are identifying issues of community concern. If you are unable to attend one of our scheduled hearings, please consider writing a letter to the Board. Your comment is important, we can not make informed decisions on your behalf without it.

In closing I would like to thank the Board members, Joanne Campbell, Jim Langdon, Patsy Rogerson, Joe Rogerson, Jeanne Forrest, and alternate, David Publicover and our ever patient secretary, Yvette, for a job well done. I would also like to recognize the following Ad Hoc Committee members, Bill Fabrizio, Frank Suprenard Sr., George Howard, Jeanne Forrest, and David Publicover, for their outstanding contributions to the amendments being proposed, and thank Laurie Pettengill for her many years of dedicated service. Thank you.

## **BARTLETT PUBLIC LIBRARY REPORT 1999**

The 1999 library circulation of books, periodicals, and audio-visual materials was 11,390. 1,203 books were added to the collection with 323 being gift books. The library received sixty-six new children's books provided through the Brownstone Book Foundation. The librarian attended two Five Rivers NHAIS meetings, two workshops and 2 children's books displays.

The library continues to increase its services by accessing NHAIS to directly catalog its books and to conduct searches for materials not available in our library. It circulated 464 books to New Hampshire libraries and borrowed 54 books. It also accessed Article Express, a service provided by the New Hampshire State Library, which provides full text magazine articles on the same day or next day of the request. The library provides a video collection which rotates every two months through the Bear Camp Valley Video Cooperative and the libraries in the Carroll County Library Cooperative.

The library conducted a summer series of five story hours for children using the NH libraries theme, Once Upon a Summer Reading, and would like to publicly thank Laurie Pettengill, Carol Halupowski, Ellen Gordon, Evelyn Albert and Kathie Van Deursen for conducting these story hours. A special program, "Stories and Stuff" sponsored by the New Hampshire State Council of the Arts and the Saul O. Sidal Memorial Foundation, was held as the culmination of this summer reading program. A special fall pre-school story hour was also held in the Garland's field in conjunction with a pumpkin hunt. A presentation by Carolyn Chute, author of Beans of Egypt Maine, was also held in December and was attended by approximately fifty people.

At the December trustees meeting the family of Brett Chandler Beyerle presented a sculpture and a self portrait in memory of their son, Brett. This sculpture of an otter with a brook trout was sculpted by Ellen Brown of Wiscasset, Maine. Children visiting the library stop to stroke the otter and to show it off to newcomers in the library. It is a welcome addition to our library and especially so as a memorial of one of our former students.

Using a bequest from Howard Nichols, designed for services for adult patrons, the library is developing a computer corner in

the library for adult patrons by purchasing a new computer, printer, scanner, table and chair. Internet access will soon be available. The library also hopes to purchase genealogy programs for those interested in researching their heritage. Suggestions for the purchase of other programs are welcome.

Mrs. Garland, school and public librarian, resigned her job as school librarian after 31 years in this position. She is, however, continuing in her position as public librarian.

At their January meeting the trustees voted to change the Bartlett Public Library's hours open in order to better meet the needs of our high school students. The library will now be open on Thursdays from 2 to 5 and closed on Fridays. The new schedule of hours open is listed below. The school library also continues to welcome public library patrons to use the library when-ever the school is open. Do plan to visit your library this new millennium to use the many services available to you.

## THE BARTLETT HISTORY FUND

The Bartlett History Fund was established by the Bartlett Library Trustees following the Town's bicentennial in 1990. The purpose of the History Fund is to further the recording of the history of Bartlett and its vicinity. Profits from the sale of the local history, *Bartlett, New Hampshire, In the Valley of the Saco*, and the sale of bicentennial memorabilia were set aside to establish the Bartlett History Fund.

The following guidelines for the Bartlett History Fund have been established:

- All monies received from future sales of the Bartlett History books, bicentennial memorabilia, and any other project undertaken by the Trustees for the History Fund will go into the History Fund.
- This money is put into a separate account under the name "Bartlett History Fund."
- This fund may not be used for the Library budget. The Library may, however, use this fund to purchase books and material relating to the history of the town. This material will then become a part of the Bartlett History Collection which is being maintained in a special fireproof file cabinet.
- The money in the History Fund may be expended for historical projects, pictures, postcards, and other types of historical materials.
- The Bartlett Library Trustees must approve the above expenditures. Donations of materials and monetary gifts may be made to the Fund.

Cash on hand as of December 31, 1999 is \$10,699.66.

The Library has copies of its two histories: *Bartlett, New Hampshire, In the Valley of the Saco*, and *The Latchstring was Always Out: a History of Lodging Hospitality and Tourism in Bartlett, New Hampshire*, by Aileen Carroll, for sale. These books are also on sale in the local bookstores.

## **BARTLETT-JACKSON EMERGENCY MEDICAL SERVICE REPORT**

In 1999 we had 335 calls for service. This is up 8% over last year. Medical and rescue services are being utilized more and more as the years go by. We have many calls our members go on alone that are not recorded because we received phone calls at our homes that patients do not want put out over the radio system or they know one of us and feel more comfortable this way.

We currently have 21 members on the service. Most members can not get away from their jobs during the day to answer calls, which puts an excess burden on the few that can. Many people nowadays work more than one job. For the past two winters we have paid two members per hour to be at the Glen Station on weekends to be sure we have coverage. During weekdays, we pay two members a stipend to be available at a moment's notice. The revenues available to us far outweigh the expenses incurred. This can be seen by looking at the taxpayer contribution to the operating budget. This will be the fifth year in a row that we come to you with a zero budget request.

In 1999 non-compensated, volunteer time given to the Towns of Bartlett and Jackson were over a thousand hours. These people can only be stretched so far. It is finally time for all taxpayers of Bartlett and Jackson to consider a full time position to operate the Bartlett-Jackson Emergency Medical Services. This can be done with a minimal impact on the tax rate. The first year it would not cost taxpayers anything, we can fund it on our own revenues. The following years I firmly believe it may be able to sustain itself. I say this after careful consideration and operating the service for about the past 18 years. This needs to be addressed in a timely fashion.

As many of you have seen, we received our new ambulance this past summer. We are all very pleased with the quality and design of the vehicle. Hundreds of man hours went into the specifications to conform it to our own needs. This vehicle should last us well over ten years.

We would like to offer our condolences to the family of Jackson Selectman Peter Kelley. He will be missed for his common sense approach to any problem.

## TOWN FOREST FIRE WARDEN AND STATE FOREST RANGER ANNUAL REPORT 1999

To aid your Forest Fire Warden, Fire Department and State Forest Ranger, contact your local Warden or Fire Department to find out if a permit is required before doing ANY outside burning. Fire permits are required for any open burning unless the ground is completely covered with snow where the burning will be done. Violations of RSA 227-L:17, the fire permit law and the other burning laws of the State of New Hampshire are misdemeanors punishable by fines of up to \$2,000 and/or a year in jail. Violators are also liable for all fire suppression costs.

There are eleven Forest Rangers who work for the New Hampshire Division of Forests and Lands, Forest Protection Bureau. During the 1999 season Forest Rangers were busy assisting communities with suppression of difficult and remote multi-day fires. Forest Rangers have also investigated numerous complaints regarding violations of the timber harvest and forest fire laws, and taken enforcement action to ensure compliance. If you have any questions regarding forest fire or timber harvest laws, please call our office at 271-2217.

There are 2400 Forest Fire Wardens and Deputy Forest Fire Wardens throughout the state. Each town has a Forest Fire Warden and several Deputy Wardens who assist the Forest Rangers with forest fire suppression, prevention, and law enforcement. The 1999 fire season was a challenging but safe year for wildland firefighters in New Hampshire. The severe drought conditions throughout the spring and summer months combined with residual effects of 1998 Ice Storm, resulted in a dramatic increase in wildland fires. In addition to burning in excess of 452 acres, 35 structures were also impacted by wildfire. Wildland fires in the urban interface is a serious concern for both landowners and firefighters. Homeowners can help protect their structures by maintaining adequate green space around them and making sure that houses are properly identified with street numbers.

The State of New Hampshire operates 15 fire towers, 2 mobile patrols and 3 contract aircraft patrols. This early detection and reports from citizens aid in the quick response from local fire departments. This is a critical factor in controlling the size of wildland fires and keeping the loss of property and suppression costs as low as possible.

Please contact your local fire department before doing ANY outside burning.

## **BARTLETT ATHLETIC AND RECREATION ASSOCIATION 1999 ANNUAL REPORT**

At the 1999 Annual Town Meeting, the legislative body directed the Selectmen to establish a recreation department and also set aside \$16,000 to be used towards this mandate. Following the meeting, the Board of Selectmen appointed a study committee to develop recommendations for the formation of the recreation department. Serving on this committee was Robert Boynton, Kevin Donovan, David Wilson, Jeanne Forrest, Paula Graham, Leslie Mallett, David Roode, and Charles Russo.

The goal of the committee was to determine the needs of the community, evaluate existing programs, develop an organizational structure that would satisfy present needs, address long range planning, and utilize current resources.

As the committee set out to develop a plan and recommendation, they easily came to the conclusion that most of what is done in the way of recreation and sports occur through the use of the Bartlett Elementary School facilities. We have no community center, nor does the committee see the immediate need for one. The school was built with the community in mind and there is a long history of the use of the building on a year-round basis for recreation. Not only is the summer recreation program already held at the school, but the building is constantly in use by other recreational activities such as Scouts, drama club, Adult Basketball, etc. The committee also recognized that the programs offered through BARA have historically been in the late spring and summer months. What stood out was the development in recent years of a very strong recreational and enrichment program offered during the school year through the school. These include an after school enrichment program, adult education, a strong technology program and a sports program that is offered as early as first grade.

The committee concluded that we already have many of the components of a comprehensive year round recreation program but they are being run and paid for by fragment means. The committee developed a plan that would gather all of these programs under one "roof" and be coordinated with one Director. You will be asked to approve this recommendation at the deliberative session of Town Meeting this year.

If approved, a full time year round Recreation Director will be hired to run the new department, which will be housed within the Bartlett Elementary School. The department will assume responsibility for all of BARA's existing programs such as Bambino, Little League and Babe Ruth baseball/softball, the summer recreation program, soccer camp, and Christmas tree lighting. It will also oversee elementary level athletics, the enrichment program, clubs and adult education classes that

are currently offered through the Bartlett School. The Director will oversee all field maintenance and work towards developing partnerships for facilities such as what we now have with Glen Ellis Campgrounds and the Fields of Attitash.

In addition to the Director, the department will have a Board of Directors, appointed by the Selectmen, who will work with the Director and the Principal of the Bartlett School to prepare an annual budget for the submission to the Selectmen's office. The Board of Directors will also develop policies and procedures and be responsible for long range planning and fundraising.

Funding will be provided through a partnership between Town and School budgets. The school budget will cover approximately 40% of the department's operating budget through the transfer of funds from positions such as the Enrichment Coordinator and Adult Education Coordinator, as well as the co-curricular stipends associated with the programs that will be administered by the new department. Another 30% will be funded through a new appropriation under the Town's budget (warrant article this year). (The balance of the operating budget will be obtained through user fees and fundraising.)

We want to take this opportunity to thank the many men and women who have volunteered their time over the past twenty years through BARA. Because of their dedication, our families have had some quality recreational opportunities. Although the growth of our Town leads us down a more administrative approach to recreation, the study committee wants to emphasize that without volunteers no Director or Department will have a chance to succeed. We encourage anyone wishing to help get this department off to a great start to look towards volunteering on the Board of Directors or involvement in an activity. Please contact the Selectmen's office and let them know what you can do to help!

## 1999 TOWN MEETING MINUTES

Moderator Robert Clark opened the Annual Town Meeting by opening the polls at the Town Hall on Tuesday, March 11, 1999 at 8:00 AM by reading the following:

To the inhabitants of the Town of Bartlett, New Hampshire in the County of Carroll in said State, qualified to vote in the Town affairs: You are hereby notified to meet in the Town Hall in said Bartlett on Tuesday, March 9, 1999 at eight o'clock in the forenoon to act upon the following subjects hereinafter set forth. The voting on Articles 1 - 3 will be by official ballot at the Town Hall and the polls shall open for balloting at eight o'clock in the forenoon and shall not close before seven o'clock in the evening. The following articles (Articles 4 - 28) in the warrant will be acted upon on Thursday, March 11, 1999 at six-thirty o'clock in the evening at the Josiah Bartlett Elementary School in Bartlett Village.

We hereby certify that we posted a like copy of said Town Warrant and Budget on February 22, 1999 at the Post Offices in Glen and Bartlett; at the Town Hall in Intervale (Bartlett) and the Josiah Bartlett Elementary School (the places of meeting), all being public places within the said Town of Bartlett, New Hampshire. Board of Selectmen: Gene G. Chandler, Richard F. Patch, Sr., David W. Roode.

ARTICLE 1. To choose all necessary Town Officers for the ensuing year.

ARTICLE 2. Are you in favor of the adoption of Amendment No. 1 as proposed by the Planning Board for the Town of Bartlett Zoning Ordinance as follows: To amend Article XII. Non-conforming Uses, Lots, and Structures, Section C by including a time frame in which to file the letter of intent to re-establish a non-conforming use (1 year) and to clarify its applicability to lots, structures and signs? (Planning Board favors, Selectmen favor) Vote YES or NO.

ARTICLE 3: Are you in favor of the adoption of Amendment No. 2 as proposed by the Planning Board for the Town of Bartlett Zoning Ordinance as follows: To amend Article XIV. Prohibited Uses by adding the following sentence at the end-"Pursuant to NH RSA 674:16-V aircraft take offs and landings on private land shall not be considered a valid or permitted accessory use in any district.?" (Planning Board favors, Selectmen favor) Vote YES or NO.

Meeting was adjourned until Thursday, March 11, 1999 at 6:30 PM at the Bartlett School.

Moderator Clark then opened the deliberative portion of Town Meeting on Thursday, March 11, 1999 at 6:35 PM at the

Bartlett School. Preliminary instructions were given on balloting on the first two articles and the need for voters to get their voting cards and ballots. Clark then read the results of the voting as shown above.

[Approximately 131 people present]

Moderator Clark then proceeded with the rest of the warrant as follows:

ARTICLE 4. To see if the Town will vote to raise and appropriate the sum of \$250,000.00 for the purchase of a new fire truck and to authorize the issuance of not more than \$250,000.00 of bonds or notes in accordance with the provisions of the Municipal Finance Act (RSA Chapter 33) and to authorize the municipal officials to issue and negotiate such bonds or notes and to determine the rate of interest thereon (2/3 majority ballot vote required for passage). Selectmen favor. Motion was made and seconded to accept the article as read. David Roode spoke to the article by explaining that a committee had been formed 1-1/2 years ago to study the need for a new fire truck and once the need was determined, the group came up with the truck proposal to fill the need. Roode thanked the members of the committee - Fire Chief Roger Labbe, Pat Roberts, Joe Frackleton, and Robert Jones - and then called upon Chief Labbe to explain the truck. Chief Labbe also thanked the members of the committee adding that Bryan Campbell was also part of the study committee in the beginning. Labbe went on to explain the fire truck. Moderator Clark asked for any questions. The question was raised about whether this truck would have the ability to put out a fire at the Grand Summit Hotel. Labbe responded that it would. The question then was raised about the offer made by LBO Holding at the time of the hotel zoning amendment to pay for a fire truck for the town. Chandler explained that no formal offer was ever made by LBO Holding to the town. Chandler also went on to explain that it appears that the truck will be more in the \$230,000 range and that we may not need to borrow this full amount, that the decision on the amount will be made after the formal bids go out for the truck and at the time of the setting of the tax rate to try to insure the least impact on property taxes. No further discussion. Moderator Clark then explained that this article needed to be voted on by secret ballot since this was a bond issue and the polls would be open for at least an hour because the following article will also be a bond issue with a secret ballot vote. They



would both need a 2/3 majority of those present and voting to pass. Polls were opened at 6:55 PM.

Moderator Clark then stated that he made a Town Meeting faux pas and forgot to do the Pledge of Allegiance. He then asked student Lance Pelletier to lead the group in the Pledge of Allegiance.

ARTICLE 5. To see if the Town will vote to raise and appropriate the sum of \$300,000.00 for town road improvements and reconstruction and to authorize the issuance of not more than \$300,000.00 of bonds or notes in accordance with the provisions of the Municipal Finance Act (RSA Chapter 33) and to authorize the municipal officials to issue and negotiate such bonds or notes and to determine the rate of interest thereon (2/3 majority ballot vote required for passage). Selectmen favor. Motion was made to accept the article as read. Chandler spoke to the article. John Murphy questioned which roads would be worked on and he was referred to the Selectmen's Report included in the Town Report. Murphy then had some questions on various roads and Chandler responded. Bill Duggan stated that this was a lot of money to spend without a plan and he would like to see something more concrete. Chandler explained that we know we were directed to prepare a 10 year plan at last year's town meeting but we have not been able to get it done. It is also very difficult to do since you never know how the roads are going to come out of the winter season and the plan changes constantly. Chandler also added that with this amount of money for the work that the town road crew would not be able to do this all themselves and that private contractors would be hired, hopefully local ones. Billy Fabrizio stated that he felt the Cobb Road repair took too long and hoped this would not occur again. No further discussion. Moderator Clark then opened the polls for voting by secret ballot on this article.

ARTICLE 6. To raise such sums of money as may be necessary to defray Town charges for the ensuing year and make appropriations of the same. Selectmen favor. Motion was made and seconded to accept the article as read. Chandler spoke to the article by reviewing the detail of the budget as well as the revenues as shown in the Town Report. No discussion. VOTE WAS TAKEN = PASSED BUDGET AMOUNT OF \$1,041,600.

ARTICLE 7. To see if the Town will vote to raise and appropriate the sum of \$120,000.00 for the purchase of a new 4 wheel drive plow truck, plow and wing, and two stainless steel spreader

bodies. Selectmen favor. Motion was made and seconded to accept the article as read. Chandler spoke to the article directing voters attention to the explanation of warrant articles in the Town Report. No discussion. VOTE WAS TAKEN = PASSED.

ARTICLE 8. To see if the Town will vote to raise and appropriate the sum of \$21,100.00 for the purchase of a new white, marked, police cruiser and related communication/safety equipment. Selectmen favor. Motion was made and seconded to accept the article as read. Patch spoke to the article. VOTE WAS TAKEN = PASSED.

ARTICLE 9. To see if the Town will vote to raise and appropriate the sum of \$23,000.00 as Bartlett's share for the purchase of a new ambulance for the Bartlett-Jackson Ambulance Service. Selectmen favor. Motion was made and seconded to accept the article as read. Chandler spoke to the article and made a motion, which was seconded, to amend the amount to \$21,700. VOTE WAS TAKEN ON THE AMENDMENT - PASSED. VOTE WAS TAKEN ON THE ARTICLE AS AMENDED - PASSED \$21,700.

ARTICLE 10. To see if the Town will vote to raise and appropriate the sum of \$3,400.00 to purchase Jackson's share of the old Bartlett-Jackson ambulance for use as an equipment vehicle for the Bartlett Fire Department. Selectmen favor. Motion was made and seconded to accept the article as read. Chandler spoke to the article. No discussion. VOTE WAS TAKEN = PASSED.

ARTICLE 11. To see if the Town will vote to raise and appropriate the sum of \$26,000.00 to go towards the reimbursement of the purchase price of the former Bartlett Hotel site, removal of two underground tanks and landscaping of the site. Selectmen favor. Motion was made and seconded to accept the article as read. Chandler spoke to the article, explaining the chronology of events, the reasons for them and that a committee had been formed for planning the site. John Murphy spoke against the article questioning maintenance issues and doesn't feel there's a need for more green area. Leslie Mallett, spoke in favor of the article as a member of the planning committee, explained the work the committee had done, explained some of the grants that are available for landscaping and preserving such a site, explained benefits of the park, and thanked the donor for having the foresight to help the town. Pat Yannone spoke against the article stating she was representing her broth-

er-in-law who used to own the property and donated it to the church as a tax write-off, that the Selectmen did not contact them about purchasing it, and that there was an explicit understanding with the church and the realtor that it was not to go to the town, knew nothing about any involvement with the town until two weeks ago when the article came out, her brother-in-law was making the contribution for purposes of a tax deduction (appraised at \$125,000) and that the church lost an \$85,000 asset, that only one deed has been recorded as of this day, that this is under litigation and should not be voted on but should be tabled. Debbie Phaneuf spoke to the article saying that the church did receive it and they can do what they wish with it. Gerry Tilton, representing the Church, spoke to the article stating that the property was turned over to the church, to her knowledge there was no stipulation that they should not turn it over or sell it to the town, at the time they received it, it was a liability with a big hole in the covered foundation and they were not able to carry the financial liability, felt town would better use the property and use it as a whole for the good of the town and it was not their intent or plan to make any money on it. Chandler stated that if anyone wanted to look either now or later that we have copies of all the deeds and letters. Pat Yannone spoke again questioning why the deeds had not been recorded, that the town used the church as a tool to do their dirty work to get this property. Chandler explained the timetable on the deeds and the boundary line adjustment to the Yannone family, that they should now be recorded. Yannone questioned again why the deeds had not been recorded and why everything was so hush hush. Chandler responded that nothing was hush hush, there have been articles in the paper about the committee doing their work and nothing hush hush. Yannone questioned whether Chandler didn't just state that the town used the church as a tool to get that property. Chandler said no. Yannone questioned whether the town was currently in litigation with the church, real estate agent, and real estate company in getting a cease and desist order from their attorney. Chandler stated that's not litigation. Yannone disagreed, stated she agrees that something should be done with the property but does not agree with the way the town did it, it was dirty and wrong, Selectmen were involved in the beginning. Motion was made and seconded to table the article. VOTE WAS TAKEN = TABLE FAILED. Leslie Mallett spoke to the article stating that just because a deed is not recorded does not mean that the

transaction has not taken place, if all parties have signed the deed, you can keep it in your closet but it's still a valid transaction, recording it only puts the world on notice. Chandler stated that since this whole process started that Town Counsel has been involved and kept abreast of all activities, the town did receive a cease and desist order from the Yannone's attorney, but our Town Counsel has said that everything we have done is legitimate and no reason why we can't proceed with this article. Motion was made and seconded to move the question. VOTE TO MOVE THE QUESTION = PASSED. VOTE ON THE ARTICLE = PASSED.

After the vote of Article 13, Selectman Chandler acknowledged that Stoney Morrell, representing the Morrell Corp., was the generous donor that allowed the town to acquire the property, it was very generous of him to take the risk that he would not be reimbursed for this, and we are fortunate that he had the civic-mindedness and foresight that this property was an asset to the town. There was a round of applause.

ARTICLE 12. To see if the Town will vote to raise and appropriate the sum of \$9,000.00 for the removal of underground storage tanks at the Town garage. Selectmen favor. Motion was made and seconded to accept the article as read. John Murphy asked why it was twice as much to remove these tanks as the ones at the hotel site. Chandler explained these tanks are twice the size. VOTE WAS TAKEN = PASSED.

ARTICLE 13. To see if the Town will vote to raise and appropriate the sum of \$16,000.00 for the creation of a recreation department for people of all ages who are residents of the Town of Bartlett, said department to have a paid staff person, and which department shall assume responsibility for, and supervision of, those youth programs heretofore supervised by the Bartlett Athletic and Recreation Association, which shall continue to serve the people of the Town of Bartlett, but in an advisory capacity to the recreation department. Agreeable to a petition signed by David Wilson and others. Selectmen oppose. Motion was made and seconded to accept the article as read. David Wilson spoke to the article. Maryellen Szetela spoke in favor of the article explaining that they will be looking into grants to support the program. Ruth Ainsworth spoke against the article feeling that parents and volunteers should continue to support the program. John Murphy spoke against the article citing that support of recreation in the school budget already totals \$80,000. Voter asked if each Selectmen would state why they are

opposed to it. Roode stated that he wants more detail before he can support it and no one presented anything other than the petition to the Selectmen. Chandler stated that he didn't know how the program would run and that there were a lot of questions that need to be answered. Patch stated he echoed both their comments and that the Selectmen are charged with the prudent management of the town's affairs and they did not have enough information to support it. Voter stated that the missing link in this community is the lack of a recreation department. Wilson stated that BARA has been working on a plan but just not enough time to get it in to the Selectmen. Other voters spoke in favor of the article. Kathy Nealley spoke in favor of the article but stated that it was poor planning not to have presented a plan or more detail and suggested that we pass the article and ask the Selectmen and BARA to get together and work on a plan. Richard Ware stated that the article is faulty as worded as it states "residents" and does not include "summer residents" and is not legal and offered to amend the article to read "to see if the town will vote to create a recreation department" which was then seconded. Leslie Mallett then spoke to the amendment stating that no money was appropriated and asked if Ware would amend his motion to include the \$16,000. Ware agreed as did the second to the motion and the amendment now reads "to see if the town will vote to raise and appropriate \$16,000 to create a recreation department". VOTE WAS TAKEN = AMENDMENT PASSED.

Moderator Clark then announced that the polls were closed on Articles 4 and 5 and asked the ballot clerks to count the ballots. Polls were closed at 8:35 PM.

Peter Pelletier then called the Moderator on a point of order in that we did not vote on the article as amended in Article 13. Moderator Clark then returned to Article 13 and asked for a vote on the article as amended. VOTE WAS TAKEN = PASSED.

ARTICLE 14. To see if the Town will vote to raise and appropriate the sum of \$1,742.00 for the support of the Mount Washington Valley Economic Council. Agreeable to a petition signed by Kathlyn Nealley and others. Selectmen oppose. Motion was made and seconded to accept the article as read. Kathlyn Nealley spoke to the article. No discussion. VOTE WAS TAKEN = PASSED.

ARTICLE 15. To see if the Town will vote to raise and appropriate the sum of \$500.00 for the Mt. Washington Valley

Chamber of Commerce. Agreeable to a petition signed by Joanne Campbell and others. Selectmen oppose. Motion was made and seconded to accept the article as read. No one spoke to the article. Bob Jones spoke against the article stating that if no one is here to support it and explain it then we should vote it down. VOTE WAS TAKEN = FAILED.

ARTICLE 16. To see if the Town will vote to raise and appropriate the sum of \$1,998.00 to defray the expense of Disaster Services of the Mt. Washington Valley Chapter of the American Red Cross. Agreeable to a petition signed by Robert Boynton, Jr. and others. Chandler/Patch oppose - not a proper use of town funds for national organizations; people should have an individual choice concerning donations to charitable organizations/Roode favors. Motion was made and seconded to accept the article as read. Bob Boynton spoke to the article. John Murphy spoke against the article. VOTE WAS TAKEN = PASSED.

ARTICLE 17. To see if the Town will vote to raise and appropriate the sum of \$7,205.00 for the Children's Health Center. Agreeable to a petition signed by Vicki Varrichione and others. Selectmen oppose. Motion was made and seconded to accept the article as read. David Brooks, a non-resident, asked the body if he could speak to the article. Moderator asked for any objections, there being none, Brooks was allowed to speak to explain the program and its costs. VOTE WAS TAKEN = PASSED.

Moderator Clark then read the results of the secret ballot vote on Article 4 Fire Truck as being YES = 108 NO = 23 (PASSED) and Article 5 Roads as YES = 112 NO = 12 (PASSED).

ARTICLE 18. To see if the Town will vote to raise and appropriate the sum of \$2,000.00 for support of the Tri-County Community Action Program for the purpose of continuing services of the Fuel Assistance Program for the residents of Bartlett. Agreeable to a petition signed by Ellen Hayes and others. Selectmen favor. Motion was made and seconded to accept the article as read. No discussion. VOTE WAS TAKEN = PASSED.

ARTICLE 19. To see if the Town will vote to raise and appropriate the sum of \$1,458.00 for the Family Support Program of the Center of Hope, Inc. Agreeable to a petition signed by Allan Libby and others. Selectmen oppose. Motion was made and seconded to accept the article as read. No discussion. VOTE WAS TAKEN = PASSED.

ARTICLE 20. To see if the Town will vote to raise and appropriate the sum of \$1,236.00 to assist the Family Health Centre. Agreeable to a petition signed by Vicki Varrichione and others. Selectmen oppose. Motion was made and seconded to accept the article as read. No discussion. VOTE WAS TAKEN = PASSED.

ARTICLE 21. To see if the Town will vote to amend the wording of the Electioneering Ordinance which was passed at the 1987 Town Meeting and eliminate the words "any meeting" so that the new Ordinance would read: "To eliminate electioneering and/or signature gathering on Town or School owned property at elections held within the Town of Bartlett". Selectmen favor. Motion was made and seconded to accept the article as read. Chandler spoke to the article. John Murphy asked about signature gathering on town/school property. Chandler clarified that as long as it wasn't an election he could do it. Vicki Harlow asked if defeating this article would allow the candidates to stand outside town hall on election day. Clark stated no, it would just leave the wording as it was originally written. No further discussion. VOTE WAS TAKEN = PASSED.

Motion was made and seconded to vote on Articles 22-27 as a block. Ruth Ainsworth asked about amending an article in the block. Clark stated she could after we voted to take them as a block. VOTE ON TAKING ARTS. 22-27 AS A BLOCK = PASSED. Motion was made and seconded to amend Article 23 to the amount of \$1,000. Ruth Ainsworth spoke to the amendment and Karen Hebert offered supportive information. Chandler clarified that the Selectmen supported the amount \$650.00 since that is what the agency asked for and does not favor the \$1,000. VOTE WAS TAKEN ON THE AMENDMENT = PASSED \$1,000 FOR ARTICLE 23. VOTE WAS TAKEN ON THE BLOCK OF ARTICLES 22-27 AS AMENDED = PASSED.

Therefore, the following articles passed as amended:

ARTICLE 22. To see if the Town will vote to raise and appropriate the sum of \$500.00 for support of operating expenses of the Eastern Slope Regional Airport Authority. Selectmen favor. (PASSED).

ARTICLE 23. To see if the Town will vote to raise and appropriate the sum of \$650.00 for the support of Starting Point for providing crisis services to victims of domestic and sexual violence and their children. Agreeable to a petition signed by

Karen Hebert and others. Selectmen favor. (PASSED AMENDED AMOUNT OF \$1,000)

ARTICLE 24. To see if the Town will vote to raise and appropriate the sum of \$2,326.00 for the Visiting Nurse Services of Northern Carroll County, Inc. Agreeable to a petition signed by Terrie Kroger and others. Selectmen favor. (PASSED).

ARTICLE 25. To see if the Town will vote to raise and appropriate the sum of \$2,700.00 to assist the Carroll County Mental Health Service. Agreeable to a petition signed by Vicki Varrichione and others. Patch opposes - Chandler/Roode favor. (PASSED).

ARTICLE 26. To see if the Town will vote to raise and appropriate the sum of \$4,769.00 for the support of the Gibson Center for Senior Services. Agreeable to a petition signed by Maury Beaumont and others. Selectmen favor. (PASSED).

ARTICLE 27. To see if the Town will vote to raise and appropriate the sum of \$1,725.00 for the Early Support and Services Program (birth to 3 years) of Children Unlimited, Inc. Agreeable to a petition signed by Kimberly Perley and others. Selectmen favor. (PASSED).

ARTICLE 28. To transact any other business that may legally come before said meeting. Bob Holmes asked about the status of E-911 mapping. Chandler explained it has been a long process but we are progressing. Ruth Ainsworth expressed that as a postal worker that numbers certainly help and that displaying the number should be mandatory to make it easier for emergency personnel especially with so many visitors in the area.

A voter asked that the Selectmen follow up with Attitash on the contribution toward the new fire truck. Selectmen agreed to send a letter.

Tom Caughey expressed his satisfaction with the town taking care of their underground storage tanks and would ask that the town address the containment of salt at the town sand/salt pile which is killing the trees along the river.

Motion was made and seconded to adjourn. VOTE WAS TAKEN - ADJOURNED AT 9:15 PM.

## TOWN OF BARTLETT REGULATIONS

The Town of Bartlett Officials closely monitor compliance with the following ordinances, regulations, and by-laws. This list is provided to make people aware that these regulations exist and a summary of each regulation appears here. Complete descriptions may be obtained from the Selectmen's Office and any questions should be directed to that office.

\*\*\*\*\*

**WINTER PARKING ORDINANCE:** prohibits parking on town streets between Nov. 1 and May 1 (24 hours a day). Violation = fine of up to \$50.00 plus towing charges.

**SNOW PLOWING REGULATION:** prohibits the plowing of snow into or across any town road.

**EXCAVATION PERMIT REGULATION:** requires permits to be acquired 24 hours prior to excavation in a town road. Violation - fine of \$100.00.

**ILLEGAL DUMPING ORDINANCE:** prohibits dumping and littering at other than in authorized areas at the Transfer Station. Violation - fine of \$100.00.

**ALCOHOLIC BEVERAGE ORDINANCE:** prohibits drinking of alcoholic beverages in public places. Violation - fine of \$25.00.

**TEST PIT INSPECTION ORDINANCE:** requires inspection of pits prior to application for State septic design approval. Fee of \$20.00 per pit dug.

**SEPTIC SYSTEM DESIGN AND CONSTRUCTION ORDINANCE:** governs the design and construction of septic systems and requires all septic system designs, prior to submission to the State, to be reviewed by the Selectmen's Office. Fee of \$50.00 per design.

**BUILDING PERMIT ORDINANCE:** required for construction valued at \$1,000 or more, AND/OR which would affect the assessed value of a property, AND/OR to which zoning requirements apply. Violation = fine of up to \$100/day.

**PERMIT TO OCCUPY ORDINANCE:** required prior to occupancy of any construction that is intended for habitation or for which a septic system is required. Violation = fine of up to \$100 and/or \$10/day each day of violation.

**ZONING ORDINANCE:** requires compliance with such items as signs, setbacks, density, green areas, frontage, permitted uses, etc.

**FLOODPLAIN ORDINANCE:** governs activity in the floodplain.

**GRAVEL PIT ORDINANCE:** governs excavation of gravel pits.

**DOG LEASH BY-LAW:** requires that all dogs be restrained by leash or under direct control of owner. Violation - fine of up to \$100 plus board reimbursement.

**SPECIAL EVENTS ORDINANCE:** regulates the conduct of special events. Violation = fine of up to \$300.

**ELECTIONEERING ORDINANCE:** eliminates all electioneering or signature gathering on Town or School owned property at any meetings or elections held within the Town of Bartlett.
