

#### COMMISSIONERS' REPORT

To the Citizens of Belknap County:

In compliance with the Laws of the State of New Hampshire, the Commissioners of Belknap County herewith present the annual report of the County Commissioners, Treasurer, Superintendent of Farm and House of Correction, Clerk of Superior Court, Sheriff, Solicitor, Farm Physician, Chaplain, Auditors, for the year ending December 31, 1931.

Belknap County mourns the loss of Charles F. Locke, our senior member, who died October 20, 1931. Mr. Locke had served the County in various capacities for many years. The vacancy caused by the decease of Mr. Locke was filled by the appointment of Joseph F. Smith of Meredith.

Belknap County is very fortunate in securing Mr. and Mrs. W. J. Hartford, who have both had wide experience in Institutional Work, to fill the vacancy at the farm made by the removal of Superintendent and Mrs. Magill.

The laying of a new water pipe and the purchase of additional fire hose are among the most important improvements towards protecting our County Farm Buildings. This labor and all repairs made on the farm buildings has been done as much as possible by the unemployed, who were receiving aid from the county. These men also did the greater part of the work in grading the Court House lawn after the removal of the Abbott buildings.

The Overseer of the Poor of Laconia, the Selectmen of the towns, and other officials have cooperated with us in our efforts to provide for the poor.

We desire to extend to them and all others who have contributed to the comfort, entertainment and spiritual welfare of the people under our care and supervision, our sincere thanks.

As Solicitor for Belknap County I beg to report that during the past year aside from the prosecution of criminal cases my department has been engaged to a great extent in the settlement of pauper cases, a matter which has held the attention of every solicitor of the State. The amount of correspondence has been larger than ever before.

The prosecution of criminal cases has taken the greater part of my attention and while the county has not been put to the expense of a single jury trial, the expenses incurred in the apprehension of criminals has been large. The records of the Clerk will show a large number of cases where respondents have been sent to prison for crimes of burglary, statutory offenses and in bad check cases. At the coming March 1932 Term several burglary cases will be disposed of. My department with the assistance of the sheriff, has done its utmost to apprehend criminals who during the depression have robbed the homes of the citizens of this county.

To print a detailed report of my department would be an expensive burden for the tax payers of the county to pay but if any information that can be properly given out is desired by any citizen of the county it will be cheerfully furnished. During the past year I have personally given advice not only to the commissioners, but to hundreds of worthy citizens who have asked for it, and I shall endeavor to do so while I remain in office.

That in the exercise of authority granted by and in compliance with an act of the General Court of the State of New Hampshire approved May 7, 1931, entitled: "An Act authorizing the County of Belknap to issue Bonds," the County Commissioners of said County be and the same are hereby authorized and directed to prepare, issue and sell for and on behalf of said County serial coupon bonds in the aggregate principal amount of sixty-five thousand (65,000) dollars for the purpose of meeting deficiencies in money raised for county expenses heretofore made and or accrued which on said May 7. 1931 amounted to at least \$65,000. Said bonds shall be dated August 1, 1931, shallbe payable \$6500 on the first day of August, each year, 1932 to 1941 inclusive, shall be in in the denominations of \$1000 and \$500 and shall bear interest at the rate of 4% per annum payable semi-annually. Other particulars as to the form, issuance and sale of said bonds shall be determined by the County Commissioners.

No further business appearing before the Convention, it was voted to adjourn.




