

SELECTMEN'S REPORT

1985 has been a busy year, keeping up with changing times and managing the Town business with the best of our ability, for the benefit of the taxpayers.

Our Town Hall is looking good, and we feel that before a great deal more money is invested, a study committee should be appointed to study future space needs for the Town.

We are still studying our sanitation waste needs. We must arrive at the best solution for the Town of Deering.

Our Rescue Squad under the leadership of Captain Gordon Sherman has the Selectmen's approval to put on-line a rescue vehicle for the Town. This will help to relieve Hillsboro and Weare Rescue Squads who over the past years have faithfully responded to Deering calls.

Our Police Department under the leadership of Chief Alfred Kelley has done a fine job keeping our Town, and our children waiting for their school buses, well protected.

Our Fire Chief William Edes has with guidance from the Fire Wards maintained a good functional Fire Department for the Town. Consideration should be given for establishing a Capital Reserve Fund to purchase new fire trucks. Future consideration should be given to planning a new fire house for the center of Town.

Our Highway Department headed by Peter Beard has increased maintenance operations on our roads. In the last two years with building permits up and demands on our roads increasing, more frequent repair and maintenance is needed. The Highway Department has a great need for another dump truck to haul sand and gravel, also to plow snow. This would reduce private contract expense and make the Department more efficient. For the first time in many years the Town chose to upgrade roads in Deering at the last Town Meeting. We are hopeful that the voters will continue to support the upgrading of more roads in the Town.

The Planning Board Chairman Robert Pilley and Zoning Board Chairman James Wolf have been keeping their Boards busy with subdivisions, preparing a Zoning Ordinance for the Town, and (as directed by State Law) redoing the subdivision regulations.

The Conservation Commission under the guidance of Robert Lorber has been keeping an eye on Deering Lake striving to keep it pollution free.

Once again we thank the many public spirited citizens who serve on the various boards and committees without compensation. We also wish to recognize all our employees for carrying out their respective duties to deliver the services required by the Town. A special thanks to those persons who have given us guidance and support during the year. Thank You.

TOWN WARRANT

To the inhabitants of the Town of Deering in the County of Hillsborough, in said State, qualified to vote in Town Affairs,

GREETINGS:

You are hereby notified to meet at the Town Hall in said Deering on Tuesday, the 11th day of March next, at 10:00 A.M. in the morning to act upon the following subjects;

Article 1. To choose all necessary Town Officers for the ensuing year.

Article 2. To bring in your votes on the Proposed Zoning Ordinances. Polls will open at 10:00 A.M. in the morning and will remain open until 6:00 P.M. (The polls may be continued to be open following the above hour by vote of the meeting, but may not be closed before the hour of 6:00 P.M. - RSA 39:2).

Additionally, pursuant to RSA 39:2a you are hereby notified that Article 3 through 38 will be taken up at 7:30 P.M.

(All articles hereinafter are submitted by the Selectmen unless otherwise noted).

Article 3. To see if the Town will vote to accept the reports of the Town Officers, Agents, Committees and Auditors for the year 1985.

Article 4. To see if the Town will vote to authorize the Selectmen to borrow money in anticipation of taxes and to raise and appropriate the sum of \$12,500. for payment of interest expense, or to take any other action relating thereto.

Article 5. To see if the Town will vote to authorize the Selectmen to auction property taken by Tax Collector's Deeds, in accordance with the provisions of RSA 80:42.

Article 6. To see if the Town will vote to raise and appropriate the sum of \$858. for the Contoocook Valley Counseling Center or to take any other action relating thereto.

Article 7. To see if the Town will vote to raise and appropriate the sum of \$500 for the support of the Hillsboro Park Board, or to take any other action relating thereto.

Article 8. To see if the Town will vote to raise and appropriate the sum of \$5000 for the support of the Hillsboro Youth Services Director or to take any other action relating thereto.

Article 9. To see if the Town will vote to raise and appropriate the sum of \$400 for the current operating expenses of the Planning Board; \$400 for the current operating expenses of the Zoning Board of Adjustment and \$400 for the current operating expenses of the Conservation Commission, or to take any other action relating thereto.

Article 10. To see if the Town will vote to raise and appropriate the sum of \$700 for membership fee for the Central New Hampshire Regional Planning Commission for the ensuing year or to take any other action relating thereto.

Article 11A. To see if the Town will vote to raise and appropriate the sum of \$13,500 for continued use of the Hillsboro Landfill (Deering's share for the cost of using the Landfill to be determined by dividing the sum of the equalized evaluation of both Deering and Hillsboro into the cost of the Landfill's operation and multiplying the result by Deering's equalized evaluation) and for refuse removal, or to take any other action relating thereto.

Article 11B. To see if the Town will vote in principle to use the same formula stated in Article 11A to determine Deering's share of the cost of closing the Hillsboro Landfill when at such future date it is mandated that the Landfill must be closed and sealed, or to take any other action relating thereto.

Article 12. To see if the Town will vote to raise and appropriate the sum of \$60,000 to purchase land and the sum of \$20,000 to set up and operate a transfer station for solid waste disposal, or to take any other action relating thereto.

Article 13. To see if the Town will vote to raise and appropriate the sum of \$905 for the Concord Regional Resource Recovery Cooperative, Town's share based on annual tonnage, or to take any other action relating thereto.

Article 14. To see if the Town will vote to raise and appropriate the following sums of money:

1. Town Officers Salaries	\$ 14,900.
2. Town Officers Expenses	24,500.
3. Election & Registration	2,000.
4. Town Buildings	15,500.
5. Cemeteries	4,000.
6. Reappraisal of Property	3,500.

and to raise and appropriate such sums of money as may be necessary to defray Town Charges for the year 1986, or to take any other action relating thereto.

Article 15. To see if the Town will vote to raise and appropriate the sum of \$5000 for the paving of the parking lot at the Town Hall, or to take any other action relating thereto.

Article 16. To see if the Town will vote to raise and appropriate the sum of \$35,000 for the purchase of Highway equipment, namely the OshKosh and the purchase of a second dump truck, and authorize the withdrawal of \$12,000 for this purpose from the Federal Revenue Sharing Fund, or to take any other action relating thereto.

Article 17. To see if the Town will vote to raise and appropriate the sum of \$48,247 for the improvement and repairs to portions of East Deering Road, Old County Road and Peter Woods Hill Road, or to take any other action relating thereto.

Article 18. To see if the Town will vote to raise and appropriate the following sums of money for Highway Purposes:

1. Maintenance and General Expenses of the Highway Department \$176,829.
2. Road Sealing 21,120.

(State Share Highway Block Grant Aid \$52,921.99), or to take any other action relating thereto.

Article 19. To see if the Town will vote to raise and appropriate the sum of \$10,000 for the Highway Equipment Capital Reserve Fund, or to take any other action relating thereto.

Article 20. To see if the Town will vote to raise and appropriate the sum of \$23,000 for the Fire Department, or to take any other action relating thereto.

Article 21. To see if the Town will vote to raise and appropriate the sum of \$10,000 for the Fire Truck Capital Reserve Fund, or to take any other action relating thereto.

Article 22. To see if the Town will vote to raise and appropriate the sum of \$18,500 for the Police Department and the sum of \$200 for Civil Defense, or to take any other action relating thereto.

Article 23. To see if the Town will vote to raise and appropriate the sum of \$3000 for the Police Cruiser Capital Reserve Fund or to take any other action relating thereto.

Article 24. To see if the Town will vote to raise and appropriate the sum of \$500 for the support of Rescue Squads, or to take any other action relating thereto.

Article 25. To see if the Town will vote to raise and appropriate and authorize withdrawal from the Federal Revenue Sharing Fund for use as setoff against budget appropriations in the amounts indicated, and, further to authorize the Selectmen to make pro-rata reductions in the amounts if estimated entitlements are reduced or to take any other action relating thereto.

Road Maintenance \$12,000.

Article 26. To see if the Town will vote to allow the Deering Historical Society to install a plaque on the World War I memorial stone in the Town Common. Said plaque will be approximately 10" by 28" and will be centered below the present plaque. Inscription will be as follows: This monument rededicated to those courageous men and women who served their country during times of strife, and to those who made the ultimate sacrifice. 1986.

Article 27. To see if the Town will vote to grant the Deering Historical Society facility (land and building) located on East Deering Road, a property tax exemption.

(Submitted by petition)

Article 28. To see if the Town will vote to oppose the burial, storage, and transportation of high level radioactive waste in the Town of Deering and State of New Hampshire; and to call upon Congress to conduct an independent investigation with full public participation into the feasibility and prudence of the U. S. Department of Energy's present plan to dispose of radioactive waste.

(The record of the vote on this article shall be transmitted to the Governor of New Hampshire, the New Hampshire Congressional Delegation, and to the President of the United States.)

(Submitted by petition)

Article 29. To see if the Town will vote to raise and appropriate the sum of \$5205 to be contributed to an area-wide task force to oppose the burial, storage, transportation, and production of high level radioactive waste in the Town of Deering and State of New Hampshire; and to call upon Congress to conduct an independent investigation with full public participation into the feasibility and prudence of the U. S. Department of Energy's (DOE's) present plan to dispose of radioactive waste and into the DOE's competence to carry out such a plan.

Article 30. To see if the Town will vote to adopt 261:157-a, Exemption for Prisoners of Wars, waiving the fee to be charged for a permit to register one motor vehicle owned by any person who was captured

and incarcerated for 30 days or more while serving in a qualifying war or armed conflict as defined in RSA72:28, IV, and who was honorably discharged, provided the person has provided the Town Clerk with satisfactory proof of these circumstances.

Article 31. Shall we adopt the provisions of RSA 72:37 for the exemption for the blind from property taxes? This statute provides that every inhabitant who is legally blind shall be exempt each year from the property tax on a residence to the value of \$15,000.

Article 32. To see if the Town will adopt an Ordinance to provide that the celebration of Halloween shall be held during the daylight hours the Sunday before October 31st.

Article 33. To see if the Town will vote to authorize the Selectmen to apply for, accept and expend money from the State, Federal or another governmental unit or a private source which becomes available during the year in accordance with the procedures set forth in RSA 31:95-b, or to take any other action relating thereto.

Article 34. To see if the Town will vote to authorize the Selectmen to trade, sell or otherwise dispose of any surplus Town property, or to take any other action relating thereto.

Article 35. To see if the Town will vote to authorize the Selectmen to accept or purchase on behalf of the Town any Federal or State surplus fire, police, or highway equipment or to take any other action relating thereto.

Article 36. To transact any other business that may legally be brought before this meeting.

TRUSTEES OF TRUST FUNDS REPORT

Projects this past year included extensive tree work, either complete removal or trimming. Cemeteries covered included West Deering, Appleton and East Deering. The fence at East Deering was completely replaced, with a two-rail, treated lumber, with urn finials. Funds for the fence came from the Gove Fund.

The Trustees would like to thank the Deering Historical Society for their most generous donation of the signs for each cemetery.

The Trustees have initiated a ten-year plan to upgrade the cemeteries. Prime concern is the condition of the grave stones, many of which are either sinking, or have been broken. The Keene Monument Company was hired this past fall to restore the stones in West Deering. A total of 78 stones were repaired. Repair included new footings of cement, rejoining of broken stone, and the setting in cement for those stones that could not be righted due to extensive breakage. The cost for all stone work was \$1700.

Our goal is to restore or partially restore a cemetery each year. The next project will be stone work in East Deering. Our appropriation this year is for an additional \$2500. towards this project. Due to the downward slide of interest rates, we will be unable to attempt this project without additional funding from the Town.

ROAD AGENT'S REPORT

I am pleased to report that in 1985 the following progress has been made in upgrading Deering's roads:

1. Major reconstruction of Skye Farm Road
2. Ditching, shimming and sealing of Reservoir Road.
3. Continued work on North Deering Road.
4. Continued graveling and improving drainage of the gravel roads.

Our plans for 1986 include the reconstruction of three deteriorating sections of asphalt roads:

1. A $\frac{1}{2}$ mile stretch of Old County Road.
2. A short stretch on East Deering Road.
3. A section of Peter Woods Hill Road.

We also plan to improve the drainage and regravels Longwoods Road. Continue widening the North Deering Road.

In 1986 I will be consulting with a paving engineer to draw up a pavement rating system which will supply us with an accurate though subjective index of the general conditions of each road. This index will be valuable in setting maintenance priorities and enable us to present to the Townspeople in 1987 a realistic long range plan for shimming and overlaying our existing roads with hot asphalt.

In closing I should like to add that while we will be continuing to improve the roads of Deering to handle the added traffic they are being subjected to, we will still endeavor to preserve the scenic beauty that we all so appreciate in our Town.

DEERING FIRE DEPARTMENT

The Deering Fire Department has had a very constructive year. 1985 has been a very busy year both in the number of responses and the work and training we have been continuing.

The Deering Fire & Rescue has made many advances in the training of our men and women over the past year. We have 6 new EMT's trained and certified and now have 9 of our members attending a State certification course for Fire Fighter I. Many of the members have also attended one and two day courses at Meadow Wood Fire School as well as other area schools.

I now have a membership of 36 men and women with more than 80% state certified. We have six trucks (3 pumpers - 3 tankers) and are in the process of bringing in an ambulance into service. We are bringing this ambulance on line because of problems with our neighboring towns not being able to service us any longer. We have support in this endeavor from both Hillsboro and Weare Fire & Rescue. The Deering Fire Rescue Company has worked many hours on this project and deserve a great deal of credit.

This past year we have been working on preplans of the Town and at present we are involved with the Historical Society trying to develop a local register of the Town's residents both for our use and that of the Historical Society.

The Board of Fire Wards and myself, as Chief of the Department, would like to express our thanks to the Town for its support of the Fire Department, also thank the residents for their efforts in "Fire Prevention" - it makes our job a lot easier. If at any time there is some question or suggestion to do with the Fire Department please feel free to contact me, the Fire Wards or the Selectmen. Your input is important.

REPORT OF TOWN FOREST FIRE WARDEN AND STATE FOREST RANGER

Between July 1984 and June 1985, we experienced more forest fires throughout our state than in any year in the last 50. Two of the leading causes of the 1605 fires were children and fires kindled without written permission of a Forest Fire Warden. Both causes are preventable, but only with your help.

Please help our town and state forest fire officials with forest fire prevention. Contact your Forest Fire Warden for more information.

Enforcement of a state timber harvest regulations is the responsibility of State Forestry officials. Our state has excellent timber harvest regulations; however, your assistance is needed.

If you know of a logging operation and suspect a state timber harvest law may be violated, call your Forest Fire Warden.

If you own forest land, you will become responsible for the timber tax payment starting April 1, 1986. This is a change in the Timber Tax Law that will impact all forest landowners. Contact your Board of Selectmen for timber tax forms.

CONSERVATION COMMISSION REPORT

The Commission provided camperships for two Deering students, John Thyng, Jr. and Shawn Corliss, to the Youth Conservation Camp conducted by the Society For The Protection of New Hampshire Forests. Any Deering student who has completed 8th grade and is between the ages of 13 and 18, interested in attending the camp, should contact the Commission before May 1.

Deering Clean-up Day was held on April 28, 1985. Lunch was served at the Deering Community Church to the 19 participants.

A joint effort with the Deering Association resulted in laying out, marking and clearing a nature trail in the Gregg-Sleeper lots.

Water samples from 5 locations in Deering Reservoir were submitted to the N. H. Water Supply and Pollution Control Commission for analysis for the presence of fecal coliform. Test results showed 19 parts per 100 milliliters of water at the North Inlet. Other test locations showed levels of 9, 6 and 4 PP100ML, with a count of 0 at the recreation area by the dam. While all test results were considerably below the 240 PP100ML limit considered acceptable for swimming and fish habitat, water at 4 of the locations exceeded the limit of 1 PP100ML for untreated drinking water. The Commission plans to continue this water testing program on an annual basis.

Signs were placed on the boundary of the Aucoin Lot on North Road, designating it as land under the supervision of the Deering Conservation Commission.

DEERING CONSERVATION COMMISSION

PLANNING BOARD REPORT

The Deering Planning Board during the year of 1985 saw signs of the wave of development produced by industrial growth of surrounding areas. Industrial growth primarily in the Merrimack River Valley, has created a need for land and residential housing. Developers are now looking at Deering as a community to satisfy these needs. With the potential for major development a reality, the Planning Board has worked in conjunction with the Zoning Board of Adjustment on updated subdivision regulations and a Town Zoning Ordinance. The Deering subdivision regulations and zoning ordinance have been written to allow for the orderly and systematic development of Deering in accordance with the Master Plan.

State recodification of RSA's associated with Planning and Land Use Regulations forced a rewriting and updating of the existing subdivision regulations. The Planning Board generated the new regulations on a word processor, so updates in the future will be much faster and easier to make. A public hearing on the new regulations was held in January of 1986, comments from the public hearing were taken under board advisement and appropriately incorporated into the regulations.

During the year of 1985, 12 subdivision applications were received. Of the 12 applications submitted, 2 were major subdivisions containing more than 4 lots, 8 were minor subdivisions, and 2 were lot line adjustments. This compares with 3 applications for subdivision during the year of 1984. The board approved 11 subdivisions: 2 major subdivisions, 7 minor subdivisions and 2 lot line adjustments.

The Planning Board was solicited by the Central New Hampshire Regional Planning Commission for interest in supporting the newly reorganized commission. The Planning Board discussed membership issues and whether the board would create a warrant item for the 700 dollar membership fee.

The Planning Board has generated preliminary plans to update the Town Master Plan and will be getting involved in this activity over the spring and summer months. The Town's input will be solicited and concerned citizens who are interested are gladly asked to participate.

The Planning Board meets the second Wednesday of the month at 7:30 p.m. at the Town Hall, and attendance by concerned citizens is always welcome.

ZONING BOARD OF ADJUSTMENT REPORT

The activity for the Zoning Board of Adjustment during 1985 has included five applications for variances; one to start a business which was approved and four for lot line adjustments. One of the four appeals was unnecessary as the proposed building addition was within the limits of the ordinance. Two of the others were approved and one denied. All decisions were made by a unanimous vote.

The balance of the year has been devoted to the formulation of a new ordinance as Interim Zoning, which was adopted April 19, 1984, will expire this March. The town has several options this year; extend Interim Zoning for one more year, adopt the new ordinance tailored to fit the needs of Deering proposed by the Planning Board, or do without zoning completely.

New Hampshire is the 15th fastest growing state in the nation. Deering will continue to share in this growth along with other rural communities. Zoning will be an essential element to control growth and to preserve property values.

Hillsboro -Deering School Board Member for three years - Joyce E. Bosse - 139; Barbara D. Cohen - 73; Jeffrey A Schadlet - 72; Margaret A. Scarcello - 53.

At 7:30 p.m. Charles A. Gaides, Moderator, opened the meeting with a salute to the Flag followed by a prayer. Article 2 through 14 were voted.

Article 2. It was voted to accept the reports of the Town Officers, Agents, Committees and Auditors for the year 1984.

Article 3. It was voted to authorize the Selectmen to borrow money in anticipation of taxes and to raise and appropriate the sum of \$12,500. for payment of interest expense.

Article 4. It was voted to authorize the Selectmen to auction property taken by Tax Collector's Deeds, in accordance with the provisions of RSA 80:42.

Article 5. It was voted to raise and appropriate the sum of \$827 for the Contoocook Valley Counseling Center.

Article 6. It was voted to raise and appropriate the sum of \$500 for the support of the Hillsboro Park Board.

Article 7. By amendment, it was voted to raise and appropriate the sum of \$4525 for the support of the Hillsboro Youth Services Director.

Article 8. It was voted to raise and appropriate the sum of \$400 for the current operating expenses of the Planning Board; \$400 for the current operating expenses of the Zoning Board of Adjustment; and \$400 for the current operating expenses of the Conservation Commission.

Article 9 and 10. It was voted to pass over Articles 9 and 10, to be considered after Article 27.

Article 11. It was voted to raise and appropriate the following sums of money:

And to authorize the Treasurer to pay each Selectman \$1500 per year and to raise and appropriate such sums of money as may be necessary to defray Town Charges for the year 1985.

Article 12. It was voted to raise and appropriate the sum of \$5000 for structural repairs and renovations of the Town Hall and to authorize the withdrawal of \$4516.74 for this purpose from the Federal Revenue Sharing Fund.

Article 13. By amendment it was voted to raise and appropriate \$5000 for the painting of the Town Hall and the sum of \$1000 for the painting of the library.

Article 14. By amendment it was voted to adopt an Ordinance for the Town of Deering as follows:

Whereas, the Town of Deering is desirous of adopting an Ordinance relative to Fire Protection in the Town of Deering and establishing guidelines and regulations for the administration of the Town of Deering Fire Department, be therefore ordained by the Town of Deering duly assembled at its Annual Meeting as follows:

The Town of Deering does hereby adopt the provisions of R.S.A. 154. (Vote Yes-73; No-50).

Section I. Establishment of Fire Wards

The Fire Wards of the Town of Deering shall constitute a Board of Fire Wards. There shall be five (5) fire wards, all of whom shall be residents of the Town of Deering, to be appointed as follows:

A. The Board of Selectmen shall appoint one of its own as an ex-officio member for a term of one year during his term of office.

B. The Fire Chief, during his term of office.

C. Three citizens from the Town, appointed by the Selectmen, one from each section of town, being East Deering, Central Deering and West Deering. These appointments shall serve staggered terms of three years respectively. At the first appointment one member shall be appointed for a one-year term, one member appointed for a two-year term, and one member appointed for a three-year term. No member of the Deering Fire Department other than the Fire Chief shall be eligible for appointment to serve as a fire ward. In addition, these appointed Fire Wards shall, of their own accord, attend at least two one-day courses, within six months, relative to Fire Department Administration and/or Fire Ground Management. If they fail to do so, they shall be removed and replaced within 30 days. (Vote Yes-71; No-24).

At this time, it was voted to adjourn this meeting and return on Thursday, March 14, 1958 at 8:00 p.m. to act on the remaining articles. Meeting adjourned at 11:15 p.m.

The meeting convened at 8:00 p.m. on March 14, 1985. Moderator Charles A. Gaides opened the meeting with a salute to the Flag followed by a prayer. Article 15 through 28 were voted.

Article 15. By amendment it was voted to raise and appropriate the sum of \$18,000. for the Fire Department.

Article 16. It was voted to raise and appropriate the sum of \$16,500 for the Police Department and the sum of \$200 for Civil Defense.

Article 17. It was voted to raise and appropriate the sum of \$10,000 for the purchase of Highway Equipment and to authorize the withdrawal of \$10,000 for this purpose from the Federal Revenue Sharing Fund.

Article 18. It was voted to raise and appropriate the sum of \$17,600 for the improvement of Reservoir Road.

Article 19. By amendment it was voted to raise and appropriate the following sums of money for Highway Purposes:

1. Maintenance and General Expenses of
the Highway Department \$180,914.
2. Road Sealing 14,000.

(State Share Highway Block Grant Aid \$53,904.61).

Article 20. It was voted to raise and appropriate the sum of \$10,000 for the Highway Equipment Capital Reserve Fund.

Article 21. By amendment it was voted to raise and appropriate the sum of \$500 for the support of the Hillsboro Rescue Squad and the sum of \$500 for support of the Weare Rescue Squad.

Article 22. It was voted to authorize the transfer of the North School Lot, so-called, bordered by land of Peter Soukas, Thelma Copadis, Ann Watson and Thomas Copadis, located on the south-west corner of Peter Woods Hill Road and Glen Road, to said Peter Soukas, Thelma Copadis, Ann Watson and Thomas Copadis upon such terms and conditions as the Selectmen see fit.

Article 23. Withdrawn.

Article 24. It was voted to authorize the Selectmen to discontinue a short portion at the mouth of the Old Deering Road at its intersection with the East Deering Road and relocate the Old Deering Road to lie along side the barn at the C. Spencer Cake property. The petitioner, C. Spencer Cake, et al, shall agree to be responsible for all costs, liability and damages which may be assessed against the Town of Deering.

Article 25. It was voted to authorize the Board of Selectmen to apply for, accept and expend money from the State, Federal or another governmental unit or a private source which becomes available during the year in accordance with the procedures set forth in RSA 31:95-b.

Article 26. It was voted to authorize the Selectmen to trade, sell or otherwise dispose of any surplus Town property.

Article 27. It was voted to authorize the Board of Selectmen to accept or purchase on behalf of the Town any Federal or State surplus fire, police or highway equipment.

Article 9. It was voted to raise and appropriate the sum of \$1000 for costs of investigating the possible acquisition of land to be used as a Solid Waste Disposal Transfer Station.

Article 10. It was voted to authorize the Board of Selectmen on behalf of the Town to enter into a cooperative agreement, pursuant to RSA Chapter 53-A, for the Purpose of joining together towns and cities in a joint and cooperative effort for the disposal of solid waste in a manner which will meet Federal and State regulations and for the economical and efficient recovery of energy from said solid waste disposal. The Cooperative to be formed under the cooperative agreement will be designated the "Concord Regional Solid Waste/Resource Recovery Cooperative". A copy of the current draft of the proposed cooperative agreement is posted with the warrant and is available at the town offices during normal business hours. The Board of Selectmen is specifically authorized on behalf of the Town (a) to execute and deliver the cooperative agreement (with such changes therein from the posted agreement as the Board of Selectmen shall approve such approval to be conclusively evidenced by the Board of Selectmen's execution thereof) and such other instru-

ments, documents, and agreements as the Board of Selectmen may deem necessary or desirable in furtherance of the purposes of the cooperative agreement; (b) to cause to be performed all obligations which may from time to time be required pursuant to the terms of the cooperative agreement.

Article 28. A request was made to have Town Reports mailed out next year. Mr. Merrill asked if there were any volunteers for any Boards of the Town, also to let him know of any land that might be available to be used as a Solid Waste Disposal Transfer Station.

Meeting was adjourned at 11:00 P.M.
