You are hereby notified to meet at the Town House said Ellsworth on Tuesday, the ninth day of March, pext at nine of the clock in the forenoon, to act upon the following subjects:

- 1. To choose all necessary Town Officers for the year ensuing.
- 2. To raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriations of the same.
- 3. To see how much money the town will vote to raise and appropriate for the support of highways and bridges.
