### TOWN WARRANT

To the inhabitants of the Town of Grantham, in Sullivan County, qualified to vote in town affairs:

You are hereby notified to meet at the Town's Municipal Building in said Grantham on Tuesday, the twelfth of March next, at 9 o'clock in the forenoon, to act on the following subjects:

Article 1. To choose by ballot and major vote, for the ensuing three years:  
one (1) Selectman  
one (1) Trustee of the Library  
one (1) Trustee of Trust Funds  
one (1) Member of the Planning Board

And, for the ensuing two years:

one (1) Treasurer (to fill unexpired term)  
one (1) Auditor

And, for the ensuing one year:

one (1) Auditor

And to elect all other necessary Town Officers, Agents and Committees, and pass any vote relating thereto.

Article 2. To see if the Town will approve the addition of a full time Administrative Assistant to work under the direction of the Selectmen and vote to raise and appropriate the sum of \$14,000.00 for the salary and \$6,000.00 for recruitment and other expenses.

Article 3. To see if the Town will vote to raise and appropriate the sum of \$13,830.00 to defray Town Officers' Salaries and \$16,850.00 to defray Town Officers' Expense.

Article 4. To see if the Town will vote to raise and appropriate the sum of \$2,000.00 for the care and maintenance of cemeteries.

Article 5. To see if the Town will vote to raise and appropriate the sum of \$1,500.00 toward the restoration and preservation of cemeteries and to accept contributions for the same from other sources. The Selectmen to appoint a Cemetery Commission to oversee the restoration, preservation, care and maintenance of the cemeteries.

Article 6. To see if the Town will vote to appropriate three thousand dollars (\$3,000.00) to build a 20' x 24' one bay sand shed at the Town Office site and authorize the withdrawal of this amount required for this purpose from the Federal Revenue Sharing Fund.

Article 7. To see if the Town will vote to appropriate fourteen thousand dollars (\$14,000.00) to expand the present Municipal Building parking lot and loam and seed the balance of the playground area and authorize the withdrawal of \$6,600.00 from the Capital Reserve Fund Entitled "Trust Fund 'B' " and authorize the withdrawal of \$7,400.00 from the Federal Revenue Sharing Fund.

Article 8. To see if the Town will vote to raise and appropriate the sum of \$22,650.00 for the care, maintenance and insurance of the Town Hall, Municipal Building and Town Office.

Article 9. To see if the Town will vote to raise and appropriate the sum of \$5,000.00 to update the "Grantham Master Plan" as required by R.S.A. Chapter 672-677.

Article 10. To see if the Town will vote to raise and appropriate the sum of \$700.00 to update the "Grantham Subdivision Regulations" as required by R.S.A. Chapter 672-677.

Article 11. To see if the Town will vote to raise and appropriate the sum of \$4,000.00 to be used for Legal Assistance and Fees.

Article 12. To see if the Town will vote to raise and appropriate the sum of \$639.00 to support the Upper Valley-Lake Sunapee Council for the ensuing year.

Article 13. To see if the Town will vote to raise and appropriate the sum of \$44,020.00 for the use of the Police Department.

Article 14. To see if the Town will vote to raise and appropriate the sum of \$16,606.00 for the use of the Volunteer Fire Department.

Article 15. To see if the Town will vote to raise and appropriate the sum of \$5,030.00 for the use of the FAST Squad.

Article 16. To see if the Town will vote to raise and appropriate the sum of \$16,000.00 for Summer Maintenance of roads and to appropriate the sum of \$17,318.00 from the Highway Block Grant for Summer Maintenance and Improvements of roads.

Article 17. To see if the Town will vote to raise and appropriate the sum of \$16,000.00 for Winter Maintenance of roads.

Article 18. To see if the Town will vote to raise and appropriate the sum of \$2,300.00 to defray the cost of Street Lighting.

Article 19. To see if the Town will vote to appropriate three thousand dollars (\$3,000.00) to replace the fence at the Transfer Station site with a 6' chain link fence and authorize the withdrawal of this amount from the Capital Reserve Fund Entitled "Grantham Town Dump."

Article 20. To see if the Town will vote to appropriate two thousand five hundred (\$2,500.00) to complete the Dump Closure and authorize the withdrawal of this amount from the Capital Reserve Fund Entitled "Grantham Town Dump."

Article 21. To see if the Town will vote to raise and appropriate the sum of \$31,035.00 to provide for operating the Solid Waste Disposal facility.

Article 22. To see if the Town will vote to raise and appropriate the sum of \$1,145.00 to support the N.H./V.T. Solid Waste Project for the ensuing year.

Article 23. To see if the Town will vote to raise and appropriate the sum of \$300.00 to support a local nursing service, and \$2,075.00 to subscribe to the Newport Area Home Health Agency.

Article 24. To see if the Town will vote to raise and appropriate the sum of \$1,684.00 which will enable Grantham to be serviced by the Newport Ambulance Service.

Article 25. To see if the Town will vote to raise and appropriate the sum of \$300.00 to support the New London Ambulance Service.

Article 26. To see if the Town will vote to raise and appropriate the sum of \$3,500.00 for Old Age Assistance, Town Poor and Aid to permanently Disabled Persons.

Article 27. To see if the Town will vote to raise and appropriate the sum of \$250.00 for Sullivan Nutrition, a subsidiary of the Newport Senior Center, for the support of its Meals on Wheels Program for the benefit of Grantham residents.

Article 28. To see if the Town will vote to raise and appropriate the sum of \$9,585.00 for the support of the Dunbar Free Library.

Article 29. To see if the Town will vote to raise and appropriate the sum of \$600.00 to support the Youth Recreation Program.

Article 30. To see if the Town will vote to raise and appropriate the sum of \$1,400.00 to be used for the Independence Day-Old Home Day Celebration.

Article 31. To see if the Town will vote to authorize the selectmen to borrow money in anticipation of taxes and raise and appropriate \$40,000.00 for Interest Expense.

Article 32. To see if the Town will vote to authorize the transfer of seventeen thousand two hundred dollars (\$17,200.00) from the Fire Department to the Capital Reserve Fund Entitled "New Fire Truck."

Article 33. To see if the Town will vote to raise and appropriate the sum of one hundred thirty thousand dollars (\$130,000.00) for the purchase of a new fire truck and equipment and authorize the withdrawal of seventy-five thousand dollars (\$75,000.00) from the Capital Reserve Fund Entitled "New Fire Truck," one thousand six hundred dollars (\$1,600.00) from the Capital Reserve Fund Entitled "New Equipment Trust Fund 'C'," twenty-three thousand four hundred dollars (\$23,400.00) from the Capital Reserve Fund Entitled "New Equipment Fund" and thirty thousand dollars (\$30,000.00) to be raised from taxes.

Article 34. To see if the Town will accept as a gift from Emil and Tony Hanslin a certain parcel of land (Tax Map #02-1071) located west of Route 10 in North Grantham for a Brookside Park and Picnic Area for the exclusive use of Grantham residents and their Guests. Also a gift of \$8,000.00 from Emil and Tony Hanslin to be used for this Brookside Park and Picnic Area as the Town sees fit. In recognition of this gift a plaque naming the Park would be appropriately placed at the site that will be acceptable to both the Hanslins and the Selectmen.

Article 35. To see if the Town will vote to appropriate \$8,000.00 to develop the Brookside Park and Picnic Area.

Article 36. (By Petition) "To see if the Town will approve the use of the Dunbar Free Library Building by a Grantham Historical Society should one become organized."

Article 37. (By Petition) "To see if the Town will vote to tear down the Old Fire Station."

Article 38. (By Petition) "To see if the Town will vote to pave the northern access road into Eastman from where it begins on Route 10 to approximately Douglas Annis' driveway and to raise and appropriate \$18,000.00 to cover the same."

Article 39. To see if the Town will vote to petition the State Tax Commission to have an audit made by the Division of Municipal Accounting and make an appropriation to cover the expense of the Audit.

Article 40. To see if the Town will vote to authorize the Selectmen to dispose of any acquired properties through sealed bids, with the Selectmen having the right to accept or reject any or all bids.

Article 41. To hear the reports of Officers, Agents and Committees heretofore chosen and pass any vote relating thereto.

Article 42. To transact any other business that may legally come before this meeting.

**SULLIVAN COUNTY REGIONAL REFUSE DISPOSAL DISTRICT  
1984 Annual Report of Activities**

After experiencing a number of setbacks early in the year which created delays and significant changes from previous plans, the District, together with the Southern Windsor/Windham Counties Solid Waste Management District and Clark-Kenith, is now approaching a bond sale and subsequent construction of a waste-to-energy facility.

During January Keene decided not to join the Sullivan County District and a Federal Urban Development Action Grant application was turned down. At a Joint Meeting with the Southern Windsor/Windham Counties District in February the District Committee decided to request a new proposal from Clark-Kenith and a competitive proposal from Vicon Recovery Systems for a smaller facility more closely matching the quantity of waste available from existing District towns.

The decision to request new proposals gave the Districts time to investigate other sites in Claremont that would be more acceptable to the residents of Claremont. The Claremont City Council agreed to support a site location in an area zoned for industry in southwest Claremont, east of the Joy Foundry. Revisions to the environmental impact assessment were subsequently made, with the City splitting the costs of the assessment and other site investigations with the Districts.

Clark-Kenith and Vicon Recovery Systems submitted bid construction costs and operating proposals to the Districts during May. Differences in projected disposal costs were less than two dollars per ton. Clark-Kenith remained the preferred vendor



because of their technology and financial strength, and the uncertainties associated with beginning negotiations with Vicon.

On September 19, 1984, the District signed a long-term 20 year waste disposal agreement with Clark-Kenith for the financing, construction and operation of a 200 ton per day facility. An option to purchase 51 acres of land at the new location was also signed during September.

Lazard Freres and Company, investment bankers for Clark-Kenith, are now in the final stages of preparing a 28 million dollar industrial revenue bond sale through the New Hampshire Industrial Development Authority. Prior to closing on the bonds an equity commitment agreement must be signed which will provide for the sale of the facility to a private investor at the end of construction. The sale, together with the expected retirement of certain contingency funds and bond reserve funds, will leave approximately 16 million dollars in outstanding bonds which must be retired during the 20 year operating period.

The present schedule calls for finalizing an agreement with Signal RESCO, the expected equity owner, by March, 1985. Construction will begin immediately thereafter, with operation expected early in 1987.

**REPORT OF THE TOWN FOREST FIRE WARDEN  
 AND STATE FOREST RANGER**

Our first forest fire prevention law was enacted by our State Legislature 90 years ago. This early law set in place a cooperative forest fire prevention and suppression effort between city and town governments and State government. It simply stated that no open fire could be kindled, when the ground is free of snow, without the written permission of the town/city Forest Fire Warden. This law also stated that anyone kindling a fire without written permission shall be liable for the damage caused and subject to a \$1,000.00 fine.

During the past 90 years, this law has worked so well that it has remained unchanged. All open fires when the ground is not covered with snow must be authorized by the local Forest Fire Warden. Persons kindling a fire without a permit when one is required are liable for damages caused, fire suppression costs and subject to a \$1,000.00 fine.

This cooperative fire prevention law has contributed significantly to our nationally recognized annual forest fire loss record.

**CEMETERY ADVISORY COMMITTEE**

The Town of Grantham Board of Selectmen appointed a Cemetery Advisory Committee to make recommendations for the needs of the cemeteries in the Town. The committee has met three times and members have worked individually to gather information and report to the Selectmen. We recommend a "Yes" vote on the Cemetery Articles and the establishment of a Cemetery Commission/Commissioners.

The Cemetery Advisory Committee's goal is to restore and preserve all of Grantham's cemeteries. We are concerned about the condition of five that appear to be deserted and abandoned as well as three currently being used. Due to investigations made by this committee, the Littlefield Cemetery is being restored with funds provided for its care.

Did you know there are nine cemeteries in Grantham? Some of Grantham's early settlers are buried in the Gleason Cemetery in Meriden which was once part of Grantham. The earliest burial in the Grantham Mountain Cemetery (Lily Pond Road) was in 1810; Dunbar Hill in 1818; and Leavitt Hill (Leavitt Pond Road) in 1839. The other cemeteries are: Burpee Hill, (commonly called Brown Cemetery), Hastings Memorial Cemetery on Burpee Hill, Fisher or Smith Cemetery on Miller Pond Road, Hill Dale Cemetery on East Grantham Road, Littlefield Cemetery on Dunbar Hill Road, and the new Grantham Memorial Cemetery off East Grantham Road near the Municipal Building and School. Some of these are private family graveyards. with funds from the 1984 appropriations. The Dunbar Hill Cemetery Gate has been moved to the lower corner to improve access to the cemetery with funds provided by The Henry A. Howard Memorial Fund. Plans are underway to hold volunteer clean-up days at Leavitt Hill Cemetery where brush and trees have taken over, destroying and dislodging many of the markers. Similar work is needed at Grantham Mountain and both cemeteries on Burpee Hill. The only way to get to Leavitt Hill and Grantham Mountain Cemeteries is on foot or in dry weather by all-terrain or 4x4 vehicles.

We wish to express our appreciation to the following for their help in accumulating information, providing transportation and directions and allowing us to cross their property: Mr & Mrs. Kenneth Flewelling, Mr. Kenneth Barton, Trustees of Croydon Congregational Church and The New Hampshire Old Graveyard Association. We also thank those who have offered to help with the clean-up and transportation when the work bees are scheduled.

This past June the Dunbar Library combined with the school library. Both collections have been combined in the library facility of the school. There is a signed merger agreement between the school board, the library trustees and the selectmen. This operating agreement covers such areas as financial responsibilities, maintenance and termination of agreement.

With the move to a new building came the installation of a library telephone. This has come in handy for people renewing books, asking questions or for myself doing overdue or reserve books.

The summer reading program, the book worm club, attracted 35 children who read 459 books. At the end of the summer reading party five three dollar gift certificates to Dartmouth Book Store were drawn from the names of the participants. The more books a child read, the greater chance he had to win.

A card catalogue, dictionary stand, two tables and eight chairs were purchased with money from the school budget. With the remaining school library furnishings money, and hopefully money from the town library account, a charge desk will be custom made to fit the small check-out area. In the future a librarian's desk and wall storage will be added.

Last town meeting \$5,000 from Revenue Sharing money was appropriated to improve the library collection. The money is being spent mostly on reference books as encyclopedias, dictionaries, thesaurus, atlas and other non-fiction books as crafts, cook books, biographies etc. For the children books will be purchased to supplement the school curriculum and to increase the fiction collection.

This spring the library plans to start a preschool puzzle collection. Also in the planning is an adult puzzle collection. Donations for either collection are needed to supplement what is bought. The library will be starting some magazine subscriptions and recommendations are welcome.

During the summer of 1985 we plan on holding our fourth library festival. We will be looking for donations of books and white elephant items. Please keep the library in mind before throwing the above out. We will accept donations at any time. The library is currently open Monday from 9:00 to 12:00; Wednesday from 9:00 to 12:00, 2:00 to 4:30 p.m. and 6:30 to 8:30 p.m.; and Saturday from 9:00 to 12:00. Every Wednesday at 10:30 there is a preschool story time. Why don't you stop in and visit us some time?
