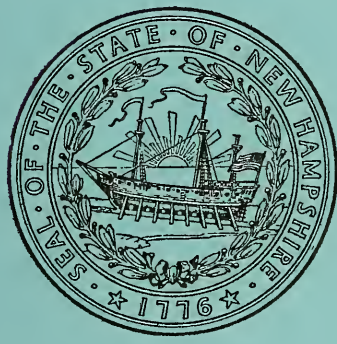

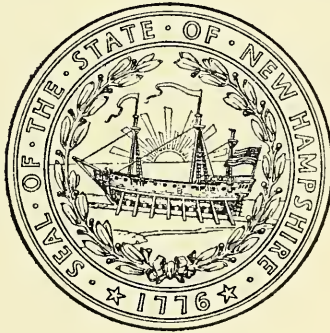

State of New Hampshire

To the Inhabitants of the Town of Groton in the County of Grafton in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at the Town House in said Groton on Tuesday, the 10th day of March, next at three o'clock in the afternoon, to act upon the following subjects:

1. To choose all necessary Town Officers for the year ensuing.

2. To raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriations of the same in accordance with the budget herewith attached.

3. To see if the Town will vote to give a discount for prompt payment of taxes.

4. To see if the Town will vote to authorize the Selectmen to borrow in anticipation of taxes.

5. To see if the Town will vote to continue plowing driveways with the present fee of \$7.00.

6. To see if the Town will vote to authorize the Selectmen to dispose of or administer any real estate acquired by Tax Collector's deeds.

7. To see if the Town will vote to use \$1000.00 of the Total Highway Appropriation for the sealing of the section of the North Groton Road, starting at Bickford Hill and continuing as far as the money will allow.

8. To see if the Town will vote to raise a sum of \$500.00 for furnishing and maintaining the Selectmen's Office.

9. To choose Delegates to the Constitutional Convention.

10. To vote on the question "Shall sweepstake tickets be sold in this city or town?"

11. To transact any other business that may legally come before this meeting.

PERAMBULATION OF TOWN LINE

"1962-- 1963"

ALEXANDRIA - HEBRON

May 26, 1963 Representatives from Hebron, Groton and Alexandria met in Groton near the Bill Smith Cottage and proceeded up Hardy Road to Hardy Corner.

Hardy Corner: One flat stone and iron stake marked H.A.G. 1850 57, 71, 78, 85, 92, 1906, 13, 20, 27, 34, 41, 48, & 55 being the southeast corner of Groton and bounds between said towns.

Line Stone: Thence south 31 degrees west approximately 220 rods to flat stone marked 1955 A & H being a corner of a Draper Lot.

Mike Akerman Corner: Thence same course 80 rods to above named corner being stake and stones marked A & H 06, 13, 20, 27, 34, 41, 48, 55.

Note: Mowglis Trail crossed on above run.

Healey Corner: Thence south 55 degrees east about 300 rods crossing three brooks and the Welton Falls trail to a stake and stones marked 1857 - 78 - 85 - 06, 55 a little west of a steep ledge marked 1850, 06, 13, 20, 27, 34, 41, 48 TL.

Gove Corner: Thence south 40 degrees west about 28 rods to an upright stone about 4 feet high marked 1857, 06, 13, 20, 27, 34, 41, 48 & 55 about 8 feet west of a steep edge marked 1857 - 71.

Note: On top of above mentioned ledge there is a pile of stones being a line marker. This marker is visible from the true corner at base of ledge.

By agreement the undersigned met and perambulated the above line May 26, 1963 renewing town spots on trees and painting them white, adding date "62" on monuments and stones.

FIRE WARDEN'S REPORT

During the past year New Hampshire faced the greatest forest fire threat to its woodlands in more than sixty years. The continued drought brought home to our citizens, as never before, the potential threat of destructive fires to their beautiful and valuable forests, homes and livelihood. In true American traditions of meeting a common threat by volunteer effort, this fire danger was minimized by active prevention, patrol and a relinquishing of personal rights for the common good. It was the greatest demonstration of public cooperation ever experienced by those responsible for local and state fire control. The ready forces of volunteer fire services kept the losses low. For their effort and public response the general fire service expresses its heartfelt thanks for a job well done.

Prevention however, is not just an activity for the bad fire years. It must be practiced until it becomes a part of our public conscience — a habit. Just plain carelessness with fire causes too many of our fires.

The following practices and suggestions will help:

1. Always have a permit for outdoor burning and burn within the terms of the permit and in a safe place. Burn late in the afternoon when the wind is down or on rainy or damp days. Check your fire and if winds develop extinguish it promptly.
2. Carry your rubbish to the public dump—it's safer. A neglected backyard incinerator causes many fires.
3. Never discard lighted cigarette or match. Make this a

year round habit regardless of the safety of your surroundings.

4. Children caused fires are now a major concern. Keep matches away from them and teach them to respect fire and not make it a subject of play.

Let's all join with "Smokey the Bear" and "Keep New Hampshire Green" and growing in 1964.

The fulfillment of the Newfound Area School District on July 1, 1964 will abolish the Groton School District, as such. Some voters will regret this move as the ending of another of New Hampshire's traditional concepts of education, the local school district. This is not strictly true, as Groton is simply becoming a part of a larger local district, whose voters are vitally concerned in providing good education for their children.

It is difficult to request a deficiency appropriation at this time, but the unpredictable addition of a few pupils to the district, with additional costs of tuition and transportation, cannot be absorbed by a small district's regular budget.

I want to commend Mrs. Orr for her dedicated service during the past years. I wish also to thank the members of the School Board with whom I have worked. Their devotion to the welfare of the children has been sincere and, I am sure, will continue to be expressed in the endeavors of the larger cooperative district.
