TOWN WARRANT

Sharon, New Hampshire

To the inhabitants of the Town of Sharon, N.H. in the County of Hillsborough, in said State, qualified to vote in Town Affairs:

You are hereby notified to meet in the Brick Schoolhouse on Tuesday, the 14th of March, 1978 at 7:30 in the evening to act upon the following subjects:

Article 1. To choose all necessary Town Officers for the ensuing year, specifically, Town Clerk, 1 year; Selectman, 3 years; Tax Collector, 1 year; Treasurer, 1 year; Trustee of Trust Funds, 1 year.

Article 2. To see if the Town will vote to establish the amounts which shall be paid the Town Officers for their services, or take any action relative thereto.

Article 3. To raise and appropriate the sum of \$1,400 for Town Officers expenses, or take any action relative thereto.

Article 4. To see if the Town will vote to have the Audit made by the Department of Revenue Administration and to raise and appropriate the sum of \$325.00 to cover the expense of the same.

Article 5. To raise and appropriate the following sums of money for the purposes specified:

Article 6. To see if the Town will vote to raise and appropriate the sum of \$54.00 for the Monadnock Region Association, or take any action relative thereto.

Article 7. To see if the Town will vote to raise and appropriate the sum of \$193.00 for the Monadnock Community Visiting Nurse Association, or take any action relative thereto.

Article 8. To see if the Town will vote to raise and appropriate the sum of \$75.00 for the Monadnock Family and Mental Health Service, or take any action relative thereto.

Article 9. To see if the Town will vote to raise and appropriate the sum of \$112.88 as the Town's share for the studies and operation of the Southwestern New Hampshire Regional Planning Commission, or take any action relative thereto.

Article 10. To see what sum the Town will authorize the Selectmen to borrow in anticipation of taxes.

Article 11. To see if the Town will authorize the Selectmen to withdraw from the William Leroy Young Trust Fund \$150.00 interest for maintenance of the Brick Schoolhouse, or take any action relative thereto.

Article 12. To see if the Town will vote to accept the sum of \$1,302.81 which is restricted to the maintenance of Class V highways, or take any action relative thereto.

Article 13. To see if the Town will vote to raise and appropriate the sum of \$2,500.00 for oiling Town roads, where needed, or take any action relative thereto.

Article 14. To see if the Town will vote to raise and appropriate the sum of \$2,000 for Summer maintenance of Town roads and the sum of \$2,500.00 for Winter maintenance, or take any action relative thereto.

Article 15. To see if the Town will vote to raise and appropriate the sum of \$235.68 provided the State of New Hampshire appropriates \$1,571.19 for the construction of Class IV and V highways, or take any action relative thereto.

Article 16. To see if the Town will vote to authorize withdrawal from the Revenue Sharing Fund established under the provisions of the State and Local Assistance Act of 1972 for use as set-offs against budget Appropriations in the amounts indicated: and further authorize the Selectmen to make pro-rata reductions in the amounts if estimated entitlements are reduced or take any other action relative thereto.

Article 18. To see if the Town will vote to raise and appropriate the sum of \$100.00 to be placed in a Capital Reserve Fund for the future reappraisal of the Town, or take any action relative thereto.

Article 19. To see if the Town will vote to raise and appropriate the sum of \$1,000 for necessary maintenance of the Brick Schoolhouse, or take any action relative thereto.

Article 20. To see if the Town will vote to raise and appropriate the sum of \$349.95 as the Town's share in the purchase of a new ambulance for the Peterborough Fire Department, or take any action relative thereto.

Article 21. To see if the Town will vote to raise and appropriate the sum of \$1,000.00 for the purpose of stumping and graveling the Town-owned piece of property adjacent to the Brick Schoolhouse, or take any action relative thereto.

Article 22. To see if the Town will vote to raise and appropriate the sum of \$300.00 as the Town's contribution to the Peterborough Library Building Fund, or take any action relative thereto.

Article 23. To see if the Town will vote to ban the future location of mobile homes in the Town, or take any action relative thereto.

Article 24. To see if the Town will vote to limit the number of new residential building permits to 1 permit per calendar year per parcel of land existing at the date of passage of this article, or take any action relative thereto.

Article 25. To see if the Town will vote to return the sum of \$255.00 to the Sharon Taxpayers Association, or take any action relative thereto.

Article 26. To see if the Town will transact any other business that may legally come before this meeting.

SELECTMEN'S REPORT

The past year has been rather frustrating for the Selectmen. The problems came from outside of Town. The State was slow to set its budget as we learned from the papers. No sooner than that matter was settled, the County turned up with the same problem. This resulted in late setting of the tax rate and increased interest charges on our short-term loan. Both delays were unnecessary and we hope that it will not happen again.

The cutting on the Robert P. Bass Memorial Forest got off to a poor start due to wet weather. The timber firm returned shortly after the start of winter and has made a good start in removing the 1,200,000 board feet of timber. The job should be complete in about 2 years. The Town will net about \$45,000 as a result. The proceeds have been invested in certificates-of-deposit.

The Selectmen would like to meet with any Townspeople interested in removing firewood which results from the weeding and thinning operation. The forester will explain where the wood is located later in the Spring. The meeting will be at the monthly meeting following Town Meeting.

The New Hampshire National Guard repointed the joints in the brickwork at the Schoolhouse during the Fall. The total cost to the Town was \$5.80, the price of two bags of mortar patch. We would like to express our thanks to the National Guard for their help.

During the Fall, the Selectmen completed the purchase of a 75' x 100' parcel adjacent to the Brick Schoolhouse. We hope to have the property stumped and graveled so that it will provide parking that is off the highway. This will provide security for vehicles especially during the winter months when the roads are narrow.

The Selectmen have taken a close look at the Schoolhouse and have decided that it is time to take action regarding maintenance of the structure. We recommend that the outside trim be painted, the ceiling be covered with sheetrock and painted, the inside walls washed and painted, the floor sealed, and repointing the top of the chimney which should have a cap installed on it. We have the estimates and will present them at the Town Meeting.

We believe that it would be in the best interest of the Town if it were to vote a sum of money for the Peterborough Library Building Fund. Sharon is not assessed a fee for the use of the Library and it is utilized by the residents of Sharon.
