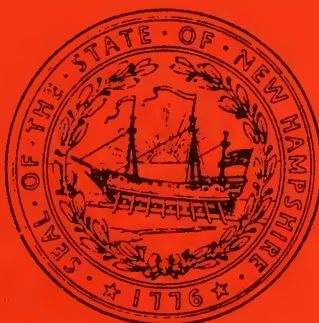

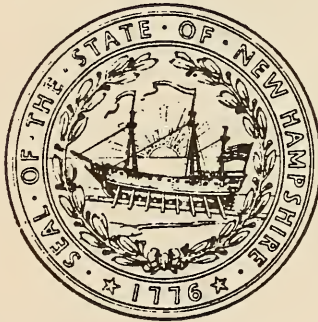

TOWN WARRANT

To the inhabitants of the Town of Hebron, in Grafton County, in the State of New Hampshire, you who are qualified to vote in Town affairs:

You are hereby notified to meet at the Community Hall in Hebron on Tuesday, the fourteenth day of March next, at five o'clock in the afternoon to act upon the following subjects:

ARTICLE:

1. To choose all necessary Town Officers for the ensuing year. The polls will be open from 5:00 p.m. to 9:00 p.m., and the business meeting will commence at 7:00 p.m.
2. To hear the reports of any committee.
3. To see if the Town will authorize the Selectmen to borrow money in anticipation of taxes.
4. To see if the Town will vote to authorize a two percent cash discount on property taxes paid within thirty days of the date of the tax bill.
5. To see if the Town will vote to increase the Town Officers' salaries as follows:

6. To see if the Town will vote to accept all gifts, legacies, and devises made to it during the year.
7. To see if the Town will vote to raise and appropriate the sum of seven thousand one hundred dollars (\$7,100.00) for the Hebron Fire Department FAST Squad to purchase a cardiac monitor and a cardiac defibrillator, to be used by the squad to serve the medical needs of the community. (By Petition)



8. To see if the Town will vote to raise and appropriate the sum of twelve hundred dollars (\$1,200.00) for a new swim line, additional sand, and other improvements to the Town Beach.
9. To see if the Town will vote to raise and appropriate the sum of twelve thousand dollars (\$12,000.00) to shim a portion of the George Road with "Hot Mix".
10. To see if the Town will authorize the Selectmen to appoint a person or persons to serve on a committee with persons of surrounding town or towns to look into the feasibility of a regional or shared police department to serve two or more towns and to report their findings to the Selectmen by January first 1990.
11. To see if the Town will adopt the provisions of RSA 80:58-86 for a real estate tax lien procedure. These statutes provide that tax sales to private individuals for nonpayment of property taxes on real estate are replaced with a real estate tax lien procedure under which only a municipality or county where the property is located or the state may acquire a tax lien against land and buildings for unpaid taxes. (By written ballot)
12. To see if the Town will vote to release any and all proprietary interest it has or may have in equipment or other property owned by the Newfound Area Ambulance Association or Newfound Ambulance Rescue Squad, Inc.
13. To see if the Town will vote to to discontinue the portion of the road that goes through the common from the paved area in front of the school to the West Shore Road. (Common Committee)
14. To see if the Town will vote to raise and appropriate the sum of three thousand dollars (\$3,000.00) to be used as recommended by the Common Committee and Selectmen towards improvements to the Town Common. (Common Committee)
15. To see if the Town will vote to raise and appropriate the sum of one thousand dollars (\$1,000.00) to be used to purchase office equipment.
16. To see if the Town will authorize the Selectmen to use the unspent portion (\$5,977.74) of the money previously appropriated to paint and insulate the Town Office and Library for general improvements to these two buildings.



17. To see if the Town will vote to accept from Ernest and Ellen Evans the road in their subdivision as approved by the Planning Board.
18. To see if the Town will vote to turn over the Class 6 unimproved, unused roadway bounded by lots 5 and 30 on the Hampson Point subdivision to the owners of these lots. These boundaries to be agreed upon between the owners of lots 5 and 30 and the Selectmen and any expense to be borne by the owners of lots 5 and 30.
19. To see if the Town will vote to raise and appropriate such sums of money as may be necessary to defray Town charges for the ensuing year.
20. To transact any other business that may legally come before the meeting.

## HEBRON LIBRARY REPORT

The Library in 1988 showed, again, an increase in patrons and visitors. Circulation of books and magazines to summer borrowers accounts for some of the increase, but regular use by the children of the Hebron School and citizens of the town throughout the year indicate the important part reading and the Library play in our community .

With the completion of the eight college hour credits in library science required, our librarian, Jane Ramsay, is now a certified librarian in the state of New Hampshire. We congratulate her upon this accomplishment and know her expertise in librarianship will benefit the community.

Also, the Hebron Library has fulfilled requirements for joining the New Hampshire Statewide Library Program at associate level. This program is an attempt by the State Library Association to raise the standards of all libraries in New Hampshire, regardless of size. We are pleased to be among the first to qualify.

There have been some improvements made in the Library's physical appearance this year. A new coat of white paint has made the building look sparkling clean. The trustees have planted shrubs and spring bulbs in a small dooryard garden. Two new rugs have been purchased for the librarian's desk area and in the children's book area. A new vacuum cleaner was bought to keep the rooms swept and dusted. Two new book cases made by John Matthews have enabled the library to combine the children and adult non-fiction and to rearrange other shelves and use space to better advantage.

In September, the Library hosted Forum meeting at which twenty librarians, including the NH State Library Commissioner, attended. Forum is an organization of librarians in New Hampshire who meet to discuss library concerns.

The annual Book and Bake Sale in August was very successful (\$465.55). Many friends of the Library donated time, food and books. We are grateful for their generosity.

Special exhibits of carved birds by Albert Dix and a scene of a maple sugaring operation by Edward Raynor attracted interest.

In October, the Library sponsored an evening program on the Shakers. It was well attended. Slides illustrating the subject and commentary by Douglas Leitch were outstanding.

At Christmas, it was our pleasure to serve punch and cookies to the Hebron School children, followed with a story read by Mrs. Ramsay. Throughout the afternoon, other library patrons enjoyed the holiday treats.

The Trustees of the Hebron Library meet the first Monday of the month at the library. We welcome your suggestions and continued interest and support.

**HEBRON FIRE DEPARTMENT**  
**Annual Report for 1988**

During 1988, the Hebron Fire Department responded to a total of 72 calls. This compares with 58 calls in 1987 and 71 calls in 1986. The breakdown of the 72 calls was as follows: 36 medical emergencies involving 40 persons, and 36 fire related incidents. Of the 36 medical calls, 18 were illness related, 18 trauma related. The 36 fire related incidents breakdown as follows: 1 structure fire involving a petition, 13 mutual aid to other towns (3 were medical aid mutual aid), 7 chimney fires, 4 powerlines down, 3 fire alarm activations, 2 car accidents (no personal injury involved), 2 service calls, 1 assist police, 1 children playing with matches, 1 lightning strike, 1 unintentional false.

In looking at the statistics for the last several years, it is clear that medical emergencies account for at least 50% of the calls. This has important implications for budget planning and equipment purchases. This year, we replaced our 1972 rescue truck with a 1981 model and while it has over 100,000 miles on it, it should last us several years.

The past year saw the arrival of our new Engine 3, a pumper/tanker from the American Eagle Fire Apparatus Co. in Gainesville, Florida. The new engine has a 1,000 gallon per minute pump and carries 1,250 gallons of water. The body and tank are made of aluminum. The engine is everything we had hoped it would be.

The greatest problem facing small town fire departments today is personnel. And we are no exception. It is partly a problem of time. Those of us who are most active on the department are also people who have deep commitments to many other things. And quite frankly, finding the time to do the training and maintenance is not easy. The other part of the problem is recruiting new people who are interested in becoming firefighters and who are willing to do the schooling required. Taken together, these form the most difficult issue that the volunteer fire service is facing.

Finally, on behalf of the department, let me thank the community for the support it has shown. Without such a high level of support, our task would be much more difficult. I also want to personally thank the officers and firefighters for their loyalty. There is little in the way of financial reward for a job well done. It takes a special person to give as much as some do simply for the love of the fire and emergency medical service.

## NEWFOUND AMBULANCE RESCUE REPORT

Newfound Ambulance Rescue experienced another busy year in 1988 with increased call activity in providing service to Hebron and the surrounding Newfound Area including the towns of Alexandria, Bridgewater, Bristol, Danbury, and New Hampton.

There were a total of 456 calls during 1988, an increase of 24 over the previous year. This continues the trend in recent years of steadily increasing call activity. For example, in 1984, there were 316 calls. For the Town of Hebron there were 28 calls, up from 21 the year before. A breakdown of the number of calls per town is shown below.

Efforts are ongoing to ensure continuing compliance with basic State requirements and to improve on the level of care we can offer the residents and visitors in our service area. Most important in this regard are the E.M.T. attendants who staff the ambulances, a small dedicated group who strive to enhance their individual training and upgrade to advanced levels of certification. They deserve your support.

Newfound Ambulance Rescue is always on the lookout for new attendants. As activity grows, we need additional help. If you might be interested in becoming an ambulance attendant, or know someone who could be, please contact Roger Pedersen at the Bristol Town Offices for more information.

In the year ahead, we look forward to replacing the 1981 ambulance with a new unit. Also significant is an anticipated change in dispatch service, to the Lakes Region Fire Dispatch Center, approximately July 1. This will result in a single number to call for emergency ambulance and rescue needs, the same number you now call for your Fire Department. This change will be possible as a result of the integration of Newfound Ambulance Rescue as a department of the Town of Bristol.

## REPORT OF PEMI-BAKER HOME HEALTH AGENCY

As a non-profit agency, the Pemi-Baker Home Health Agency has been serving its member towns since 1967. Staffed with Nurses, Therapists, Aides and Homemakers, we bring care to those who are essentially homebound.

Our current staff includes: Nurses - Paula Baker, Mary Bellgowan, Dot Curran, Jeanne Erickson, Sally Shevenell and Sharon Smith. Aides - Carole Cosine, Nancy Morin, Darlene Pierce and Susan Reese. Homemakers - Jo Elliott and Eva Wakefield. Physical Therapist - Meinsje DeNoble. Speech Therapist - Paul Lister. Occupational Therapist - Kathryn Smith. Our office staff consists of Kathryn Dauphine and Mary Moulton. Margaret Crowell is the Executive Director and Elaine Vieira is the Director of Clinical Services. Janice Gallinger is Chairman of the Board of Directors.

The Pemi-/Baker Home Health Agency holds free blood pressure and diabetic screening clinics in Ashland, Hebron, Plymouth and Rumney. Free immunization clinics are now held at our office six times a year.

Our annual flu clinic was held in November. We offer this clinic for two days in order to accommodate everyone in the area who wants a flu shot.

The "Helping Hands" program is doing well and Betty Robson of Thornton is the new coordinator. This program provides, at no cost, volunteer time on a regular basis to individuals who have full charge and care of a homebound person who cannot be left unattended.

A Long Range Planning Committee has been formed to set goals for the Agency so that it may better meet the future needs of the community. Committee members include June Winsor, Pemi-Baker Home Health Board of Directors, Chairman; Carol Dustin, Upper Valley Senior Citizen Council; Shirléy Bennett, District 8 Representative, N.H. House of Representatives; Barbara Newsom, Pemi-Baker Home Health Agency Board of Directors; Betty Jo Taffe, Grafton County Commissioner; Janice Gallinger and Margaret Crowell.

The Pemi-Baker Home Health Agency was chosen to participate in a survey conducted by the Georgetown University School of Nursing and sponsored by the Health Care Financing Administration. This survey will help identify which characteristics are important in predicting patient resource use and costs. The findings of this survey will contribute to the information base needed for future Medicare policy decisions concerning reimbursement for Home Health services. There are approximately 400 Medicare Certified Home Health Agencies participating. The Pemi-Baker Home Health Agency was the only New Hampshire Agency chosen.

Our 1988 visit statistics show a 20% increase from last year.

#### REPORT OF THE HEBRON BEACH COMMITTEE

Over the course of the past fiscal year, the Lakes Region Planning Commission provided support and assistance to the Town of Hebron at both regional and local levels. The following list represents a sample of the ways in which the LRPC has assisted community representatives.

- Provided list of consultants qualified to prepare impact studies.
- Provided copies of the town's zoning ordinance and subdivision regulations.
- Provided information on the appeals process for a historic district commission decision.
- Provided information on the use of High Intensity Soil Surveys.
- Provided information on the potential impact of vinyl siding on a historic building.
- Sent a list of factors that should be considered while preparing a traffic impact study.
- Sent a copy of an introductory packet on Capital Investment Programs.
- Provided an in-depth review of the town's subdivision regulations along with suggested revisions.
- Sent information on gravel pit regulations and site plan review regulations. Provided information on subdivision filing fees in the Lakes Region.
- Researched and analyzed changes in local housing characteristics since the 1980 Census as part of a Regional Housing Characteristics Study.
- Reviewed changes in local land use regulations to update a report on development regulations in the Lakes Region.
- Co-hosted the annual Municipal Law Lecture series, where practicing attorneys provide a legal perspective on local planning, zoning and procedural issues.
- Prepared a guide book for implementing Cluster Development Regulations.
- Presented three public workshops for local land use boards on how to prepare fiscal, traffic and environmental impact studies.
