TOWN WARRANT

The State of New Hampshire

To the Inhabitants of the Town of Canterbury in the County of Merrimack in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at the Town Hall in said Canterbury on Tuesday, the tenth day of March, next at ten of the clock in the forenoon (Polls open from 10:00 a. m. to 6:30 p. m. at least), to act upon the following subjects:

1. To choose all necessary Town Officers for the year ensuing.

Meet at seven of the clock in the evening to act on the rest of the articles in the warrant.

- 2. To raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriations of the same.
- 3. To see if the Town will vote to give the Selectmen authority to borrow money in anticipation of taxes.
- 4. To see if the Town will authorize the Board of Selectmen to sell, lease or otherwise transfer, at public sale, real property acquired by the Town by Tax Collector's deed.
- 5. To see if the Town will vote to authorize the Selectmen to appoint a Road Agent instead of having one elected, to take effect at the time of the 1960 March Town Meeting.
- 6. To see if the Town will vote to give the Selectmen authority to sell the observation post building to the highest bidder.
- 7. To see if the Town will vote to abolish the Zoning and Building Ordinance and General Regulations now in effect. (By Petition).

- 8. To see if the Town will vote to adopt the amendments to the Zoning Ordinance as proposed by the Planning Board and appended with this Report.
- 9. To see if the Town will vote to accept, at no cost to the Town, for the Canterbury Unit of Civil Defense, a truck to be used as a rescue unit in the Canterbury Civil Defense organization under the jurisdiction of the Canterbury Volunteer Fire Department, and upon granting this request to see if the Town will vote to raise and appropriate the sum of one hundred twenty-five dollars (\$125.00) to insure said truck and cover any liabilities which may occur. This money to be raised in the name of the Canterbury Civil Defense appropriation. (By Petition).
- 10. To see if the Town will vote to change the terms of office of the two Town Auditors from concurrent one year terms to staggered two year terms, with one Auditor elected in March 1960 to serve a one year term, the other Auditor elected in March 1960 and all subsequently elected Auditors to serve a two year term.
- 11. To transact any other business that may legally come before the meeting.

CLERK'S REPORT OF ANNUAL TOWN MEETING OF MARCH 11, 1958

Meeting called to order by the Moderator, Carl A. Thunberg, at ten o'clock in the forenoon. Then followed the reading of the warrants and posting of the checklist. The next order of business was to work on Article I.

Article I The election of officers for the ensuing year. It was voted to keep the polls open until seven p. m.

At that time the polls were declared closed and the Budget was read. It was voted to take the items of the budget one by one and accept the budget as amended. Voted to consider items of the budget under Article V which read as follows: To raise such sums of money as may be necessary to defray town charges for the ensuing year.

- Article II To see if the town will vote to trade the Adams grader for an Austin-Western grader. Accepted as read.
- Article III To see if the town will authorize the Selectmen to use the \$5,000 of insurance money received in settlement of the claim on the Walters Sno Fighter and the \$1,000 of capital reserve for new equipment established at the last town meeting, toward payment for the Austin-Western grader. Accepted.
- Article IV To see if the Town will vote to raise and appropriate \$1,000 toward the cost of the Austin-Western grader and authorize the Selectmen to issue notes in the name of the Town for \$7,000 to finance purchase of same. It was voted in the affirm-

ative. The maturity notes will be \$1,000 per year. Voted by more than two-thirds majority. Yes vote, 96.

Article V As noted above considering the Budget. Items changed or added are as follows. Added \$100 lighting for school grounds; interest on long term notes changed from \$121.50 to \$331.50, raising budget at this stage to \$27,240.93. Warrant articles as follows: Bridge repairs for Canterbury-Boscawen Bridge, \$500; Planning Board, \$100; Blister Rust Control, \$400, making total budget of \$28,240.93. Budget accepted as amended.

Article VI To see if the Town will give the Selectmen authority to borrow money in anticipation of taxes. Accepted.

Article VII To see if the Town will authorize the Selectmen to sell, lease, or otherwise transfer at public auction or sale real property acquired by Tax Collector deed. Selectmen were asked why more of the property acquired by the Town had not been sold. Selectmen replied that said property was being appraised, and bounds established before taking action on sale of same.

Article VIII To see if the Town will vote to raise and appropriate \$400.00 for Blister Rust Control. As this was deemed a compulsory item it was approved as read.

Article IX To see if the Town will vote to put an addition on the Town Garage to be paid for out of the income from the Sam Lake Fund. It was voted to give the Selectmen

authority to negotiate this matter with the Trustee of the said Sam Lake Fund up to \$10,000.00 and was accepted under these conditions.

Article X To see if the Town will vote to raise and appropriate the sum of \$100 for general expenses of the Planning Board. Accepted as read.

Article XI To see if the Town will vote to approve the construction of an addition to the Fire House when and as funds are available from sources other than tax revenue. Accepted as read.

Article XII To see if the Town will vote to approve the transfer of those subscribers of the N. E. Telephone and Telegraph Service situated in the Town of Canterbury who now come within the Belmont exchange, to the Canterbury exchange, in so far as it is compatible with the majority of the subscribers who would be affected by such transfer. Accepted by unanimous vote.

Article XIII To transact any other business that may legally come before this meeting. At this time it was voted to return to Article V.

Under Article V the condition of the Canterbury-Boscawen Bridge was discussed and it was voted to make temporary repairs to insure safe travel over same, and it was voted to raise and appropriate \$500 for same.

Returning to Article I as the counting of ballots was completed, the Moderator announced the results which were as follows:

There being a tie vote for auditor between Arthur Mudge and Robert Colby, the chairman cast one ballot to break same, the vote being for Robert Colby. He was declared elected as the second Auditor.

SELECTMEN'S LETTER

We are concerned as administrators of your town business that the 1958 operation shows a deficit. We are in the "red" by the amount of over-expenditure on the Canterbury-Boscawen Bridge. Your balance sheet shows you that Canterbury is financially sound. We are perfectly aware, however, that repeated deficit spending could quickly change this favorable situation. You as citizens and we as Selectmen have a responsibility to avoid spending beyond our means. Your duty is to attend your Town and School District meetings which enact the commitments we live with; our duty is to administer your town business according to your commitments. If your decisions are right decisions and our administration within the spending authority you give, our financing can be kept under control.

After Town Meeting last year we traded our 1956 truck for a new one. Because we needed another truck during the summer we established a rental arrangement so we could keep the 1956 truck at work. Our agreement specified that rental fees could, if we wished, apply against purchase for the amount of the trade-in allowance. Your Road Agent worked the truck out on other towns' road work to earn enough to more than equal these rental payments. In this manner we have accumulated two trucks. We are fully aware that the added expense of maintaining and depreciating another vehicle is signifiant. The justification lies in more work for the same labor charges and more productive use of our other machinery. It also helps us give faster snow clearance which becomes increasingly important to more people each year.

We repeat our belief that time has changed the requirements for the office of Road Agent. It is no longer a position, it has become a job and a specialized one at

that. Our Highway Department is completely mechanized. Our machinery represents a large capital investment. That investment requires special skills for its conservation but at best is subject to expensive depreciation. Placing the administration of this investment at the vagaries of an election year after year is not in our opinion prudent management. We again introduce an Article in your Warrant, suggesting that this be an appointive job rather than an elected position.

The year of 1959 will be remembered as a year of decisions regarding bridges. We own half the Hannah Dustin bridge and half the Canterbury-Boscawen bridge. One is being replaced by a new bridge and will need to be removed, the other must be replaced because it is worn out, weak and dangerous. You will hear plenty about both of these problems during the coming year.

As so often in the past, we again have reason to remember with gratitude the late Sam Lake whose perpetual trust has done so much for Canterbury. By pledging income from this Trust we were able to add another stall to the Town Garage. This solved two problems. It provided us a space big enough to house the grader with the wing and plow mounted and ready for instant use. It released garage room so we could properly house the school bus in heated quarters.

May we again respectfully remind you that practicing citizenship pays off in Canterbury.

REPORT OF PLANNING BOARD

Our population like that of many small towns adjacent to a metropolitan area is becoming less stable. A considerable moving of people in and out of town is taking place. This will accelerate as we become more a community of commuters. During the year the Selectmen issued 13 building permits. The year 1958 saw several mobile homes established in Canterbury.

Our zoning ordinance and building code has become firmly established and increases in importance as a protection to those who invest in our town and will share our tax load. Certain proposed amendments to the zoning code come before you at Town Meeting for your consideration. Your Planning Board acts as an auxiliary of your Board of Selectmen. Our chief concern in 1958 was a thorough study of our Zoning Ordinance. That study has resulted in the amendments proposed. We believe their adoption will strengthen the code and correct at least some of the weaknesses of this instrument which time has uncovered.

ELKINS PUBLIC LIBRARY

Trustees' Report

This year has been an active one at the Library with a circulation increase of 331/3%.

The generous gifts of books are greatly appreciated.

In addition to the regular hours of 2:00 to 5:00 p.m. on Saturday afternoons, the Library has been open from 7:30 p.m. to 9:30 p.m. on Tuesday evenings for the public and on Tuesday afternoons from 12:00 p.m. to 2:30 p.m.

"Friends of the Library," a group of volunteers organized last year by Mrs. Walter Comee, have been most helpful in acting as librarians for the Tuesday openings and in mending the bindings of 200 books.

The Library building has been used as a meeting place for local organizations and committees and for special exhibits.

Services of the State Library and Bookmobile are continuing.

Because the Librarian has difficulty in having books returned on time, it seems advisable to charge a fine of one cent per day on books overdue which have not been renewed. This policy will be in effect beginning April 1.

Repairs on the building have necessarily been curtailed because of the Valley Trust Bank closing. These will be attended to as soon as possible.

It is a State requirement that trustees of libraries in towns of less than 5,000 population shall meet at least quarterly. Your library trustees are planning to meet once a month to share the problems of library work.

Suggestions for improving or increasing the services of your Library will be most welcome.

REPORT OF THE CANTERBURY VOLUNTEER FIRE DEPARTMENT, INC.

The year 1958 has been the best in the history of the Department in respect to fires in our community. During the twelve month period the Department responded to fourteen emergency calls. They consisted of one truck fire (Walters), one child fell in a brook, one child lost, five building fires, one forest fire, two chimney fires, one rubbish heap fire and two out of town calls.

The Walters truck fire and the Worsted Church fire were the only fires causing a loss to the community. In both instances the outcome was total loss.

The Penacook Rescue Unit of Civil Defense gave us valuable aid at the time Rebecca Mudge fell in the brook near her home and also at the Worsted Church fire. Such help certainly shows the value of good neighbors.

Our eight year program for new equipment received a big boost during 1958, thanks to friends of the Department, particularly Civil Defense. We have added during the year, the completion of the installation of our new siren at the fire house, purchased three walkie talkie radios, 200 ft. of hose, a stand-by electric plant, two Indian tanks and some hand tools. These items greatly exceeded our budgeted amount in total value and cost, however, the town's share in this cost did not exceed the amount provided in the budget.

I cannot help but feel that our remarkable record during 1958 was due for the most part, to the people of our community in exercising care in the use of fire and good fire prevention habits. The best that any fire department can do when fire breaks out is to keep it a small one. It is the people of our town that can prevent fires from breaking out in the first place. You have been doing a very commendable job in that respect.

Thank you many times for doing so well. Keep up the good work.

YOU CAN HELP PREVENT FOREST FIRES

Twenty-five percent of all forest fires in New Hampshire are caused from careless debris burning — brush, paper, leaves, grass, etc. Most of them are started without the required permit from the local forest fire warden. The cost of extinguishing these fires annually runs into large sums of money.

According to law, responsible parties must pay the cost of putting them out. In addition, violators may be subject to court prosecution with fines running as high as \$200.

If you do burn on your premises:

- 1. Secure a permit from your local forest fire warden, the law requires it.
- 2. Be sure to properly supervise your burning. Don't leave it.
- 3. Make certain your fire is DEAD OUT before leaving it. Save yourself much possible difficulty.

REPORT OF THE SUPERINTENDENT OF SCHOOLS

To the Members of the School Board, Parents and Voters:

This is the third year of operation of the new Central School in Canterbury. It has probably resulted in the people thinking in terms of the best education for the children of the entire town rather than the sectional feeling when five schools were operated.

The pupils have become better acquainted with the associations of the school and the playground, and there has been better educational competition than possible in small schools. The cooperation of the town library officials and the availablity of more and better books have helped to make progress. There has been an improvement of transportation facilities and the bus schedules. The textbooks have been annually improved with basic books for all the grades rather than five schools operated like five separate towns.

The year just passed was marked by the first full year of the Sputnik era and the Space age of missiles and satellites with Russia and the United States engaged in world competition in the military, economic and social fields. The cold war has continued and it is daily more evident that Communism and Democracy are engaged in a struggle for survival, and we must see that our children are completely indoctrinated to the advantages of our American system of freedom and the disadvantages of the Russian slave system.

The educational picture in Canterbury and every other community is going to be affected in many ways, including:

(1) The stiffening of the curricula in grade schools with more attention to mathematics, science, foreign languages, and an increase of guidance.

- (2) More attention to the education of the gifted child so that many pupils will go far beyond the requirements for grade school and high school graduation.
- (3) The improvement of the high school curricula, the canceling of easy courses, better discipline, the elimination of pupils interfering with the education of other children by laziness or school distractions, increase in home work from Grades 4-12 inclusive, and the higher academic and disciplinary standards of high school decreasing the number of graduates.
- (4) The school day being extended in time and every minute of the day devoted to school work, with extra-curricular activities such as athletics and picnics held on non-school time.

As time progresses, the following may be objectives of the people of Canterbury, although more state and federal aid are necessary before the ideas become realities:

- (1) A salary schedule for Canterbury teachers which will make possible the securing of the best teachers available when teaching vacancies develop.
- (2) The replacement of the old antiquated pupil seating with the excellent types of furniture bought in recent years.
- (3) A man teacher, when some vacancy exists, who can direct playground activities, assist with guidance, and discipline problems.
- (4) The development of a school lunch program with the proper equipment and facilities.
- (5) Facilities for science, industrial and home arts, and home economics.
- (6) Art instruction in all the grades.
- (7) A new television set to take advantage of the Educational Programs for schools from the State Television Station at the University of New Hampshire.

PROPOSED AMENDMENTS TO CANTERBURY ZONING AND BUILDING ORDINANCE

Amendment A

Article II. Change heading to "General Regulations for all Zones."

Article II, Section 1. Strike out the words "Zone A and B" and substitute the words "any zone" in the second line of said section.

Add in Section 1 after the words "value of nearby properties" the words "or is not contrary to the best interests of the community as a whole."

The Section as amended would read:

"Section 1. Commercial or industrial use of property is permitted in any zone with authorization by the Board of Adjustment, except that authorization need not be obtained for sale of agricultural products produced on the premises or for uses permitted in Zone C under Article V, Section 1. This is intended to permit commercial or industrial use which will not, due to noise, odor, appearance or fire hazard, damage the value of nearby properties or is not contrary to the best interests of the community as a whole."

Amendment B

Article II. Insert new Section 3 as follows, and renumber remaining sections accordingly.

Section 3. No trailer or mobile home may be occupied as a dwelling for a period of more than thirty days without first obtaining a permit and unless such trailer or mobile home conforms to all the general and specific regulations applicable to the zone in which it is located, excepting Sections 3, 4 and 6 of Article III.

Amendment C

Article II Section 3 (New Section 4). Strike out the words "or alteration," and substitute the words "alteration or emplacement."

The section as amended would read:

Section 4. The Board of Selectmen shall be the administrative authority to issue permits for the erection, alteration or emplacement of buildings or structures.

Amendment D

Article III, Section 3. Strike out the existing section in its entirety and replace with the following:

"Section 3. Except for windows and bulkheads, foundations shall be solid and continuous and shall be constructed of concrete, brick, concrete block or mortared stone and shall extend down to solid rock or to thirty-six inches below grade, whichever is less, and foundations shall be completed prior to placing any sills, floors or bearing walls.

Amendment E

Insert the following as new Article V and renumber existing Articles V through XII accordingly.

Article V. Rural Zone (Zone C).

The provisions of Zone A shall be applicable to Zone C except in the following respects:

Section 1. Quarrying and gravel or sand pit operations may be carried on without authorization by the Board of Adjustment.

Section 2. The Administrative Authority may waive the requirement of a building permit for lumber camps or hunting camps not intended for continuous use as a dwelling and not so used for more than one hundred and fifty days each year. Such buildings need not conform to the building requirements of this ordinance."

Amendment F

Article V (New Article VI) Section 2, Paragraph b. Strike out the words "The Board of Adjustment may after public hearing allow commercial or industrial uses in Zone A."

Add the following as new Section 3:

Section 3. On application made to the Board of Adjustment to allow commercial or industrial uses or any variances in any zone, the Board of Adjustment shall:

- a. Within thirty days hold a public hearing on the application, and notice of such hearing shall be posted for seven days prior thereto in the Canterbury Post Office and shall be published in a newspaper of general circulation in the community.
- b. Within seven days after such public hearing, grant such permission unless, it its judgment, such use or variance will damage the value of nearby properties due to noise, odor, appearance, or fire hazard or is deemed contrary to the best interests of the community as a whole.

Amendment G

Strike out the old Article VIII and substitute the following (Underlined words are new):

Article IX. Nonconforming Use.

Section 1. Any nonconforming use, other than those specified in Section 2 below, may continue in their present use except that any nonconforming use or buildings may not be

- a. changed to another nonconforming use;
- Re-established after discontinuance for one year except to a use conforming to the zone in which it is located;
- c. Extended;
- d. Rebuilt after damage exceeding 50% of its value unless it is made to conform to the requirements of the zone in which it is located.

Section 2. Same as old paragraph B.

Section. 3. Any nonconforming building barred from further use under Article IX, Section 1, may be made to conform if a building permit is issued by the Administrative Authority for the necessary building alterations and such alterations are completed within three years from the date of issuance of the permit.
