TOWN WARRANT

To the inhabitants of the Town of Northwood in the County of Rockingham in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at Town Hall in said Northwood on Tuesday the eighth day of March, next at ten o'clock in the forenoon to act upon the following subjects. (Polls to close at 6 p. m.)

1. To choose all necessary Town Officers for the ensuing year.

2. To raise such sums of money as may be necessary to defray town charges for ensuing year and make appropriations of the same.

3. To see if the town will vote to authorize the Selectmen to borrow money in anticipation of taxes and vote to raise and appropriate the sum of \$200.00 for interest on same.

4. To see if the town will vote to raise and appropriate the sum of \$1,200.00 for Northwood Public Libraries.

5. To see if the town will vote to raise and appropriate the sum of \$550.00 as asked for by Recreation Commission for recreation purposes.

6. To see if the town will vote to raise and appropriate the sum of \$125.00 for care of cemeteries.

7. To see what sum of money the town will vote to raise and appropriate for Town Highways.

8. To see if the town will vote to raise and appropriate the sum of \$568.12 for the purpose of Town Road Aid, the state share to be \$3,787.45.

9. To see if the town will vote to raise and appropriate the sum of \$4,000.00 in addition to the \$568.12 for construction of T. R. A.

10. To see if the town will vote to raise and appropriate the sum of \$2,000.00 towards purchase of a truck.

11. To see if the Town will vote to raise and appropriate the sum of \$200.00 for Municipal Court Judge.

12. To see if the town will vote to raise and appropriate the sum of \$495.00 for Concord Hospital.

13. To see if the town will vote to install a blinker light at the intersection of Blake's Hill road and Routes No. 9, No. 202 and No. 4, and vote to raise and appropriate \$400.00 for installation of same.

14. To see if the town will vote to close the section of road leading from the front of the Donald Ford property to the road over the Narrows Brook culvert, consisting of approximately 100 feet. (By petition, ten signatures.)

15. To transact any other business that legally may come before said meeting.

REPORT OF NORTHWOOD VOLUNTEER FIRE DEPARTMENT

The Northwood Volunteer Fire Department answered twenty-eight alarms in 1959:

- 8 House Fires
- 8 Chimney Fires
- 9 Grass Fires
- 3 Car Fires

Six of the twenty-eight calls were for out-of-town fires, five of which were house fires and one car fire.

There were about 130 permits issued for outdoor fires in 1959.

Again this year the department has purchased several items which will certainly help to give you better fire protection. The department itself has purchased a 1350 gallon tank and is now waiting to purchase a suitable truck on which to mount this tank. This truck, on completion, will replace the 600 gallon truck now housed at the East Northwood Fire House. We have also purchased a Mouth to Mask Resuscitator and three Dry Chemical Fire Extinguishers.

This year the department, with the aid of the Firemen's Auxiliary, plans to put in running water and toilet facilities. This will be financed from their own funds.

Again this year we have been very fortunate in having no brush or forest fires and we can continue to keep it so if you will remember to get your permit to burn before starting a fire outside. Please remember that a permit is necessary to kindle a fire outside unless the ground is covered by snow.

SCHOOL WARRANT
The State of New Hampshire

To the Inhabitants of the School District in the Town of Northwood qualified to vote in district affairs:

You are hereby notified to meet at the Town Hall in said district on the 12th day of March 1960, at four o'clock in the afternoon, to act upon the following subjects: (Business meeting at 7 p. m.) Polls closing at 9 p. m.

1. To choose a Moderator for the coming year.
2. To choose a Clerk for the ensuing year.
3. To choose a Member of the School Board for the ensuing three years.
4. To choose a Treasurer for the ensuing year.
5. To determine and appoint the salaries of the School Board and Truant Officer, and fix the compensation of any other officers or agent of the district.
6. To hear the reports of Agents, Auditors, Committees, or Officers chosen, and pass any vote relating thereto.
7. To choose Agents, Auditors and Committees in relation to any subject embraced in this warrant.
8. To see what sum of money the district will raise and appropriate for the support of schools, for the salaries of school district officials and agents, and for the payment of statutory obligations of the district, and to authorize the application against said appropriation of such sums as are estimated to be received from the state foundation aid fund together with other income; the school board to certify to the selectmen the balance between the estimated revenue and the appropriation, which balance is to be raised by taxes by the town.

9. To see if the district will vote to authorize the constructing and equipping of a new consolidated Elementary School on the present site, but easterly of, the present Ridge School, including the purchase of necessary equipment and furnishings for same, substantially in accord with plans and specifications contained in the report of the study committee as presented to the June 27, 1959 special meeting, and appropriate money therefor and raise the same by the issue of bonds, notes or otherwise, authorize the School Board to execute any and all contracts relative thereto, including the employment of an architect and counsel and to take such other action with respect thereto as may be necessary or advisable.

10. To see if the district will: (a) vote to raise and appropriate a sum or sums of money, not to exceed \$175,000, in the aggregate, for the purpose of preparing plans, specifications, constructing, equipping, and furnishing the new consolidated Elementary School; (b) vote to accept any gift, contribution, grant or otherwise to or for the benefit of the district, from any source, including but not limited to the State or Federal Governments, or any department or agency thereof, available or to become available for such proposed constructions; (c) vote to use and apply capital reserve funds, if any, together with any accrued interest, previously raised and appropriated or otherwise available, for the aforesaid purpose; (d) vote to authorize the School Board to issue serial notes or bonds, or both, upon the credit of the district under the Municipal Finance Act, or any other enabling authority, to pay for all or any portion of the sum or sums so appropriated and to authorize the School Board to determine the terms, conditions and provisions upon which said notes or bonds, or both, shall be issued; and (e) vote to authorize the School Board to take any other action incidental to or connected with the foregoing in order to carry out the purposes and intent of said votes.

11. To see if the district will vote to authorize the establishment of a Building Committee, so-called, to supervise up to the point of completion and turning over to the district the new proposed consolidated Elementary School, to consist of a committee of five members, made up as follows: the three members of the School Board and two additional members at large, who shall be qualified voters of the district; all members shall have equal voting power, all vacancies to be filled by vote of the members of said Building Committee, and all members of said Committee to serve until said project is completed and turned over to said district.

12. To choose two members at large, who are qualified voters of the district, to serve as members at large on the Building Committee.

13. To see if the district will vote to authorize the School Board to apply for available funds from the Federal and/or State Government, or any departments or agencies thereof, for use in connection with school projects described in the preceding Articles and to provide for the use of said funds, if and when received, to pay for said school projects, or, for any bonds or notes issued to finance said projects, and to take any other action incidental to or connected with the foregoing.

14. To see if the district will vote to establish a School Planning Committee, in the event the foregoing articles on school construction are defeated. This committee to be made up of the School Board and 12 qualified members from the voting list. The twelve members to be selected by the School Board members and the Moderator, each selecting three, thereby making a committee of 15 members.

The purpose of this committee shall be to make a thorough study of school plans and construction and present their recommendations at a public hearing in February 1961. (By Petition — 10 signatures.)

15. To see if the district will vote to raise and appropriate the sum of \$4,500.00 for the installation of a new heating system in the Ridge Elementary School. (By Petition — 11 signatures.)

Voted out by the Budget Committee.

16. To transact any other business that may legally come before this meeting.

In September Mrs. Julia Jordan replaced Mrs. Hester Picard in grades one and two, and Mrs. Billie Greenlaw replaced Mrs. Mildred Chesley in grades two and three.

All grades received a battery of the Metropolitan Achievement test at the end of the first semester, except grade 1, their test is given at the end of the year. Grades 2-4-6-8 have taken the Otis Quick Scoring Test of Mental Ability.

Educational Television at the Ridge School is now a "fait accompli." A 21 in. General Electric set has been installed. This media will be used to supplement the existing curriculum. Beginning February 1st, the fourth and fifth grades will participate in a social studies program on New Hampshire. Other programs available through WENH-TV, Channel 11, which will enrich the present curriculum are elementary French, Mathematics and Science.

The present practice of grouping grades among the five teachers on the elementary staff has reached a point of diminishing return. If this practice is continued another year, a combination of the seventh and eighth grade will mean a class load of forty-six students. Therefore, it is urgently recommended that an additional teacher be procured for the 1960-61 fiscal year.

A continued shortage of teachers in all areas and the demand for additional teachers is creating a critical situation in New Hampshire. A poll taken recently at the Southeastern Superintendent's meeting indicated that there will be needed 131 additional teachers in this area next year. Consequently, each community should exercise every financial effort to retain their better and experienced teachers.

Northwood continues to have a definite school housing problem. Any major repairs or renovating of the present buildings will be costly. The school board has had several meetings with various architects and has accumulated considerable data on school construction cost. This information will be presented to the community in the near future. It will be necessary for the citizens of Northwood to make some very important decisions at the next regular school district meeting. Voting on such matters is your prerogative and duty, please exercise it.

In our American Democracy, the education of our children and the financial support of our schools is largely the responsibility of the local community, however, few people realize the scope of this expenditure in

Supervisory Union No. 44, which includes your community. The following data will be of interest to you:
