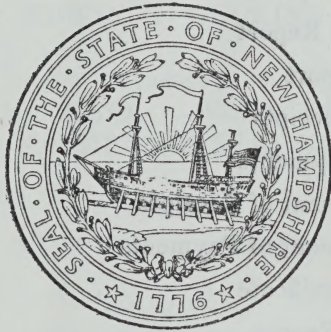

TOWN WARRANT**The State of New Hampshire**

To the Inhabitants of the Town of New Hampton in the County of Belknap in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at the Town House in said New Hampton on Tuesday the 9th day of March next, at 10:00 A.M. in the forenoon, the Polls to close not earlier than 6:00 P.M., to act upon the following subjects:

Business meeting at 8:00 P.M.

1. To choose all necessary Town Officers for the ensuing year.
2. To raise such sums of money as may be necessary to defray Town Charges for the ensuing year and make appropriations for the same.
3. To see what sum of money the Town will vote to raise and appropriate for the Maintenance and Repair of Highways and Bridges.
4. To see if the Town will vote to raise and appropriate \$1,136.81 for Town Road Aid, the State to contribute the sum of \$7,578.74.
5. To see what sum of money the Town will vote to raise and appropriate for tarring of Class V roads.
6. To see if the Town will vote to authorize the Selectmen to borrow money in anticipation of taxes.
7. To see if the Town will vote to raise and appropriate the sum of \$6,375.00 for principal and interest on the new Fire Station Note.

8. To see what sum of money the Town will vote to raise and appropriate for the repair of sidewalks.

9. (Petition) To see if the Town will vote that only phosphate free laundry detergent be offered for sale in Town of New Hampton after June 1 1971.

10. To see what sum of money the Town will vote to raise and appropriate for Memorial Day.

11. To see what sum of money the Town will vote to raise and appropriate for Old Cemeteries.

12. To see what sum of money the Town will vote to raise and appropriate for Old Home Day.

13. To see if the Town will vote to raise and appropriate the sum of \$500.00 for the care of the Village Cemetery.

14. To see if the Town will vote to raise and appropriate the sum of \$125.00 for the control of White Pine Blister. Rust.

15. To see if the Town will vote to raise and appropriate a sum of money for the support of hospitals.

16. To see if the Town will vote to authorize the Selectmen to appoint a full time Police Chief, the elected Chief to serve until the full time Chief is appointed.

17. To see if the Town will vote to raise and appropriate \$1,500.00 to be put into the Capital Reserve Fund for a new Fire Truck.

18. To see if the Town will vote to raise and appropriate \$2,000.00 to be put into the Capital Reserve Fund for the purchase of new Highway Equipment.

19. To see if the Town will vote to raise and appropriate the sum of \$500.00 for widening and repairing a section of the Sky Pond Road.

20. To see what sum of money the Town will vote to raise and appropriate for the Bristol Community Center.

21. (Petition) To see if the Town will vote to raise and appropriate the sum of \$300.00 to be expended on the improvement of the roadway leading to Winona Lake Improvement Association Property; provided that Winona Lake Improvement Association likewise raises the sum of \$300.00.

22. To see if the Town will vote to authorize the Selectmen to negotiate for land for highway department use, and to see what sum of money the Town will vote to raise and appropriate for the same.

23. To see what sum of money the Town will vote to raise and appropriate for the Town House Fund, and to authorize the Selectmen to use the existing Town House Funds for any necessary repairs to the building.

24. To see if the Town will vote to raise and appropriate the sum of \$900.00 for the Newfound Area Nursing Association.

25. To transact any other business that may legally come before this meeting.

REPORT OF FOREST FIRE WARDEN AND DISTRICT CHIEF

During this past year, the public has shown a great deal of cooperation in the prevention of fires. We wish to express our thanks for a job well done.

Your forest fire warden's job would be easier if everyone understood the State laws that govern the kindling of outdoor fires, a synopsis of these laws follow.

Fire Permits

A fire permit is needed for all outdoor fires in or near woodland anytime the ground is not covered with snow. This includes household waste burning, even if in an incinerator, grass burning, garden trash as well as brush burning (*such burning is restricted by regulation to be prior to 9:00 A.M. and after 5:00 P.M.*)

An Air Pollution regulation forbids the burning of household waste in towns where such rubbish is collected by the town.

Exceptions

Commercial or industrial burning is allowed under normal conditions with permission of the District Fire Chief and a permit from the Fire Warden.

Camp or cooking fires are allowed on your own property with permission of the Fire Warden. On another's property with written permission of the landowner and permission of the Fire Warden. The Warden can forbid such fires if in a hazardous area. Permits for cooking fires in the White Mountain National Forest can be obtained from the Laconia Office or at the Ranger Stations. Permits are not required in public camp or picnic grounds where fireplaces have been built for this purpose.

NEWFOUND AREA NURSING ASSOCIATION

January 1, 1970 through December 31, 1970

A full time visiting nurse service was started on July 1, 1969. The Newfound Area Nursing Association became Medicare certified on August 20, 1969. It is supported by contributions from the four-town area which it covers: Bristol, Bridgewater, New Hampton and Alexandria. The office is located in the Bristol Medical Center. Twenty-four hour coverage is available in the event of emergencies. When the Visiting Nurse is making calls, the telephone is covered by an answering service located in the Community Service Office from 9:00 A.M. to 4:00 P.M. This year NANA purchased a new black Jade Maverick to be used by the Visiting Nurse. It can be easily identified by NANA's own gold insignia painted on the side and the identification number plate NANA1. The nursing staff has increased with the addition of two part-time nurses. The total number of nursing visits for 1970 was 1585, with the break down as follows:

Skilled nursing care visits:	1303
Physiotherapy visits:	61
Health promotion - no charge visits:	218
Consultation visits:	3

These nursing visits covered all age groups with a varied number of problems as can be seen by the following: 17 visits were made to age group newborns to 1 yr.; 31 visits to children 1 to 4 yrs.; 37 visits to age group 5 - 17 yrs.; ten visits to age group 18 to 20 yrs.; 107 visits to age group 20 to 44 yrs.; 235 to age group 45 to 64, and 1148 visits to people 65 and over.
