You are hereby notified to meet at the Brentwood Fire House in said Brentwood on Thursday, the llth day of March next, at 7:00 of the clock in the evening, to act upon the following subjects:

- 1. To raise such sums of money as may be necessary to defray Town charges for the ensuing year and make appropriations for the same.
- 2. To see if the Town will vote to authorize the Selectmen to borrow such sums of money as may be necessary to defray Town expenses in anticipation of taxes.

At a legal meeting of the Inhabitants of the Town of Brentwood in the County of Rockingham, State of New Hampshire, qualified to vote in Town Affairs, held at the Fire House on Tuesday, the 10th day of March, 1981, the following business was conducted:

The warrant was read by Moderator Harold Sherman and the polls were declared open at 10:00 AM.

#### REPORT OF THE TOWN MEETING

#### March 12, 1981

At a legal meeting of the Inhabitants of the Town of Brentwood, in the County of Rockingham, State of New Hampshire. qualified to vote in Town Affairs, held at the Fire House on Thursday, the 12th day of March, 1981, the following business was conducted:

The meeting was opened by Moderator Richard Chamberlain at 7:00 PM. A motion was made by William Vahey and duly seconded to waive the reading of the Warrant. Motion passed by voice vote.

Article 1. A motion was made by Letty Hett and duly seconded to table Article 1 untill action is completed on Article 16. Motion passed by voice vote.

Article 2. A motion was made by Bruce Stevens and duly seconded to see if the Town will vote to authorize the Selectmen to borrow such sums of money as may be necessary to defray Town Expenses in anticipation of taxes. Motion passed by voice vote.

Article 3.A motion was made by William Vahey and duly seconded to see if the Town will vote to authorize the Selectmen. to accept and expend such sums of money as may become available through the Governor's Crime Commission Fund, the Federal Manpower Fund, the Additional Highway Subsidy Fund, or any other Federal, State, or Town monies or Private Funds which may become available. The motion passed by voice vote.

Article 4. A motion was made by James Fralic and duly seconded to see if the Town will vote to authorize the Fire Wards to accept and expend such sums of money as may become available for the use of the Fire Department. The motion passed by voice vote.

Araticle 5. A motion was made by Bruce Stevens and duly seconded to see if the Town will vote to raise and appropriate the sum of Thirty Thousand Three Dollars and Thirty-four cents (\$30,003.34) for the purpose of having a complete revaluation in 1981; and to authorize the Selectmen to withdraw from the Capital Reserve Fund set up in 1976 for this purpose, Thirteen Thousand Three Dollars and Thirty- four cents (\$13,003.34). Seventeen Thousand Dollars (\$17,000.00) additional to be raïsed by taxes. The motion passed by voice vote.

Article 6. A motion was made by William Vahey and duly seconded to see if the Town will vote to raise and appropriate the sum of Twenty-eight Hundred Dollars (\$2800.00) for the purchase of a copier. The motion passed by voice vote.

Article 7. A motion was made by Walter Small and duly seconded to see if the Town will vote to petition the Representatives and Senators who represent the Town in the General Court, to support in the current session of the General Court, the concurrent resolution to amend the State Constitution to limit the annual increase in property taxes to five percent and to limit the annual increase in spending by the State or any City, Town, or other Governmental unit of the March 12, 1981 Town Meeting cont'd.

Articlo 7. continued:

State to five percent. A motion was made by Jane Byrnes and duly seconded to close debate. Debate closed by voice vote. The motion failed by voice vote.

Article 8. A motion was made by William Vahey and duly seconded to see if the Town will vote to raise and appropriate the sum of Sixty Dollars (\$60.00) for the Children and Youth Project. Amotion was made be William NeCain and duly seconded to close debate. Debate closed by voice vote. The motion passed by voice vote.

Article 9. A motion was made by Letty Hert and duly seconded to see if the Town will vote to appropriate and authorize the withdrawl from the Federal Revenue Sharing Fund for the use as setoffs against budgeted appropriation for the following specific purposes and in amounts indicated herewith or take any other action hereon:

Highway Naintenance \$15,000.00. The motion passed by voice vote.

Article 10. A motion was made by Bruce Stevens and duly seconded to see if the Town will vote to authorize the Selectman to sell at Public Auction to the highest bidder, a certain parcel of land on Mill Road known as "Moul Land & Chimney". A motion was made by Sidney Northrup to close debate. Debate closed by voice vote. The motion passed by voice vote.

Article 11. A motion was made by Martha Roy and duly seconded to see if the Town will vote to authorize the Town to raise and appropriate the sum of Two Hundred and Thirty-eight Dollars (\$238.00) for the Rockingham Child and Family Services. Amotion was made by Jane Byrnes and duly seconded to close debate. Debate closed by voice vote. The motion passed by voice vote. Said vote was challenged and then passed by a showing of hands. 31 yes, 25 no.

Article 12. A motion was made by William Vahey and duly seconded to see if the Town will vote to raise and appropriate the sum of Three Thousand Dollars (\$3000.00) to establish a Capital Reserve Fund for the purpose of renovating or rebuilding the Town Highway Shed. An amendent was made by William Vahey and duly seconded if article passes in the affirmative a committe of five be appointed by the Moderator including one selectemen, and the road agent. A motion was made by William Vahey and duly seconded to close debate. Debate closed by voice vote. The amendent passed by voice vote. The main motion failed by voice vote. Said vote was challenged and failed: 37 yes, 56 No.

Article 13. Failed for lack of motion.

Article 14. A motion was made by Bruce Stevens and duly seconded to see if the Town will vote to authorize the Tax Collector, with the approval of the Selectman, to appoint a Deputy Tax Collector. Notion passed by voice vote.

Article 15. A motion was made by Donald Tash and duly seconded to confirm and reaffirm the grant of authority by the 1974 Annual Town Meeting empowering the Planning Board to review and approve or disapprove Site Plans for the development of tracts for non-residential uses, whether or not such development includes a subdivision or re-subdivision of the site, and to futher authorize the March 12, 1981 Town Meeting continued:

Article 15. continued

Planning Board to now exercise said authority in regards to multi-family dwelling units, other than one or two-family dwellings, all as provided by N.H. RSA 36:19-a (SUPP, 1979). A motion was made by Mrs. Stevens and duly seconded to close debate. Debate closed by voice vote. Motion passed by voice vote.

Article 16. A motion was made by William Vahey to see if the Town will vote to authorize the Board of Selectmen to accept the bequest of one George H. Beyea, Jr., late of Brentwood, of land and the improvements thereon located on Rt. 111A in Brentwood believed to be of 4.33 acres and in any event being no more than 16 acres, upon condition that the Town at its expense will forever maintain the land as open land, without buildings, bushes or scrub trees, except trees of an ornamental nature and, since the Executor of the estate has petitioned the Probate Court for instructions as to the said bequest in light of ambiguities arising between the Will of the said George H. Beyea, Jr., and his subsequent actions in respect to his real property, to futher authorize the Board of Selectmen in the likelihood that the said bequest to the Town is contested by the heirs or legatees of Beyea to act to protect the Town's interest and to be fully authorized, after consulting with Counsel, to enter into any settlement, or other negotiated disposition of the contest, including the specific authority to release the Town's claim to any improvements on the property or to accept less than the total bequest called for in the Will. Motion passed by voice vote.

Article 1. Taken from the Table. A motion was made by Letty Hett and duly seconded to remove Article 1 from the table. A motion was made by William Vahey and duly seconded to see if the Town would vote to authorize the sum of \$257,179.50 for a total budget. Motion passed by voice vote.

Article 17. A motion was made by William Thorsell and duly seconded to accept all reports and recommendations of all Committees and Commissions and to take any action necessary in regards to said reports. A letter was read by Letty Hett from the Brentwood Planning Board to the Selectmen stating that they had approved the Brentwood Master Plan at their February 27, 1980 meeting. Motion passed by voice vote.

Article 18. Amotion was made by Leslie Hett for a vote of applause for the citizens who worked on Brentwood's Master Plan.

Amotion was made by William Vahey and duly seconded for the Moderator to appoint a committe of five (5) to return at next year's Town Meeting with the price and type of structure for a new town shed to replace the existing one. Motion passed by voice vote.

## REPORT OF THE BRENTWOOD CONSERVATION COMMISSION

After three plus years serving our community as Chairman of the Conservation Commission, Dick Chamberlain resigned as Chairman due to travel pressures. He remains as a member of the commission. We would like to take this opportunity to thank Dick for all his hard work and leadership these past years and are delighted he remains with us so we may benefit from his experience.

Jim McGean and John Fletcher agreed to co-chair the commission until a full-time replacement is found.

Under the town's new Wetlands Ordinance it is the commission's shared responsibility to review dredge and fill requests. Two such requests were received and approved in 1981. Information on Gypsy moth control has been collected and passed on to the selectmen.

During the year our plans for the Town Forest moved forward. Lawrence Lyford has agreed to do the logging. In December, Earle Chase, County Extension Forester, marked the trees for cutting. The trees removed will be on a selective basis for timber stand improvement. Due to the present market situation and the poor quality of the wood involved, it was decided that the timber sale should be carried forth for three consecutive years. This would allow Lawrence to sell this low-grade wood in quantities which can realistically be absorbed by the marketplace. Approximately 11,000 board feet are marked and when sold should realize between \$400-\$500.

With the advice and consent of the Selectmen, the Commission intends to use part of these proceeds to develop a nature trail. Cleo Castonguay and the Swasey Friends for Recreation hosted a meeting last fall for members of the school staff, School Board, Selectmen, Conservation Commission, and other interested townspeople to discuss, among other things, a nature trail. Although principally of interest to the school (in subjects such as plants, animals, weather, ponds and streams, geology, mapping and surveying and social studies to name a few) the trail would be available for general community use. Cleo and his group, with their ideas and energy, were most helpful to the commission.

Archie Schroeder offered to prepare a pamphlet on the trail. It was thought that the best area would combine parts of the Town Forest and the School Forest. In the spring the commission will walk the area with Earle Chase, the Forester, members of the school staff, and a nature trail expert. The trail will be roughed out and Earle will mark those trees which should be cut consistent with the objectives for the trail.

Any person interested in attending our meetings, normally the second Wednesday of each month at the Town Office Building, and in, perhaps, serving on the commission, are most welcome.

The motion carried by a voice vote.

Article 4. Les Hett made a motion and was duly seconded to choose agents and committees in relation to any subject embraced in this warrant. The motion carried by a voice vote.

Article 5. Jonathan Rice made a motion and was duly seconded to see if the School District will vote to raise seven hundred ninety five thousand nine hundred dollars (\$795,900.00) for the support of schools, for the payment of salaries for school district officers and agents, and for the payment of the statutory obligations of the District. Ike Cross made a motion and was duly seconded to go over the budget item by item. The motion carried by a voice vote. After reviewing the budget Al Belanger moved the question and was duly seconded. The main motion passed by a voice vote.

Sid Northrup made a motion and was duly seconded to hear Article 2. He asked for a report concerning the renovation of Swasey School. John Rice explained that as of this time there was no longer any committee to make this report, but he reported that all the paving had been done and the drainage work had been completed. During the heavy rain of a couple of weeks ago the school remained dry. Plans have been submitted for the rest of the work (roof and exterior). Bids will go out the 25th of March. Article 2 was accepted by a voice vote.

Article 6. Al Belanger made a resolution to give thanks to the School Board, the teachers, the volunteers, the school secretary, and the school principal for their fine work. The resolution was seconded and passed by a voice vote. Al Belanger made a motion and was duly seconded to adjourn the meeting at 8:30 P.M. The motion passed by a voice vote.

## Superintendent's Report Frederick B. King

Once again it is time to reflect on some of the school matters in the Brentwood School District. This time of year is critical in the sense that decisions made by the school board, budget committee and voters have far reaching implications on the education of the youngsters in 82-83, as well as direct impact on property taxes; the financial document is a "blue print" of the upcoming school year. It is based upon the planning of the teachers and principal as they look ahead to the future. This process begins in September and reaches the end of the process with your vote. I trust you will look favorably upon this year's budget and will give it your support.

Special Education programs as a result of State and Federal Statutory requirements continue to cost the district more money in each budget year. In 82-83 a larger portion of tax dollars will go to educating the handicapped. This is due to three main reasons, the federal money has been reduced, the new state special education law puts a larger portion of the financial burden on the districts and thirdly, there appears to be more children requiring services. We will continue to investigate ways of delivering of special education services at lower costs, but I wish to alert you through this report that special education services are expensive and we are somewhat limited by law in reducing these costs.

As a result of a major curriculum study last year a new science program is now in all of our elementary schools. One of the goals of science education is, in addition to a background in scientific facts, to satisfy the needs of individuals so they can use science inquiry skills in their own lives and be able to cope with an increasingly technological world of the future. We hope a strong elementary science program will foster more interest in high school science.

This year three areas are under review. These are our grade 1 to 8 "level" system of presenting the basic subject areas, the reading system and the method of reporting to parents, namely the "report cards". At the same time a study of the high school curriculum has gotten underway. This committee will be reviewing what is taught at the secondary level and making new recommendations for proposed curriculum changes. The report is not due until next November 1982.

Evidence continues to mount to indicate that we have a good school system. This is largely due to the efforts of our teachers and administrators reinforced by the support of the many parents and citizens of this community. There are two types of testing programs which verify how well our students are learning. One is a test given as part of the State Accountability program. We are now able to compare our schools with others in the Seacoast Area. In all subject areas tested we score as high and in most cases higher than those around us. On the national tests taken recently at grades 2, 4 and 6 our towns showed scores again in the top quarter of schools in the country. Mr. Short, Teacher Consultant, has worked very closely with the Brentwood Board this year. This has been a great help to me in trying to give attention to all the many school matters. There is a need for additional help. Perhaps this is not the year - but then is there ever a year to increase Central Office staff? I have always, and will continue to give as much of my time as is possible to keeping our schools in the top quarter of the country. I am grateful to the principal and the teachers for their cooperation and dedication. I've always said a school is only as good as its staff. Brentwood is fortunate to have a group of dedicated teachers who have been with us for quite sometime. This is a definite strength in providing a quality program.

Organizations are not always perfect. The schools are no exception. What we continually need to do is assess our school programs including the achievement of students and work upon those weaknesses that hamper student progress and learning. As educators, I believe we do address the issues that effect classroom learning and school environment. To do less is to be less professional than we can be. The fact remains in this community the tax dollar has basically been utilized well to produce student achievement and success. More emphasis upon teacher evaluation, effective schools, in-depth in-service programs for the staff, and greater utilization of test results will occupy much of the future planning. In conclusion, we know our schools are doing an important job, and I welcome your comments and concerns for future planning.

#### Swasey Central School's Principal's Report

The beginning of 1981 saw Swasey with 184 children (six of whom were in our Special Education class) and 9 full time teachers. The high caliber of education offered at Swasey continues largely due to our experienced staff, with very low turnover. The addition of two lunch aides enabled the teachers to have an uninterrupted lunchtime; the only such break in the day.

General curriculum continued to be guided by SAU #16 in Exeter. Two Swasey staff members and a Brentwood parent served on the Science Curriculum Committee, that recommended a basic curriculum and text books to the Superintendent. In the spring, our school participated in the "Young Author's Program" in which children in all grades wrote books that were judged by a panel. The author of the best was then invited to attend a dinner honoring all such winners in New Hampshire. Jodi Packard and her family attended.

This year, volunteers who have traditionally helped in the school were organized into a School Volunteer Program under the leadership of Cindy Sheldon. By talking with personnel from the New Hampshire School Volunteer Program headquarters in Manchester, Cindy was able to get new ideas on how lay people could support and supplement the efforts of the school staff. Both Cindy, the principal, and the Swasey staff sought to identify additional needs that could be met through volunteer services. Then, additional parents and townspeople were encouraged to share their talents and time as school volunteers. As a result, our children are exposed to more music, physical education and art activities than was possible previously. Teachers have additional "people" resources to enrich their student's education.

In a tribute to Cindy's involvement, she was named as one of the ten outstanding N.H. School Volunteers of 1981. In addition, our program received one of nine national awards for "Parent Involvement" from the National School Volunteer Program this past November.

In May, a most successful "Swasey Carnival", was held to raise money for a new playground. Due to the efforts of chairmen, Bill and Elaine Carroll, other organizers, and an army of workers, we raised \$2300. An anonymous matching gift brought our total to \$4600. The planning timetable aims to get construction started as early as this spring.

School opened this fall with a renovated new wing: new roof, ceilings, fixtures, and exterior insulated walls. The site work and drainage work have improved ground water run off considerably. These improvements have cut our heating bill and virtually eliminated the perennial moisture problem.

Last June the school board increased the principal's position from four to five days. Increased special education and other supervisory responsibilities were a few reasons for this change. Another first for Swasey was the beginning of a small band, under the direction of Alan Nasberg, a local music teacher. The parents of the children participating bear the total cost of this new program.

In summary, 1981 was a productive one at Swasey. The entire staff extends their appreciation for the support and understanding demonstrated by the town in our efforts to educate your children.
