The year 1976 has been good to the town of Cornish with the majority of the departments staying within their budgets.

Our T.R.A. money was spent on finishing up Harrington Road. Our Duncan Fund money was spent on Hell Hollow Road—a road that has had no major work done on it for years.

With matching funds from The Bureau of Outdoor Recreation the town has remodeled the Cornish Flat Swimming area. We rebuilt the dam, installed a guardrail across the top of the dam, and made a sandy beach. This area is open for everyone as we used government matching funds to build it.

The Selectmen purchased a 3M Copier machine which is used a great deal by all departments.

The microfilming of town records was carried out, using money voted at the 1976 Town Meeting.

The Cornish Flat Meeting House land has been surveyed and the deed transferring the property to the town has been prepared.

We wish to thank all departments for trying to stay within their budgets, and we particularly want to thank the ladies who carried out the work in the microfilm project.

**TOWN WARRANT
THE STATE OF NEW HAMPSHIRE**

The Polls will be open from 10:00 a.m. to 7:00 p.m.

To the Inhabitants of the Town of Cornish, N.H. in the County of Sullivan in said State, qualified to vote in Town affairs:

You are hereby notified to meet at the Town Hall in said Cornish on Tuesday, the 8th day of March 1977 at 10:00 a.m. to act upon the articles set forth in the Warrant.

Articles 1, 2, 3, 4, 5, 6, and 7 will be acted upon at 10:00 a.m. Voting will be by official ballot and check list, and the polls will remain open for this purpose from 10:00 a.m. until 7:00 p.m., at which time polls will close.

At 1:00 p.m. articles 8 through 24 will be voted upon.

Article 1: To choose all necessary Town Officers for the year ensuing.

Article 2: To see what action the Town of Cornish will take on Amendment No. 1 to the Cornish Zoning Ordinance pertaining to "Lots in more than one District", as presented by the Planning Board. Vote by ballot.

Article 3: To see what action the Town of Cornish will take on Amendment No. 2 to the Cornish Zoning Ordinance to change Residential Districts from 1 acre to 2 acres, as presented by the Planning Board. Vote by ballot.

Article 4: To see what action the Town of Cornish will take on Amendment No. 3 to the Cornish Zoning Ordinance to allow for 2 acre lots in the Rural Residential and Conservation Districts under certain special conditions, as presented by the Planning Board. Vote by ballot.

Article 5: To see what action the Town of Cornish will take on Amendment No. 4 to the Cornish Zoning Ordinance to allow for certain nonresidential uses as special exceptions and definitions of some of these uses and additional standards and conditions for granting special exceptions, as presented by the Planning Board. Vote by ballot.

Article 6: To see what action the Town will take in authorizing the use of absentee ballots at the annual Town Meetings pursuant to the provisions of RSA 60:31, et seq. Vote by ballot.

Article 7: Shall we adopt the provisions of RSA 72:43-b and 43-c for expanded exemptions on real estate which provide for a resident sixty-five years of age up to seventy-five, a five thousand dollar exemption; a resident seventy-five years of age up to eighty, a ten thousand dollar exemption; a

resident eighty years of age or older, a twenty thousand dollar exemption; provided that the resident owns the real estate individually or jointly with another or his spouse with whom he has been living for at least five years as man and wife; said resident had a net income of less than seven thousand dollars or combined income with spouse of less than nine thousand dollars; and owns assets of any kind, tangible or intangible, less bona fide encumbrances, not in excess of thirty-five thousand dollars?

Article 8: To raise such sums of money as may be necessary to defray Town charges for the ensuing year and make appropriations of the same.

Article 9: To see if the Town will vote to authorize the withdrawal from the Revenue Sharing Fund, under the provisions of the State and Local Fiscal Assistance Act of 1972 as amended by the Second Session of the 94th Congress, of \$4,000.00 to make the last payment on the note due on December 15, 1977 on the Fire Truck Loan.

Article 10: To see if the Town will vote to raise and appropriate the sum of \$1,500.00 to assure ambulance service for the Town of Cornish, and to

see if the Town will vote to authorize the withdrawal of the above amount from the Revenue Sharing Fund under provisions of the State and Local Fiscal Assistance Act of 1972 as amended by the Second session of the 94th Congress.

Article 11: To see if the Town will vote to raise and appropriate the sum of \$6,500.00 for a new 4-wheel drive pickup truck with snow plow for the use of the Highway Department, and authorize the withdrawal of \$4,000.00 of the above amount from the Revenue Sharing Fund under the provisions of the State & Local Fiscal Assistance Act of 1972 as amended by the Second Session of the 94th Congress.

Article 12: To see if the Town will vote to indemnify the selectmen, members of the Planning Board and Zoning Board of Adjustment, Town employees and any other person or persons who are members or officers of any other administrative board or agency and its staff against financial loss and expense including legal fees and costs if any arising out of any claim, demand, suit or judgment resulting from an act or acts within the scope of such person's employment or office pursuant to the provisions of RSA 31:105.

To see whether the Town will vote to appropriate up to \$2,000.00 for the year 1977 for the purpose of processing liability insurance coverage for the purpose of insuring against liability and employees pursuant to RSA 31:105 and/or as a result of liability arising under RSA 31:106.

Article 13: To see if the Town will vote to raise and appropriate the sum of \$1,200.00 for the completion of the Town Record Microfilming Project.

Article 14: To see if the Town will vote to raise and appropriate the sum of \$500.00 for Meals on Wheels' service for Cornish residents.

Article 15: To see if the Town of Cornish will authorize the Planning Board to adopt Non-residential Site Plan Review Regulations.

Article 16: To see if the Town wishes to exclude from the Town's Federal Social Security Plan service in any class or classes of positions of election officials or election workers for a calendar quarter in which the remuneration paid for each service is less than \$50.00.

Article 17: To see if the Town will vote to appropriate the sum of two hundred fifty six dollars (\$256.00) as its share of the cost of publicizing and promoting the natural attractions of the Dartmouth-Lake Sunapee Region.

Article 18: To see if the Town will vote to make the office of Constable appointed, and to authorize the Selectmen to appoint such constables as they deem necessary and proper; if adopted this vote takes effect in March of 1978.

Article 19: To see if the Town will vote to set a maximum salary of \$1,200.00 for the tax collector, instead of the statutory fee of 5/8 of 1% of all property and resident taxes collected.

Article 20: To see if the Town will authorize the Selectmen to accept and expend federal and state grants, gifts and other funds from miscellaneous sources in addition to the original appropriations for 1977 general expenses, equipment and improvements.

Article 21: To see if the Town will vote to instruct the Selectmen to sell or otherwise administer property acquired through tax sales.

Article 22: To see if the Town will vote to instruct the Selectmen to borrow money, if necessary, in anticipation of taxes.

Article 23: To hear the reports of Officers, Agents, Auditors, and Committees heretofore chosen and pass any vote in relation thereto.

Article 24: To transact any other business that may legally come before this meeting.

TOWN MEETING—MARCH 2, 1976

Check List 717 names; Ballots printed—600; Voted—247

Ballot Clerks Adel Bayliss, Nancy Laro, Polly Monette and Clara Weld counted the regular ballots, and the Zoning Amendments ballots; Supervisors signed all four Check Lists, and were sworn in by the Clerk.

Polls were opened at 10:10 a.m. by Peter H. Burling, there being a quorum, and he proceeded to read the warrant.

Polls were closed at 7:55 p.m., and the business meeting also came to a close at 8:30 p.m. and this part of the meeting was adjourned by Edwin Lawrence and Orville Fitch II.

Results of *Article 1*: To choose all necessary Town Officers for the ensuing year.

Michael M. Yatsevitch received 207 votes and Hollis J. Boardman, Sr. 37 votes; Michael Yatsevitch was thus elected as Selectman for 3 years.

Bernice F. Johnson received 243 votes for Town Clerk, and was elected.

Donald J. Powers received 235 votes for Town Treasurer, and was elected.

Carol F. Fitch had 242 votes for Tax Collector, and was elected to office again.

Eben A. Farnsworth got 237 votes for Auditor for 2 years, and so was elected.

Norma J. LaClair received 234 votes for Library Trustee for 3 years, and was elected.

Lewis O. Gage, Jr. received 228 votes for Trustee of Trust Funds for 3 years, and was elected to office.

For two Constables, Orville B. Fitch II received 202 votes, and James Lukash received 226, and both were thus elected.

William B. Tracy received 233 votes for Overseer of Public Welfare, and was re-elected.

Robert C. LaClair received 197 votes for Highway Agent, and was re-elected to that office.

Hollis J. Boardman, Sr. received 109 votes for Sexton, and Michael D. Monette received 129 votes; Michael Monette was elected Sexton.

The write-ins were as follows: Selectman-Ed Lawrence, 1; Town Clerk-Nancy Laro, 1; Treasurer-Eben Farnsworth, 1, Pete Decatur 1, and James Neil, 1; for Tax Collector-Bernice Johnson, 1; for Auditor-Sandi Powers, 1, Lewis Gage, 3; Library Trustee for 3 years-Barbara Rawson, 1, Kay Kibbie, 1, and Joan Hier, 1. For Trustee of Trust Funds,-Ellsworth Atwood, 3, Bill Tracy, 1, and Donald Saunders, 1. For Constables,-E. P. Jones, 1, Harry Jones, 1, Dan Poor, 1, Paul LaClair, 9, and Arthur Macy, 6. For Overseer-of Public Welfare-Marion Boardman, 7; for Highway Agent-Ed Jones, 1, Orville Fitch, II, 1, Myron Kuhre, 2, Harold Morse, 13, and Milt Jewell, 3; and for Sexton-Jim Borchert, 1.

Article 2: To see what action the Town will take on Amendment 1 to the Cornish Zoning Ordinance pertaining to the appointment of members and alternates to the Zoning Board of Adjustment, as presented by the Cornish Planning Board. Voted by ballot: Yes-163 No-60

Article 3: To see what action the Town will take on Amendment 2 to the Cornish Zoning Ordinance to change Rural Residential Zone from 5 acres to 2 acres as presented by petition. Voted by ballot: Yes-106 No-138

At 12:45 a short skit was put on, outside the rails, by some of the school children, supervised by Beverly Widger, teacher. It depicted some of the earliest Cornish Town Meetings, with the youngsters in appropriate costumes, all as men, and brought in some of the incidents that did happen during the early days of the forming of Cornish as a town. Each pupil represented one of our forefathers that was active in town affairs at that time. This was a contribution from the school to the town's Bicentennial of the American Revolution and the birth of this country.

Following the skit, the school children led in the Salute to the Flag. Peter H. Burling asked for a moment of silent prayer by everyone. Then he read the articles in the Warrant, from Article 4 through Article 28. Dan Poor moved that the Cornish school students be allowed to participate in the discussions that are to be held on the floor, seconded by Michael M. Yatsevitch. Jack MacMillan spoke against this, and so moved, supported by N. A. Leyds. It was voted on, against. The original motion was voted on, in favor.

Ruth Rollins moved, seconded by Paul Tewksbury, that we handle *Article 4* line by line. Bob LaClair moved, Myron Quimby seconded, that we accept Article 4. This was so voted.

Article 4a: Ed Lawrence moved, seconded by Harold Tillson, that we raise and appropriate \$7,000.00 for Town Officers' Salaries. It was voted on, in the affirmative.

Article 4b: Bud Fitch moved, Joseph Woodward supported, a motion to raise and appropriate \$4,500.00 for Town Officers' Expenses. This was voted on, in the affirmative.

Article 4c: Ruth Rollins moved, Myron Quimby supported, to raise and appropriate \$1,500.00 for Election and Registration expense. This was voted on, in favor.

Article 4d: Fred Sullivan moved, Ed Lawrence seconded, that we raise and appropriate \$7,500.00 for Town Hall and other buildings. Paul Tewksbury asked about insulating the Town Hall. Stephen Tracy corrected the figure for Total Appropriations on page 20, to read \$162,702.89. The motion by Fred was voted on, in the affirmative.

Article 4e: Peg Densmore and Ruth Stewart moved and seconded that we raise and appropriate \$5,000.00 for Employees' Retirement and Social Security. This was so voted.

Article 4f: Ed Lawrence moved, Paul Therriault supported, a motion to raise and appropriate \$1,600.00 for the Police Department. So voted.

Article 4g: Harold Tillson and Duane Allen moved and seconded that the town raise and appropriate \$3,900.00 for the Fire Department. It was a vote in the affirmative.

Article 4h: Willow Densmore moved, Donald Powers seconded, \$2,500.00 be raised and appropriated for insurance, for workman's compensation. This was voted on, in the affirmative.

Article 4i: Clara Weld made a motion to accept the amount of \$5,000.00 to be raised and appropriated for legal expenses, supported by Bud Fitch, after the article had been explained by the Selectmen. This motion was passed by vote.

Article 4j: Paul Tewksbury moved, Bob LaClair seconded, that we raise and appropriate \$300.00 for the costs of dogs in town. It was voted on in the affirmative.

Article 4k: Robert LaClair moved, Shirley Sullivan supported, that we raise and appropriate \$100.00 to defray the expenses of the Board of Adjustment. This was so voted by the Town.

Article 4l: The sum of \$100.00 for Civil Defense was raised and appropriated by vote of the town, after being moved by Ruth Rollins and seconded by Duane Allen.

Article 4m: E. Leonard Barker moved, John Rand supported, a motion to raise and appropriate \$100.00 for the Health Department of Cornish. This was so voted.

Article 4n: Donald Powers and Myron Quimby moved and seconded a motion to raise and appropriate \$100.00 for Vital Statistics. This was so voted.

Article 4o: Following some information on the statistics of the Visiting Nurse and the number of people in town that she attends, Polly Rand moved we raise and appropriate a sum of \$500.00 for this purpose, supported by Michael Yatsevitch, and it was voted in the affirmative.

Article 4p: Fred Sullivan moved, seconded by Bob LaClair, that we pass over Article 4p until we take up Article 12—on Sanitary Landfill. This was so voted by a hand vote.

Article 4q: Willow Densmore moved, Michael Yatsevitch seconded, that the \$93,000.00 suggested for Town Maintenance of Class V Highways & Bridges, be amended to be reduced by \$16,195.63—the amount of the gas tax subsidy from the state. The total amount comes to about \$30,000.00 more than last year, and after some discussion. Robert LaClair was asked to explain why such a high budget for our roads, and where he planned to have all this used. He explained that he spent \$35,366.40 last year, and

\$38,418.72 this year. Blue Cross, etc., is included in these figures. There is a big difference in prices of liquid asphalt, which amounts to \$10,000.00 of budget; gravel and cold pack, \$7,000.00, blades \$8.40 each or \$16.80 a pair a few years ago. are now \$60.00 each! After this year, Bob thought about \$5,000.00 per year would be spent on asphalt. Costs between \$1,350.00 and \$1,650.00 a mile to apply asphalt. Old theory was to apply new every 3 years; now maybe every 4, as it doesn't crack up. He plans on 7 miles of liquid asphalt. Kevin Farley asked what the types of roads are. Mr. LaClair explained what Class V and Class VI etc. are. He explained the costs of gravelling roads. Ruth Rollins spoke in giving Bob and his crew much credit. Myron Quimby said this had been hashed over, and he called for a vote on the motion. Bill Gallagher asked what roads he planned to asphalt. Mr. LaClair answered. The original motion was repeated and a vote was called, Leonard Barker having supported Myron Quimby's motion. The town voted in the affirmative, for \$76,804.37 to be raised and appropriated for Town Maintenance of Class V Highways and Bridges.

Article 4r: Ed Lawrence moved the town raise and appropriate \$300.00 for street lighting, seconded by Ellsworth Atwood. After a short discussion on what this consists of—light bulbs, etc., the motion was passed by vote.

Article 4s: It was voted by the Town to raise and appropriate \$1,150.89 for Town Road Aid by motion made by Ruth Rollins, seconded by Shirley Sullivan.

Article 4t: \$1,800.00 for George H. Stowell Library was moved to be raised and appropriated by Donald Saunders, supported by Joseph Woodward. This money would include over last year's budget scrape and paint of trim, plus an increase of 20c of from \$2.10 to \$2.30 per hour for the Librarian's salary; also increased hours of being open; also insurance increased from past to \$27,500.00. It was brought out that Article 4d (Town Hall & other buildings) does not include the Library. Motion was voted on, in favor.

Article 4u: Duane Allen moved, Nicolaas Leyds supported, a motion to raise and appropriate \$3,700.00 for Public Welfare. This was so voted.

Article 4v: Fred Sullivan moved, Willow Densmore seconded, a motion to raise and appropriate \$2,500.00 for Cemeteries. It was voted on, in the affirmative.

Article 4w: Ruth Stewart moved, Willow Densmore seconded, a motion to raise and appropriate \$9,200.00 for Principal and Long Term Notes. This was voted on, in the affirmative.

Article 4x: Leonard Barker moved, Duane Allen supported, the motion to raise and appropriate \$2,952.00 for Interest on Long Term Notes. This was so voted.

Article 4y: Fred Sullivan and Nicolaas Leyds moved and supported the motion to raise and appropriate \$2,400.00 for Interest on the motion to raise and appropriate \$2,400.00 for Interest on Temporary Loans, and it was passed by vote of the Town.

Article 4z: Michael Yatsevitch and Donald Powers made and supported the motion to raise and appropriate \$1,000.00 for Capital Reserve Fund for Highway. This was voted on, in the affirmative.

Article 4z1: Ed Lawrence moved that we pass over this article until we reach Article 5, seconded by Orville Fitch II, and voted on, in the affirmative.

Article 4z2: Fred Sullivan moved, Donald Clineff seconded, a motion to raise and appropriate \$1,000.00 for the Conservation Commission Capital Reserve Fund. This was so voted.

Article 4z3: Fred Sullivan moved, Marilyn O'Grady seconded, that the town raise and appropriate \$1,000.00 for the Tax Map Capital Reserve Fund. This was voted on, in the affirmative.

Article 4z4: The necessary amount for County Taxes was moved by Michael Yatsevitch and supported by Leonard Barker to be raised and appropriated. This was voted on, in favor.

Article 5: Robert Rice, Jr. seconded Duane Allen's motion that the Town vote to increase the contribution to the Fire Department Capital Reserve Fund from \$1,500.00 to \$3,000.00 by appropriating each year the sum of \$3,000.00 and instructing the Selectmen to make it a budgetary item each year thereafter. Pete Decatur, supported by N. A. Leyds, moved to change the word "each" to this year. Voted on the amendment, in favor. Discussion followed, by Susan VanRensselaer, Nic Leyds, Ed Lawrence, Paul Queneau, etc. The original motion, as amended, was called for a vote by the Moderator, and was voted on, in the affirmative.

Article 4z1: Fred Sullivan moved, seconded by Duane Allen, to pass over the article. This was a vote in favor.

Article 6: Myron Quimby moved, Shirley Sullivan seconded, that the Town vote to raise and appropriate the sum of \$26,100.00 for the reappraisal of the town by the State Dept. of Revenue Administration, and for a tax map of the Town. Also to see if the Town will vote to pay for this by appropriating \$8,700.00 from taxes this year, the balance of cost by notes to be paid over a period of two years. The money in the Tax Map Capital Reserve to be used to help reduce the balance to be financed by notes. Myron Quimby then moved to amend, seconded by Pauline Monette, to reduce the \$26,100.00 to \$20,100.00. The vote on the amendment was called, and was voted for in the affirmative.

Further comments: Need to have the tax map and reappraisal by 1980 at 100% of valuation. Current land use bill brought up by Arthur Densmore, who wanted everyone to pay their tax and not receive a refund because of being a tree farm or from having brush cut, etc. Jim Neil spoke in favor of it—to have an unbiased appraisal by an outsider. Neil moved we call for a vote, seconded by Robert LaClair. This was voted. Myron Quimby added that by a signing of 40 or 50 people, they could force a reappraisal. The original motion, as amended, was called for a vote, and was passed in the affirmative.

Article 7: Ruth Rollins moved, Kay Kibbie seconded, that the Town raise and appropriate the sum of \$600.00 for a copying machine for the Selectmen's and Town Clerk's office, and authorizing the withdrawal of \$300.00 of the above amount from the Revenue Sharing Fund under the provisions of the State and Local Assistance Act of 1972. This motion was voted on, in favor.

Article 8: Pete Decatur moved, Ed Lawrence seconded, that the Town authorize the withdrawal from the revenue Sharing Fund, under the provisions of the State and Local Assistance Act of 1972 of \$4,000.00 to make payment on the note due on December 15, 1976 on the New Fire Truck loan, as a set-off against this debt service incurred for "priority expenditures" since Jan. 1, 1972. This motion was passed by vote of the Town.

Article 9: Shirley Sullivan moved, supported by Ellsworth Atwood, that the Town raise and appropriate the sum of \$1,200.00 to assure ambulance service for the Town of Cornish; and to see if the Town will vote to authorize the withdrawal of the above amount from the Revenue Sharing Fund under provisions of the State and Local Assistance Act of 1972. This was so voted.

Article 10: Robert Hilliard moved, Jack MacMillan supported, a motion that the Town raise and appropriate a sum of money for the repair of the Mercer Bridge. Michael Yatsevitch and George Edson moved that the sum be for \$6,500.00. Donald Powers suggested that the Town borrow this money—said sum to be paid by a series of notes not to exceed three years. He made it a motion to amend, seconded by Sandi Powers. After considerable discussion, they withdrew their amendment. Robert LaClair said this bridge was inspected in 1973 and was in need of repair. He then moved that the Town vote on the motion, seconded by Nic Leyds. This was a vote in favor. The original motion was then read, and voted on, in the affirmative.

Article 11: Milt Jewell moved, and Jim Neil supported, that we pass over the article—to raise and appropriate money for the repair of the covered bridge off Platt Road. This was voted in the negative. Bill Overman gave the amount of \$8,000.00 for the repair of this bridge, and moved that the Selectmen be requested to apply for what the state will give, seconded by Bob Widger. This covered bridge was closed in 1974. The abutment on one

corner is cracked and the splicing of timbers is needed. It will cost between \$9,000.00 and \$10,000.00 to repair it for vehicle traffic.

Bill Gallagher and Lynn Eberhardt moved and supported to raise and appropriate \$3,000.00 to preserve the covered bridge. They withdrew their motion, after discussion.

Donald Powers asked if the road crew would have time to fix this bridge, if we voted it? J. T. McSwain moved, seconded by Orville Fitch, to amend the motion to see if the Town will vote to raise and appropriate \$3,000.00 to preserve the bridge off Platt Road. This was voted against.

Donald Powers moved to see if the Town will finance the appropriation authorized in Article 10 by a series of notes, the first to be due in 1977, the second in 1978 and the third to be due in 1979, terms of the notes to be at the discretion of the Selectmen. This was seconded by Sandi Powers. Polly Monette moved we vote by paper ballot, seconded by Ruth Rollins. The town then voted: Yes: 57 No: 78

Article 12: Fred Sullivan moved, Paul Therriault supported, to raise and appropriate a sum of money for the purchase of land to meet the Town's sanitary Land-fill requirements. Nicolaas Leyds gave a report of the committee. Arthur Densmore moved, Jill Edson seconded, to contract with Claremont to utilize the Claremont sanitary land-fill at the terms decided by the Land-fill Committee, the payment terms are not to exceed \$5,000.00 a year, said contract to be negotiated as soon as possible. There followed a long discussion. Two ways to get our trash to Claremont—ourselves, or by garbage collector.

Bill Gallagher amended the above motion to read, do we stay with our own dump, buy land for a landfill, or go to Claremont? Seconded by Susan VanRensellaer. Voted on, against.

Shirley Sullivan moved, seconded by Sandi Powers, that we raise and appropriate \$5,000.00 for Sanitary Land-fill. This was voted on in the affirmative.

Article 13: Orville Fitch II moved, Ed Lawrence supported, that the Town vote to raise and appropriate the sum of \$350.00 for the purchase of equipment for the Police Department. This was voted on in the affirmative.

Article 14: Polly Monette moved to pass over the article, to vote to raise and appropriate the sum of \$879.00 for membership in the Upper Valley-Lake Sunapee Council. George Edson supported her motion. This was voted in favor.

Article 15: Clara Weld moved to accept this article, that the Town do raise and appropriate the sum of \$184.00 as its share of the cost of publicizing and promoting the natural attractions of the Dartmouth-Lake Sunapee Region, seconded by Paul Therriault. This was voted on in the affirmative.

Article 16: Peter Storrs moved, Bob Hilliard supported, that the Town raise and appropriate the sum of \$111.00 for white pine blister rust control. This was voted on, in the affirmative.

Article 17: John Dryfhout moved, Craig Black supported, that the Town raise and appropriate the sum of \$350.00 for administration and expenses of the Conservation Commission. Craig Black explained the reason for this; it was brought to a vote, and passed in favor.

Article 18: Fred Sullivan moved, Bob LaClair supported, that the Town raise and appropriate a sum not to exceed \$500.00 for surveying town-owned land. This motion was voted on, in favor.

Article 19: (By request) Be it resolved that, first, the Town authorize and instruct the Board of Selectmen to negotiate and enter into a sales agreement with the United Church of Cornish, its officers or assigns, for the donation or purchase of the building and lands at Cornish Flat, formerly known as the Baptist Church; and second, that the Town raise and appropriate the sum of \$2,500.00 for the maintenance of the building. The sum of \$200.00 to be used from this allotment for the purchase or donation agreement costs, the remainder to be held in escrow as a building maintenance fund. Such funds to be available to the Selectmen for matching funds from any source for the restoration and rehabilitation of the building; maintaining the historic character of the structure and at the same time making it available as a public building.

John Dryfhout so moved the above article, seconded by Jill Edson. John then proceeded, with permission, to read an article he had written, on the history of the building. Built in 1803; moved from Parsonage Hill Rd. to its present site in 1817-1818; its architect was William Abbott; contains 4,000 square feet, etc. Really an excellent article. He suggested such figures as \$500 to \$600 for what repairs by a carpenter would be needed, and \$1000 to \$1500 for painting.

Clara Weld presented the church's viewpoint—would have preferred to have it used as a church, but better to have it being used than to tear it down and the United Church cannot continue to keep up both this and the Center brick edifice.

Paul Queneau made a plea to accept the generosity of the United Church. He spoke of the fact that Cornish's Salmon P. Chase was the one who had "In God We Trust" put on the United States' monies.

Joseph Woodward said the Church had three alternatives; to give it back to the Baptist Conference; use it as a church with an assistant minister; or tear it down.

Polly Rand suggested appointing a Board of Trustees to be a working group to repair and keep the building going.

Paul Terriault moved, Sandi Powers supported, a motion to call the article to a vote, and end discussion. This was so voted. Moderator Burling read the motion again, and asked for a vote. This was voted on with well over two-thirds being in the affirmative.

Article 20: Bud Fitch moved, Ed Lawrence seconded, that the Town vote to raise and appropriate the sum of \$2,000.00 for microfilming Town records. In explanation, it was stated that this is for the current records of 1900 to the present date. Also that the Mormons will be back this spring to do more records, prior to 1900, free of charge. A vote was called for, and the Town voted in the affirmative.

Article 21: Ed Lawrence moved, Pete Decatur seconded, to pass over this article, for \$4,000.00 to repair the 1952 Ford fire truck. It was so voted by the town, and thus passed over.

Article 22: Myron Qimby moved, Jim Neil supported, a motion to discontinue the stretch of road, which is now subject to gates and bars, starting from opposite the Patkowsky property to the Tifft Road near the Tilghman place now owned by Alfred Hoidahl. Quite a discussion was held, in the middle of which the Moderator declared the Polls closed, as it was then 7:55 p.m. Finally it was decided to call the question: the vote taken was all in favor but one. Thus the road will be discontinued.

Article 23: Fred Sullivan moved, seconded by Ed Lawrence, that the stretch of road, that was part of East Road, that was abandoned in front of the Zelma Fox property when the road was repaired and straightened, be discontinued. This was voted on in the affirmative.

Article 24: Michael Yatsevitch moved, Joseph Woodward supported, a motion to authorize the Selectmen to accept and expend federal and state grants, gifts and any other funds from miscellaneous sources in addition to the original appropriations for 1976 general expenses, equipment and improvements. Mike then amended it to add: that the Town authorize the Selectmen to apply for, contract for and accept aid from any and all agencies, both State and Federal, relative to disasters which may occur during the ensuing year and until the Annual Town Meeting in 1977, and to expend funds so received to repair and restore damaged municipal properties and to alleviate disorders resulting from such disasters. On the motion to amend, it was voted unanimously in favor. Then the main motion was voted on, in the affirmative.

Article 25: Pete Decatur moved to instruct the Selectmen to sell or otherwise administer property acquired through tax sales. George Edson supported his motion. This was voted on in the affirmative.

Article 26: It was voted to instruct the Selectmen to borrow money, if necessary, in anticipation of taxes, through motion of Ed Lawrence seconded by Willow Densmore.

Article 27: Ellsworth Atwood moved to accept the reports as printed in the Town Report, seconded by George Edson. This was so voted.

Article 28: Lewis Gage commented on the Cornish Rescue Squad's participation in District B1, of Claremont. He much favored, and so moved, that the Town join A6 District in Hanover, and resign from District B1. Polly Rand supported this motion. This was voted on, by the Town, in the affirmative.

Nominations were asked for, for Fence Viewers, and it was stated that this was a serious office as these people sometimes called upon to settle disputes over property lines. Ellsworth Atwood moved, Jill Edson seconded, nominations for the same Fence Viewers as last year, as well as the same for Surveyors of Wood, Bark and Lumber. All were elected by unanimous vote. Fence Viewers: Fred Sullivan, Edwin G. Lawrence, and Katherine E. Kibbie. Surveyors of Wood, Bark and Lumber: Jesse Stone, Orville Fitch, Fred Weld and James Neil.

Ruth Stewart moved that Cornish establish the idea of bi-annually paying real estate taxes in Cornish. Robert Hilliard seconded this idea.

Quite a discussion was held following a statement by Ruth Stewart about having Absentee Ballot voting for our local Town Meetings. The sense of the meeting is that the Selectmen contact Town Counsel as to what the Town can do to allow people in hospitals or unable to attend Town Meeting to vote by absentee ballot.

Nominations were opened for Hog Reeves: Pet Densmore moved, Paul Tewksbury seconded, nominations for the same slate of Hog Reeves as last year. Charles Weld nominated Fred Weld. Frank Ackerman moved that nominations close. This was supported, and the following were elected to office: William Ardinger, Donald Clineff, Daniel Poor, Lester Little, Leonard Barker, Sheila Kearns, John Dempsey, Charles Weld, John Dryfhout and Fred Weld.

Beverly Widger suggested that the Cornish Youth Group take over the Cornish Town Recreation Committee. The Moderator will so do.

Clara Weld said the Cornish Natural Resources Inventory is on sale for \$2.00.

Nominations were called for, for Buffalo Reeves: The following were nominated and so elected by vote to office: Jim and Ginny Hunt, Nancy Laro, Dr. Sam Livingston.

Ed Lawrence and Bud Fitch moved to adjourn the business part of the meeting. 8:30 p.m.

Supper was served, and ballots counted. Results were recorded, ballots wrapped and signed. Adjourned at 10:30 p.m.

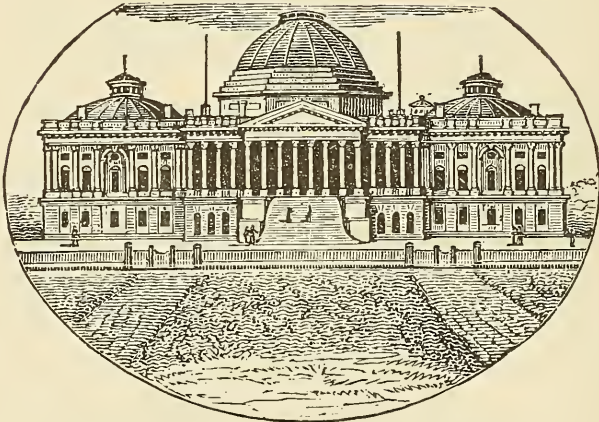

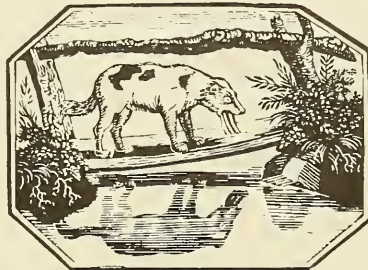

We held ten business meetings and a number of informal ones during 1976.

In the Spring we displayed a beautiful bicentennial quilt made by the Helping Services Council of Sullivan County.

In May, we opened the library on Mondays 3-8 p.m. This makes 13 hours that the library is now open a week. Thank you to all the volunteers who have helped with the Monday and Saturday hours. More volunteers are still needed.

We received more gift books this year than in the past. Thank you to all of those people. A thank you also to the people who have given the library gift subscriptions for magazines.

The town was given a Microfilm Reader by the Historical Society and the selectmen have housed it in the library for use by townspeople during library hours.

In May, Charles Bretton was appointed by the selectmen to fill in as Trustee. He has done a fine job and we have enjoyed having him to work with.

We would like to thank the Garden Club for the beautiful red, white, and blue petunias in our flower boxes. Thank you to Virginia Colby for the donation of a light for our Gratia Huggins Memorial Room.

During the month of July we loaned 2 portraits and a Hilliard rifle to Saint Gaudens Memorial for their Cornish Display.

We held an Open House on July 24 with a Food and Bake Sale on the lawn. This was to enable the townspeople to see the new renovations on the Gratia Huggins Room.

Park Grange members volunteered to paint the library trim—due to rainy weather and conflicting schedules only the front entrance was done. The job will be completed this spring.

The library has been given a Spirit Duplicator by Mr. and Mrs. Paul Moore—Lebanon—the townspeople are welcome to use it during library hours as long as they provide their own paper.

With the funds received from the Gratia Huggins estate—we have purchased a new typewriter (for staff use) and installed a telephone. We need to decrease the number of overdue and lost books from the library and we feel that a direct line to the people will help on this. The cost of replacing books has gone from \$5.00 to \$8.00 a book. Everyone in town will find it more convenient to renew their books.

The Joan Lovejoy Hier Fund was established this summer by Fritz Hier and sons in memory of Joan. This fund has been set up for books and a new set of encyclopedia has been the only purchase so far.

During the summer months a tutoring program was held at the library twice a week for six weeks with 16 children participating. This was put on by some concerned citizens and was a huge success.

FIRE DEPARTMENT REPORT

The year 1976 found the fire department responding to twenty nine calls. Nine chimney fires, two minor house fires, one motorcycle fire, one car fire, two smoke investigations, one train derailment, three electrical wires down with limbs burning, three mutual aid calls to Windsor, one mutual aid call to Meriden and two mutual aid calls to Claremont. The fire department also responded to four rescue squad calls to wash down gasoline.

A program was presented to the school children during fire prevention week.

There were fund raising projects by the fire department and the ladies auxiliary during the year. This money is used to purchase equipment for the department. Several thousand dollars worth of equipment has been purchased in this way. Through these fund raising projects we are able to do our small part in keeping our budget at a minimum.

Several department members attended a training school in Norwich this year.

The 1952 Ford truck was sold to the town of Croydon. A 1959 Mack was purchased to replace it. This has resulted in insurance rate reductions for anyone living within a three mile radius of the Parsonage road fire station.

REPORT OF DISTRICT FIRE CHIEF & TOWN FOREST FIRE WARDEN

Since its beginning in 1893, the State Forestry Department has recognized the fact that forest fire prevention and suppression is a joint state and town or city responsibility. Local authorities recommend names of persons to the State Forester, who appointed one person as town or city fire warden and several other persons as town or city deputy fire wardens to a three year term.

The local forest fire warden controls the kindling of all outside fires, when the ground is not covered with snow, by issuing a written permit for kindling a fire. Permits are only issued at such times and in such places as the fire warden deems as safe.

The State Forest Fire Service trains the local forest fire organization in modern forest fire prevention and suppression tactics. The State also provides backup personnel and equipment for suppression and prevention activities.

The combination of State and local forces has resulted in one of the smallest acreage loss due to forest fires in the United States for the past 20 years.

CORNISH POLICE DEPARTMENT REPORT FOR 1976

During 1976 the constables of the Cornish Police Department handled approximately 450 complaints:

- 45% Motor Vehicle accidents, DWI, speeding, other MV law violations
- 30% Crime—burglary, theft, prowlers, brawls, domestics, lost people
- 15% Animals—dogs, cattle, horses
- 7% Assisting—fire department, rescue squad, other police departments
- 3% Public Services—Vin verification, finger printing

During 1976 there were approximately 25 motor vehicle arreests (summons) and 4 criminal arrests, 3 on drugs, 1 on burglary.

There were 22 reported motor vehicle accidents in Cornish last year. Of the 22, one was a fatal, ten involved personal injury, with the remaining 11 involving property damage only. The state law requires that any accident involving more than \$300 total property damage or any personal injury be reported to Concord within 5 days. Police should be called to the scene of any of these accidents before any vehicles are removed.

During the past year the following new equipment has been purchased by the Police Department: two 9mm pistols, two handcuffs, 1 scanner (for cross channel communications), two portable radios, and two accident investigation kits.

A new system of record keeping has been established. A complaint service report will be made out for every complaint received by the Department. A new dispatch system will also go into effect this year. Anyone wanting police in Cornish should call the one dispatch number which will be answered by the dispatcher at the Claremont Police Station. The dispatcher will take the necessary information and will dispatch local or state police as the situation requires. The dispatcher will also keep track of the constables' time and mileage for each complaint. These new changes will provide for exact account of all police work done in the town and will also provide exact crime statistics for next year.

The area of police services is an increasingly complex one which requires that all police officers be properly trained and equipped. It is our opinion that the standards and training of the present constable system is grossly inadequate and that eventually the mistakes made by untrained and un-equipped constables of our present system will cost the town far more than providing good equipment and training. To ensure good protection and the security of the lives and homes in Cornish the Town must provide for the proper training and equipping of their local constables.

CORNISH PLANNING BOARD

The Cornish Planning Board has had a quiet year. There were three major subdivisions granted. Seven minor subdivisions and nine annexations were also granted.

James Linke resigned and was replaced by Donald LeClair. During 1976 the Planning Board held many meetings to consider changes to the Zoning Ordinance in order to make it more workable and to better meet the expressed desires of Cornish residents to members of the Board and the Selectmen.

On December 9, 1976 and on January 17, 1977 the Planning Board held well attended public hearings on the proposed amendments to the Zoning Ordinance and received comments from the citizens on these proposed

amendments. As the result of these hearings the Board has finalized the proposed amendments for Town Meeting.

One of the purposes of the Zoning Ordinance was not to allow too many buildings too close together in areas where sewage disposal might be a problem. On studying the Residential District areas the Planning Board believes a one-acre lot size is too small and therefore is recommending a change to two acres.

Many people in the community have contacted the members of the Planning Board and Selectmen about the lack of available smaller lots as the Village and Residential Districts are small in area and not much land in these areas is available for new construction. The Planning Board explored various ways to meet this problem, including amending the zoning map and by creating new areas for Residential Districts. This has met with much opposition. Therefore, another approach is recommended to solve the need for additional smaller lots. This is to allow in Rural Residential and Conservation Districts zones some two-acre lots providing they meet certain standards so as to assure that these smaller lots will not be grouped too closely together, that health regulations for sewage will be met, that they will be for single family homes, and that they will have access to public roads.

The Planning Board believes that some non-residential development located throughout the Town is desirable as it will broaden the tax base and in some instances assure the retention in good condition of many of the larger, older homes in the community which are no longer economically feasible as single family dwellings. In permitting such expansion of uses adequate safeguards should be added to the Zoning Ordinance and incorporated into site plan review regulations to assure that such extended non-residential use will not substantially affect the character of the community and the neighborhood in which the use may be located. Therefore, a series of changes to the Zoning Ordinance is proposed as one amendment. This amendment provides for certain non-residential, non-industrial uses such as for office and neighborhood stores be allowed as special exceptions, and as a safeguard, the standards and conditions for granting a special exception by the Board of Adjustment be revised. In addition, the Planning Board strongly recommends that the Town authorizes the Planning Board to review non-residential site plans for proposed new non-residential uses to further help assure they will not be detrimental to the nearby homes.

REPORT OF THE BOARD OF ADJUSTMENT

During the last year, the Zoning Board of Adjustment heard eight cases. Four cases involved requests for special exceptions to build a single family dwelling in the Conservation Zone. Of these, three were granted and one denied.

The Board granted a variance to the Cornish Fair Association to build a Show Cattle Shed closer to the road than normally permitted by the building regulations. Another variance was granted concerning lots in a subdivision. A variance was needed because the lots were located in two zones.

A request for a variance to allow the expansion of a retail food business was denied but further legal action has clouded the issue and it is now in the hands of the Selectmen. The Board also denied a request for a variance to allow a restaurant in a Rural Residential Zone.

This year, for the first time, the Zoning Board of Adjustment has alternate members in addition to the five regular members. This allows the Board to more effectively serve in cases where a member is unable to be in attendance or is unable to hear a case because of a conflict.

ANNUAL REPORT OF ACTIVITIES: CORNISH CONSERVATION COMMISSION

During the past year, the Cornish Conservation Commission has worked on a number of projects. As usual, we selected two students to attend the annual conservation education camp held at Bear Brook State Park and sponsored by the Society for the Protection of New Hampshire Forests. The tuition for these students is generously provided each year by the Fair Association. In addition, we also sponsored, along with the Fair Association, the attendance of the school principal, Mr. Poor, to the four-day teacher's conservation education camp. His response upon returning was so enthusiastic that we now hope to send more teachers in the future. This year also saw the completion of improvements on the swimming pond near Cornish Flat, a project we and other organizations have worked on for a number of years. During the summer of 1975, under our sponsorship and the sponsorship of the Mass. Audubon Society, a graduate student from the University of Massachusetts completed a resource inventory of Cornish for the Commission. This report has now been condensed and is available for a small fee during town meeting, during the Cornish Fair, or from any member of the Commission. At the Commission's Fair exhibit this year we

presented a series of color slides which accompanied this report and which describe Cornish's natural and scenic resources. This same presentation, given by a member of the commission, is available at no cost to interested groups.

During the coming year, the Commission hopes to take an increasingly active role in conservation education, particularly at the school. The Sullivan County Soil Conservation Service is scheduled to set up a nature trail on school property, and we hope to assist the school staff in making the most effective use of this facility and in other conservation education activities.

3. Sent to the town officials information on 404 Dredge and Fill Law. Section 208: Nonpoint Pollution Source. The Council has been trying to keep abreast of this. It is now in the planning stage and 3 members of the Council are active on the committee.

The services of the County Engineer are invaluable to the community. It is a pleasure and honor to serve on this Council.

1976 ANNUAL REPORT
OF
THE CORNISH RESCUE SQUAD, INC.

This past year saw the Cornish Rescue Squad continuing to serve Cornish with improved emergency medical care. Since our inception we have strived to serve our neighbors with quick, efficient emergency medical care.

With your help we have been able to increase our ability to meet most any emergency medical situation. Your response to our Capital Fund Drive has so far raised \$4,405.00 toward our equipment treasury. With this money we have been able to buy a light-duty rescue vehicle and many life-saving tools and supplies. This equipment has heretofore been available to Cornish residents on an "on call" basis only, and then only after long and possibly fatal delays. The Squad also had other fund-raising projects during the year which helped greatly.

In addition to helping with our fund-raising projects, all our members have sought to maintain and improve their skill level in emergency medical care. Most members completed a 20-hour E.M.T.A. refresher course required by the state every two years. Some members took a 12-hour Defensive Driving Course offered by the New Hampshire Department of Transportation. Four members became Advanced First Aid and Emergency Care Instructors, certified by the American Red Cross. We also had four members become C.P.R. instructors, certified by the New Hampshire Heart Association. One member has qualified and is now a registered E.M.T.A. instructor. The Squad has also participated in an emergency disaster drill at the Lebanon Airport and a local disaster drill co-sponsored by the Vermont E.M.S. and the Cornish Rescue Squad. Also, regular monthly training drills held by the Squad have insured that all our members maintain adequate knowledge and skill to assist you in any emergency.

Early in the year we held a meeting with local selectmen, police, and fire departments to explain and coordinate our function. As a result of this meeting, we have been asked by, and are now serving, Plainfield-Meriden with much the same service we now offer Cornish. The Squad has also been called to assist Claremont Fire Department and by Windsor Fire Department for stand-by ambulance coverage.

With the support you have given us in the past, and with the interest we hope you will continue to give in the future, the Cornish Rescue Squad will continue to offer the best in improved Emergency Medical Care.

WINDSOR REGIONAL VISITING NURSE ASSOCIATION

The Windsor Regional Visiting Nurse Association provides nursing services ranging from pediatric referrals to conventional nursing care to home bound and chronically ill residents of Windsor, West Windsor and Cornish. All visits are made under the direction of physicians affiliated with area hospitals.

The importance of this service is evidenced by the fact that the number of patient visits to residents of Cornish has tripled during the past 3 years. The total number of visits made during 1976 was 3507. Approximately 8% of these calls were made to Cornish residents. Because of this dramatic increase in case load we are asking the participating towns to increase their allocation proportionate to their use of our services. In addition, effective January 1, we have raised the fee per visit from \$3 to \$4.50.

The staff consists of one RN, one LPN, and one Nurses Aide, all working to provide adequate weekday coverage from 9 a.m. to 5 p.m. to patients in the three participating towns. As of January, 1977, a second RN was hired to assist in handling the increased case load.

The office of the Visiting Nurse is located at Mt. Ascutney Hospital and Health Center and can be reached by calling 674-6711.

REPORT OF BICENTENNIAL COMMISSION



Cornish celebrated the American Revolution Bicentennial in three ways: Heritage, Festival and Horizons, during 1975 and 1976. Thanks to a good group, the committee got things planned early, and our Selectmen were presented, Memorial Day of 1975, with Cornish's Bicentennial Flag and Certificate of Recognition from Congressman Cleveland.

Under *Heritage* Cornish Town History Volumes I and II were reprinted into one volume, and will be available from now on through the Cornish Historical Society for \$30.00.

The original papers of General Jonathan Chase were painstakingly transcribed and printed copies will be distributed to all the libraries in the area and can be purchased by interested persons.

Also, after many, many hours put in by a couple of volunteers, the town vault was cleaned out and organized, and volunteers are in the process of indexing all of the Vital Records—from the beginning of Cornish as a town, to the present.

Under *Festival* the Bicentennial Commission started off with a public Turkey Supper, hoping other organizations would follow suit, to help earn monies to be used in our celebration. Cornish Grange members pitched in to assist in cleaning the Mustering and Trinity Church grounds, repairing the cemetery fence and quite a bit of it has been painted. This needs to be finished. Cornish Grange also had a Bicentennial Supper and several special programs.

Park Grange held three Bicentennial programs, exhibited the County "Helping Hand Quilt", made and put up the Bulletin Board outside Powers Country Store, and started the job of painting the trim on the George Stowell Free Library.

Cornish School helped by putting on a skit Town Meeting Day—of the earliest Town Meetings. All town officers were dressed in 1700 costumes and we wish to thank them for these extra efforts. Cornish School also had all graduates and many 7th graders dressed accordingly at graduation in

June of 1976, which was held outdoors at the St. Gaudens National Museum.

The trustees of St. Gaudens held two special exhibits—one during July, 1976 covering the First 100 Years of Cornish 1763-1863; and during August an exhibit of The Cornish Colony. At the grand opening of these exhibits the ladies of the Bicentennial Commission served beautiful, dainty refreshments.

At Cornish Fair the themes were "Cornish Heritage" and "Spirit of '76". The Bicentennial Commission had a booth both years, and sold town histories, our special notepaper, and this past year the Cornish medals also. All of these are still available, and may be obtained at the Town Clerk's office, or through the Cornish Historical Society.

Special costumes were worn on Old Home Day, both years; the Community Chorus with Arthur Quimby directing, sang; and our committee had a table from which we sold the histories, etc.

Under *Horizons* we had five large "Welcome to Cornish" signs made and put up, and are proud of these. Because of our heritage, we now have a Micro-film Reader which was presented to the Selectmen by the Bicentennial Commission, and is kept in Cornish Library for public use. All old records have been microfilmed, and may be viewed in this Reader.

The treasurer's report below is of December 31, 1976; the Jonathan Chase project was not quite completed at that time, so report shows state grant money designated for this project. Also there is an outstanding bill at V. H. Blackington for Cornish medals.

REPORT OF THE COMMITTEE FOR THE PRESERVATION OF THE MEETING HOUSE AT CORNISH FLAT

At Town Meeting last year, a warrant article was passed that authorized the Selectmen to negotiate with the United Church of Cornish for the possible acquisition, by the town, of the Baptist Church in Cornish Flat. The building is to be restored and maintained as an historic site. Committees were appointed by the United Church of Cornish and the Selectmen to work out the details of the transfer. Final legal papers were signed early in 1977.

During the summer of 1976, when it appeared that the transfer would be carried out, the Selectmen authorized an interested group of citizens to raise funds to be used for the restoration of the building. An auction was held in October which resulted in a profit of about \$2,900. Individual donations to date bring the total raised to \$3,500. Tentative approval has been granted, by the State, for matching funds which will then result in a total of \$7,000 available for the Meeting House.

A group of Trustees is being named by the Selectmen. The Trustees will help co-ordinate the operations of the building and will be completely responsible to the Selectmen. All financial affairs will also be under the direction of the Selectmen.

SCHOOL WARRANT

Cornish School District

State of New Hampshire

To the inhabitants of the School District in the Town of Cornish qualified to vote in District affairs:

You are hereby notified to meet at the Town Hall, in said District, on the 5th day of March, 1977, at 10:00 a.m. to act upon the articles set forth in this Warrant.

Articles 1 and 2 of the Warrant will be acted upon at 10:00 a.m. and voting will be by official ballot and checklist, and the polls will remain open for this purpose from 10:00 a.m. until 7:00 p.m., at which time polls will close.

At 1:00 p.m., Articles 3 through 9 will be acted upon.

Article 1: To choose a Moderator, Clerk, Treasurer, and Auditors for the ensuing year, and one member of the School Board for three years.

Article 2: To see what action the School District will take in authorizing the use of absentee ballots at the annual School District Meetings pursuant to the provisions of RSA 60:31, et seq.

Article 3: To see if the School District wishes to exclude from its Social Security plan services performed by election officials or election workers for each calendar quarter in which the remuneration paid for such services is less than \$50.00.

Article 4: To hear the reports of Agents, Auditors, Committees or Officers chosen, and to pass any vote relating thereto.

Article 5: To see what sum of money the District will raise and appropriate for the support of schools, for the salaries of District officials and agents, and for the payment of statutory obligations of the District and to authorize the application against said appropriation of such sums as are estimated to be received from the state equalization fund, together with other income, the School Board to certify to the Selectmen the balance between the estimated revenue and the appropriation, which balance is to be raised by taxes by the Town.

Article 6: To see if the District will authorize the School Board to make application for and to receive, in the name of the District, such advances, grants-in-aid or other funds for educational purposes as may now or hereafter be forthcoming from the United States Government and/or state agencies, and to expend the same for such projects as it may designate.

Article 7: To see if the District will authorize the School Board to appropriate receipts from federal lunch reimbursements, tuition, gifts and any other receipts from miscellaneous sources in addition to the original appropriation for 1977/78 for the lunch program, general expenses, equipment and improvements. And to expend the same for such projects as it may designate.

Article 8: To choose Agents and Committees in relation to any subject embraced in this Warrant.

Article 9: To transact any other business that may legally come before this meeting.

PRINCIPAL'S REPORT

To The Members of the Cornish School District:

In response to an enrollment drop of about eighty (80) pupils over the past several years, the full time teaching staff this year dropped from ten to nine. Six of these nine are teachers returning from last year's teaching staff. No changes were made in other staff positions. I find this decline in turnover encouraging.

Academicall, our program has been strengthened in several areas:

1. ESEA Title I money has provided an additional teacher and an aide to work with youngsters (alone and in small groups) with low test scores in the areas of reading and math.
2. ESEA Title IV money has provided library materials and staff training in the area of Environmental Studies. We hope a second year of these funds will help develop outdoor nature study areas around the school as well as provide special reading materials for many youngsters.
3. We have departmentalized in grades 7 & 8 this year, with a made the Honor Roll at the Annex and at Stevens. At that point, we had ninety-one youngsters enrolled in those two schools from Cornish.

This year witnesses the inauguration of the School Advisory Panel, a group of interested citizens meeting monthly (weather permitting), to discuss and review activities and programs at the school. The Panel has considered Board Policy, Interscholastic Sports, and Discipline. Future topics will include Drug Education, School Budget, Improvements to the School Grounds, and Physical Education.

We would like to express our thanks to all the organizations and individuals who have helped maintain and improve the quality of life and education in the school since my last report. Notable projects include the following: reconstruction of the ball field; painting the bathrooms; volunteer tutoring (summer and school year); installation of a sound system for the cafeteria, halls and out-of-doors; the Fire Prevention Program; the start of the Cornish Honor Society; and the several Cultural Arts Programs throughout the year.

Report of the Assistant Superintendent

Faculty

Our school has five teachers new to the district; changes brought about by resignations, leaves of absence, and one addition to the instructional program.

Karen Rielly, of Etna, N.H. replaced Linda Bradley and she is teaching a combination 5/6th grade. A 1973 graduate of the University of Vermont with a Bachelor of Arts Degree, Miss Rielly trained under the Upper Valley Teachers Training Program. Her practice teaching was done in the elementary schools of Hanover, N.H. and Norwich, Vt.

Marilyn Wood of Hanover, N.H. replaced Livia Alexion who was granted a one year leave of absence to pursue graduate studies. Miss Wood was awarded a Bachelor of Arts Degree from Ft. Lewis College, Colorado. She too, obtained her teaching credentials through the Upper Valley Teachers Training Program. Her intern work was completed at the Ray School in Hanover, N.H.

Donald Hart of Springfield, Vt. replaced Paul Nevin who resigned to accept a position in Mt. Holly, Vt. From 1974 to 1976, Mr. Hart taught in the elementary schools of Charleston, S.C. His Bachelor of Science Degree was earned at Bridgewater State College.

Shirley Haubrich of Claremont, N.H. replaced Beverly Widger in December, who was granted a leave of absence. Miss Haubrich is a 1975 graduate of Keene State and last year taught a 4th grade in Campton, N.H.

Beverly Morrison, a resident of Washington, N.H., joined our staff as a Title I teacher after school reopened. This position is totally funded by Federal and State Funds. Her Bachelors Degree was awarded by Nathaniel Hawthorne College in 1975.

All teachers in the Cornish School District are certified by the State of New Hampshire to teach the positions to which they are assigned.

Budget

The largest increase is reflected in the tuition account—more students at a higher fee. . . teachers and board members met frequently to work out a pay schedule with related fringe benefits that, in my judgment, is equitable to both the staff and community from the standpoint of available tax dollars to support it.

The budget was developed and recommended to the board on the premise we must, whenever possible, hold down costs while still maintaining a quality program.

Buildings and Grounds

This fall it was necessary to replace the oil tank, a major expenditure. Your Board acted with great fiscal responsibility and procured a 20,000 gallon tank; purchased and installed for \$1,595.00. This action enables an additional fuel savings also as deliveries are now made at a discounted full tanker drop.

Continued improvements are being made and planned at the school as the Board conscientiously oversees the town's major investment. Last summer most of the worn tile flooring was replaced at a cost of \$1,050.00. . . a sum of \$5,500.00 from active and supportive.

We constantly strive to expand communications. An open exchange of ideas, with respect for differences of opinion, creates a real awareness of the towns expectations for its school's educational program and related activities. Such participation enables us to continue to develop an appropriate program for Cornish students.

Staff and Curriculum

The Teacher Consultants basic function is working with teachers to upgrade instruction and also to monitor its effectiveness. This year I again quote from a portion of Mr. Rooker's recent report to me. He states in part. . . "In addition to making school a pleasurable experience for children the faculty continues to be very concerned with academic progress. They work to assist the students in achieving to the best of their ability. Academic excellence is one of the foremost goals of the school.

Continuous curriculum improvement is creating learning environments that accurately reflect the real needs of the students, the community, and parents. This curriculum work is accomplished through the cooperative efforts of teachers and administrators. Through these cooperative efforts an atmosphere conducive to real learning has developed and continues to grow and prosper."

In summary, my appreciation: to principal Daniel Poor, the teachers, and all others at the school who function well as a team and continually work to upgrade their own skills to help make each day a productive one.

To Board members, for countless hours of work, for giving unselfishly of their time, for the betterment of Cornish education.

CORNISH HONOR SOCIETY

REPORT OF CORNISH SCHOOL LUNCH

The school year of 1975-76 recorded 24,467 lunches prepared and served to students, an average of about 140 per day. This is less than recent years due to lower enrollment, but a slightly higher percentage of the student body are taking hot lunches.

The account balance at the beginning of the school year f was \$963.56. On September 1, 1975 these funds were placed in a NOW checking account, and during the school year earned \$34.05 interest. The total interest for the calendar year 1976 was \$39.68.

At the end of June, 1976 there was a small balance after bills were paid, and due to increased costs, the School Board authorized a change in lunch price from \$.40 each to \$.45 for 1976-77; still one of the lowest in the State. Extra reimbursement received in October, 1976 brought the balance for the year to \$1,573.58.

The main reason why we continue to enjoy one of the best school lunches at one of the lowest prices is that Mrs. Ackerman and Mrs. Hilliard give maximum planning, quality and service for little more than the minimum wage. Our thanks to them and others who have contributed much to serving good meals.
