To the Inhabitants of the Town of Campton in the County of Grafton in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at the Town House in said Campton on Tuesday, the Eighth day of March, next at two of the clock in the afternoon, to act upon the following subjects:

1. To choose all necessary Town Officers for the year ensuing.
2. To raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriations of the same.
3. To see how much money the Town will vote to raise and appropriate for the maintenance of its highways and bridges.
4. To see if the Town will vote to authorize the Selectmen to hire money in anticipation of taxes.
5. To see if the Town will vote to raise and appropriate the sum of \$100 for Memorial Day.
6. To see how much money the Town will vote to raise and appropriate for the White Mountain Region Association.
7. To see if the Town will vote to raise and appropriate the sum of \$125.00 for the control of White Pine Blister Rust.
8. To see if the Town will vote to raise and appropriate the sum of \$1,000.00 for the maintenance of Blair and other cemeteries in Town.
9. To see if the Town will vote to raise and appropriate the sum of \$1640.00 to reimburse the Campton Village Precinct for hydrant rental.
10. To see if the Town will vote to raise and appropriate the sum of \$750.00 for the support of the Sceva Speare Memorial Hospital. (by request)

11. To see if the Town will vote to raise and appropriate the sum of \$750.00 for the support of the Campton Volunteer Fire Department.

12. To see if the Town will vote to raise and appropriate the sum of \$300.00 for the Historical Committee

13. To see if the Town will vote to raise and appropriate the sum of \$1000.00 to be set aside towards the trade-in of the road grader.

14. To see how much money the Town will vote to raise and appropriate to help, with other Towns, in promoting "Ski 93."

15. To see if the Town will establish a Town Conservation Commission per RSA 36-A.

16. To see if the Town will vote to accept the reports of agents and officers.

17. To transact any other business that may legally come before said meeting.

REPORT OF THE FOREST FIRE WARDEN AND DISTRICT CHIEF

Most of us who live in New Hampshire and the thousands of vacationists that visit us every year love the State for the variegated woodlands that encircle our clean lakes and clothe the hills and mountains. Most of us appreciate these values, but still there were enough careless people among us to cause over 880 grass and woodland fires to start in 1965. True this was a much dryer than normal year but this should have meant the use of extra care. Fortunately the fire fighting forces have held the line against such careless acts. It is up to each one of us to be ever mindful that a spark or flame is a potential fire.

WE MUST ALL BE CAREFUL:

1. To teach our children the danger in lighting matches.
2. To never discard lighted smoking material from a car or while walking through fields or woods.
3. To safely dispose of rubbish preferably at the town dump. If you must burn rubbish or brush:
 - a. Always get permit to burn from the warden
 - b. Start your fire late in the day after 5 P. M.
 - c. If burning a field or brush have equipment and adequate help on hand. The heat from your fire creates its own draft to spread fire.

Our carelessness with fire is costing our State and Towns thousands of wasted dollars in suppression and hundreds of acres of destroyed woodlands. Yours never to enjoy.

CHAPTER 267-A (NEW)

MOTOR VEHICLE JUNK YARDS

267-A:1 Purposes. This chapter is adopted under the police power of the state to conserve and safeguard the public safety, health, morals, and welfare, and to further the economic growth and stability of the people of the state through encouragement to the development of the tourist industry within the state. A clean, wholesome, attractive environment is declared to be of importance to the health and safety of the inhabitants and the safe-guarding of their material rights against unwarrantable invasion. In addition, such an environment is considered essential to the maintenance and continued development of the tourist and recreational industry which is hereby declared to be of significant and proven importance to the economy of the state and the general welfare of its citizens. At the same time, it is recognized that the maintenance of junk yards as defined in this chapter, is a useful and necessary business and ought to be encouraged when not in conflict with the express purposes of this chapter.

267-A:2 Definitions. For the purposes of this chapter:

1. Junk yard means any place of storage or deposit, whether in connection with another business or not, where two or more unregistered, or old motor vehicles, no longer intended or in condition for legal use on the highways, are held, whether for the purpose of resale of used parts, for the purpose of reclaiming for use some or all of the materials, whether metal, glass, fabric, or otherwise, or to dispose of them, or for any other purpose. The term includes any place of storage, or deposit for any purposes, of used parts or materials from motor vehicles which, taken together, include in bulk two or more vehicles. The term includes anyone registered as a motor vehicle junk dealer under Chapter 260:53, but does not include an establishment operated by a firm or individual registered under Chapter 260:46 as a new or used motor vehicle dealer.

II. "Legislative body" means the mayor and board of aldermen or the council of a city, the selectmen of a town, or the commissioners of a village district.

III. "Motor vehicle" means any self-propelled vehicle not operated exclusively upon stationary tracks, originally intended for use on public highways.

IV. "Motor vehicle dealer"

a. "New motor vehicle dealer" means every person principally engaged in the business of buying, selling or exchanging new and secondhand motor vehicles, or tractors on commission or otherwise who maintains in operating condition, and in operation, and at which the dealer does a major portion of his business a place of business capable of housing indoors in one building in an area of 1200 square feet, five averaged-sized

automobiles, devoted to the motor vehicle, or tractor business and gives mechanical service on the same and who holds a written contract with a manufacturer giving such person selling rights for new motor vehicles, or tractors, or with a distributor of such vehicles who, as such distributor, holds a manufacturer's franchise or contract giving selling rights on new motor vehicles, or tractors.

b. "Used motor vehicle dealer" means every person or firm principally engaged in the business of buying, selling and exchanging secondhand motor vehicles or tractors, who maintains in operating condition and in operation and at which the dealer does the major portion of his business a place of business capable of housing indoors in one building, in an area of at least 1200 square feet, five averaged-sized motor vehicles devoted to the used motor vehicles, or tractor business, and gives mechanical service on the same and at which the repair of used motor vehicles, or tractors is subordinate or incidental to the business of buying, selling and exchanging the same.

c. "Junk motor vehicle dealer" means any person or firm who has an established place of business at which he is engaged in the business of buying secondhand motor vehicles for the purpose of taking the same apart, or buying, and selling parts of secondhand motor vehicles, or tires, for the assembling secondhand motor vehicle parts.

267-A:3 Requirement for operation or maintenance. A person shall not operate, establish, or maintain a junk yard until he (1) has obtained a license to operate a junk yard business and (2) has obtained a certificate of approval for the location of the junk yard.

267-A:4 Application for License and Certificate of Approval. Application for the license and the certificate of approved location shall be made in writing to the legislative body of the municipality where it is proposed to locate the junk yard. In municipalities having a zoning ordinance and a zoning board of adjustment, the application must be accompanied by a certificate from the board of adjustment that the proposed location is not within an established district restricted against such uses or otherwise contrary to the prohibitions of the zoning ordinance. The application must contain a description of the land to be included within the junk yard, by reference to so-called permanent boundary markers.

267-A:5 Time of Hearing. A hearing on the application shall be held within the municipality not less than two nor more than four weeks from the date of the receipt of the application by the legislative body. Notice of the hearing shall be given to the applicant by mail, postage prepaid, to the address given in the application and the notice shall be published once in a newspaper having a circulation within the municipality, which publication shall be not less than seven days before the date of the hearing.

267-A:6 License Requirements. At the time and place set for hearing, the legislative body shall hear the applicant and all other persons wishing to be heard on the application for a license to operate, establish, or maintain the junk yard. In passing upon the application, it shall take into account the suitability of the applicant with reference to his ability to comply with the fencing requirements or other reasonable regulations concerning the proposed junk yard, to any record of convictions for any type of larceny or receiving of stolen goods, and to any other matter within the purposes of this chapter.

267-A:7 Location Requirements. At the time and place set for hearing, the legislative body shall hear the applicant and all other persons wishing to be heard on the application for certificate of approval for the location of the junk yard. In passing upon the application, after proof of legal ownership or right to the use of the property by the applicant for the license period, it shall take into account the nature and development of surrounding property, such as the proximity of churches, schools, hospitals, public buildings or other places of public gathering; and whether or not the use of the proposed location can be reasonably prevented from affecting the public health, safety, or morals by reason of offensive or unhealthy odors or smoke, or of other causes. In no case may a license be granted for a new junk yard located less than 660 feet from the right of way lines of Class I, Class II and Class III highways or located less than 300 feet from the right of way lines of Class IV, Class V and Class VI highways.

267-A:8 Aesthetic Considerations. At the hearing regarding location of the junk yard, the legislative body may also take into account the clean, wholesome, and attractive environment which has been declared to be of vital importance to the continued stability and development of the tourist and recreational industry of the state and the general welfare of its citizens by considering whether or not the use of the proposed location can be reasonably prevented from having an unfavorable effect thereon. In this connection the legislative body may consider collectively the type of road servicing the junk yard or from which the junk yard may be seen, the natural or artificial barriers protecting the junk yard from view, the proximity of the proposed junk yard to established tourist and recreational areas or main access routes thereto, as well as the reasonable availability of other suitable sites for the junk yard.

267-A:9 Grant or Denial of Application; Appeal. After the hearing the legislative body shall, within two weeks, make a finding as to whether or not the application should be granted, giving notice of their finding to the applicant by mail, postage prepaid, to the address given on the application. If approved, the license, including the certificate of approved location, shall be forthwith issued to remain in effect until the fol-

lowing April 1. Approval is personal to the applicant and is not assignable. Licenses shall be renewed thereafter upon payment of the annual license fee without a hearing, if all provisions of this chapter are complied with during the license period, if the junk yard does not become a public nuisance under the common law, and if the applicant is not convicted of any type of larceny or of receiving stolen goods. A writ of certiorari lies from the denial of the application to the superior court of the county in which the proposed location is situated.

267-A:10 License Fees. The annual license fee is twenty-five dollars to be paid at the time the application is made and annually thereafter in the event of renewal. If the application is not granted, the fee shall be returned to the applicant.

267-A:11 Fencing. Before use, a new junk yard shall be completely surrounded with a solidly constructed fence at least six feet in height which substantially screens the area and with a suitable gate which shall be closed and locked except during the working hours of the junk yard or when the applicant or his agent is within. All motor vehicles and parts stored or deposited by the applicant shall be kept within the enclosure of the junk yard except as removal is necessary for its transportation in the reasonable course of the business. All wrecking or other work on such motor vehicles and parts and all burning of vehicles shall be accomplished within the enclosure.

Where the topography, natural growth of timber, a natural barrier, or other considerations accomplish the purposes of this chapter in whole or in part, the fencing requirements hereunder may be reduced by the legislative body, upon granting the license. Any citizen of the municipality may apply for writ of certiorari to the superior court for the county in which the new junk yard is located to review the action of the legislative body.

267-A:12 Effect of Local Ordinances. This chapter is not in derogation of zoning ordinances or ordinances for the control of junk yards now or hereafter established within the proper exercise of the police power granted to municipalities, but rather is in aid thereof. Specific local ordinances shall control when in conflict with this chapter.

267-A:13 Established Junk Yards. For the purposes of this chapter the location of junk yards already established are considered approved by the legislative body of the municipality where located and the owner of the yard considered suitable for the issuance of a license. Within sixty days from the passage of this chapter, however, the owner shall furnish the legislative body the information as to location which is required in an application, together with the license fee, and the legislative body shall issue him a license valid until April 1, 1966, at which time the owner may apply for a renewal. The

owner shall comply with all other provisions of this chapter including the fencing requirements set forth in section 267-A:11 of this chapter.

267-A:14 Motor Vehicle Dealers. Both new and used car dealers are hereby required to remove from their premises registered with the director of motor vehicles as their principal place of business any motor vehicle which is of the type referred to in paragraph I of this chapter under the definition of junk yard within at least 160 days from the date of its original entrance thereon. Any other location within the same community used by such dealer shall be subject to the terms of this chapter if in its operation it falls within the confines of the definition of the term motor vehicle junk yard as defined in this chapter. The director of motor vehicles shall issue plates designating whether a dealer is a new, used or junk motor vehicle dealer. Definitions in chapter 259 are hereby amended to conform to definitions in this chapter.

267-A:15 Penalty. After ninety days from the passage of this chapter, a maximum fine of ten dollars shall be imposed upon a person for each twenty-four hours or fraction thereof in which he is in violation of this chapter.

267-A:16 Injunction. In addition to the penalty in section 267-A:14 of this chapter, the legislative body may obtain a mandatory injunction to end the violation. If the legislative body does not obtain such an injunction the attorney general may obtain an injunction in the name of the state.

372:2 Effective Date. This act takes effect upon its passage.

COMPLETE INFORMATION ON ARTICLE 15

RSA 36-A

36-A:1 Method of Adoption. Any city by vote of its city council, and any town at any duly warned meeting, may adopt the provisions of this chapter.

36-A:2 Conservation Commission. A city or town which accepts the provisions of this chapter may establish a conservation commission, hereinafter called the commission, for the promotion and development of the natural resources and for the protection of watershed resources of said city or town. Such commission shall conduct researches into its local land areas and shall seek to coordinate the activities of unofficial bodies organized for similar purposes, and may advertise, prepare, print and distribute books, maps, charts, plans and pamphlets which in its judgment it deems necessary for its work. It shall keep an index of all open areas within the city or town, as the case may be, with the plan of obtaining information pertinent to proper utilization of such open areas, including lands owned by the state or lands owned by a town or city. It shall keep an index of all open marshlands, swamps and all other wet lands in a like manner, and may recommend to the city council or selectmen or to the department of resources and economic development a program for the better promotion, development or utilization of all such areas. It shall keep accurate records of its meetings and actions and shall file an annual town or municipal report. The commission may appoint such clerks and other employees as it may from time to time require.

36-A:3 Composition of Commission. The commission shall consist of not less than three nor more than seven members. In cities the members shall be appointed by the mayor, subject to the provision of the city charter, and in towns they shall be appointed by the selectmen. When a commission is first established, terms of the members shall be for one, two or three years, and so arranged that the terms of approximately one-third of the members will expire each year, and their successors shall be appointed for terms of three years each. Any member of a commission so appointed may, after a public hearing, if requested, be removed for cause by the appointing authority. A vacancy occurring otherwise than by expiration of a term shall be filled for the unexpired term in the same manner as any original appointment.

36-A:4 Powers. Said commission may receive gifts of money and property, both real and personal, in the name of the city or town, subject to the approval of the city council in a city or the selectmen in a town, such gifts to be managed and controlled by the commission for the purposes of this section. Said commission may acquire by gift, purchase, grant, bequest, devise, lease or otherwise the fee in such land or water rights, or any lesser interest, development right, easement, covenant, or other contractual right including conveyances with conditions, limitations or reversions, as may be necessary to acquire, maintain, improve, protect, limit the future use of or otherwise conserve and properly utilize open spaces and other land and water areas within their city or town, and shall manage and control the same, but the city or town shall not have the right to condemn property for these purposes.

36-A:5 Appropriations Authorized. For the purpose of establishing and maintaining a conservation commission to promote the development and better utilization of our natural resources, as authorized by Section 2, a town or city may appropriate moneys as is deemed necessary. The whole or any part of money so appropriated in any year may be placed in a conservation fund and allowed to accumulate from year to year. Money may be expended from said fund for the purposes of this chapter.

36-A:6 Commissioner of Resources and Economic Development. The commissioner of the department of resources and economic development may establish a program to assist, at their request, the cities and towns which have adopted the provisions of this chapter, in acquiring land and in planning of use and structures as described in Section 2.

168:2 Takes Effect. This act shall take effect sixty days after its passage.

1. To choose a Moderator for the coming year.
2. To choose a clerk for the ensuing year.
3. To choose a Member of the School Board for the ensuing three years.
4. To choose a Treasurer for the ensuing year.
5. To determine and appoint the salaries of the School Board and Truant Officer, and fix the compensation of any other officers or agent of the district.
6. To hear the reports of Agents, Auditors, Committees, or Officers chosen, and pass any vote relating thereto.
7. To choose Agents, Auditors and Committees in relation to any subject embraced in this warrant.
8. To see what sum of money the district will raise and appropriate for the support of schools, for the salaries of school district officials and agents, and for the payment of statutory obligations of the district, and to authorize the application against said appropriation of such sums as are estimated to be received from the state foundation aid fund together with other income; the school board to certify to the selectmen the balance between the estimated revenue and the appropriation, which balance is to be raised by taxes by the town.
9. To see if the District will vote to authorize the School Board to make application for and to accept on behalf of the District, any or all grants or offers for educational purposes which may now or hereafter be

forthcoming from the State of New Hampshire and/or the United States.

10. To see if the District will authorize the School Board to negotiate tuition contracts with other districts for the education of pupils grades 9-12.

11. To see if the District will vote to authorize the School Board to give a quitclaim deed to Hazel B. Hartleb of Bath, Maine, of any interests it might have in the property conveyed by Clara J. Pulsifer to Hazel B. Hartleb and Casper F. Hartleb, as joint tenants, by a deed dated November 7, 1942 and recorded in Grafton County Registry of Deeds in Book 713, Page 293, for the purpose of perfecting the title of Hazel B. Hartleb.

12. To see if the District will vote to establish a contingency fund to meet the cost of unanticipated expenses that may arise during the year in a sum not exceeding \$500 in the budget within the provision of RSA 198:4-6.

13. To see if the district will raise and appropriate a sum not to exceed \$350.00 to buy audio-visual equipment for the school.

14. To transact any other business that may legally come before this meeting.

REPORT OF THE SCHOOL NURSE

January 1, 1965 to January 1, 1966

The School Nurse made thirty-five visits to the school and fourteen home visits. During her school visits, children were inspected, conferences held with Principal and teachers, First Aid treatment and advice given when necessary, supplies checked and replenished.

Hearing tests were made on each pupil, also vision screening. Notices were sent home on all who did not pass the test. Inspections were made of skin, hair, and scalp. Each pupil was weighed and measured.

The school nurse assisted parents for Sight Conservation, Orthopedic Clinics and Mental Hygiene Clinics. Conferences were held with the State Nurse, State Welfare Case Workers and Guidance Clinics.

Health records were kept on every child, sick children were taken home when necessary and notice sent on all T. B. Chest Clinics.

Pre-School Registration was held May 25th, the nurse attended a workshop on Speech and Hearing in Keene on May 7th, the School Nurses' Meeting in Concord on March 31st and School Nurses' Section of the State Teachers Convention in Concord in October.

REPORT OF SUPERINTENDENT OF SCHOOLS

Hereby submitted is my annual report as your Superintendent of Schools.

The school year began with only one staff change in your school. Mr. Tkach, who had been employed to finish the year, resigned to accept the position as Principal in Thornton. This vacancy was filled by Mr. Wesley Lavin who graduated from Plymouth State College in June. Because of the draft, he will not be available for another year and a replacement is needed. With Mrs. Avery reaching compulsory retirement age, I expect two vacancies to be filled beginning next September. There are already several desirable applicants for these positions and with the time at our disposal, I am sure we can find some very acceptable replacements. Mrs. Avery, after her many long years of faithful service, will be missed by many and I am sure you join with me in wishing her a good retirement.

Slowly but surely I think we are making changes in curriculum, textbook revisions, and the use of audio-visual equipment that makes it possible for better teaching and provides boys and girls with better learning experiences. You will find an article within the school district warrant for an amount of money to be used for the purchase of some of the equipment I have mentioned. I think it is safe to say that these materials are needed and would be used to improve the quality of instruction. However, with the increase in the budget, opinion was that the decision should be left to the voters. Plans for next year include continuation of the phonics program and the adoption of new science and language arts books in the middle grades. We already have these two series in the 7th and 8th grades similar to the ones being used in Plymouth Junior High School. I think our testing programs are adequate at the present. Some time in the near future, I would like to see aptitude tests and personality inventories given in the 7th and 8th grades which would be part of the guidance program.

I am sorry that Campton was one of the few school districts in the state for which there are no funds under Title I of the Elementary and Secondary Act of 1965 Public Law 89-10. I am reasonably sure that there are a number of youngsters in the district that would qualify us under the regulations. The figures are based on the 1960 census and in some cases, the answers given to the census taker might not necessarily agree with the facts. However, we will still be able to take advantage of the Title II part of the program for library books and N. D. E. A. Title III.

It is not definite at this writing whether or not the cooperative school will have been voted upon by the time regular school district meetings are held. If the voting meetings have taken place, and your town has accepted the provisions of the Articles of Agreement, I think you have made a wise decision. If the vote has not been taken, or your district has voted against it, I would hope you will take another long hard look before it is too late. It has been brought up at most of the hearings, the 7th and 8th grade students, where an accredited Junior High School program is not available, are the ones who need a comprehensive program most. The broadened curriculum offering that ought to be available for these young people cannot possibly be met financially in small districts. As far as the students in grades 9-12 are concerned, a broader curriculum offering and more students will make keener competition and produce better trained young people to go on to college or to enter the work forces. A new and larger centralized school will provide many of the answers to better education for all. After wrestling with this problem for a number of years, I am convinced as I think most members of the Planning Board are, that the solution your committee has approved is the best and most economical for everyone at the present time.

I appreciate very much the continued cooperation between the school district and the school. There is no question that better education results when a harmonious relationship is established.

EXPLANATION OF SUPERINTENDENT'S SALARY

Section 5, Chapter 243, Laws of 1953, of the State of New Hampshire, requires that the school district annual reports show the total amount paid to the superintendent of schools as per the following quotation: "Reports. Each superintendent of a supervisory union shall annually prepare a report showing the total salary paid to the superintendent, which report shall show in detail the amount derived from the per capita tax and the amount paid directly by each school district in the union."

One-half of the supervisory union expenses is prorated among the several school districts of the union on the basis of adjusted valuation. One-half is prorated on the basis of average daily membership in the school for the previous school year ending June 30th. The Superintendent of Supervisory Union No. 48 during 1964-65 received a salary of \$10,050.00 which was made up as follows: \$4750.00 paid from the per capita tax and \$5300.00 prorated among the several school districts. Allowances of \$1100.00 for travel within the union was also prorated as stated above. The several school districts numbered five in 1964-65. The School District of Warren became a part of Supervisory Union No. 48 as of July 1, 1965.

The table shows the portion of salary and travel charged to each school district.
