Warrant for Town Meeting

To the inhabitants of the Town of Fremont in the County of Rockingham in said

State, qualified to vote in Town Affairs:

You are hereby notified to meet at the Fremont Town Hall in said Fremont on Tuesday the Eleventh day of March next at ten of the Clock in the forenoon to act upon the following subjects:

1. To choose all necessary Town Officers for the ensuing year.

2. To see if the Town will vote to raise and appropriate the sum of \$112,700.00 as its proportional share of the estimated cost of reconstructing Bridge No. 096/095 on the Sandown Road, so called, a Class V Highway, under and in compliance with the provisions of the Municipal Finance Act (RSA Chapter 33 and any amendments thereto), and any other enabling authority; and to authorize the Selectmen to issue and sell such Bonds or Notes and determine the rate of interest to be paid thereon as may be necessary to effect the financing of said sum and the issuance, negotiation, sale and delivery of such Bonds or Notes as shall be in the best interests of the Town; and authorize the Selectmen to apply for an receive Town Bridge Aid, so-called, from the State of New Hampshire, Department of Public Works and Highways, all pursuant to the terms and provisions of RSA Chapter 242 as amended, and to apply for and to accept State and Federal Aid grants in aid on said project.

(2/3 Ballot Vote required for passage)

- 3. To see if the Town will vote to establish in accordance with the provisions of RSA 35 a Capital Reserve Fund for the reconstruction of Bridge No. 096/095 on Sandown Road and to appropriate and withdraw from the current surplus the amount of \$5,000.00 for the same.
- 4. Upon application of ten (10) legal voters: to see if the Town will vote to raise and appropriate the sum of \$350.00 for Recreational and Educational purposes for the Elderly, and to authorize the withdrawal of this amount from the Federal Revenue Sharing Funds under the provisions of the State and Local Assistance Act of 1972 and as amended in 1976.
- 5. To see if the Town will vote to appropriate and authorize the withdrawal from the Revenue Sharing Fund established under the provisions of the State and Local Assistance Act of 1972 for use as setoffs against budgeted appropriations for the following specific purpopses and in the amounts indicated herewith; and further to authorize the Selectmen to make pro rata reductions in the amounts if estimated entitlements are reduced or take any other action hereon:

6. Upon application of ten (10) and more legal voters; to see if the Town will vote to raise and appropriate the sum of \$5,500.00 for the purpose of obtaining a new soils map of the Town.

(Not recommended by Budget Committee)

7. To see if the Town will vote to raise and appropriate the sum of \$10,950.00 to cover the cost of the purchase of one (1) Police Cruiser @ \$8,000.00, the required Insurance @ \$500.00 and \$2,450.00 to cover the cost of added gasoline and repairs.

(Not recommended by Budget Committee)

- 8. To see if the Town will vote to raise and appropriate the sum of \$5,000.00 for use by the Road Agent to seal Town roads.
- 9. To see if the Town will vote to raise, appropriate and allocate the additional Highway Subsidy Funds which may become available under the provisions of RSA 241:15 as amended, for the year 1980, said funds believed to be in the amount of \$5,595.78 and to be used for the construction or reconstruction of Class IV and V Highways.
- 10. To see if the Town will vote to appropriate and withdraw from the current surplus the sum of \$7,300.00 to be used as a setoff against the payment of the Principal and Interest on the long term Fire Truck Note.
- 11. To hear the report of the Budget Committee and take such action as the Town deems necessary.
- 12. To raise such sums of money as may be necessary to defray Town charges for the ensuing year and make appropriations of the same.
- 13. To see if the Town will vote to authorize the Selectmen to request an audit by the Municipal Services Division of the Department of Revenue Administration or employ a Certified Public Accountant to examine the accounts of the Selectmen, Town Treasurer, Town Clerk, Collector of Taxes and any other Officers or Agents handling funds of the Town at the close of each fiscal year. This action to become effective on the expiration of the term of the Auditor elected at the March 11, 1980 Town Meeting thus discontinuing the Annual practice of electing and Auditor as provided in RSA41:31 and this vote shall remain in full force and effect until changed by a vote of a subsequent Town Meeting.
- 14. To see if the Town will vote to authorize the prepayment of Resident Taxes and authorize the Tax Collector to accept such prepayments in accordance with R. A 80:1-a.
- 15. To see if the Town will vote to recind the action taken at the Town Meeting of March 15, 1978 concerning Article 15 of the warrant which authorized the sale of certain Town land to Walter E. Cook.
- 16. To see if the Town will vote to accept from Stoney-Brook Development Corporation, (Richard Beck, President) The Deed to the Town of Fremont for land covering approximately 1.2 Acres located adjacent to the Leavitt Cemetery described as follows: Beginning at a point at the Northwesterly corner of the present Cemetery and at the Northeasterly corner of the lot herein conveyed, thence traveling S10° 40' 35"W along said cemetery a distance of 267.92 feet to a point; thence turning and running N 85° 32' 29"W along Lot 6-11-1-6 as shown on recorded Plan D7526, a distance of 199.37 feet to a point; thence turning and running N 9° 41' 43" E along Lot 6-11-1-7 on said plan a distance of 253.16 feet to a point; thence turning and running S 89° 30' 30" E along Lot 6-11-1-7 a distance of 205.77 feet to the point of beginning.
- 17. To see if the Town will vote to authorize the Selectmen to sell property acquired by Tax Collectors Deeds at public auction.
- 18. To see if the Town will vote to authorize the Selectmen to borrow money in anticipation of Taxes.
- 19. To see if the Town will vote to authorize the Board of Selectmen to apply for, accept and expend, without further action by the Town Meeting, money from the State,

Federal or other governmental unit or a private source which becomes available during the fiscal year in accordance with with procedures set forth in RSA 31:95-b.

20. To transact any other business that may legally come before this meeting.

NOTE: In accordance with RSA 39:2A adopted at the March Town Meeting of 1972 the first session of the Town Meeting for the Choice of Town Officers for the ensuing year will open on March 11, 1980 at 10:00 o'clock in the forenoon and will remain open until 7:00 o'clock in the evening. The second session for the consideration of the remainder of the warrant articles will be held at the Fremont Town Hall on Wednesday March 12, 1980 at at 7:00 o'clock in the evening.

- 7. To see if the Town will vote to appropriate and withdraw from the current surplus the amount of \$1,316.42, the funds realized from the sale of lumber cut from the Little League Field Town Land Area

during the year 1978. These funds to be used to grade and provide an area for laying out and providing a playing field for use by the Pony League. These funds to be used as an offset against the Recreation Budget.

8. To see if the Town will vote to raise and appropriate the sum of \$2,400.00 for the purchase of one Frink Snow Plow.

To see if the Town will vote to raise, appropriate and allocate the additional Highway Subsidy Funds which may become available under the provisions of RSA 241:15 as amended, for the year 1979, said funds believed to be in the amount of \$4,330.82 and to be used for the construction or reconstruction of Class IV and Class V highways.

11.To see if the Town will vote to raise and appropriate the sum of \$15,000.00 for the complete re-valuation of all property in the Town in accordance with the Order issued by the State Board of Taxation on April 28, 1978, in accordance with RSA 75:1 to become

effective as of April 1, 1979.

12. To see if the Town will vote to raise and appropriate the sum of \$10,000.00 to be deposited in the Class A Pumper Fire Truck Capital Reserve Fund established in 1976 and authorize the withdrawal of this sum for this purpose from the Revenue Sharing Fund established under the provisions of the State and Local Assistance Act of 1972.

13. To see if the Town will vote to transfer the balance of the principle and accrued interest to the date of withdrawal, of the Town Building Capital Reserve Fund established by Act of the Town Meeting held on March 13, 1962 to the Class A Pumper Fire Truck Capital Reserve Fund established in 1976. (2/3 Vote required for passage)

14. To see if the Town will vote to transfer the Principle and accrued interest to the date of withdrawal, of the Capital Reserve Fund for the Town Dump established by Act of the Town Meeting of March 10, 1970 to the Class A Pumper Fire Truck Capital Reserve Fund established in 1976. Further to transfer the principle and accrued interest to the date of withdrawal, of the Waste Disposal Funds deposited in the Town Dump Capital Reserve Fund voted at the Town Meetings of 1971, 1972 and 1973 to the Class A Pumper Fire Truck Capital Reserve Fund established in 1976. (2/3 Vote required for passage)

15. To see if the Town will vote to appropriate and withdraw from the current surplus the sum of \$6,500.00 to be deposited in the Class A

Pumper Fire Truck Capital Reserve Fund established in 1976.

16. To see if the Town will vote to raise and appropriate a sum not to exceed \$70,000.00 for the purchase of a Class A Pumper Fire Truck and to authorize the withdrawal from the Class A Pumper Fire Truck Capital Reserve Fund established in 1976, the principle and accrued interest to the date of withdrawal and to authorize the Selectmen to appoint a committee to negotiate the purchase of this equipment. This committee to consist of the Board of Selectmen, three Officers

of the Fremont Fire Department and three Members at Large from the Town.

17. To see if the Town will vote to raise and appropriate the sum of \$13,000.00 to cover the balance required for the purchase of the

Class A Pumper Fire Truck. (Majority Vote Required)

18. To see if the Town will vote to raise and appropriate the sum of \$13,000.00 to cover the balance required for the purchase of the Class A Pumper Fire Truck and to authorize the Selectmen to issue and sell Notes or Bonds for all or any portion of the sum appropriated in accordance with the provisions of the Municipal Budget Act. (2/3 Vote required for passage)

19. To see if the Town will vote to raise and appropriate the sum of \$761.40 to cover the cost of 1979 Dues in the Southeastern New

Hampshire Regional Planning Commission.

20. To see if the Town will vote to raise and appropriate the sum of \$150.00 to complete the Animal Shelter Facilities required by Chapter 580 enacted by the General Court in 1977.

21. To see if the Town will vote to raise and appropriate the sum of \$2,200.00 for Mosquito control by the Rockingham County Mosquito Control Project in the Town of Fremont during the year 1979.

- 22. To see if the Town will vote to accept from Paul D. and Bonnie L. Danforth the Deed to the Town of Fremont covering approximately 0.4 Acres of land located adjacent to the Fremont Village Cemetery described as follows: Beginning at a point at the Southeasterly corner of the described premises and at the Northwesterly corner of the land now or formerly of Marquis and thence running South 51° 41' West 236.3 feet to a point at the brook, thence turning and running Northwesterly along the brook to a point at the Southwesterly corner of other land of the Town of Fremont, being known as the Fremont Village Cemetery; thence turning and running North 64° 32' East along said cemetery land 228.14 feet to a point; thence turning and running South 19° 22' East 47.4 feet to the point of beginning; containing 0.4 Acres, more or less.
- 23. To see if the Town will vote to take deeded title to the paved section of a certain street named Louise Lane located in Poplin Acres Development from Charles K. and Louise M. Rowe, the present owners. The requested road to be accepted is approximately 1,300 feet in length and runs Easterly from Rowe Drive to the Ridge Road
- 24. Upon application of fifteen (15) legal voters, to see if the Town will vote to recind and cancel the vote taken at the Annual Town Meeting in March of 1943 pursuant to Article 5 of the Warrant for said meeting whereby a part of the Ridge Road, so called, was closed subject to Gates and Bars, said recission and cancellation only to extend to the portion of Ridge Road beginning at the house located on the Steele property (Lot 4-1 on Tax Map) and running to the Southerly boundary of SBS, Inc. property (Lot 4-8 on Tax Map), so that such portion of the Ridge Road shall hereafter be an open

highway. This section of road will be re-established by SBS, Inc. at their expense to the standard of the present Ridge Road to which it becomes an extension as approved by the Town Road Agent. The reconstruction of this section of road need not be completed prior to sub-division approval.

25. Upon application of ten (10) legal voters; to see if the Town will vote to change the name of Old Ridge Road to Cross Road, said

road extending between North Road and Ridge Road.

- 26. To see if the Town will vote to grant to Michael and H. Nadine Homola a right and easement to travel by foot or by vehicle from Main Street over the Town Hall property in the area of the driveway and parking lot to obtain entrance to their existing garage, subject to the right of the Town to temporarily block said easement area from time to time with motor vehicles parked there and to authorize the Selectmen to execute such a right and easement on behalf of the Town.
- 27. To see if the Town will vote to authorize the Selectmen to sell property acquired by Tax Collector's Deed at public auction.
- 28. To see if the Town will vote to authorize the Selectmen to borrow money in anticipation of Taxes.
- 29. To see if the Town will vote to authorize the Selectmen to apply for, contract for, accept and expend aid from Federal, State and County Governments, including but not limited to programs such as Manpower, CETA, etc., in such sum or sums as may become available.
- 30. To see what action the Town will take by ballot on the following question: Are you in favor of the adoption of the following changes and amendments to the existing Town Zoning Ordinance as proposed by the Fremont Planning Board.
 - 1. Article IV Section 2

Delete reference to Lakes, Ponds, Rivers and Shoreline so that the Article will read as follows with the omission of the words and phrases enclosed in brackets:

2. Article V — Section 11

Add the phrase "single or" so that the amended Section will read as follows:

"All existing structures if converted into single or multiple family dwelling units shall meet all requirements specified in the current zoning ordinances".

31.To transact any other business that may legally come before this meeting.

Selectmen's Report

The total reassessment of the town has been completed, and all property now is at 100% of fair market value.

The Assessors received quite a number of inquiries and disagreements on Valuation. All of these were answered, and where necessary, a reappraisal of the property was done. There are still many questions in property owner's minds, and we constantly hear the question: Why is my valuation higher than So and So's? Their house is the same as mine. If their house were exactly the same as yours; example, same age, condition, location, land area and type, size, etc., the two house would be very close if not the same in valuation. Please do not attempt to compare because there are differences that effect valuation on each property. If you have questions, please see the Selectmen at their regular meetings.

The Selectmen have changed their regular meeting nights to the 2nd and 4th Monday of each month, 7 to 9 p.m. Most of the towns around us meet on Monday, and this enables us to have better communication between towns.

Very soon each taxpayer will receive the first draft of the Master Plan for the town. This is a very important document that concerns the future prosperity and well-being of the town and its' inhabitants. The N.H. Supreme Court has stated that all towns shall have a Master Plan as a foundation for their zoning laws and future additions or amendments.

A sub-committee under the direction of the Planning Board, with the endorsement of the Selectmen, has been established to develop this Master Plan.

Please read the Plan very closely and respond with your comments, both favorable and unfavorable on any or all sections. It will make a difference. If you do not respond, you leave the door wide open for any special interest group in town to have the say over what you can or cannot do with your property for years to come.

Growth is inevitable. If allowed to go uncontrolled it can be disasterous for the individual property owner, expecially the young property owner who now, because of the spiraling inflation rate, finds it hard to pay oppressive taxes on their income and property. The Senior Citizens, who live on fixed incomes such as Social Security, can't keep up with food costs let alone taxes.

The faster we grow, the more services need to be provided from all departments of the town. Controlled growth under the law can be a good thing for all. It's up to you - THE VOTER.

Report of the Road Agent

This winter has been a good one as far as expenses go, which helped the winter maintenance budget. Some of this money will be used for extra summer work.

Bridges need guard-rails or rail repairs, and all bridges need cleaning and painting.

There are a number of trees on various roads that are hazardous and need to be taken down. I will not cut down any tree or trim it unless it is dead or a hazard to traffic. Different types of trees are available through the Conservation Commission if you wish to plant them, but please place them well back from the highway.

As with everything else, the cost of asphalt is going up fast because it is made with oil. If we want to preserve our roads, we have to use it. Alternates are now being developed and tested.

The deep frost this winter has been hard on roads and caused frost heaves, etc. The roads we have sealed with the Special Sealing Appropriation have stood up very well, and I recommend this program be continued.

I hope an agreement can be reached between the Town and the Riverside Drive/Tibbs Grove area residents so that these roads can be maintained and given as much consideration as all other roads in town.

I would like to thank all the people who have helped me in various ways over the past four years and hope for continued cooperation.

Report of the Fremont Fire Department

To The People of Fremont:

This is the year we of the Fremont Fire Department have long been waiting for. The new Class A Pumper is on order and it looks as though it will be delivered early this spring. This has been a long wait, as our last new fire truck was purchased in 1961.

The next thing I'd like to mention is in regards to the ever increasing use of wood for home heat. With the use of wood, we are beginning to see many problems arising, such as faulty chimneys, stoves being installed to close to combustible materials and stove pipes to close to ceilings, wallboard, studding, etc... There are several pamphlets available at the Fire Station explaining proper ways to install wood burning devices. Stop by and pick one up! Also, care must be taken when disposing of the ashes. You should always use metal container and let them cool down in it before disposing of them in a safe place such as a cleared piece of ground or in a garden.

I would like to remind you also, that a permit is required for the installation of any oil fired heating device. The Fire Department must inspect the installation of this heating device BEFORE it can be used. For

information on oil burners, please contact Captain Lloyd Metevier at 895-2942 after 6:00 P.M.

The Fire Department is still being plagued by unknown persons starting woods fires in very inaccessible areas. One must realize this greatly increases the cost of control which is directly reflected in your tax bill. We would appreciate anyone who sees a suspicious person in or near woodlands to report it to the Fire or Police Departments.

I would like to remind everyone that a permit is required for any outside burning when the ground is not covered by snow. These permits can only be issued for burning BEFORE the hour of 9:00 A.M. and AFTER 6:00 P.M.. This is a State regulation. These permits may be obtained by contacting any one of the Forest Fire Wardens listed in the front of this book.

I would like to take this opportunity to thank the members of the Fremont Firemen's Association and The Ladies Auxiliary for their hardwork and financial help.

And last but not least, I would like to thank the officers and men for the many hours they have so unselfishly given to make the Fremont Fire Department the fine organization that it is!

Report of Forest Fire Warden and State Forest Fire Service

Prevention and control of forest fires is handled through a cooperative effort between town/city fire organizations and the State Forest Fire Service.

Since 1903, when the first forest fire laws were passed by our Legislature, the State Forester has appointed someone in each municipality as a Forest Fire Warden and charged him with the responsibility of forest fire prevention and control within his town/city. This person may ask the State Forester to appoint as many Deputy Forest Fire Wardens as may be necessary to efficiently carry out his charge.

The State Forester has divided the State into ten forest fire districts with a full time District Forest Fire Chief in each district. The State organization is charged with assisting the municiple forest fire organization in any way possible.

State personnel conduct fire training schools, assist with forest fire suppression, fire cause investigation, prosecution of fire law violators and forest fire prevention programs. Forest fire suppression equipment is purchased through State bulk purchasing ability and sold to local forest fire organizations at one-half cost. Excess military property is obtained and turned over to town/city fire departments at no cost to local departments for conversion into fire suppression units. This cooperative arrangement between State and municipality has resulted in one of the best forest fire records in the United States with less than one-half acre of woodland burned in each fire reported.

Report of Fremont Conservation Commission

-1979-

The 7-member Fremont Conservation Commission experienced a year of change both in membership and in emphasis of objectives for the commission. At year's end, two new members had been appointed and one appointment remains to be filled. Increased emphasis was placed on commission review activities on dredge and fill permits and development of resource inventories.

The Annual Wildlife Tree and Shrub Program was held in March and was well received. Many orders for wildlife plantings were taken and an excellent film was shown by State Game Warden Herb Rollings.

The commission entered negotiations with the Society for the Preservation of New Hampshire Forests to acquire their 100 acre tract on Ridge Road as a town conservation area. Title work was begun and appraisals and possible transfer of ownership are schedule for 1980.

Review of dredge and fill permits resulted in the correction of one fill

violation by the developer. A request was made to the State Special Board for review by the state engineer on another fill application before permit was granted. Monitoring of development in or adjacent to wetlands will continue.

A model wetlands ordinance was studied and is being adapted for use by the town.

In a joint effort with the master plan sub-committee of the planning board, a wetlands inventory was initiated. Final mapping will be completed in early 1980. This inventory marks the first time the wetlands of Fremont have been outlined in detail.

The Big Tree Program continued with several candidate trees being measured for possible nomination. To date, no state or national championship trees have been found but there are a number of areas in town yet to check.

A large thank you from the commission members and the town is in order to Elmer A. Schramm. His many years of dedicated service as chairman and his continuing active membership is truly appreciated.

- 3. To attract industry; to set up specific areas for commercial and for non-polluting industry.
 - 4. To provide recreation areas.
 - 5. To provide medical and dental services.

Our target date for the distribution of the first draft of the Plan for comment is April 15, 1980. We sincerely request that you do take the time to read the Plan and write your comments and return the material to us for this is the only way we will be able to establish a workable plan for our town.

Memorial Day - 1979

A group of citizens interested in revitalizing Fremont's observance of Memorial Day pooled their efforts and hopefully restored a real "town day" on this national holiday. Because of the confusion that exists in the state and nation as to the actual holiday, it was decided to declare Sunday, May 27, 1979, as this town's Memorial Day - 1979.

The traditional parade of town officials, veterans, service and civic organizations led by the color bearers and band proceeded from the Pratt Memorial Park to the town hall where a flag given by Mrs. Lindsay in memorial of her husband Ralph Lindsay was dedicated. At the Fremont Fire Station a flag and plague were dedicated to the memory of former Fire Chief, Clarence Philbrick.

The ceremonies at the cemetery included a short appropriate speech by Lt. Col. Carmen D. Ragonese and an excellent rendition of the Gettysburg Address by Lisa Thomas, a sixth grader who took first place in the public speaking contest at Ellis School. The graves of the veterans of all wars in all the town cemeteries had been previously decorated with flags and geraniums.

Following the ceremonies, a cold roast beef and salad luncheon was served to over three hundred people at the Ellis School, thanks to the efforts and donations of the ladies of the town through the organizations of the Methodist Church, Fire Flames and Community Club. Assistance with preparation and slicing of the beef was generously provided by Dave Lafayette of Vining's Market. The cost of the tickets for this meal was \$2.00 and \$1.00 (under 12), purposely inexpensive so all could partake who so wished.

The Old Meeting House, complete with historical display and guides was open much of the day thanks to Sandy Thomas and his helpers.

Ruth and Jerry Candela planned and sponsored a doll carriage and bicycle parade at 1 p.m. in front of the school with excellent participation.

The Fremont Firemen and Policement teamed off and started a new tradition with a softball game in the afternoon.

Thanks to the efforts and good will of many citizens, the day was a success well worth repeating. The project was planned to be self-sufficient but non-profit. However, perhaps sparked by the donation of \$50 from the Community Club as it closed its sixty year history of community dedication and service, "non-profit" became an inaccuracy. When the committee tallied up its receipts, and paid all the bills, a balance of \$346.90 was banked at the Exeter Cooperative Bank as the non-profit, duly identified "Fremont Memorial Day Fund" with Lloyd Metevier, Patricia Johnson and Jean Ragonese as trustees.

Report of the Building Inspector

A new Code isued by the Governor's Council on Energy was put into effect in August of 1979. Basically it states that all new housing and remodeling of existing structures in excess of 50% of the assessed valuation must meet the requirements of these regulations. Budget Committee

School District Meeting

March 12, 1979

The School District Meeting for the Town of Fremont opened at 8:00 p.m. at the Laurence Pettengill Hall, Ellis School, in said district. Mr. George H. Baker, Moderator, made the following announcement:

The Chair will use only as guides in the conduct of this meeting Robert's Rules of Order, Demeters Manual on Parliamentary Procedure, The Annual School District Meeting Handbook, and the Revised Statutes Annotated, State of New Hampshire.

The only persons the Chair will recognize other than legal voters of the Town of Fremont are the Superintendent of Schools or his Agent, and Mr. Standen, the Principal of Ellis School.

In compliance with RSA 197:5, no article other than those contained in the official Warrant may be entered at this meeting.

It is with regret that I announce the absence from this meeting of Mr. Leonard Bonagura, School Board Member, due to a heart attack. We all with Len a speedy and full recovery.

I will now read the Articles of the official Warrant to be acted upon at this meeting; then we will act on each Article separately.

ARTICLE I

To hear the reports of Agents, Auditors, Committees, or Officers chosen and pass any vote relating thereto.

Mrs. Mary Stiner, School Board Member, made the motion that the reports of Agents, Auditors, Committees, or Officers chosen be accepted as printed and read.

Seconded by Mrs. Maureen Buhrman, School Board member.

Mrs. Stiner stated that she would like to discuss the new law regarding handicapped children, which is as follows:

PUBLIC LAW 94-142

The Education for all Handicapped Children Act of 1975

The item which has added the largest increase to the school budget is Special Education. Perhaps, the following facts will be helpful in providing a clearer understanding of the whole subject.

First of all is the definition of handicapped. Public Law 94-142 defines handicapped children as: "mentally retarded, hard of hearing, speech impaired, visually handicapped, seriously emotionally disturbed, orthopedically impaired, or other health impaired children, or children with specific learning disabilities who by reason thereof require special education and related services."

The Back ground of P.L. 94-142 is as follows:

The Rehabilitation Act of 1973 includes a provision which stated that "no otherwise qualified handicapped individual in the united States, shall, solely by reason of his handicap, be subjected to discrimination under any program or activity receiving federal financial assistance." Therefore, this law mandates as a civil right that all handicapped children must have available to them a free public education.

Then in 1975, Public Law 94-142 was passed, and this is even more specific in mandating that states provide a free education for all handicapped children. The purpose of this act requires that states "assure that all handicapped children have available to them, . . . a free appropriate public education and related services designed to meet their unique needs. . ."

Even though this law was passed in 1975, the compliance date was September 1, 1978. As of last September, New Hampshire school districts have had a legal obligation to identify all handicapped children, ages 0 to 21 within their district, and to be sure that all of these children, ages 3 to 21

have available to them a free, appropriate public education.

Before any action is taken to place a handicapped child in a special education program, a full and individual evaluation of the child's educational needs must be done. If testing and conferences show the need for special ed and related services, then an individualized education program must be developed for the child, and suitable placement must be decided.

This individualized educational program must make provisions for any necessary related services, such as transportation and other developmental, corrective, and supportive services. Speech pathology and audiology, psychological services, physical and occupational therapy are a few of the types of services which may be needed.

The important thing is that all services must be provided at no extra cost to parents or guardians. Also, every handicapped child, who can benefit in a regular classroom, should be so placed and provided with the

aids needed to compensate for the disability.

Obviously, this type of education can be very expensive. Who is going to pay the bills? Approximately \$20 million of federal, state, and local funds were spent last year in New Hampshire to educate the handicapped. A little more than \$1 million was given to the state under federal funding, and the state spent \$2 million. The remaining \$17 million was born by local governments.

Another question which is frequently asked is "Why does New Hampshire, or Fremont, have to comply with P.L. 94-142?" First of all, handicapped persons, like all Americans, have civil rights, and a free public education is one of these rights. The federal government can withhold all federal funds for handicapped education, and furthermore, if the state fails to comply, the federal government can also withhold either all or part of the total amount of all federal funds granted to the state for education. In 1977, New Hampshire received more than \$29 million from the federal government for all education programs.

This is an extremely bried explanation of special education and its many aspects. The important thing which we must all remember is that school districts are required to comply. We no longer have a choice."

Mrs. Stiner went on to explain in more detail our situation in Fremont. There were four children in Rockingham at the beginning of the year; now there are six. Three children are in Raymond Junior H.S. All these children have serious problems that we cannot handle here at Ellis.

Ten children now at Ellis have already been tested and are in need of help. Seventeen children are identified and are waiting to be tested when and if we have the funds. The total figure in the budget for handicapped children is \$42,650, which includes testing, nurses' assistance, a partition to make a Resource room, and \$7,000 in transportation. Your School Board is trying to comply in the most economical way possible to this law and still do what must be done for these children. This is the largest increase in the budget.

The Moderator called for the vote. Motion carried by voice vote.

ARTICLE II

To see if the District will vote to authorize the School Board to apply for, contract for, accept and expend aid from the Federal, State and County Governments in connection with the Manpower Jobs, Program for the economically disadvantaged for training programs, in such sum or sums as may be available from said program.

Mrs. Buhrman made the motion that the District authorize the School Board to apply for, contract for, accept and expend aid from the Federal, State, and County Governments in connection with the Manpower Jobs, Program for the economically disadvantaged for training programs, in such sum or sums as may be available from said program.

Seconded by Mrs. Stiner.

A question was asked from the floor if this was CETA funds. Mrs. Stiner stated it included CETA funds but the School Board had no program in mind. This is put in the Warrant in case someone becomes available that we can use.

The Moderator called for the vote. Motion carried by voice vote.

ARTICLE III

On petition of ten legal voters (and more) to see if the District will vote to rescind Article V of the District Meeting of March 13, 1978 and vote to provide transportation of high school students to Sanborn Regional High School only.

Mr. Theron Young made the motion to reject this Article.

The motion was ruled as not in order.

Mrs. Phillis Menard moved that this Article be open for discussion. Seconded by Mr. Steven Menard.

Mr. Stuart Langton made a motion to postpone this Article indefinitely. Seconded by Mr. Philip Davis.

Mr. Langton felt that the School Board should continue to have the authority as passed in Article V at the 1978 School District Meeting, to bus children to Pinkerton and to Sanborn. He also felt that there were some irregularities in the submission of this Article for the Warrant.

The Moderator called for the vote. The voice vote not being clear, the Moderator called for a standing vote. Yes - 79; No - 30. The motion was carried.

ARTICLE IV

To see if the District will authorize the School Board to make application for, to receive and spend in the name of the district such advances, grants - in - aid or other funds for educational purposes as may now or hereafter be forthcoming from Federal, State, Local or Private Agencies.

Mrs. Stiner moved that the District authorize the School Board to make application for, to receive and spend in the name of the district such advances, grants-in-aid or other funds for educational purposes as may now or hereafter be forthcoming from Federal, State, Local or Private Agencies.

Seconded by Mrs. Buhrman. Motion carried by voice vote.

ARTICLE V

To see if the District will vote to authorize the School Board to change the position of Assistant Superintendent in Supervisory Union No. 14 to Business Manager beginning July 1, 1979.

Mrs. Buhrman made the motion that the District vote to authorize the School Board to retain the position of Assistant Superintendent in Supervisory Union #14.

Seconded by Mrs. Stiner.

Inclusion of this Article was mandatory by the State, but the School Board would like to retain the Assistant Superintendent instead of changing the position to Business Manager. Changing the title of this position would change the job description from a person oriented in education to one more oriented in business, which the School Board objected to.

The Moderator called for the vote. The Article was defeated.

ARTICLE VI

The see what sum of money the District will vote to raise and appropriate for the support of schools, for the payment of salaries for school district officials and agents, and for payment of statutory obligations of the district.

Mrs. Stiner made the motion to consider the budget by line item.

Seconded by Mrs. Buhrman. The vote on the motion to consider the budget by line item was carried.

Discussion and vote on the budget line by line commenced.

Under Section 210 Salaries, Mr. Larry Whitman made the motion to reduce the figure to \$126,000. Discussion of all the teachers' salaries for this year and last year followed.

The Moderator called for the vote. The motion to reduce the Salaries was defeated. Voting followed on original figure of \$134,167 for Salaries. Passed by voice vote.

Under Section 500 Pupil Transportation, Mr. Larry Whitman moved that the figure of \$31,658 be reduced to \$22,748, the difference being \$8,910 which was the amount quoted by the School Board as the Cost of busing to Pinkerton. Discussion followed.

The moderator called for the vote on the amended figure of \$22,748 for Pupil Transportation. The voice vote not being clear, the Moderator called for a standing vote. Yes - 65; No - 43. Motion to reduce the figure to \$22,748 passed.

Under Section 640 Heat, Mr. Stuart Langton made a motion to increase this figure to \$12,000 in view of the current cost of fuel and future

increases. Motion seconded.

The Moderator called for the vote. The motion to increase the figure for Heat to \$12,000 was defeated by voice vote. Voting followed on original figure of \$9,500 for Heat. Passed by voice vote.

Under Section 1000 Student Body Activities, Mr. Larry Whitman made the motion to reduce the figure of \$1,350 to \$1,100. Seconded. Discussion followed on the different sports programs at Ellis, the coaches, and the amount of money each received.

The Moderator called for the vote. Motion defeated by voice vote. Vote on original figure of \$1,350 for Student Body Activities passed by voice vote.

Voting on the line item budget being completed, the Moderator called for action on Article VI.

Mrs. Stiner made the motion that the District raise and appropriate \$496,489.18 for the support of schools, for the payment of salaries for school district officials and agents, and for the payment of statutory obligations of the district.

Seconded by Larry Whitman. The motion was passed by voice vote. ARTICLE VII

To transact any other business which may legally come before this meeting.

Mrs. Buhrman made the motion to adjourn. Seconded by numberous people. The meeting adjourned at 10:45 p.m.

Superintendent's Report

Not long ago the late Raymond Hoyt, former headmaster of Sanborn Seminary, and later, a very successful superintendent of schools in Exeter said, in one of his annual reports, that it didn't seem possible that he was submitting his 17th annual Superintendent's Report. I know exactly how Mr. Hoyt felt, for this happens to be my 18th report. Since becoming superintendent of schools in S.A.U. No. 14 in 1962, I've seen many changes in public education. I sincerely believe that, for the most part, these changes have been for the good.

However, many public education critics today would have us believe differently. They claim that our standards have declined and that our system is near or approaching complete chaos. These individuals say that our pupils can neither read nor write, that our teachers are poorly trained, that the schools are unsafe, that test scores are way down, that public professional educators don't care anymore and that in general public education is just plain failing.

Back in 1647 when public education was born in this nation, schools were basically asked to teach the three "R's"; reading, 'riting and 'rithmetic. Today, however, according to Mr. Wilson Riles, State Superintendent of Schools in California, schools are being asked, "to do what people used to ask God to do". He probably isn't far from wrong.

Our schools are being asked to feed our students breakfast, as well as lunch; to check student's vision, hearing and teeth; to teach children how to brush their teeth; to teach good nutrition and good health habits; to integrate the schools where communities have failed to do so in their own neighborhoods; to provide recreation; to teach respect for others, as well as for themselves; to show young people how to ride bikes safely and how to drive cars; to teach how babies are made; and to convince young people not to use drugs. In the past, the family or some other agency handled many of these responsibilities, but today, they seem to have become the responsibility of public education.

We would be the first to admit that public education is far from perfect, but, even with all these additional tasks, we do have a measure of success.

Today's students are reading better at the 6th and 10th grade levels than those of 30 years ago, according to a 1976 national study conducted by Indiana University. This is surprising, since in a Neilson TV watching poll, it was shown that by the time the average person in our country is 18 years of age, he or she has watched 18,000 hours of TV. This compares to 15,000 hours spent in school.

Also the percent of functionally illiterates in the United States has dropped from 11.3% in 1900 to a mere 1.2% in 1970.

It is further interesting to note that between the years of 1968 and 1978 circulation in American Public Libraries rose by 15%. This fact is also surprising in view of the various forms of entertainment available in America today. We are obviously reading more, and our schools start our people on this road.

The editors of Better Homes & Gardens reported in 1978 that 60% of the United States population rated the quality of education being offered in our schools as "good" or "very good".

In a 1979 Gallup Poll 53% of parents with children in school said

their children were getting a better education than they did.

In 1900, only 6% of the seventeen year olds finished high school, where as in 1975, 75% were graduated.

In 1900, one third of the total school enrollment missed classes regularly while in 1976, only 8% were habitual absentees.

1950, the average twenty-five year old had completed only 9.3 years of schooling; in 1976 this figure was up to 12.3 years It is even higher today.

The United States ranks number one among all countries on the basis of percent of 15 to 18 year olds enrolled in schools.

Incidentally twenty-three of the first twenty-five entrants assigned

to Lunar Missions were public school graduates.

Many of the above statistics and certain other material used in this report were obtained from a 1979 publication issued by the California Association of School Administrators, entitled "What's Right With Education".

Perhaps one of the loudest complaints of public education today is the frequently cited test score decline.

In an article criticizing public education, recently published in a New Hampshire newspaper, Mr. Allan C. Braunfield stated that it was announced in September 1979 that the school aptitude test scores of the American high school seniors fell in 1979, continuing a downward trend that began a decade ago. He uses this argument to show that students are learning less today. Of course he does not state that the actual drop in scores since 1963 on the SAT is only 3 questions in math and 7 verbal. Before one accepts Mr. Braunfield's conclusion one must first understand that the school aptitude test is not intended to evaluate education in grades 1 through 12. The college entrance examination boards, creator of the SAT, has said many times that, "the sole purpose of the SAT test is to predict how well students will perform in college.

Yet, even with such a minor drop in these scores, former Secretary of Labor Willard Wirtz, chaired a committee to look into the mater. The panel stated that, starting in the mid 1960's a larger percentage of students with comparatively lower high school grade averages were going on to college, and that a larger percent of young people were staying is school through 12th grade with the consequence that there has been a lowering of the averages on examinations, taken previously by a more select group. The panel tells us that we are enrolling over a million more students in our colleges and universities in 1979 than we were just ten short years ago.

Is then, the missing of three more math and seven more verbal questions on the SAT really this dramatic? Probably not, when one considers that a greater cross section of students are taking the SAT's at a time when public education is being asked to do more and more.

Instead of criticizing, one should probably commend public education for meeting the needs of the students as well as it has. Is it not the goal of public education to provide more education for a greater number of our young citizens in order to prepare them with the skills they need to survive in a very complex society — rather than to attain high college entrance exam scores on SAT's?

At a time when we are minimizing the importance of preparing pupils primarily to score well on college entrance exams, we must insist that public education continue to provide a sound foundation of basic skills for our students. We must further insist that all capable students demonstrate certain competencies in reading, writing, and arithmetic prior to receiving a high school diploma. Today, this is commonly referred to as "Educational Accountability".

In Mr. Standen's report this year he speaks of "Accountability", especially as it relates to Grades 1 through 8 at Ellis School.

Mr. Standen Reports:

The Accountability Plan, as it affects Fremont as well as the other towns in our School Administrative Unit No. 14 is receiving more and more attention lately. Citizens across the country are asking for an accounting of where the money for education goes. We wish to assure people as to the quality of local education. Each group in society is concerned with the quality of education.

The State Department of Education, in conjunction with each local school board, is in the process of implementing a plan to take effect by June of 1981. Our plan involves the four towns in our administrative unit and the boards have agreed to join together to pool costs and other resources.

We have been asked to complete a six step cycle by 1981. The first step is to develop outcomes for the student in the fourth, eighth and twelfth grades. The subjects, to begin with, would be language arts, reading, mathematics and United States - New Hampshire government.

Our unit must then devise means of measuring these things we want to have happen. We must then test is order to measure the performance of our students. The fourth step is concerned with developing a process that will provide the teachers, parents, administrators, and taxpayers with useful information. The fifth step is a report to the local community and the state. Finally we must manage the plan from year to year making necessary adjustments.

The result should be a quality education for all our children.

School Board Report

The money spent for educating students, maintaining facilities. and paying personnel makes the costs of running a school a complex and expensive project. Persons involved with educational systems soon become very aware of this, but all taxpayers should realize that many state and federal statutes, particularly for school districts, must be funded by local means. Approximently 75% of all money which must be appropriated for a school year is spent for basic minimum services required by state and federal laws. Of this 75%, the state and federal share finances about 13%; the rest comes from the taxpayers pocket. Since such a large share comes from local taxes, the Fremont School Board would like to mention some of the new innovations or programs upon which these funds are being spent.

Remodeling done during the summer of 1979 has given Ellis School a Special Education classroom and provided separate areas for Remedial Reading and the Title I program. This expanded space has made it possible to provide Remedial Reading for 29 children this year.

The Special Education program, in its first year, has an enrollment of 17. If Ellis could not provide these services, in house, these children would have to be sent out of the district, at a far higher tuition cost. Our Special Ed teacher is also certified to provide guidance counselling, and her allotted time for this is fully booked.

New sinks with automatic shut-off faucets were installed in the bathrooms of the original wing. An additional slop sink was added to each bathroom.

Energy conservation items done during the summer included weatherstripping doors and caulking windows. Thermostats are now covered with a locked cage, to prevent random adjustments.

The Board would like to mention one final item which has changed since last year. There has been a new accounting system which was put into effect by the state. It will give school districts a much more detailed breakdown of costs and expenditures. But because this is the transition year, it may be difficult to make a comparison between the published budget for 1980 - 81 and the previous year.

In closing, the Fremont School Board would like to thank the Fremont PTA for their continued support of various services and programs. We also thank those individuals who are generously giving their time on a volunteer basis. We would again like to remind everyone that school board meetings are open to the public. Meetings are normally held on the fourth Tuesday of every month, 7:30 PM, at the Ellis School Library.
