TOWN MEETING WARRANT

The State of New Hampshire

To the inhabitants of the Town of Lisbon, in the County of Grafton, and the State of New Hampshire, qualified to vote in town affairs:

You are hereby notified to meet at the Town Hall in said Lisbon on Tuesday, the 13th day of March next, polls to be opened at nine o'clock in the forenoon, and will not be closed before four o'clock in the afternoon, to act upon the following subjects:

Article 1. To choose all necessary town officers for the ensuing year.

Art. 2. To raise such sums of money as may be necessary to defray town charges, the same being, Town Officers' Salaries, Town Officers' Expenses, Election and Registration Expenses, Municipal Court Expenses, Expenses of Town Hall and other Town Buildings, Insurance, Police Department, Fire Department, and Vital Statistics, for the ensuing year, and make appropriations for the same.

Art. 3 To see if the town will fix and determine the compensation to be paid each of the town officers.

Art. 4 To see if the town will vote to fix the salary of the Justice of the Municipal Court at four hundred dollars.

Art. 5 To hear the reports of agents, auditors and special committees heretofore chosen, and to pass any vote in relation thereto.

Art. 6. To see how much money the town will vote to raise and appropriate for the repairs of highways and bridges for the ensuing year.

Art. 7. To see how much money the town will vote to raise and appropriate for the public libraries in addition to what is required by law, and to determine how the same shall be divided.

Art. 8. To see if the town will vote to authorize the selectmen to give a discount on all property taxes paid on or before such date as they may designate.

Art. 9. To see how much money the town will vote to raise and appropriate for the cemeteries in the town of Lisbon.

Art. 10. To see if the town will vote to authorize the selectmen to buy and have installed Parking Meters after a suitable free parking area has been provided, meters to be installed if authorized, between the Titus Block and Dexter's Garage.

Art. 11. To see if the town will vote to light the streets of Lisbon Village District all night during the entire year; Sugar Hill from the dwelling of H. J. Field to Hotel Lookoff, from the Baptist Church through Lover's Lane to the Franconia town line, from the former location of the Goodnow school house to the Homestead, and from the Lisbon and Franconia town line to the dwelling of James Dudley; Sugar Hill and vicinity to be lighted the entire year until midnight, and from 5 a.m. until daylight, excepting the lights from the Homestead to the Hotel Lookoff for six months of the year; all the above premises to be lighted with electricity; and to raise and appropriate the necessary money for the same.

Art. 12. To see how much money the town will vote to raise and appropriate for the District Nursing Association.

Art. 13. To see if the town will vote to raise and appropriate the sum of \$150.00 for the proper observance of Memorial Day.

Art. 14. To see if the town will vote to accept State Road Aid and raise and appropriate the sum of \$991.72 for the same.

Art. 15. To see if the town will vote to plow the town roads, and if so to raise and appropriate the necessary money for the same.

Art. 16. To see if the town will vote to authorize the selectmen to oil such roads in the town as are already oiled, and to raise and appropriate the necessary money for the same.

Art. 17. To see if the town will vote to give to the Lisbon Fire Dept. the sum of \$300.00 toward the purchase of a respirator.

Art. 18. To see if the town will vote to raise and appropriate the sum of \$300.00 to the White Mountain Region Association for the purpose of advertising the town of Lisbon.

Art. 19. To see how much money the town will raise and appropriate for the support of the poor.

Art. 20. To see how much money the town will raise and appropriate for Old Age Assistance.

Art. 21 To see if the town will vote to authorize the

selectmen to borrow such sums of money as they deem necessary in anticipation of taxes.

Art. 22. To see if the town will vote to raise and appropriate a sum of money to be divided between the Littleton Hospital and the Woodsville Hospital.

Art. 23. To see if the town will vote to authorize the selectmen to pay for the repairs to the Footbridge out of the town surplus.

Art. 24. To see if the town will vote to authorize the selectmen to purchase a new truck, the money to pay for same to be taken out of the town surplus:

Art. 25. To see if the town will vote to raise and appropriate the sum of \$500.00 for the purpose of helping maintain the Sugar Hill Fire Dept. in the town of Lisbon.

Art. 26. To see if the town will raise and appropriate the sum of \$400.00 for the community skating rink.

Art. 27. To transact any other business that may legally come before the meeting.

There were eleven requests for direct relief during the year, but I only granted aid to two deserving families and two single adults.

I had two funeral bills to pay this year, one a local charge, and the other a tourist from the State of Maine who came into town without funds or means of support and died suddenly after arrival in town. I contacted the proper officials in Maine, but could not spin a thread with them, resulting in the town's footing the bill.

I had one man cited for contempt of court as he had become ten months in arrears on his payments for the support of his children.

At the present time there are six children receiving board and care at the expense of the town and only one direct relief case.
