TOWN WARRANT

THE STATE OF NEW HAMPSHIRE

[L. S.]

To the Inhabitants of the Town of Newbury, in the County of Merrimack, in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at the Town Hall in said Newbury on Tuesday, the eleventh of March, next at nine of the clock in the forenoon, to act upon the following subjects:

1. To choose all necessary Town Officers for the ensuing year.
2. To raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriations of the same.
3. To hear reports of Town Officers, Agents and Committees heretofore chosen and pass vote relating thereto.
4. To see if the Town will vote to authorize the Selectmen to borrow money in anticipation of taxes.
5. To see what action the Town will take in regard to raising and appropriating the sum of four hundred dollars (\$400.00) for control of Pine Blister Rust.
6. To see what action the Town wishes to take in regard to disposing of property acquired by tax deed.
7. To see if the Town will vote to raise and appropriate the sum of Three Hundred dollars (\$300.00) for hospitalization.
8. To see if the Town will vote to raise and appro-

appropriate the sum of one hundred twenty-five (\$125.00) dollars for the purpose of publicizing and promoting the natural advantages and resources of the Town, together with the other towns in the Dartmouth-Lake Sunapee Region.

9. To see what action the Town wishes to take in regard to accepting from the estate of Inez M. Brockway, the sum of one hundred fifty (\$150.00) the same to be held in trust and the income from said trust fund to be used for the perpetual care of the graves of Edmund P. Dodge, Martha Dodge and the burial lots of Virgil C. Brockway, George E. Brockway, in the Cemetery in said Newbury, N. H.

10. To see what action the Town wishes to take in regard to accepting from the estate of George E. Brockway, the sum of one hundred fifty (\$150.00) the same to be held in trust and the income from said trust fund to be used for the perpetual care of the graves of Edmund P. Dodge, Martha Dodge and the burial lots of Virgil C. Brockway and George E. Brockway in the Cemetery of said Newbury, N. H.

11. To see what action the Town wishes to take in regard to accepting from the estate of George E. Brockway, one (1) desk and the sum of two hundred (\$200.00) to be used for the purchase of books selected by the Board of Trustees of said Library.

12. To see what action the Town wishes to take in regard to establishing the salaries and wages of all Town Officers and employees and set effective date.

13. To see what action the Town wishes to take in regard to raising the salaries of the Librarians to Fifty dollars (\$50.00) each per year, retroactive to 1 January 1952.

14. To see what action the Town wishes to take in regard to raising and appropriating the sum of two hundred dollars (\$200.00) for Civil Defense.

15. To see what action the Town wishes to take in regard to transferring the interest of Series "G" Bonds (\$183.04) to Highway Equipment Fund.

16. To see what action the Town wishes to take in regard to raising and appropriating the sum of three thousand seven hundred dollars (\$3700.00) for the purpose of resurfacing tarred roads.

17. To see what action the Town wishes to take in regard to trading the Chevrolet truck for a new truck and raise and appropriate money for same.

18. To see if the Town will vote to raise and appropriate the sum of five hundred dollars (\$500.00) to operate the Information Booth for the coming year and appoint a committee of three to be in charge of the booth, they to select a person or persons to operate the same.

19. To see what action the Town wishes to take in regard to doing private work.

20. To see what action the Town will take in regard to raising and appropriating the sum of ——— for the purpose of Class V roads.

21. To see what action the Town wishes to take in regard to closing the Cross Road so called, subject to gates and bars.

22. To see what action the Town wishes to take in regard to closing the Morse Road so called, subject to gates and bars.

23. To see what action the Town wishes to take in regard to closing part of Bly Hill Road so called, subject to gates and bars, the remainder to be repaired and raise and appropriate money for the same.

24. To see what action the Town wishes to take in regard to building an addition to the Fire House and raise and appropriate money for same.

25. To see what action the Town wishes to take in regards to participating in the Social Security Act, providing Old Age and Survivors Insurance for all employees and Officers elected and appointed.

26. To see if the Town will vote to raise and appropriate the sum of four hundred dollars (\$400.00) for the planting of fish in the waters of the Town of Newbury. The same to be turned over to the Sunapee Mountain Fish and Game Club. An accounting to be given to the Selectmen of expenditures made by the Fish & Game Club.

27. To see what action the Town wishes to take in regards to allowing the Lake Sunapee Excursions Inc., to build a suitable dock or wharf to land their boat. Same to be not nearer than one foot from present dock and at least twelve foot wide and forty foot long, extending northerly from the present dock. This dock to be used by general public.

28. To see what action the Town wishes to take in regard to putting signs on the Veterans Memorial Hall and other Town Buildings.

29. To see if the Town will vote to purchase all supplies for use by the Town of Newbury from the merchants of the town in so far as it is possible. These purchases to be equally distributed among such merchants. This article to remain in effect until rescinded by popular vote in Town meeting.

30. To transact any other business that may legally come before said meeting.

Through the efforts of the club, Blodgett Brook at Blodgett Landing and Chandler Brook at Mt. Sunapee have been opened by the State to fishing in 1952.

This is the first time in about twenty years that these brooks have been opened.

Attached you will find rulings made by the State covering said brooks, taken from Fishing Laws and Regulations effective to December 31, 1953.

Sunapee Lake tributaries of Newbury and New London: Closed to all fishing, except Blodgett, Chandler, and Mountain Brooks in Newbury where trout only may be taken.

Mountain Brook, Newbury: Open to trout fishing. Closed to all smelt fishing.

Chandler Brook, Newbury: Open to trout fishing. Closed to all smelt fishing.

Blodgett Brook, Newbury: Open to trout fishing. Closed to taking smelt.

As the Club only has a checking account, is the reason that no interest was shown on the purchase of fish.

As acting President, I wish at this time to thank the Selectmen for their co-operation and the Tax Payers for their generosity. Here's to better fishing in the Town of Newbury.

Last spring a Parent-Teacher Association was started in Newbury with George Allen as the first President. Although the group is small because of a small school enrollment, it has been quite an active and enthusiastic group. The group has taken as their major project the improvement of dental health in the schools and a great deal of conscientious work has been done to arrange for fluorine treatment and for a dental clinic. The programs have been very interesting and worthwhile.

The large number of people who turned out to the meeting in which Miss Bailey demonstrated the music work in the schools really had a fine treat. Although I have seen this work many times I never cease to be thrilled at the progress the children have made in their music. The demonstration of the piano lessons was a real joy. What a different way to learn a scale. A good example that learning can be fun.

I would like to emphasize that the Parent-Teacher Association is open to *all* people in Newbury. One does not have to have children in school or even have children. The only qualification is an interest in the welfare of the children in Newbury.

The shortage of elementary teachers remains a serious problem. Each spring the students graduating from the teachers' colleges are demanding and getting higher salaries. We have been fortunate in Newbury in having the same teachers for the past four years. It is much better to have this continuity than having a continual change of teachers. A rapid turnover of teachers is not helpful to a good teaching situation.

I have enjoyed working with the pupils, teachers, school board and parents of Newbury and might add the children of Newbury are taking an important part in the activities of Simonds High School. They have done well, both in the classroom and in the outside activities.
