#### **DISTRICT WARRANT**

The State of New Hampshire County of Rockingham

SS

To the inhabitants of Little Boar's Head, a Village District in the Town of North Hampton, New Hampshire, organized under the provisions of Chapter 196, Session Laws of 1905, qualified to vote in District affairs, greetings:

You are hereby notified to meet at Union Chapel, 7 Willow Avenue in said District on the first Tuesday in September next, being the third day of September 2013 at 6:30 p.m. for the following purposes:

Article One: To elect a Moderator, a District Clerk, a Treasurer, and an Auditor for the ensuing year.

Article Two: To elect one Commissioner for a term of three years following the expiration of the term of Brian Goode at the conclusion of this meeting.

Article Three: To hear the reports of the Clerk, the Treasurer, the Zoning Inspectors, the Zoning Board of Adjustment, the Commissioners and others, which reports are printed in this Annual Report, and to take such action as you may wish with regard to them.

Article Four: To see if the Village District will vote to accept in whole or in part a Village District Operating Budget in the amount of Twenty-Four Thousand Nine Hundred Dollars (\$24,900), as has been submitted to the Municipal Budget Committee of the Town of North Hampton, and has been approved by them, which budget is included in this Annual Report.

Article Five: To see if the Village District will raise and appropriate

the sum of Seven Thousand Five Hundred Dollars (\$7,500) to be added to the Little Boar's Head Improvement Expendable Trust Fund previously established. The Commissioners and the North Hampton Municipal Budget Committee recommend this appropriation, which would be in addition to the Village District Operating Budget.

Article Six: To take such action as the Village District may wish to give the Treasurer of the Village District authority to borrow money in anticipation of taxes upon the written request of at least two of the Commissioners, and to dispense the funds of the Village District with the approval of at least one of the Commissioners.

**Article Seven:** To see if the Village District will authorize the Commissioners, or any two of them, to apply for, to accept, and to expend without further action by this Village District, moneys from the Federal Government, from the State of New Hampshire or from private sources in accordance with the provisions of Revised Statutes Annotated, Chapter 32.

Article Eight: To see if the Village District will authorize the Commissioners, or any two of them, as agents, to transfer funds from the Little Boar's Head Improvement Fund into the Operating Account, and/or to deposit funds from the Operating Account into the Little Boar's Head Improvement Fund, which Fund is administered by the Trustees of Trust Funds of the Town of North Hampton, as may be necessary to carry on the work of the Village District.

Article Nine: To raise and appropriate such sums of money as may be necessary for the purposes included in the Budget, including the extinguishing of fires, the lighting or sprinkling of streets, the planting and care of shade or ornamental trees, the supply of water for domestic or fire purposes, the construction and maintenance of main drains and common sewers, the construction, maintenance and care of parks and commons, the maintenance of activities for recreation, the control of pollen, insects and pests, the impoundment of water, the maintenance of roads, the appointment and employment of watchmen and police officers, the enactment and enforcement of zoning regulations, and all other miscellaneous District expenses for the ensuing year.

Article Ten: To transact such other business as may legally come before this meeting.

## **REPORT OF THE COMMISSIONERS**

This has been a year of development for the Little Boar's Head District. Many of the homes in the Atlantic Avenue/Ocean Boulevard area are finishing, or in the midst of significant renovations or redevelopment. All the Boards of the District have been working to make sure that these projects are completed with the interests of the District in mind. Residents should be very appreciative of our Zoning Compliance Officer, Brian Goode, for his countless hours of diligent work.

Similar to last year, the Commissioners and the Planning Board have been working to develop and hone the District's Zoning Ordinance. The Planning Board is in the process of developing several amendments to the Ordinance which should be ready for a vote in 2018. As with all the boards in the District, the Planning Board needs volunteers as two members recently moved out of the District.

Last Fall the Commissioners had a very productive meeting with members of the Town of North Hampton's Select Board as well as several State representatives. The meeting revolved around maintaining the North Hampton Beach (NHB), cleaning up and updating the NHB parking area and redesigning the crosswalk between the State beach and the ice cream stand. While the project seemed slotted to commence this spring, we are still waiting for final state approval and the project to commence.

As reported last year, the District and the Town have worked together to have several speed feedback signs installed in and around the District. They have been installed for almost 10 months now and we hope have been effective. Per requests from members of the Heritage Commission, the Commissioners were able to have "Atlantic Avenue" signs made and installed earlier this spring. The signs were placed at Ocean Boulevard and Sea Road.

Looking forward, the Commissioners have their sights set on sidewalks and ocean walks. The planning process is starting to reclaim the sidewalk area between the Atlantic and Willow, repairing or replacing sections of the Berm walkway and plans are still in the works for the Bass Beach Berm. The engineering process for the Ocean Boulevard sidewalk project has begun. Additionally, the Commissioners are looking to restore and revitalize a lot of the natural plantings along the ocean walk.

As always, we remind you that "it takes a Village" to keep this District running. There are always opportunities for people to volunteer and help assist in the management of this very unique place we call home. Elections are held at our Annual Meeting, September 5<sup>th</sup> at 6:30pm, but many positions are appointed. Please attend the meeting or contact a District representative directly. Additionally, the Commissioners would like to invite all residents to refreshments prior to the meeting at Union Chapel at 5:30pm.

## **REPORT OF THE ANNUAL MEETING**

September 6, 2016

Minutes of the Annual Meeting of the Village District of Little Boar's Head, held in Union Chapel, Willow Avenue, North Hampton, New Hampshire, on Tuesday, September 6, 2016, commencing at 6:30 p.m. Notice of the meeting had been posted on the bulletin board outside Union Chapel and in the offices of the Town of North Hampton.

The meeting was called to order by A. Michael Burnell, who introduced the Village District Commissioners: Richard N.A. Garnett, Chairman; Leon Asadoorian; and Brian Goode.

The Moderator then took up the Year 2016 District Warrant Articles, as follows:

Article One: To elect a Moderator, a District Clerk, a Treasurer, and an Auditor for the ensuing year. By a voice vote, the following were reelected to District offices for the year 2016-2017: A. Michael Burnell, Moderator; Becky Murray, District Treasurer; Deborah Kanner, District Clerk; John Knapp, auditor.

**Article Two**: To elect one Commissioner for a term of three years following the expiration of the term of Leon Asadoorian at the conclusion of this meeting.

Leon Asadoorian was nominated and re-elected.

Article Three: Are you in favor of the adoption of the amendment proposed by the Planning Board to add a Floodplain Development Ordinance based upon recommendations made by the NH Office of Energy and Planning OEP? The intent of the proposed amendments is to come into full compliance with the National Flood Insurance Program (NFIP) regulations. John L. Knapp requested an explanation. Brian Goode answered that the Federal Emergency Management Agency (FEMA) notified Little Boar's Head that we were no longer covered by the ordinance passed by the North Hampton Planning Board last spring. If we do not pass this ordinance no residents of LBH will qualify for national flood insurance program.

By a show of hands, the article was adopted.

**Article Four:** Are you in favor of the adoption of the amendment to the zoning ordinance proposed by the Planning Board to add Section III D. Fish House Zoning District? The intent of this proposed amendment is to establish a new zoning district to preserve the historic nature of the existing buildings and the walking trail; the proposed amendment lists permitted uses and indicates that exterior work, including hardscape, requires a Little Boar's Head permit.

By a show of hands, the article was adopted.

Article Five: Are you in favor of the adoption of the amendment to the zoning ordinance proposed by the Planning Board to add Section VIII A.4 Area Regulations? The intent of the proposed amendment is to clarify requirements on Accessory Use Building such as maximum size, height and proximity to a lot line. Margaret Schoenberger requested a show of hands for those opposed.

By a show of hands, the article was adopted.

Article Six: Are you in favor of the adoption of the amendment to the zoning ordinance proposed by the Planning Board to Section VIII F. Conversion into Dwelling? The intent of the proposed amendment is to add the requirement that the existing building that is converted meet all zoning setbacks.

By a show of hands, the article was adopted.

Article Seven: Are you in favor of the adoption of the zoning ordinance proposed by the Planning Board to Section IX B. Non-conforming Structures? The intent of the proposed amendment is to change the requirement for enlarging non-conforming structures from a Special Exception to a Variance. John Knapp requested an explanation. Brian Goode answered that if there is a nonconforming building and there is an addition that extends into the nonconforming area you would need a variance rather than an exception to gain permission to proceed. If the addition is within the required setbacks it would only need an exception. The difference between the two is that a special exception is easier to obtain. A variance must meet five criteria to be granted including one for hardship. The attorneys for the district suggested the amendment after several cases arose recently. Chuck Gordon pointed out that the language as written in the report is unclear. Richard read the zoning ordinance to further clarify.

By a show of hands, the article was adopted.

Article Eight: To hear the reports of the Clerk, the Treasurer, the Zoning Inspectors, the Zoning Board of Adjustment, the Commissioners and others, which reports are printed in this Annual Report, and to take such action as you may wish with regard to them. John L. Knapp asked for a correction to the LBH Heritage Commission report which erroneously lists him as secretary. Change duly noted. By a show of hands, the article was adopted.

Article Nine: To see if the Village District will vote to accept in whole or in part a Village District Operating Budget in the amount of Twenty Four Thousand Nine Hundred Dollars (\$24,900), as has been submitted to the Municipal Budget Committee of the Town of North Hampton, and has been approved by them, which budget is included in this Annual Report. Richard explained that the increase this year is due to legal expenses. Revenue has also risen. Budget is reflective of anticipation that spending may rise next year but our anticipated revenue is expected to alleviate the increase so taxes won't rise too much.

By a show of hands, the article was adopted.

Article Ten: To see if the Village District will raise and appropriate the sum of Seven Thousand Five Hundred (\$7,500) to be added to the Little Boar's Head Improvement Expendable Trust Fund previously established. The Village District Commissioners and the North Hampton Municipal Budget Committee recommend this appropriation, which would be in addition to the Village District Operating Budget. A resident asked about how the revenue would be raised. Richard specified by taxation and revenue would be used for improvements such as sidewalks.

By a show of hands, the article was adopted.

Article Eleven: To take such action as the Village District may wish to give the Treasurer of the Village District authority to borrow money in

anticipation of taxes upon the written request of at least two of the Commissioners, and to dispense the funds of the Village District with the approval of at least one of the Commissioners. Article explained as meaning commissioners are able to obtain a loan.

By a show of hands, the article was adopted.

**Article Twelve:** To see if the Village District will authorize the Commissioners, or any two of them, to apply for, to accept, and to expend without further action by this Village District, moneys from the Federal Government, from the State of New Hampshire or from private sources in accordance with the provisions of Revised Statutes Annotated, Chapter 32.

By a show of hands, the article was adopted.

Article Thirteen: To see if the Village District will authorize the Commissioners, or any two of them, as agents, to transfer funds from the Little Boar's Head Improvement Fund into the Operating Account, and/or to deposit funds from the Operating Account into the Little Boar's Head Improvement Fund, which Fund is administered by the Trustees of Trust Funds of the Town of North Hampton, as may be necessary to carry on the work of the Village District.

By a show of hands, the article was adopted.

Article Fourteen: To raise and appropriate such sums of money as may be necessary for the purposes included in the Budget, including the extinguishing of fires, the lighting or sprinkling of streets, the planting and care of shade or ornamental trees, the supply of water for domestic or fire purposes, the construction and maintenance of main drains and common sewers, the construction, maintenance and care of parks and commons, the maintenance of activities for recreation, the control of pollen, insects and pests, the impoundment of water, the maintenance of roads, the appointment and employment of watchmen and police officers, the enactment and enforcement of zoning regulations, and all other miscellaneous District expenses for the ensuing year.

By a show of hands, the article was adopted.

Article Fifteen: To transact such other business as may legally come before this meeting.

John L. Knapp pointed out that the terms for Heritage Commission members had not been updated. Duly noted.

John also requested that his name be listed in the report as John Latham Knapp or John L. Knapp.

John L. Knapp brought up that there are still no Atlantic Avenue street signs since the state signs refer to the street as Rt. 111. He suggested that the district erect "Atlantic Avenue" street signs. Jane Rockwell pointed out that the town offices, businesses, and residents use Atlantic Avenue as their official address. She feels the Town of North Hampton should pay for the signs. Robert Hamilton proposed a resolution:

"That the inhabitants of Little Boar's Head request that the Little Boar's Head District Commissioners ask the Town of North Hampton or the State of New Hampshire to properly sign post Atlantic Avenue as Atlantic Avenue from Hobbs Road to Ocean Boulevard (6 signs.)" By a show of hands, the article was adopted.

A resident pointed out that the lamp posts don't work. Discussion on the location of the power source. Pat Myers asks that request be made to reduce the light in the neighborhood.

Question of replacing the boardwalk on the stone berm raised. LBH has considered applying for federal funds but to do so would involve an expenditure of 20,000 to apply and lowest grant would be \$400,000. Since chances are not good that district would receive the grant, decision was made not to apply. LBH has also asked the state to "firm up" the berm but no action so far. Sidewalk from corner of Willow to corner of Atlantic along Ocean Boulevard is next priority.

A resident asked whether a crosswalk or sign could be added near Appledore to facilitate crossing at the curve in Ocean Boulevard. It has been suggested to the state by the Town of North Hampton that the crosswalk to the Beach Pea be moved to a safer location by the town but the state has not approved it. Town of North Hampton is purchasing five speed feed-back signs. One of them may be located near Appledore.

The Planning Board of the Village District of Little Boar's Head met a couple of times over the course of this past year.

#### 44 Ocean Boulevard - 19 December 2016

John Cagon of Ambit Engineering presented a lot line adjustment for 44 Ocean Boulevard. Permission for this lot line adjustment had been previously approved by a board but the action by the homeowner was never taken. The Board set forth several requirements for the property owner. The requirements were met and the lot line adjustment was approved at the next meeting, 3-0-0 (March 26, 2017).

During subsequent meeting the planning board discussed changes to the zoning ordinance which included Accessory Dwelling Units and limitations on impervious paving and limits on amount of outside fill which can be brought on to a property. The process continues on these matters and no changes to the Zoning Ordinance are up for vote. Recently, two members of the Planning Board moved out of the District so there are positions and available.
