To DOG OWNERS:

- All dogs over three months of age must be registered by May 1st.
- Legal rates: Males \$6.00, Females \$6.50, Neutered Males \$3.50, and Spayed Females \$3.50.
- Rabies certificates required for registration.
- Failure to register makes owners liable for \$1.00 penalty **per month** after June 1st. It's the LAW!
- Owners are liable for free running dogs. If in doubt, check the state statutes RSA:466. The penalties are severe.

To PROPERTY OWNERS:

- Changes in the law provide that those who do not return their inventory forms by April 15 not only lose their right to appeal their taxes **but are now subject to a fine of not less than \$10.00 but up to and not over \$50.00.**

- Resident Taxes must be paid in order to register a vehicle.
- In order for a husband to register a vehicle, he must pay both his and his wife's Resident Tax. IT'S THE LAW!!

- The Town Building Code requires permits to construct or remodel any building. There are exceptions. A check should be made with the Selectmen.

SELECTMEN'S REPORT

New building construction is one of the measures of a town's growth. In 1981 the Selectmen issued building permits for four new dwellings and two more for the replacement of those destroyed by fire. In addition permits were issued for seven new barns, numerous sheds, two storage buildings, new chimneys, solar panels, a greenhouse and additions to existing buildings.

Town Hall and Other Buildings

The final touches on the major repairs made to the Town Hall the previous year were completed. The town owes many thanks to Steve Tracy for guiding this work to its completion.

Electric wiring in the Town Hall was overhauled. The Fair Association installed a new ceiling, and the Firemen installed a smoke filtering device, using income from the Bingo games to pay for it. The inside of the hall was repainted by volunteers from the "Blow-Me-Down-Snow-Riders" snowmobile club. The highway crew installed the ramp at the entrance to the Town Hall to aid the handicapped.

Installation of gas fired heaters in the Town Garage at the Flat has been completed. Insulation of the Highway portion is finished, and it is planned to do the same in the Fire Department section in 1982.

Electric wiring has been updated in the Selectmen's and Town Clerk's offices.

Highway Department

T.R.A. and Additional Gas subsidy funds were used to replace three bridges on the Center Road; Duncan Fund money was spent for replacing the deck on the Leavitt Hill Road bridge.

For some years there has been a troublesome erosion problem on the School and Fair grounds. Late in the year the Sullivan County Soil Conservation Service was able to design a diversion ditch to put an end to this erosion. Under the supervision of the S.C.S.C.S., the ditch was put in. With the help of the Highway Department, hauling gravel and grading, the work was completed before "ground freeze-up."

The end of 1981 brought snowstorms and ice early. With the public adjusted to the relatively milder conditions of late years, the demand for plowing and sanding was in many instances intense. Of course, the strain on the highway crews, equipment and budget, showed. Some experimenting was done with rearranging the plowing and sanding of the school bus routes. It was found that more efficient service could be provided the town as a whole by using a hopper sander on the town pickup truck, in addition to the regular sanding trucks.

The average number of highway workers during this past year has been less than the year before. However, costs of materials such as sand and gravel have about doubled as has the maintenance of equipment. Gasoline and diesel fuel take an increasing share of the highway budget, and there is no way to meet the public demands for safe and fast highways without heavy expenditures.

The voters should not lose sight of the fact that the grader, a basic item of highway maintenance, is nearly 20 years old and is subject to an increasing number of costly breakdowns. It is time to consider replacing it.

Overview

The Selectmen meet regularly with the Police and the Fire Chiefs to keep abreast of problems and facilitate solutions. The Planning Board, the Zoning Board of Adjustment, Supervisors of the Checklist, the Recycling Committee, the Solid Waste Study Committee, the Conservation Commission maintain frequent two-way communications with the Board.

As time goes on, the demands on the Selectmen increase. As rules and regulations increase, so does the demand for information by the public. It is not only from residents of the town that the demand comes, but from a host of public and private interests. This is not written to excite sympathy but rather to advise taxpayers in an abbreviated way of what is going on.

Although this was the year for the Selectmen to perambulate the Cornish-Croydon town line, it was not possible to coordinate a suitable time with the Croydon selectmen before deep snow interfered with the perambulation. The project has been postponed until 1982. However, for the first time on record, a portion of the boundary between Cornish and Windsor, Vt., was checked by a canoe trip down the Connecticut River in which the Cornish Boy Scouts, Billy Monette, Cheston Newbold, Michael Yatsevitch, representing the Selectmen, and Rickey Poor the Conservation Commission, participated.

The Selectmen appreciate and wish to thank all those persons who served on various boards and committees, for the generous contribution of their time and talents in the interests of the Town. For the townspeople we thank the Fair Association and the Volunteer Firemen for all they have done for the protection and betterment of Cornish.

Articles 1 and 2 of the Warrant will be acted upon at 10:00 a.m. Voting will be by official ballot and checklist, and the polls will be open for this purpose and will remain open from 10:00 a.m. until 7:00 p.m. at which time the polls will close.

At 1:00 p.m. Article 3 through 26 will be voted upon.

ARTICLE 1. To choose all necessary Town Officers for the ensuing year.

ARTICLE 2. Are you in favor of changing the term of the town clerk from one year to 3 years, beginning with the term of the town clerk to be elected at next year's regular town meeting, in accordance with RSA 41:16-a.

ARTICLE 4. (By Petition) To see if the Town will vote to request members of the New Hampshire Congressional delegation to support or cosponsor a resolution in the U.S. Congress calling for a joint United States-Soviet Union nuclear arms freeze.

ARTICLE 5. To see if the Town will vote to raise and appropriate the sum of \$4,500 to assure ambulance service for the people of Cornish.

ARTICLE 6. To see if the Town will vote to raise and appropriate \$4,000.00 and authorize its withdrawal from the Revenue Sharing Fund under provisions of the State and Local Fiscal Assistance Act of 1972 as amended by the Second Session of the 94th Congress to make the fifth payment on the note due on the International Truck.

ARTICLE 7. To see if the Town will vote to raise and appropriate \$5,000.00 and to authorize its withdrawal from the Revenue Sharing Fund, under provisions of the State and Local Fiscal Assistance Act of 1972 as amended by the Second Session of the 94th Congress, to make the 1982 Cornish Landfill Service payment to the City of Claremont.

ARTICLE 8. To see if the Town will vote to raise and appropriate the sum of \$1,500.00 to assure service by the Cornish Rescue Squad, Inc.

ARTICLE 9. To see if the Town will vote to raise and appropriate up to the sum of \$100,000.00 for the purchase of a new grader and attachments, to replace the present LeTourneau grader, such sum to be raised by notes or bonds in the full amount not to exceed \$100,000.00 under the provisions of the Municipal Finance Act (RSA 33:1 et. seq.) and to authorize the Selectmen to issue and negotiate such notes or bonds for such terms not to exceed the useful life of the vehicle, and to determine the rate of interest thereon and to take any other action as may be in the best interest of the Town.

ARTICLE 10. To see if the Town will vote to raise and appropriate the sum of \$8,200.00 to purchase a new hopper sander for the Town Highway Department.

ARTICLE 11. To see if the Town will vote to raise and appropriate \$2,400.00 to purchase a new tractor mower with a blade for the Cemetery Department and to trade in the existing tractor mower towards the purchase using \$1,000.00 to be withdrawn from the Upkeep of Cemeteries Reserve Fund, the balance to be raised by taxes.

ARTICLE 12. To see if the Town will vote to raise and appropriate the sum of \$2,000.00 to be placed in a Police Department Capital Reserve Fund for the purpose of purchasing law enforcement vehicles.

ARTICLE 13. Shall the Town of Cornish accept the provisions of Sections 1 to 10 inclusive of Chapter 53-B of the Revised Statutes annotated providing for the establishment of a Regional Refuse Disposal District, together with the Towns of Acworth, Charlestown, Croydon, Goshen, Grantham, Langdon, Lempster, Newport, Plainfield, Springfield, Sunapee, Unity and Washington, and the City of Claremont, and the construction, maintenance, and operation of a regional refuse disposal facility by said district in accordance with the provisions of a proposed agreement filed with the Selectmen, and shall the Town enter into said agreement as an interlocal agreement pursuant to RSA-A for said purposes?

ARTICLE 14. To see if the Town will vote to raise and appropriate \$660.00 for Wheels Around Windsor for Cornish residents.

ARTICLE 15. To see if the Town will vote to raise and appropriate a sum not to exceed \$1,000.00 to provide labor and equipment to haul fill to the Rescue Squad Building location.

ARTICLE 16. To see if the Town will vote to raise and appropriate the sum of \$1,042.50 towards the support of the Upper Valley-Lake Sunapee Council.

ARTICLE 17. To see if the Town will vote to raise and appropriate the sum of \$322.00 as its share of the cost of supporting the Dartmouth-Lake Sunapee Region Assn.

ARTICLE 18. To see what sum of money the Town will vote to raise and appropriate for purpose of acquiring computer equipment or services for handling the Town's fiscal and other records.

ARTICLE 19. (By Request) To see if the Town will vote to require the Selectmen, except in emergency situations, to call a public meeting between the Road Agent and all landowners whose property adjoins any stretch of town road where road work is planned that may affect roadside vegetation, drainage or topography. This meeting is to be held at the office of the Selectmen.

ARTICLE 20. (By Request) To see if the Town will vote to raise and appropriate the sum of \$1,500.00 to be used for the support of Community Youth Advocates of Sullivan County.

ARTICLE 21. To see if the Town will vote to authorize the Selectmen to make application for and to accept and expend on behalf of the Town, any and all grants or other funds for general town purposes, including but not limited to disaster relief or CETA, in excess of the money appropriated by the Town which may now or hereafter be forthcoming from the United States Government or from the State of New Hampshire.

ARTICLE 22. To see if the Town will vote to authorize the Selectmen to accept and expend, on behalf of the Town, any and all gifts or other funds received from miscellaneous sources, as the Selectmen shall determine to be advisable.

ARTICLE 23. To see if the Town will vote to authorize the Selectmen to sell or otherwise administer property acquired by tax deed.

ARTICLE 24. To see if the Town will authorize the Selectmen to borrow money in anticipation of taxes.

ARTICLE 25. To hear the reports of Officers, Agents, Auditors and Committees heretofore chosen, and pass any vote in relation thereto.

ARTICLE 26. To transact any other business that may legally come before this meeting.

CORNISH TOWN MEETING
MARCH 10, 1981

The Selectmen certified the back of the Town Warrant. The Supervisors of the Checklist signed both lists and swore to the Town Clerk that all names therein were in order. Ballots were counted by the Ballot Clerks: Adel Bayliss, Clara Weld, Polly Monette, and by Alternate Marion Stone. We had 600 ballots printed.

At 10:00 a.m. Peter H. Burling, Moderator, announced that the polls were open and he proceeded to read the Warrant in its entirety. Then people proceeded to vote on Articles 1, 2 and 3. Kathi Patterson was deputized as Assistant Moderator until 1:00 p.m.

At promptly 1:00 p.m. the Moderator brought the business meeting to order. Peter opened by reading something from 1944 — 37 years ago — by Judge Learned Hand, entitled "Liberty". Everyone joined in the pledge to the Flag and a moment of silent prayer. Peter pointed out in the Town Report what pages the last year's two meetings were on, the Budget, and the Warrant. Then he read Article 4, a to z9.

ARTICLE 4a: Peter Decatur moved, Duane Allen seconded, that we raise and appropriate \$11,500.00 for Town Officers' salaries. This was voted on in favor.

ARTICLE 4b: Dale Rook moved, Barbara LeMere seconded, that we raise and appropriate \$7,952.08 for Town Officers' expenses. It was a vote in the affirmative.

ARTICLE 4c: Judy Rook moved, Myron Kuhre seconded, that we raise and appropriate \$800.00 for registration and election. This was voted on in the affirmative.

ARTICLE 4d: Michael Yatsevitch moved, Stan Colby seconded, that we raise and appropriate \$16,798.73 for the Town Hall and other buildings' expenses. Discussion followed. Charles Aiken and Michael Monette each spoke up about the bad wiring in the Town Hall, and during the discussions a fuse was blown shutting off the lights in the stage area. Mike Yatsevitch agreed that the wiring was very old, and should be upgraded. He amended his motion by adding \$550.00 to the above amount for the wiring, as the original amount would be absorbed by the regular heating and lighting plus the building of a ramp at the front entrance, thus the amount to be voted on was \$17,348.73. Bill Monette supported the amendment and this was voted on in the affirmative. Then the original motion as amended was voted on, in favor.

ARTICLE 4e: Dale Rook moved, Earle Carpenter supported, a motion to raise and appropriate \$1,500.00 for Reappraisal of Property. With very little discussion the motion was voted on, in the affirmative.

ARTICLE 4f: Bob Bayliss moved, Susan Van Rensselaer seconded, that we raise and appropriate \$1,932.00 for the Town Officials' Insurance. This was voted on, in the affirmative.

ARTICLE 4g: Virginia Hunt moved, Jim Lukash supported, that we raise and appropriate \$7,430 for our Police Department. Stan Colby moved an amendment, seconded by Polly Rand, to raise the above amount by \$3,500.00 making it \$10,930.00. Under discussion it was brought out that the \$7,430 is higher than last year because of higher gas price, more travel needed — get 15c per mile and use own personal vehicles; Cornish had three armed robberies this past year. Stan Colby explained that \$2,500 of the increased amount is to be allocated for support money while the Workman's

Compensation payments to Matt Tinker were being clarified. \$1,000.00 was to cover possible premium expenditures to provide adequate insurance coverage for the police. Cornish police said over \$3,600 worth of stolen property had been located and returned this past year, also \$23,500 worth of vehicles (7) had been recovered. \$1,810.00 of the original amount that is budgeted, is for a new radio and its installation. The amendment was read, then voted on in the affirmative. Article 4g as amended was voted on, also in the affirmative. There was a unanimous vote expressing everyone's gratitude and extreme pleasure in having Matt Tinker back with us.

ARTICLE 4h: Dale Rook moved, Nate Cass supported, that the Town raise and appropriate \$11,745.00 for the Fire Department. Carolyn Storrs spoke up, commending the Fire Department itself for running Bingo to help keep this figure down. All present agreed. The motion was voted on, in the affirmative.

ARTICLE 4i: Peter Storrs moved, Bill Ardinger seconded, that the Town raise and appropriate \$300.00 for the use of the Planning Board. This was voted on, after short discussion, in favor.

ARTICLE 4j: Cheston Newbold moved, Bill Balch seconded, that we raise and appropriate \$100.00 for the Zoning Board of Adjustment. This was voted on, in favor.

ARTICLE 4k: Bunny Barker moved, Barbara LeMere supported, that we raise and appropriate \$100.00 for Damage by Dogs. A long period of discussion followed, as to why the money for dog licenses did not pay for any damages caused by dogs; what the \$100.00 would be spent for, etc. The motion finally passed by vote of the Town.

ARTICLE 4l: Ed Lawrence moved, Ruth Rollins seconded, that the Town raise and appropriate \$5,807.00 for Workman's Compensation Insurance. Duane Allen moved to amend this amount by \$300.00 more, as we now have ten more firemen than are now covered by this insurance. Nate Cass supported his amendment. This was voted on in favor. Then the original motion, as amended, was voted on, in the affirmative.

ARTICLE 4m: Earle Carpenter moved, Sandi Gobin supported, motion to raise and appropriate \$100.00 for Civil Defense. With little discussion, this was so voted.

ARTICLE 4n: Ricky Poor moved, Bunny Barker seconded, that we raise and appropriate \$350.00 for the Conservation Commission. Ricky stood and explained what the Commission accomplishes, what it is presently working on, and why the need for money. The motion passed, by vote of the Town.

ARTICLE 4o: Michael Yatsevitch moved, Myron Kuhre seconded, that we raise and appropriate \$800.00 for Unemployment Insurance. Stan Colby explained this was to cover any employee of the town who might be laid off, to help them in a layoff period. The motion was voted in the affirmative.

ARTICLE 4p: The Town voted in favor of raising and appropriating \$100.00 for the use of our Health Department, upon motion by Barbara LeMere supported by David Wood.

ARTICLE 4q: The Town also voted in favor of raising and appropriating \$100.00 for Vital Statistics on motion of Pete Decatur seconded by Ed Lawrence.

ARTICLE 4r: Also ARTICLE 7: Cheston Newbold moved, Polly Rand seconded, to raise and appropriate \$5,000.00 to make the 1981 Cornish Landfill Service payment to the City of Claremont, and to authorize its withdrawal from the Revenue Sharing Fund under provisions of the State and Local Fiscal Assistance Act of 1972 as amended by the Second Session of the 94th Congress. This was voted on in the affirmative.

ARTICLE 4s: Virginia Hunt moved, Matt Tinker seconded, a motion to raise and appropriate \$1,045.00 for Visiting Nurse. This was voted on in the affirmative, with very few questions or comments.

ARTICLE 4t: Upon motion by Fred Sullivan supported by Ed Lawrence, the Town voted to raise and appropriate \$1,275.73 for T.R.A. (Town Road Aid) with \$8,504.86 being the State's share. Harold Morse explained it would be used on three Center Road bridges.

ARTICLE 4u: Matt Tinker moved, Bunny Barker seconded, a motion to raise and appropriate \$105,000.00 for use on Class V Highways and Bridges. It was explained that \$95,000.00 was budgeted for this — the same as in 1980 and in 1979 budgets. \$10,000.00 was added specifically for work on bridges — most all need new railings. Several things were pointed out: \$15,846.18 in Gas Subsidy money will be available to be used for maintenance of Class V highways and bridges; there are 52.93 miles of Class V in town. Bob LeClair said the Selectmen were in charge of where the T.R.A. and Duncan Fund monies were to be spent; the Highway Agent is in charge of where maintenance is needed. Shubael Butterfield asked what Class IV, V and VI meant. The Moderator responded Class IV are State Maintained roads, Class V are Town roads, and when he said Class VI are unmaintained Town roads, the remark came — "like all the Connecticut roads"! The Town voted on the main motion — of \$105,000.00 to be reduced by the Added Gas Subsidy of \$15,846.18 in the affirmative.

ARTICLE 4v: Bob LeClair moved, Ed Lawrence seconded, that we raise and appropriate \$450.00 for Street Lighting. This was voted on in the affirmative.

ARTICLE 4w: \$3,501.75 was voted for the Cornish Library upon motion of Barbara LeMere supported by Ellie Thompson.

ARTICLE 4x: Cheston Newbold moved, Bill Ardinger seconded, that we raise and appropriate \$4,500.00 for Public Welfare. Peter Storrs explained that though he did not use this amount this past year, he felt that this amount would be a workable figure to have available. The motion was voted on, in favor.

ARTICLE 4y: \$150.00 was voted to be raised and appropriated by the Town for use on Memorial Day, per motion of Bruce Tracy supported by Stephen P. Tracy.

ARTICLE 4z: Polly Rand moved, Virginia Colby supported, that we raise and appropriate \$4,500.00 for keeping up our Cemeteries. Ellen Ballard moved to amend this amount by reducing it \$1,500. — thus \$3,000.00 seconded by Christopher Probst. This amendment was voted on in the negative. Then the original motion was voted on, in the affirmative.

ARTICLE 4z1: \$3,000.00 was voted to be raised and appropriated for Damages and Legal Expense upon motion of Barbara LeMere seconded by Myron Quimby.

ARTICLE 4z2: Michael Yatsevitch moved, Vitaline Carpenter seconded, that we raise and appropriate \$7,140.00 for Employees' Retirement and Social Security. This was voted on, in favor.

ARTICLE 4z3: ARTICLE 6: Myron Quimby moved, Ruth Rollins supported, that the Town raise and appropriate \$4,000.00 for Principal of Long Term Note, and upon Lew Gage's suggestion, they completed the motion — and to authorize its withdrawal from the Revenue Sharing Fund, under provisions of the State and Local Fiscal Assistance Act of 1972 as amended by the Second Session of the 94th Congress, to make the fourth payment on the note due on the International Truck. This was voted on in the affirmative.

ARTICLE 4z4: \$700.00 Interest for Long-Term Notes was voted to be raised and appropriated by the Town upon motion of Fred Sullivan supported by Matt Tinker.

ARTICLE 4z5: \$18,000 was voted to be raised and appropriated for Interest on Temporary Loans upon motion of Michael Yatsevitch supported by Myron Quimby.

ARTICLE 4z6: Matt Tinker moved, Stephen Tracy seconded, that we raise and appropriate \$3,000.00 for the New Highway Equipment Capital Reserve Fund. Dan Poor moved to amend their motion to increase the amount by the \$2,000.00 asked for in ARTICLE 17 to increase said fund from \$3,000.00 annually to \$5,000.00 annually. Matt seconded Dan's amendment and this was voted on in the affirmative. Then the original motion, as amended, was voted on, also in favor.

ARTICLE 4z7: Myron Quimby moved, Dale Rook seconded, that we raise and appropriate \$3,000.00 for the Fire Department Capital Reserve Fund. This was so voted.

ARTICLE 4z8: Dave Wood moved, Bunny Barker seconded, that we raise and appropriate \$1,000.00 for the Conservation Commission Capital Reserve Fund. To a query re why this Commission should need such money in a Fund, it was explained that should some land come up for sale that would not be good for homes or farming, but might be ideal for a preserve for animals or birds, or some such, this money would be available. The Commission has nothing in sight presently for this money. It was voted on, in the affirmative.

ARTICLE 4z9: It was voted to raise and appropriate enough money to pay the County Taxes upon a motion of Fred Sullivan supported by Dale Rook. Bill Ardinger stated that these taxes should not be very much more than they were the past year, but will be a little.

ARTICLE 5: It was moved by Barbara LeMere, supported by Andrew Kuhre, that we raise and appropriate the sum of \$3,312.00 to assure ambulance service for Cornish. Michael Yatsevitch explained the considerations involved in the Windsor Ambulance Service and the Golden Cross Service. Lew Gage and several others gave a number of comments — most in favor of the Windsor Service. Finally a straw vote was taken by the Moderator, and this favored the Windsor Service. The motion for the sum of \$3,312.00 was voted on, in the affirmative.

ARTICLE 6: ARTICLE 7: Ruth Rollins moved, Bruce Tracy seconded that we pass over Articles 6 and 7, as we have previously acted on these two articles. This was so voted.

ARTICLE 8: Ruth Rollins moved, Clara Weld seconded, that the Town raise and appropriate \$1,000.00 and authorize its withdrawal from the Revenue Sharing Fund, under provisions of the State and Local Fiscal Assistance Act of 1972 as amended by the Second Session of the 94th Congress, to overhaul and update the wiring system in the Town Clerk's and Selectmen's offices, and to install a single party line to the Selectmen's Office. The Selectmen explained that the wiring had never to our knowledge been renewed, and when the furnace is on and someone uses the Copier, a fuse blows. Also it has been most difficult for the Selectmen, when there has been a number of residents in the Clerk's office doing business, to use the telephone there. The motion was brought to a vote, in the affirmative.

ARTICLE 8a: Dan Poor moved, Wilbur Overman supported, that we raise and appropriate \$216.00 to pay the telephone service charges for the rest of the year 1981. This was so voted.

ARTICLE 9: Upon a motion by Bob Bayliss, seconded by Earle Carpenter, the Town voted to raise and appropriate \$1,500.00 to assure service by the Cornish Rescue Squad, Inc.

ARTICLE 10: The motion was made by Michael Yatsevitch, seconded by Polly Monette, to see if the Town will vote to authorize the withdrawal from the New Highway Equipment Capital Reserve Fund up to \$12,000.00 for the purpose of purchasing a new truck and plow to replace the Chevy Pickup and further authorize the Selectmen to sell or exchange the present pickup as an offset against the purchase price of the new truck and plow. A discussion followed, taken part by a number of residents. Finally, after everyone who wanted to had spoken, the Moderator brought the motion to a vote, which was in the negative.

ARTICLE 11: Hollis Boardman moved, Virginia Colby seconded, that the Town raise and appropriate \$1,500.00 to replace the roadside fence at Edminister Cemetery. Hollis explained the present picket fence is getting rotten, and he suggested a wire-link fence, about 400 ft. long. Ruth Rollins told of parkers on that road throwing empty cans and bottles into the cemetery. The motion was voted on, in the negative.

ARTICLE 12: Bruce Tracy moved, Ellen Ballard seconded, that we raise and appropriate \$600.00 for Wheels Around Windsor for Cornish residents. The Moderator asked that all those in favor say "Yea" and there was a large "Yea" answer. When he asked all those who wished to vote against it say "Nay", a small child playing on the floor with her doll piped up a small voice "Nay"!

ARTICLE 13: Vitaline Carpenter moved, Shirley Sullivan supported, the motion to exclude from the plan service in any class or classes of positions of election officials or election workers for a calendar year in which the remuneration paid for each service is less than \$100.00. This was brought to a vote after a short discussion, and voted on in the affirmative.

ARTICLE 14: Fran Hollis moved, Clara Weld seconded, that the Town of Cornish participate in the creation of a regional refuse disposal planning committee to work with the N.H./Vt. Solid Waste Project to find a solution for our waste disposal problem and further to appropriate the sum of \$768.00 for the expenses of the Project and to request the moderator to appoint the necessary representatives from the Town to this committee within 10 days of Town Meeting. Mike Yatsevitch explained the regional concept of the Solid Waste Disposal approach. Bill Gallagher spoke up against the whole project, and he moved an amendment to delete the \$768.00, seconded by Matt Tinker. A lot more discussion by a number of residents followed. The amendment was finally brought to a vote by the Moderator: Yes — 42, No. — 80. Then the motion as made by Fran Hills was voted on, in the affirmative, after Peter Burling moved to amend it to request the Moderator to appoint three members of the Town to be on a Committee, seconded by Bill Ardinger and so voted.

ARTICLE 15: Stan Colby moved, Dave Wood seconded, that we raise and appropriate the sum of \$1,043.25 towards the support of the Upper Valley-Lake Sunapee Council. Matt Tinker questioned why we give money for this Council. Colby explained that Cornish is influenced by what happens in the growth centers of our north and to the south, and Upper Valley monitors what goes on and makes this information available. Polly Monette suggested the Planning Board has gone to them for legal advice and it saves going to Town Counsel. After several others spoke pro and con on the article, the Moderator brought the motion to a vote which was in the negative.

ARTICLE 16: Matt Tinker moved, Ed Belak seconded, that we raise and appropriate \$322.00 as our share of the cost of supporting the Dartmouth-Lake Sunapee Region Association. Ed works for them, and explained the ways it helps the various towns in the area. It was voted on: Yes — 75, No — 35.

ARTICLE 17: Matt Tinker moved, Shirley Sullivan seconded, that we pass over the article as this was taken up in Article 4z6. This was so voted.

ARTICLE 18: Mike Yatsevitch moved that we raise and appropriate the sum of \$12,000.00 to replace the bridge on the Clark Camp Road between the Center Road and Route 120, seconded by Mike Therrien. Mike Yatsevitch explained he made the motion so that the voters could decide whether they wanted to impose this tax burden on themselves. He said the Selectmen consider this a low-priority road, and that putting in this bridge at this time would be a luxury item. Consequently the voters must decide if they want it or not. A long general discussion followed, with some speaking for the fixing of the bridge and some saying our taxes are high enough now, so why add this figure to make them even higher. The Moderator, Peter Burling, said he would appoint a committee of five people to look into the status of all Cornish bridges. He brought the motion to a vote, and it was in the negative.

ARTICLE 19: Bill Balch moved, Clara Weld seconded, that we authorize the Selectmen to make application for and to accept and expend on behalf of the Town, any and all grants or other funds for general town purposes, including but not limited to disaster relief or CETA, in excess of the money appropriated by the Town which may now or hereafter be forthcoming from the United States Government or from the State of New Hampshire. This was voted on in the affirmative.

ARTICLE 20: Bill Ardinger moved, Bruce Tracy seconded, that we authorize the Selectmen to accept and expend, on behalf of the Town, any and all gifts or other funds received from miscellaneous sources, as the Selectmen shall determine to be advisable. This was voted on, in favor.

ARTICLE 21: Matt Tinker moved, Mike Yatsevitch seconded, that the Town authorize the Selectmen to sell or otherwise administer property acquired by tax deed. After a little discussion, it was voted on in the affirmative.

ARTICLE 22: Ruth Rollins moved, seconded by Pat Youden, that we authorize the Selectmen to borrow money in anticipation of taxes. As there was no question or discussion on the motion, it was brought to a vote and declared by the Moderator to be a vote in the affirmative.

ARTICLE 23: Matt Tinker moved, Jim Lukash seconded, that the Town Report as printed, with all the reports of Officers, Agents, Auditors and committees for the year 1980 for the 214th Annual Report be accepted. Following a few comments, the motion was voted on in the affirmative.

ARTICLE 24: Ruth Rollins moved, Jim Lukash seconded, that we nominate and elect the same board of Fence Viewers we had last year; namely Fred Sullivan, Edwin G. Lawrence, Katherine E. Kibbie, Robert L. Hilliard, and Caroline E. Storrs. This was so voted.

Ed Lawrence moved, Myron Kuhre seconded, that Jesse Stone, Orville Fitch, Fred Weld, James Neil, William Monette, and Ehrhard Frost be again elected to the office of Surveyors of Wood, Bark and Lumber. This was also so voted.

The Moderator then asked for nominations for Hog Reeves. The following were nominated from the floor: Gary and Cathy Hier, Hugh and Elizabeth Wade, Leslie and Dorothy England, Cheston and Nancy Newbold,

Dave Wood and Gini Hunt, Greg and Carolyn Foster, and Fred Schad. Ruth Rollins and Polly Monette moved nominations cease. This was voted. The slate of Cornish residents above were warmly voted into office as Hog Reeves for the year 1981.

Bill Ardinger asked to speak for the body in thanking Peter H. Burling for his P A system of running the meeting. He said Peter needs a bullhorn.

Appreciation was expressed to those who got the drapes cleaned, to all those who helped in painting the Town Hall inside, as this all helped to save tax dollars.

Matt Tinker thanked everyone who had sent cards, or gone up to see him when he was hospitalized because of his car accident.

Peter Burling thanked all Cornish people who supported him in his Senate race. Though he lost on the County level, he certainly won in Cornish.

Ed Lawrence and Jim Lukash moved and seconded to suspend the business portion of the 1981 Cornish Town Meeting. This was so voted. 6:45 p.m.

The polls were officially closed at 7:00 p.m. Everyone sat down to a supper served by members of the United Church of Cornish. (This organization also served dinner at noon.) Immediately after the refreshing meal, the ballot clerks and other officials under the supervision of the Moderator, counted and tallied the ballots. With 866 registered voters on our Checklist, there were 344 regular ballots cast, and 17 absentee ballots, or a total of 361.

ARTICLE 1: To choose all necessary Town Officers for the ensuing year:

For Selectman for 3 years: Hollis J. Boardman, Sr. 23; Robert C. LaClair 26; Pauline T. Monette 97; Myron E. Quimby 211; Don Powers 1; and Paul Duval 1. Myron E. Quimby, with the 211 votes, was elected to office and was sworn in by the Moderator at the close of the meeting.

For Town Clerk: Bernice F. Johnson received 352 votes and was reelected. She was also sworn in by Peter H. Burling at the close of the meeting.

For Town Treasurer: Mary J. Garrow received 162 votes; Barbara Rawson received 162; Barbara Atherton 1; and Jim Fitch 1. On Thursday morning March 12, Mary J. Garrow and Barbara Rawson met in the Selectmen's Office with the Selectmen and the Town Clerk. Barbara very graciously withdrew her name. Mary Jean Garrow was sworn in as Treasurer by the Town Clerk.

For Tax Collector: Carol F. Fitch received 353 votes and was reelected to her office. She was sworn in following the close of the meeting by Peter H. Burling.

For Auditor: Myron A. Kuhre 314 votes; David Bevan 3; Lewis Gage 2; Donald Powers 2; Robert Laclair 1; Caroline Storrs 1; Pat Granger 1; Edna Guest 1; Michael Monette 1; and Sue Perkins 1. Myron A. Kuhre was elected as Auditor for the next 2 years.

For Library Trustee: Phyllis M. Hemphill received 235 votes; Susan Van Rensselaer 104 votes; Sherrie Morse 1; and Donald Saunders 1. Phyllis M. Hemphill was elected for a 3-year term, and was sworn into her office on March 12 by Town Clerk Bernice Johnson.

For Trustee of Trust Funds for 3 years: Edna E. Guest received 330 votes; Susan Van Rensselaer 1. Edna W. Guest was thus elected.

For Overseer of Public Welfare: Peter C. Storrs was in receipt of 323 votes; Marion Boardman 1; William Gallagher 1; Gary Hier 2; and Michael Fuerst 1. Peter C. Storrs was elected again as Overseer.

For Highway Agent: Harold A. Morse received 285 votes; John Rawson received 2; Ron Johnson 1; Myron Kuhre 8; Joseph Monette 1; Robin Johnson 1; Milt Jewell 1; Bob LaClair 3; Lee Baker 1; James Fitch 1; Albert Macy 1; and Al Garrow 1. Harold A. Morse was reelected and sworn into office by Moderator Peter Burling at the close of the meeting.

For Sexton: Hollis J. Boardman, Sr. received 195 votes; Michael D. Monette received 148. Hollis J. Boardman was reelected.

ARTICLE 2: To see if the Town will vote to Amend Art. V, Sec. A-2 of the Cornish Zoning Ordinance adopted March 5, 1974, as amended, 1975, 1976, 1977 and 1980 by inserting after sub paragraph (i) of paragraph 2 the following newly lettered section:

(j) Home Occupations

Yes: 238 No: 54

ARTICLE 3: To see if the Town will vote to Amend Art. V, Sec. D-2:A by omitting the words "is approved by the Board of Selectmen".

Yes: 200 No: 80

All used ballots were wrapped, sealed, and signed; all unused ballots were wrapped, sealed, and signed. It was unanimously voted, after proper motion, to adjourn the meeting. 10:30 p.m.

POLICE DEPARTMENT

The new radio which the town voted to purchase for use by the Police Department has been installed and is in use. Overall it significantly improves communications for our officers.

Police uniforms have been acquired. Being readily identified as police officers while dealing with the public helps immeasurably in doing law enforcement work.

Two men have completed the N.H. Police Standards and Training Course. Both Matt Tinker and myself are now certified. Philip Osgood is currently taking the course and looking forward to certification. Donald Bergman served temporarily as police officer until he moved out of town. Since all of our officers are part-time there is a need for additional personnel to ensure the public with the availability of at least one officer around the clock.

Motor vehicle accidents continue to lead the list of statistics. Speed is a contributing factor. Without a speed monitoring device it is difficult to slow down the motoring public about which numerous complaints are received. Disturbances and dogs are high on the list of our problems. Of grave concern is the number of "break-ins" that have taken place this past year. There is no simple solution, however.

Because an extra effort was made during 1981 to assist the town clerk with the collection of dog taxes, all dog taxes were paid for the first time, according to our records.

The police department appreciates the confidence and support given by the community and the town officials.

1981 REPORT FOR THE CORNISH FIRE DEPARTMENT

The fire department responded to 75 calls in 1981, 13 of which were mutual aid calls to Claremont, Plainfield and Meriden.

A 1981 International truck was purchased to replace the old tank truck at a cost of \$11,870.00. This money was raised by firemen from the bingo games which are held weekly at the Town Hall. The department also spent another \$6,344.98 on equipment and fire hose, the amount raised from bingo and various projects.

The Ladies' Auxiliary bought a new portable radio and put new crystals in all radios for a total of \$2,286.49.

This has all been done without raising your tax dollars to provide Cornish with a well equipped and well trained fire department for the protection of your lives and property, to make the job of firefighters as safe as we can.

There seems to be an increasing number of chimney fires. Please keep chimney and stove pipes free of soot buildup. Make sure your chimney is in good repair.

1981 REPORT OF THE CORNISH RESCUE SQUAD, INC.

1981 completes our eighth year of service with 22 members, all of which are Emergency Medical Technicians (E.M.T.). This past year has seen an increase of about 20% in the number of calls the Squad responded to. We had a total of 120 calls. Fifty-seven were medical emergencies in the home, 14 were auto accidents, most with some kind of injuries, 30 were coverage at fires as well as provide lighting when needed. The balance of the calls were parades, fairs, (43 treated at Cornish Fair) and mutual aid to Claremont and Windsor.

Our expenses for the year were approx. \$5,000 with \$1,500 being received from the Town of Cornish and \$1,500 being received from the Town of Plainfield. Fortunately we were able to hold our expenses down and will try to do the same for the coming year.

As most of you know, the Cornish Rescue Squad started a Building Fund campaign to build a "Rescue Shed" to house our vehicle, equipment and give us a place for training and meetings. We have reached about the three-quarter mark and have taken a lease on a piece of land on Rte. 120 near Sullivan's Sugar House. As soon as we see ground again we hope to start building.

We would like to take this opportunity to thank all those who have helped make this project possible.

As always we continue to reach the highest level of emergency medical care for our patients.

**1981 ANNUAL REPORT OF THE
WINDSOR REGIONAL VISITING NURSE ASSOCIATION
Cornish, New Hampshire**

The WRVNA is a non-profit organization offering home nursing care, under physician referral, to residents of Windsor, West Windsor and Cornish, N.H. Governed by a Board of Directors and guided by a Medical Advisory Committee, the staff of four part-time nurses work cooperatively with allied health services to provide professional care without duplication of effort or unnecessary expense to client and community.

In 1981, nursing visits for Windsor numbered 2,201, for West Windsor 329, for Cornish 337, totaling 2,867. The number of individual clients served was 206. Less than 8% of visits were not at least partially reimbursed, although our policy continues to be to provide care regardless of ability to pay. Attendance at our 21 free blood pressure clinics and 3 "flu" clinics totaled 871, bringing the total number of patient contacts to 3,738. The fee per visit was raised from \$5.00 to \$6.00 in December in order to help defray the effects of inflation: the cost to the agency is \$8.60 per patient contact.

We have been gratified by community support at budget time and by generous donations and memorial gifts. Mt. Ascutney Hospital and Health Center provides office space and telephone facilities. For more information, call us at 674-6711.

CONSERVATION COMMISSION REPORT 1981



Your Conservation Commission was organized in March 1972 by a vote of the town meeting of that year. It might be well to review some of the commission's activities on this its 10th anniversary.

1973 — The Conservation Commission worked closely with the Planning Board in forming the town's zoning ordinance, soil maps of the town were completed by the Sullivan County Conservation District, the Conservation Commission Capital Reserve Fund was voted in at town meeting. (See detailed report below.)

1974 — A zoning proposal was presented jointly by the Planning Board and the Commission. This was passed by a vote of the town.

1975 — Commission members attended meetings on solid waste management and open space; carried out a study of the natural, recreational, historical and scenic resources of the town (results of this study appear in the Menke Report and may be purchased from the Commission); flood plains were mapped in the Connecticut River, Blow-Me-Down Brook and Bryant Brook areas to cover 100-year flood limits.

1976-77 — Developed plans for a nature trail and outdoor lab on school property. Attended a series of briefing sessions held by the Department of Revenue Administration for Planning Boards and Conservation Commissions on laws and court cases relevant to town problems.

1978 — Hired a group, headed by Sue Fitch, to map Class VI and discontinued roads; to survey drilled wells, ponds and wetlands; to lay out and build a nature trail on the east side of the school property; to map and cut cross-country ski trails. The first annual Cornish Green Up Day was held.

1979 — Started preliminary plans for an agricultural survey.

1980 — Agricultural questionnaires were sent to all land owners.

1981 — During the past year results of the agricultural survey were tabulated.

Our annual Green Up Day was held in late April; and two eighth grade students, Patty Lawrence and Diane Smead, were chosen to attend the SPNHF Conservation Camp. Funds for this camp were provided by the Cornish Fair Association.

In June a selected group of Boy Scouts, two Commission members and two Cornish citizens joined the Connecticut River Watershed Council's "Source to the Sea Expedition" for a canoe trip from Sumners Falls to the entrance of the Blow-Me-Down Brook. That evening, after a supper put on by the Commission for the scouts, their families, and the canoeists, Bob Linck of the Watershed Council spoke on the return of the Atlantic Salmon to the Connecticut River.

Members have also attended meetings concerning the future of the Cornish-Windsor covered bridge, possible 1982 federal spray programs for gypsy moth, saddled prominent and spruce budworm, and acid rain.

At the Cornish Fair the Conservation Commission showed two films and a slide show. Subjects included trout, pressures on New Hampshire farming, and acid rain. The Montshire Museum's exhibit on the importance of preserving New England's farmland was also on display.

The Commission has discussed the possibility of presenting a conservation award to a Cornish citizen who is involved in good conservation practices. It is hoped we might recognize, at a local level, those citizens whose

projects or properties are not recognized elsewhere. We are presently working on the criteria for such an award.

Agricultural Survey

Of the questionnaires which were sent out, 270 or better than 50% were returned. This covers 10,997 acres, or almost 50% of the land in Cornish. If the 3,800 acres of Blue Mountain Forest Preserve are excluded this represents over 60% of Cornish's land.

As those who responded perceive their land, 18-19% is open, 55% is forested, and the remainder is wetlands, homesites, brushland, etc. In terms of slope they consider 49% of the land to be moderate slope, 13% to be flat and 23% to be either very steep or ledge.

Ninety-eight of those returning the questionnaire indicated a willingness to lease their land to some other person for agricultural use. Most indicated they would like some form of compensation. Seventy-three were not interested in leasing. Forty people were interested in leasing land from someone for agricultural purposes.

The Commission feels that the percentage of returns indicates that Cornish citizens are interested and concerned about their land. Further, if the manner in which Cornish citizens perceive their land is accurate, then a large part of the town could be used for agricultural purposes. These lands may not be "prime farmland" but history has shown us that this land can be agriculturally productive.

The Commission would like to thank those individuals who returned their questionnaires. If anyone would be interested in seeing detailed statistics please contact the Commission.

On the town warrant of 1973 the following article was placed: "To see if the Town will vote to raise and appropriate the sum of \$1,000 annually to be placed in a Capital Reserve Fund for the work of the Commission." This was voted on favorably and the town has consistently voted \$1,000 into this fund every year. The fund now stands at \$9,969.77. It is a fund which as it grows can be used for the acquisition of land at the discretion of the Commission and with the approval of the Selectmen. This fund can be used to acquire for the community, and in its interest, property that might come up for sale. Such opportunities often come up unexpectedly and unless acted upon promptly the opportunity may be lost forever. It is a foresighted community that maintains such a fund.

SUPERVISORS OF THE CHECKLIST REPORT

The year 1981 was a busy one for us. Even though the law required that all persons voting in the Nov. 4, 1980 election and the 1981 Cornish Town Meeting were reregistered in accordance with the ten-year verification process, the Supervisors of the Checklist requested that all registered voters of the Town of Cornish reregister.

The reason for this request was to get the checklist card file, which is used by the selectmen, up to date. Prior to this time three different size cards were used, making its use very difficult.

We did this by having those voting Nov. 4, 1980 re-register at that time with very little cost to the town and very little inconvenience to voters. We took cards to the elderly on our own time and tried to make it convenient for those not voting by scheduling required meetings.

However at an additional cost to the town it was necessary to mail 100 notices to registered voters. Thirty-seven of these people appeared to re-register and August 4, 1981 the other 63 names had to be struck from the list due to no response.

Forty new names were added to the checklist in 1981 also.

The number of voters in the Town of Cornish on August 28, 1981 was 803, with 359 registered Republicans and 235 registered Democrats.

RECYCLING CENTER REPORT

In 1981 the Recycling Center collected approximately:

224 pounds of aluminum

17 tons of glass

4 tons of newspaper

A bin for composting of grass clippings and leaves has been built. A new sign, made by volunteer talent and recycled and donated materials, has been erected.

During the past year, the Recycling Center has subscribed to RESOURCE RECYCLING — Journal of Recycling, Reuse and Waste Reduction; joined the National Recycling Association; joined the New Hampshire Resource Recovery Association and been represented at meetings by Marc Cohen. Louis Haas has been very helpful as a liaison person between the Center and the Solid Waste Project.

The above have resulted in increased communications concerning markets, transportation and the potentials of other recyclable materials, such as plastics. Another encouraging result is our affiliation with the Vermont Environmental Association. They are establishing area depots for recycled aluminum, thus providing an opportunity for increased bulk sales, decreased transportation costs and higher wholesale prices.

Educational activity includes the panel exhibit at the Cornish Fair and the Sun Day celebration at the Miller residence; field trips to recycling centers in Peterborough and Sutton; workshops in Meredith, Concord, Peterborough and Rutland, Vermont.

We are grateful to the Selectmen, the Road Agent and all who help with weekly maintenance, transportation, donations, moral support and, of course, all those who use the Recycling Center. The Resource Recovery Commission meets at 7:30 p.m. on the 2nd and 4th Monday of each month and welcomes interested people.

**REPORT OF THE
NH/VT SOLID WASTE PROJECT
1981**

A Summary of the activities of the Solid Waste Project since last year's Town Meeting follows. It presents an overview of developments to date. Volumes of detailed information are available for review by any individuals who request it, however.

Mentioned in the Summary is reference to the Sullivan County Regional Refuse Disposal Planning Board. The persons representing Cornish in that capacity were Robert Ballard, Louis Haas, and myself. We all are prepared to further elaborate on areas mentioned in the Summary as well as an article placed in this year's Town Warrant.

N.H./VT. SOLID WASTE PROJECT

The N.H./Vt. Solid Waste Project has concentrated on three major tasks since March 1981 town meetings. First and foremost has been the drafting of the Sullivan County Regional Refuse Disposal District Agreement. Following votes last year, the moderator in each town appointed three representatives to the Sullivan County Regional Refuse Disposal Planning Board. This board, authorized by RSA Chapter 53-B worked through the summer and fall on the wording of the Agreement. The voters in each town will be asked to vote by printed ballot on accepting the agreement at town meeting. The City Council in Claremont must also act on the question of accepting the agreement. Each town in which a majority of the voters vote in favor of the agreement becomes a member of the District. The District then has one year to complete plans for a regional disposal facility. At March 1983 town meetings any town may vote to withdraw from the District with no restrictions. If enough towns remain in the District, then the District will begin financing and construction of a solid waste disposal facility.

Voters in Southern Windsor County, Vt., will also be voting on forming a similar district. Should the production of energy from the incineration of solid waste be selected as the alternative, the two districts can cooperatively develop the facility. An Interstate Solid Waste Compact has been adopted in both state legislatures and is now being acted upon by the United States Congress.

A long-term contract for the sale of energy is the important first step in the development of an incinerator. Therefore, the second major task of the Project this year has been negotiation for the sale of electricity with Central Vermont Public Service (CVPS). Representatives from CVPS have met with the Project's engineering consultant on a number of occasions. CVPS has proposed purchasing electricity for 30 years at 15 cents per kilowatt. However, we are now negotiating to increase the proposed purchase price, based on CVPS projections of future electricity costs. Should the Project be successful, incineration to produce electricity could be competitive with landfilling. Negotiations should be completed by late spring and a decision made at that time on electricity production or landfilling.

Landfilling remains a potential option and is necessary for ash disposal even if an incinerator is constructed. Therefore, the third major task has been to locate suitable landfill sites. Wright-Pierce Engineers identified over 150 potential sites and have now narrowed those down to about seven best sites. The towns must now select the best site for detailed hydrogeologic analysis. Two sites near the Newport/Claremont border appear most promising at this time.

Should the towns vote to adopt the Sullivan County Regional Refuse Disposal District Agreement, the District will become a legal entity and will join with the Vermont District to take the place of the existing NH/Vt. Solid Waste Planning Committee. Work will then concentrate during the next year on: (1) completion of negotiations with CVPS, (2) continued work on a regional landfill site, (3) a search for a private owner/operator for an incineration facility, and (4) preparation of necessary environmental impact statements and permit applications.

United States Environmental Protection Agency funding will end in October 1982. However, local funds appropriated at last year's town meetings should be sufficient to carry the project through to March 1983. At March 1983 town meetings the final plan for the disposal system will be presented, together with the financing program, and the towns will have a final chance to vote on staying in the District.

CORNISH SCHOOL MEETING

March 7, 1981

At the annual meeting of the School District of the Town of Cornish, N.H., held on March 7, 1981, Frances A. Ackerman, Sheila R. Jackson, and Lorraine Lawrence were sworn in as ballot inspectors by the moderator. Supervisors of the Checklist, Ruth G. Rollins, Leland E. Atwood, and Myron A. Kuhre were also sworn in.

The meeting was opened by the Moderator, Peter H. Burling, at 10:04 a.m. After declaring a quorum present, the Moderator then opened the polls and read the Warrant.

Ballots Printed: 250

Used: 123

Unused: 127

ARTICLE 1:

Moderator — Peter H. Burling was elected Moderator for the ensuing year with 121 votes.

School Board — Richard B. Ackerman was elected for a three-year term with 101 votes. Also, Jill M. Edson was elected for a three-year term with 113 votes.

Treasurer — Lorraine Lawrence was elected for a year with 121 votes.

School District Clerk — Kathryn H. Patterson was elected for a one-year term with 119 votes.

Auditors — Donald Powers received 30 write-in votes and Edna Guest received 13 write-in votes.

ARTICLE 2:

Jill Edson moved that we accept the reports of Committees, Agents, Auditors or Officers as printed in the 214th Annual Report of Cornish, N.H., for the year ending December 31, 1980. Joan Baillargeon seconded. So voted.

ARTICLE 3.

Joan Baillargeon moved that the District raise and appropriate the sum of \$560,910 for the support of the schools and salaries of School District officials, agents and employees, for the payment of the District's obligations, and to authorize the application against said appropriation of such sums as are estimated to be received from the state equalization fund, together with other income, the School Board to certify to the Selectmen the balance between the estimated revenues and the appropriation, which balance is to be raised by taxes by the Town. Bill Ardinger seconded.

Mike Yatsevitch explained the graph of the distribution of expenditures and explained that the 42c figure under tuition included handicapped costs.

There was much discussion of this article with comments and questions from Mike Yatsevitch, Bob LaClair, William Monette, Fred Sullivan, Polly Rand, Nicolaas Leyds, Jim Lukash, Susan Chandler and Linda Bateman.

Sam Hibbard moved to amend the main motion to read "to raise and appropriate \$552,934 for the support of the schools, etc." His motion was seconded by William Monette. Mr. Hibbard said he wanted to cut approximately \$8,000 from the original figure as the majority of the Finance Committee felt the increase should be limited to 7%.

Discussion followed with comments for and against the motion from Nicolaas Leyds, Bob LaClair, Shirley Sullivan, Linda Rice, Jill Edson, Michael Dorris, Matt Tinker, Carolyn Madeira, Robert Jaarsma, Merilynn Bourne, Walter Gobin, Ellen Ballard and Dan Poor.

The amendment was voted on by paper ballot and failed. No 74, Yes 49.

The original motion to raise and appropriate \$560,910 was then voted on by a standing vote. It passed. Yes 80, No 47.

Polly Monette moved, seconded by Cheston Newbold, that commencing with the fiscal year 1979-82 and subsequent years, the salaries of the teachers, number of years' experience, their degrees, the table of staff salaries (including the principal), Blue Cross/Blue Shield payments, number of accumulated, paid sick-leave days, number of personal, professional and bereavement days, and the dollar and percentage increase from 1979 to 1982 and subsequent years be printed in the School District report. So voted.
ARTICLE 4:

Frank Ackerman moved, seconded by Jean Burling, that the District raise and appropriate \$7,500 for the construction of a storage shed on school property. The motion and its second were then withdrawn.

Richard Ackerman moved that the matter of a storage building be referred to a committee consisting of the School Principal, the Fire Chief, the School Custodian, one School Board Member, and one member from the Community to be appointed by the Moderator, that is to report back to the School Board by November 1, 1981. Seconded by Jill Edson.
ARTICLE 5:

Kay Kibbie moved, seconded by Mike Yatsevitch, that the District authorize the School Board to make application for and to accept and expend, on behalf of the District, any and all grants or other funds for educational purposes which may now or hereafter become forthcoming from the United States Government or from the State of New Hampshire. So voted.
ARTICLE 6:

Jill Edson moved, seconded by Myron Kuhre, to authorize the School Board to accept and expend, on behalf of the District, any and all gifts or other funds received from miscellaneous sources as the Board shall determine to be advisable.

The Moderator expressed his thanks for the manner of discussion on the previous Articles and for the work done by all involved.
ARTICLE 7:

It was moved by Kay Kibbie, seconded by Sam Hibbard, to pass over the Article. So voted.
ARTICLE 8:

Dan Poor expressed his appreciation to the Finance Committee and to the Moderator.

Polly Rand moved that thanks should be extended to the P.T.A. and all others involved for the playground structure. Seconded by Merilynn Bourne. So voted.

Kay Kibbie wanted the records to show appreciation for work done by George Runnals (deceased) and his wife, Harriet Runnals (deceased). The Moderator cast a unanimous ballot to that effect.

Dan Poor moved that the business portion of this meeting be closed; Brad Hills seconded. The Moderator announced the business meeting closed at 4:30 p.m.

At 7 p.m. the polls were closed. Ruth Rollins and Myron Kuhre were sworn in as ballot inspectors. The ballots were counted and the winners were announced. Also, the Moderator appointed Frank Ackerman to the committee established in Article 4.

REPORT OF THE ASSISTANT SUPERINTENDENT

To The Residents of Cornish:

The December newsletter from New Hampshire's Department of Employment Security reports the consumer price index just under 10 percent. This is the second consecutive month this figure has been under the double digit mark. It's good news and we hope it is just the beginning of a trend that will continue. The school budget that you will be asked to consider, I'm pleased to say, is up only half of the current cost of living rate referred to earlier.

Much has been said and written about finances in this state during the past year. A study was conducted by our university and published under the title, "N.H. School District and Municipalities." It's an analysis of towns' and cities' ability to pay, effort made, median family incomes, other. For example, the report states N.H.'s wealthiest school district has an equalized valuation per pupil of \$3,257,811 whereas the poorest has only \$60,937. Cornish ranks 49th with \$110,642. Cornish's median family income in 1979 was \$14,230 and this ranked 80th out of 169 communities.

I commend and thank the entire staff for another excellent year. Our two new faculty members proved to be fine choices. Both previously taught at Claremont's North Street School. Ms. Coolidge received her degree from Tufts University and Mr. Luce earned his at Connecticut College.

The school building has never looked better; it's receiving excellent care. A special thanks to Mr. Donald Stammers not only for his talents and energy but also for extra hours he devotes to the building.

Two unplanned projects were carried out this past year. The septic system needed considerable work. The engineering firm of Dufresne-Henry designed the required changes. Erosion damage northeast of the school had to be corrected also. We thank the County Engineer and the Sullivan County Conservation District for advice and design work.

It continues to be a pleasure working with the staff, school board and townspeople. I add my personal thanks to those of others for the continuing support Cornish residents give to our fine young men and women.

I wish to thank all of you who have continued to support the school with your enthusiasm and interest. It is through this cooperative venture that we can provide the children of Cornish a quality education.

SCHOOL NURSE REPORT

To the Citizens of Cornish:

During the 1980-1981 school year I checked all the students for pediculosis and scabies at the beginning of the school year and periodic inspections were done as needed. The incidences of either of these infectious diseases was very low.

All age students were weighed and measured for height and these results were recorded on their permanent health records.

The children were all screened for vision and hearing. Two hundred and four students were given the vision test and 10 students were asked to seek further evaluation from their doctor. Of the 195 tested for hearing four were advised to seek further evaluation.

Of the 19 students in first grade all had completed their required immunizations and had had their physical exams prior to entering school.

I offer guidance and instruction in the area of personal health and hygiene to some students.

I was also able to conduct a scoliosis screening to the fourth through eighth grades this year. I felt it was quite successful. I screened 121 students. Fourteen students are to be watched closely and two students were asked to check with their family doctor for further evaluation.

I have enjoyed this year at Cornish very much. The staff and the students are a joy to work with.

Some of these programs include: skiing (85 students), private music lessons (28 students), and private art lessons (22 students). In addition to these special programs the PTA sponsors the Town Calendar, the rummage sale, Christmas caroling, and other special projects.

This year's Current Events Quiz was, for the first time, won by students. We continue to support the entire school curriculum and in particular, the music and physical education programs.

On behalf of the PTA I wish to thank you for your support and interest. Please remember, the PTA needs your continued support and help. We look forward to another successful and interesting year.

Cornish Kindergarten, Inc.

CORNISH ELEMENTARY SCHOOL CORNISH, NEW HAMPSHIRE

To The Cornish School Board and Citizens of Cornish:

The Cornish Kindergarten, Inc. is in its fifth year of offering an educational experience to Cornish children prior to first grade. We thank the School District for providing classroom space at the Cornish Elementary School, where the kindergarten children became familiar with the staff and building before entering the first grade.

The school is a cooperative, run by the parents who elect a five member Board of Directors annually. Also on the Board are a representative from the Cornish School Board and a member of the Cornish school staff. All parents are directly involved in the school's operation: assisting in the classroom, maintaining the classroom and its equipment, and raising money to meet the budget's requirements. Earnings from annual fund-raising events (corn-on-the-cob booth at the Cornish Fair, participation in the Christmas Bazaar, and the June Flea Market at the Flat) help supplement the tuition paid to meet this year's cost.

The school meets five mornings a week from 8:45 to 11:15. HERRIKA POOR of Cornish, teacher for the fourth year, brings experience and special interests in nature and art to this year's class of 13 students. Mrs. Poor received her B. S. in early childhood education from Wheelock College, and includes in the classroom curriculum language arts, math, science, social studies and art. Nancy Newbold of Cornish, aiding three days a week, has added her special talents to the program. The program has also benefited from the expertise of Jan Ranney, physical education teacher for the Cornish School. A music program and new classroom equipment were made possible by donations from individuals and the Xerox Corp.

An Open House in the spring will welcome all children interested in attending the Cornish Kindergarten next September.
